FIG. 5 is a top view of the table condiment waste dispenser and utensil support showing my new design.

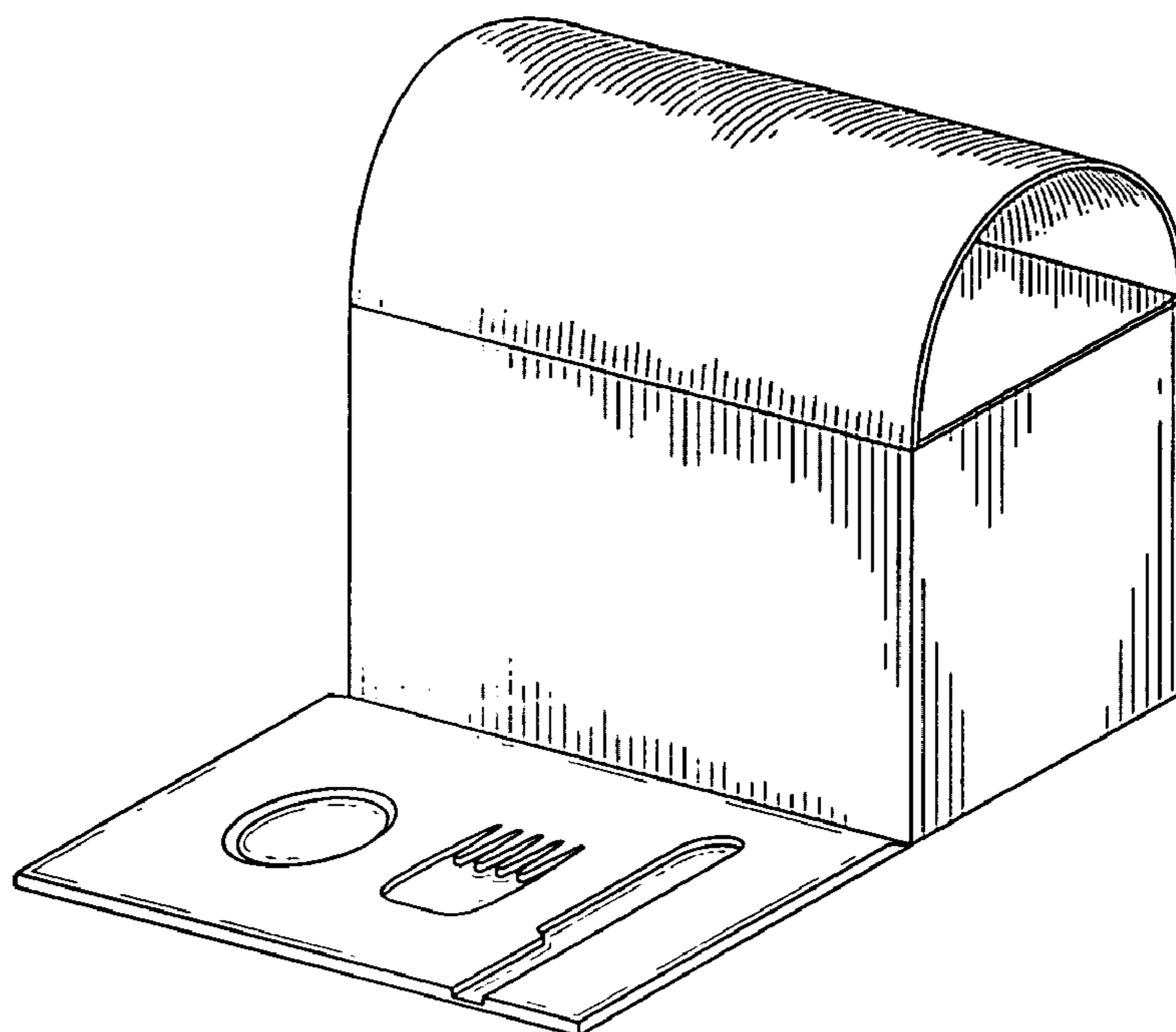
FIG. 6 is a right side view of the table condiment waste dispenser and utensil support showing my new design; and,  
FIG. 7 is a left side view of the table condiment waste dispenser and utensil support showing my new design on a person's body.

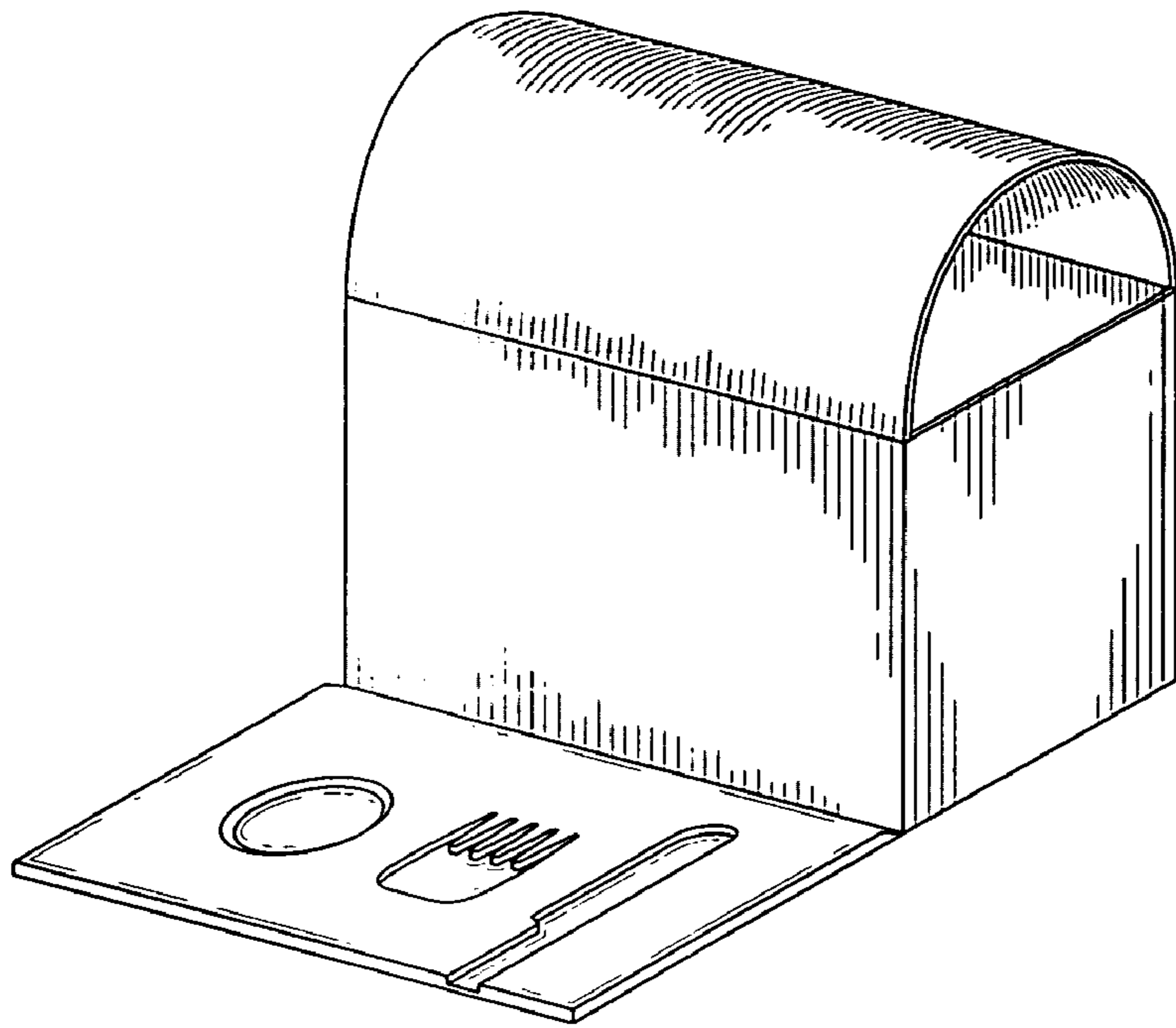

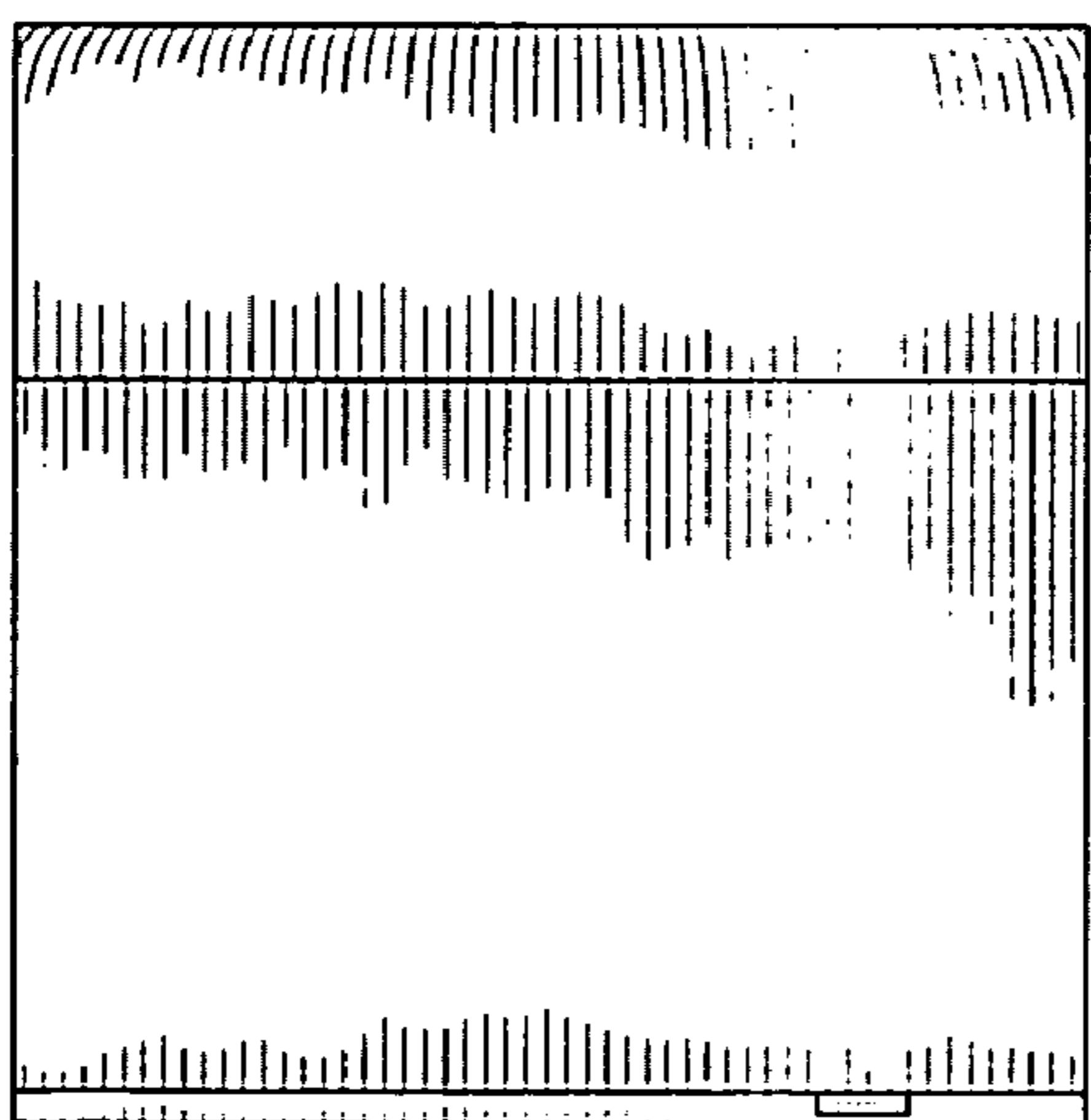

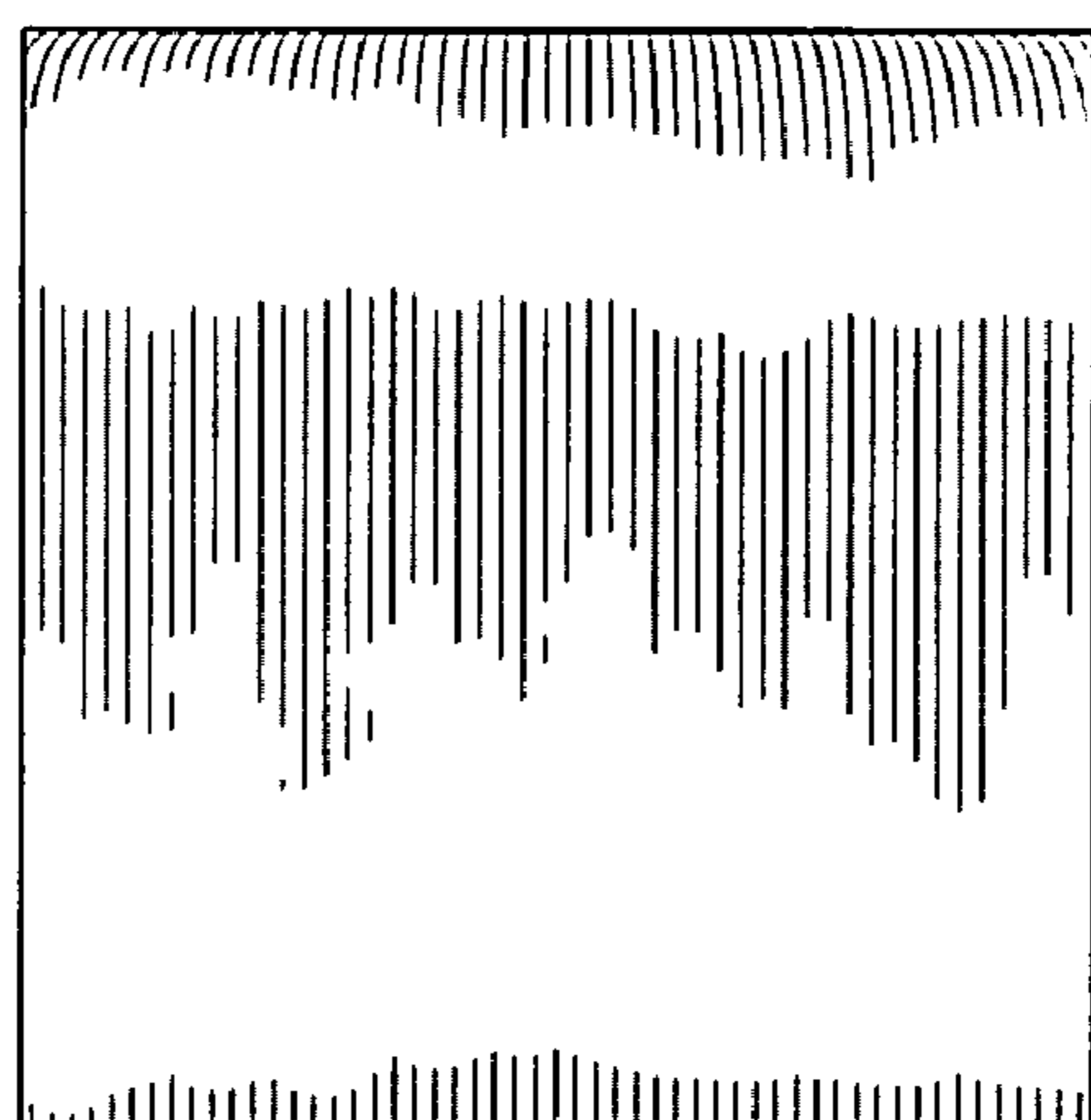




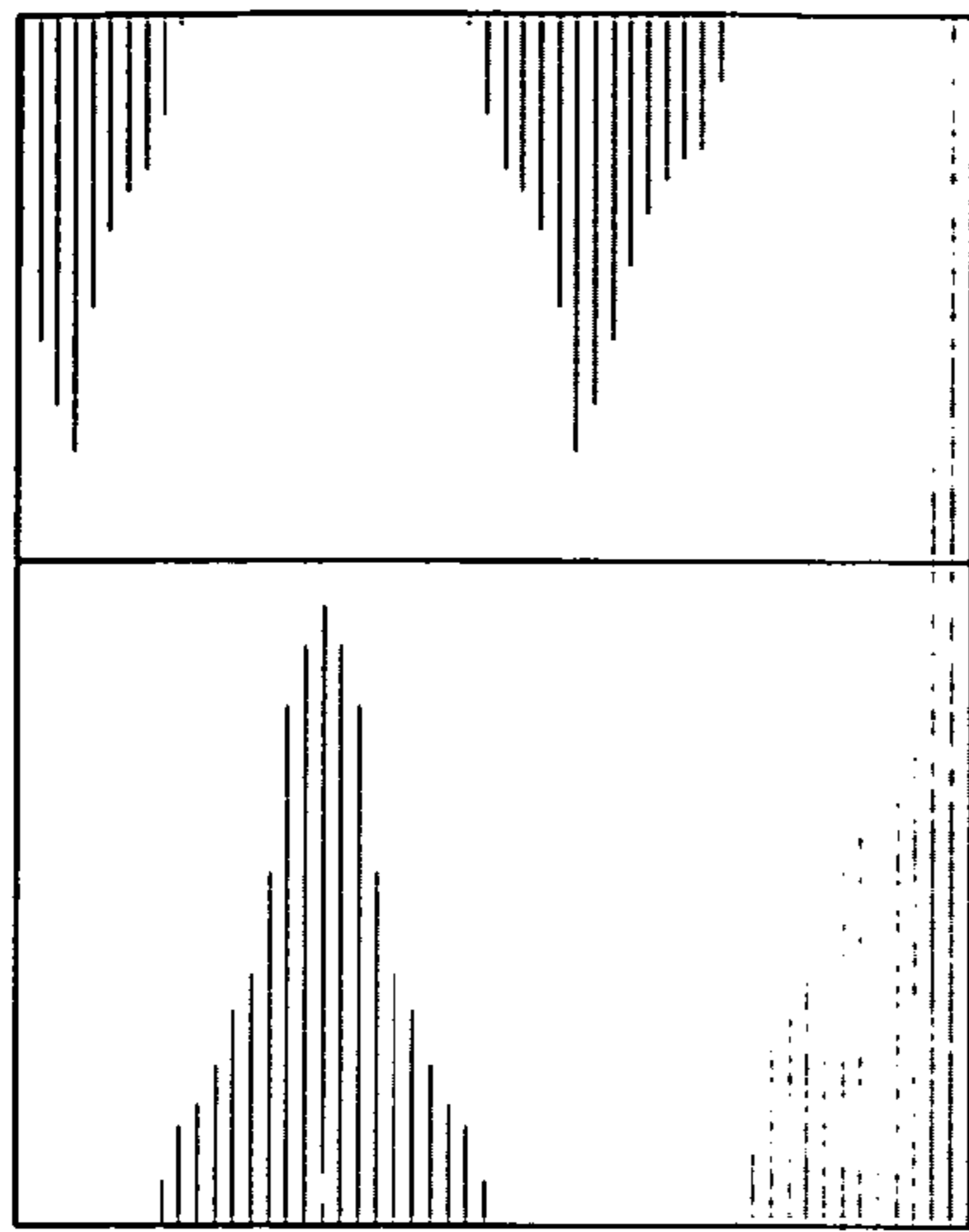

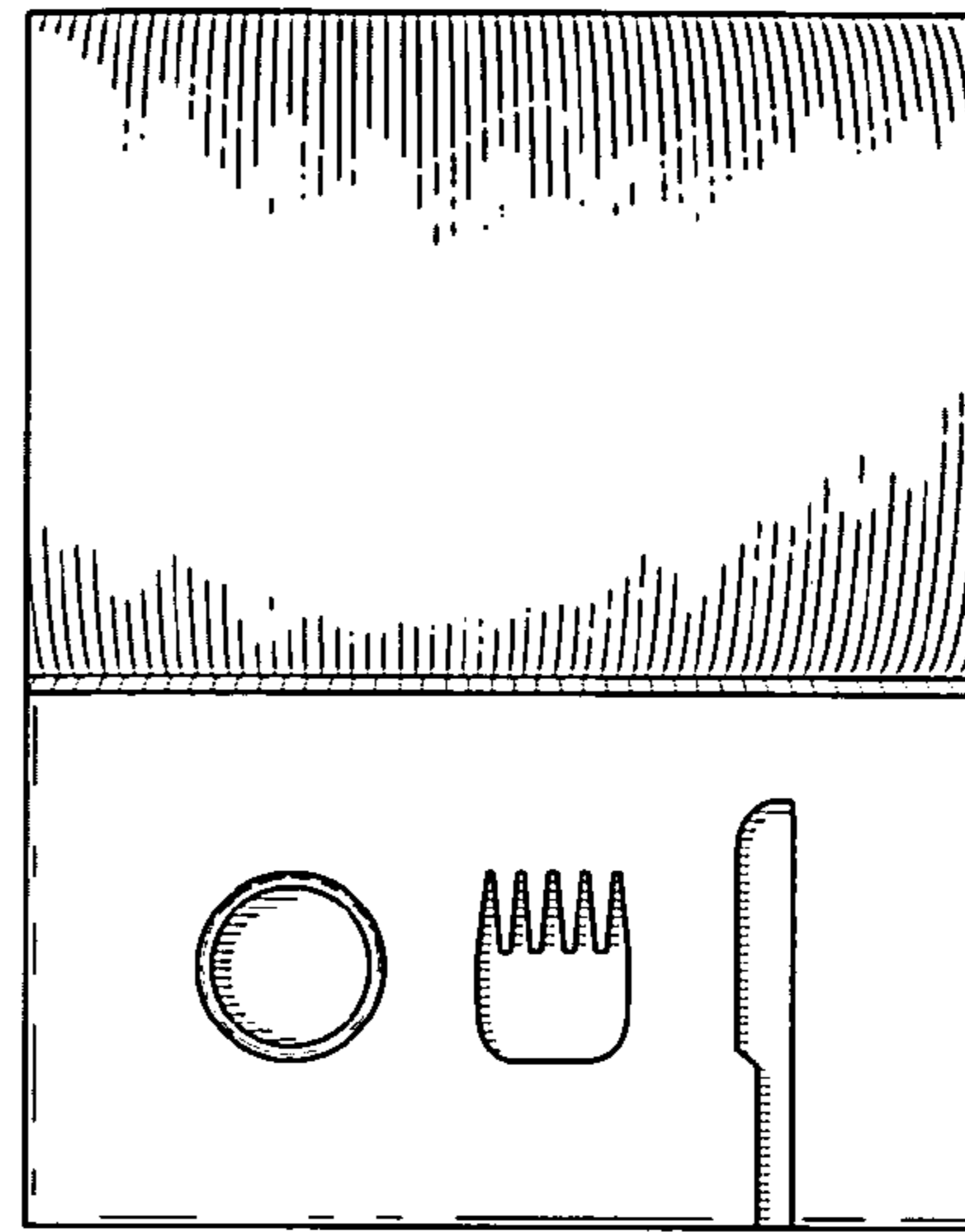

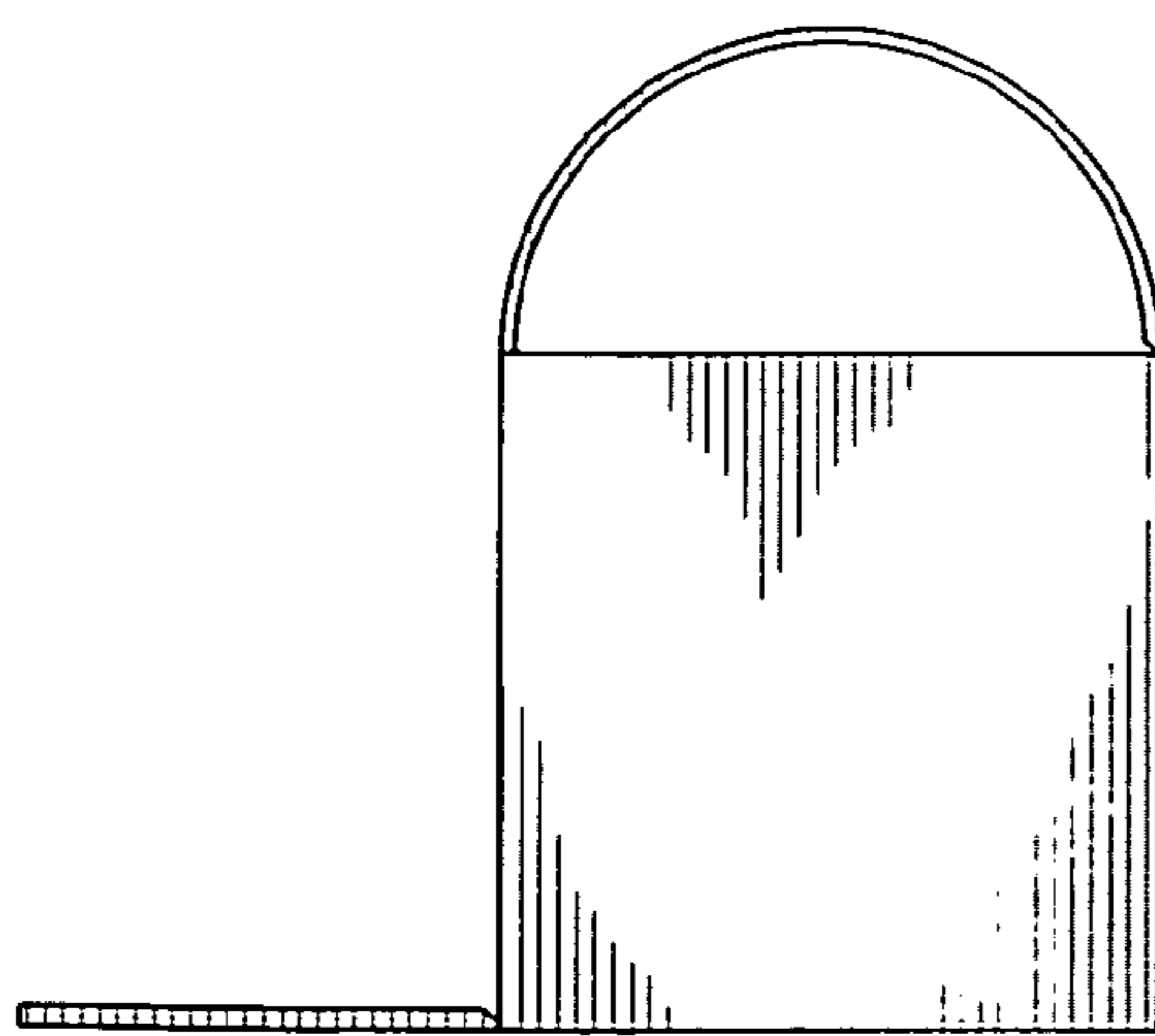

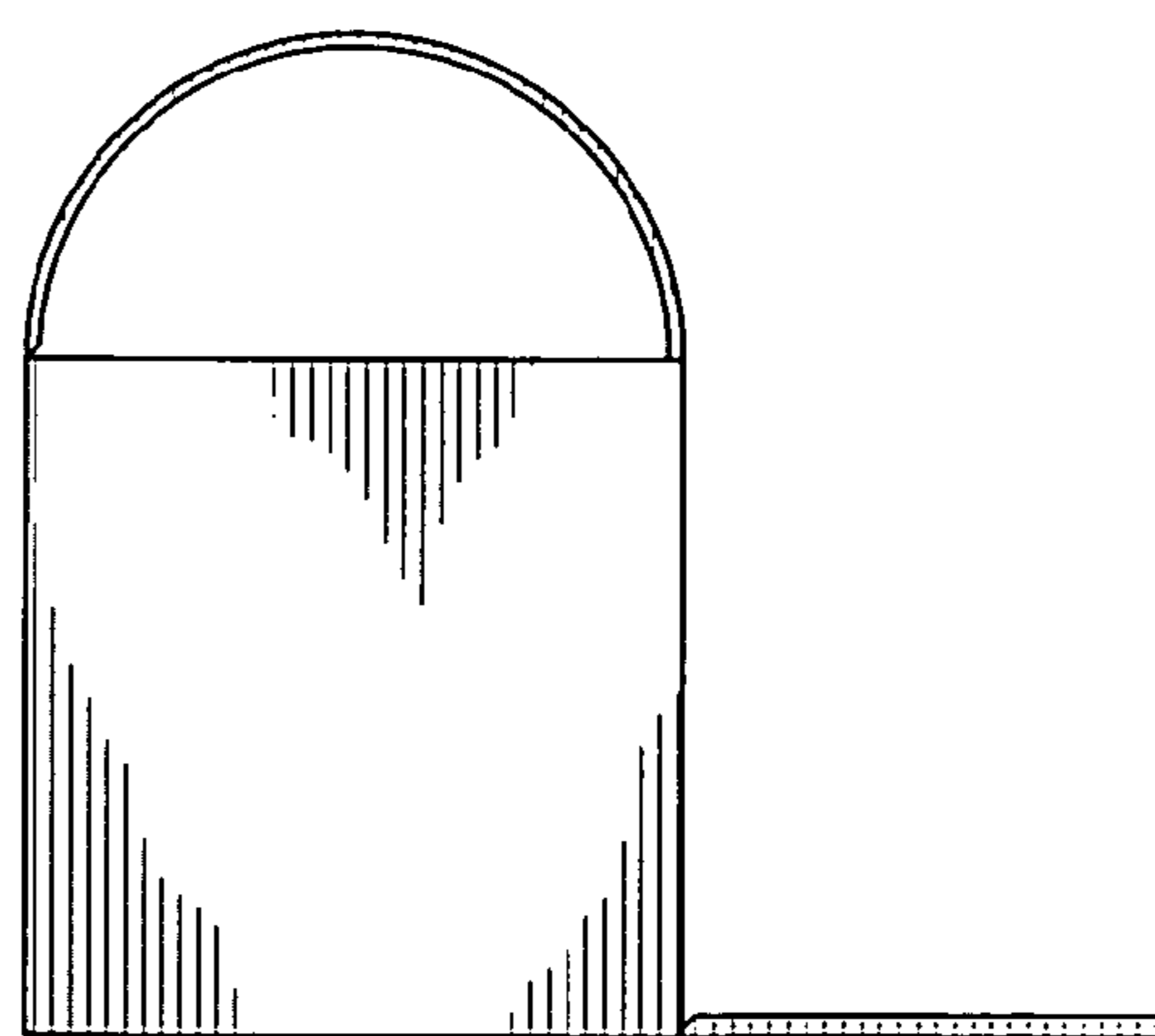
