FIG. 4 is a left side view of a shovel workhead;

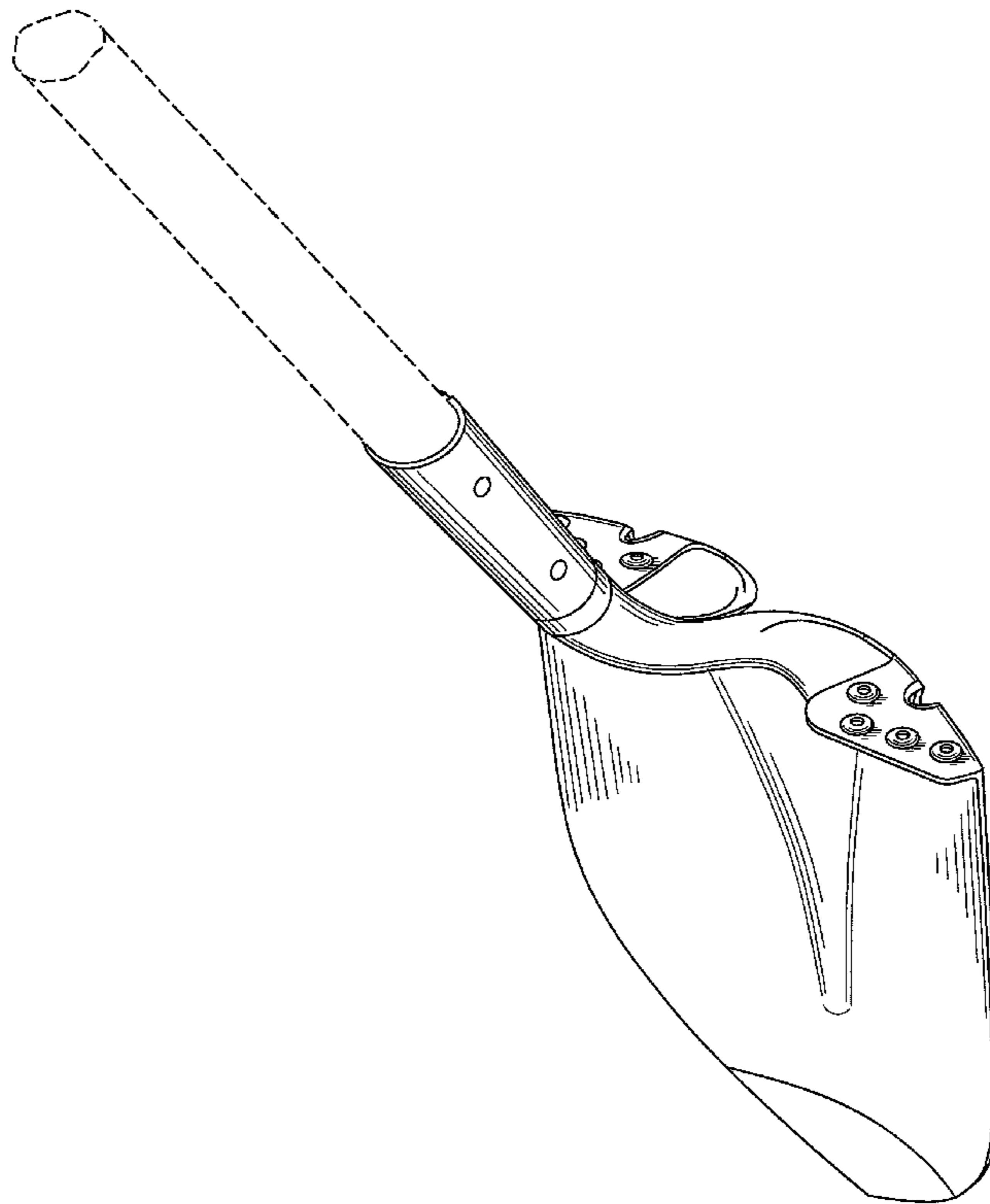
FIG. 5 is a right side view of a shovel workhead;

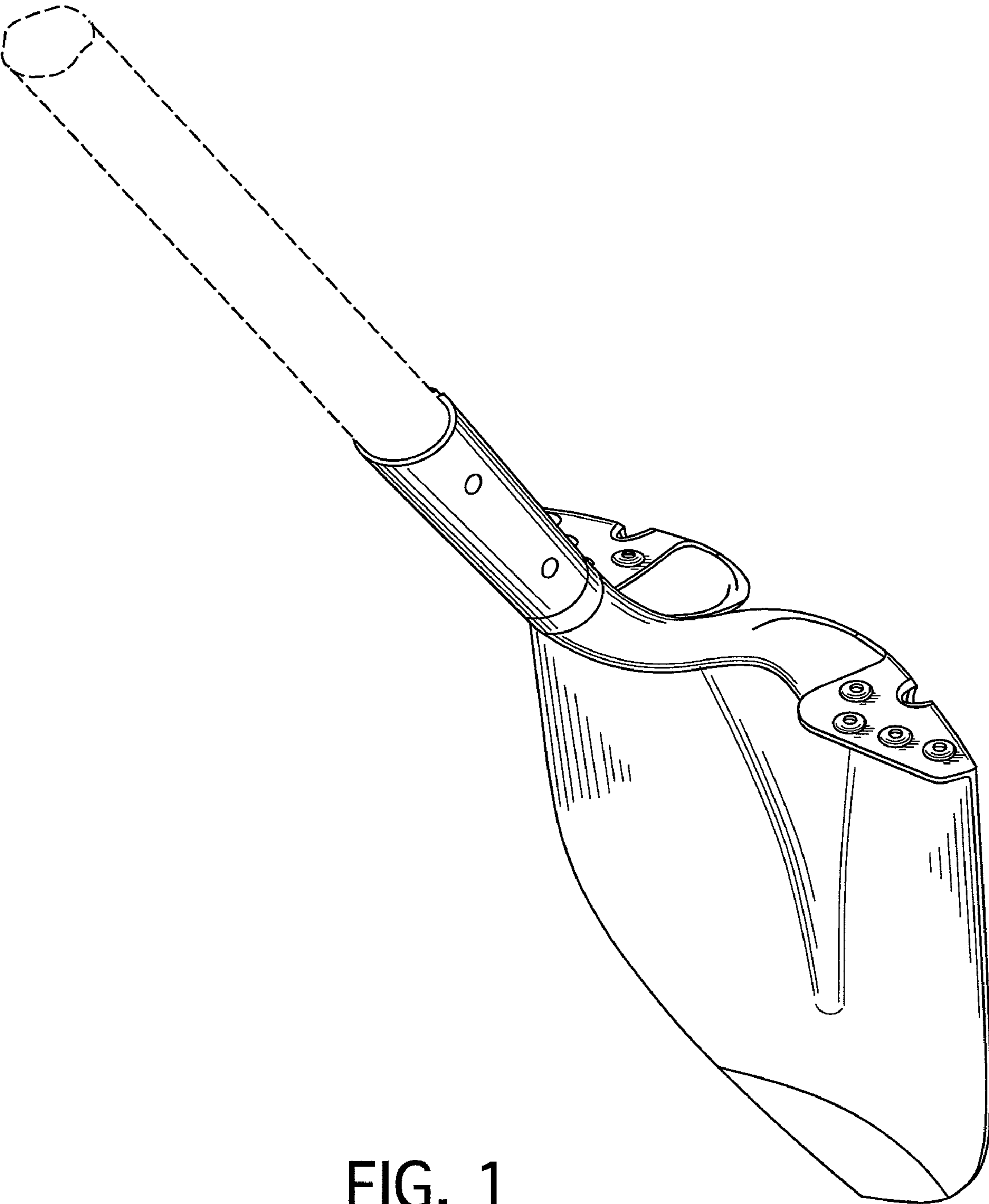

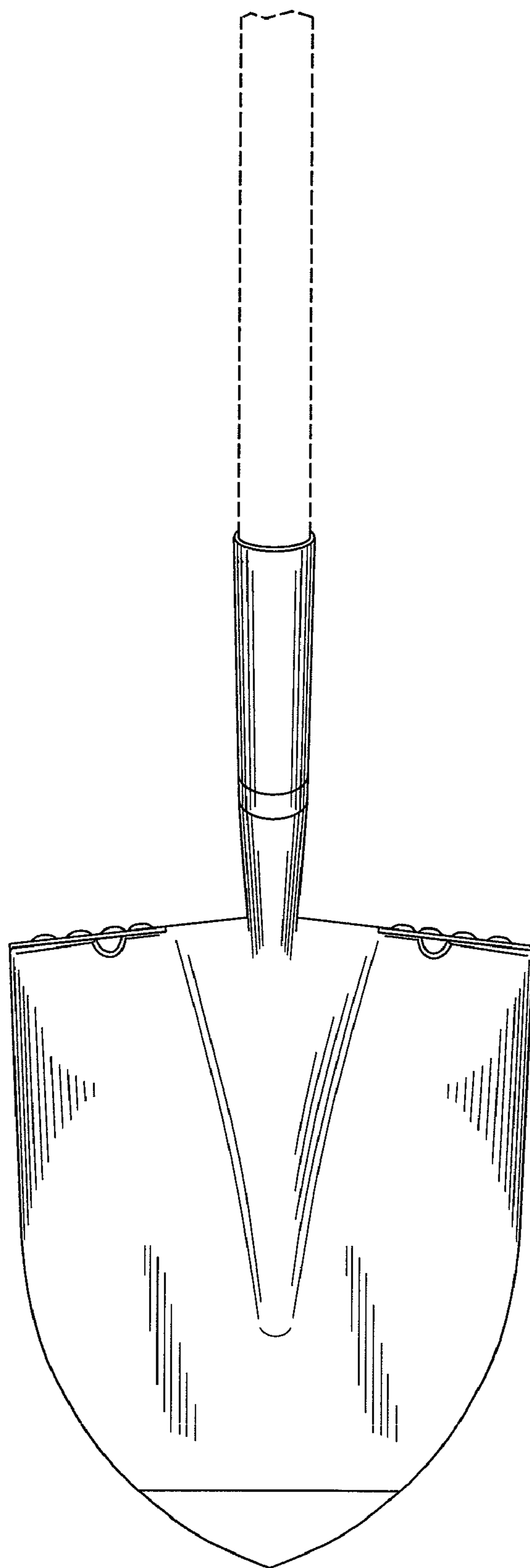

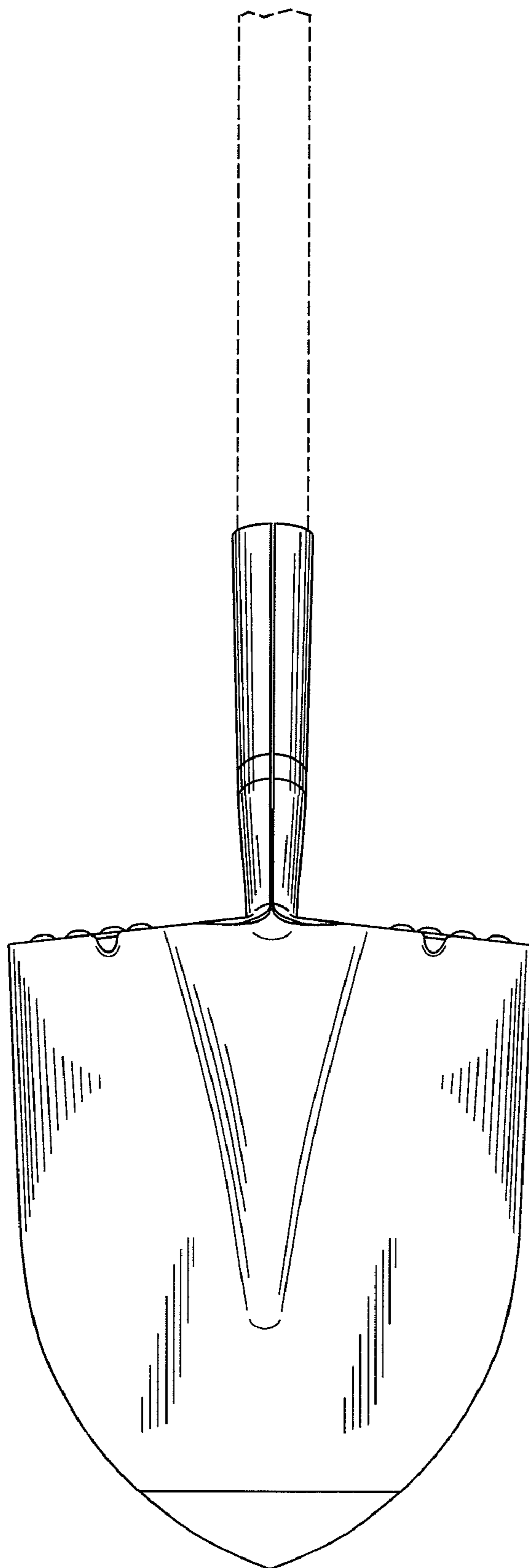

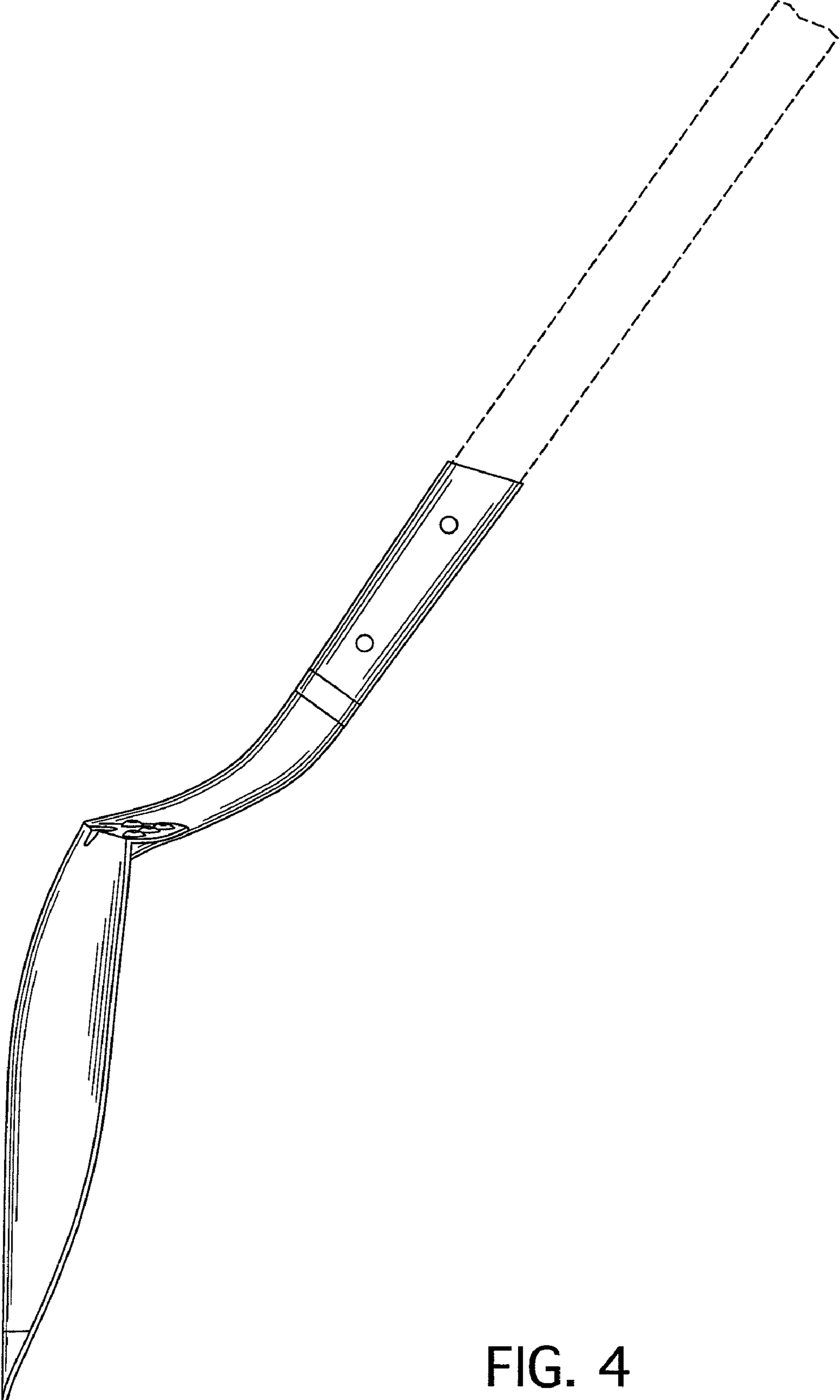

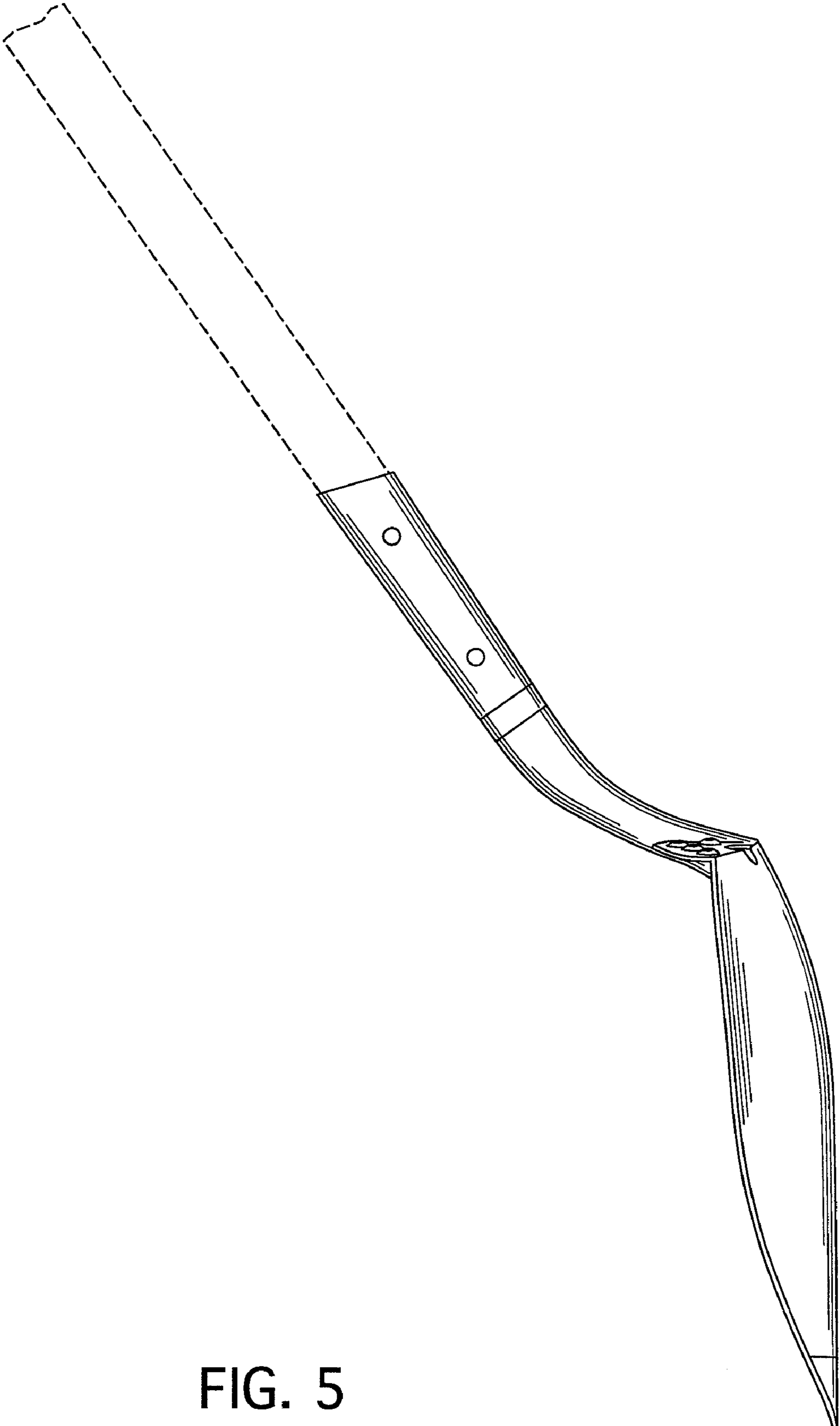

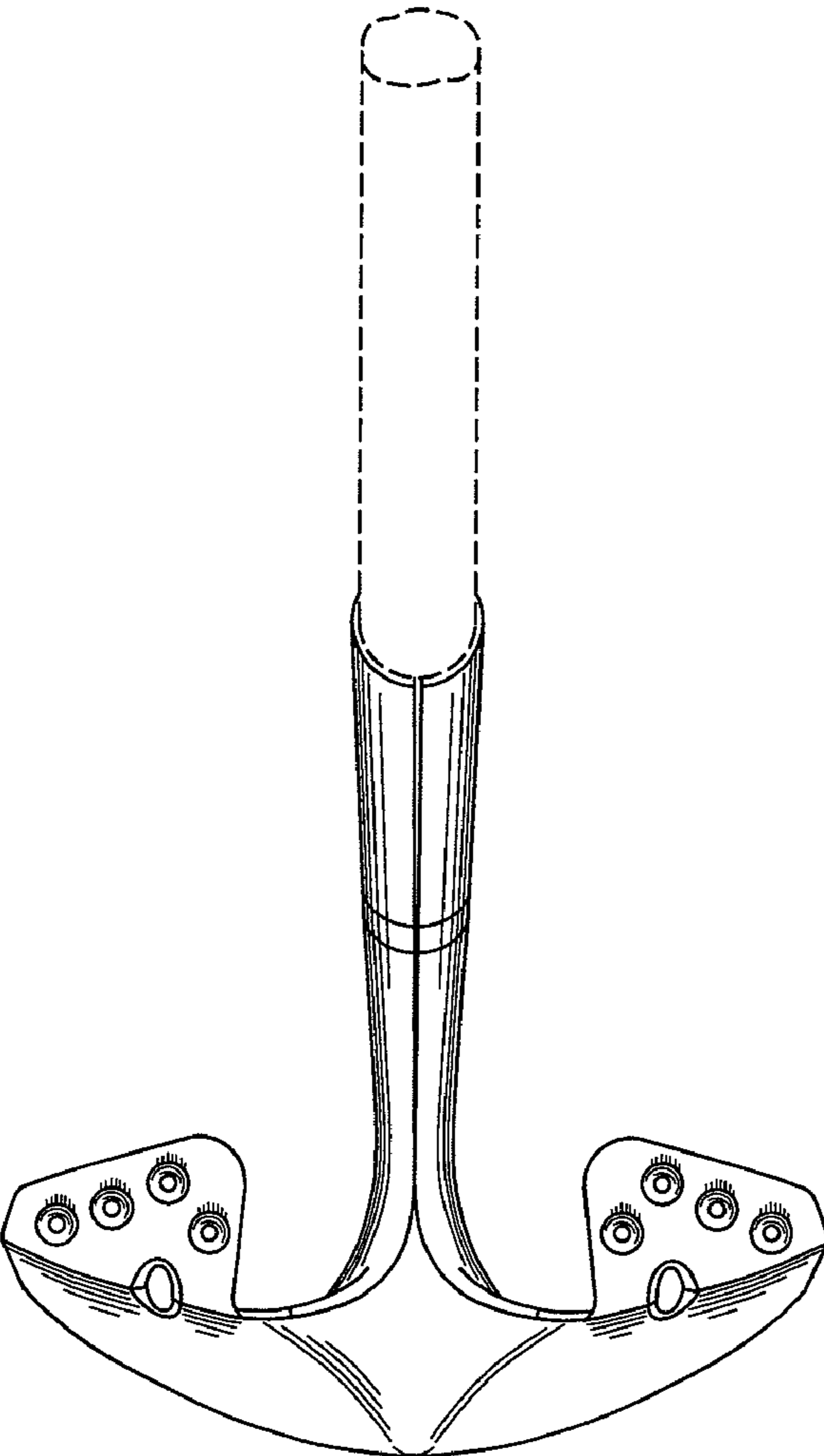

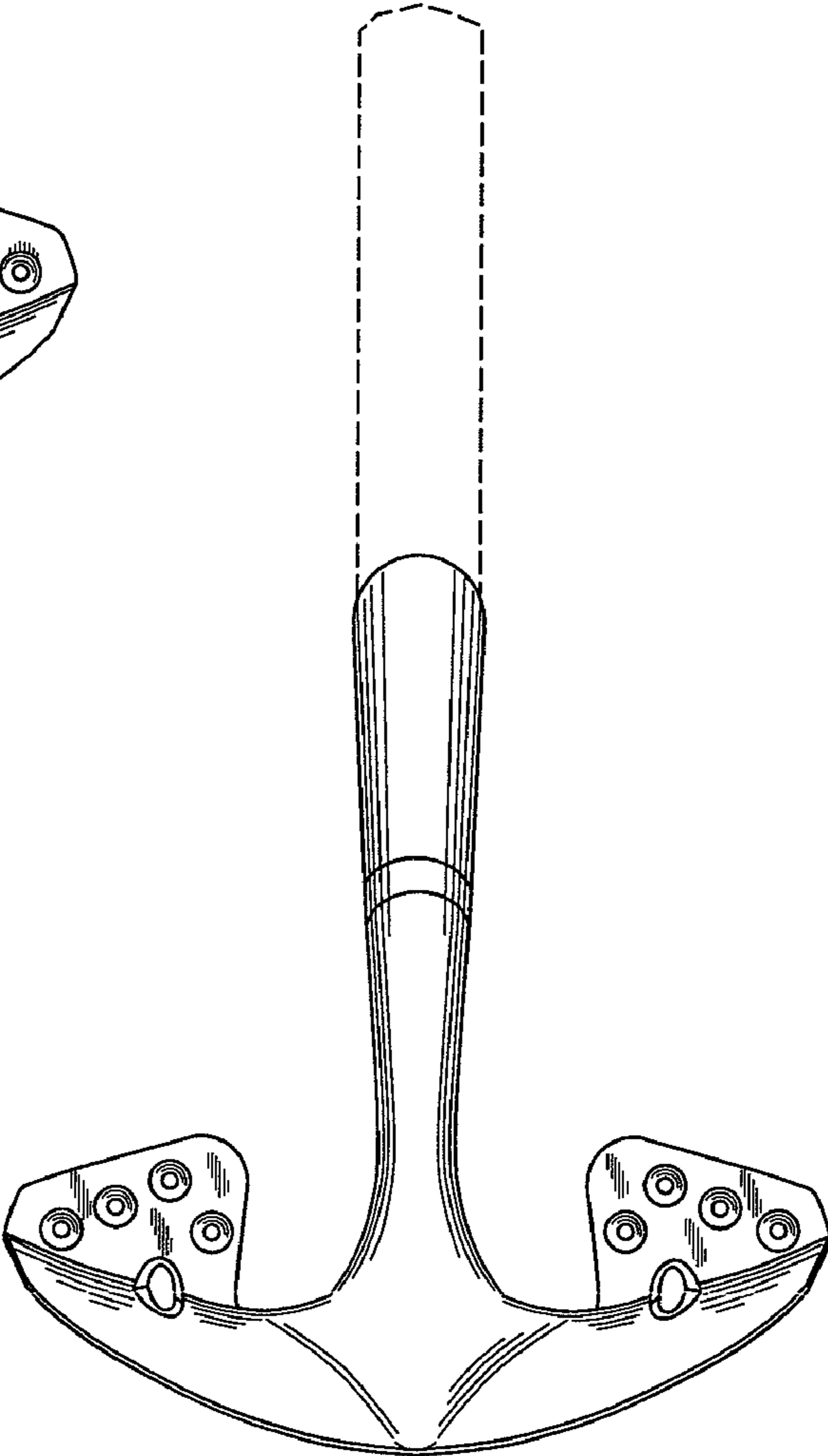
