**DESCRIPTION**

FIG. 1 is a perspective view of a coffee box cover showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

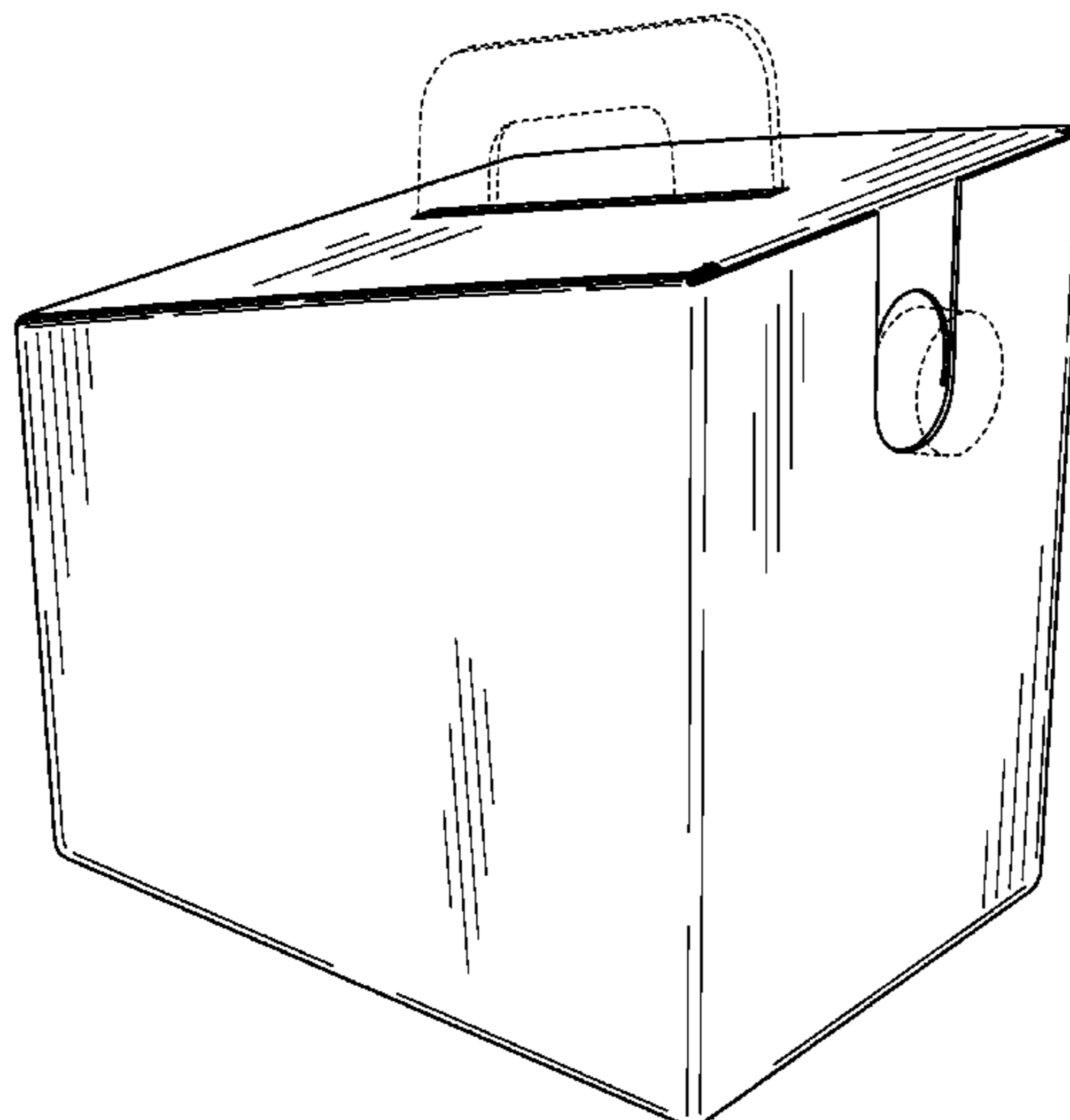
FIG. 4 is a right elevational view thereof, the left elevational view being a mirror image thereof;

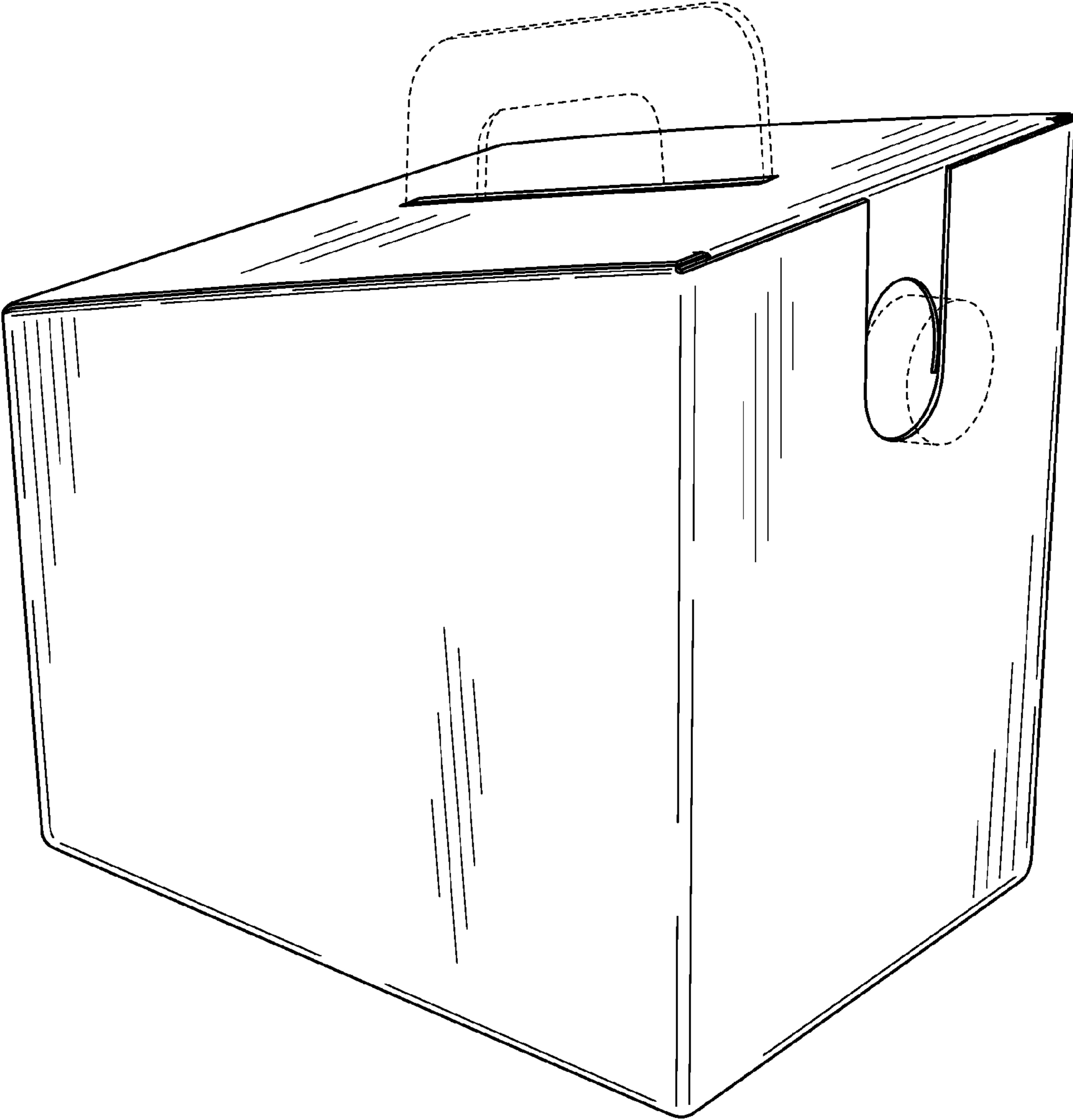

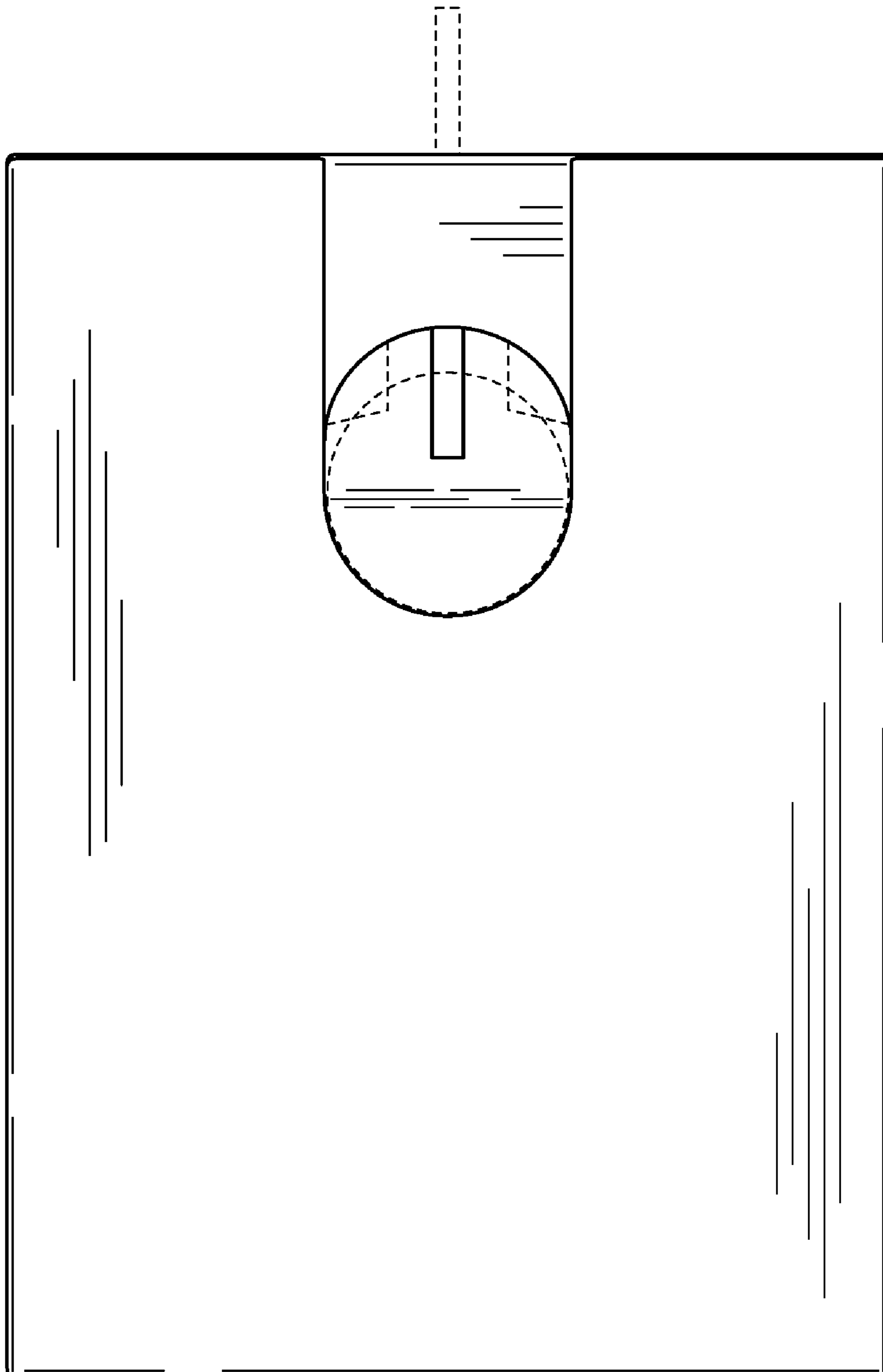

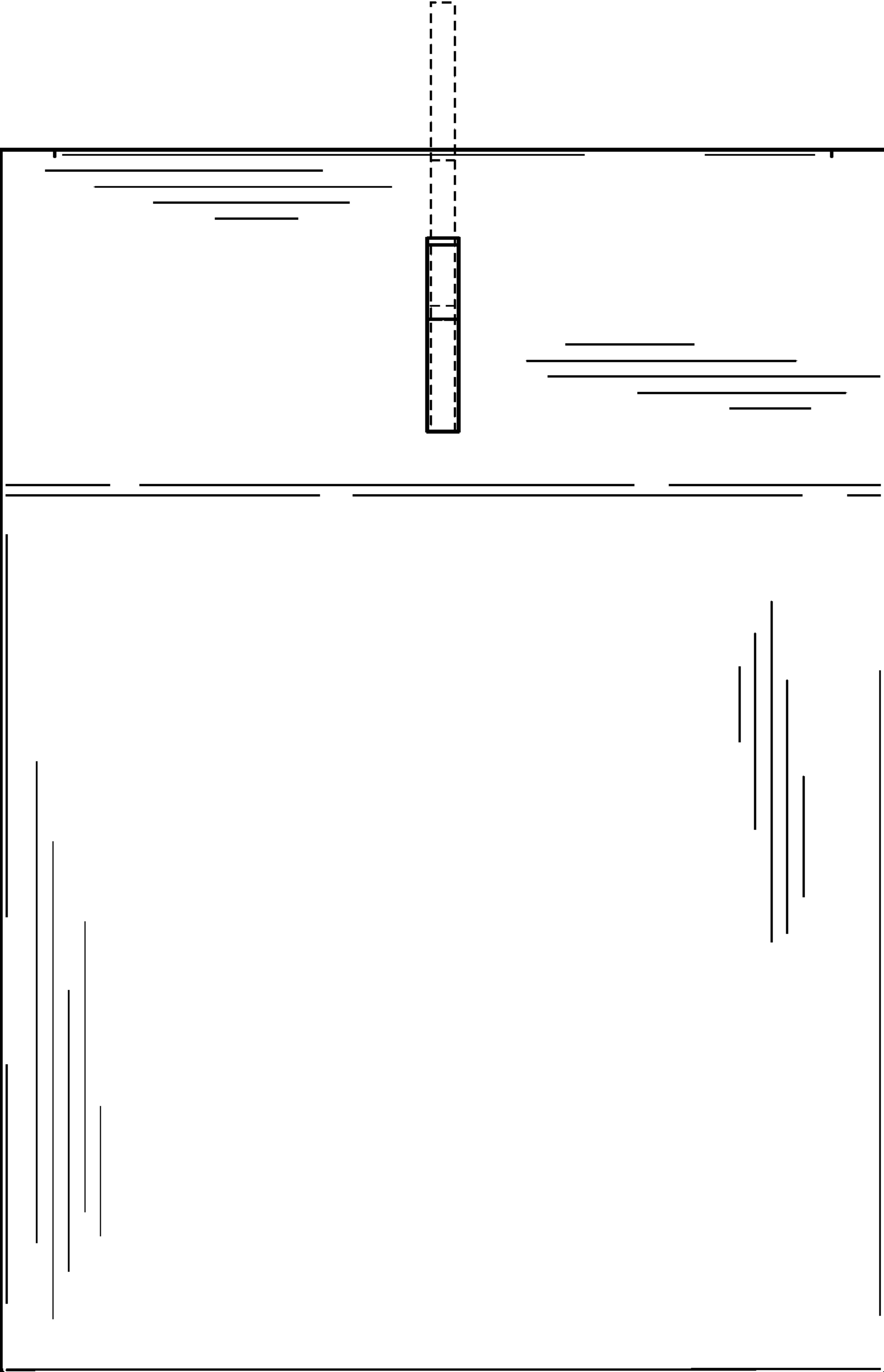

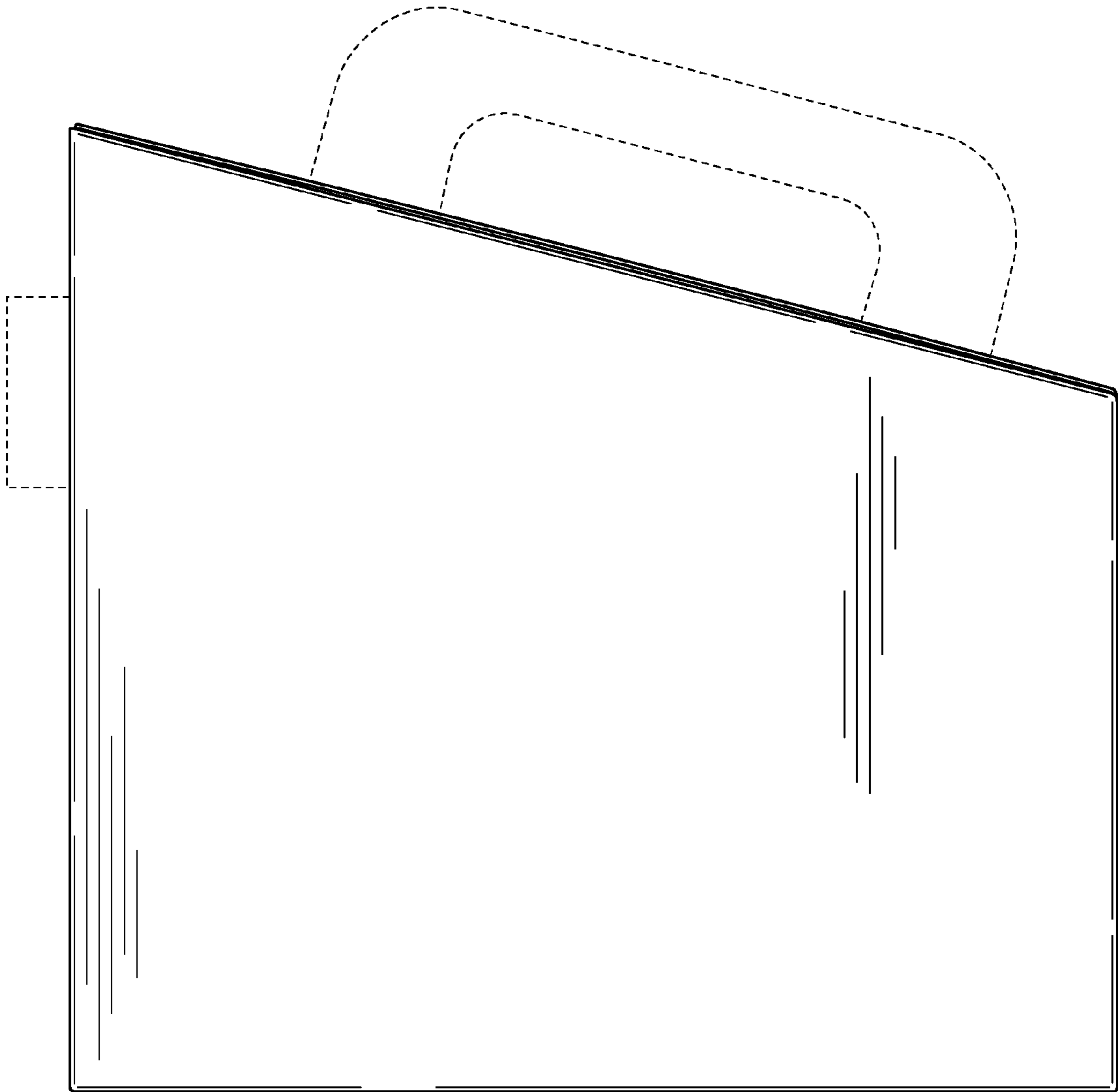

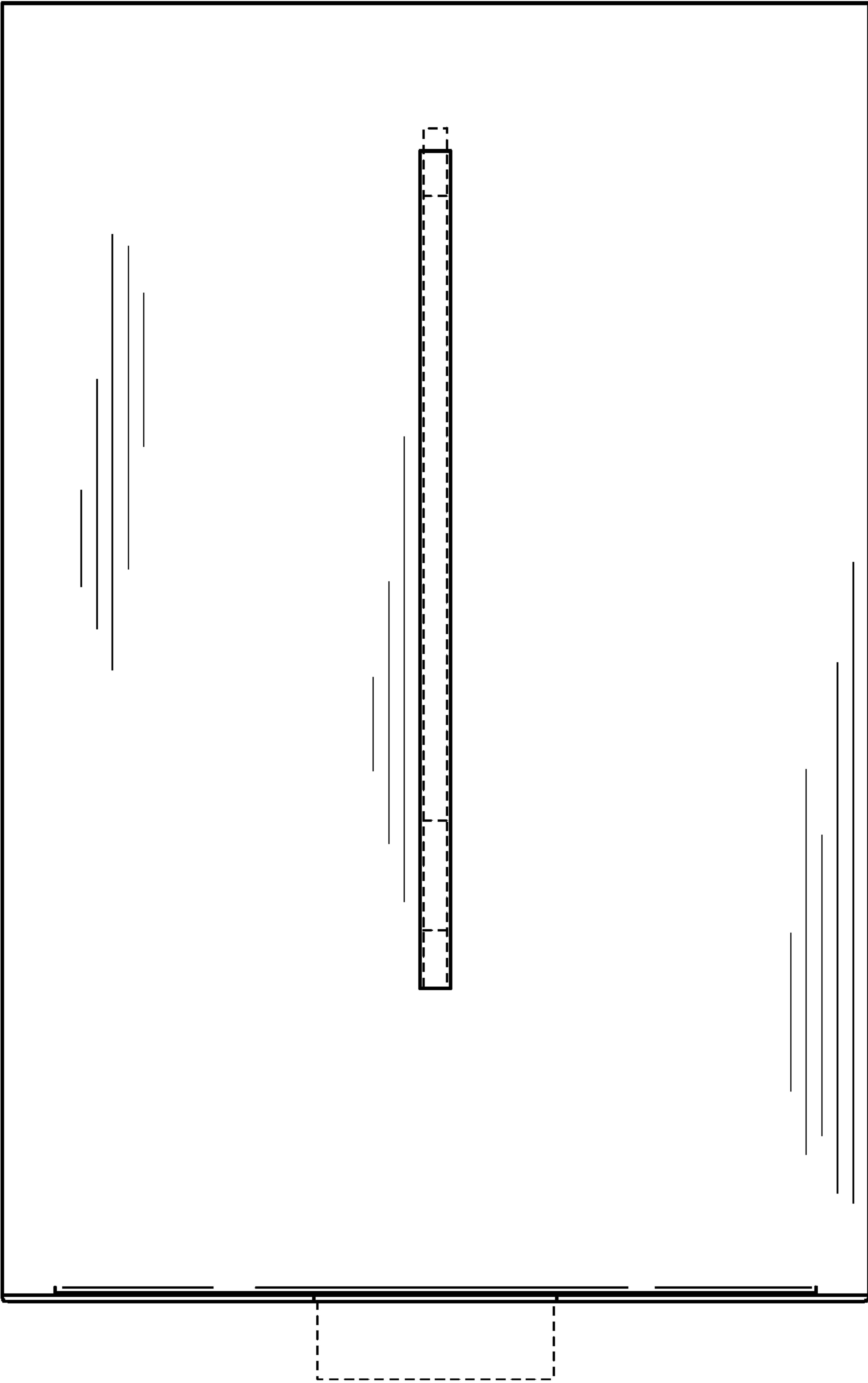

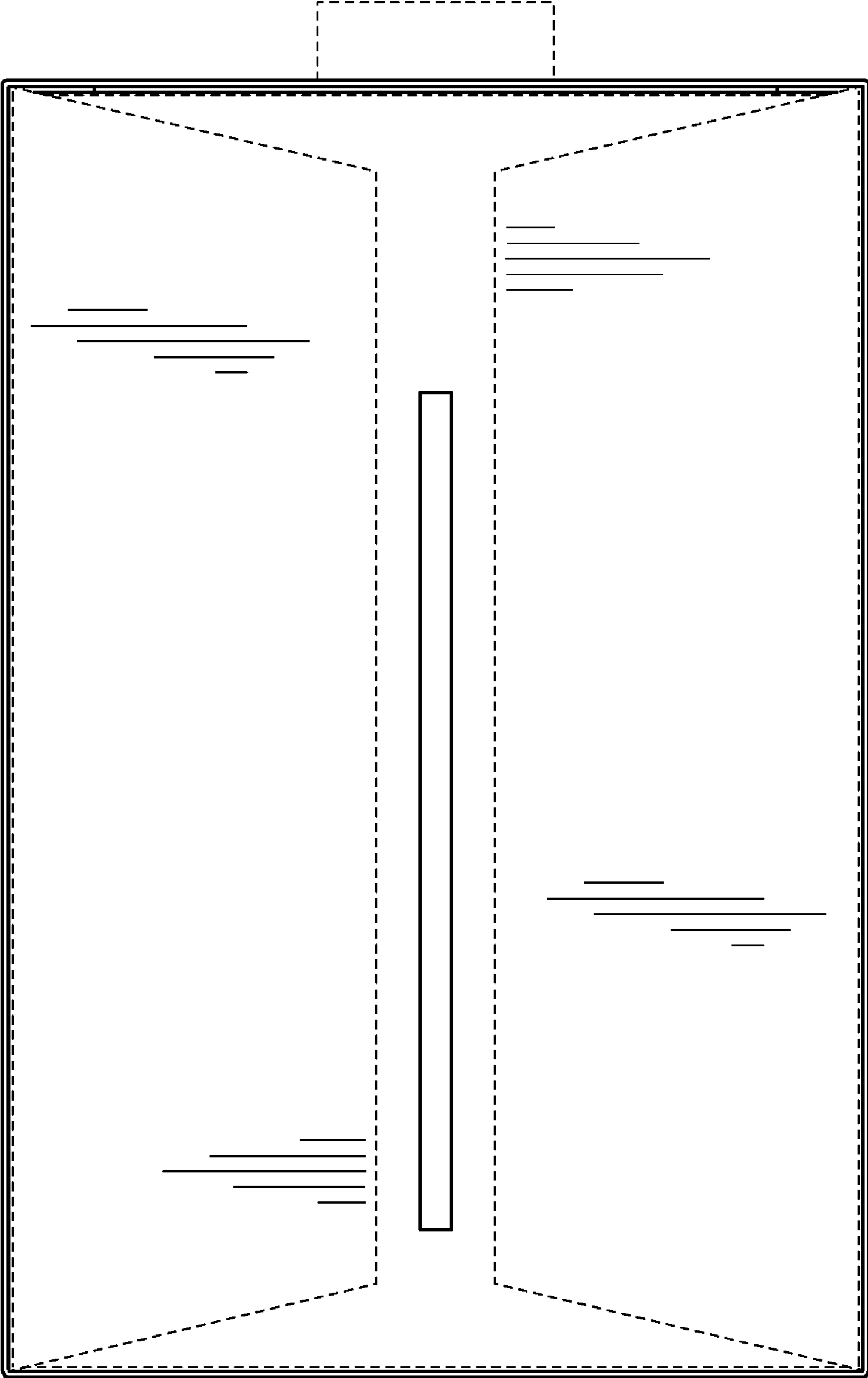
