DESCRIPTION

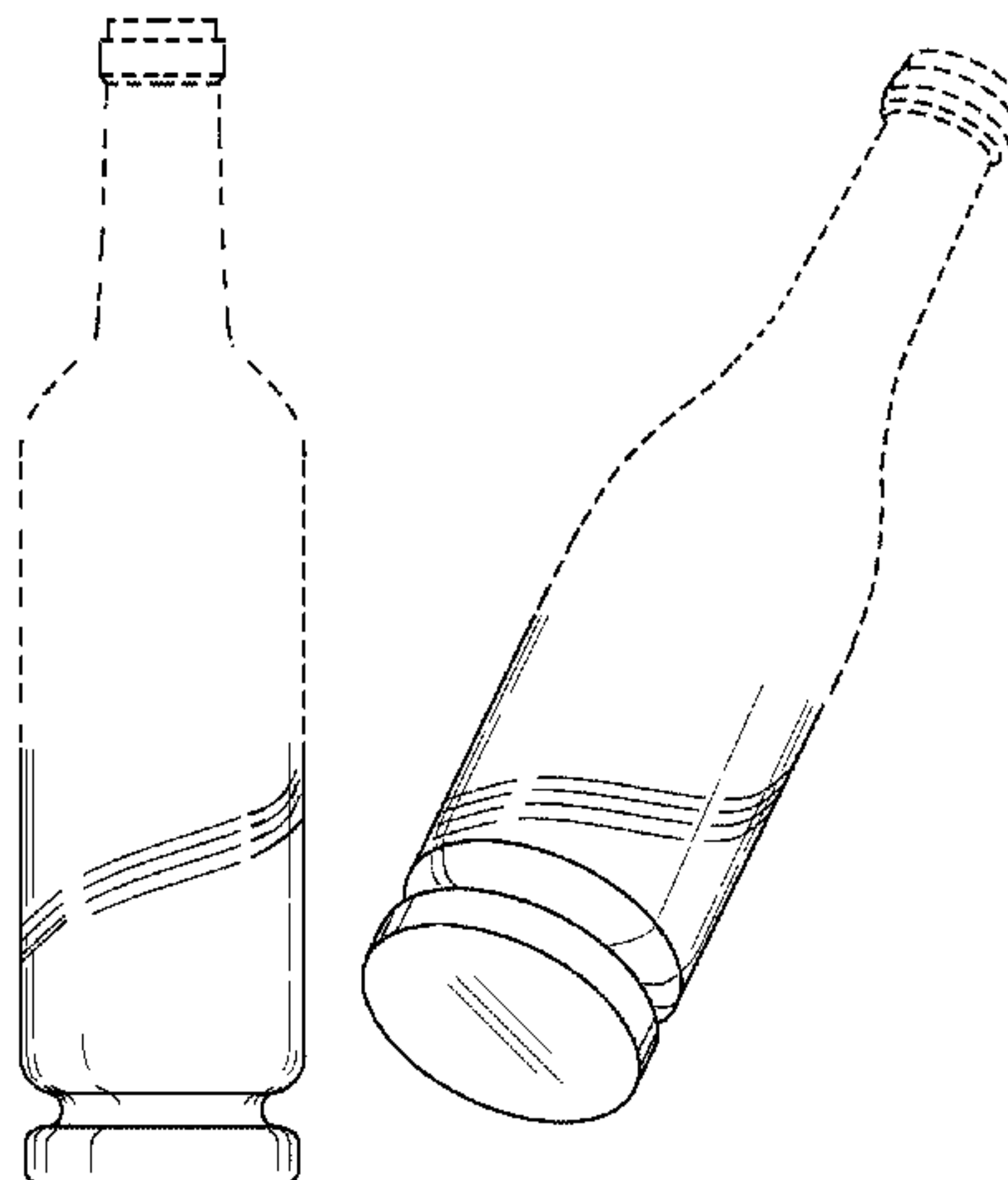
FIG. 1 is a front view of a wine bottle showing my new design; and,

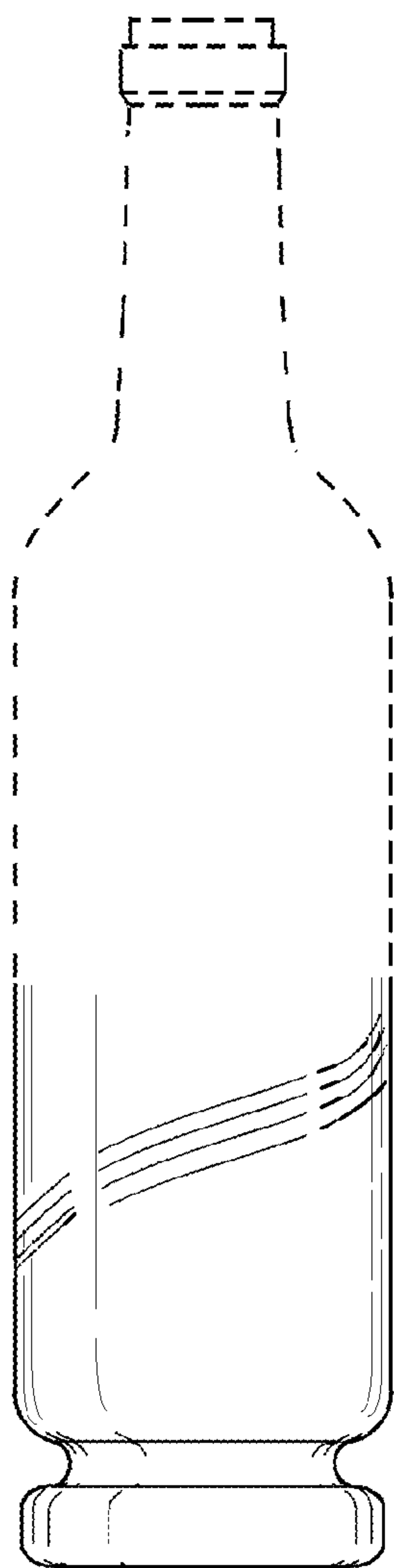

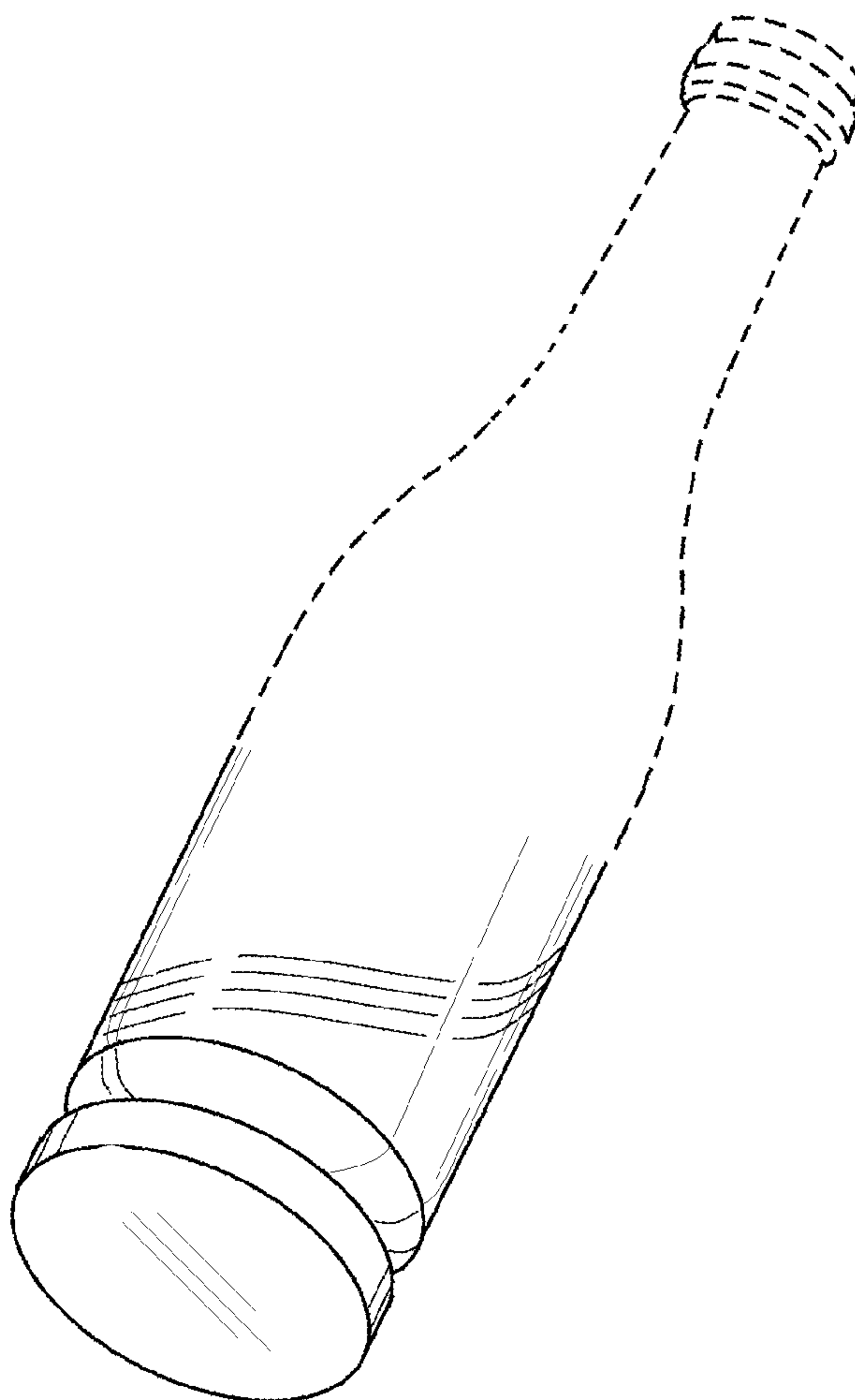
