DESCRIPTION

FIG. 7 is a front view of the bottle including a cap;

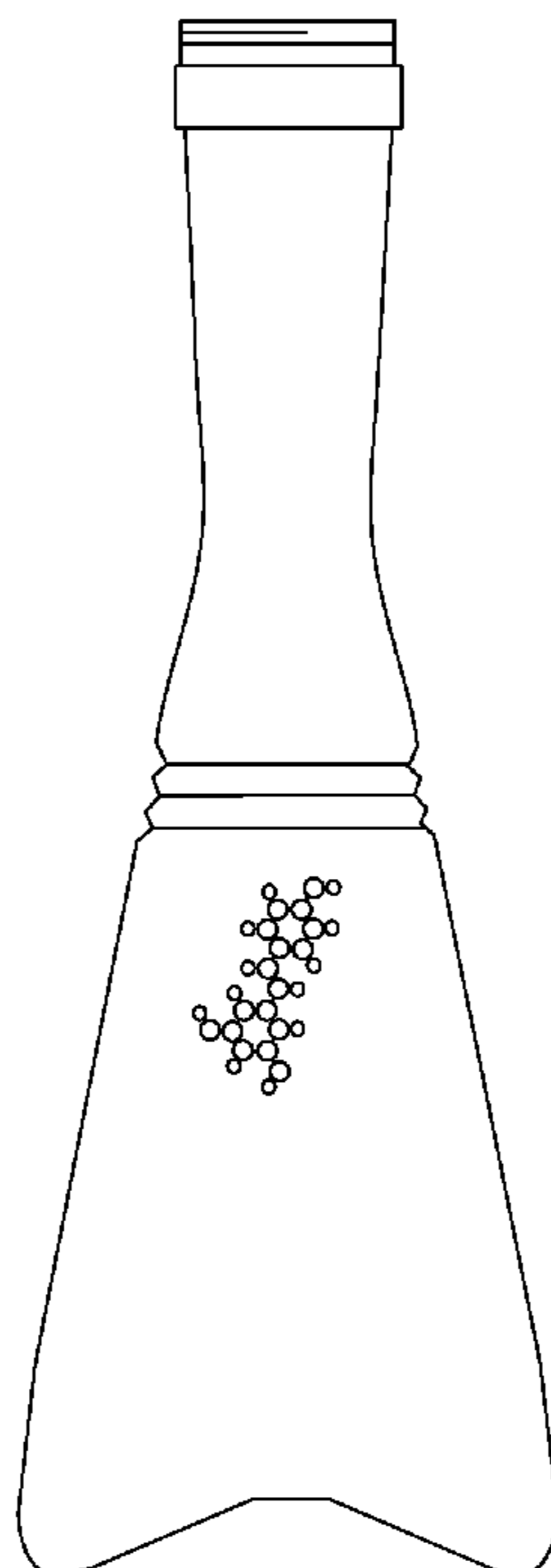
FIG. 8 is a rear view of the bottle in FIG. 7;

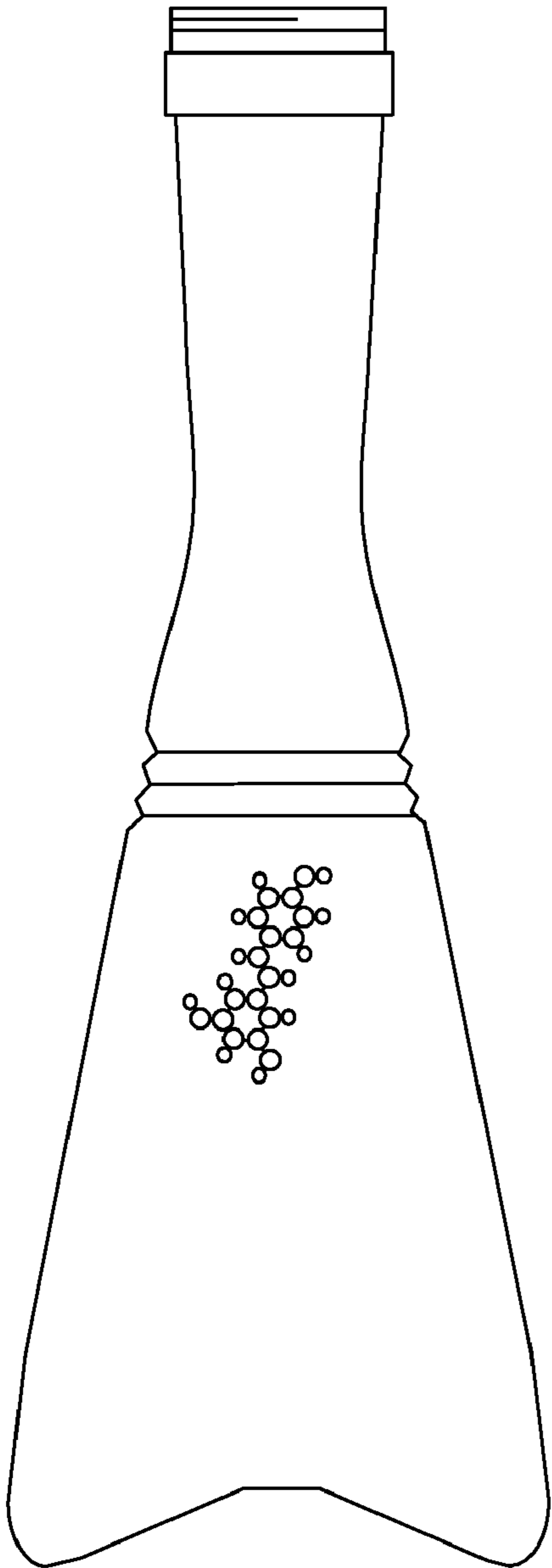

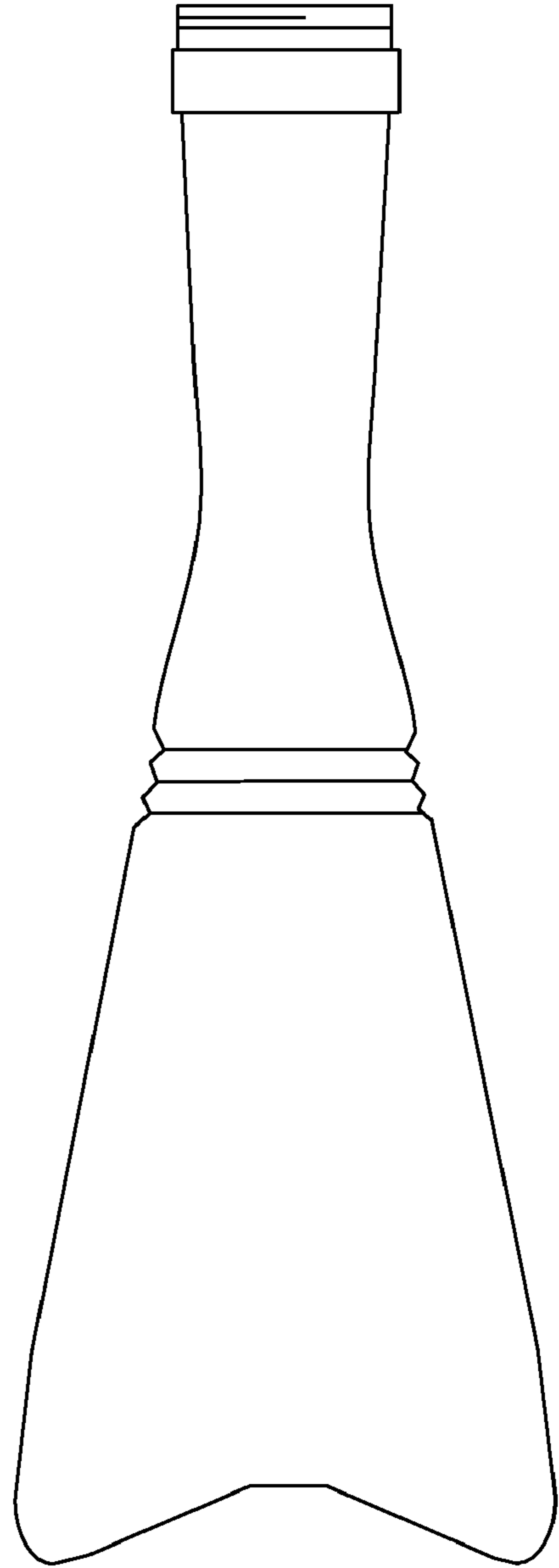

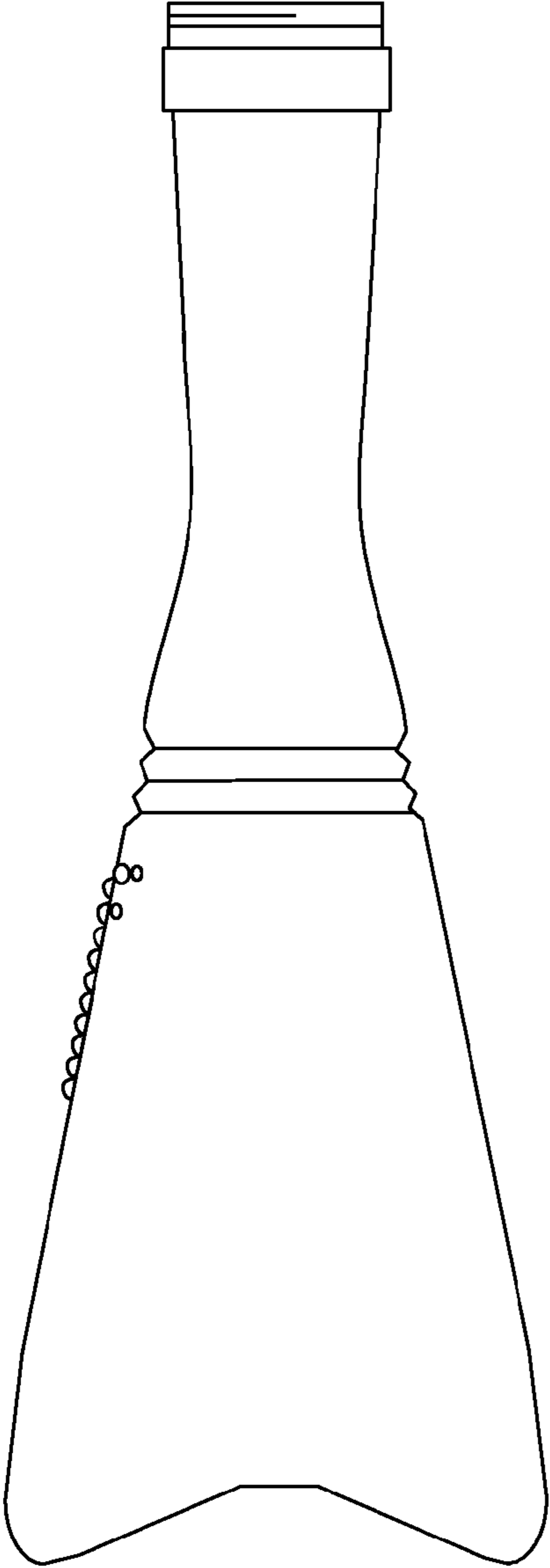

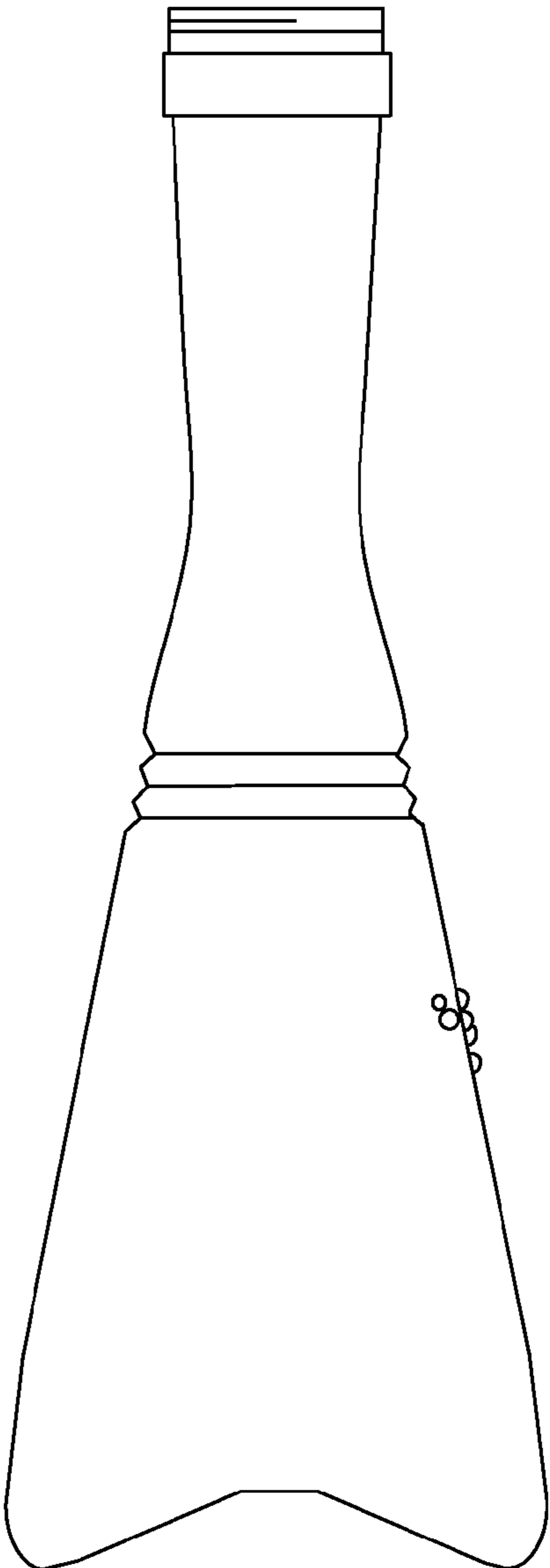

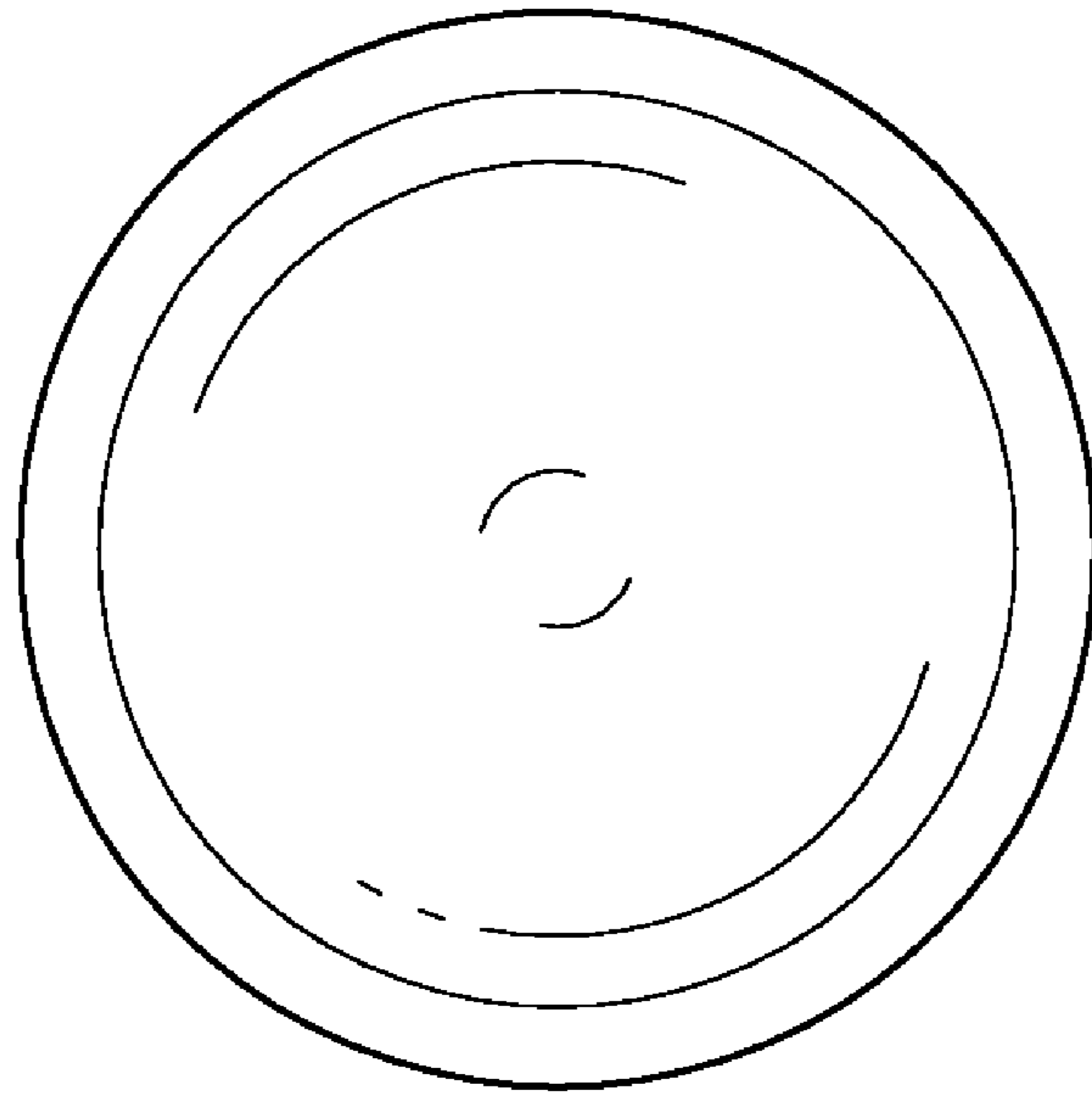

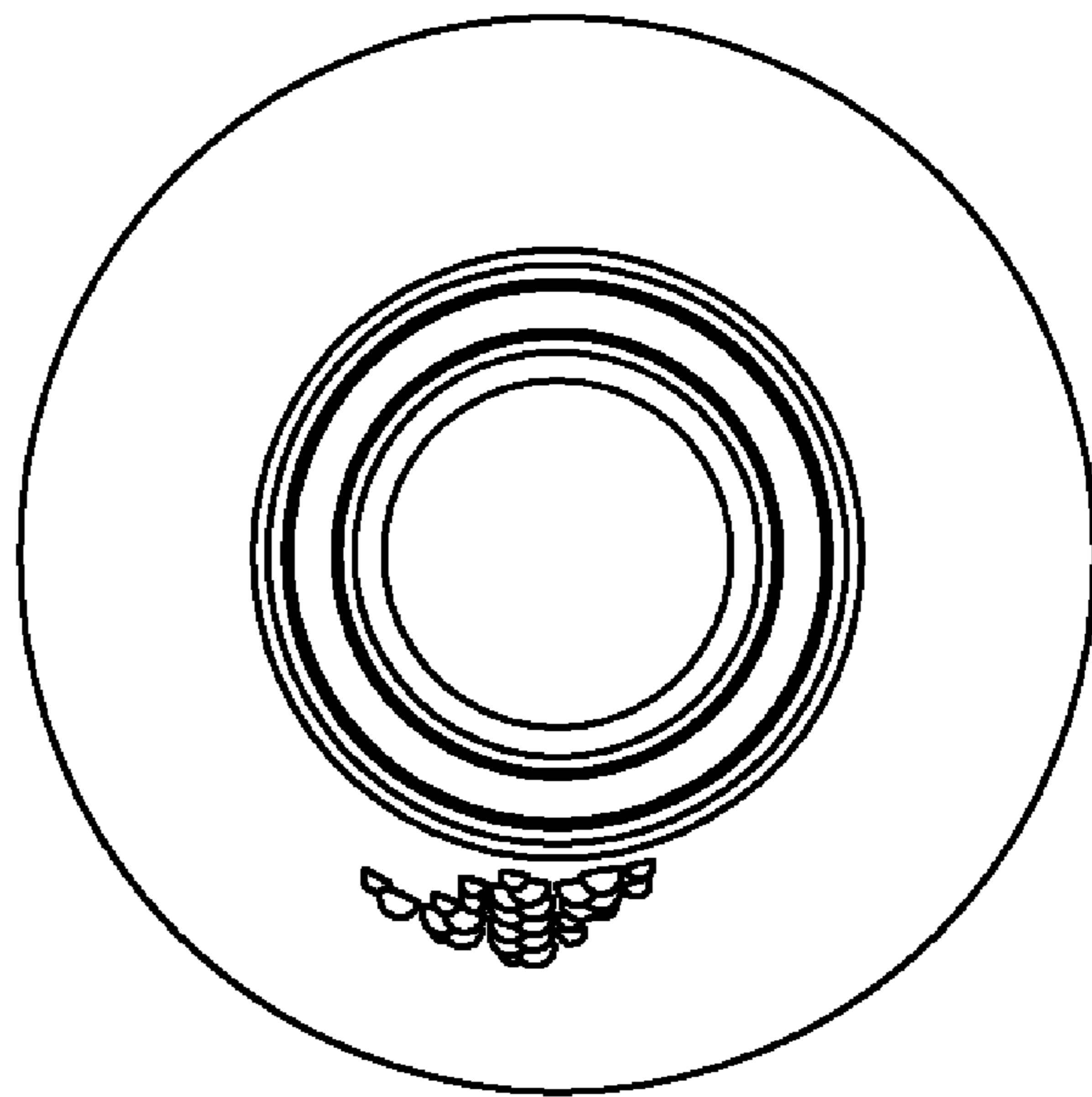

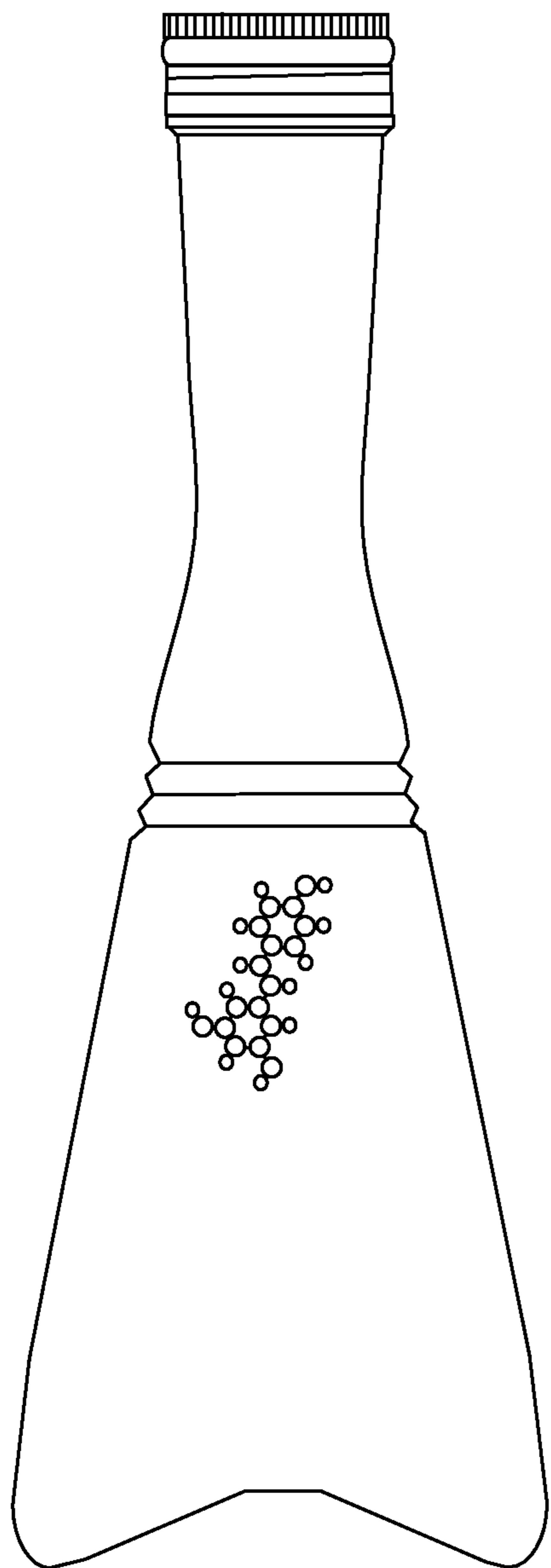

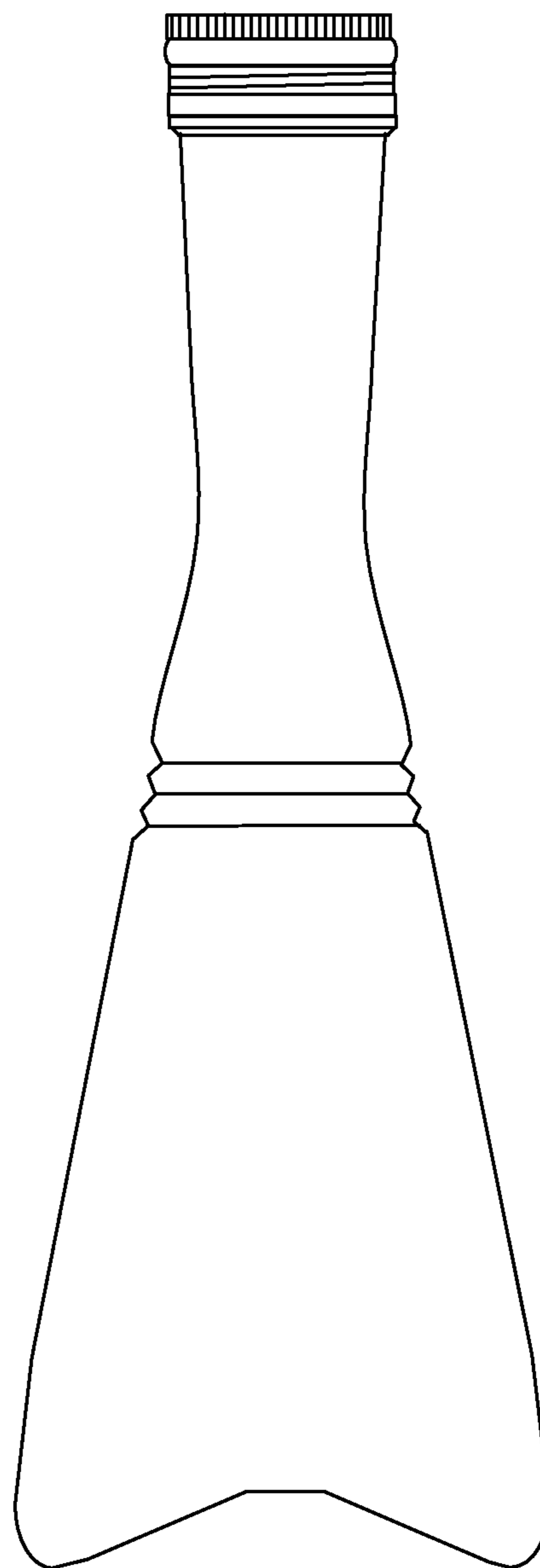

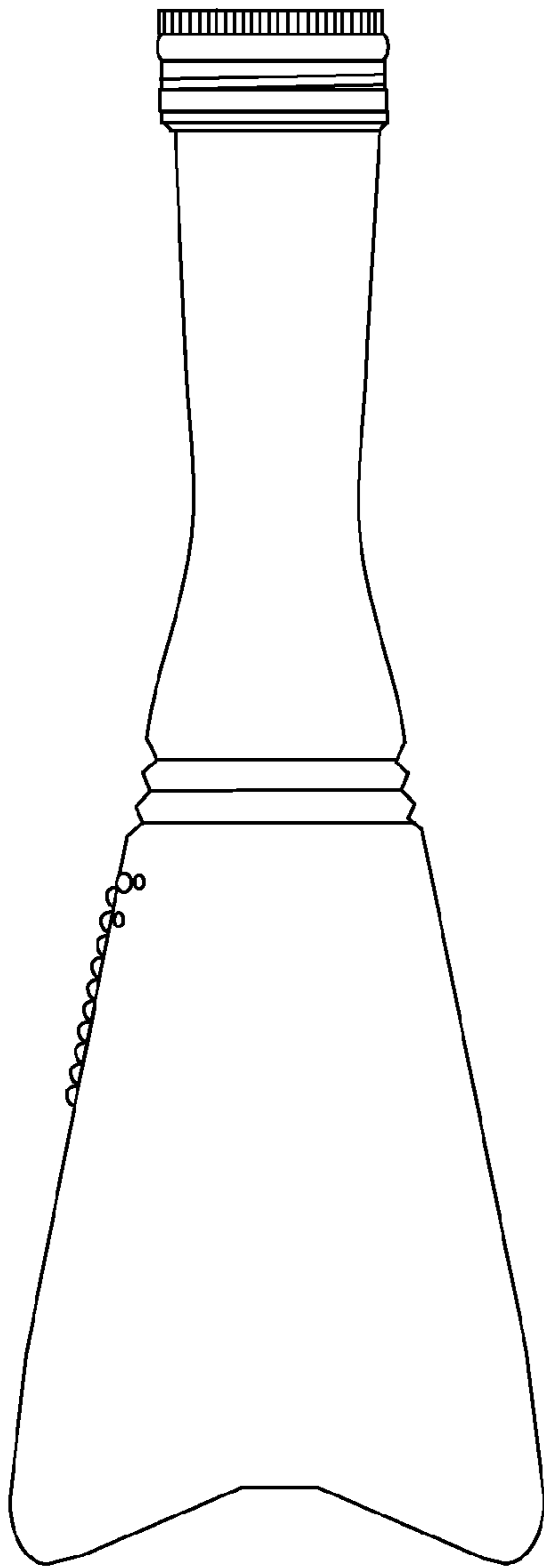

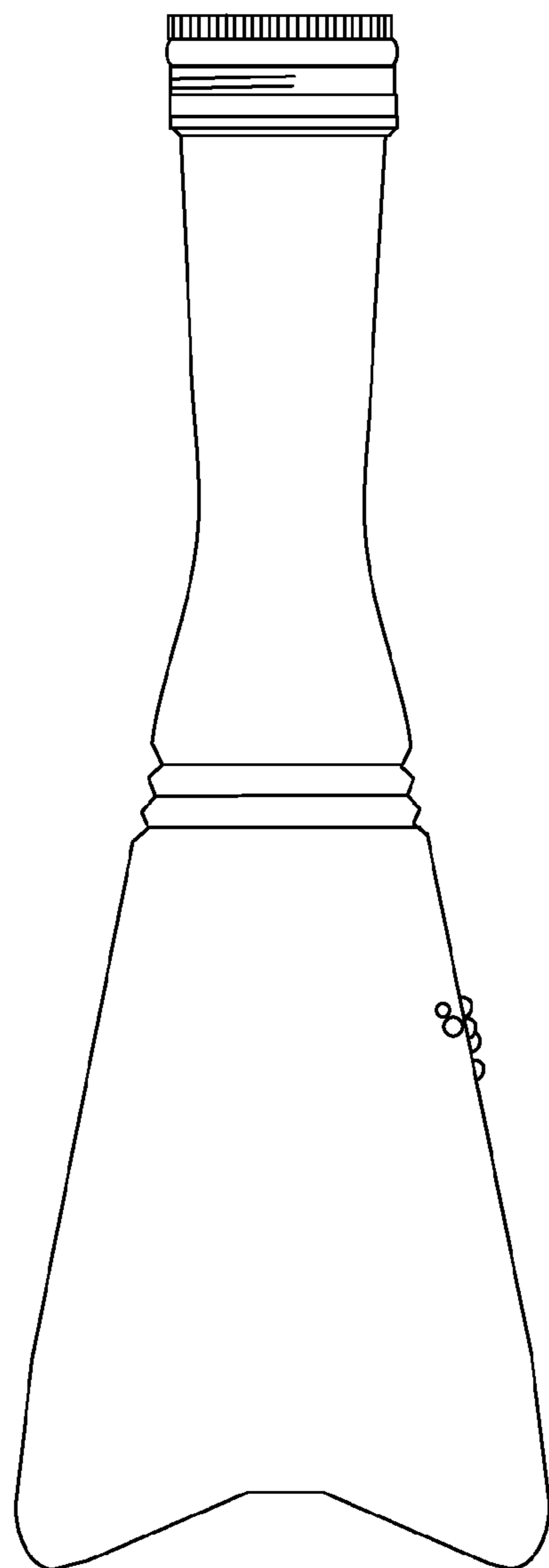

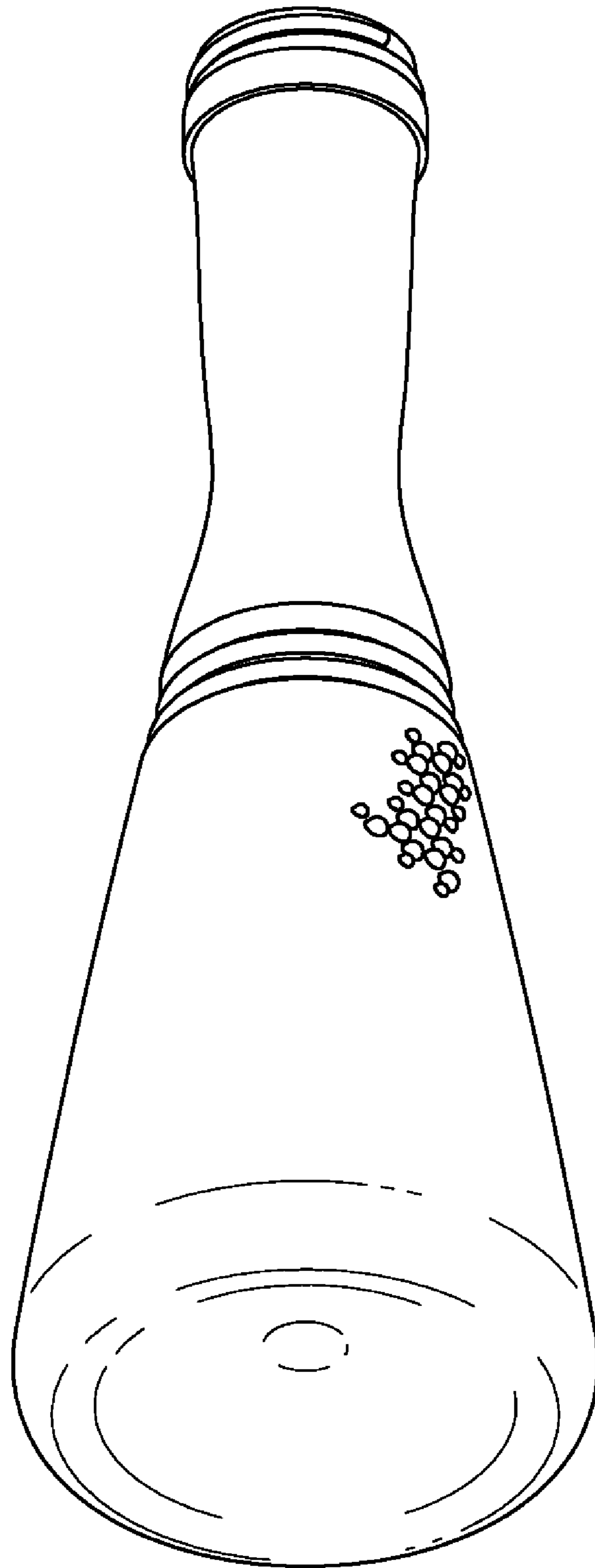
