The ornamental design for an aircraft, as shown and described.

DESCRIPTION

FIG. 6 is a front elevation view thereof;

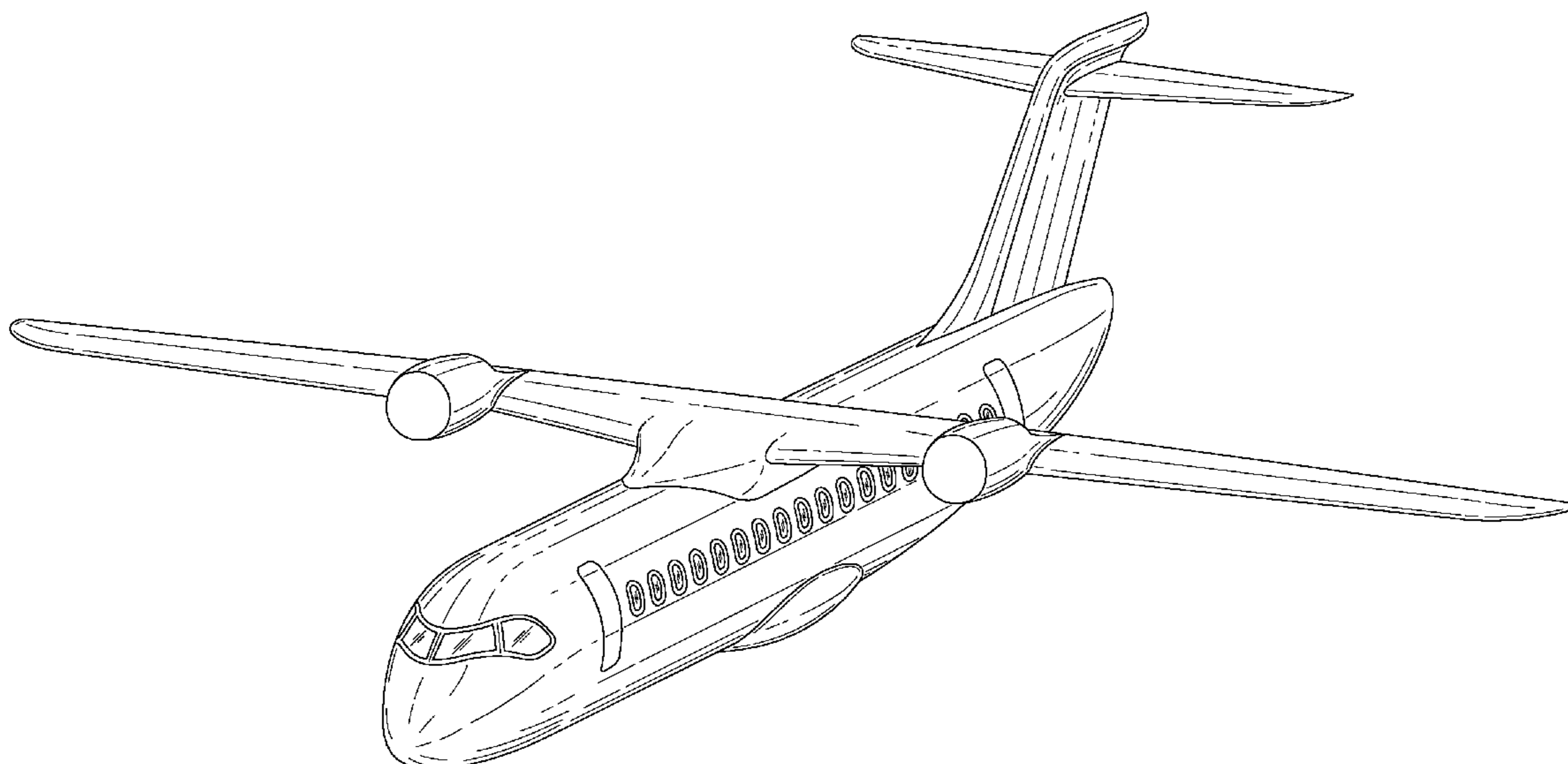
FIG. 7 is a rear elevation view thereof;

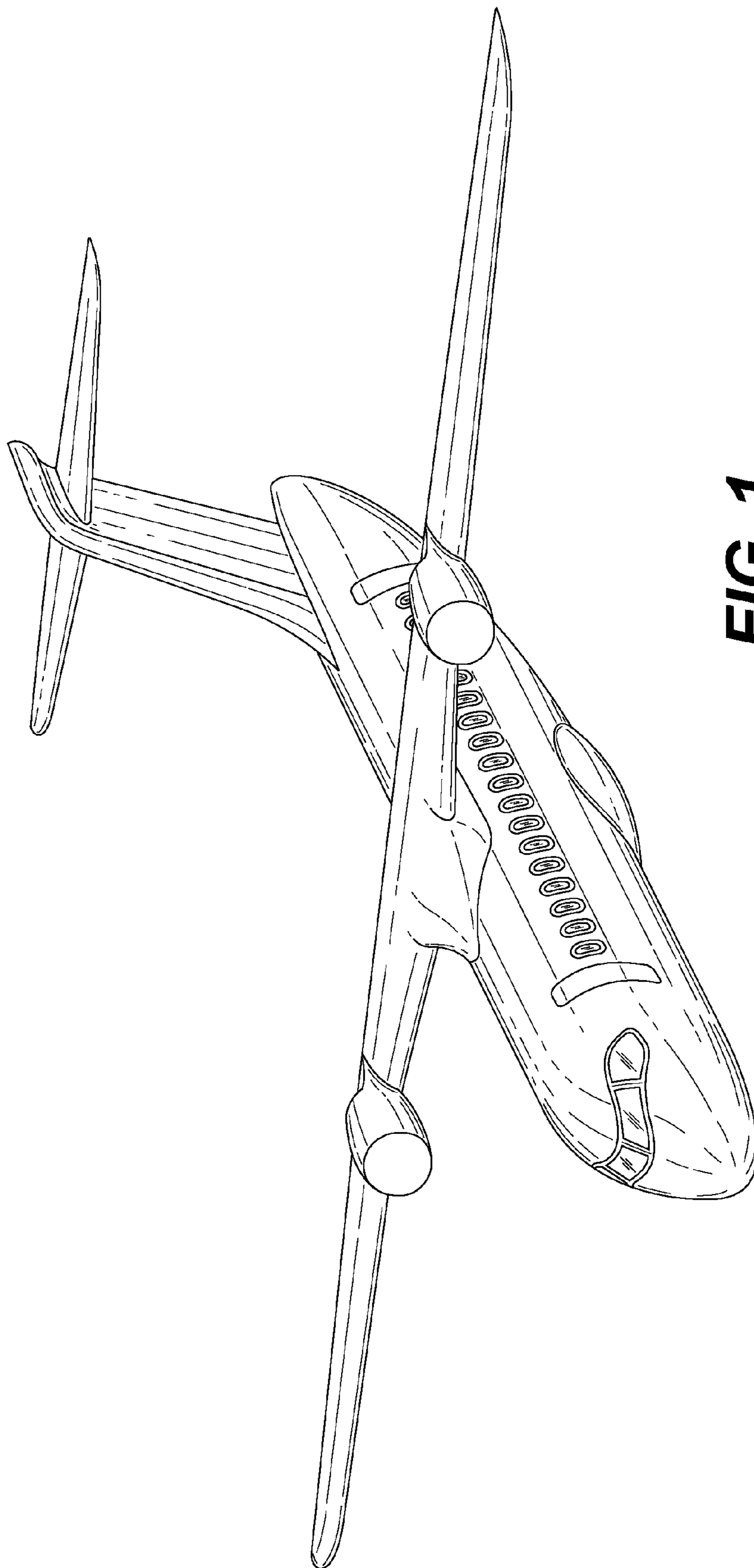

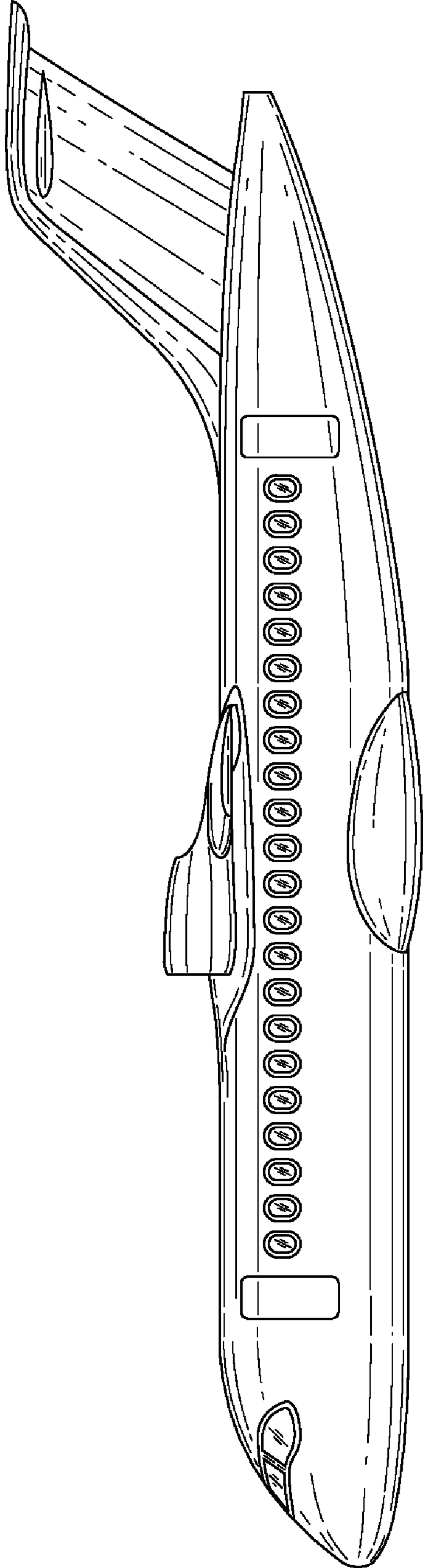

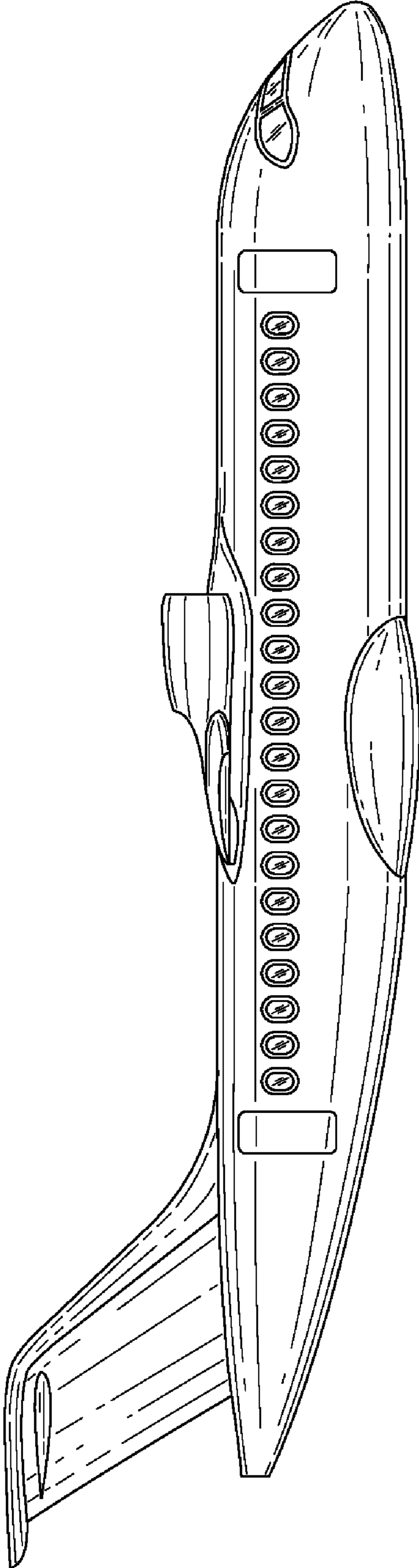

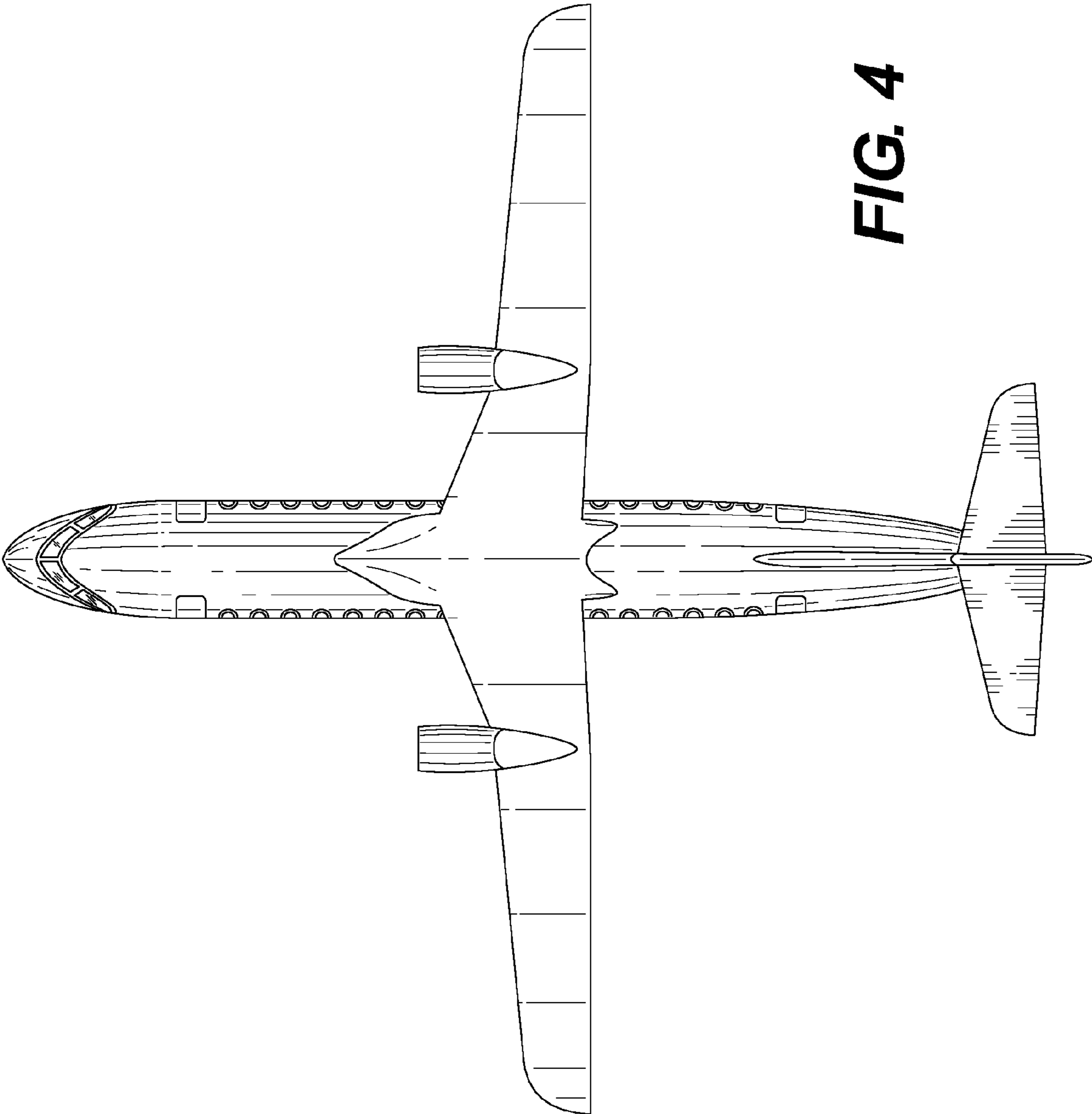

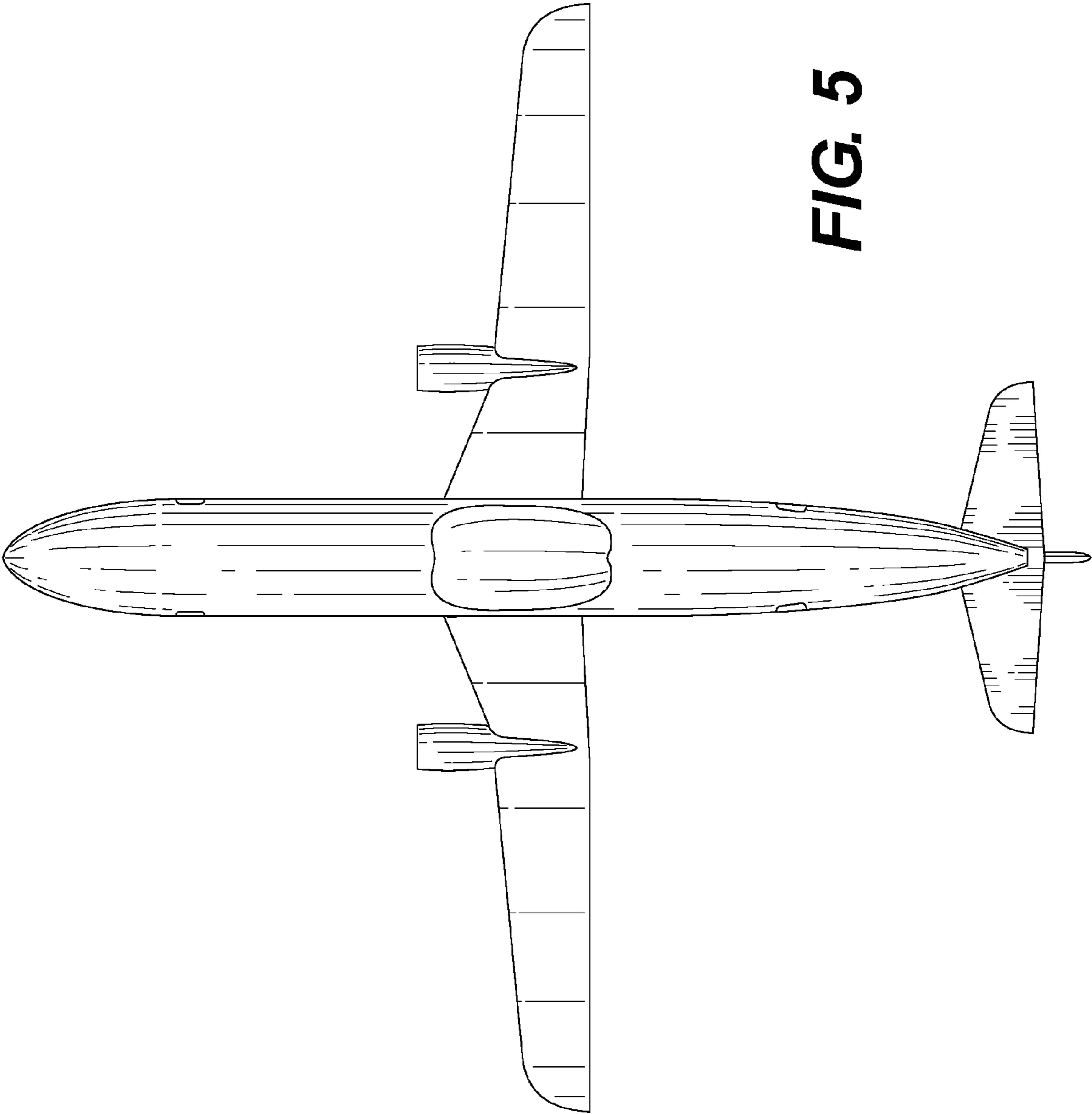

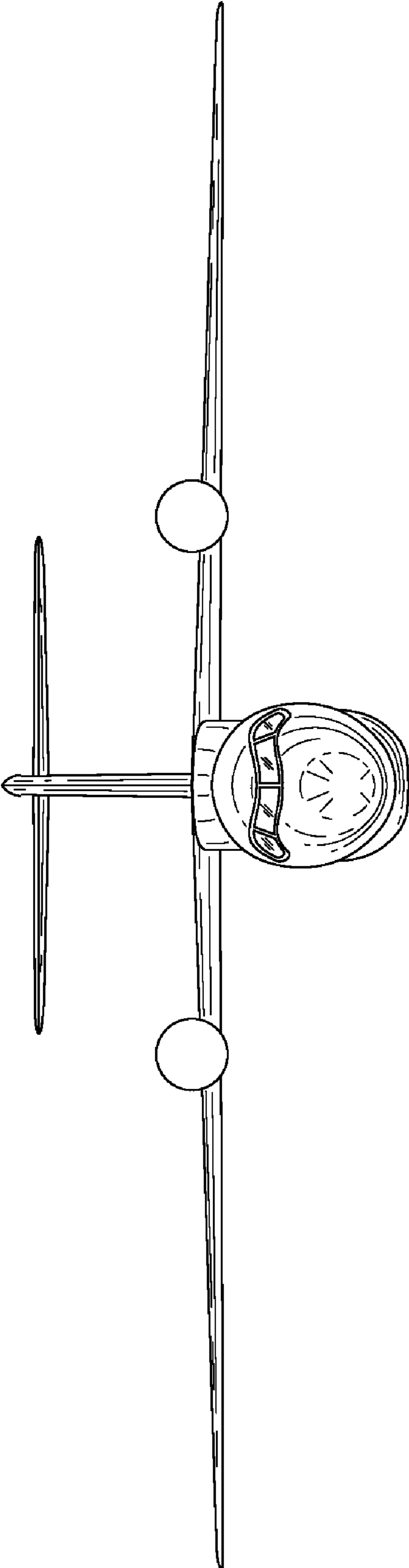

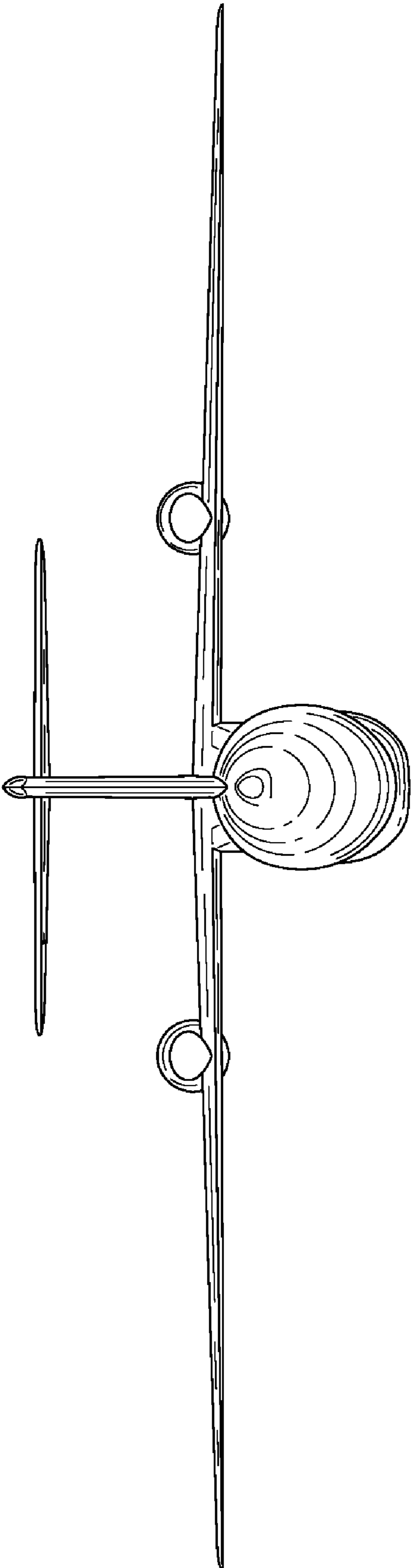

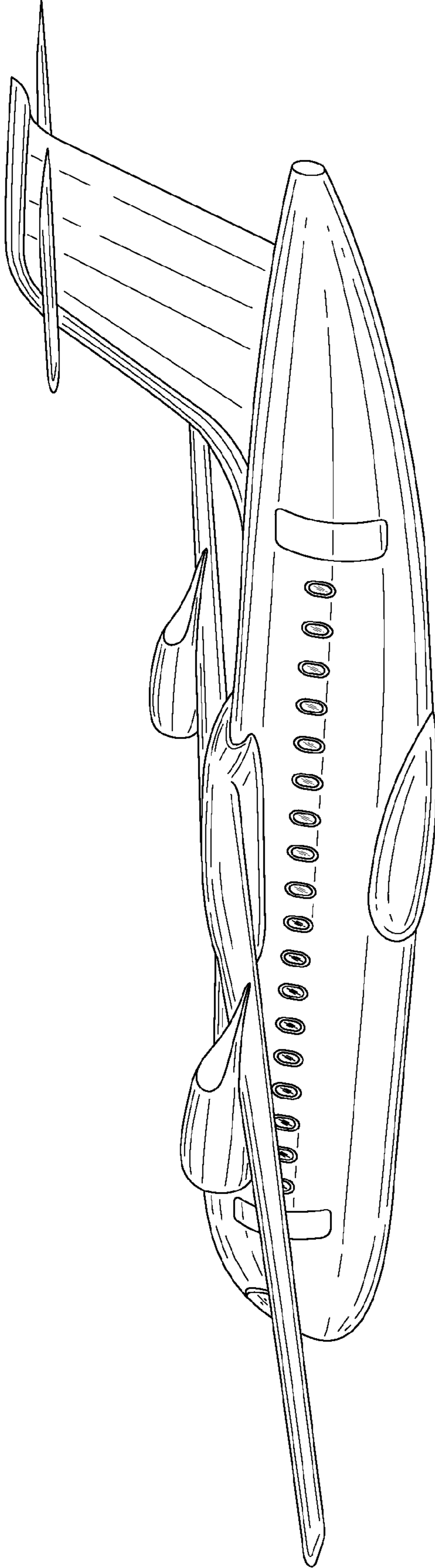

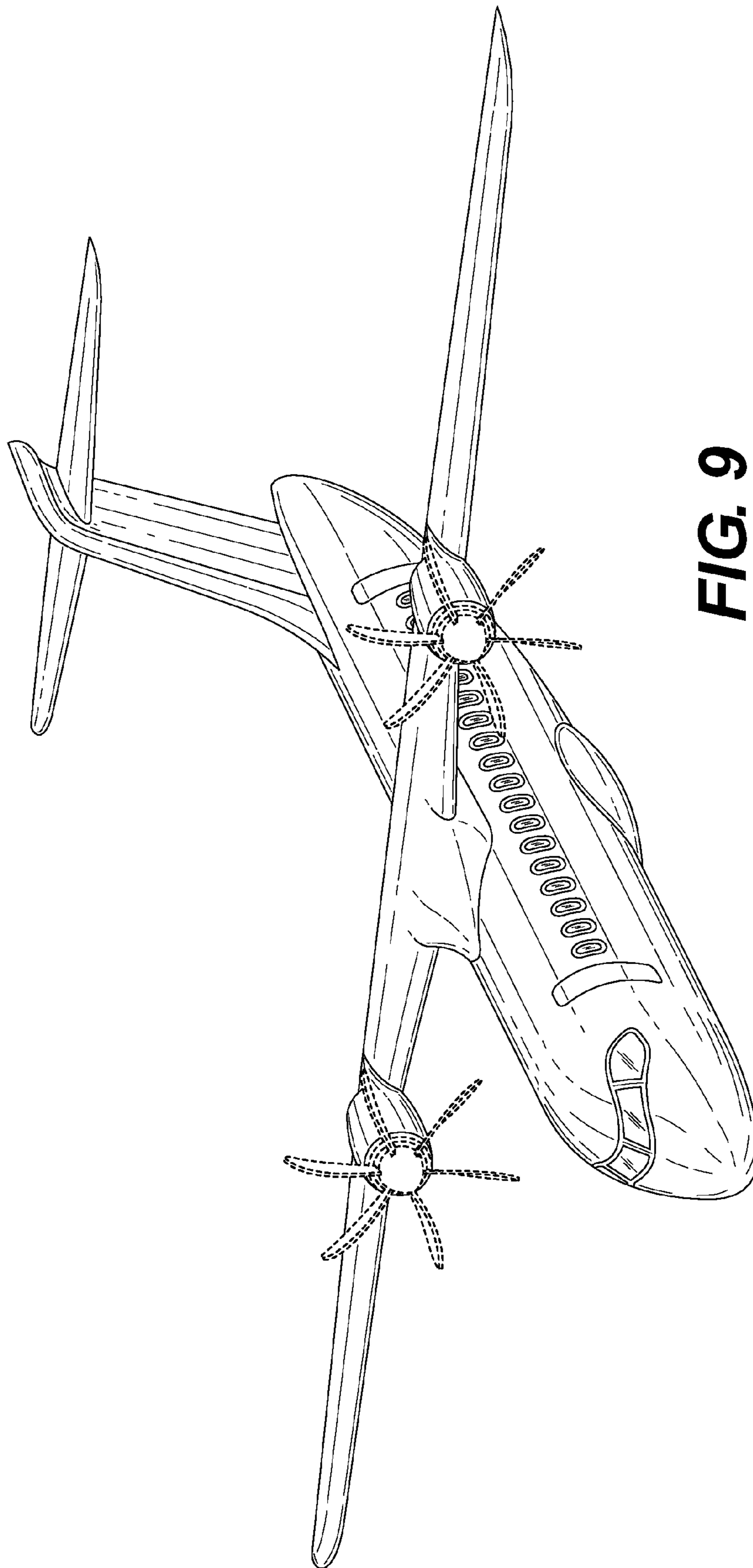
