FIG. 18 is a left side view thereof;

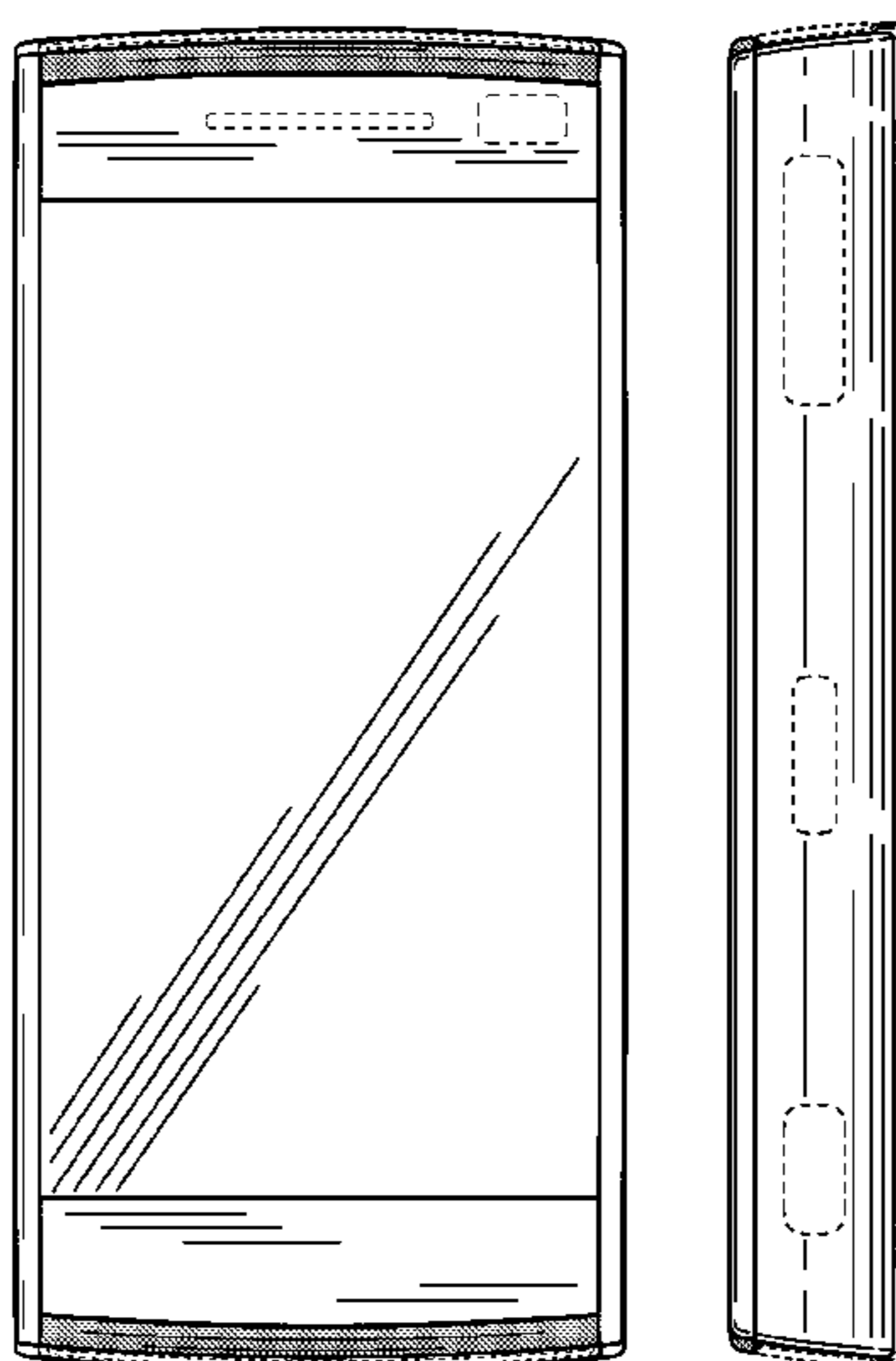
FIG. 19 is a right side view thereof;

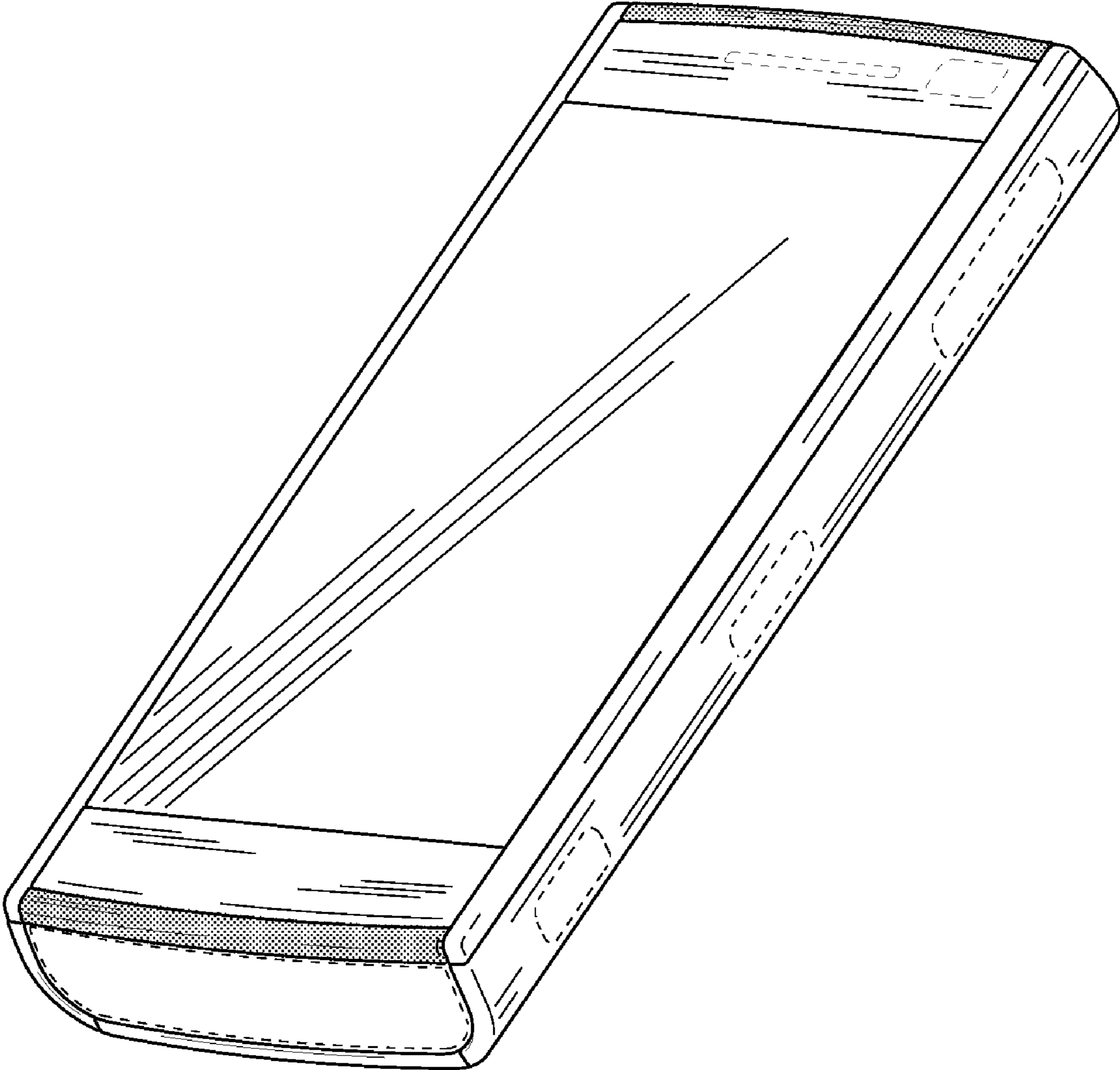

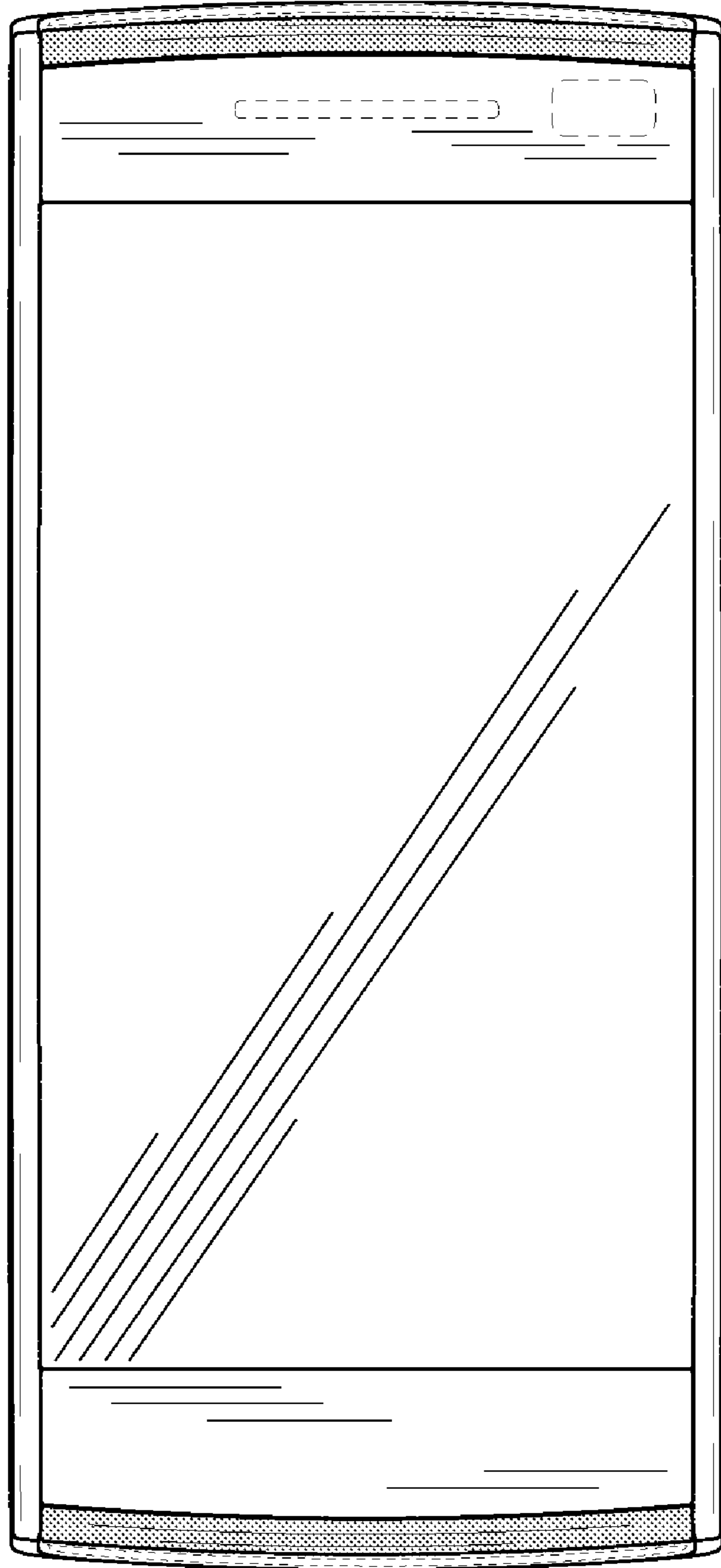

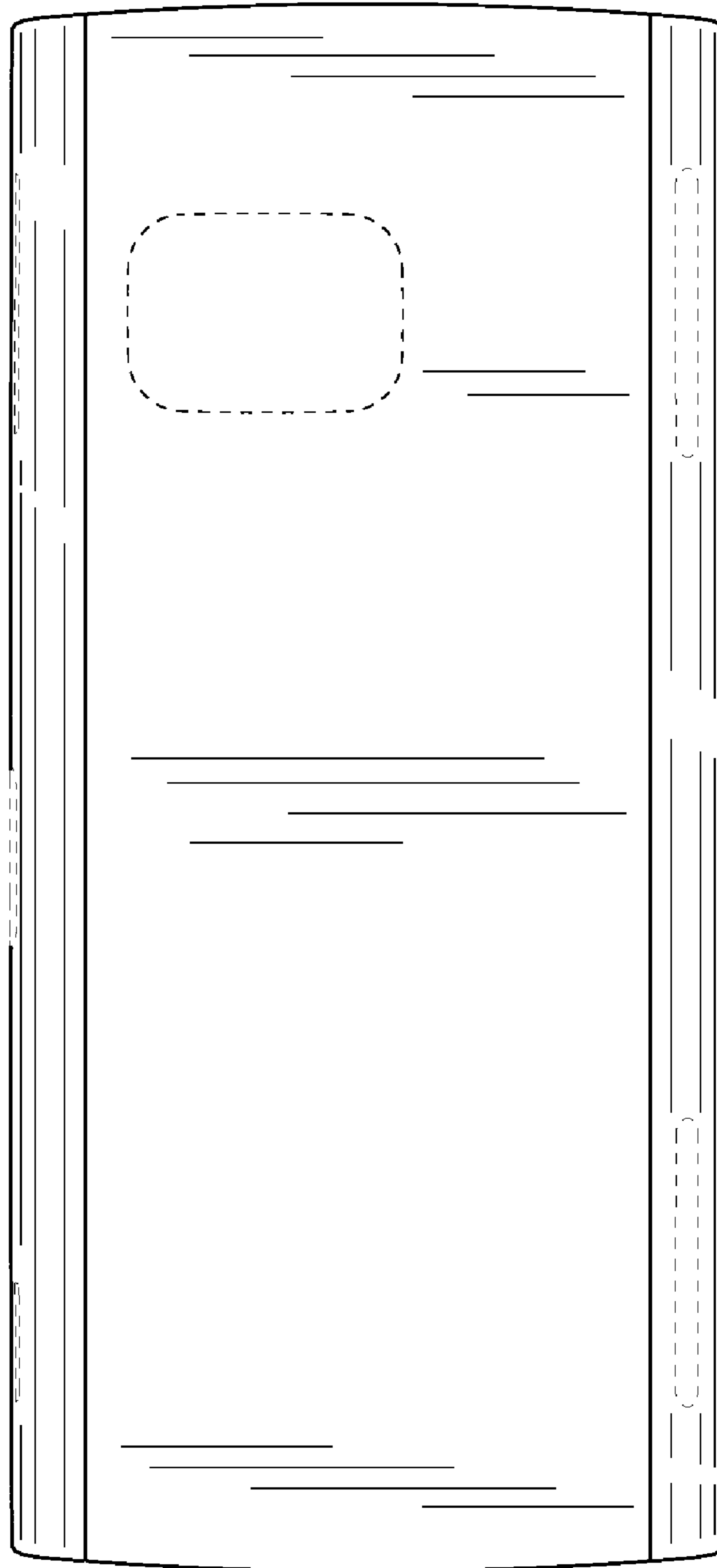

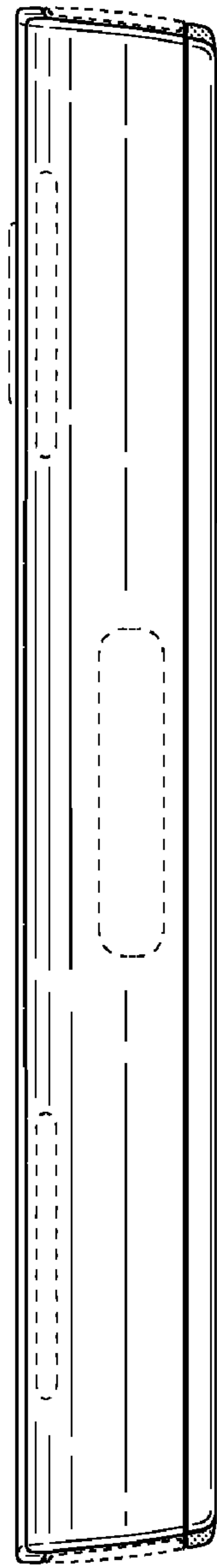

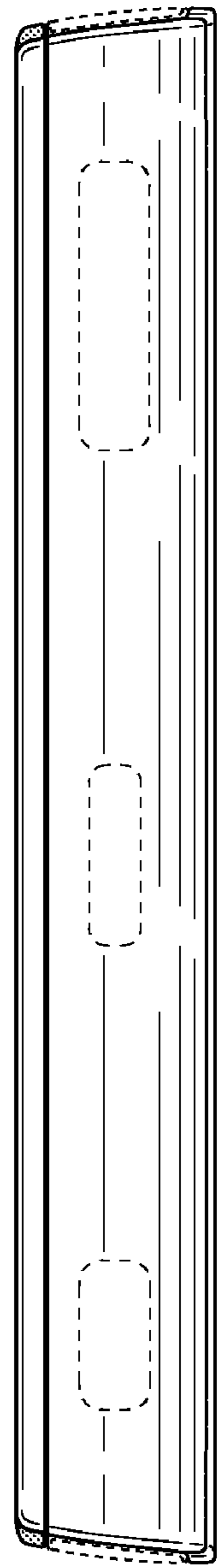

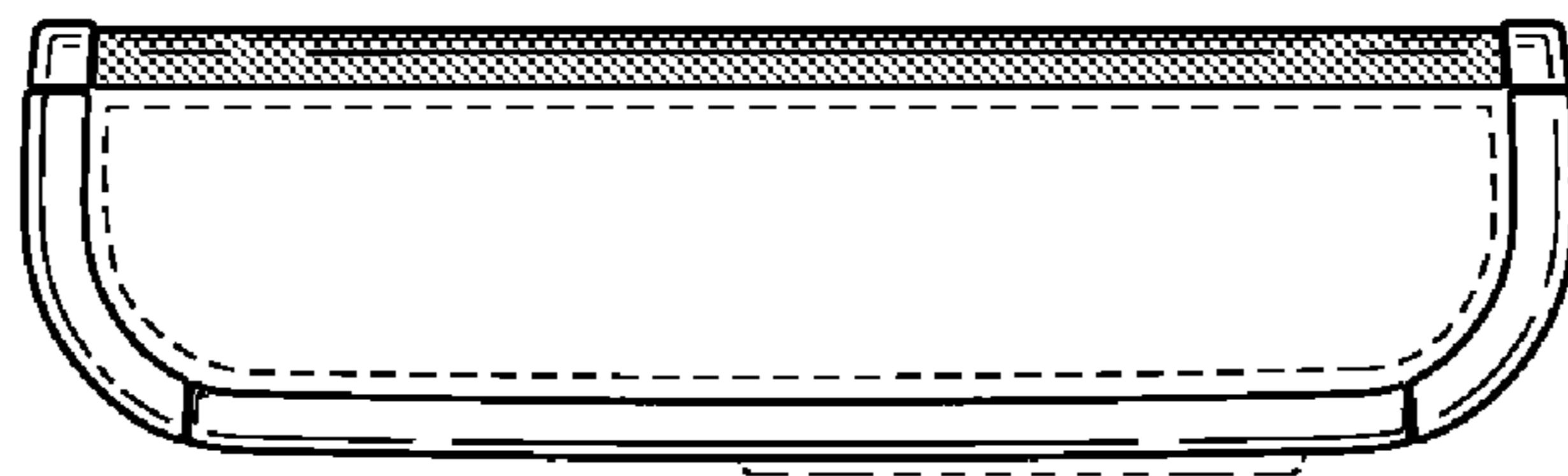

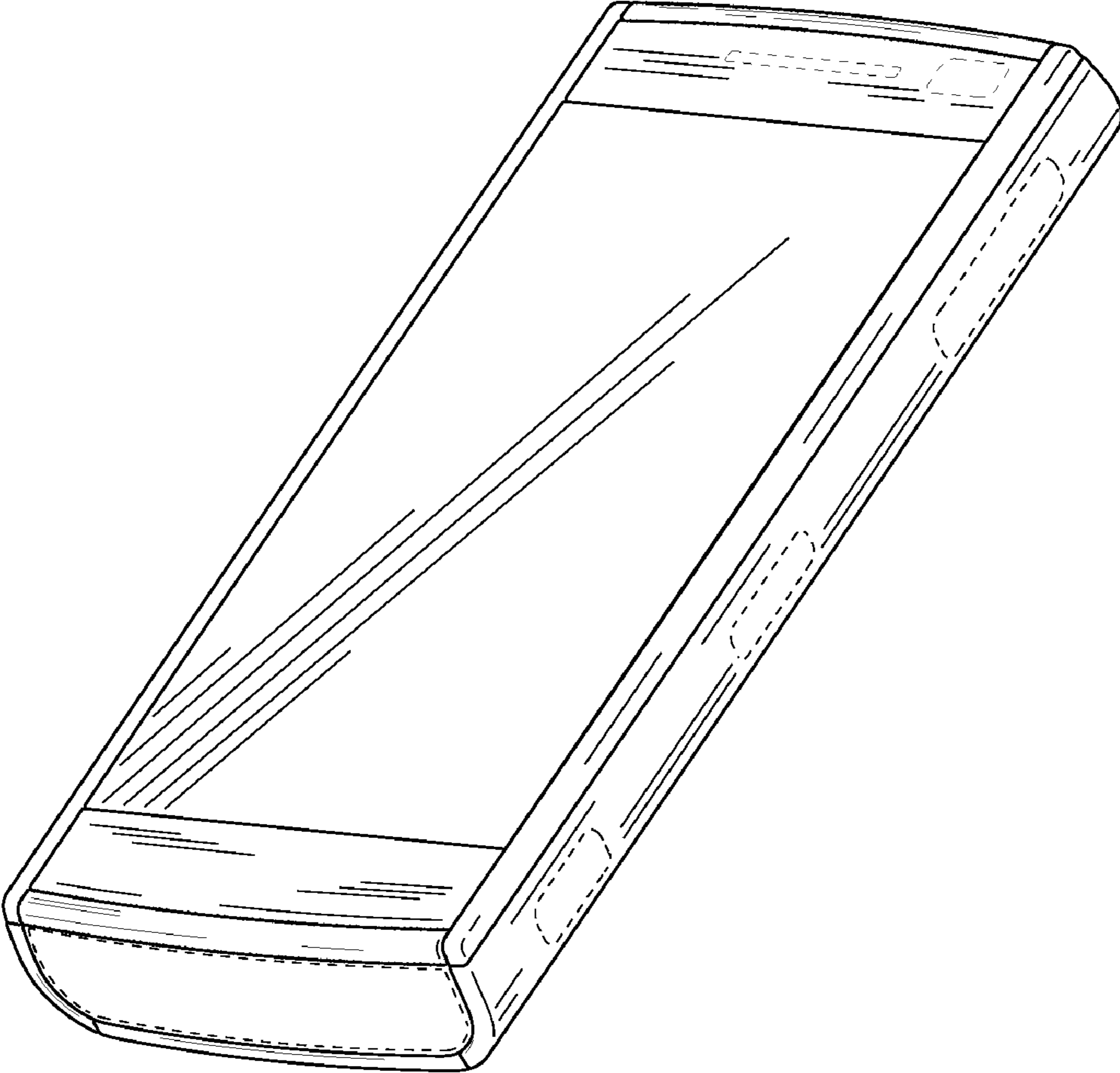

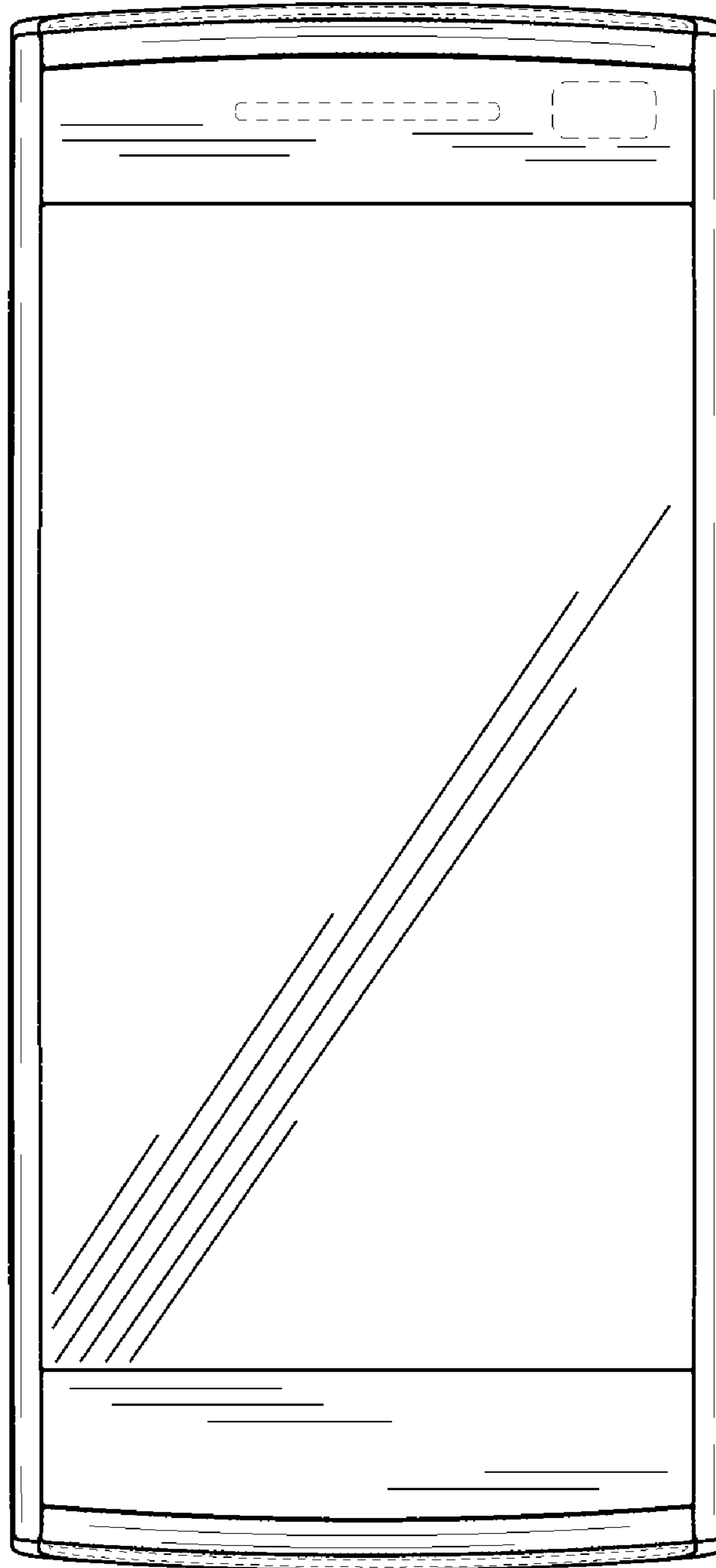

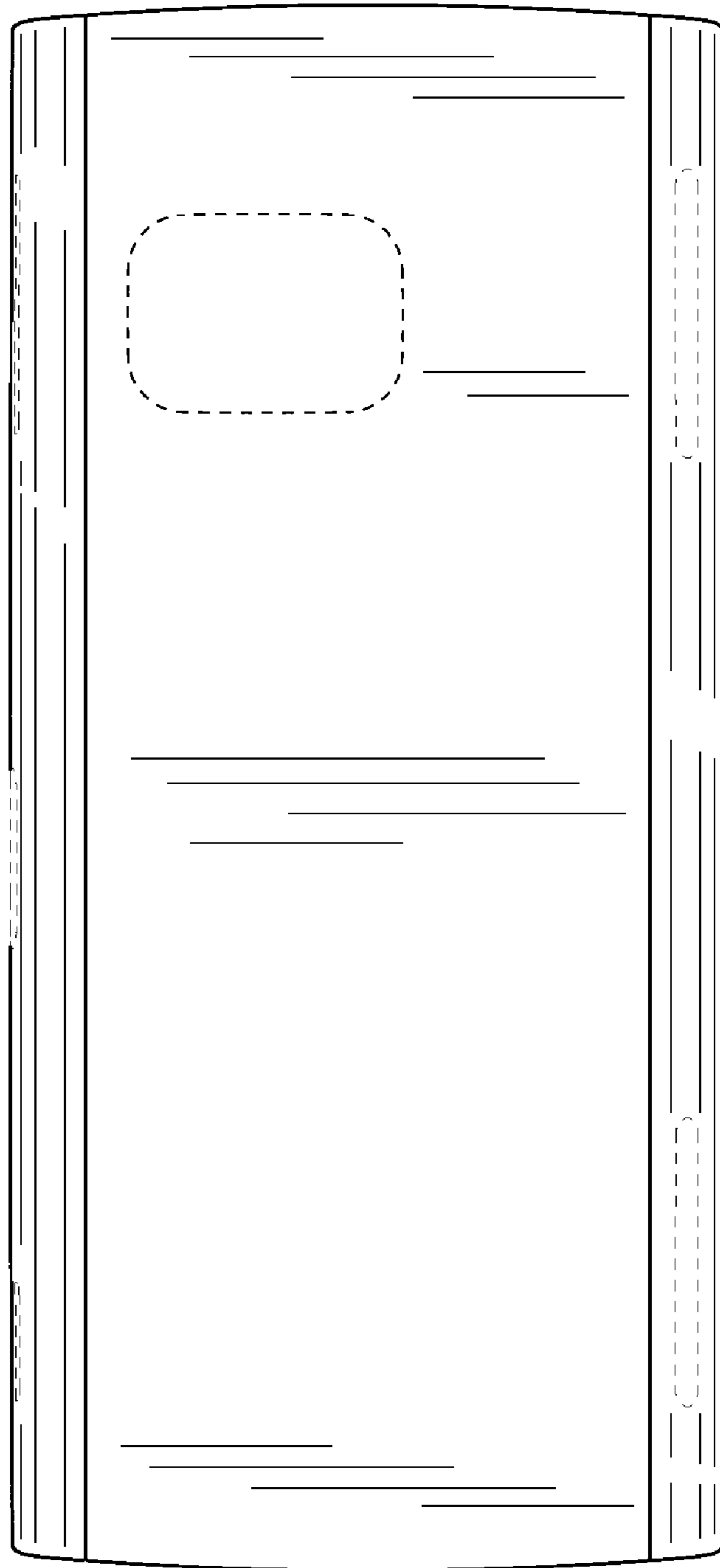

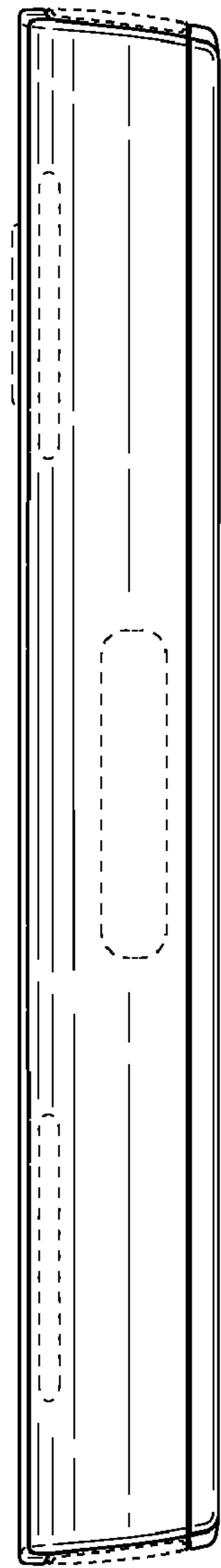

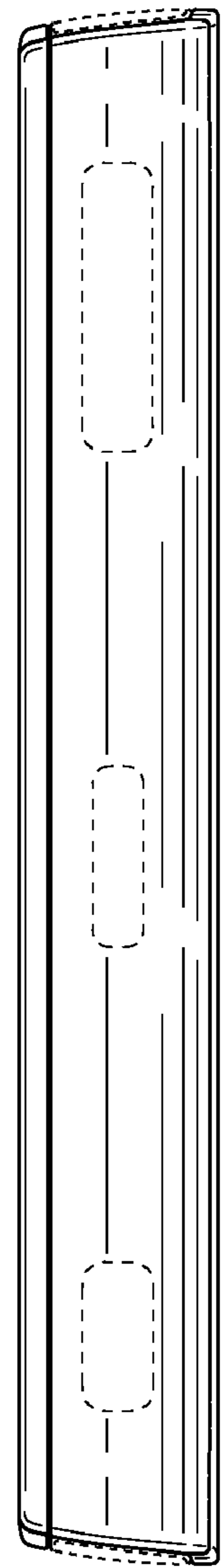

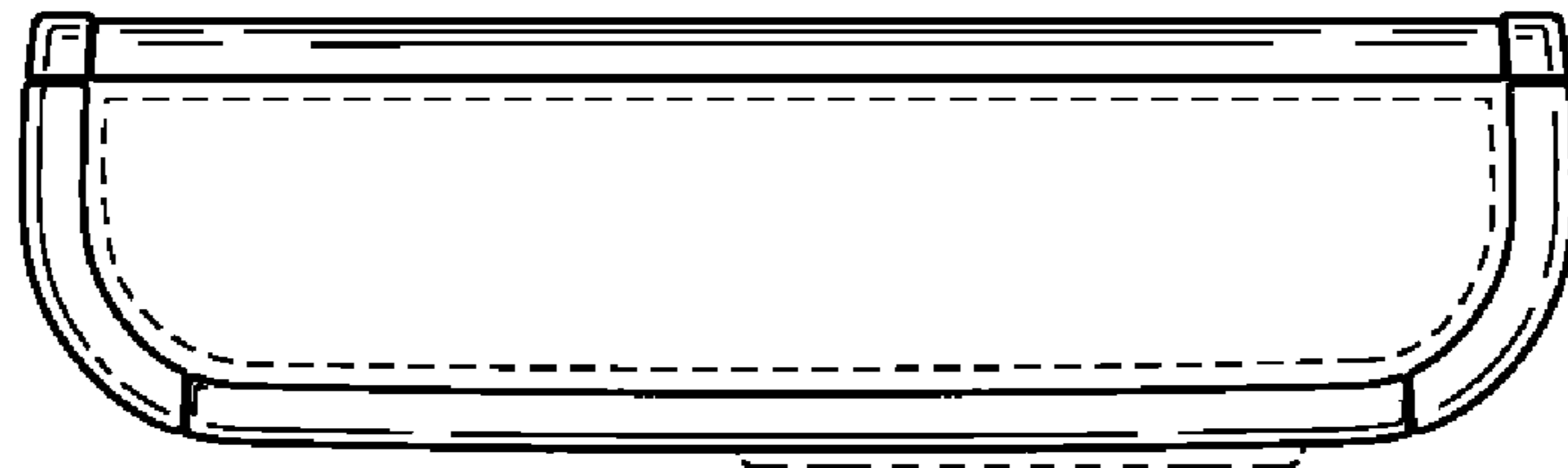

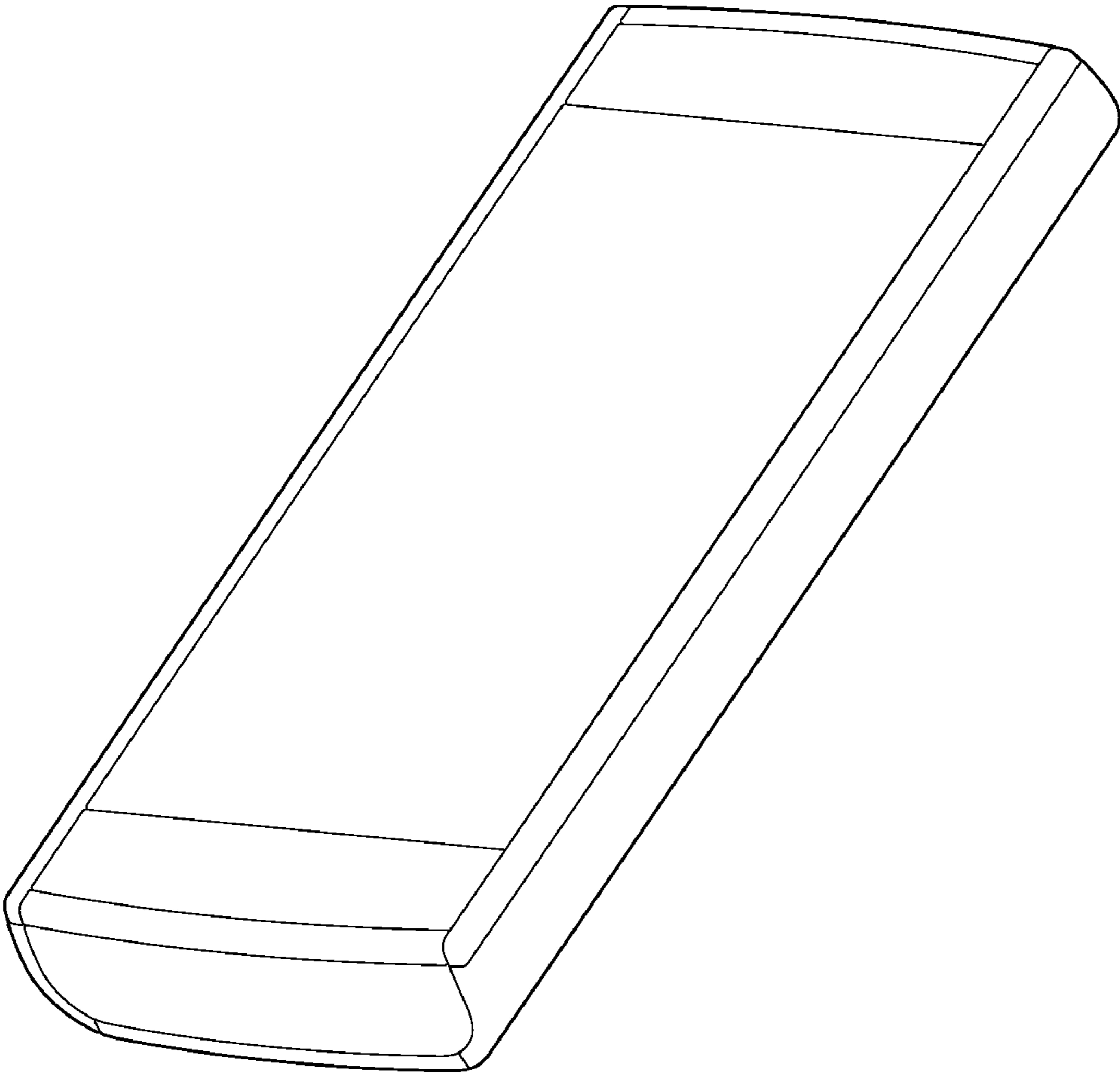

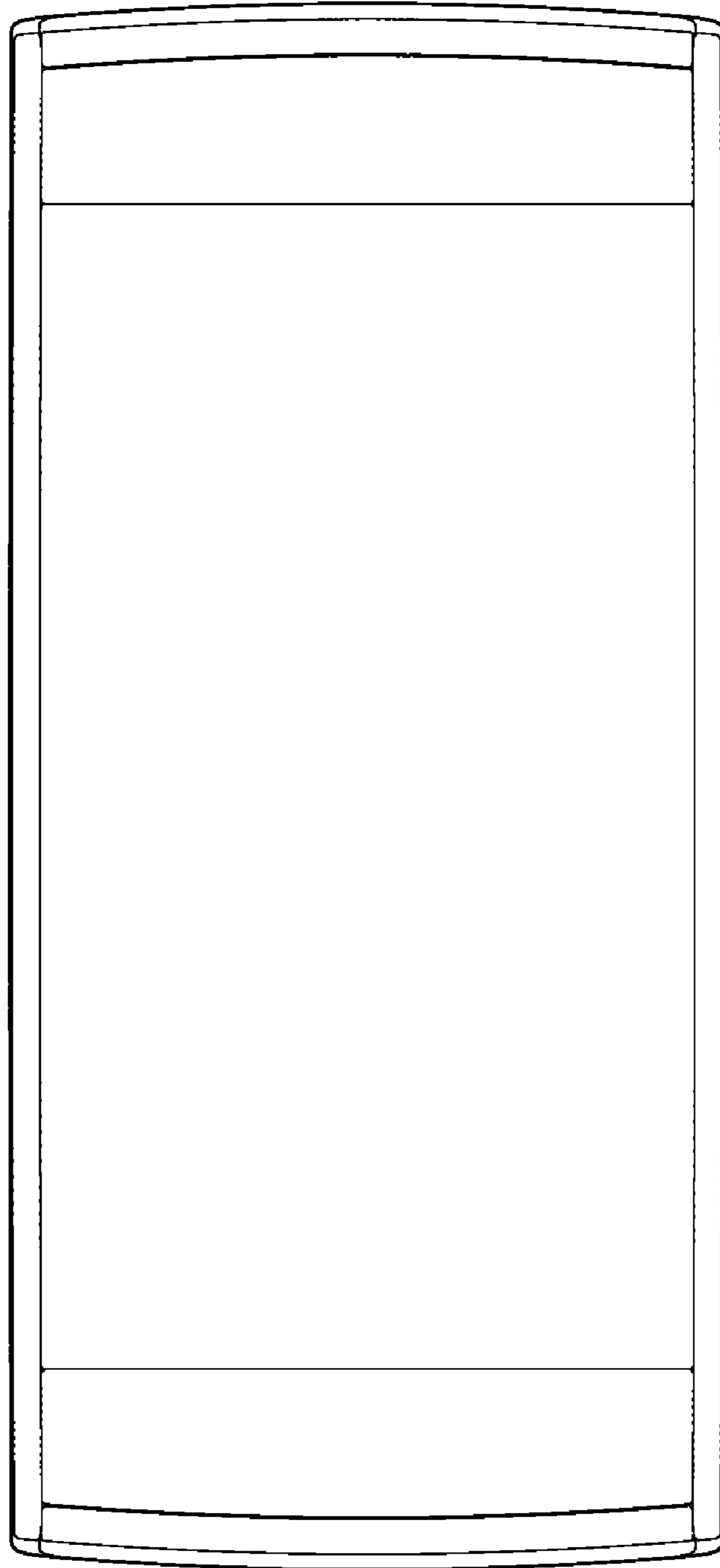

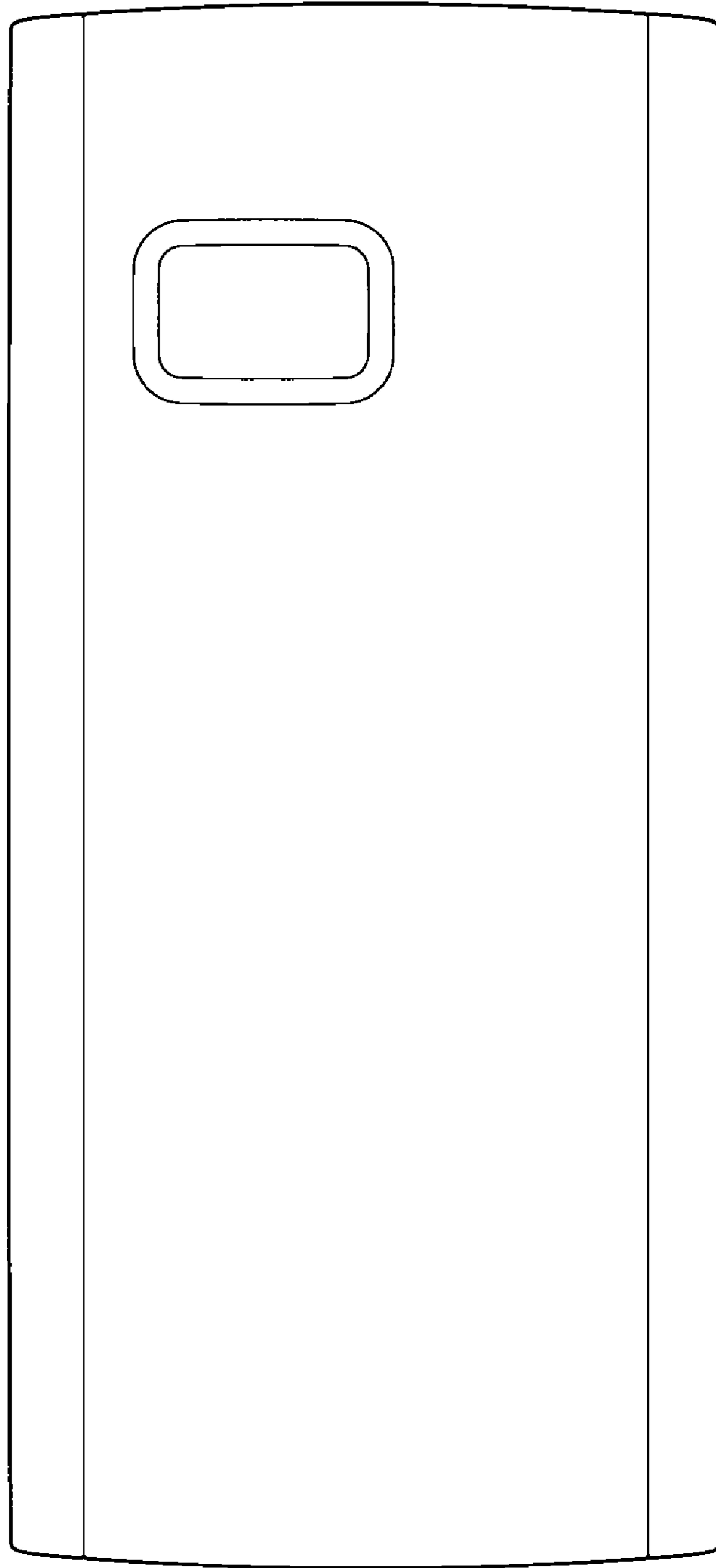

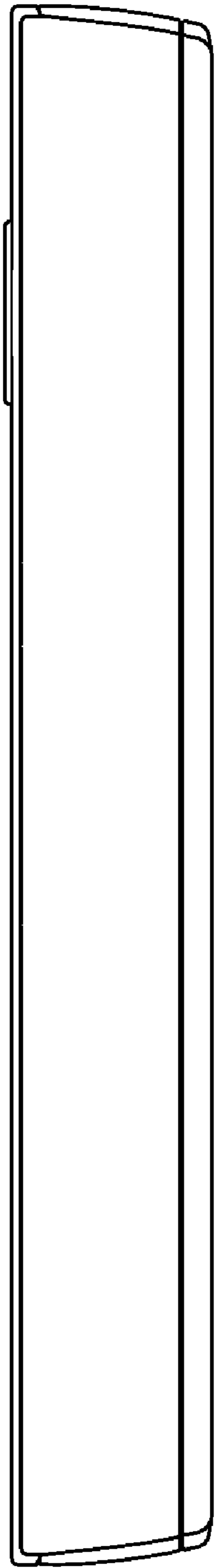

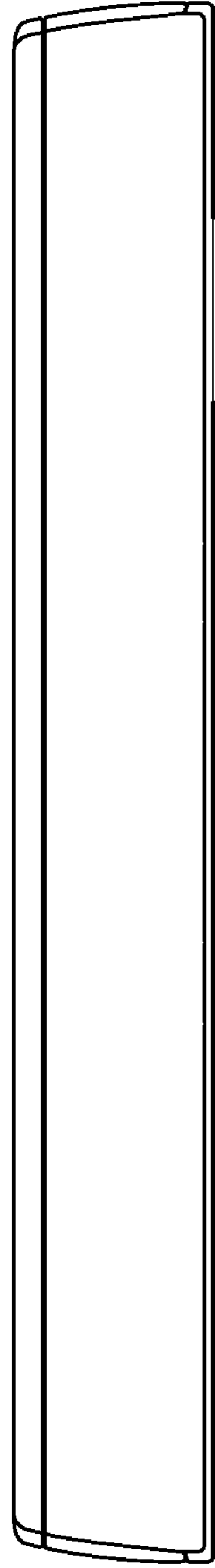

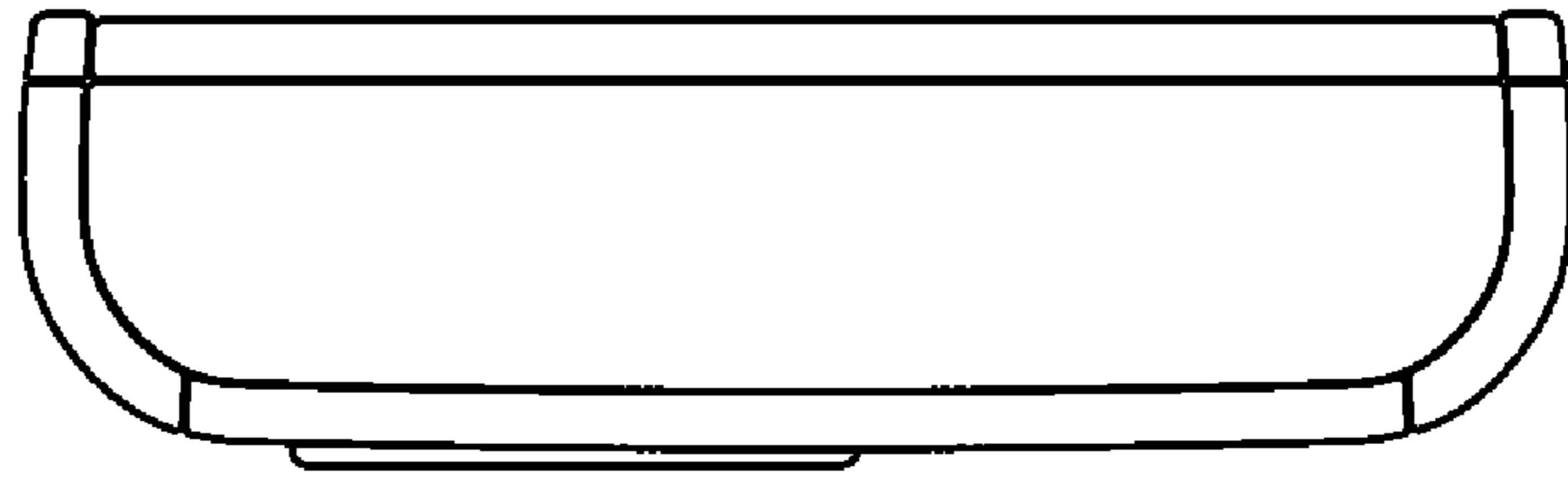

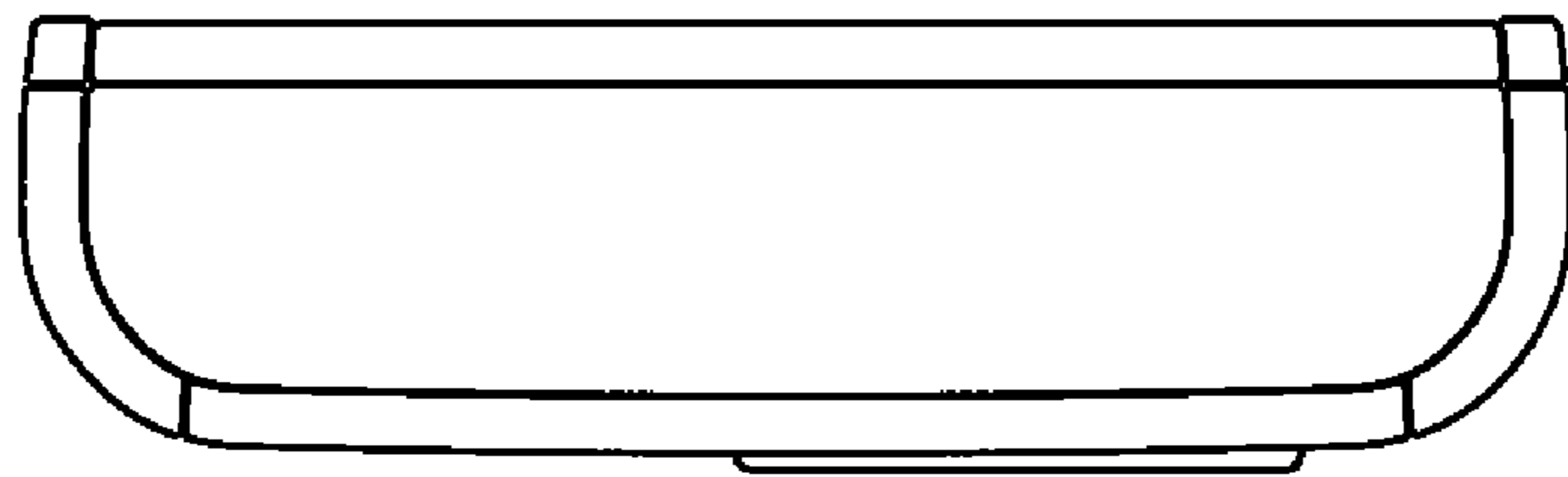
