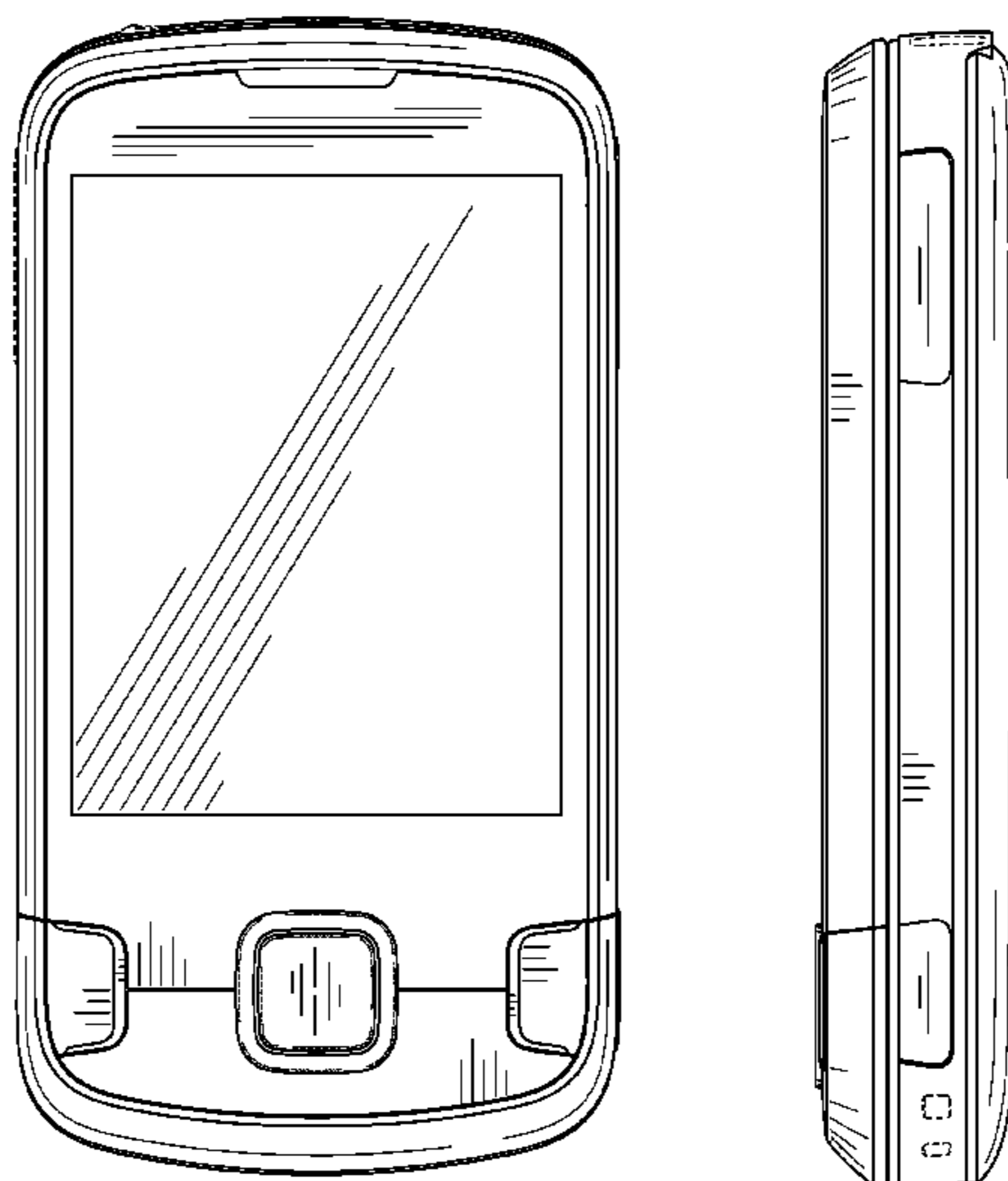
The ornamental design for a handset, as shown and described.

DESCRIPTION

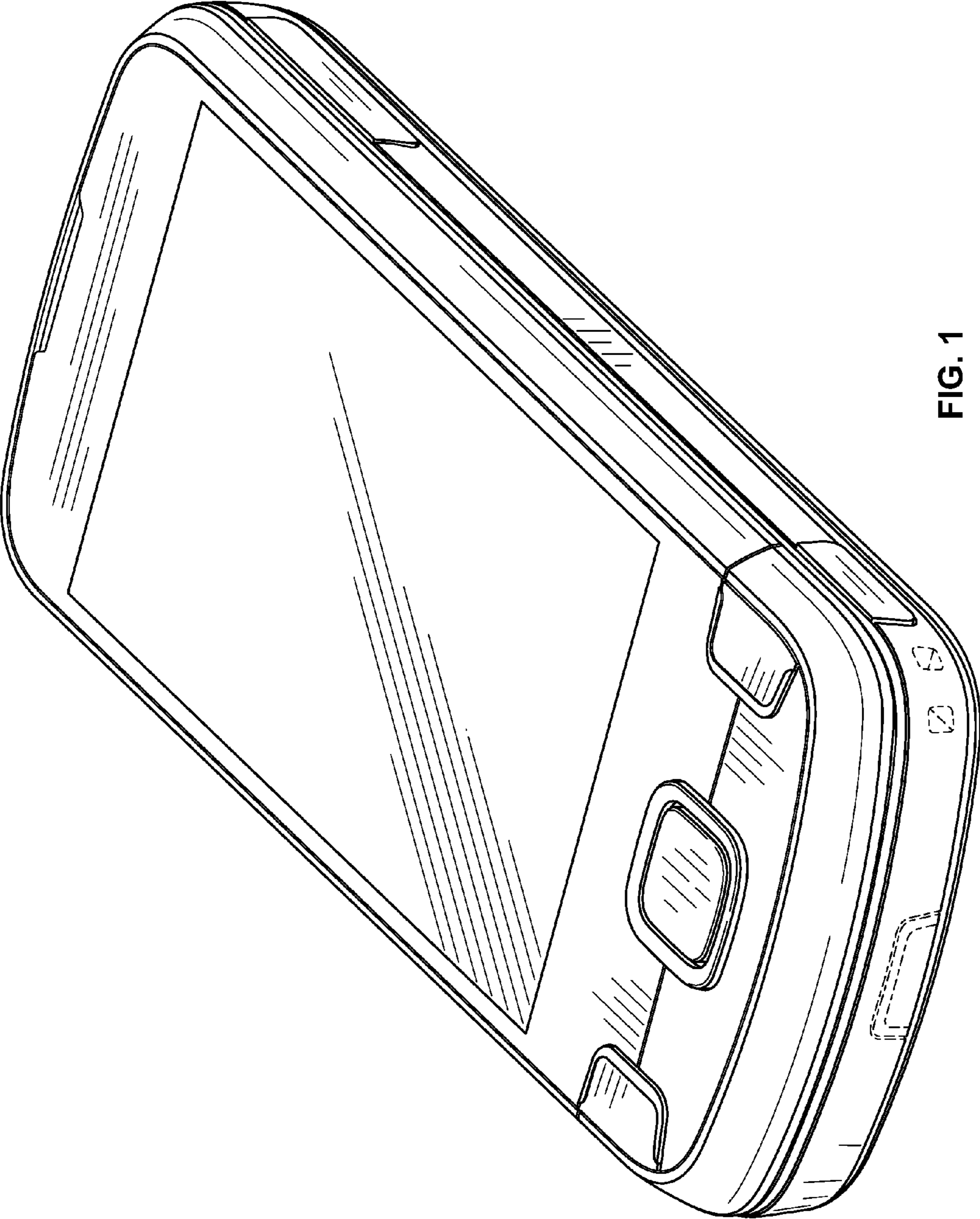

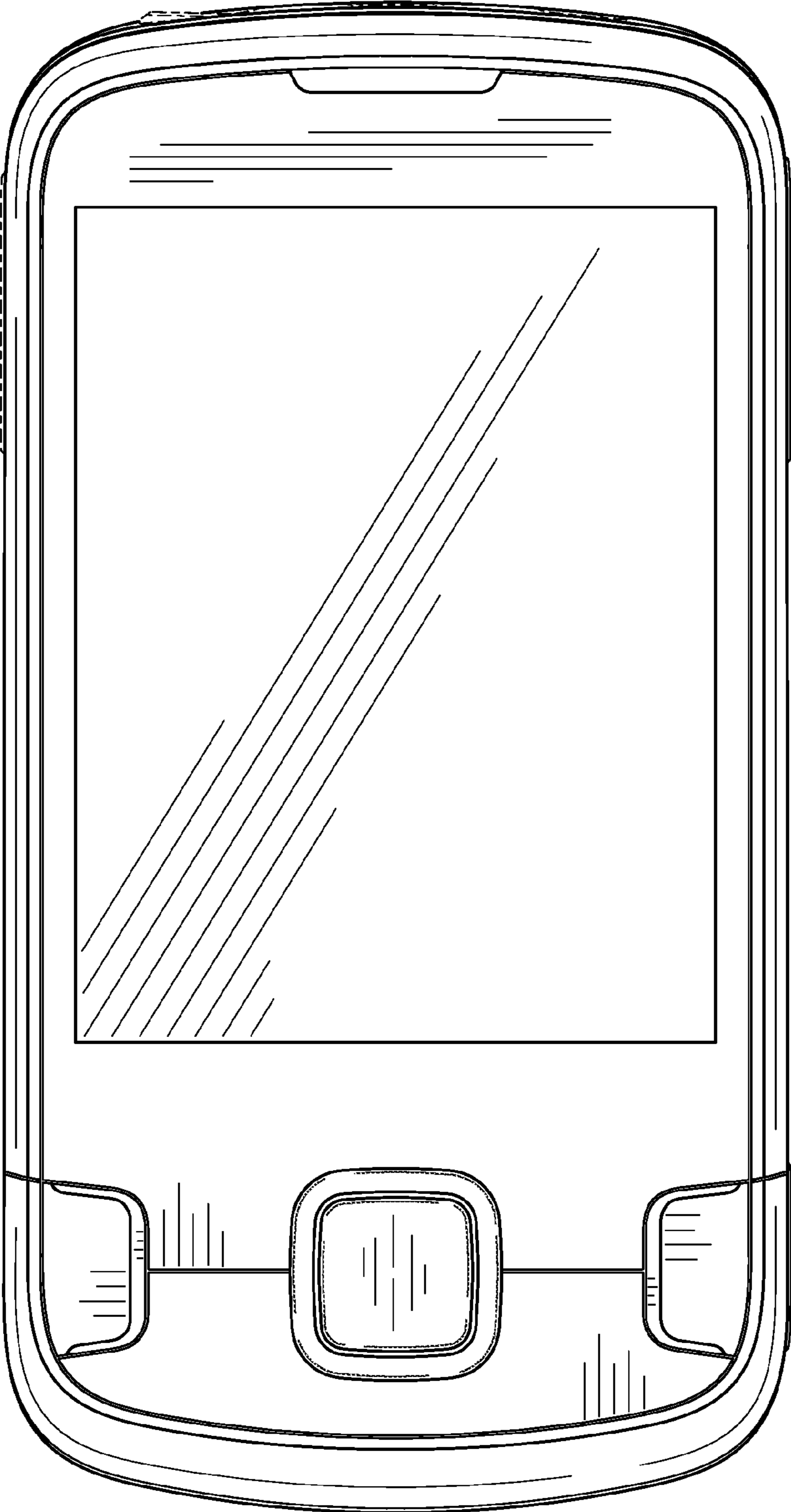

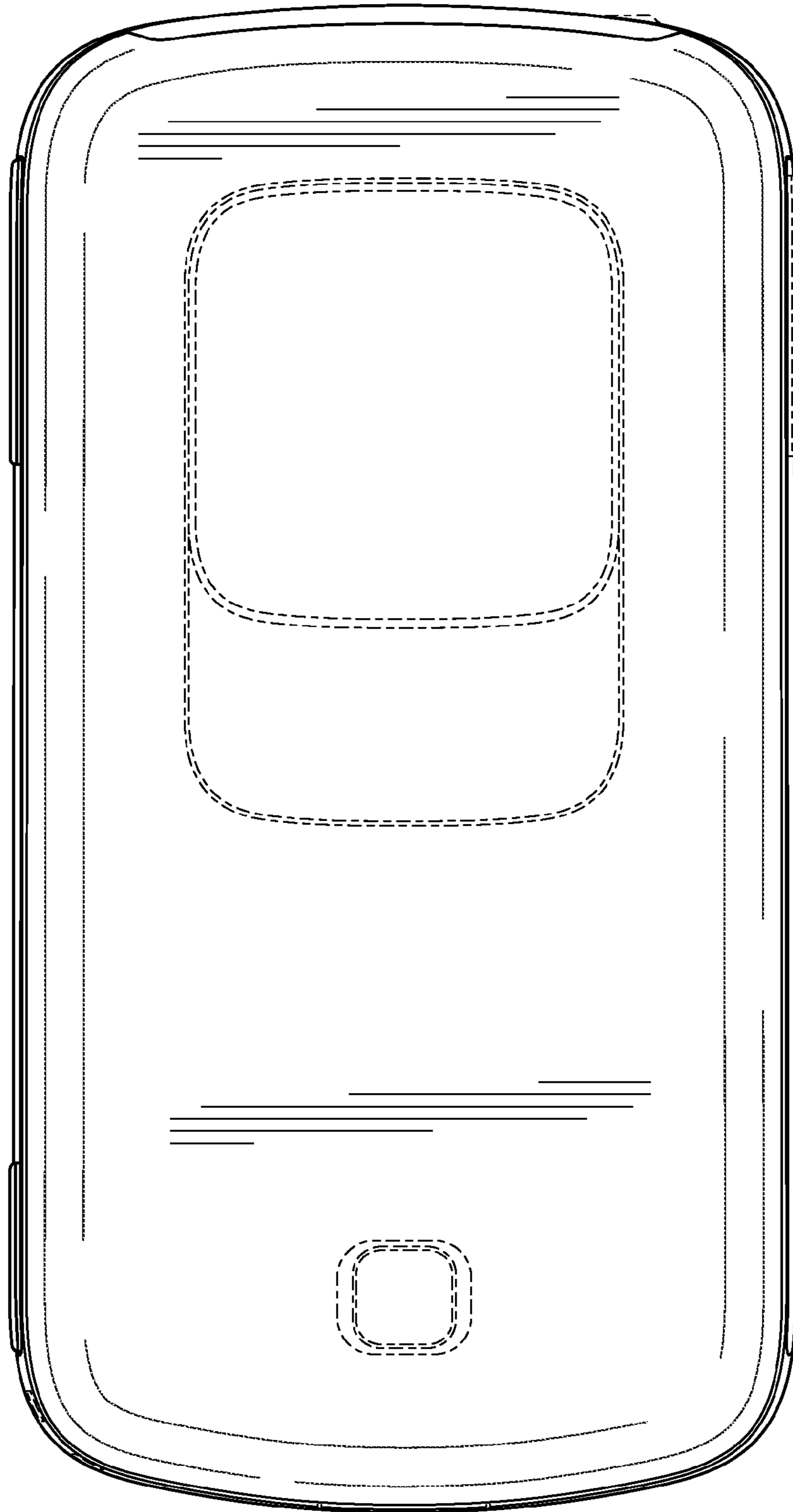

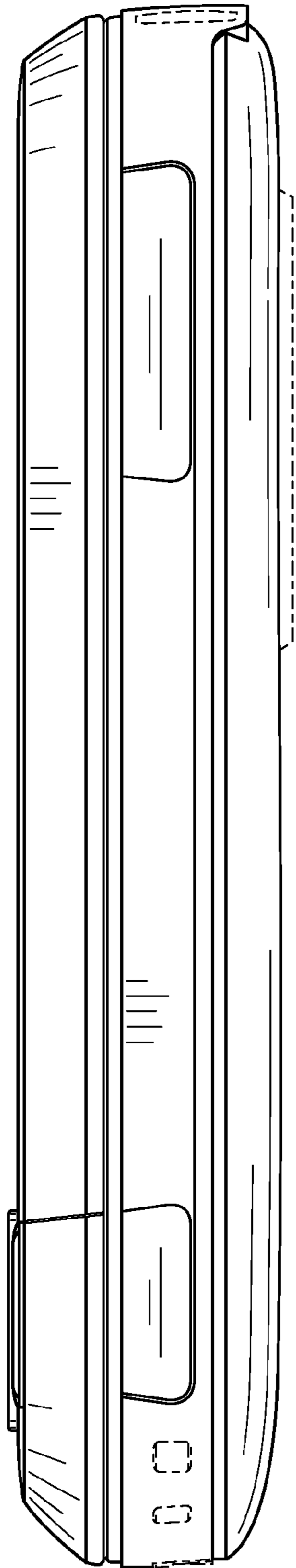

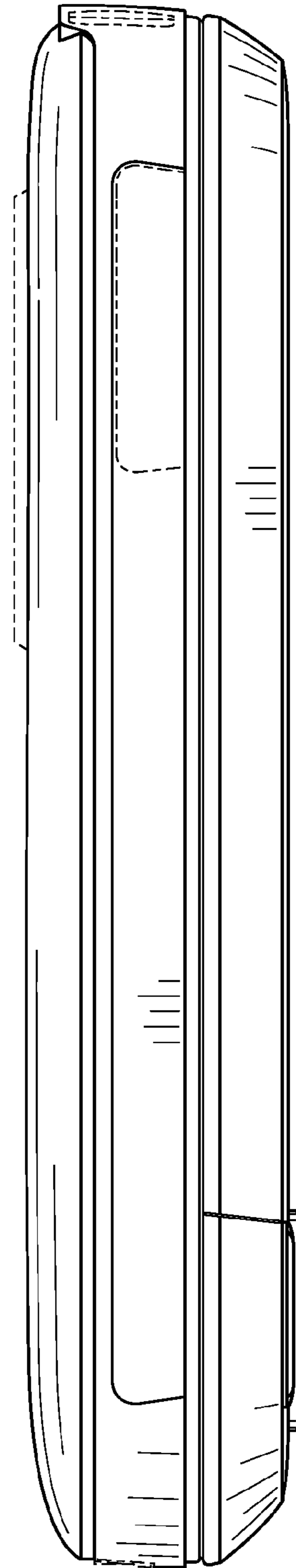

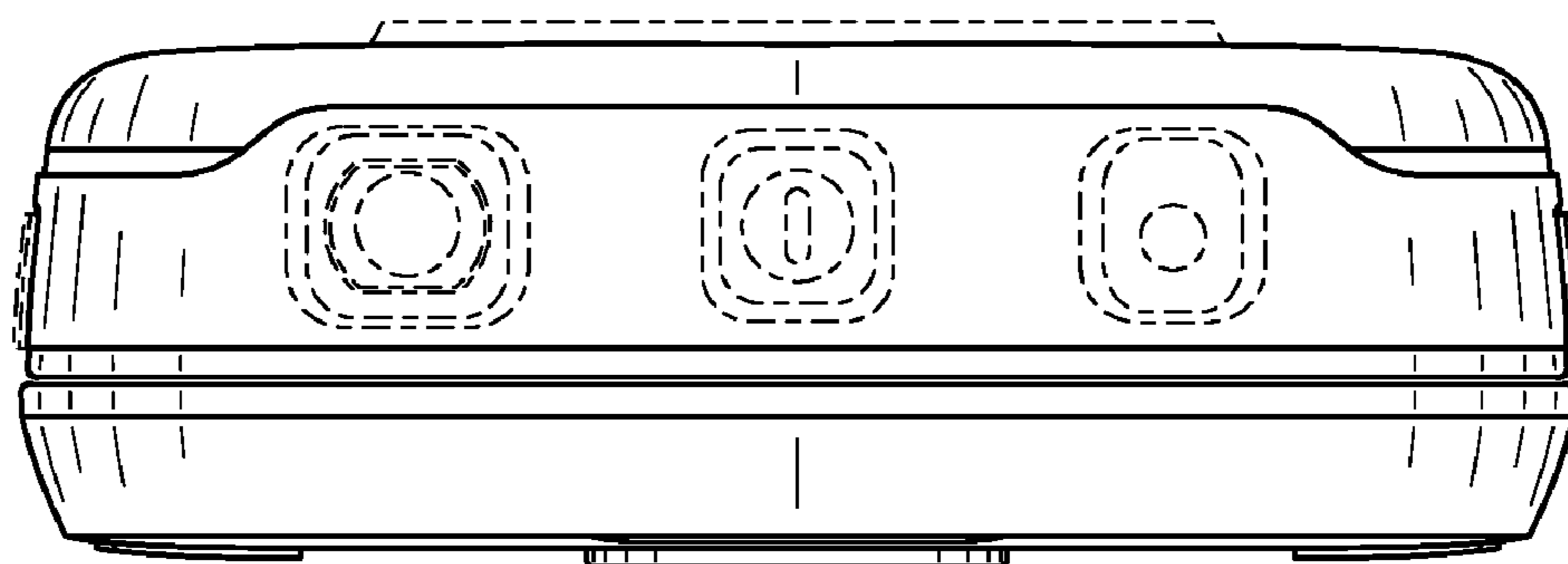

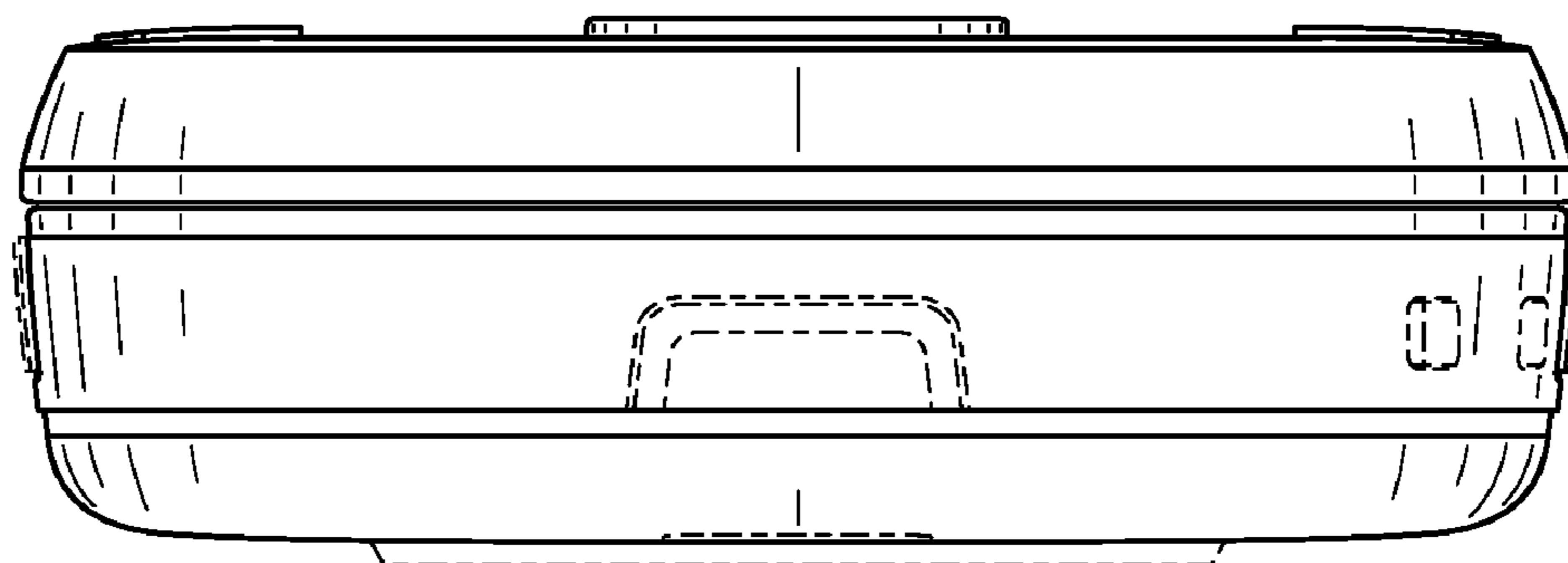
