The ornamental design for a color icon for a display screen or packaging with surface ornamentation, as shown and described.

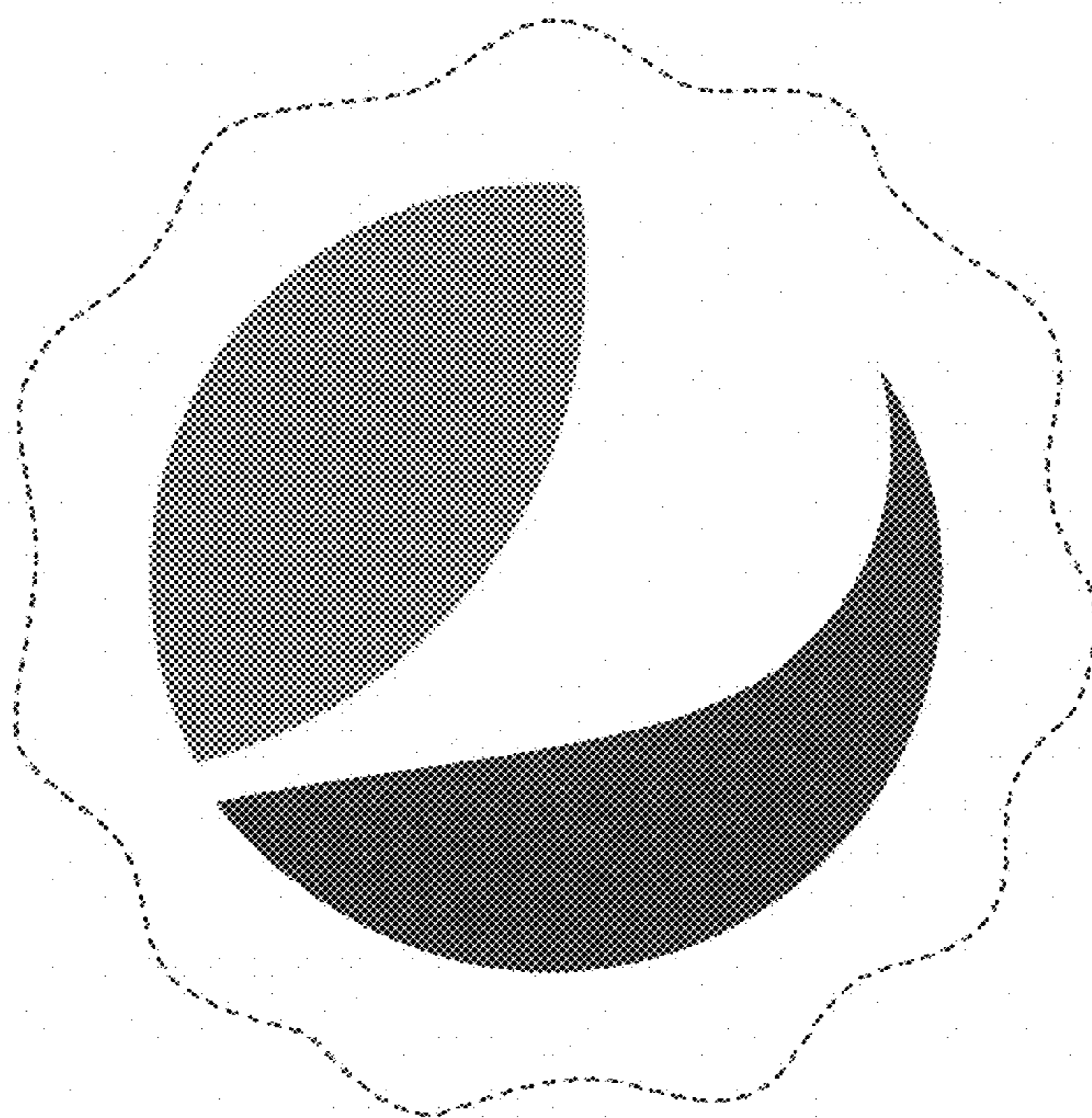
DESCRIPTION

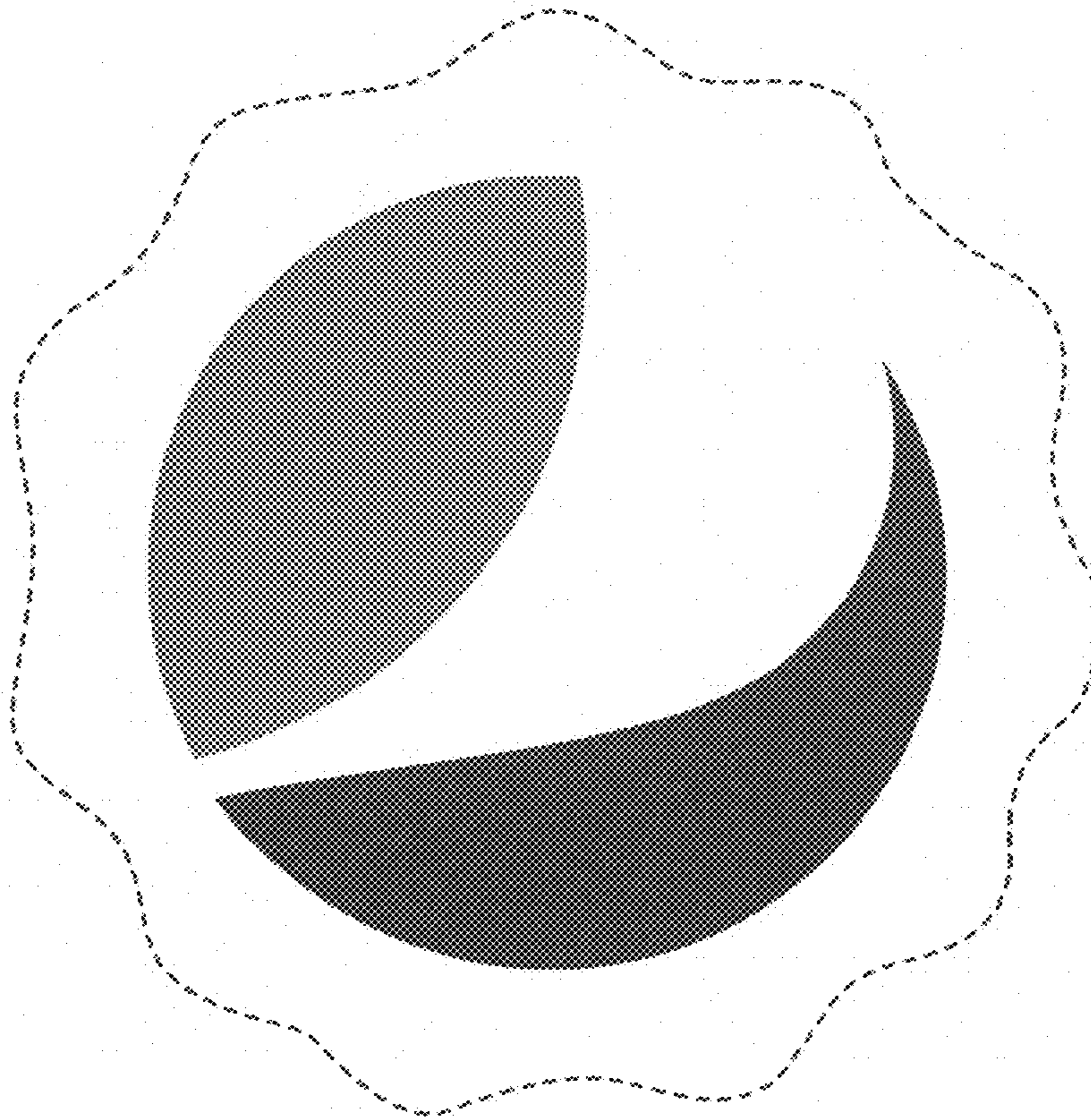
