The ornamental design for an icon for a portion of a display, as shown and described.

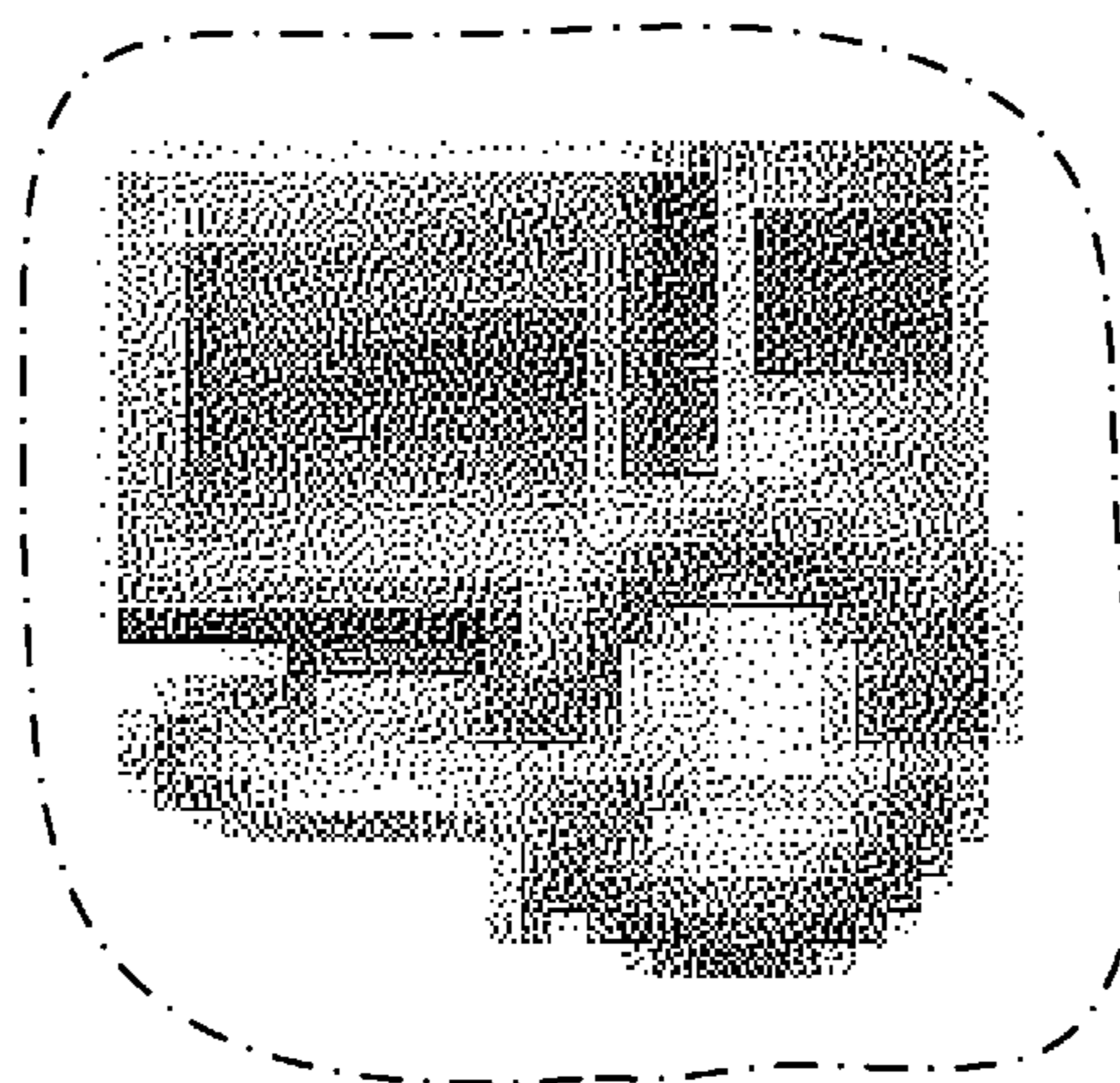
DESCRIPTION
