(57) **CLAIM**

What is claimed is the ornamental design for an angled roller applicator, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, right side perspective view of our new design for an angled roller applicator;

FIG. 2 is a top, rear, right side perspective view of the angled roller applicator shown in FIG. 1;

FIG. 3 is a bottom, front, right side perspective view of the angled roller applicator shown in FIG. 1;

FIG. 4 is a bottom, rear, right side perspective view of the angled roller applicator shown in FIG. 1;

FIG. 5 is a front elevation view of the angled roller applicator shown in FIG. 1;

FIG. 6 is a right side elevation view of the angled roller applicator shown in FIG. 1, the opposite side being a mirror image thereof;

FIG. 7 is a rear elevation view of the angled roller applicator shown in FIG. 1;

FIG. 8 is a top plan view of the angled roller applicator shown in FIG. 1;

FIG. 9 is a bottom plan view of the angled roller applicator shown in FIG. 1;

FIG. 10 is a perspective view of the angled roller applicator shown in FIG. 3 in use;

FIG. 11 is a perspective view of the angled roller applicator shown in FIG. 4 in use;

FIG. 12 is a perspective view of the angled roller applicator shown in FIG. 2 in use;

FIG. 13 is a perspective view of the angled roller applicator shown in FIG. 1 in use;

FIG. 14 is a front elevation view of the angled roller applicator shown in FIG. 5 in use;

FIG. 15 is a rear elevation view of the angled roller applicator shown in FIG. 7 in use;

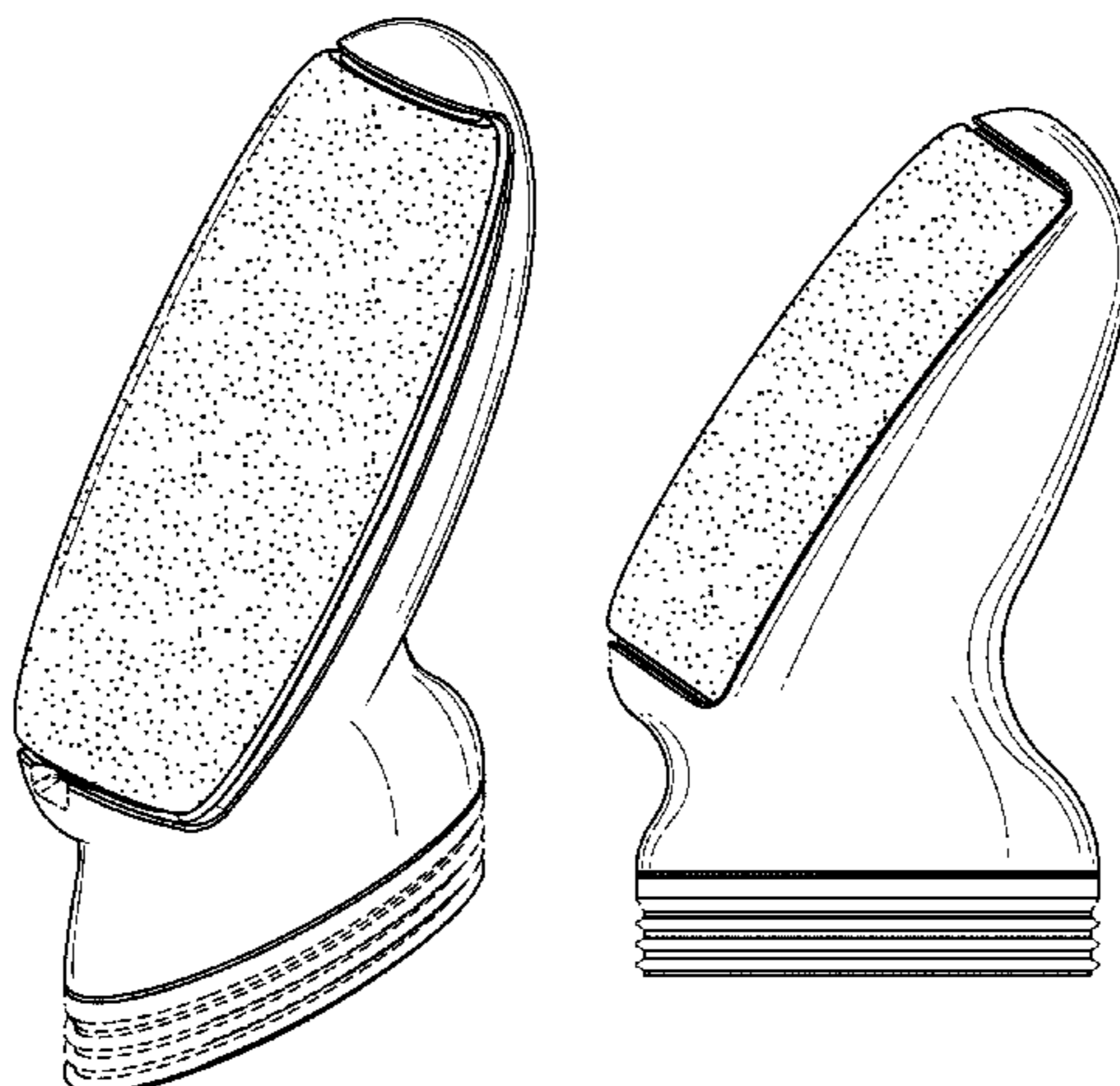
FIG. 16 is a side elevation view of the angled roller applicator shown in FIG. 6 in use, the opposite side being a mirror image thereof;

FIG. 17 is a top elevation view of the angled roller applicator shown in FIG. 8 in use; and,

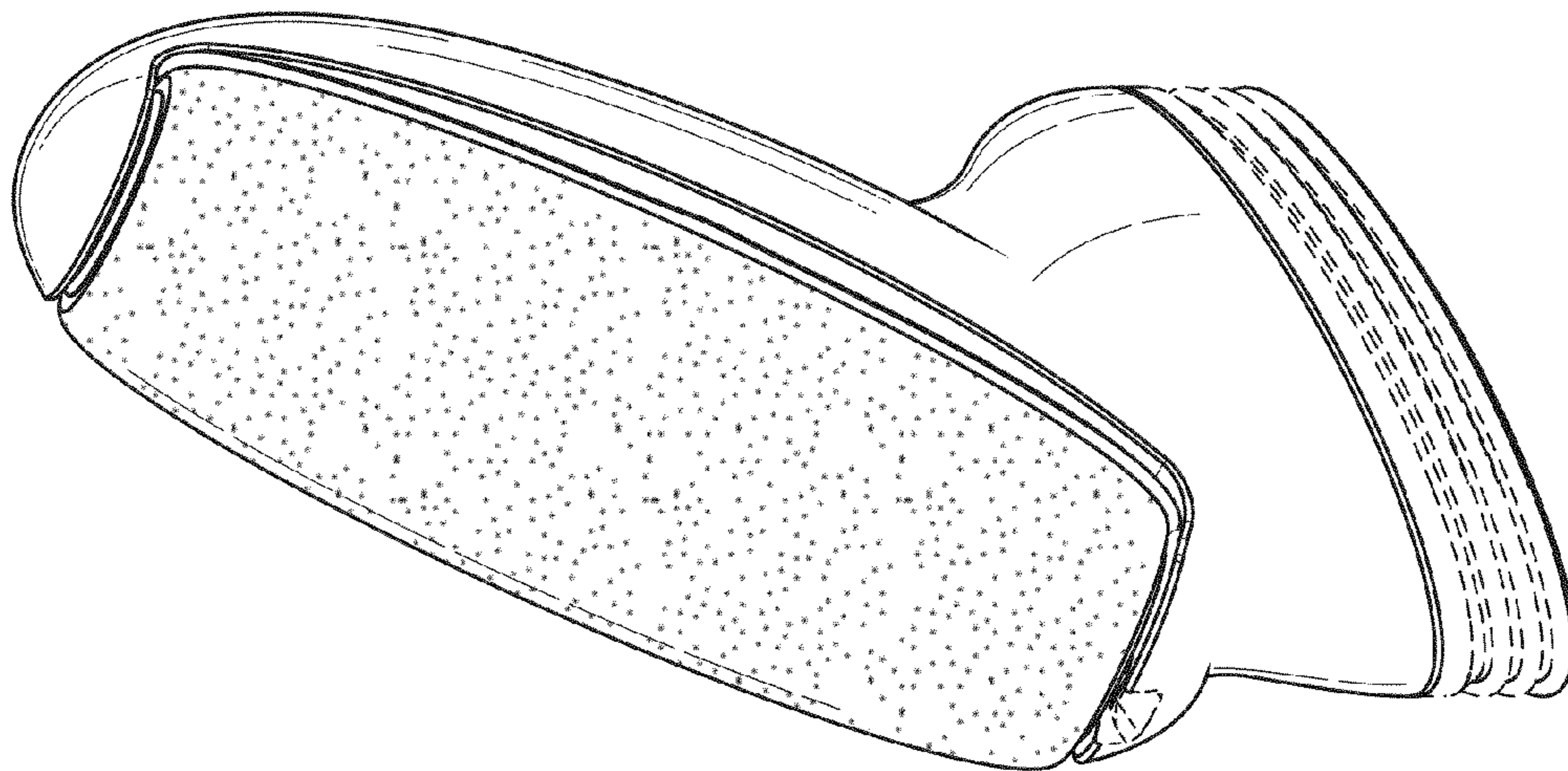

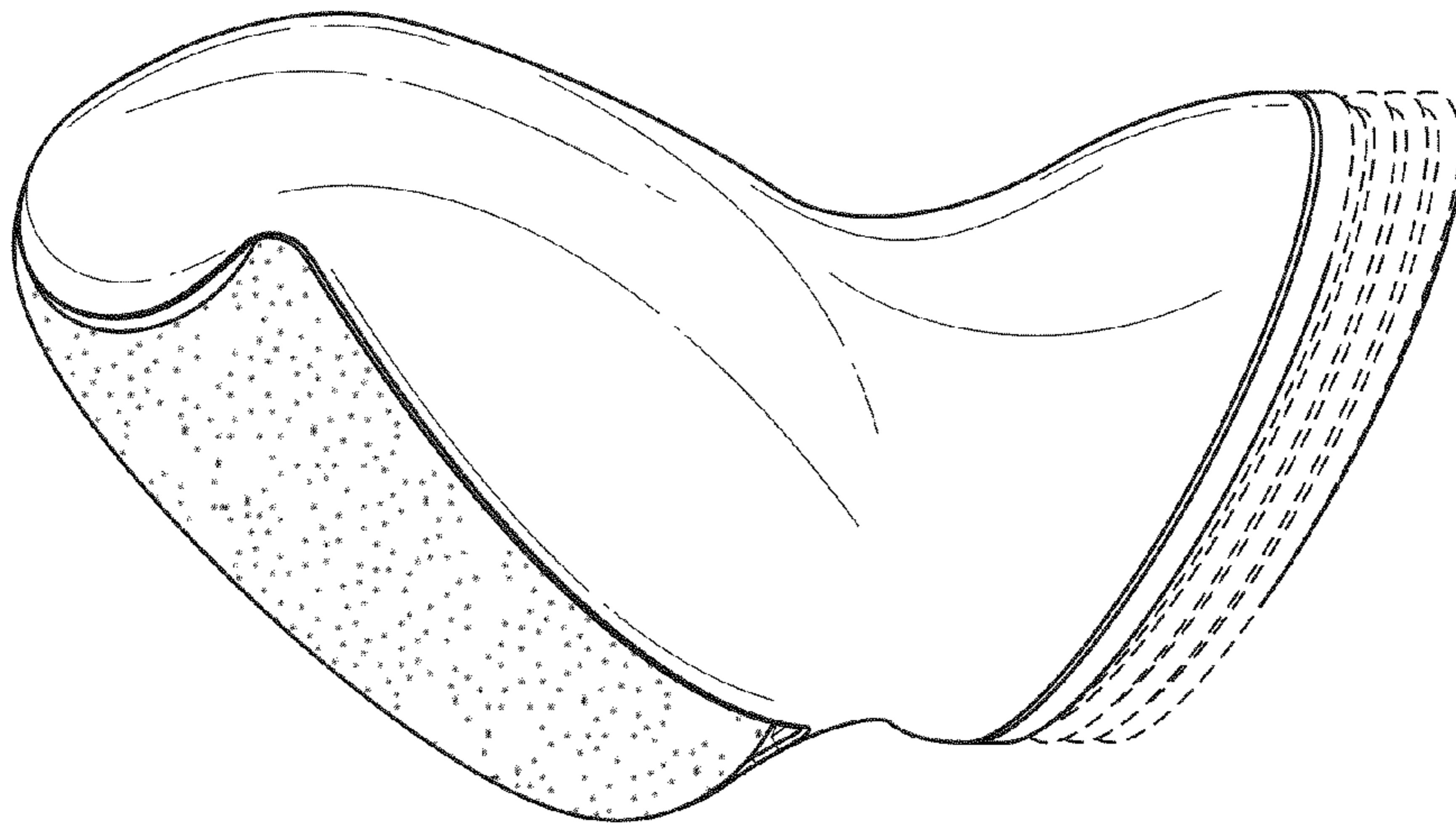

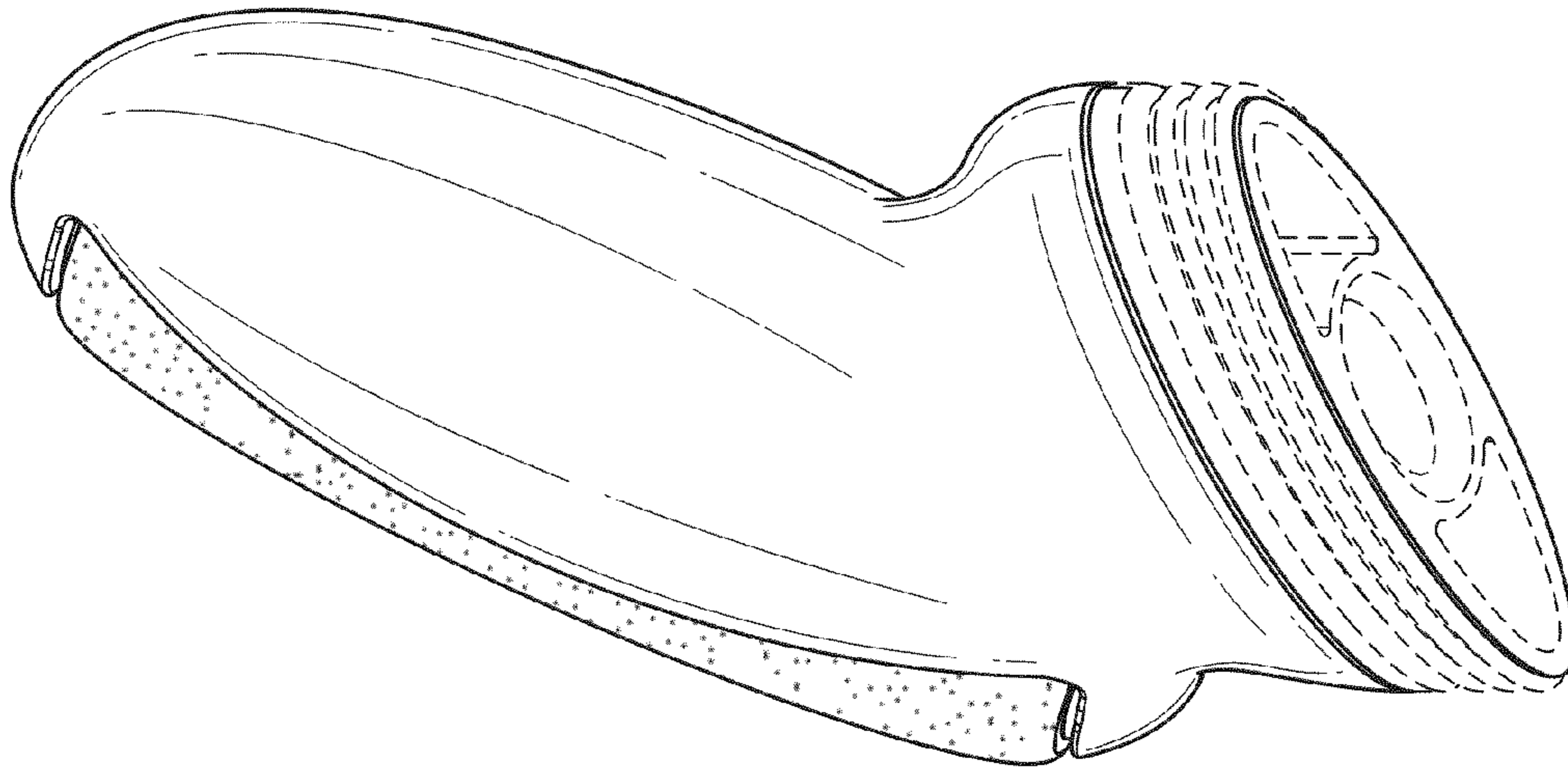

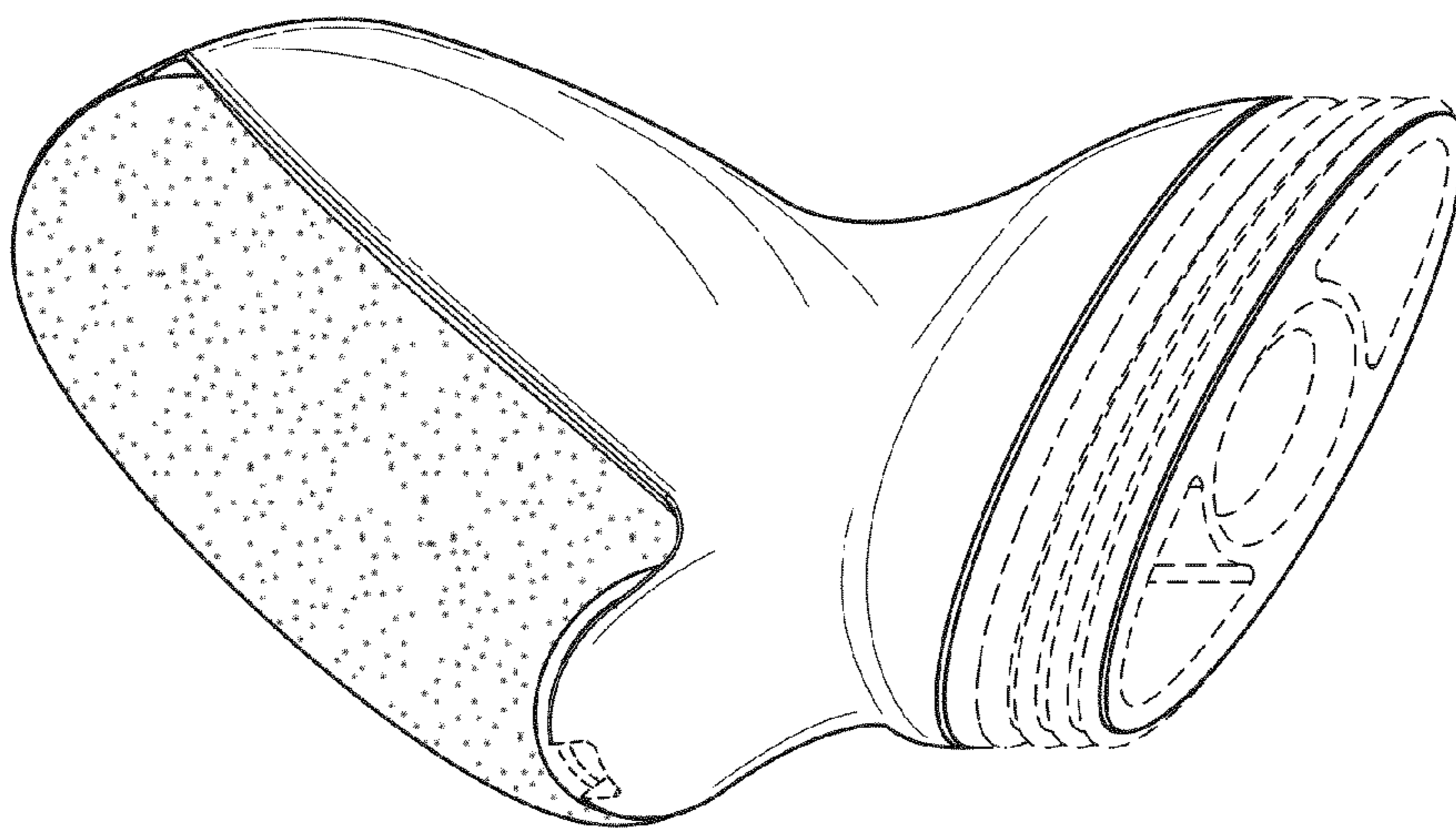

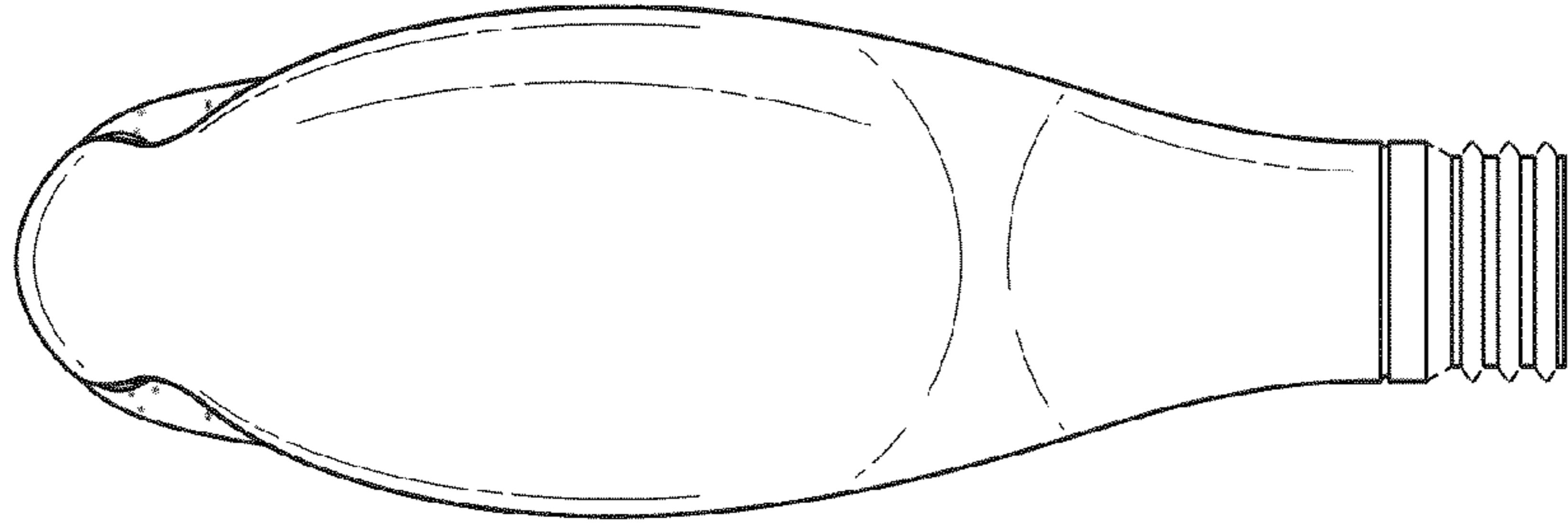

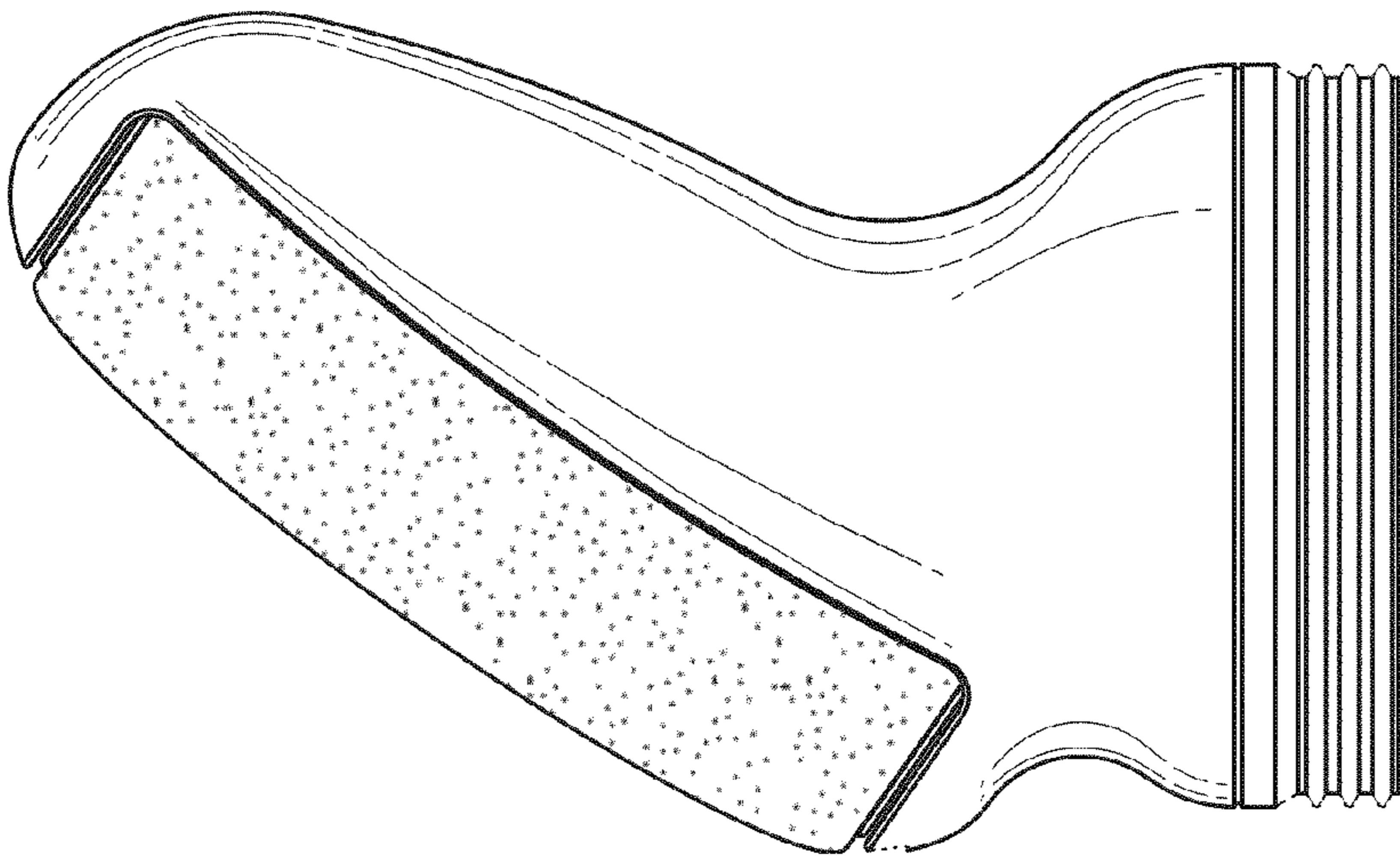

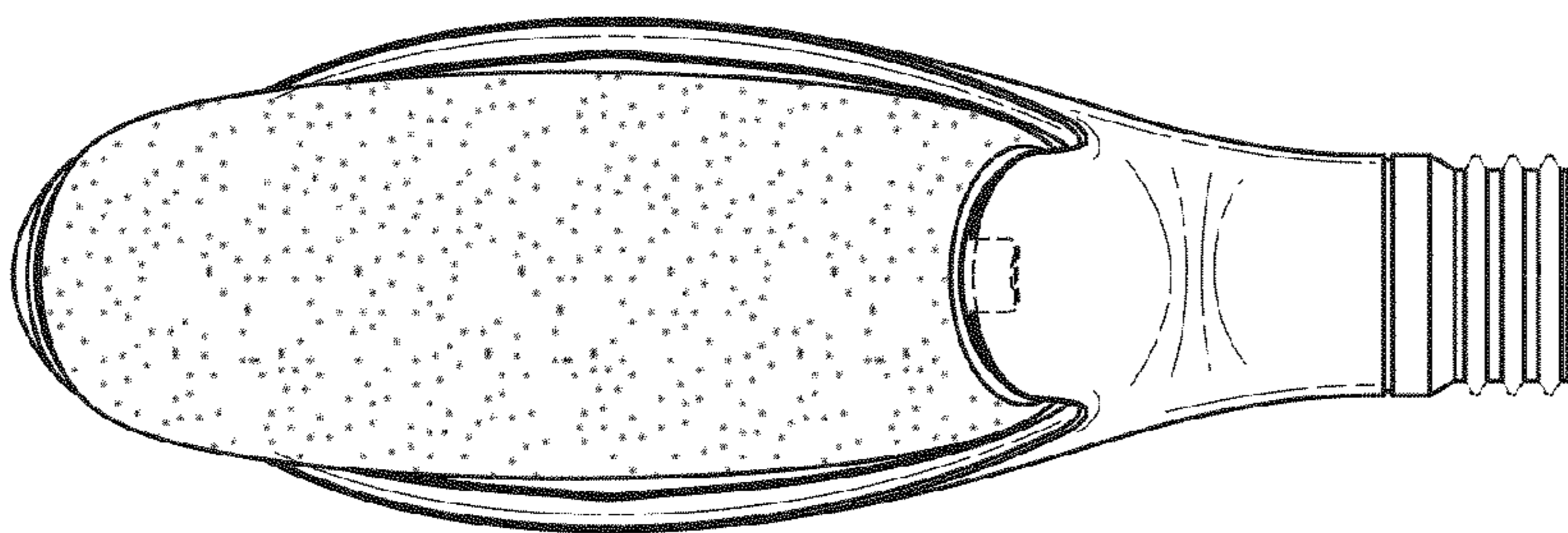

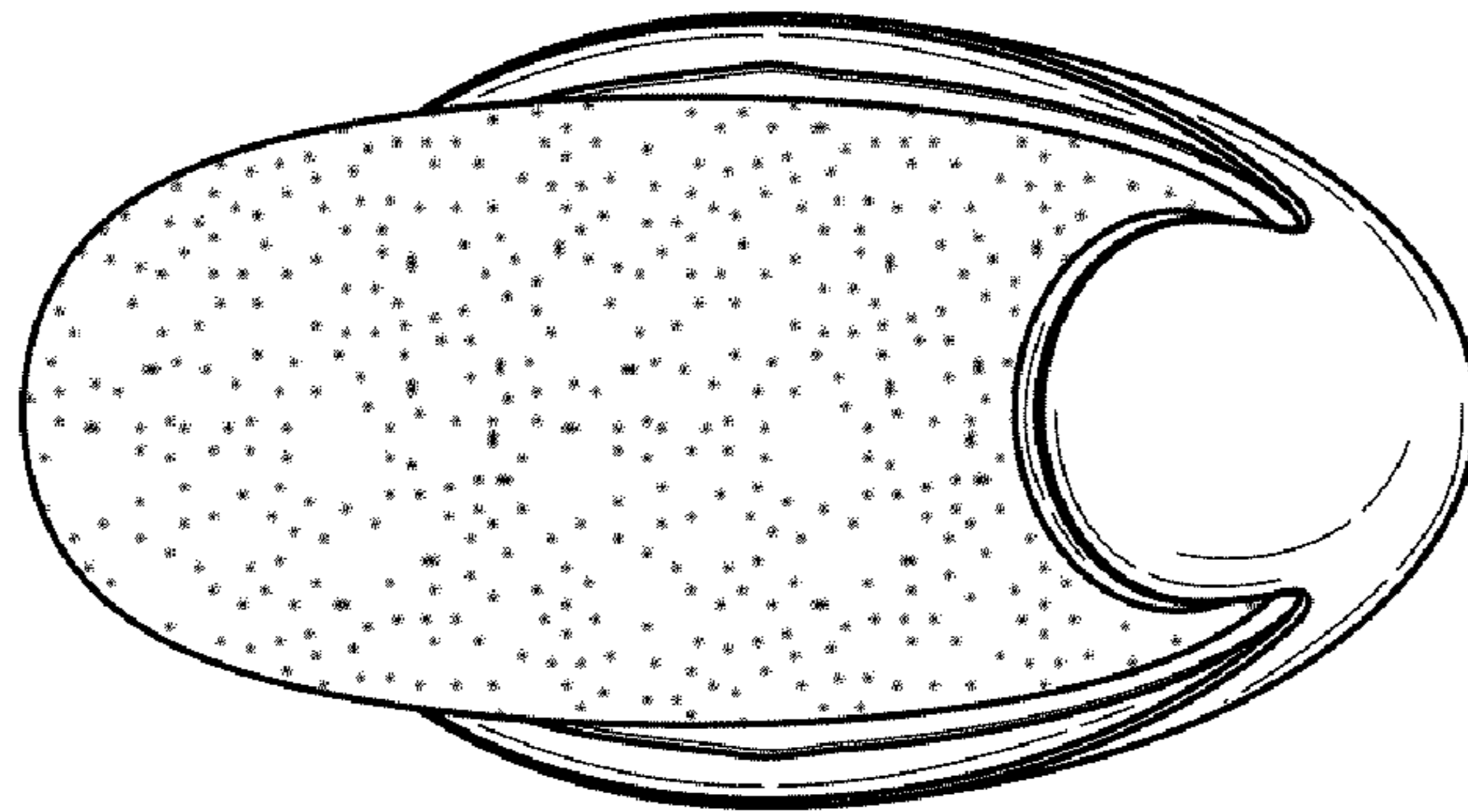

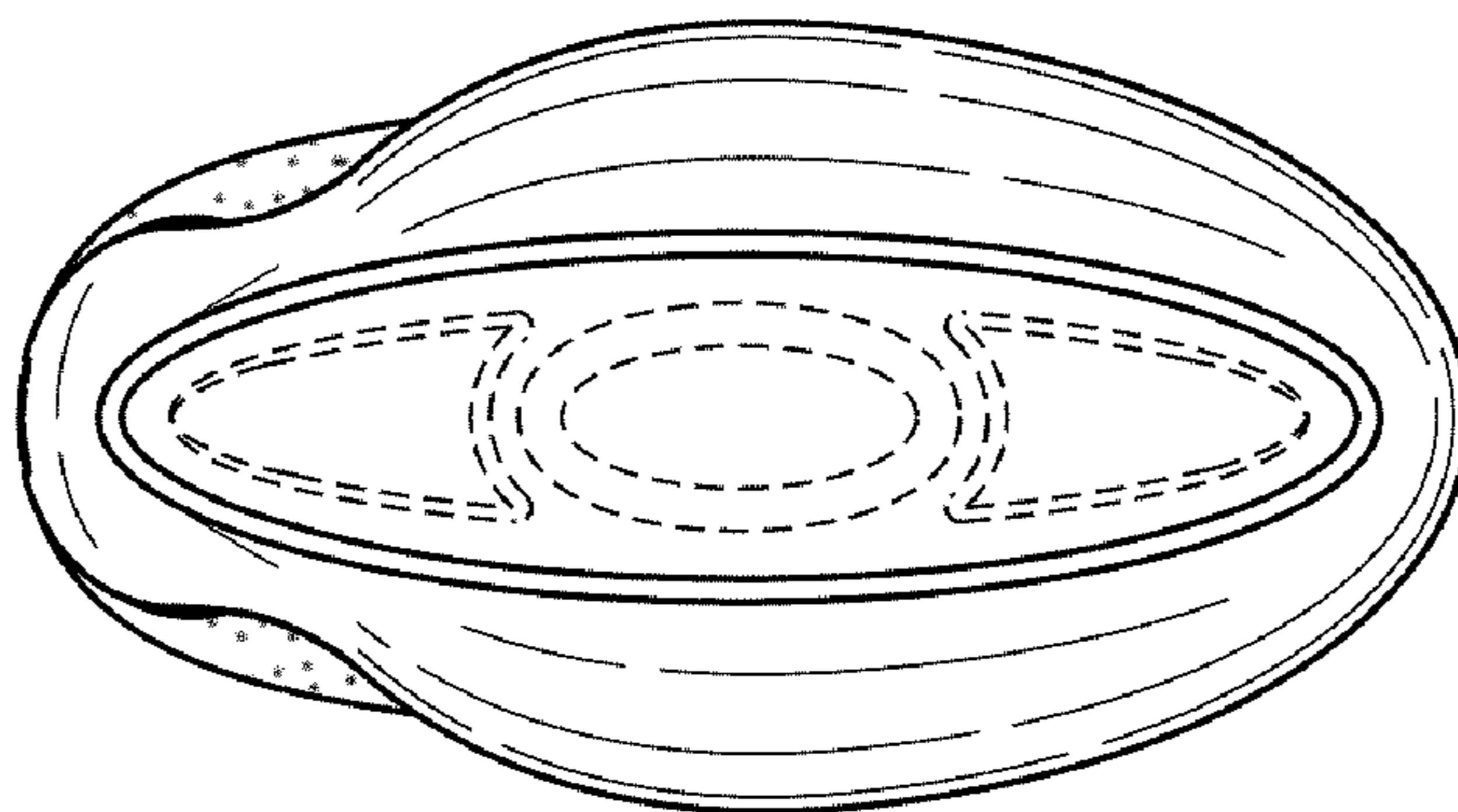

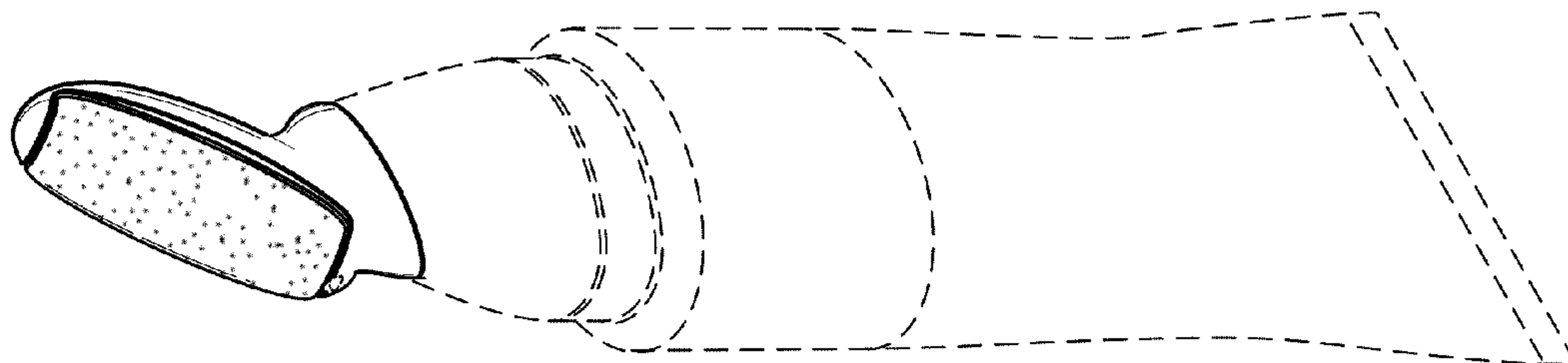

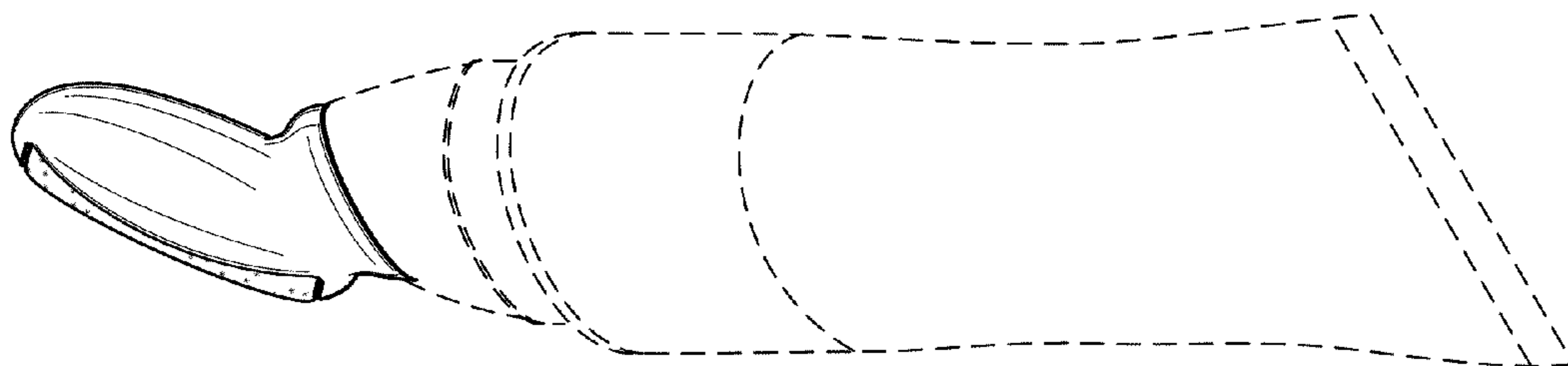

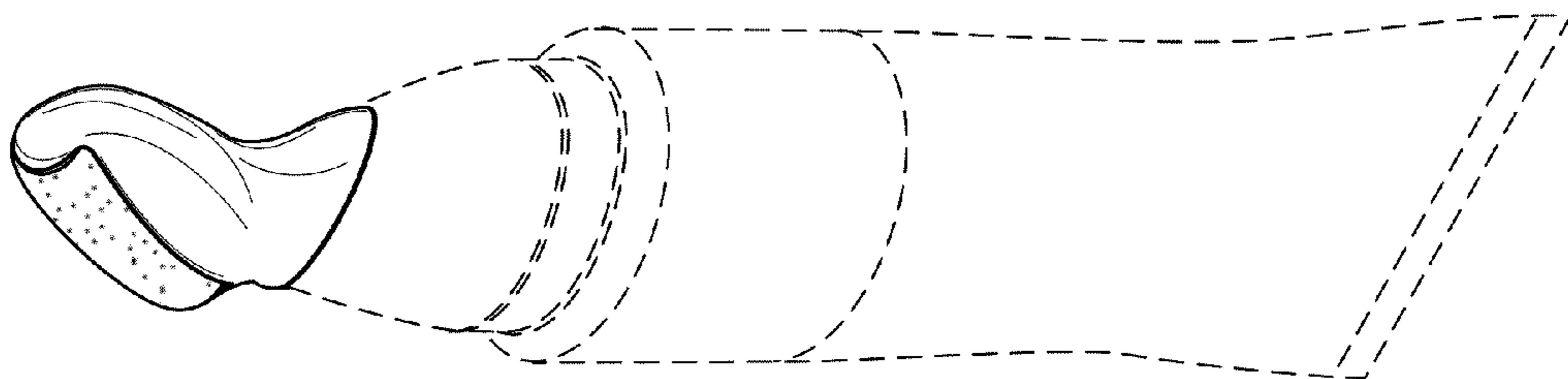

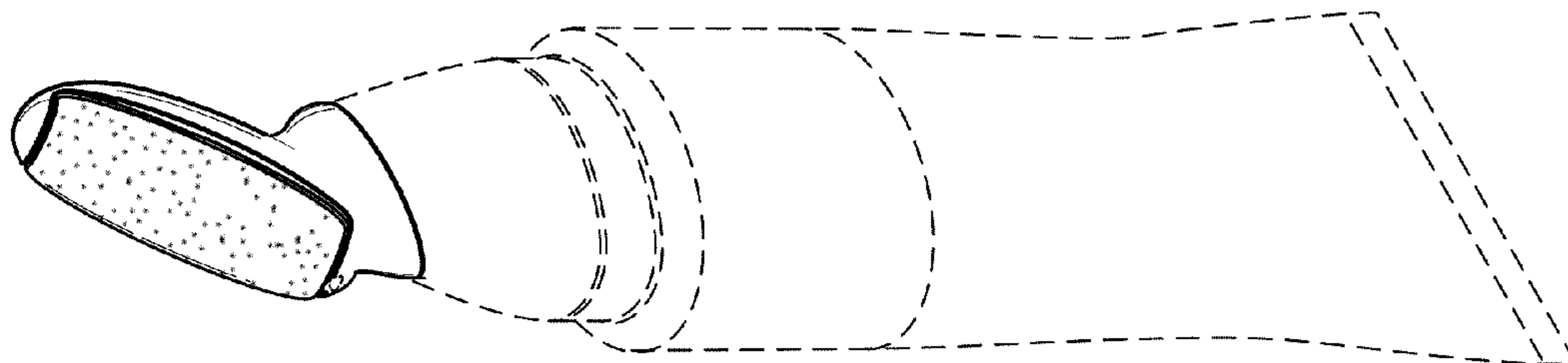

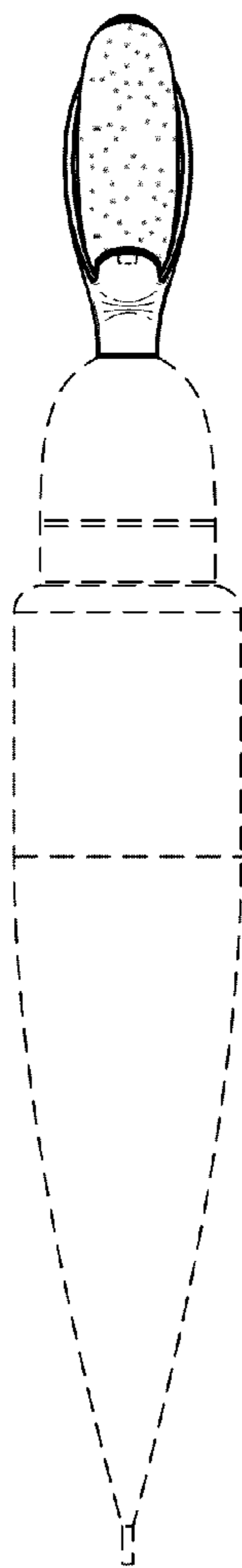

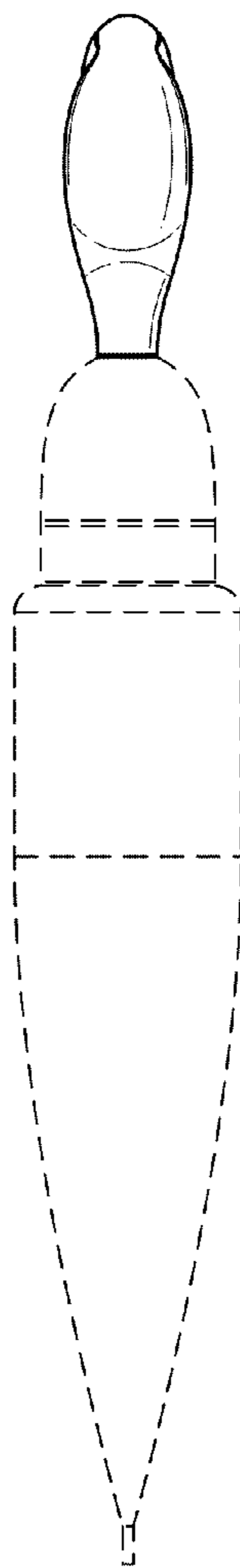

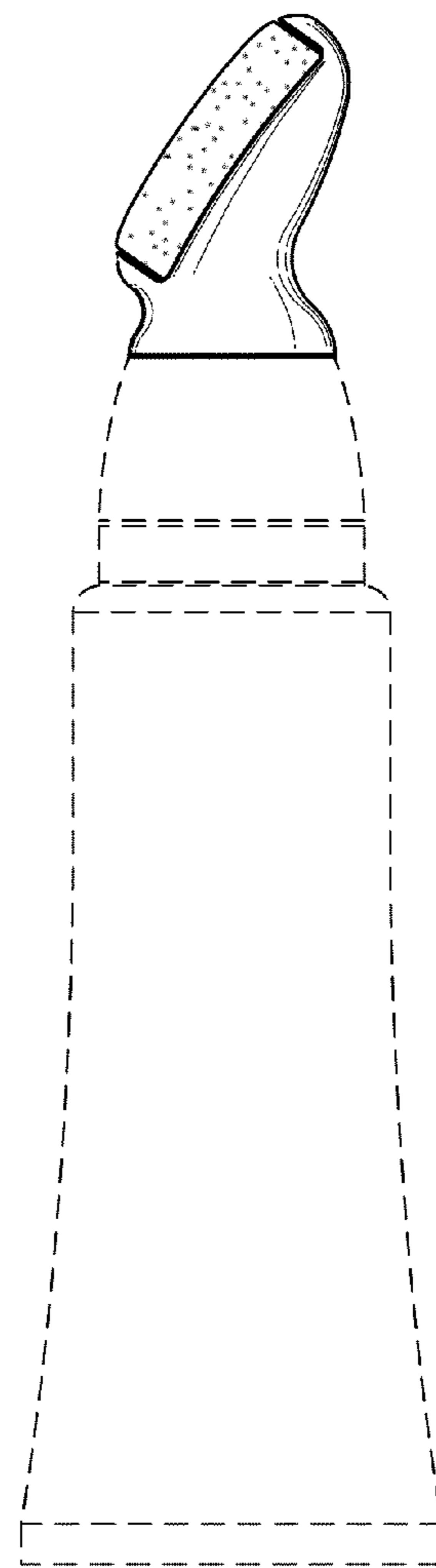

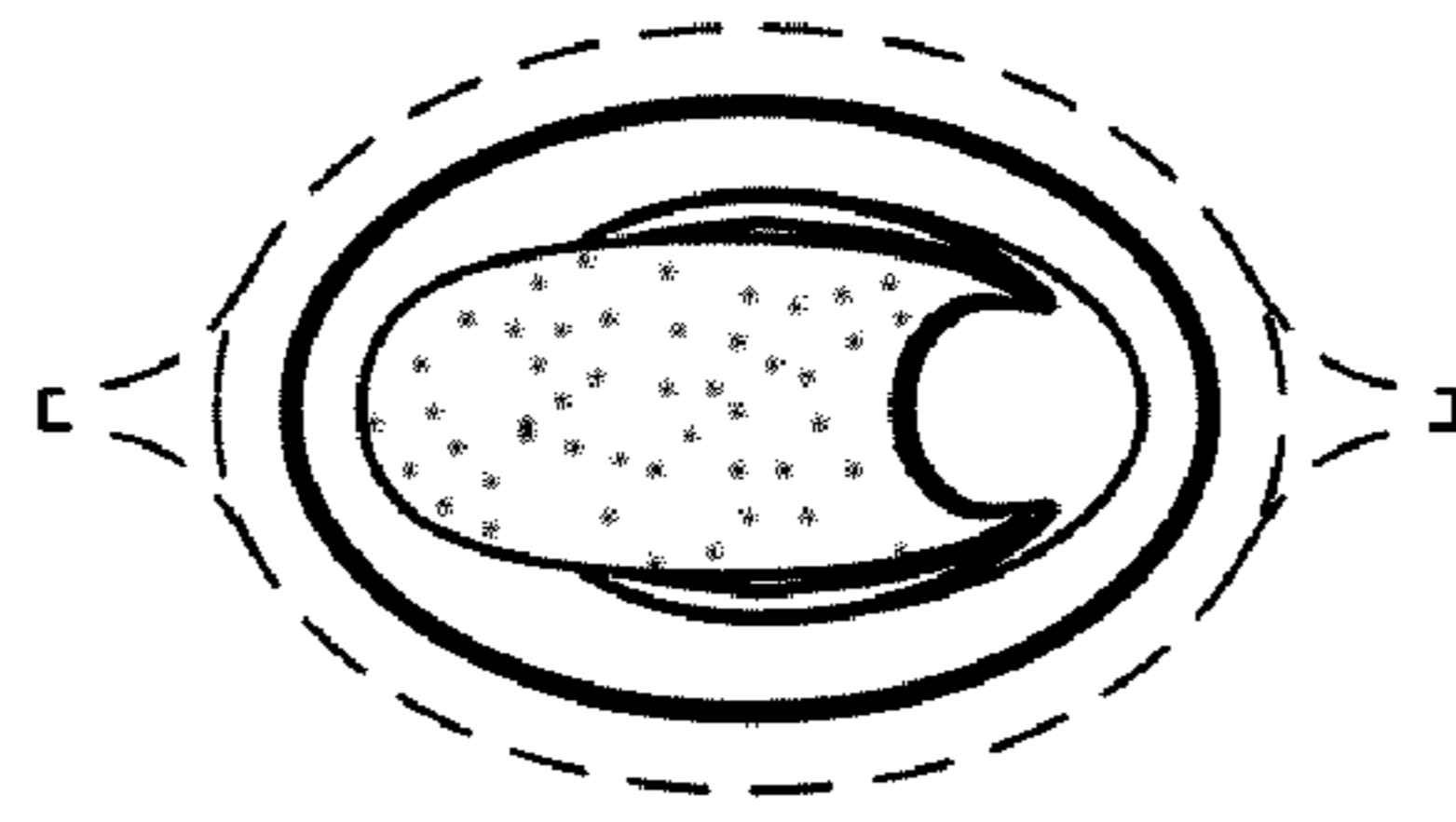

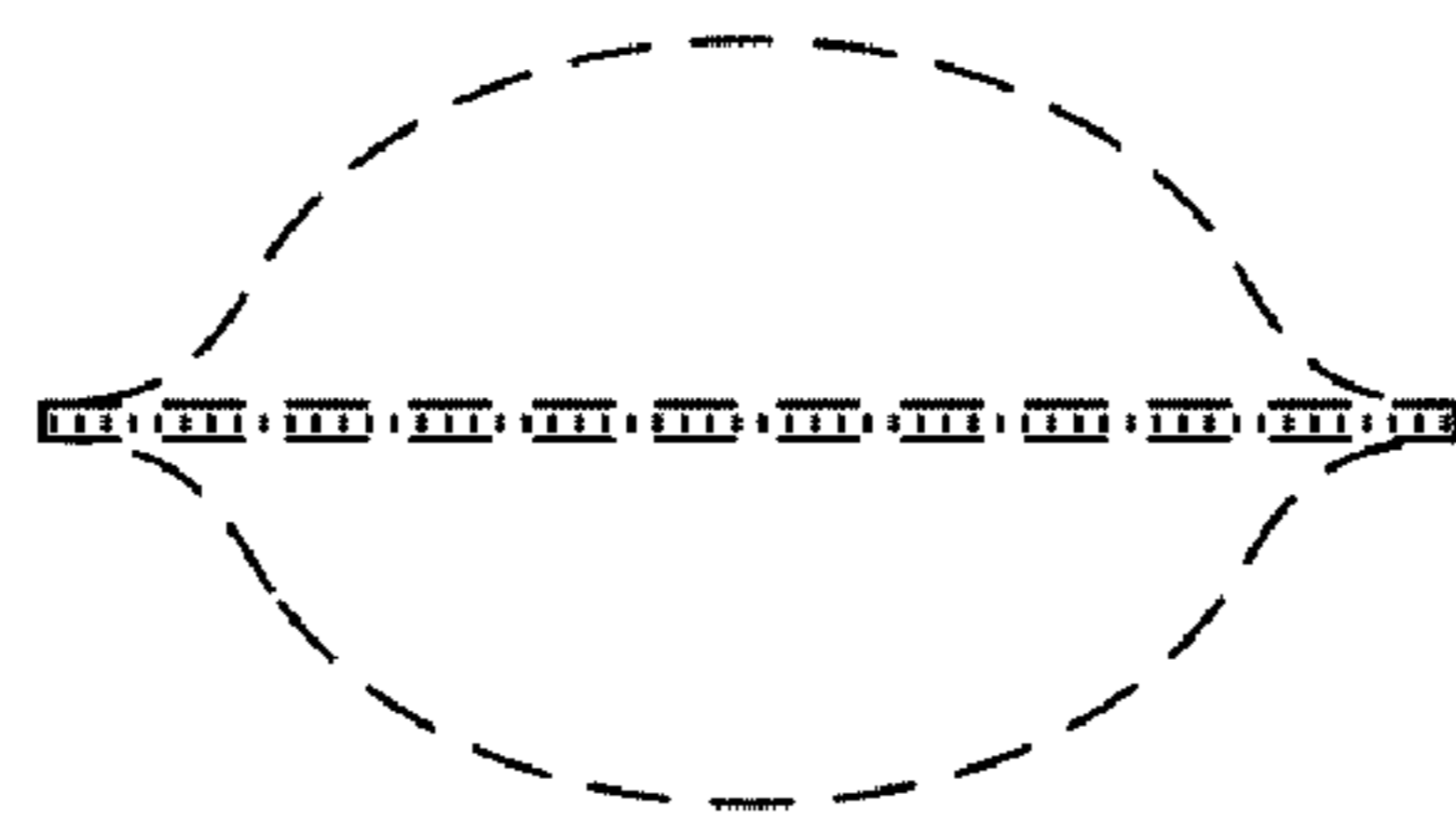
