FIG. 5 is a front view thereof.

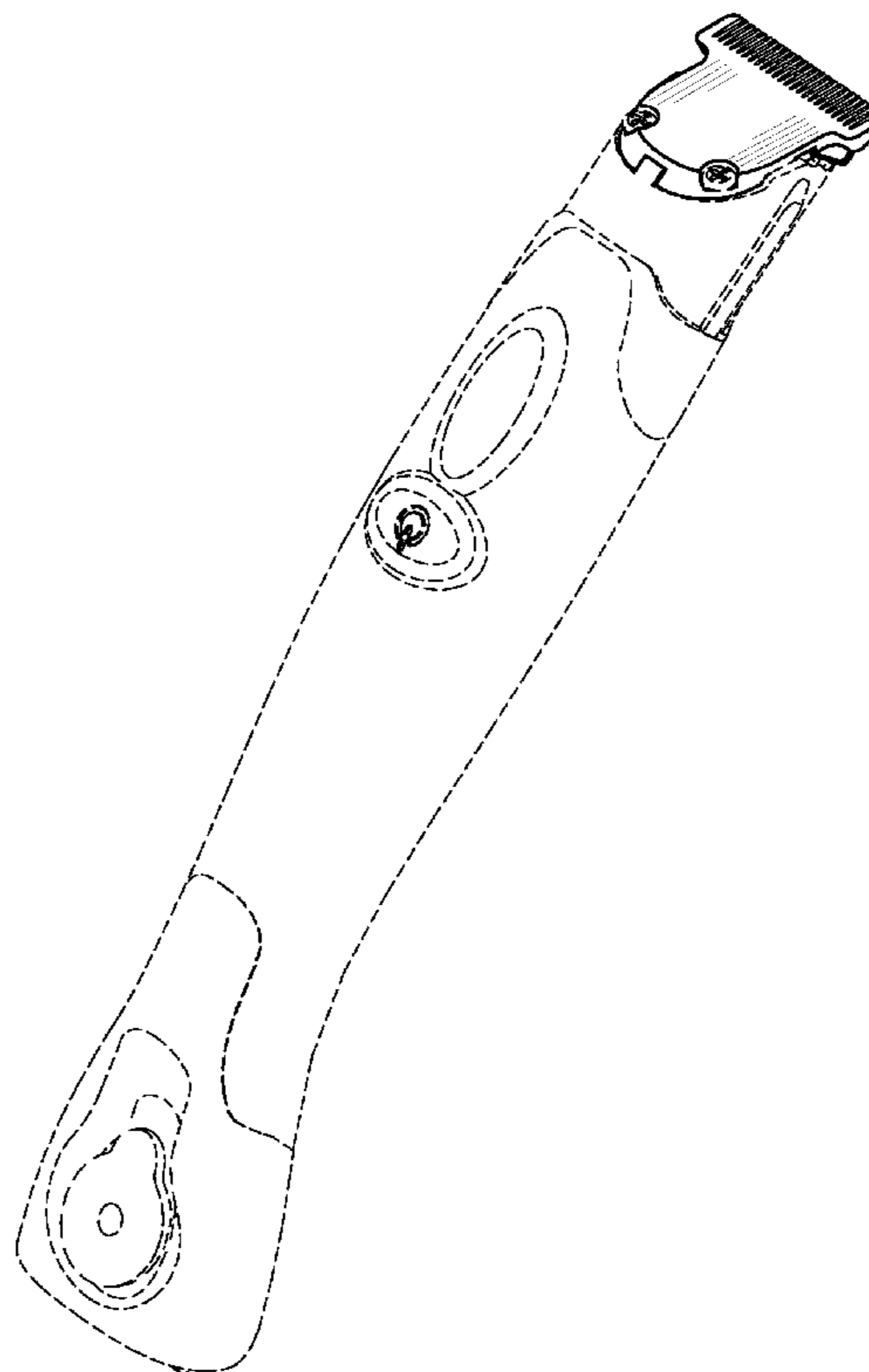
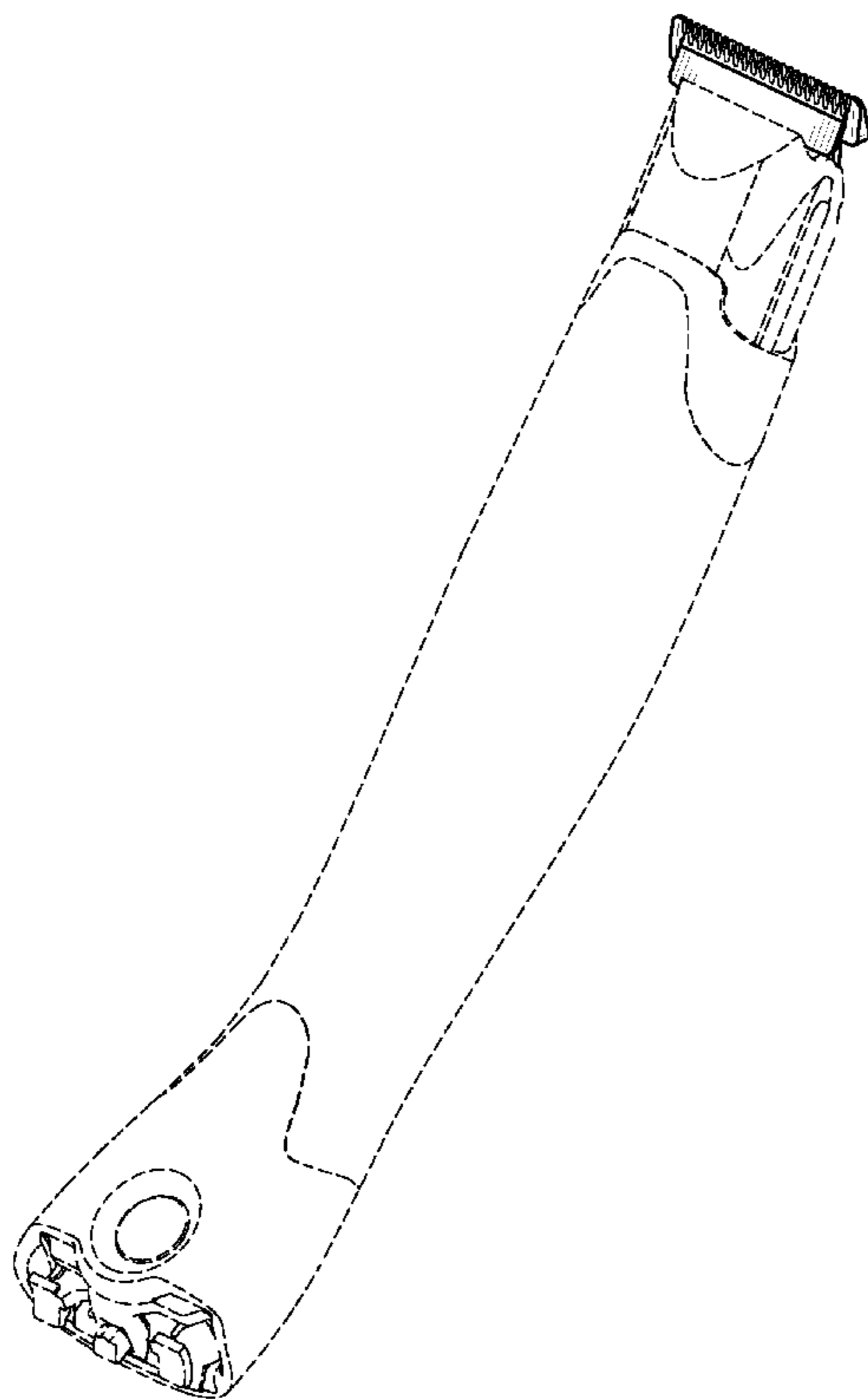
FIG. 6 is a right view of FIG. 5.

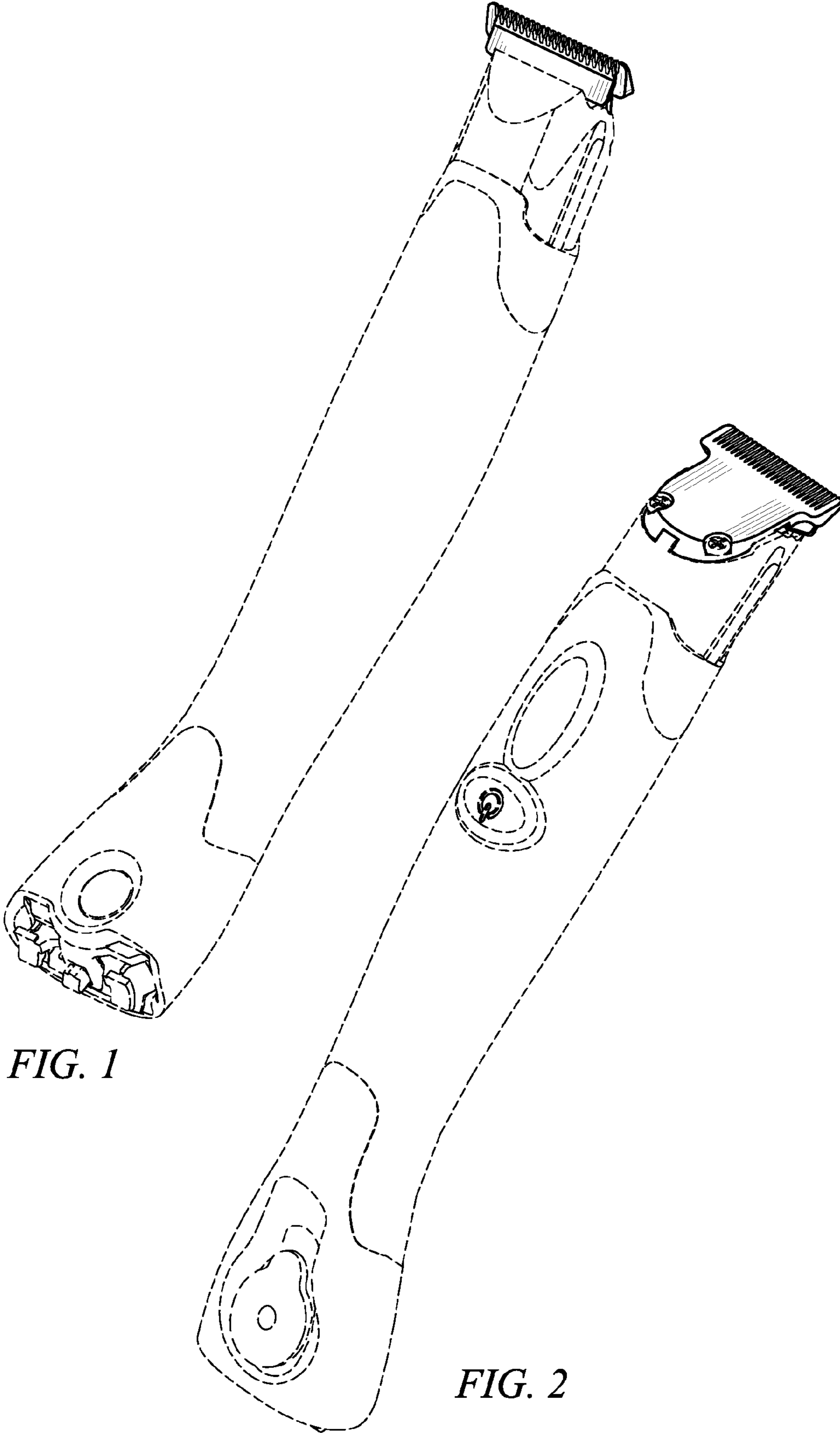
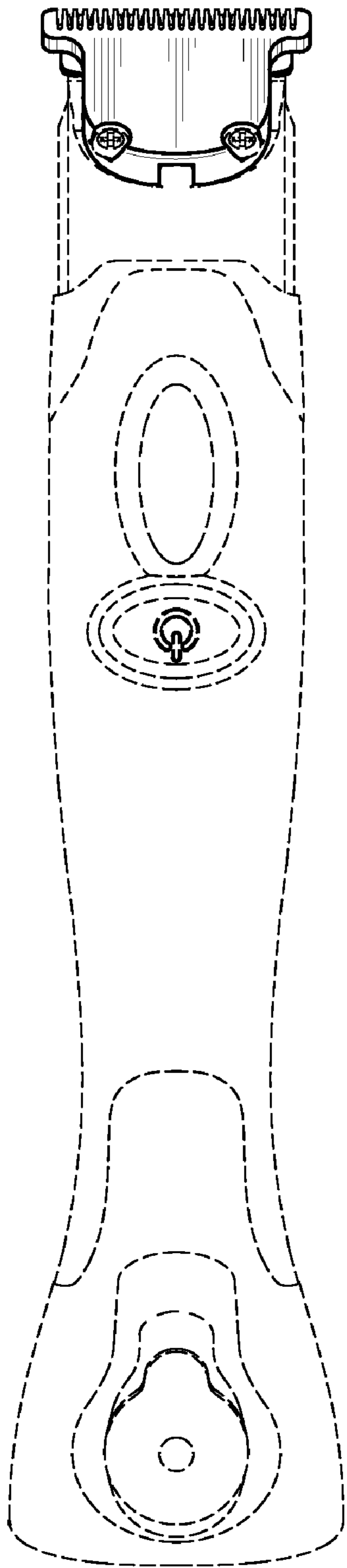
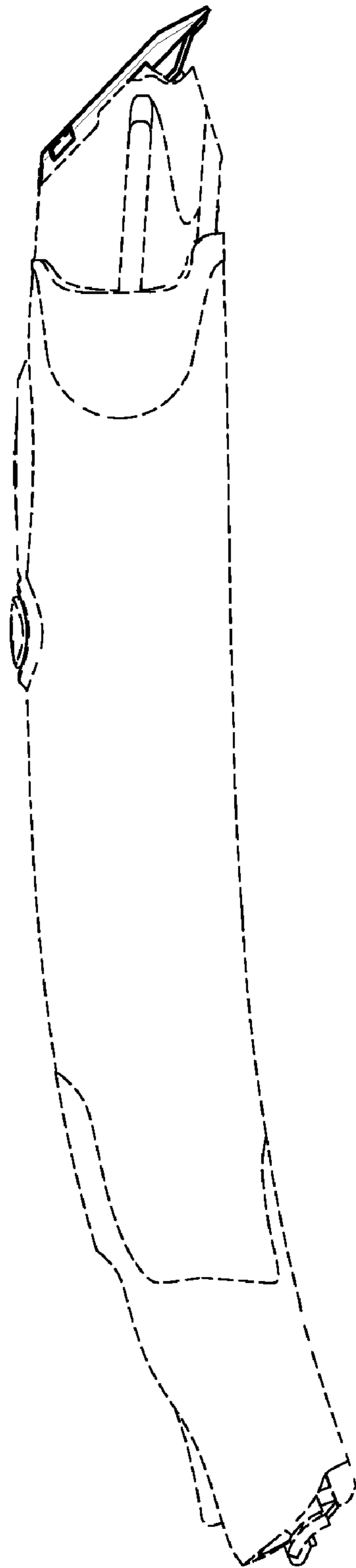

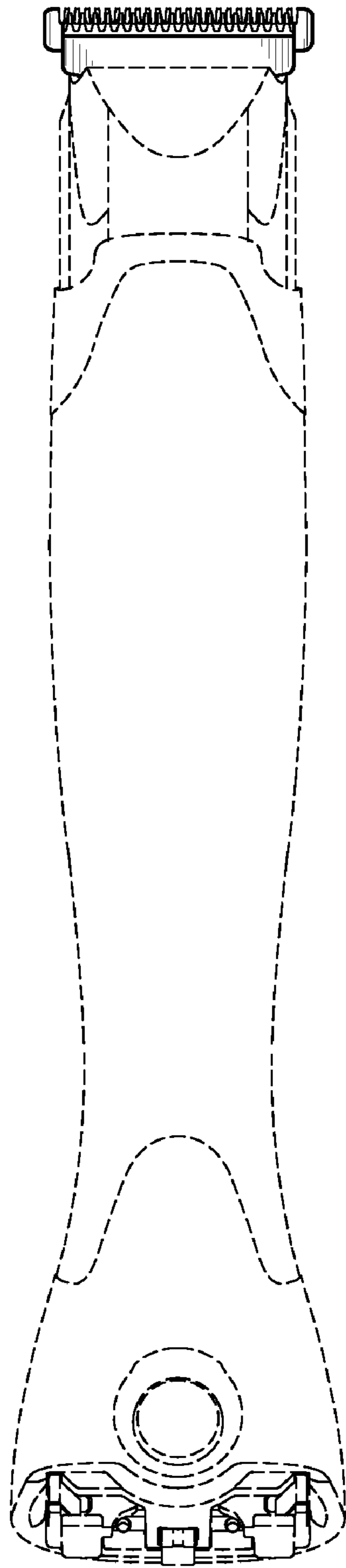

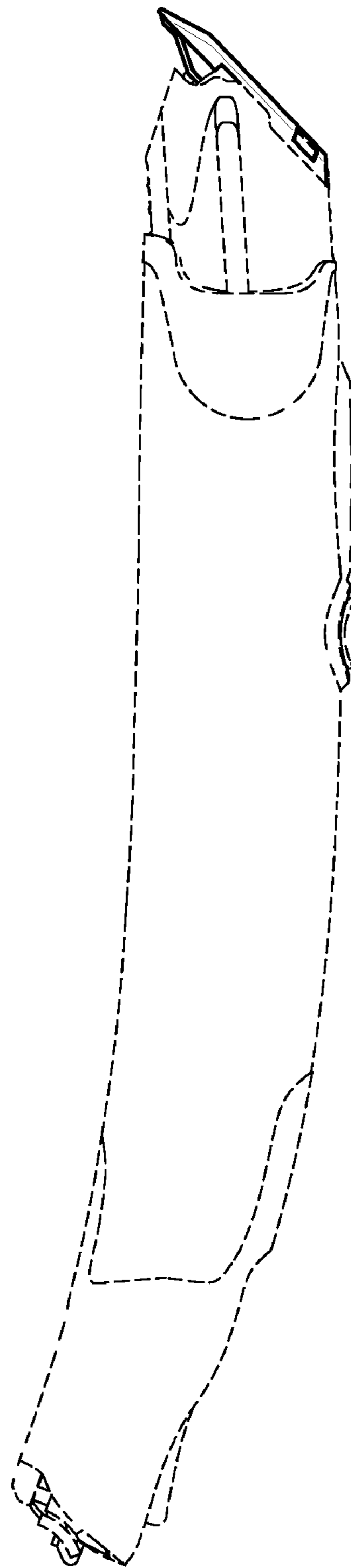

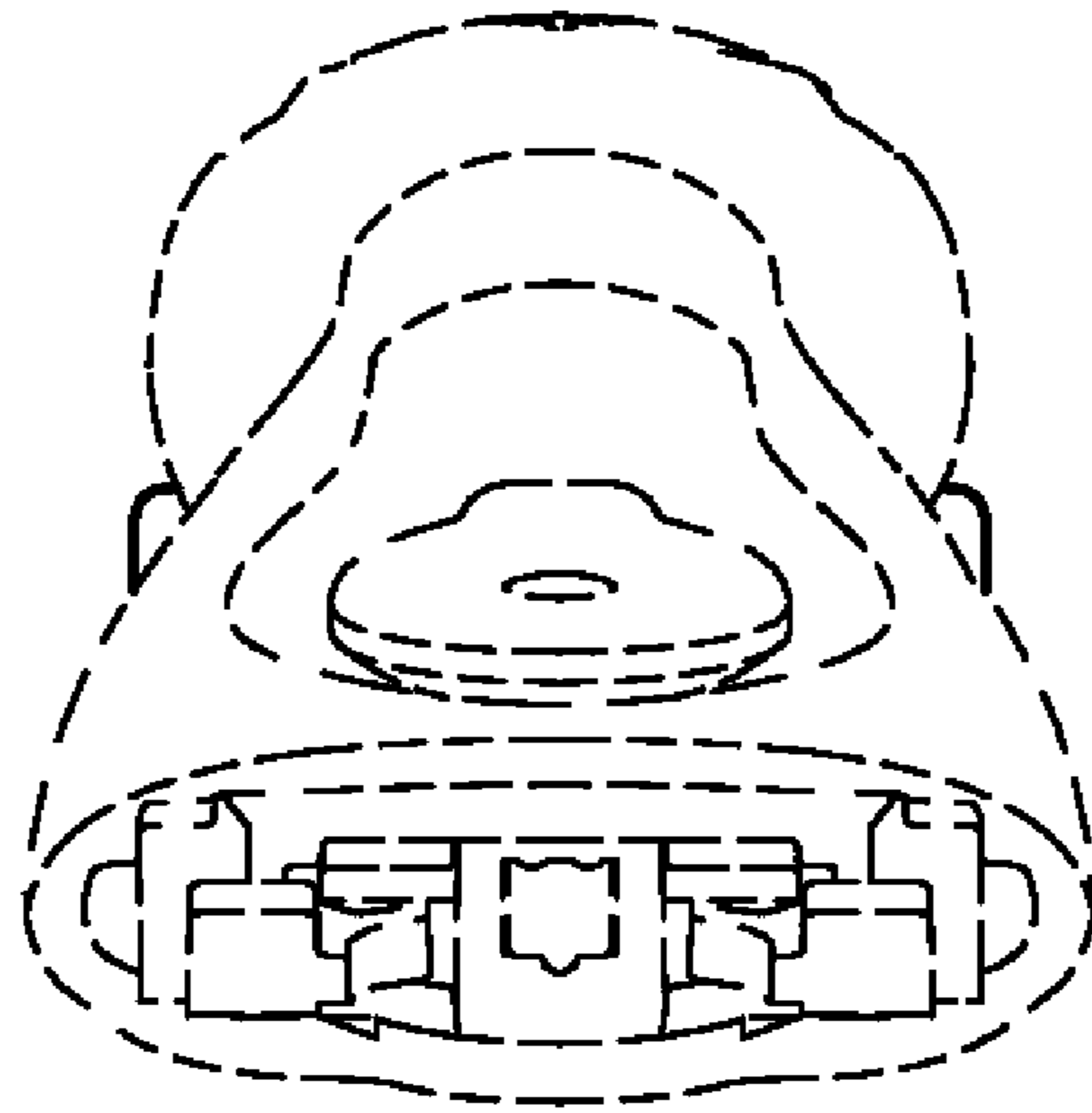

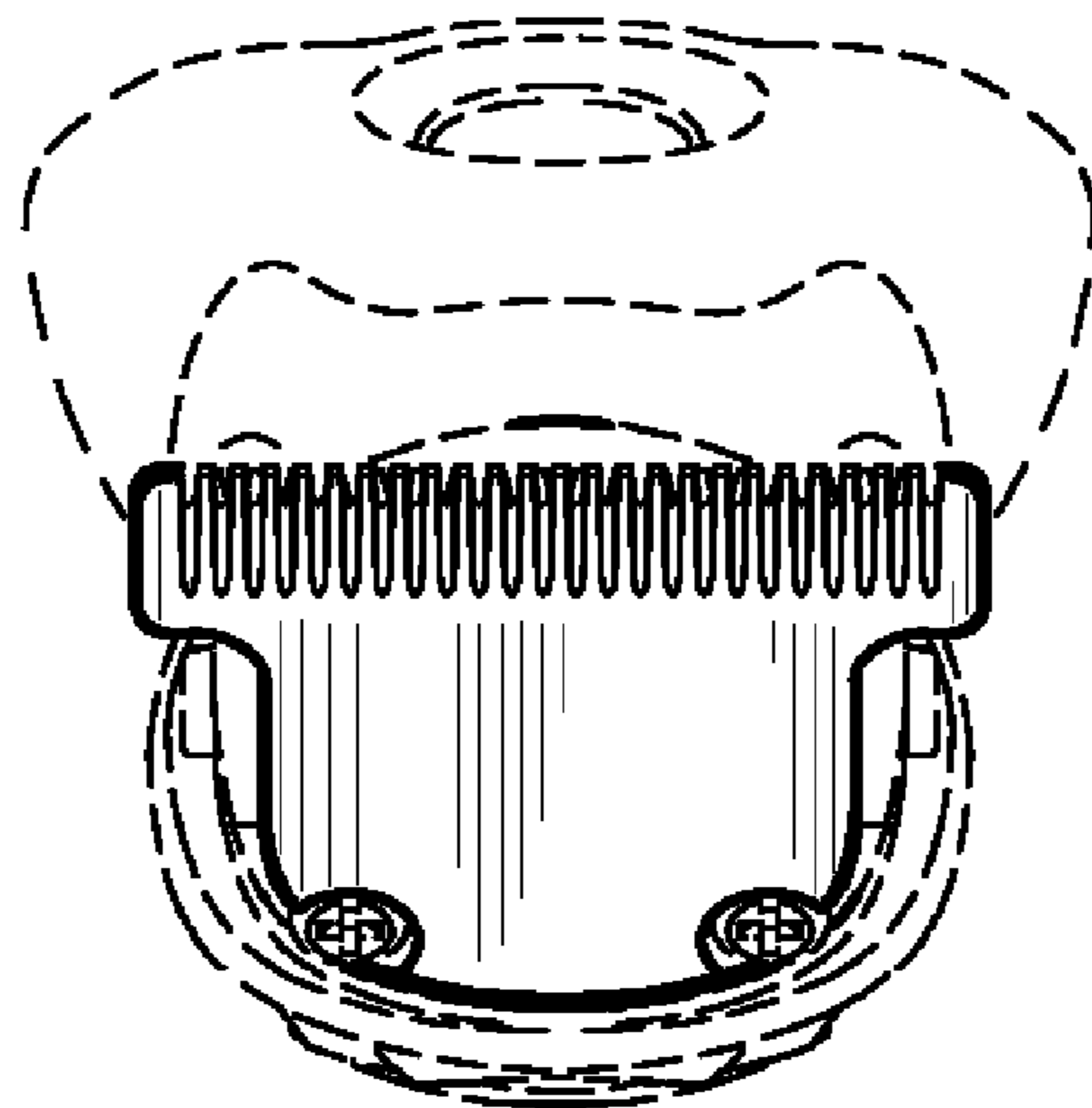
