DESCRIPTION

FIG. 17 is a FRONT view thereof;

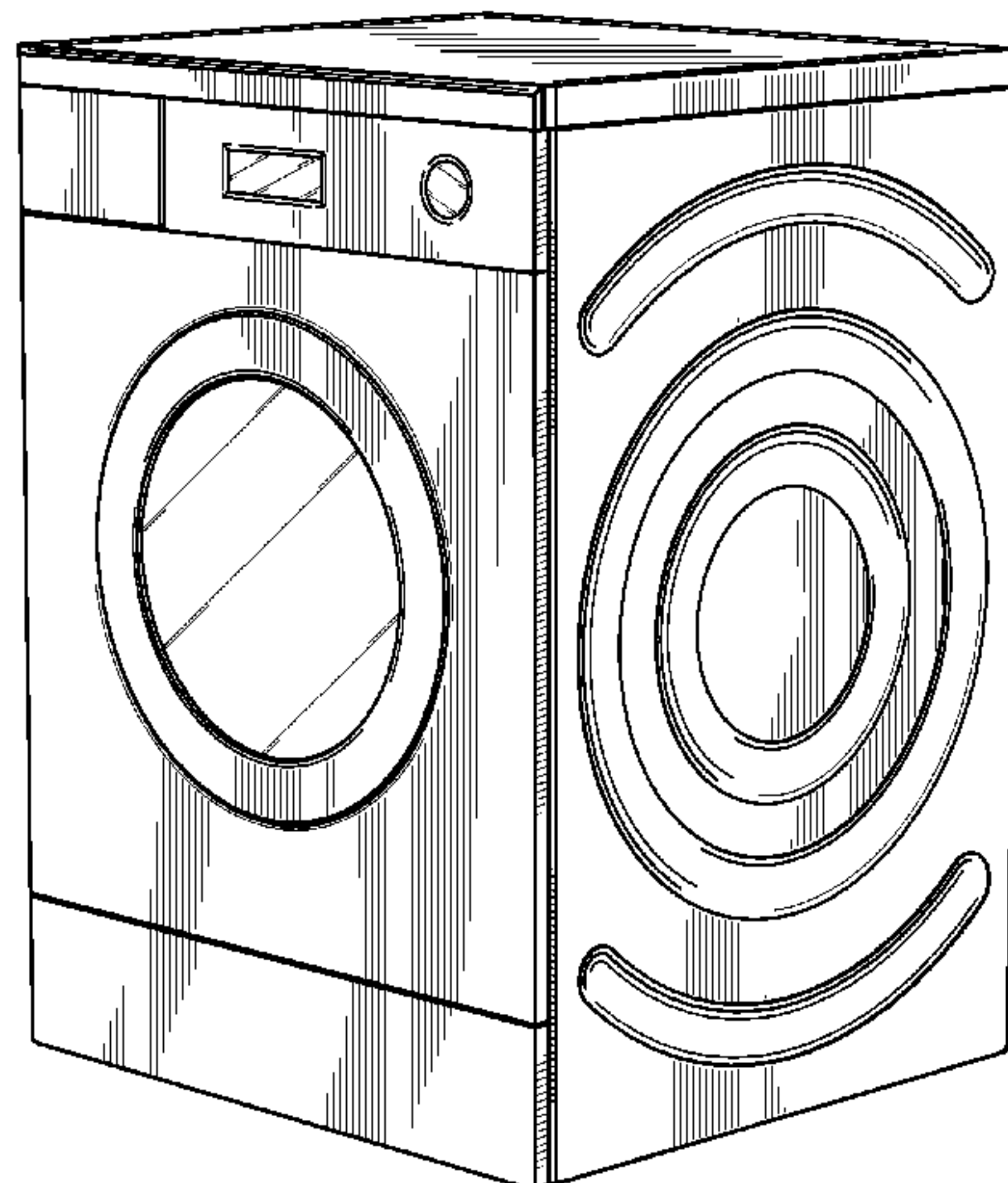
FIG. 18 is a LEFT SIDE view thereof;

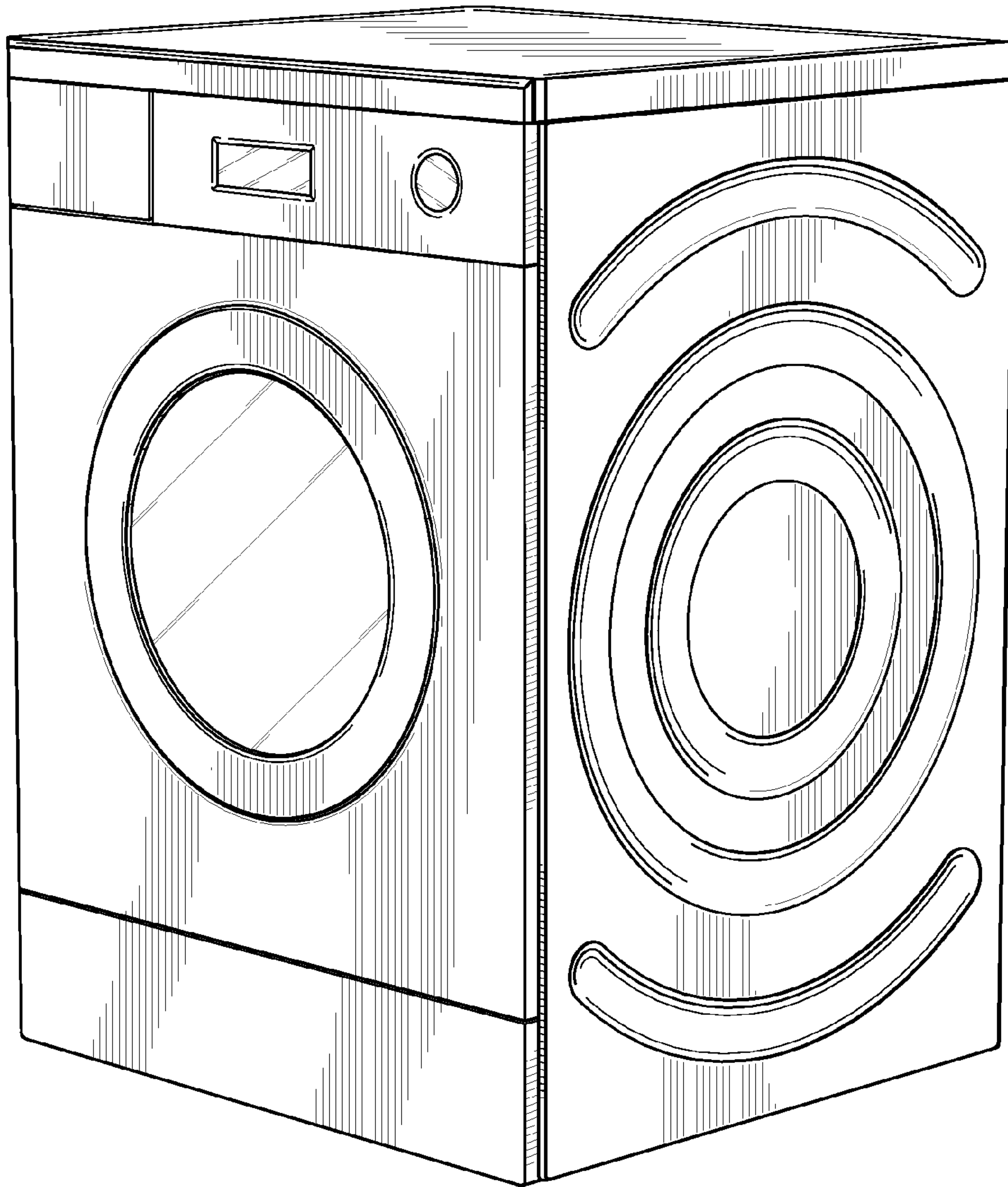

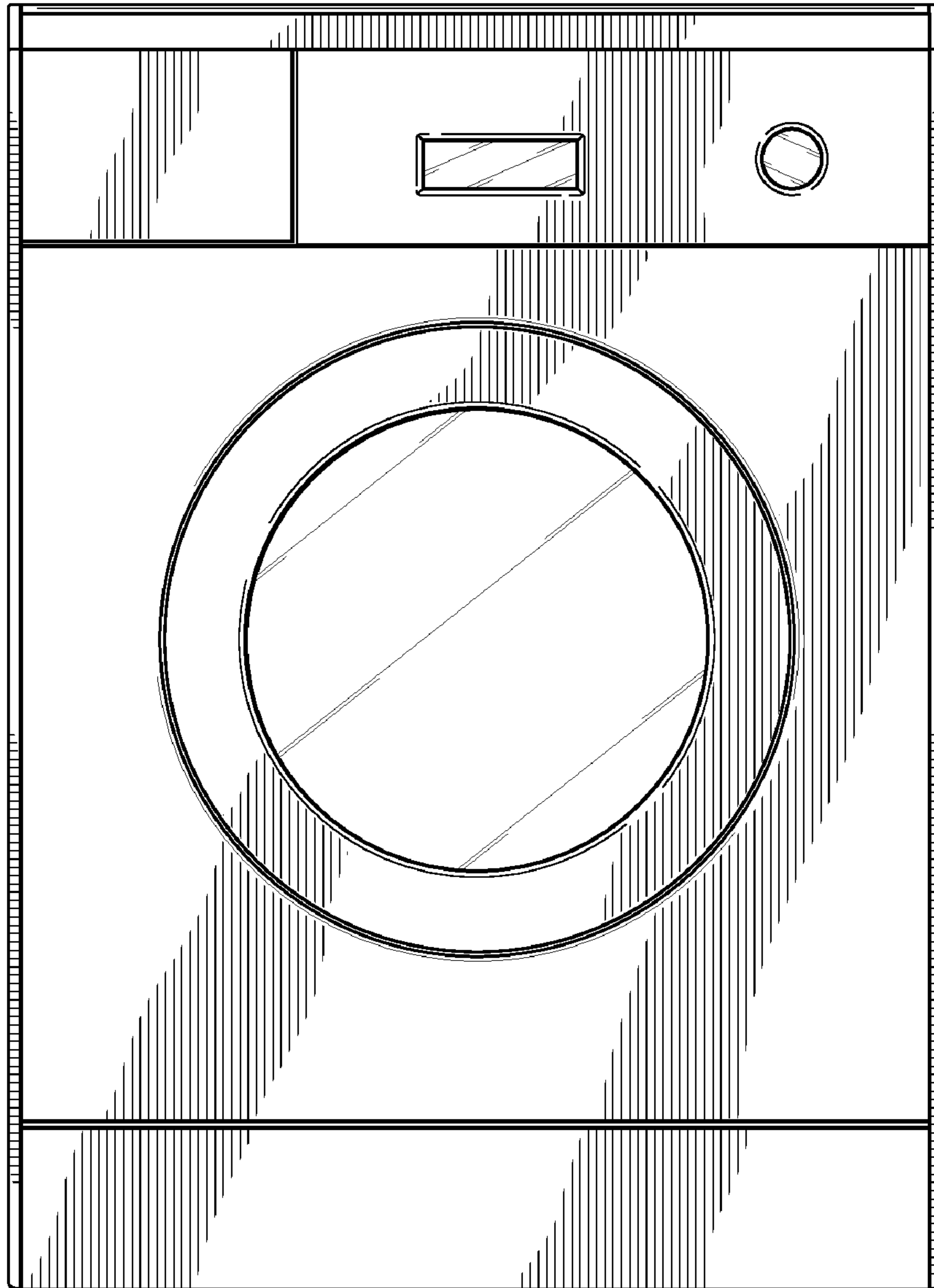

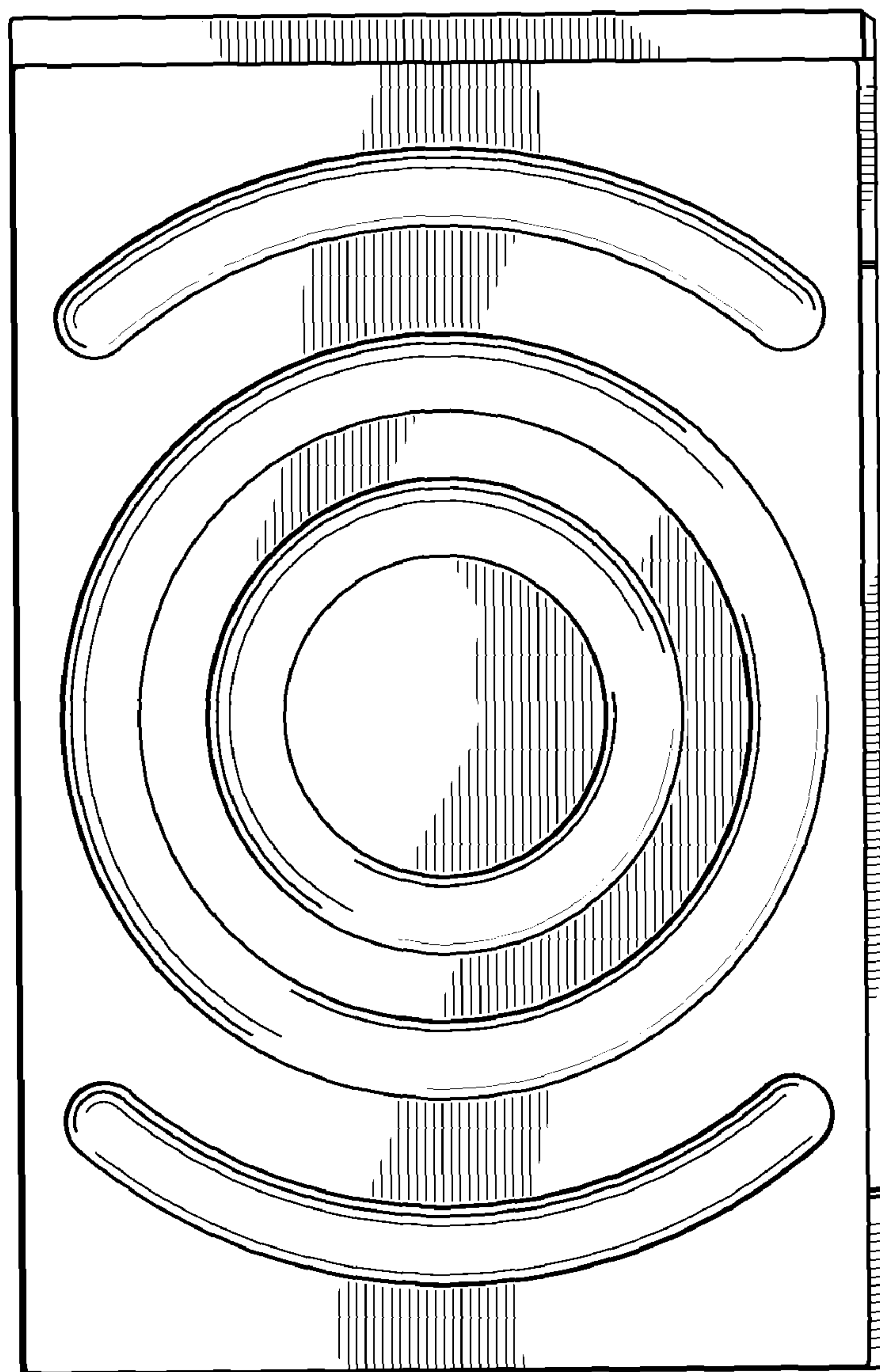

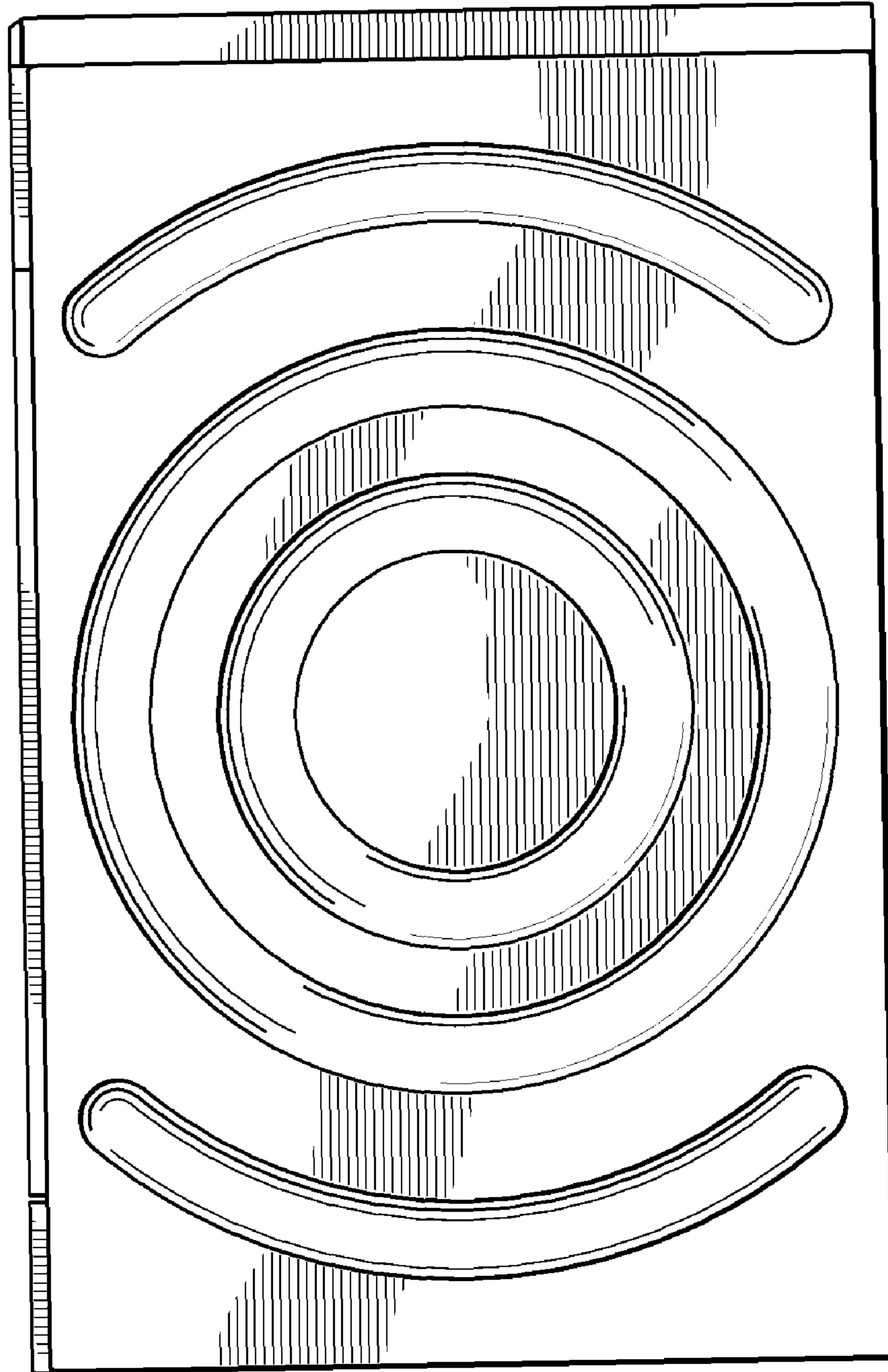

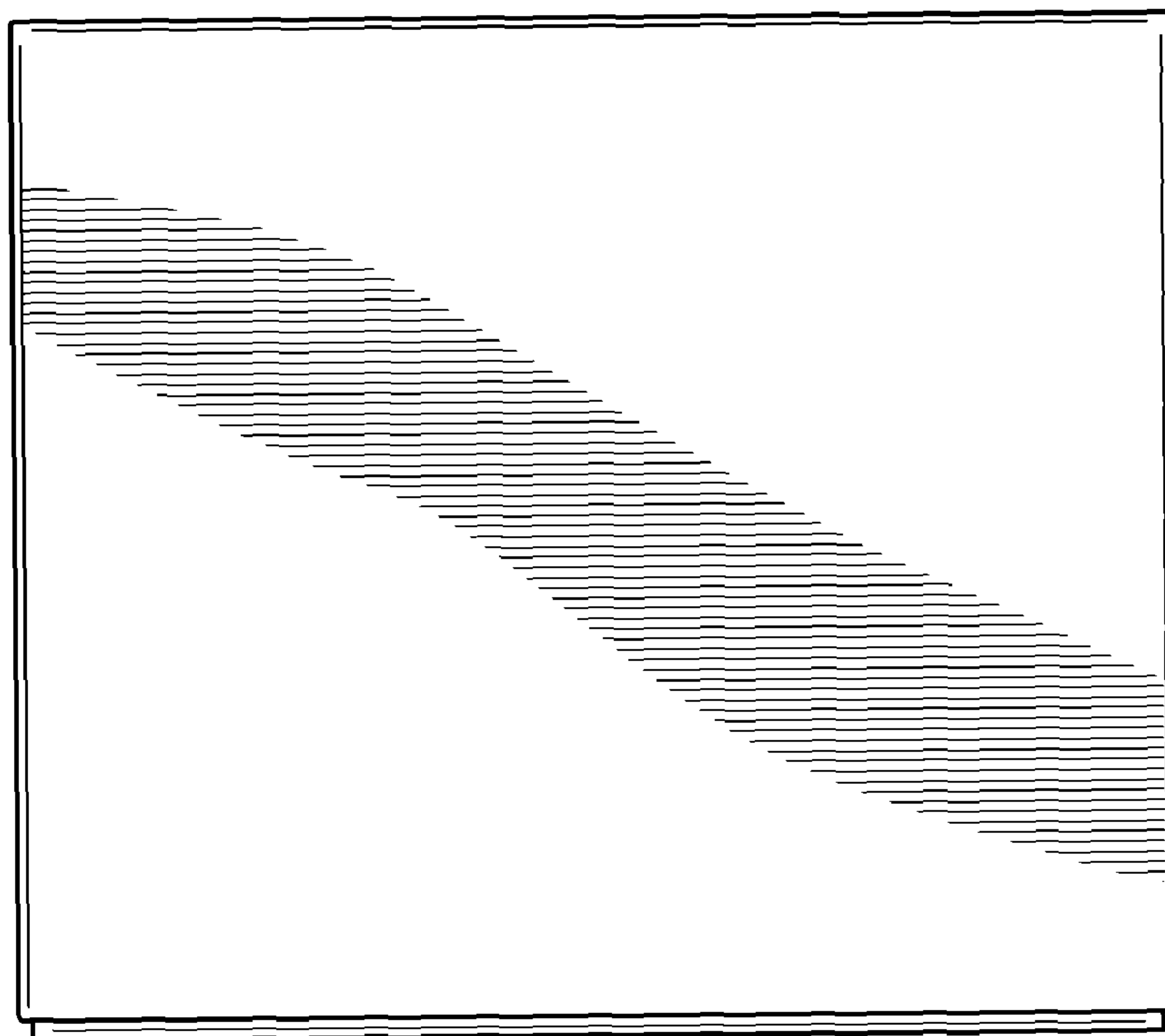

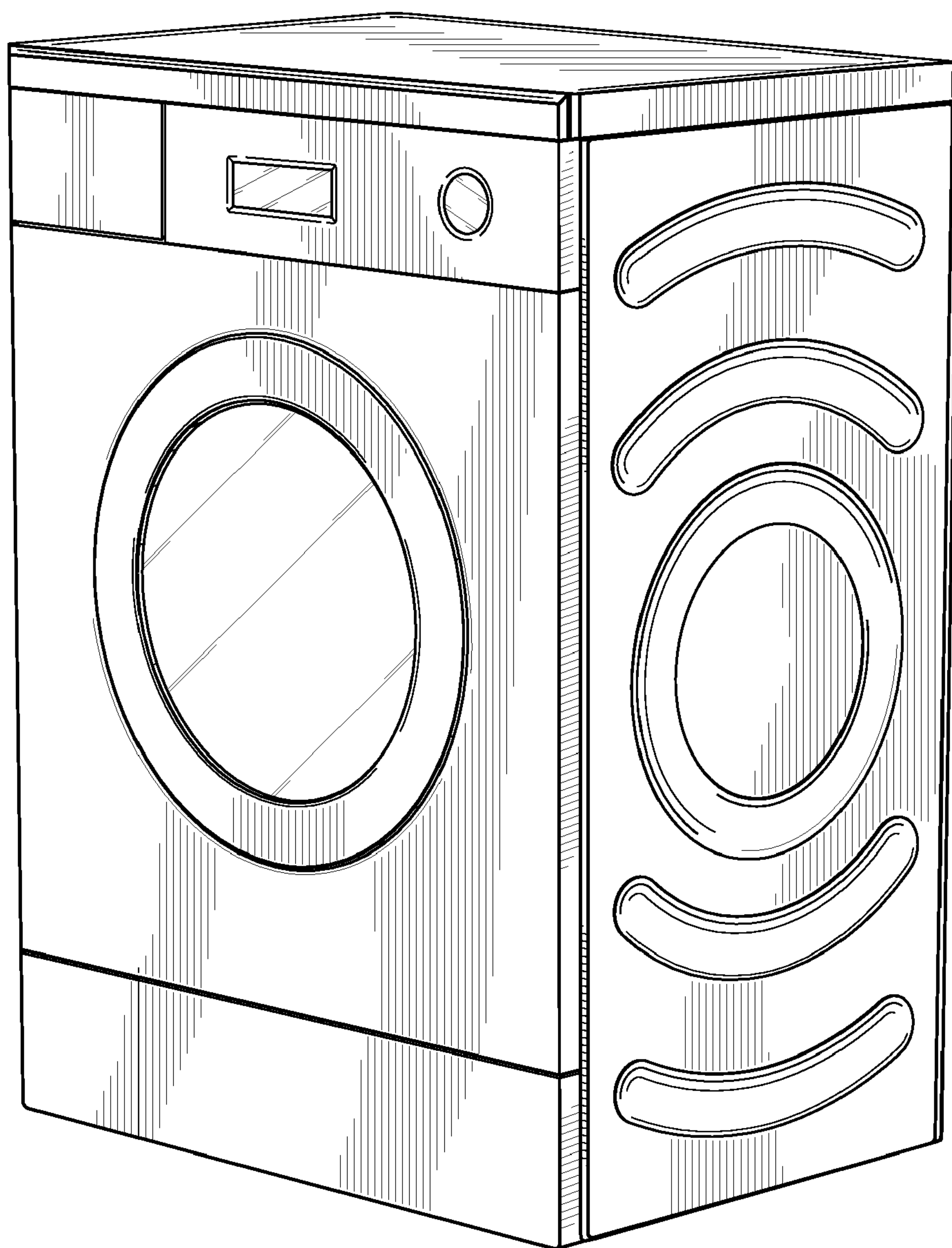

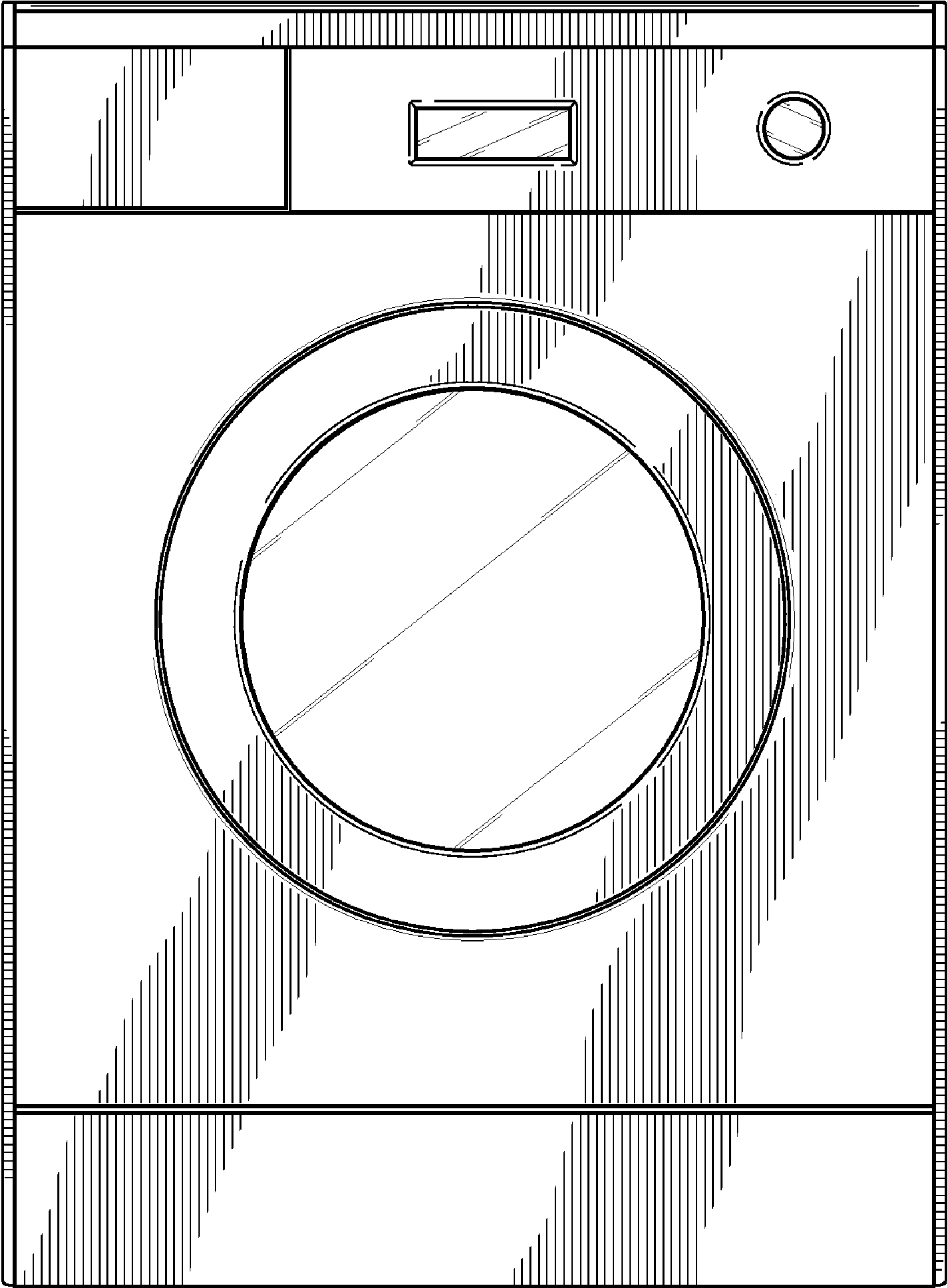

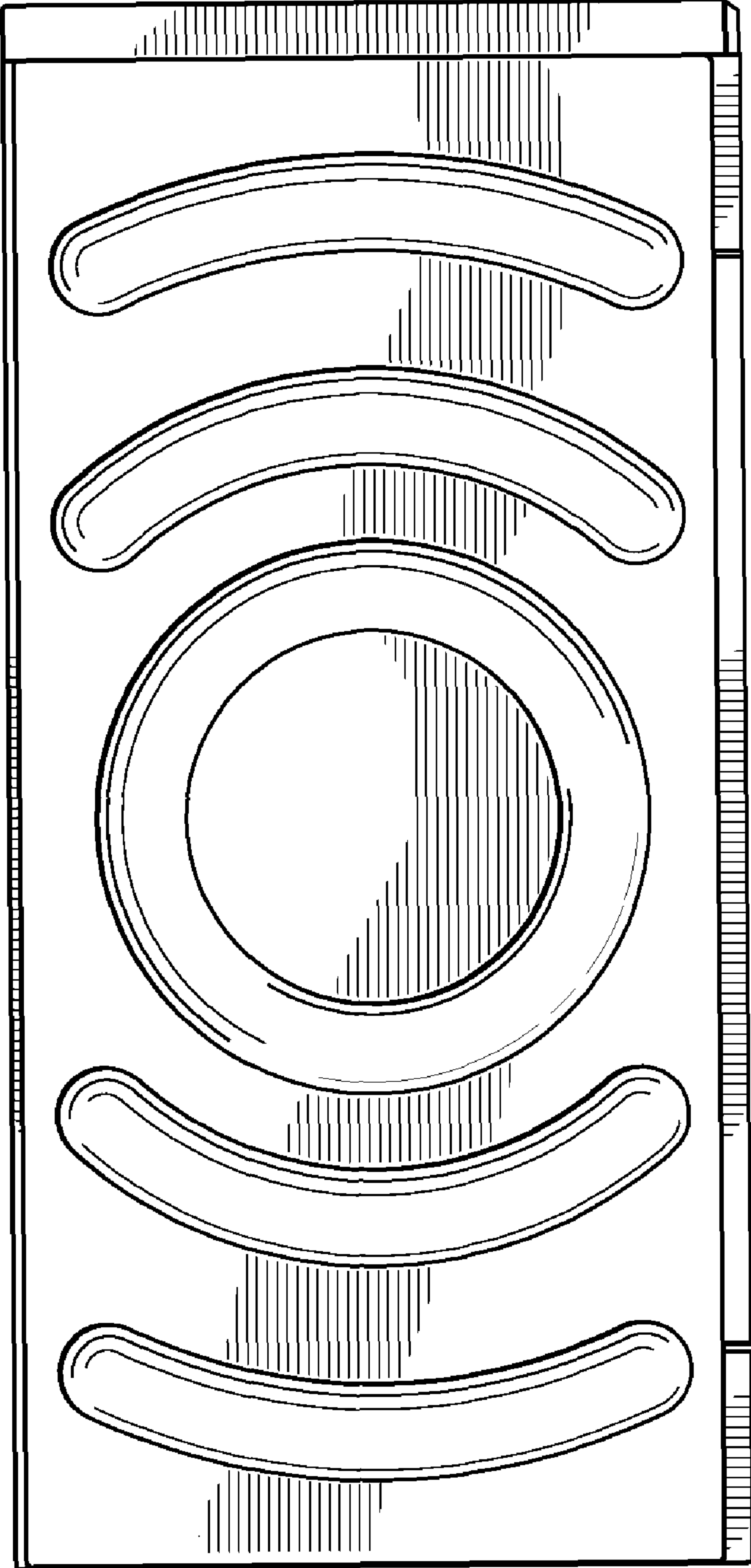

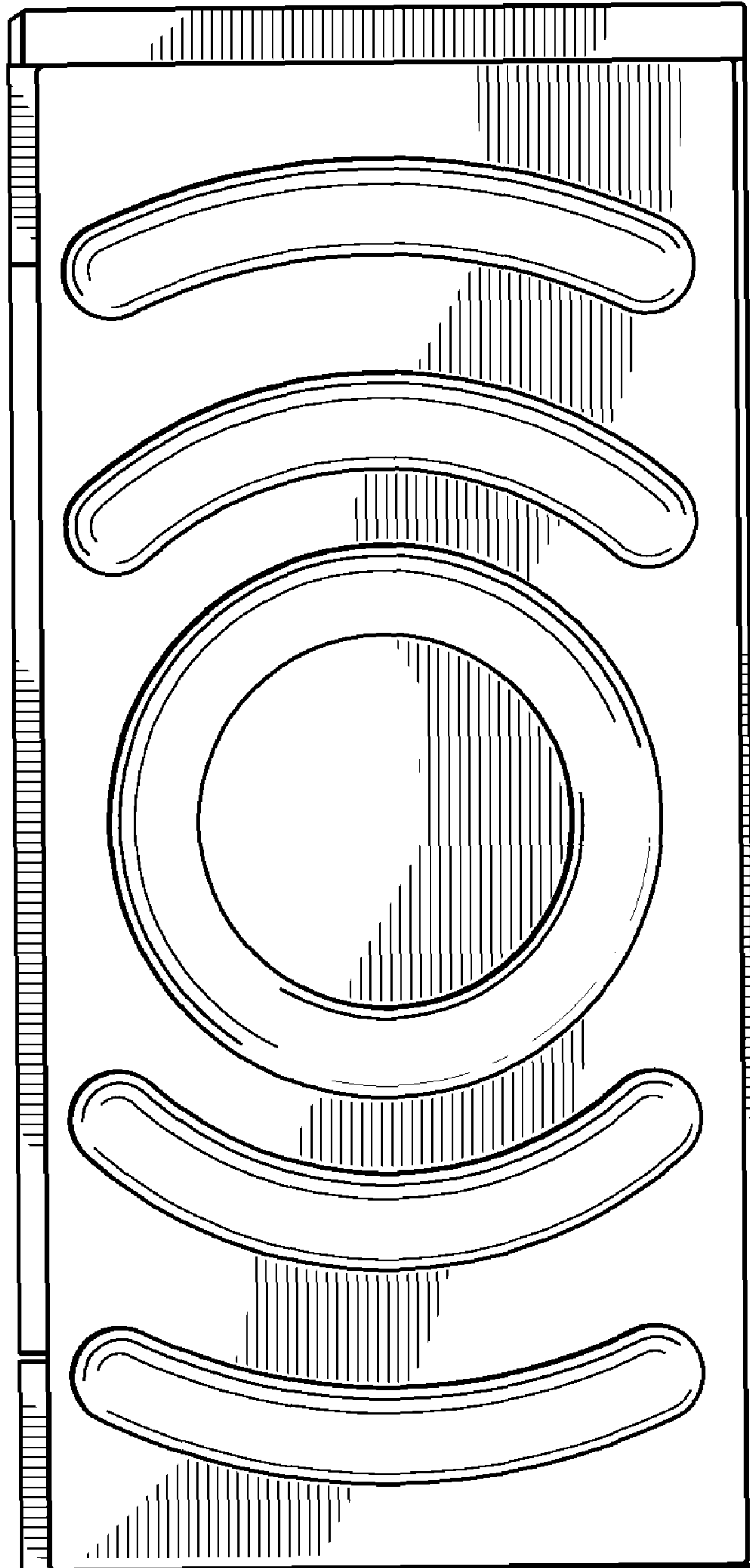

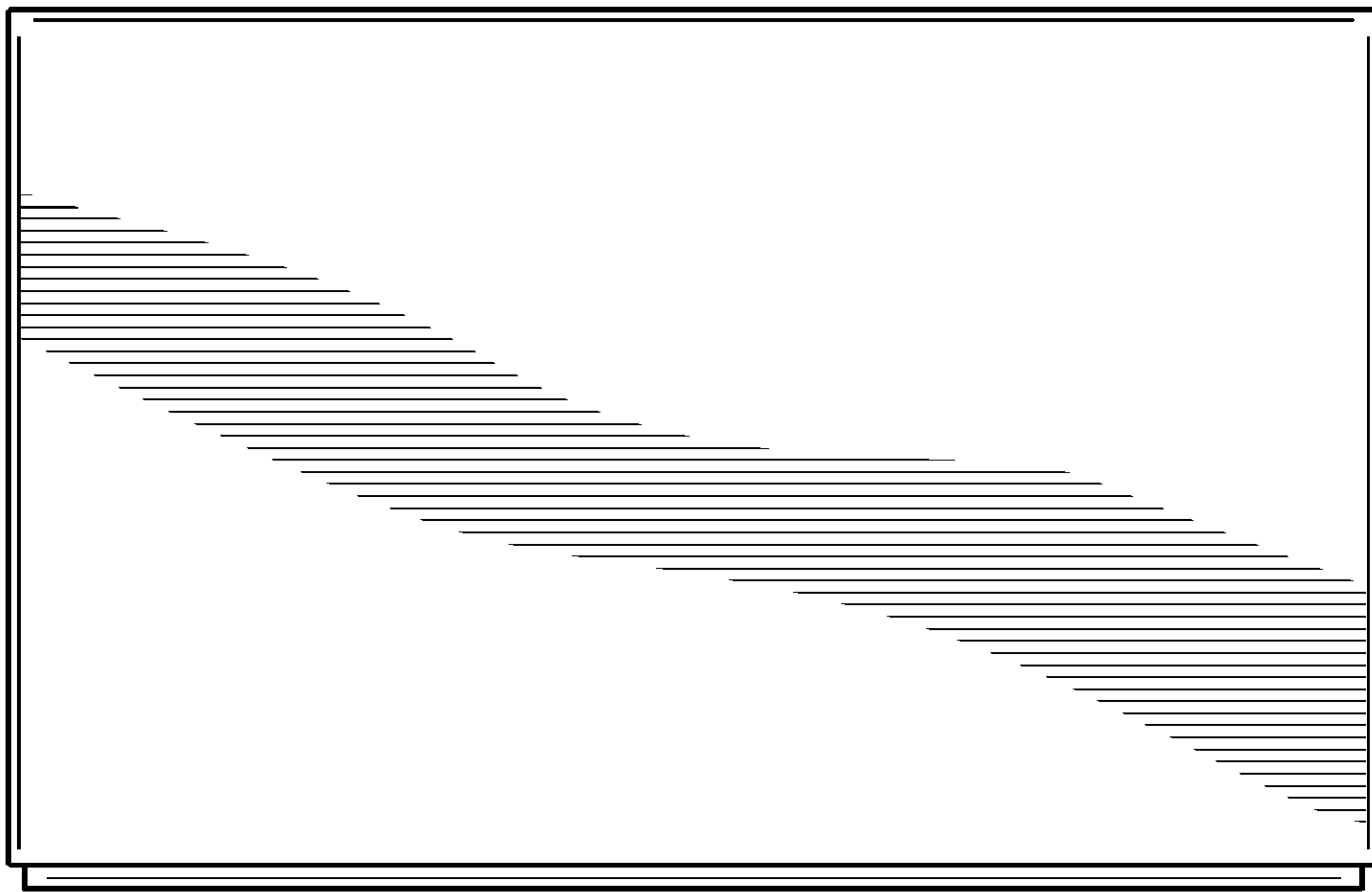

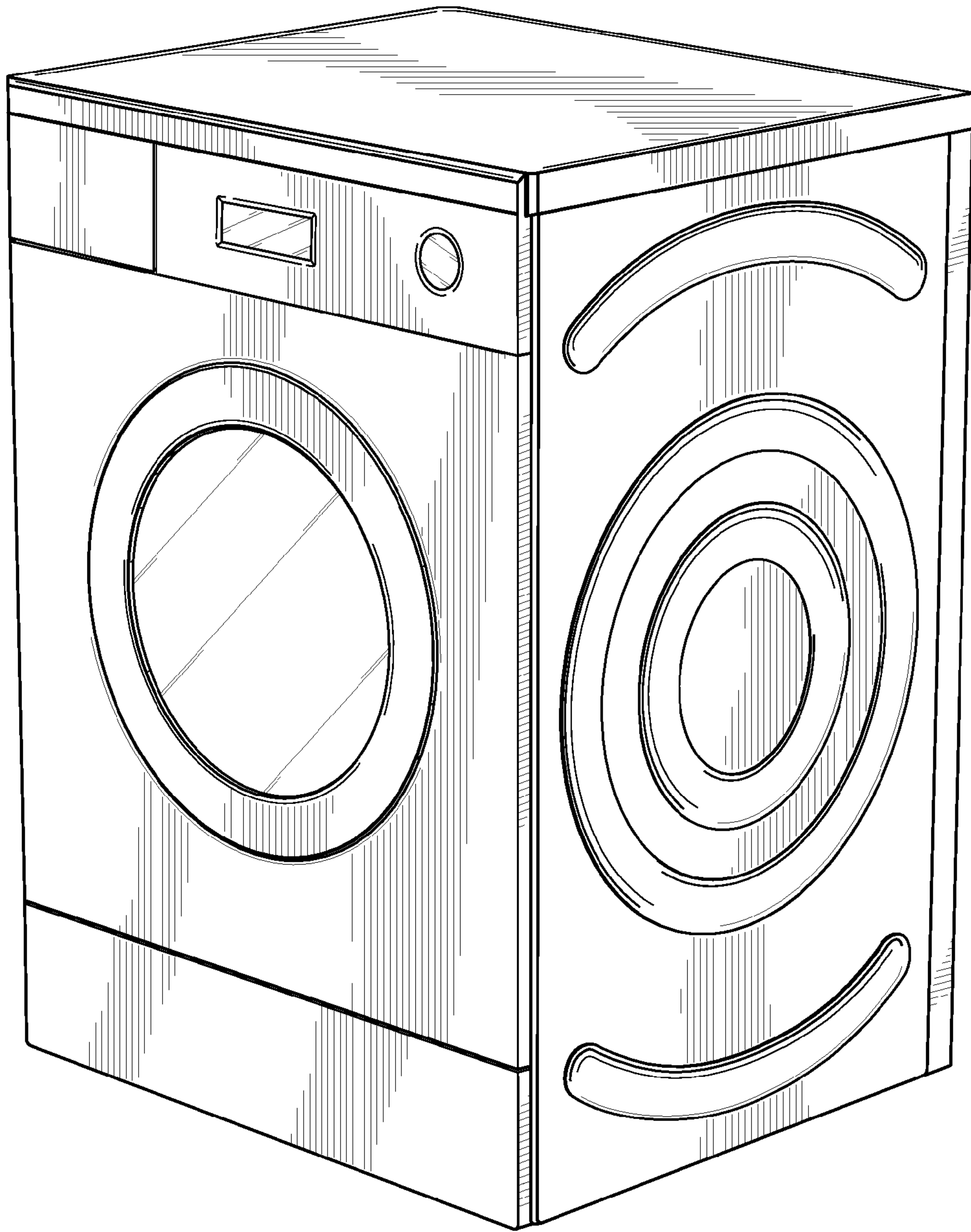

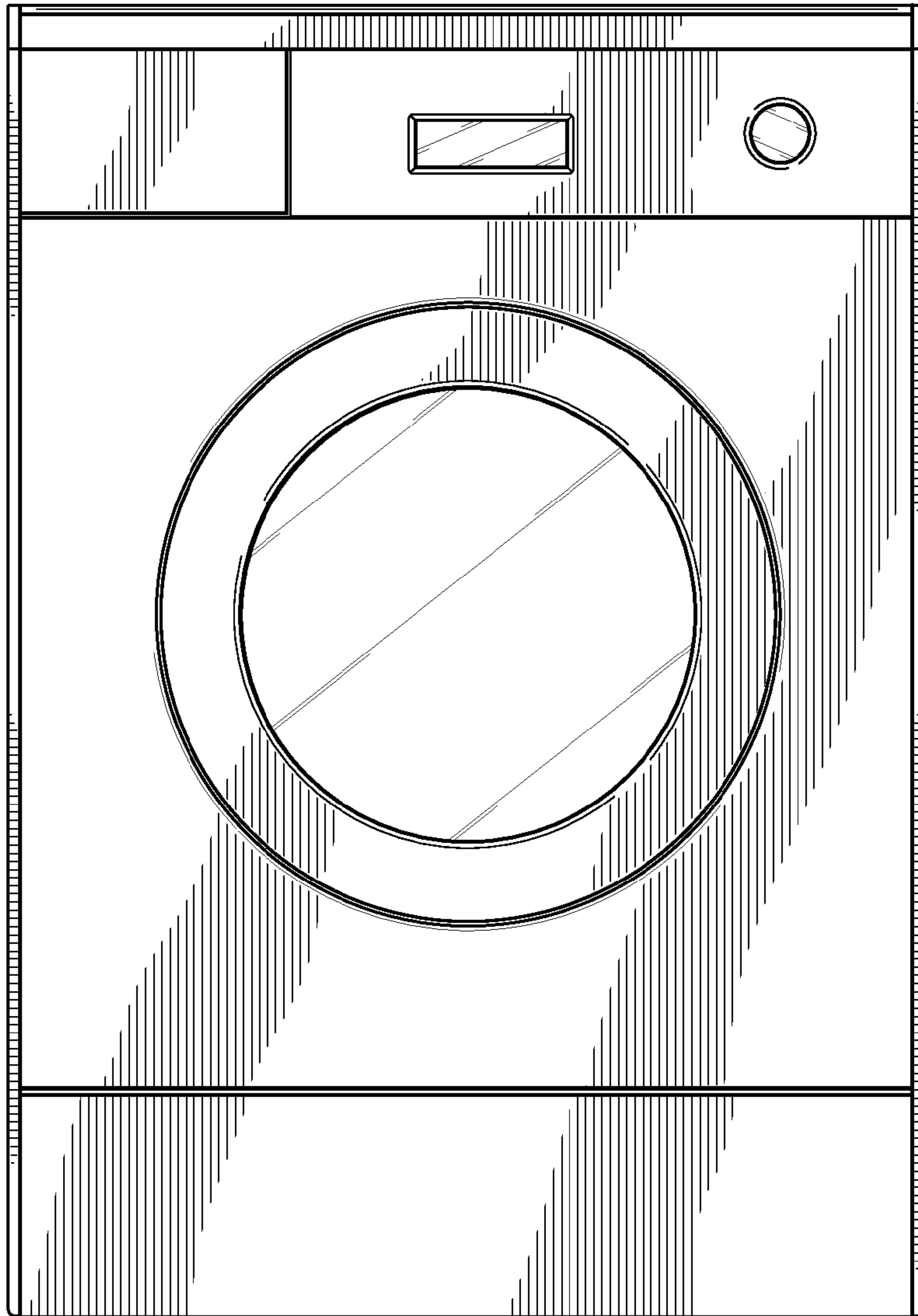

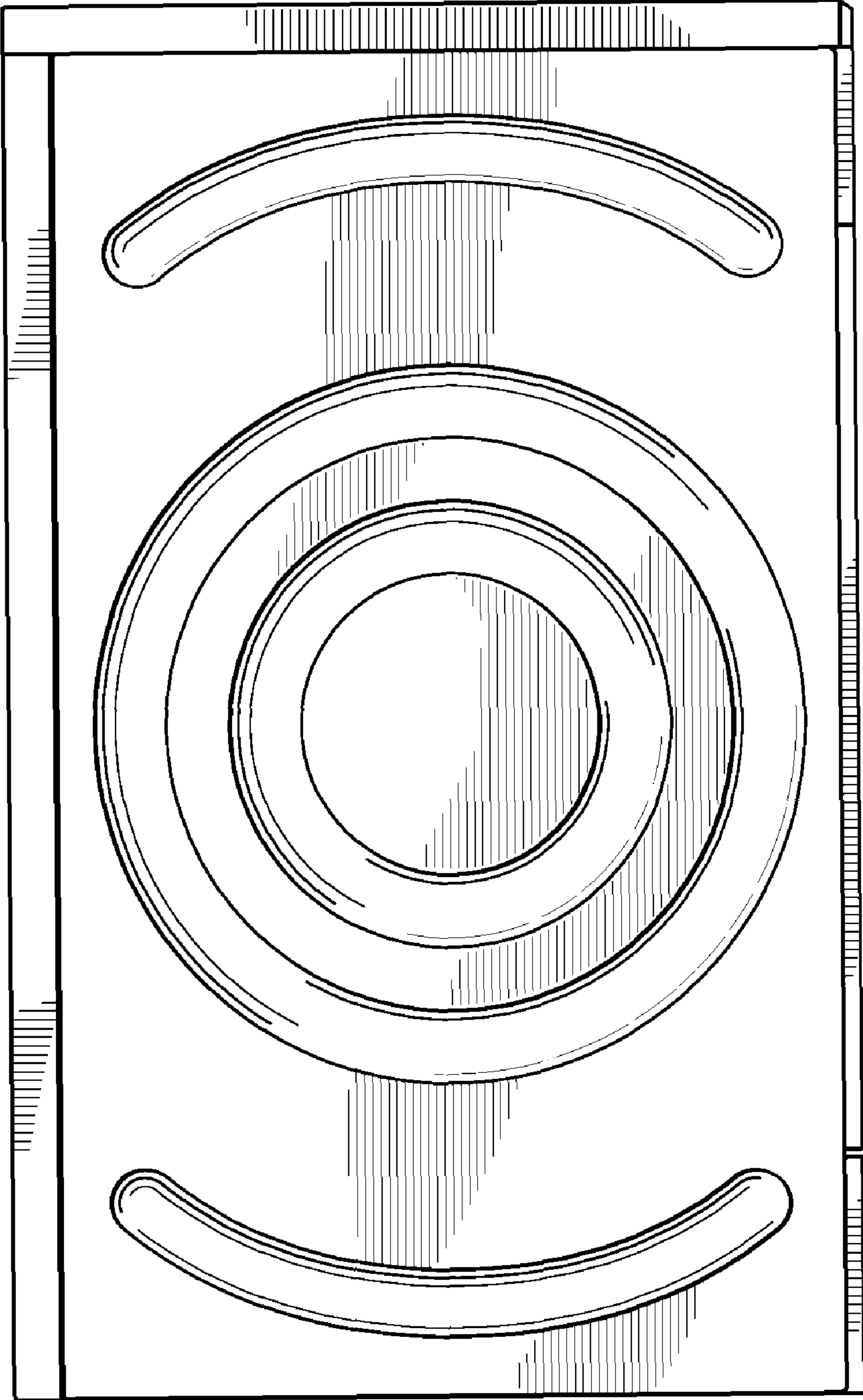

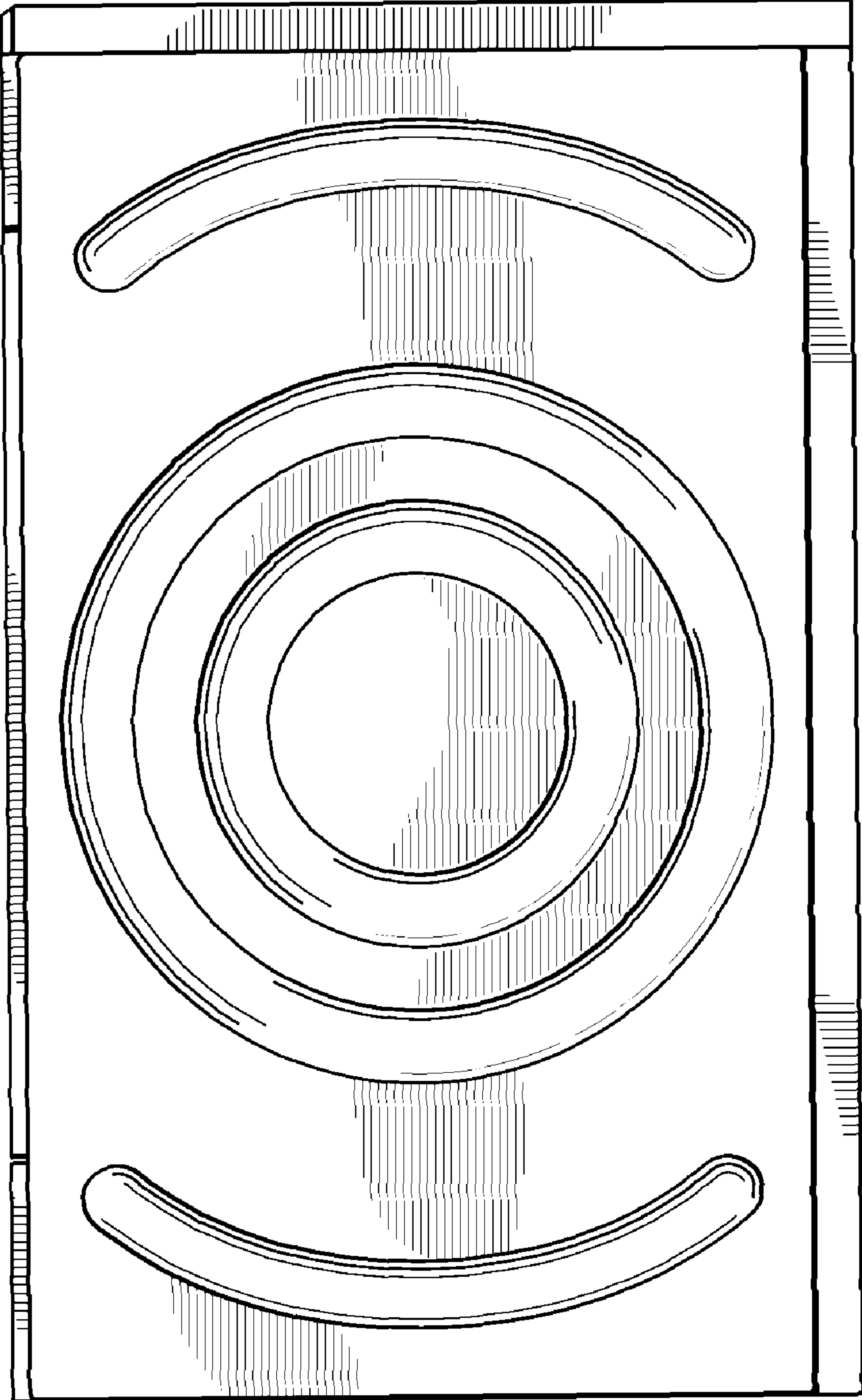

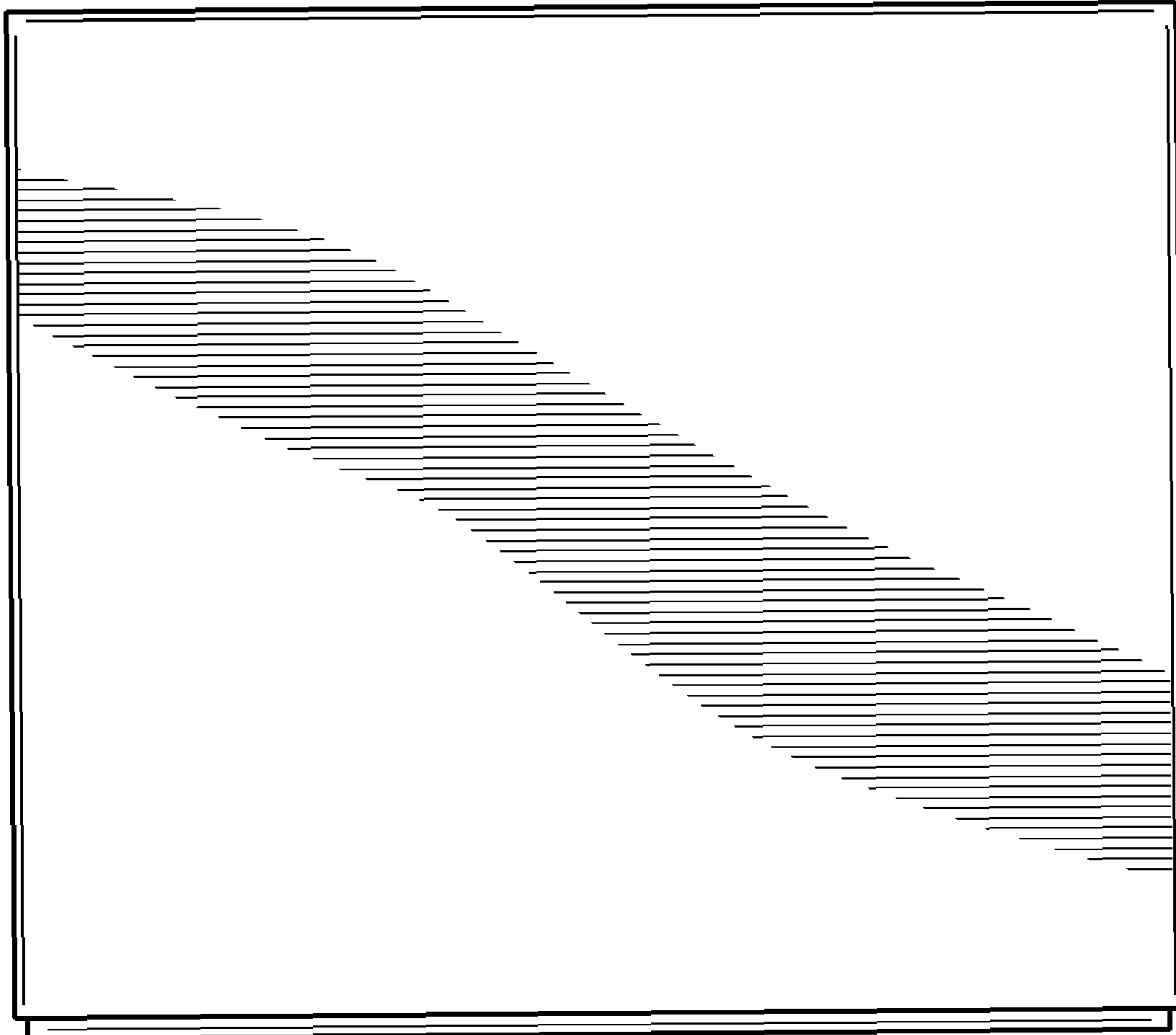

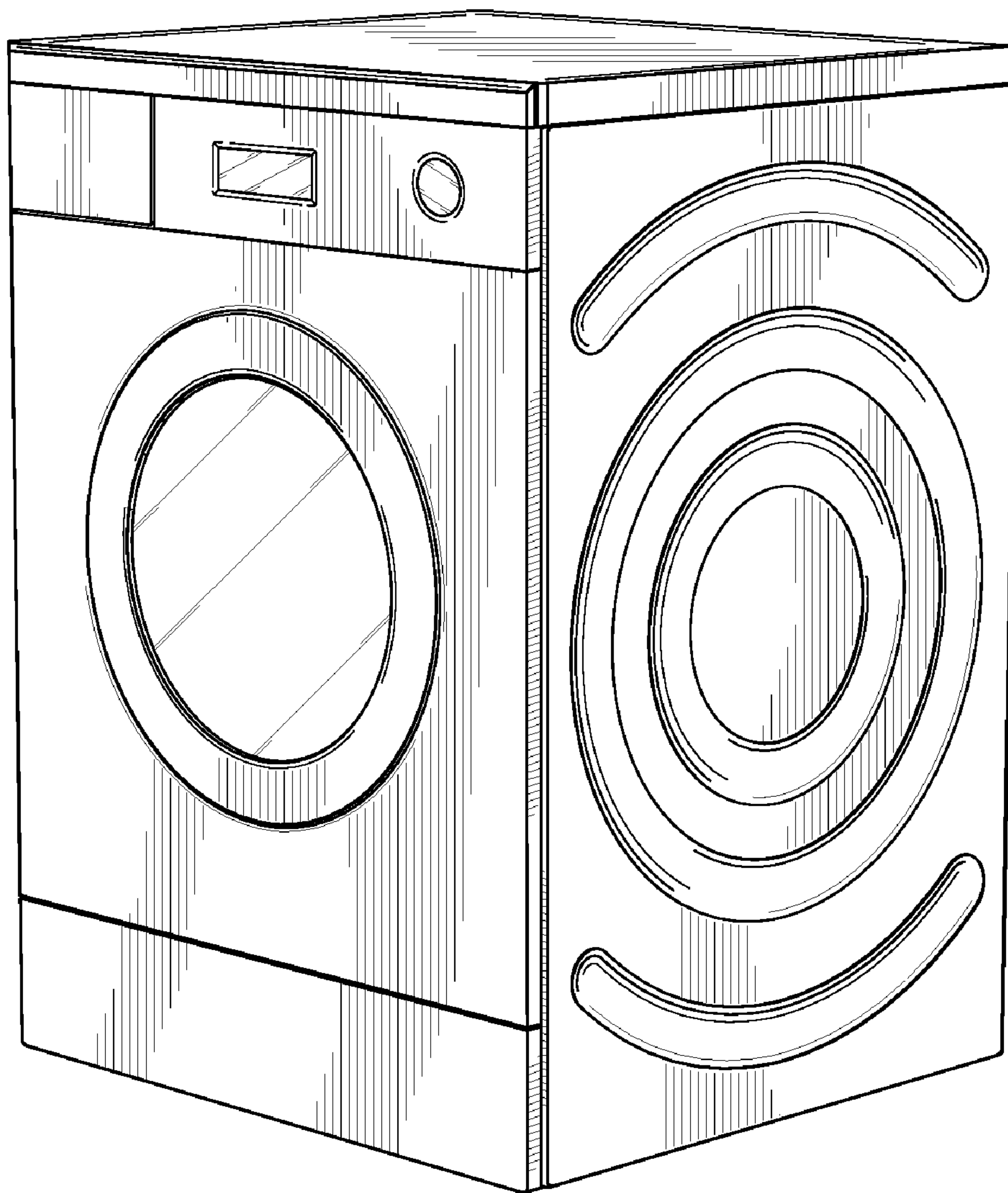

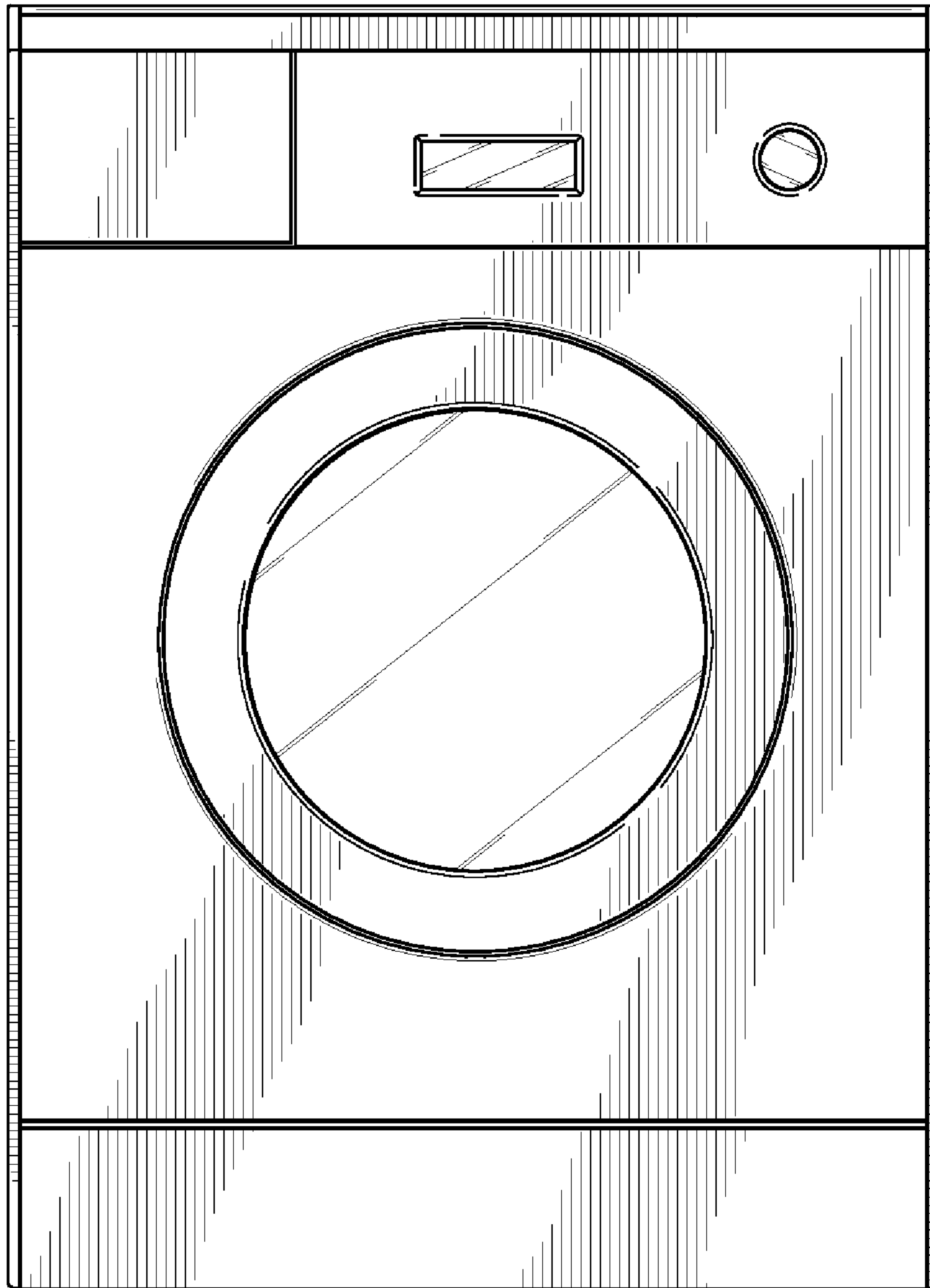

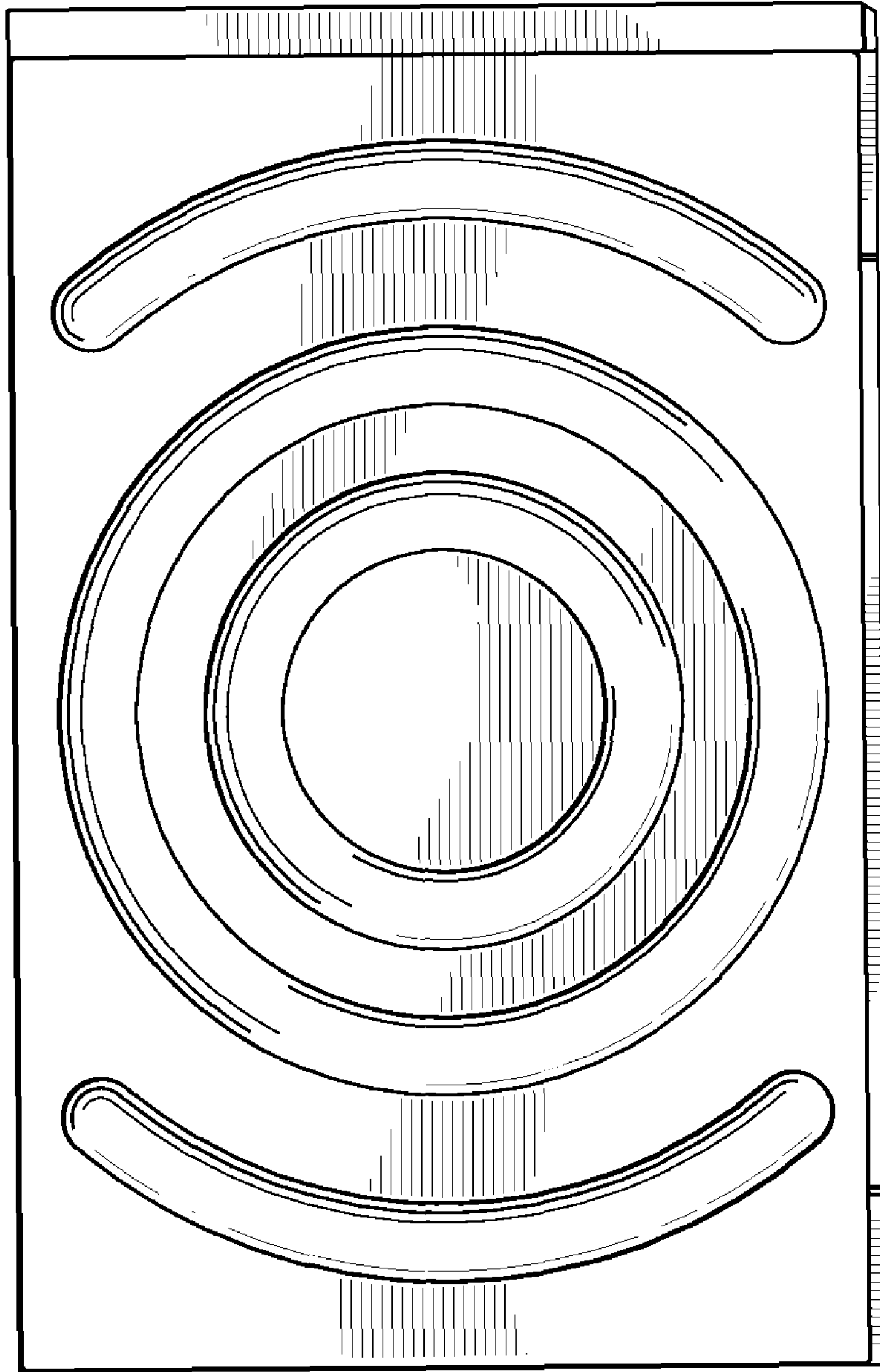

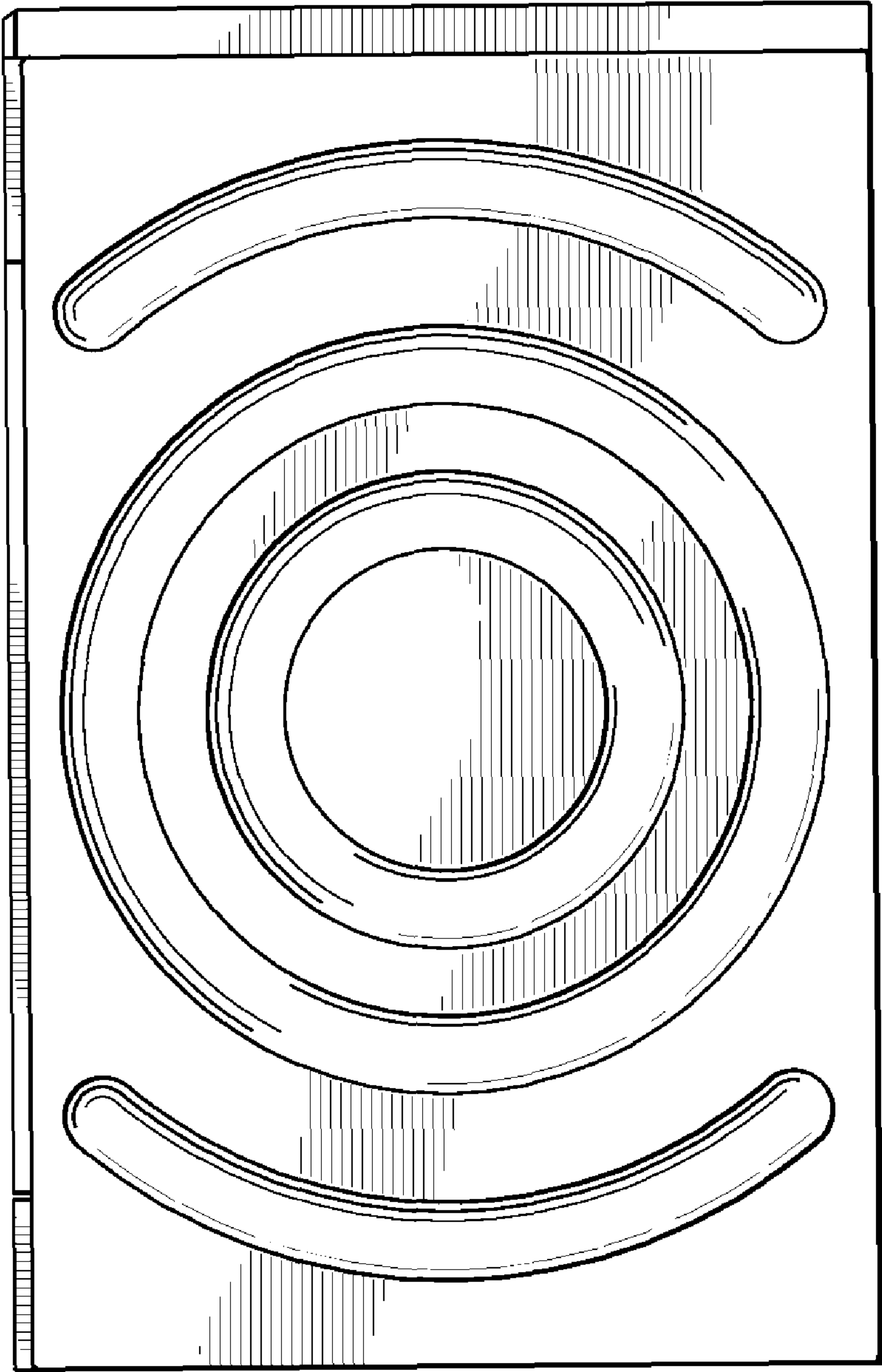

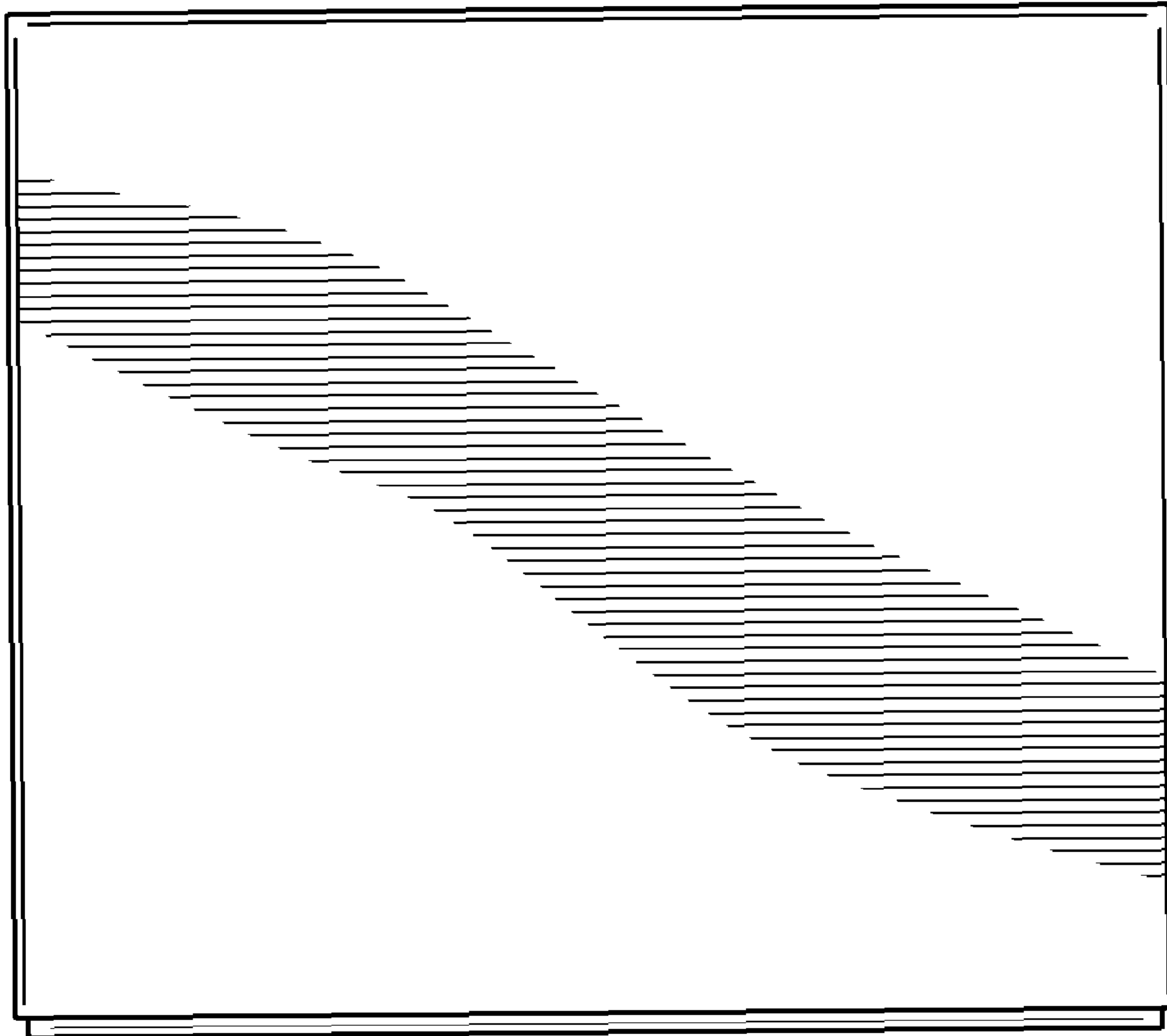
