DESCRIPTION

FIG. 1 is a front, top, and right side perspective view of the bottle with cap showing my new design;

FIG. 3 is a rear elevational view thereof;

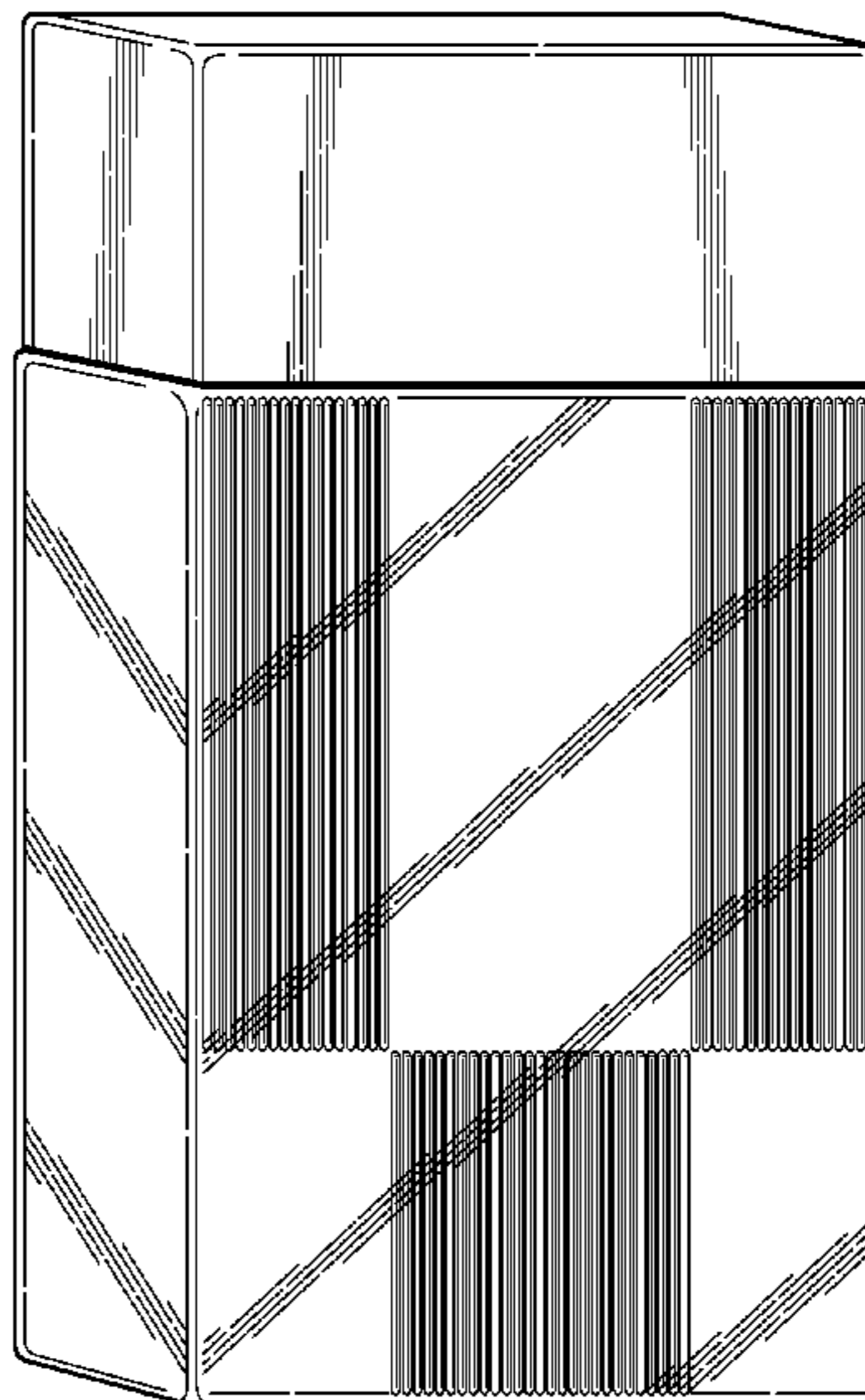
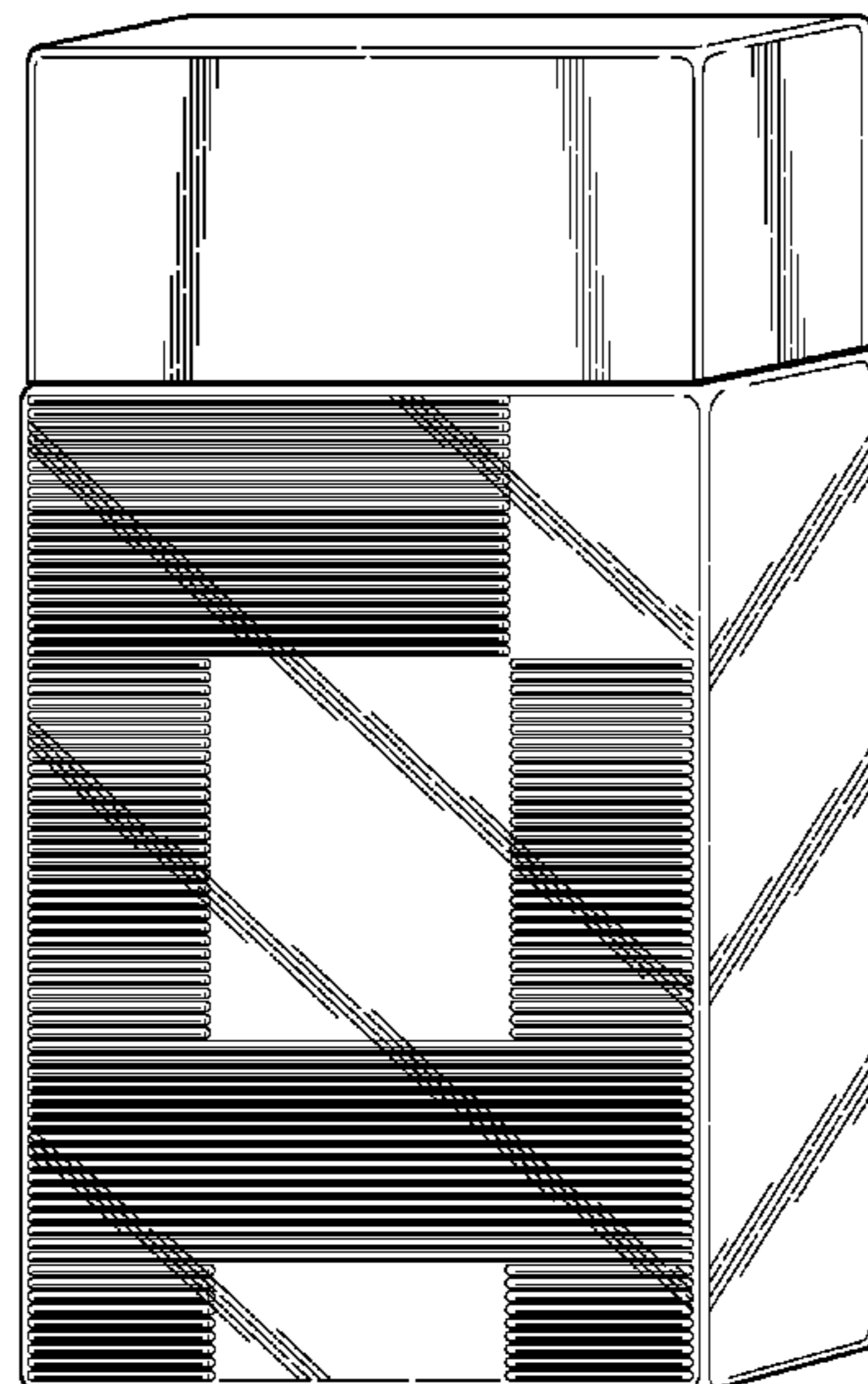
FIG. 4 is a left side elevational view thereof, the right side elevational view being identical;

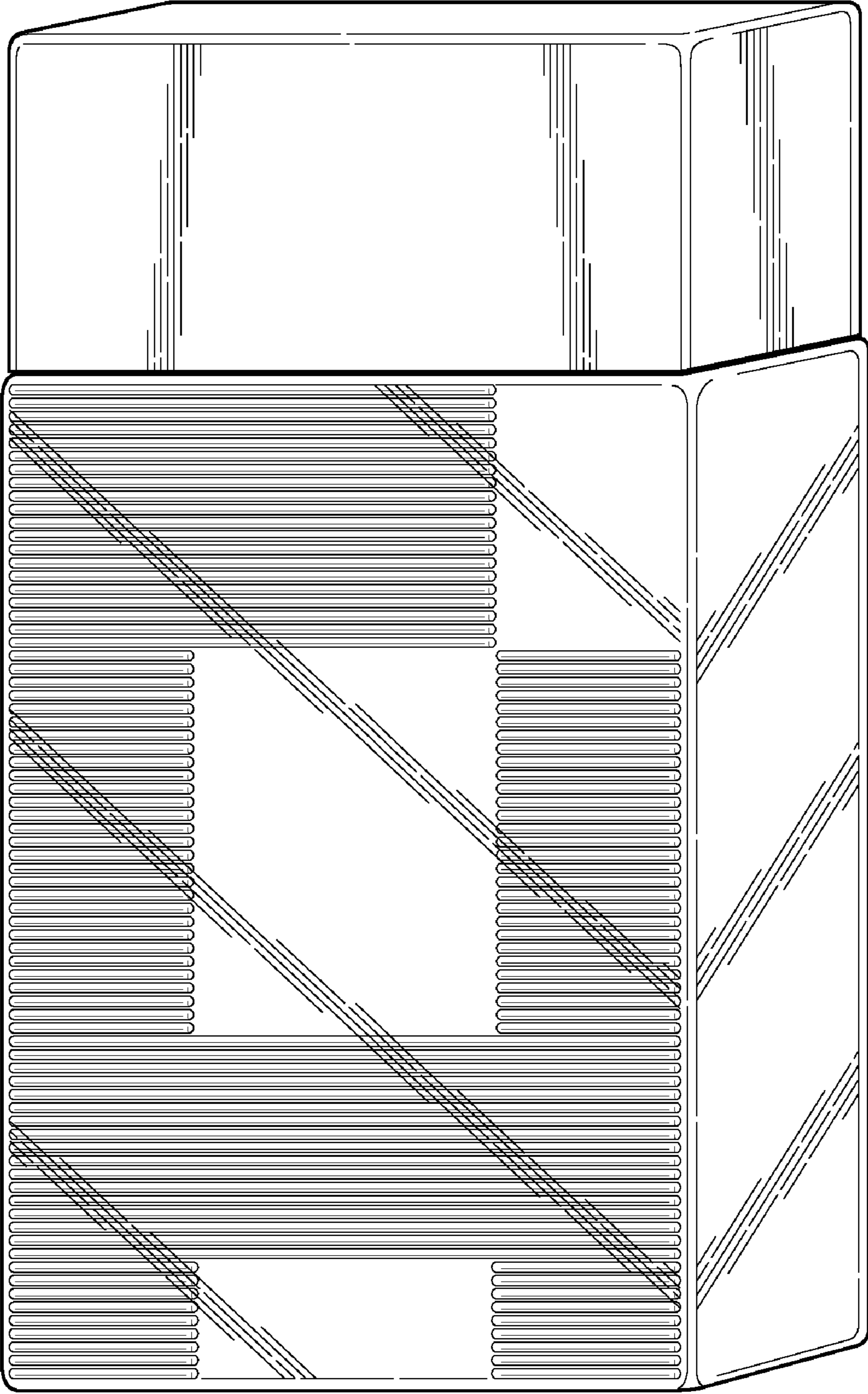

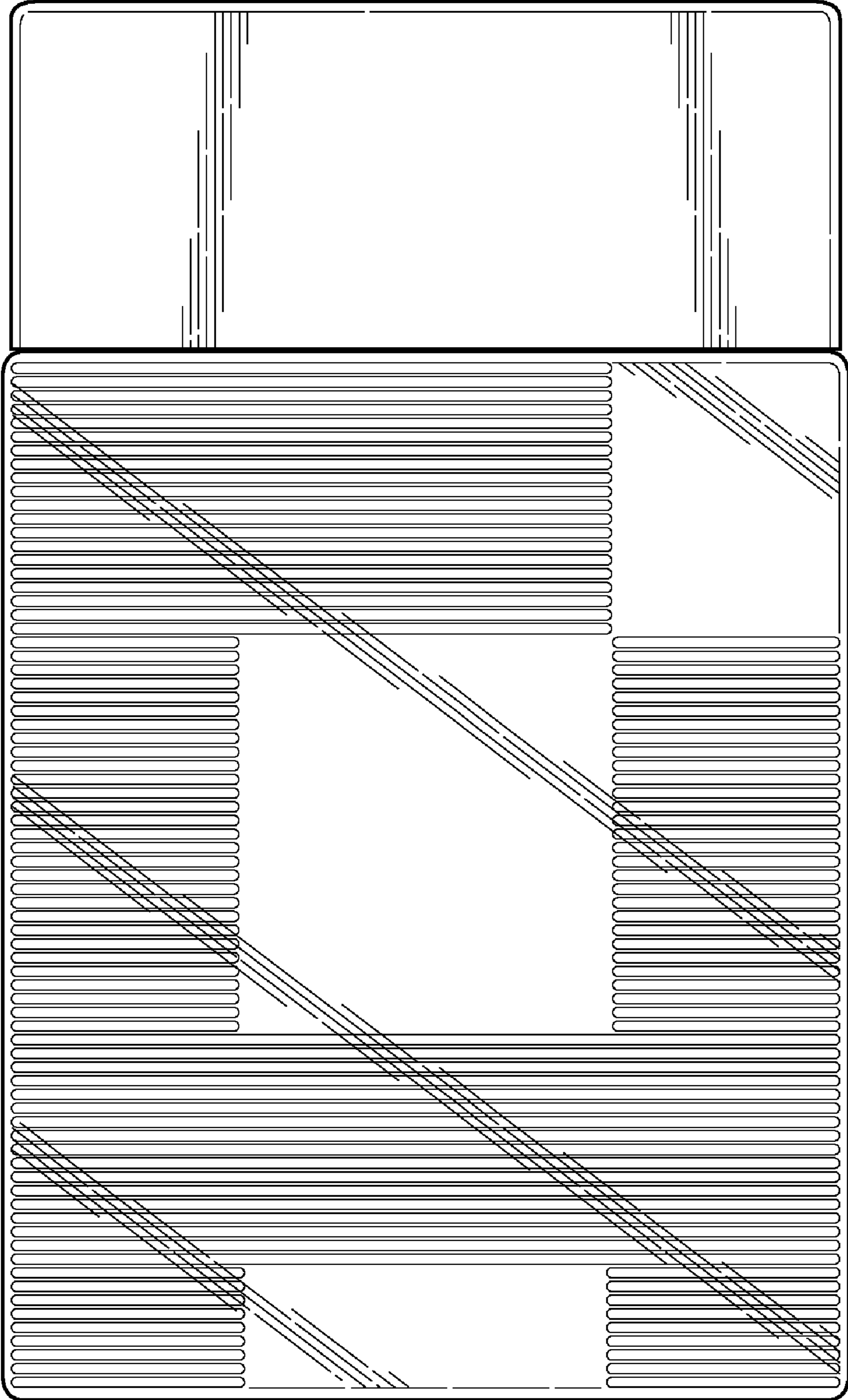

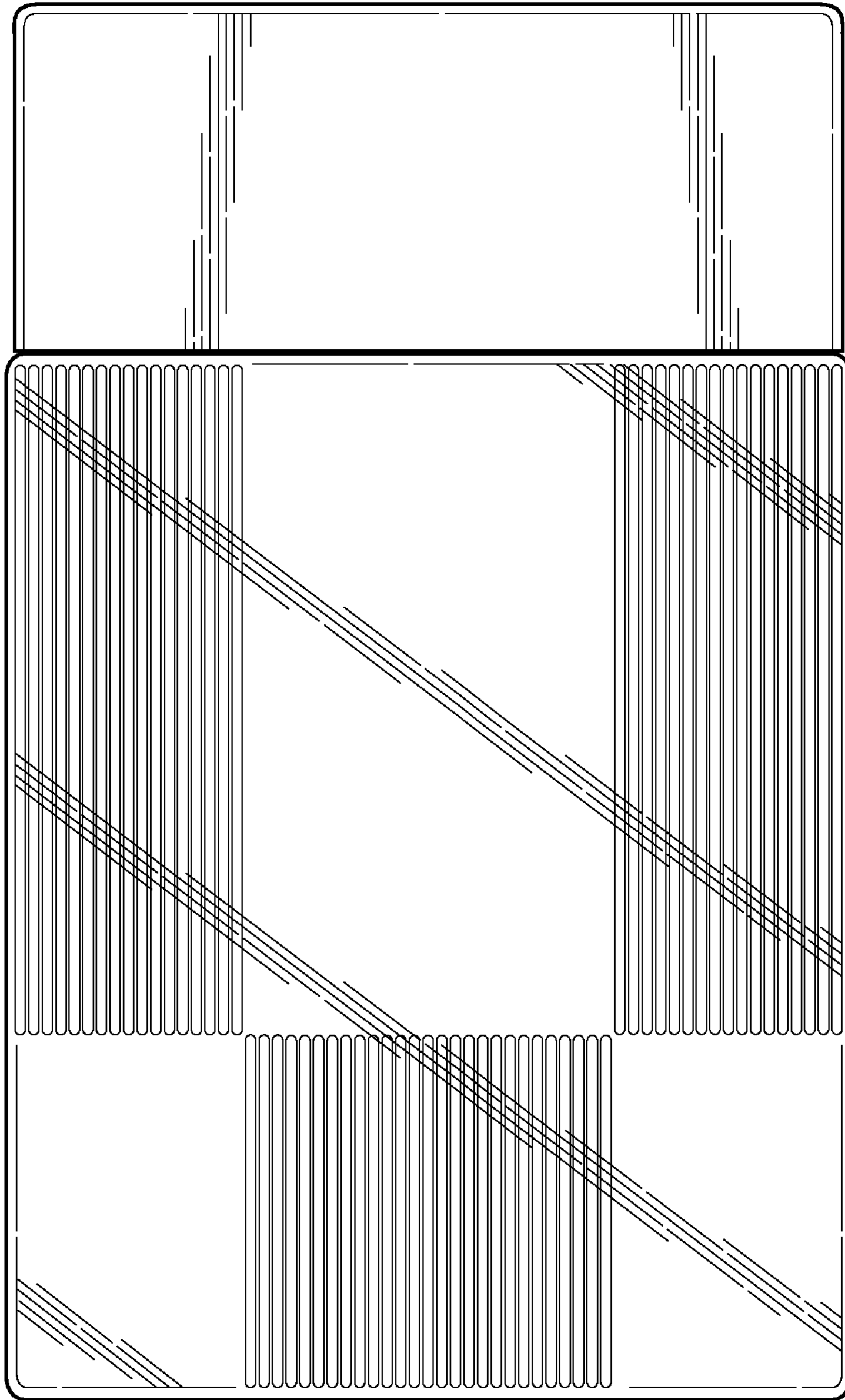

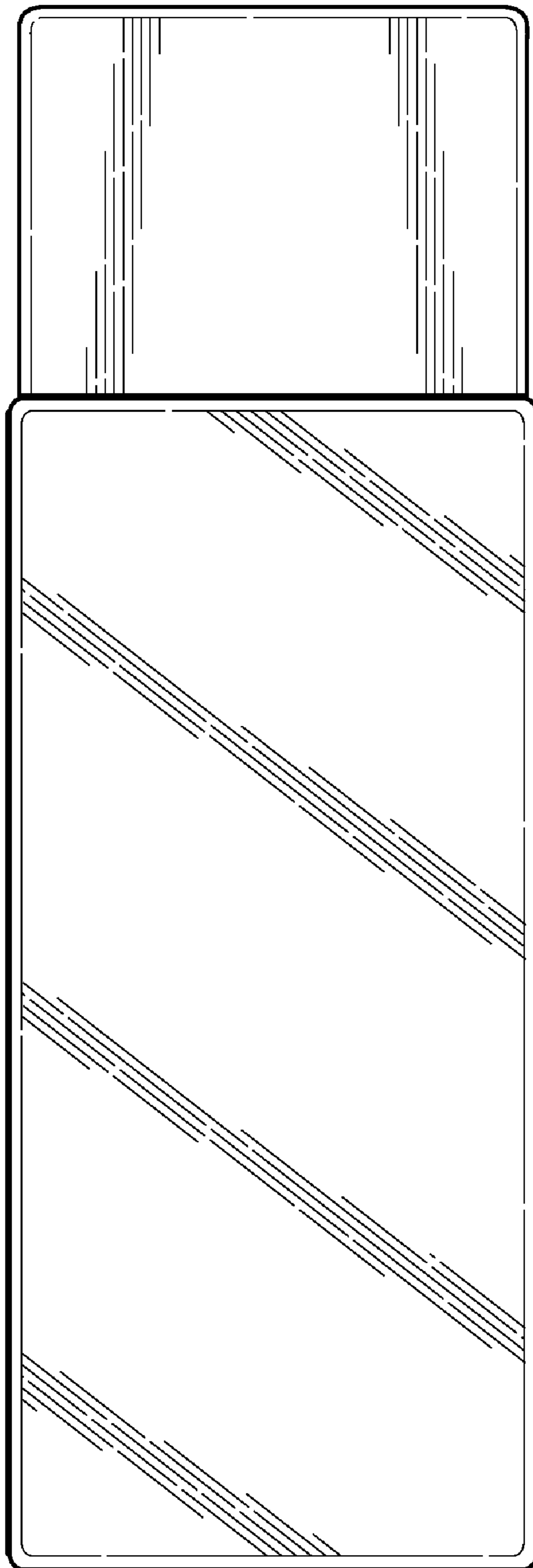

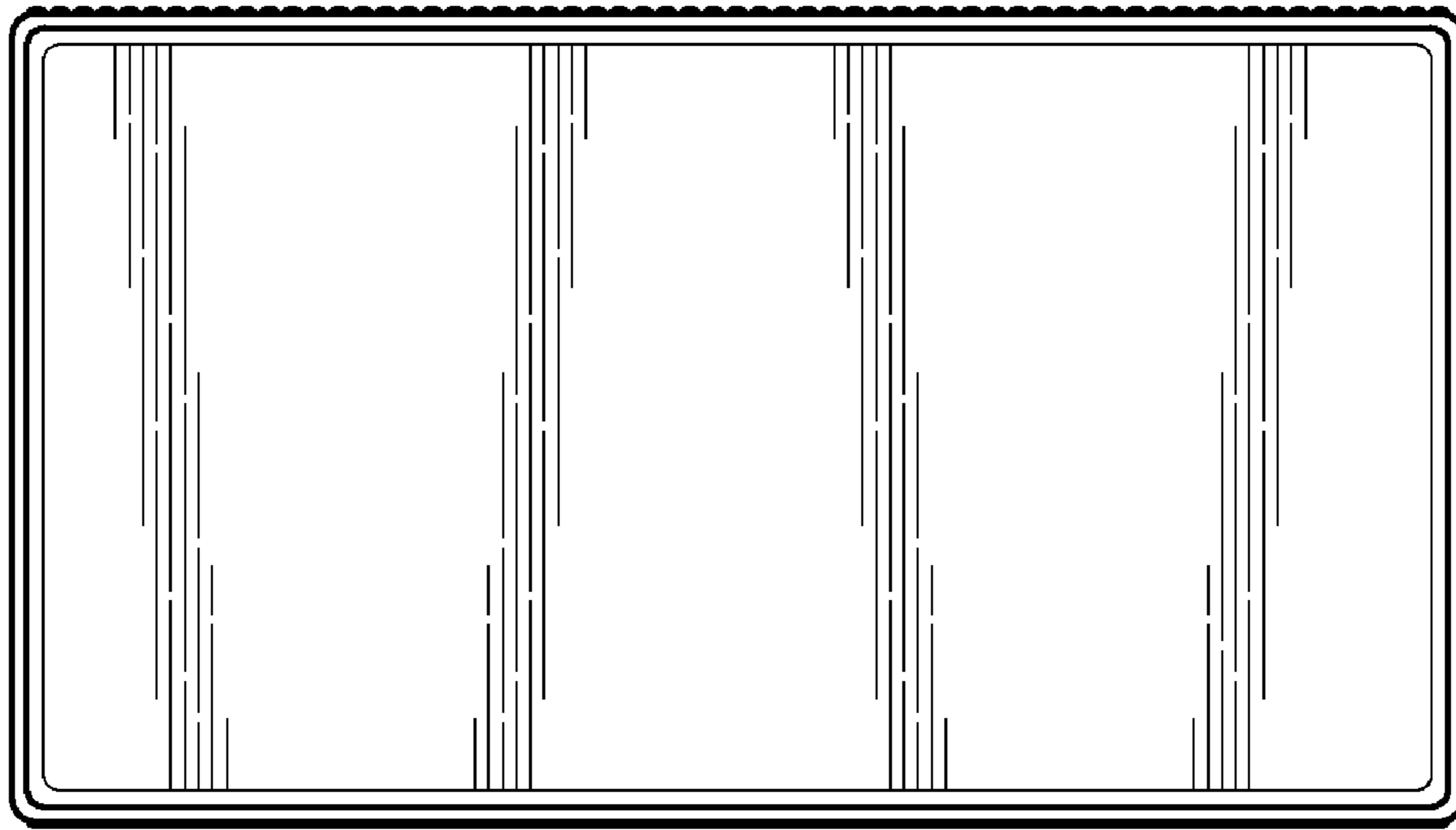

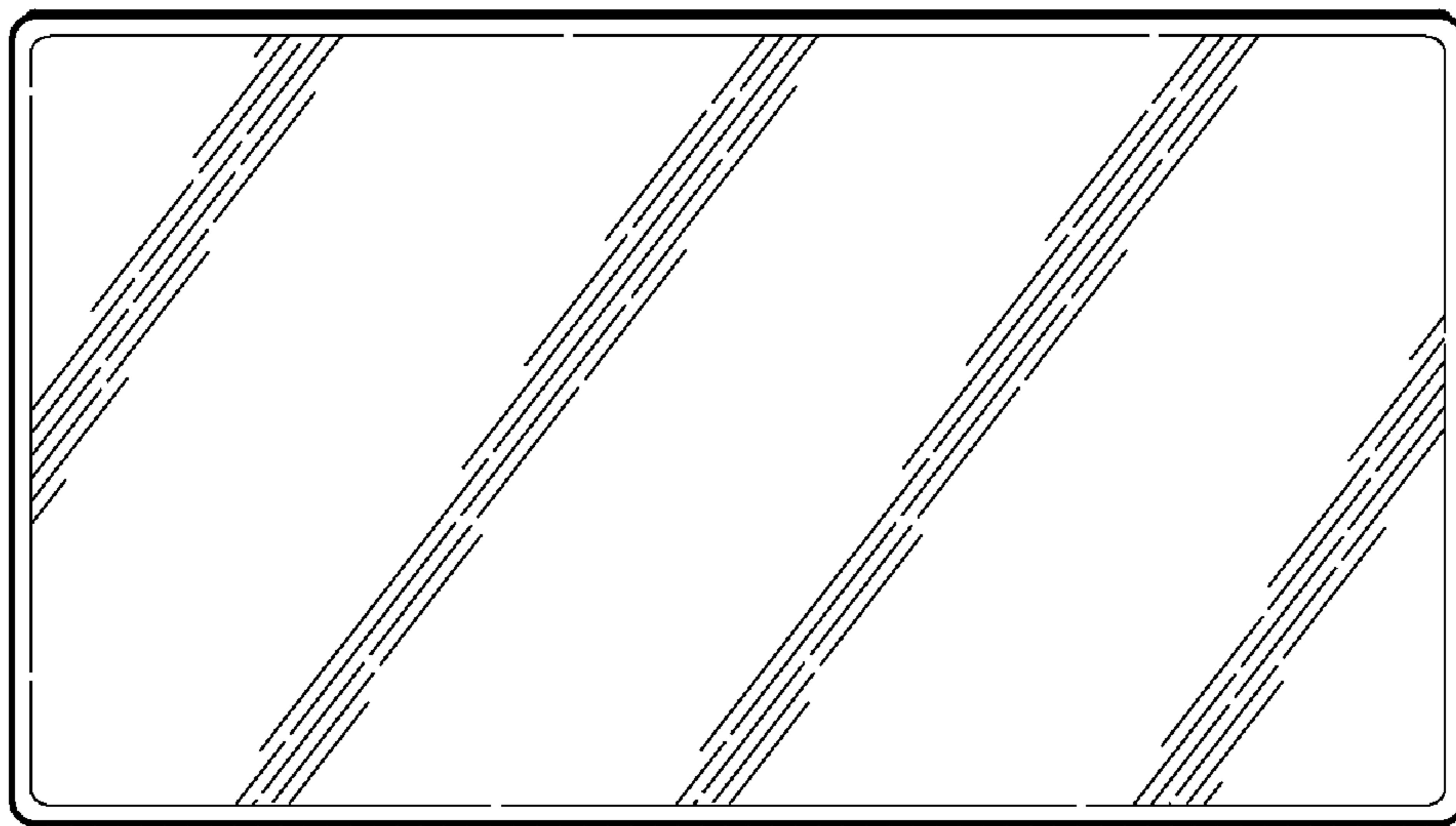

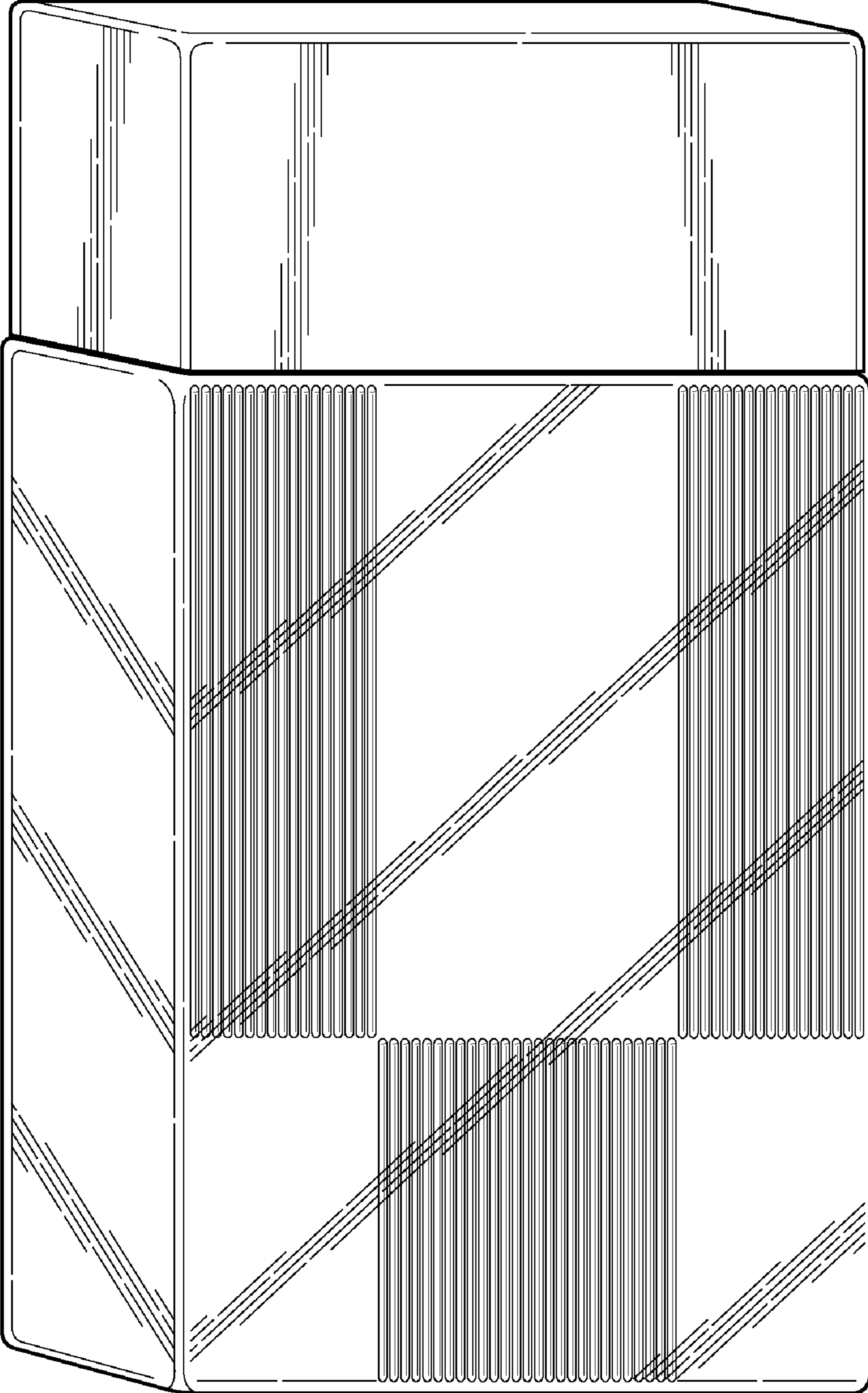
