DESCRIPTION

FIG. 1 is a perspective view of a cosmetic container;

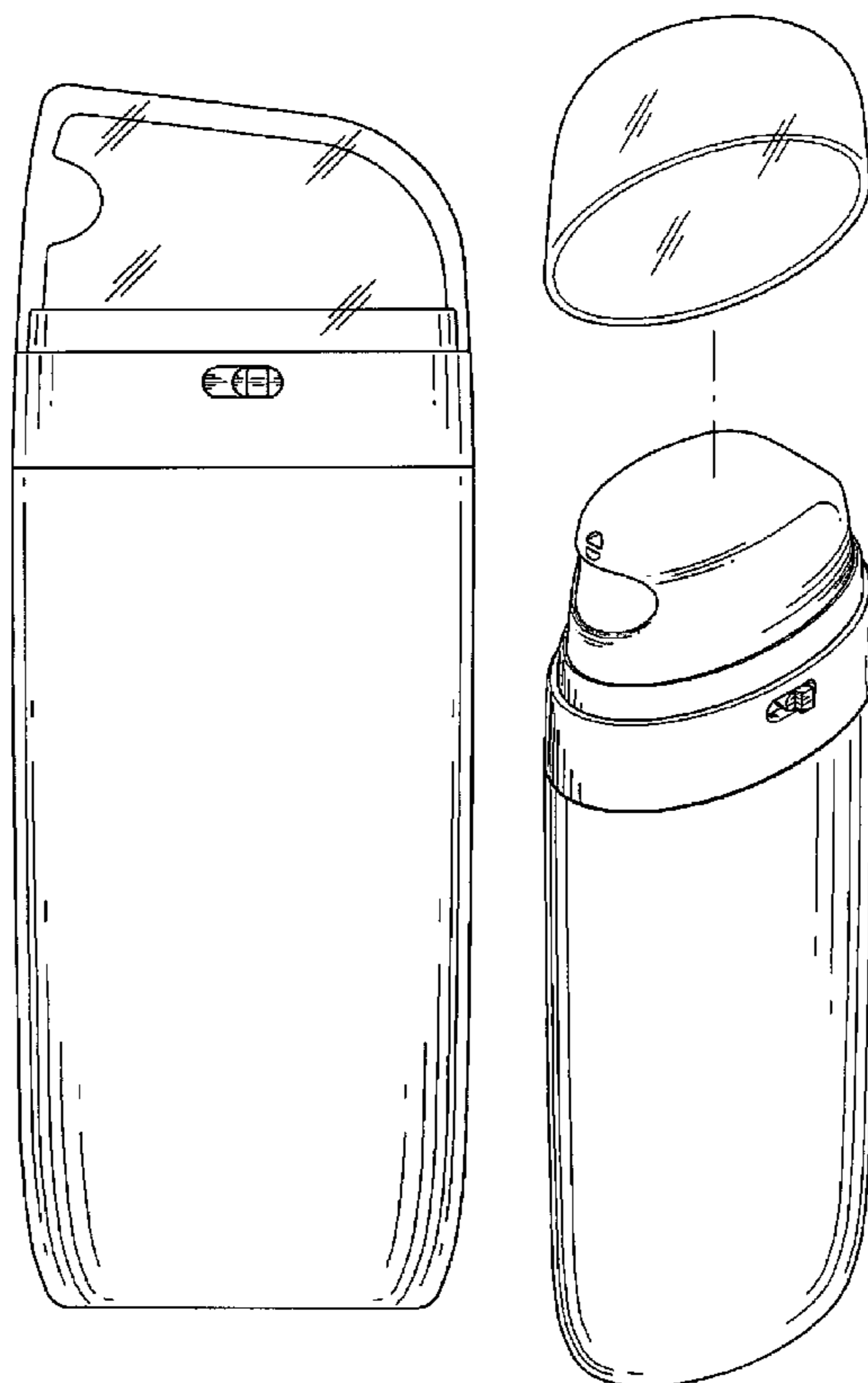

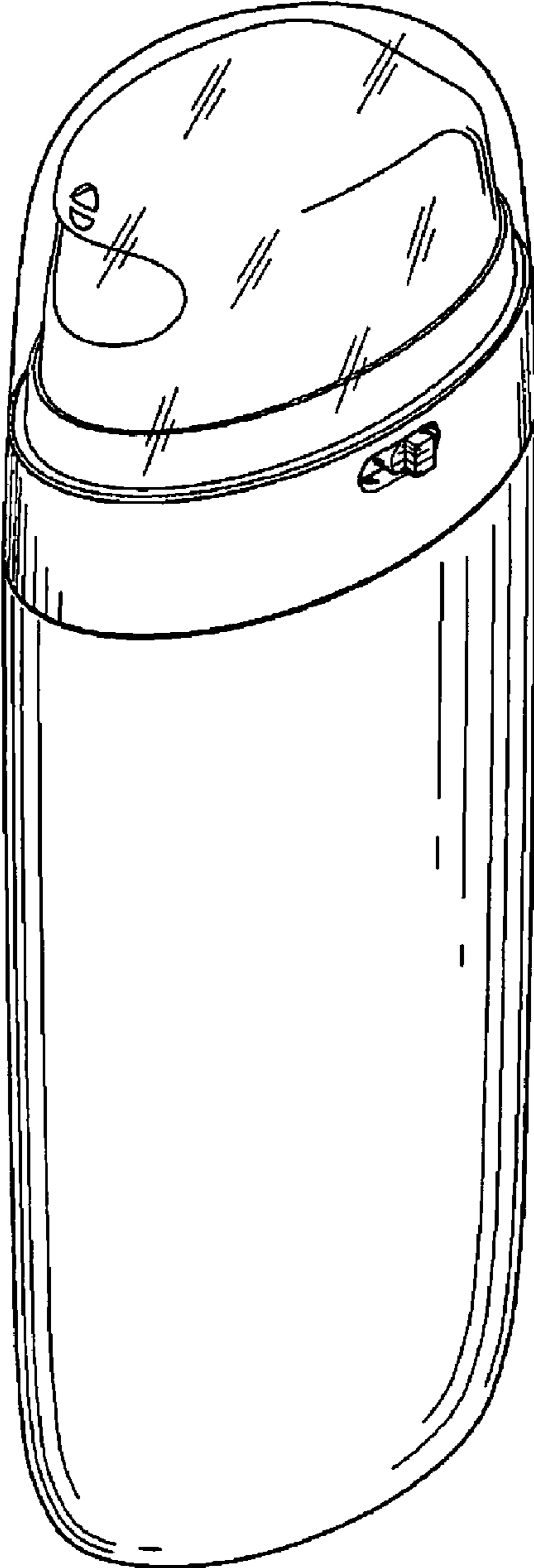

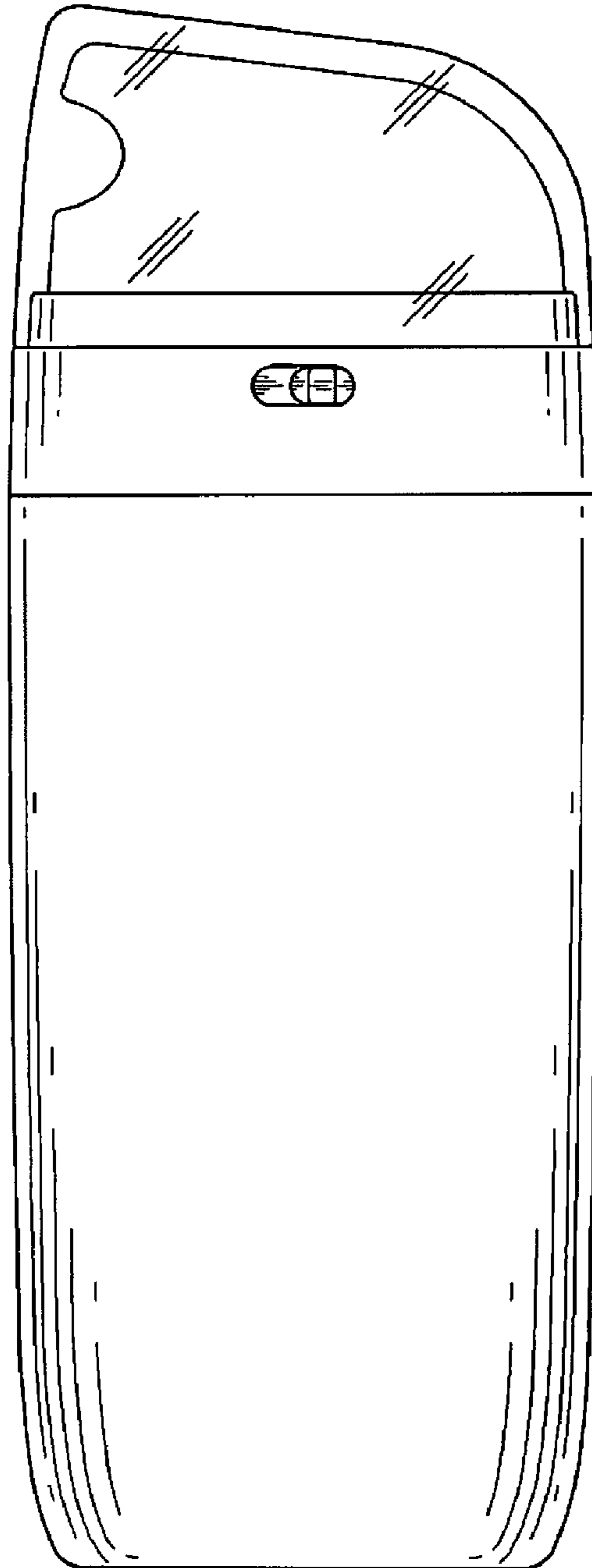

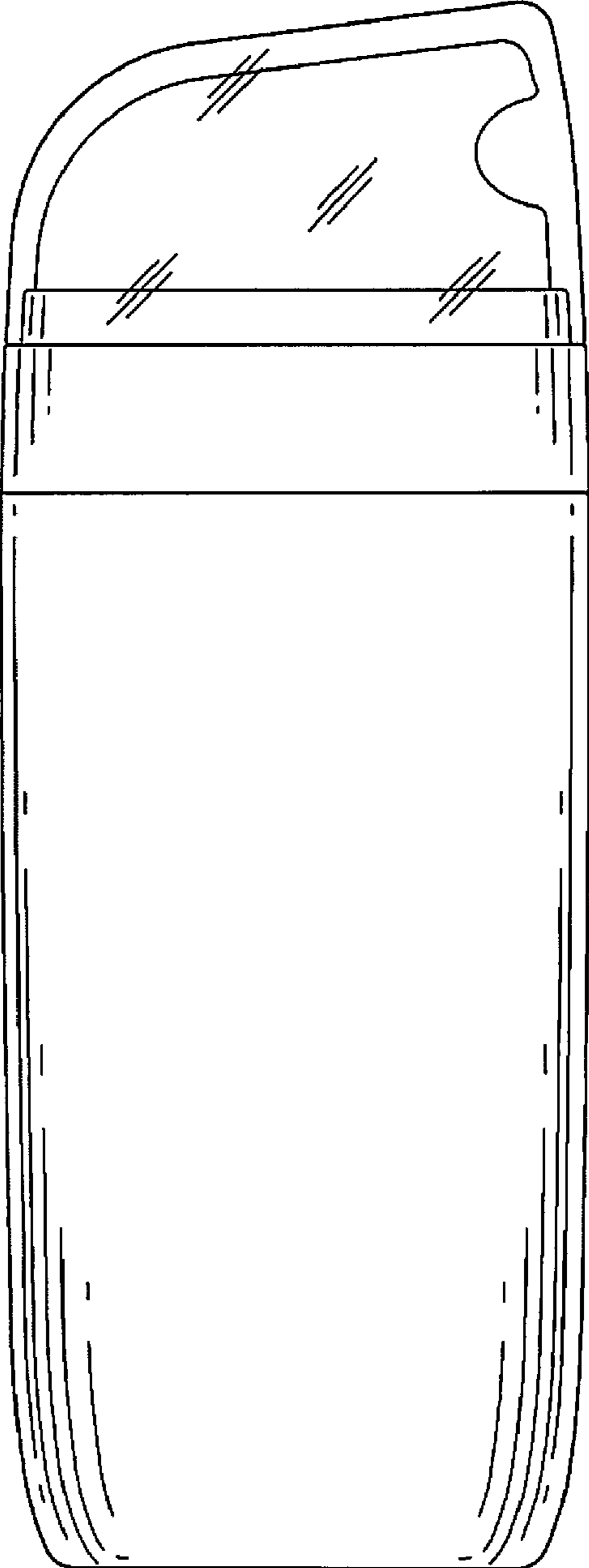

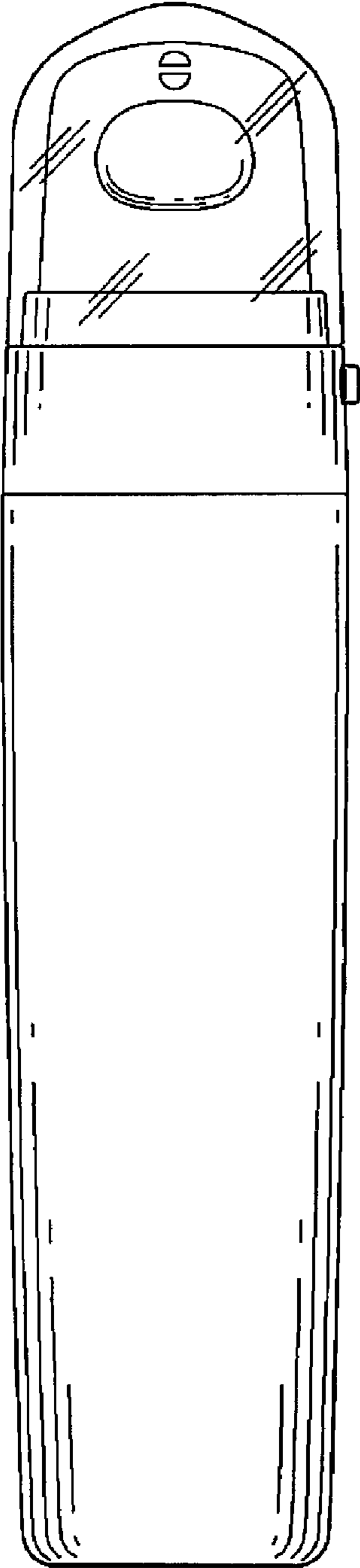

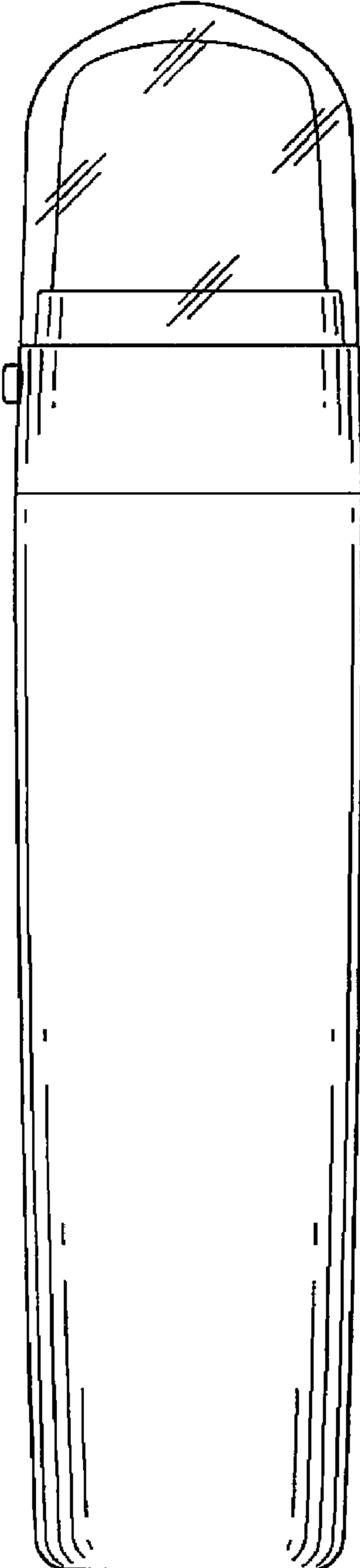

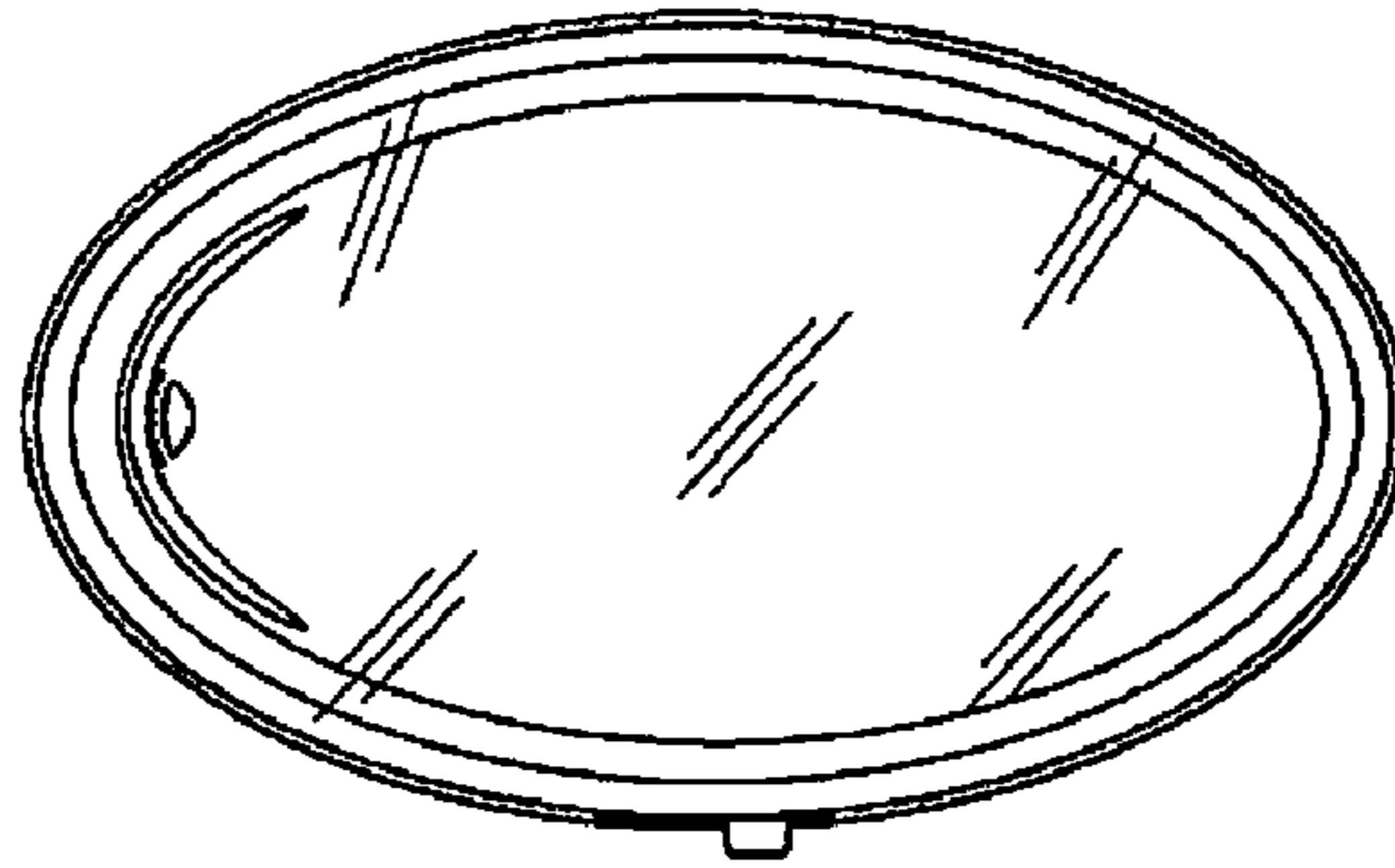

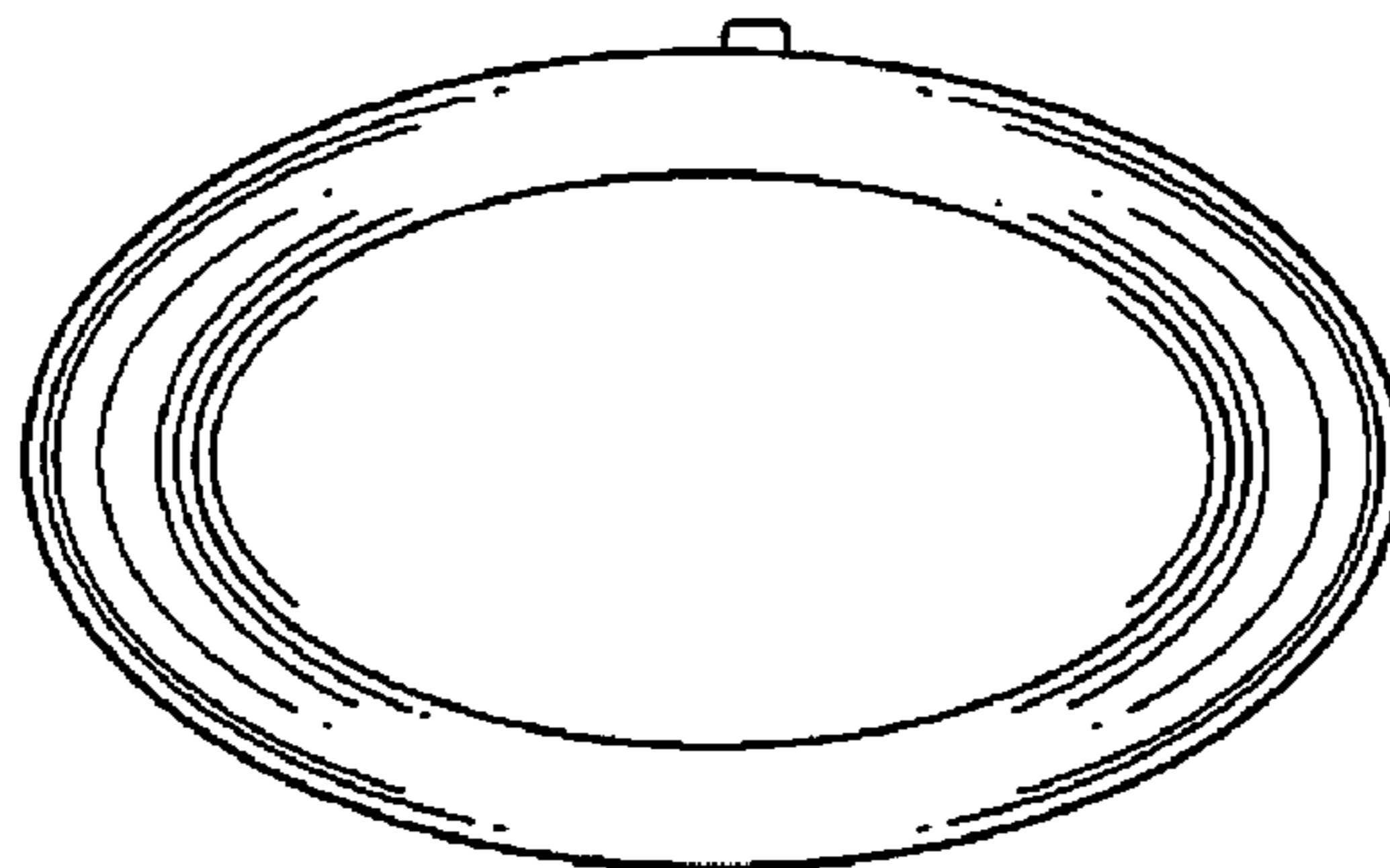
