(57) **CLAIM**

The ornamental design for a three-outlet surge-protected adaptor, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a three-outlet surge-protected adaptor, showing my new design;

FIG. 2 is a right-side elevational view thereof, the left-side elevational view being a mirror image thereof;

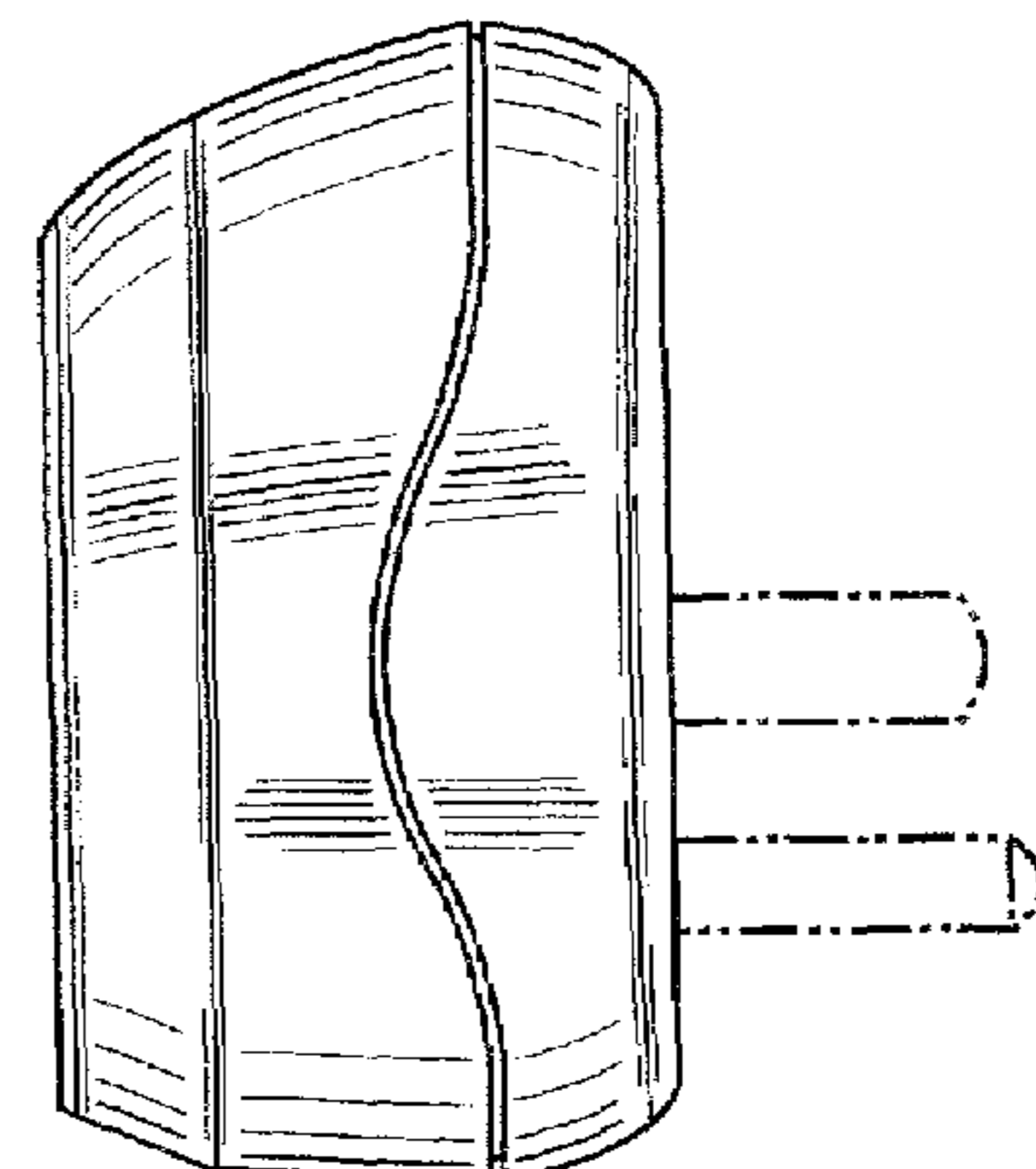
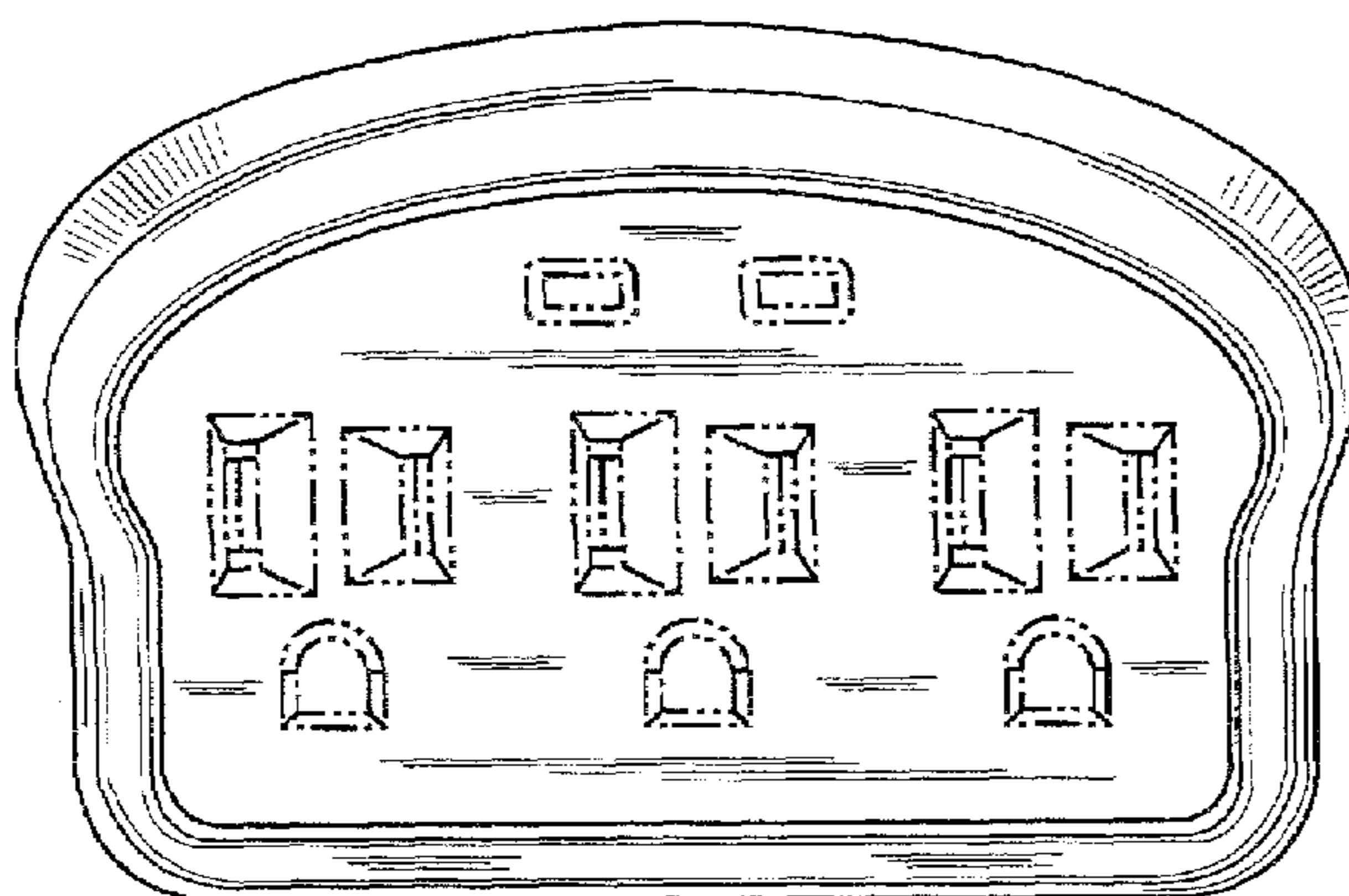
FIG. 3 is a top plan view thereof;

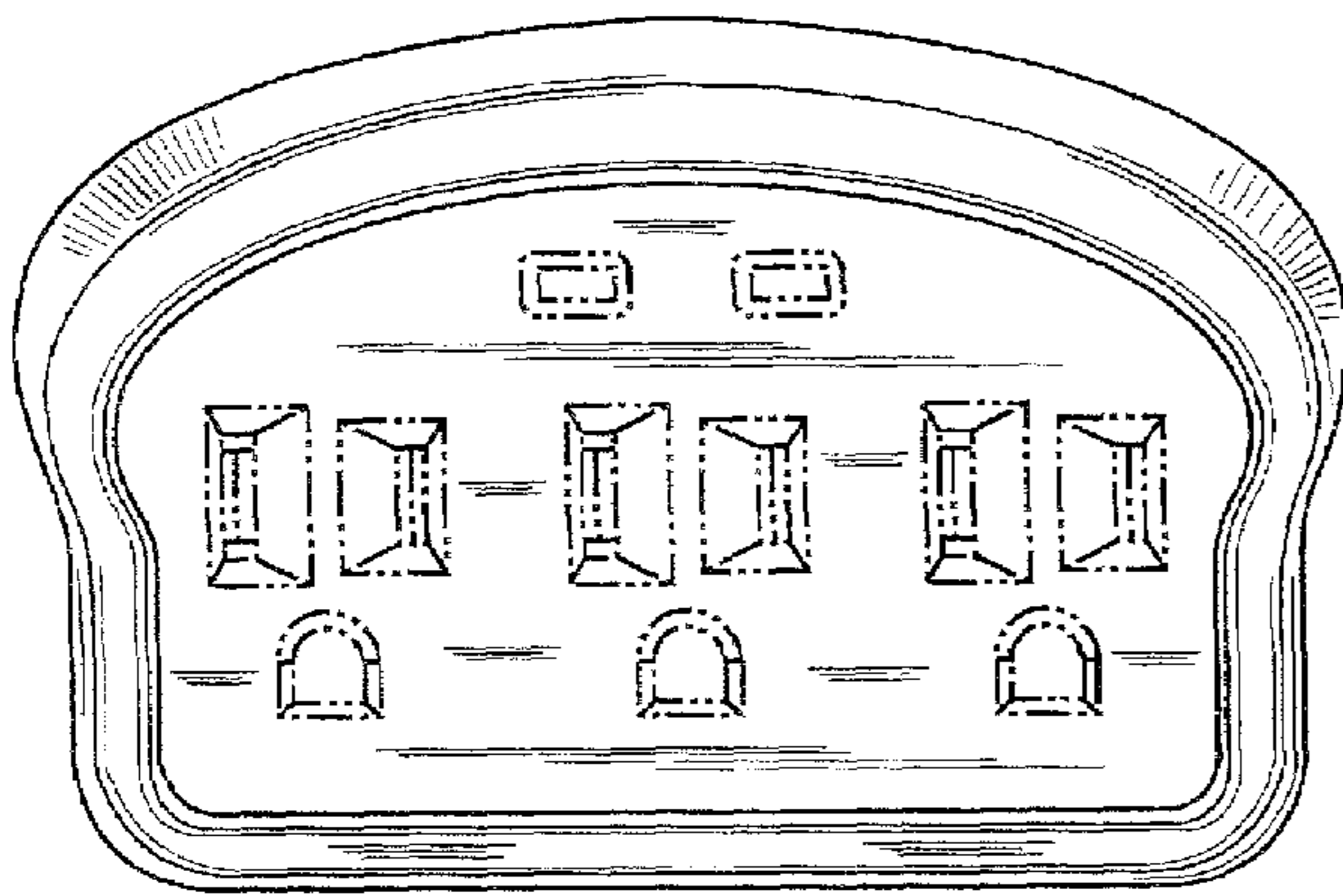

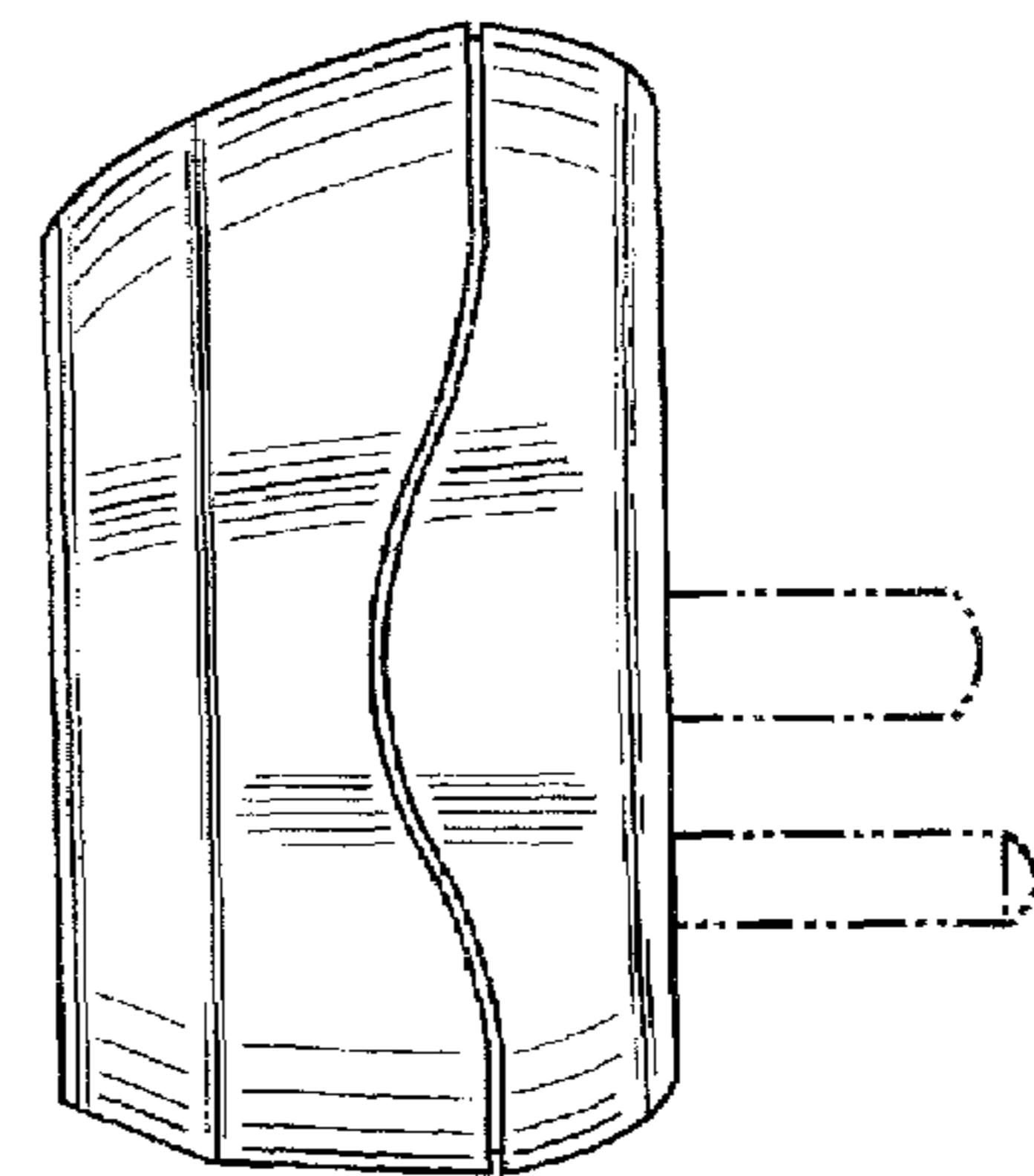

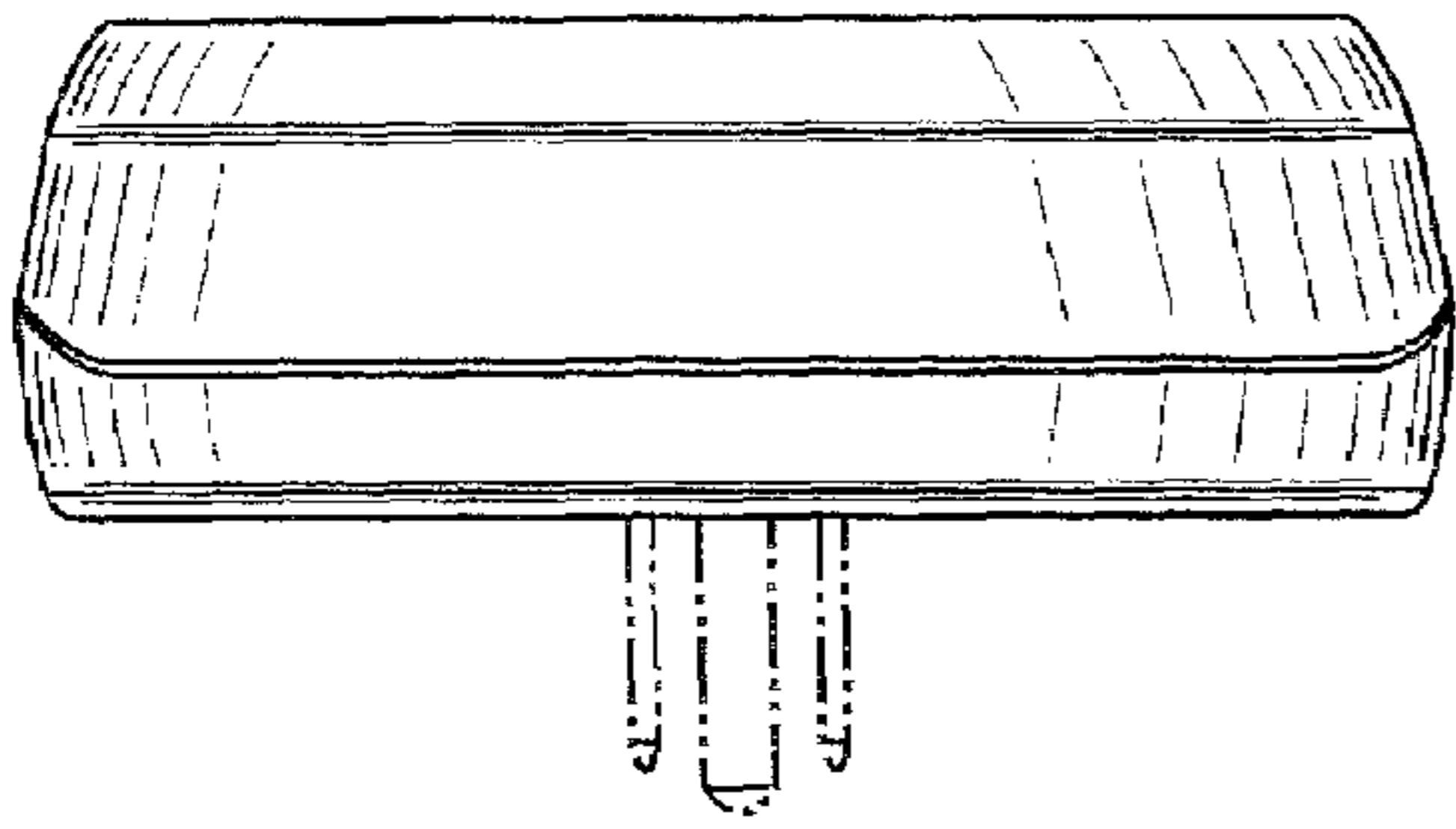

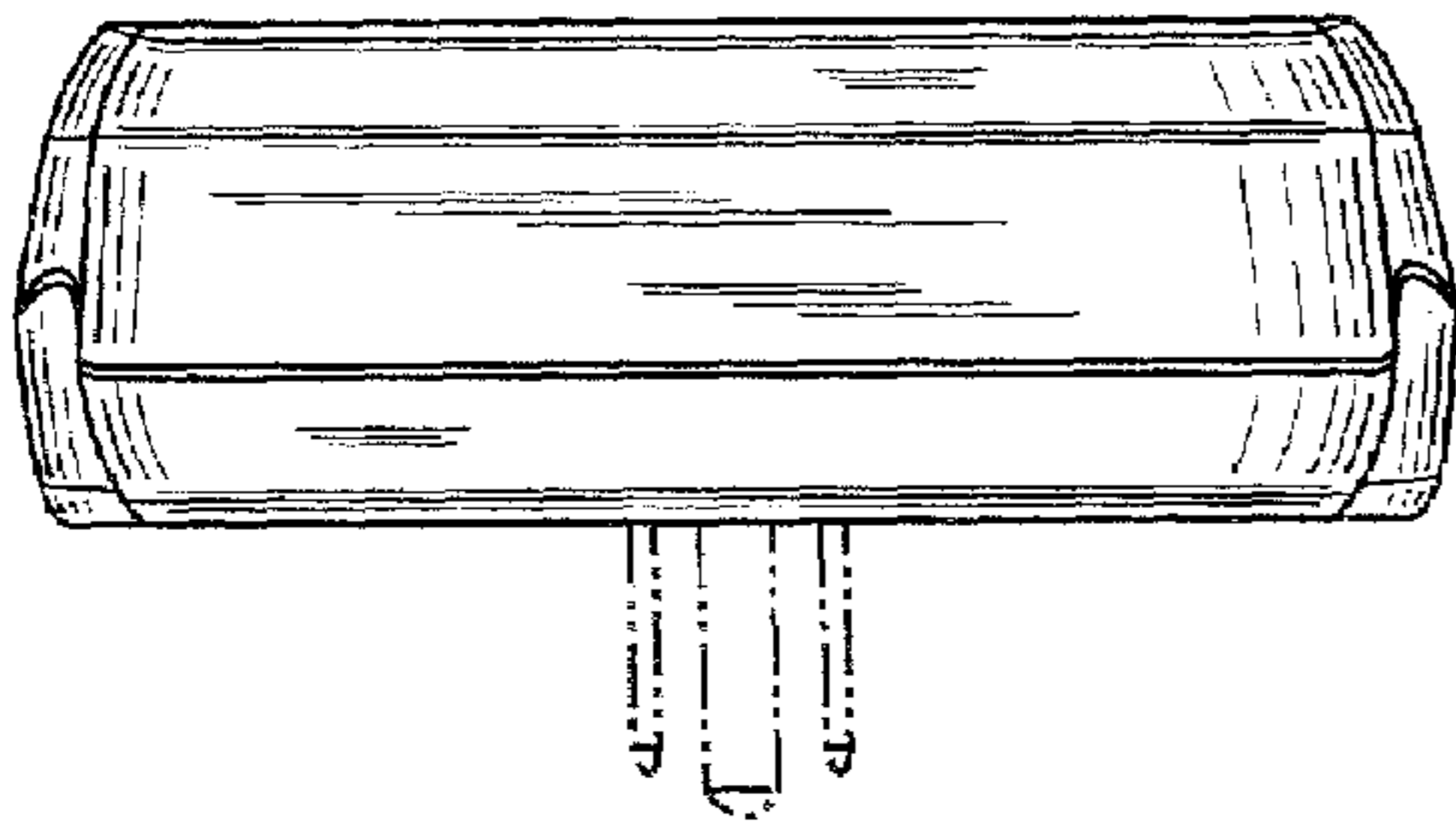

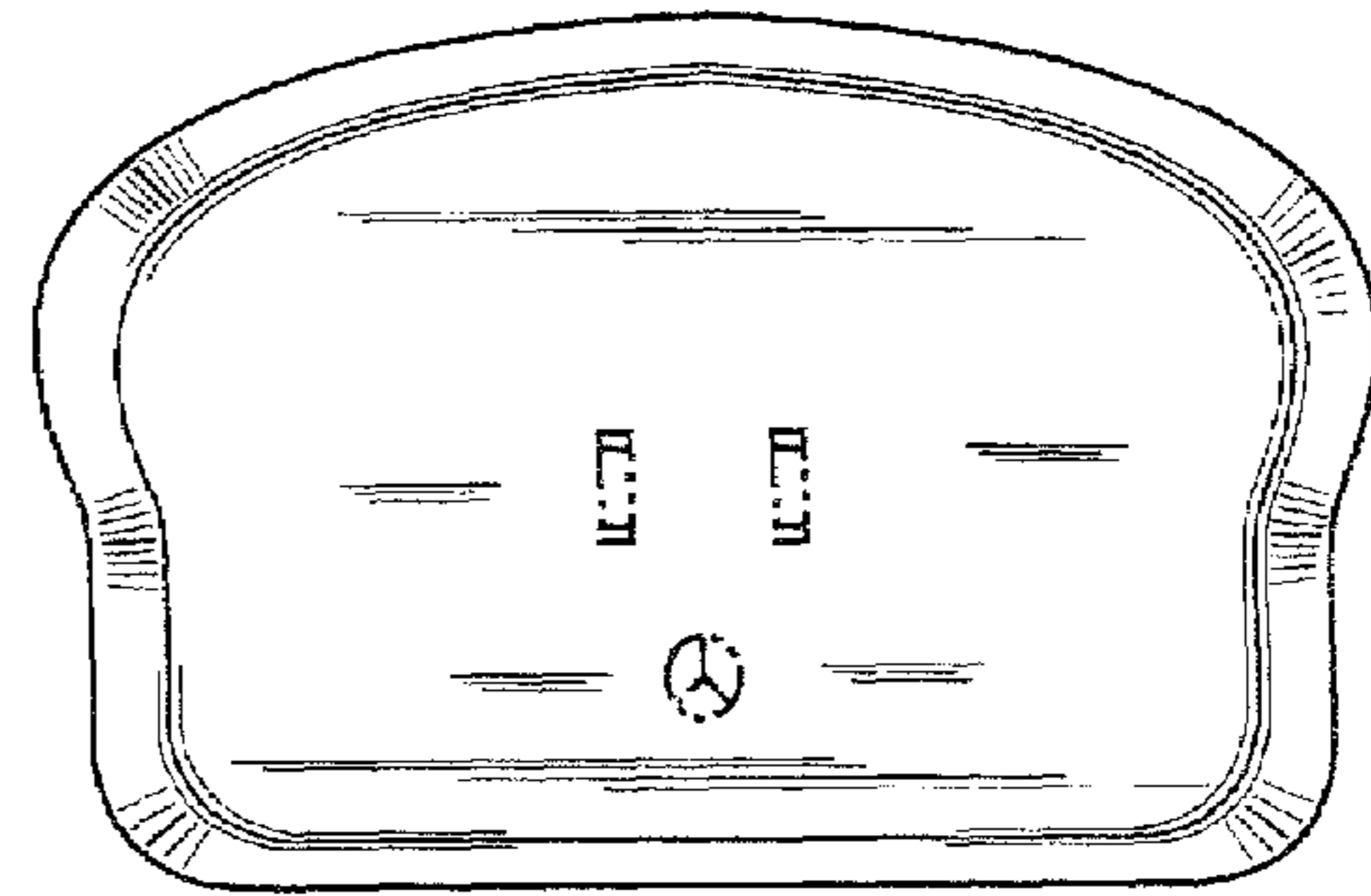
