DESCRIPTION

FIG. 1 is a top and front perspective view of mobile phone, showing our new design;

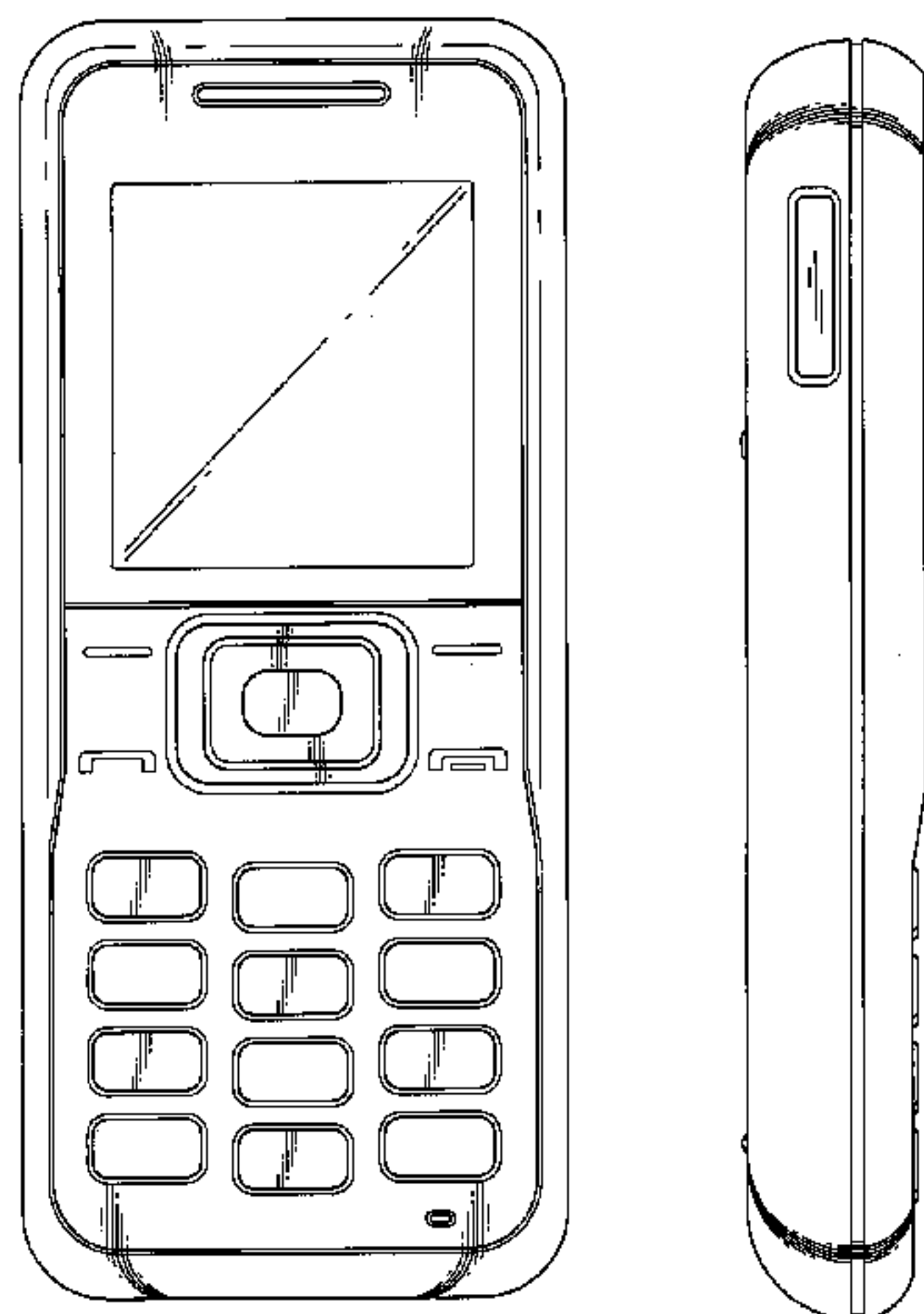

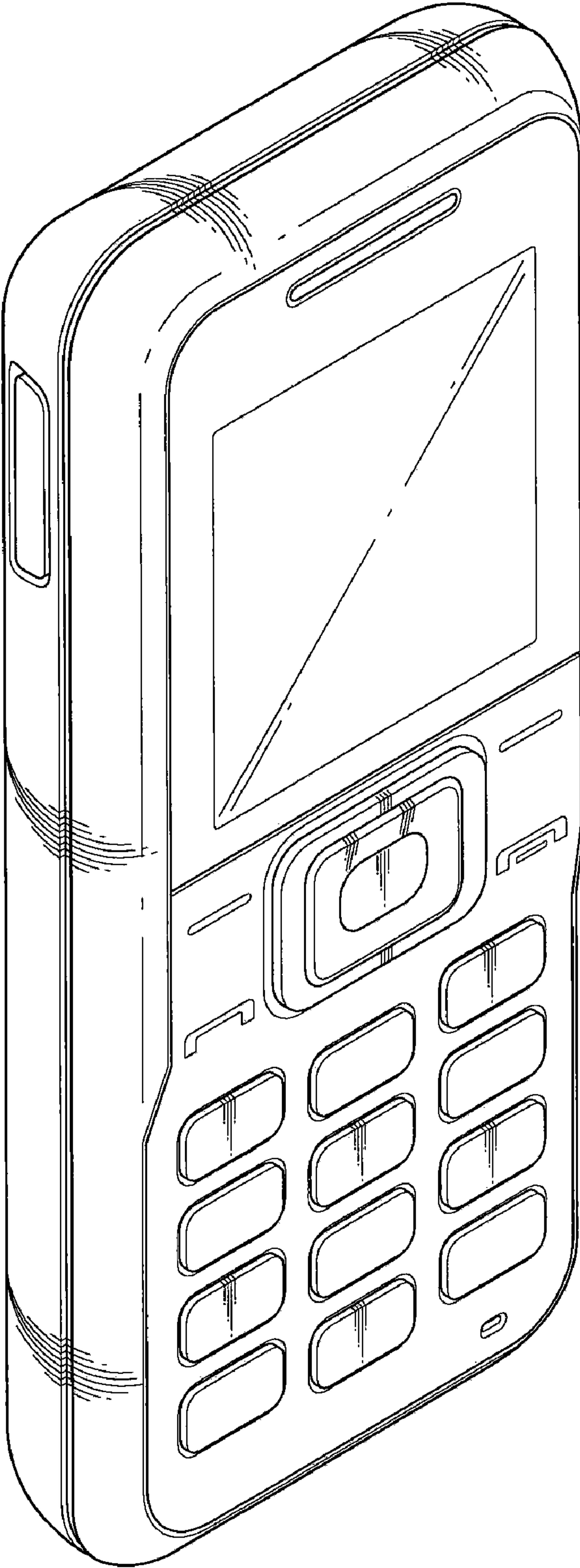

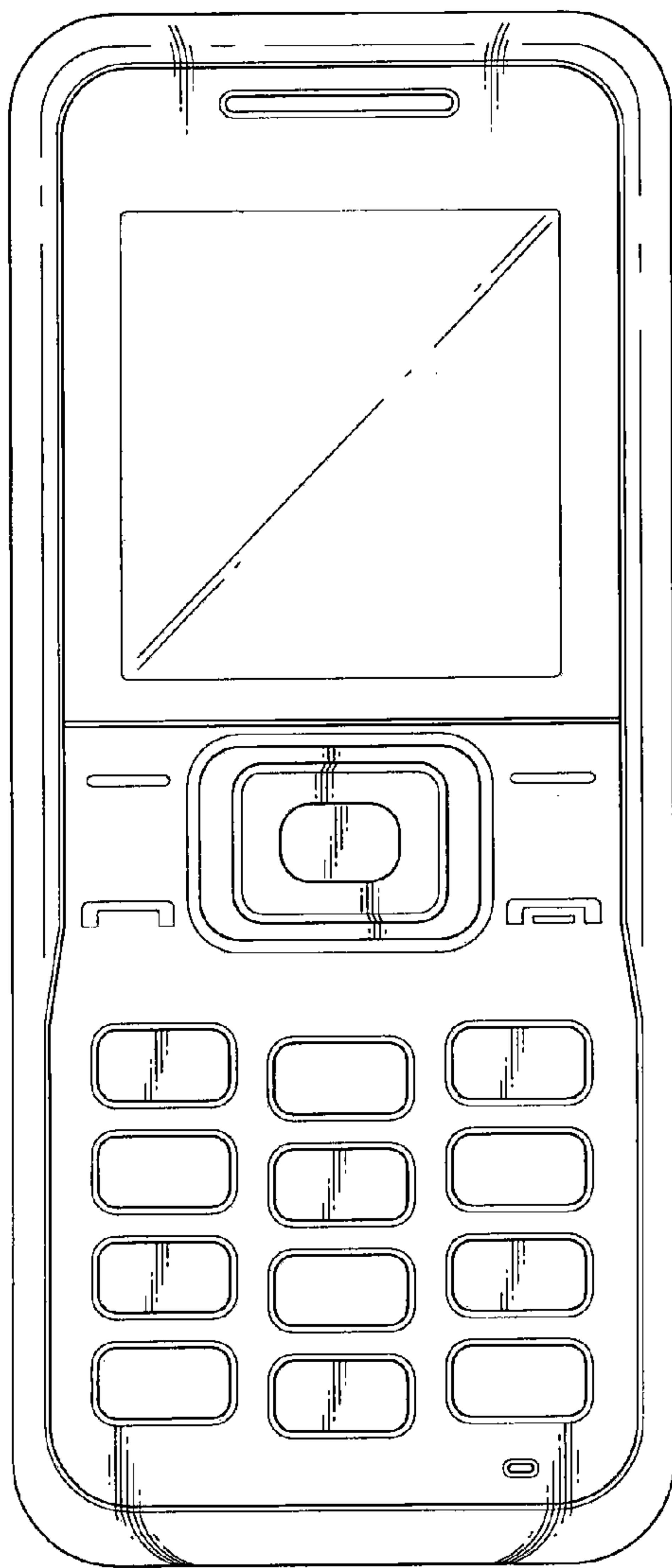

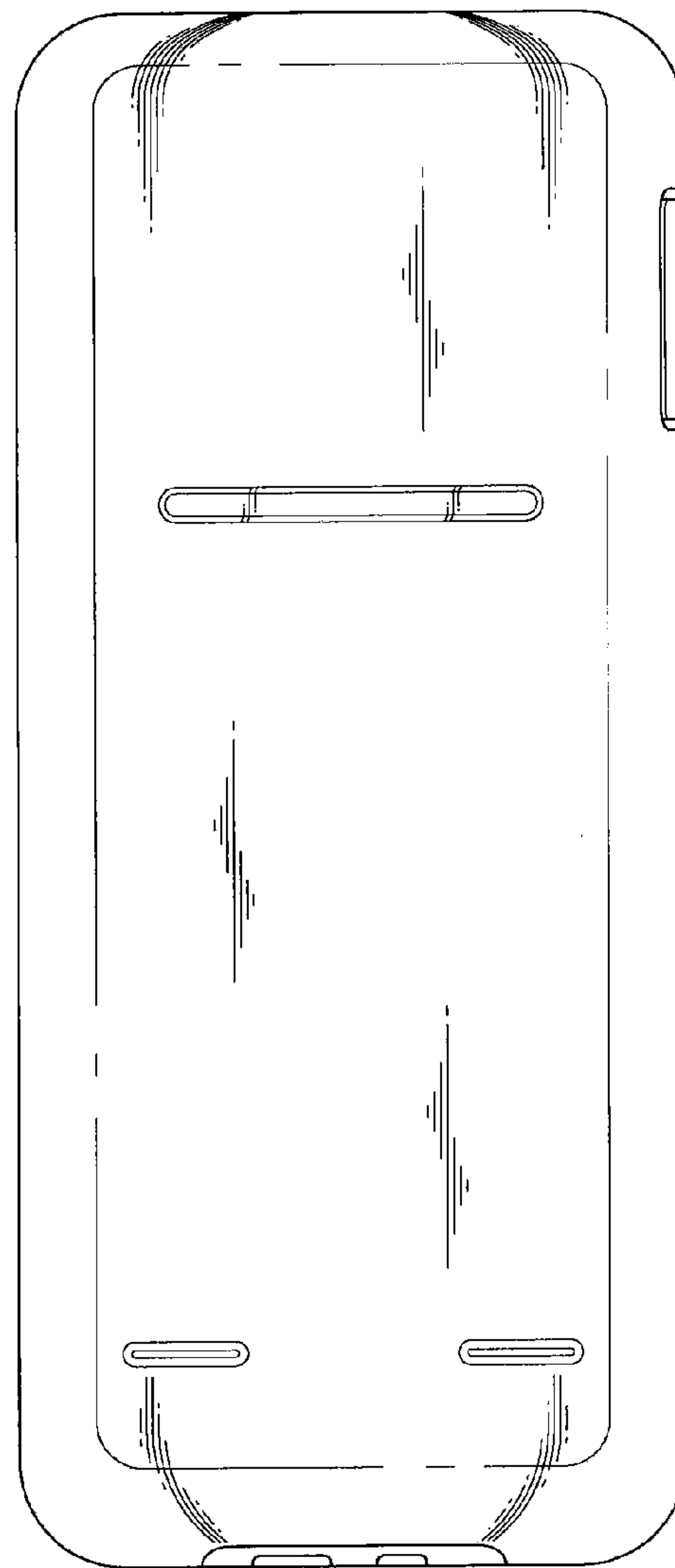

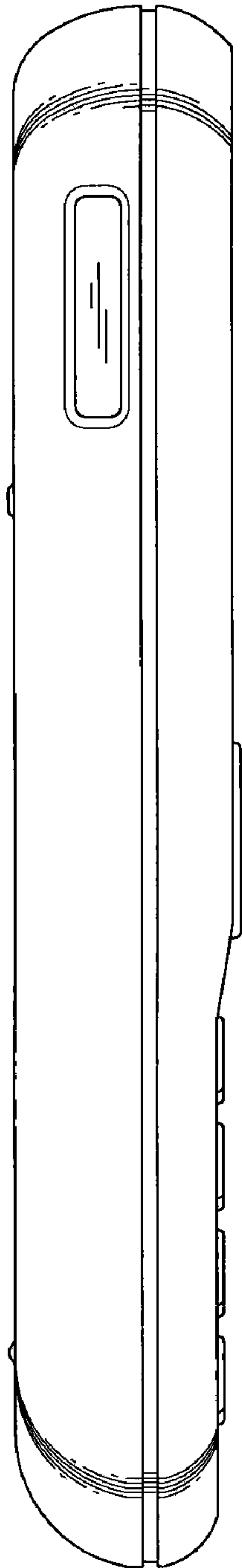

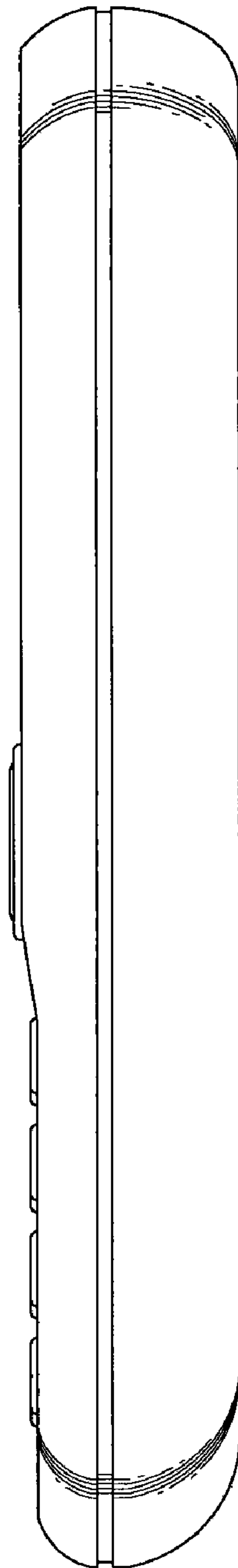

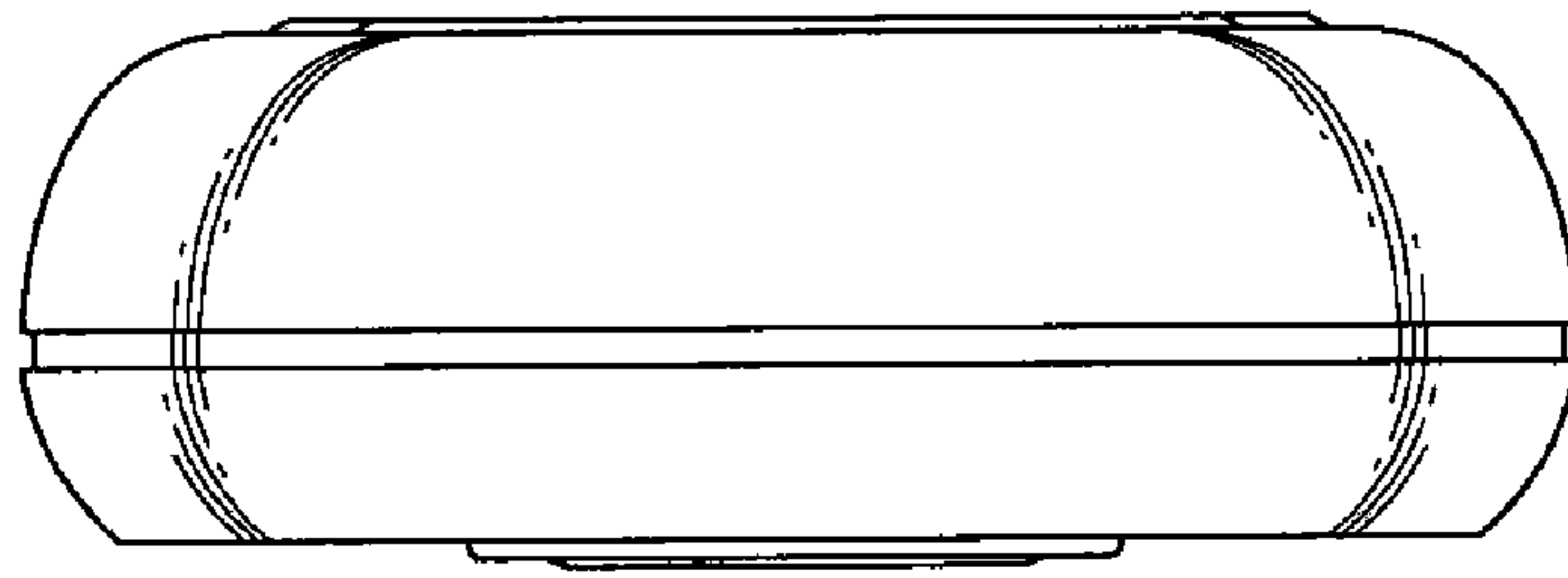
