DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of the ear bud adapter.

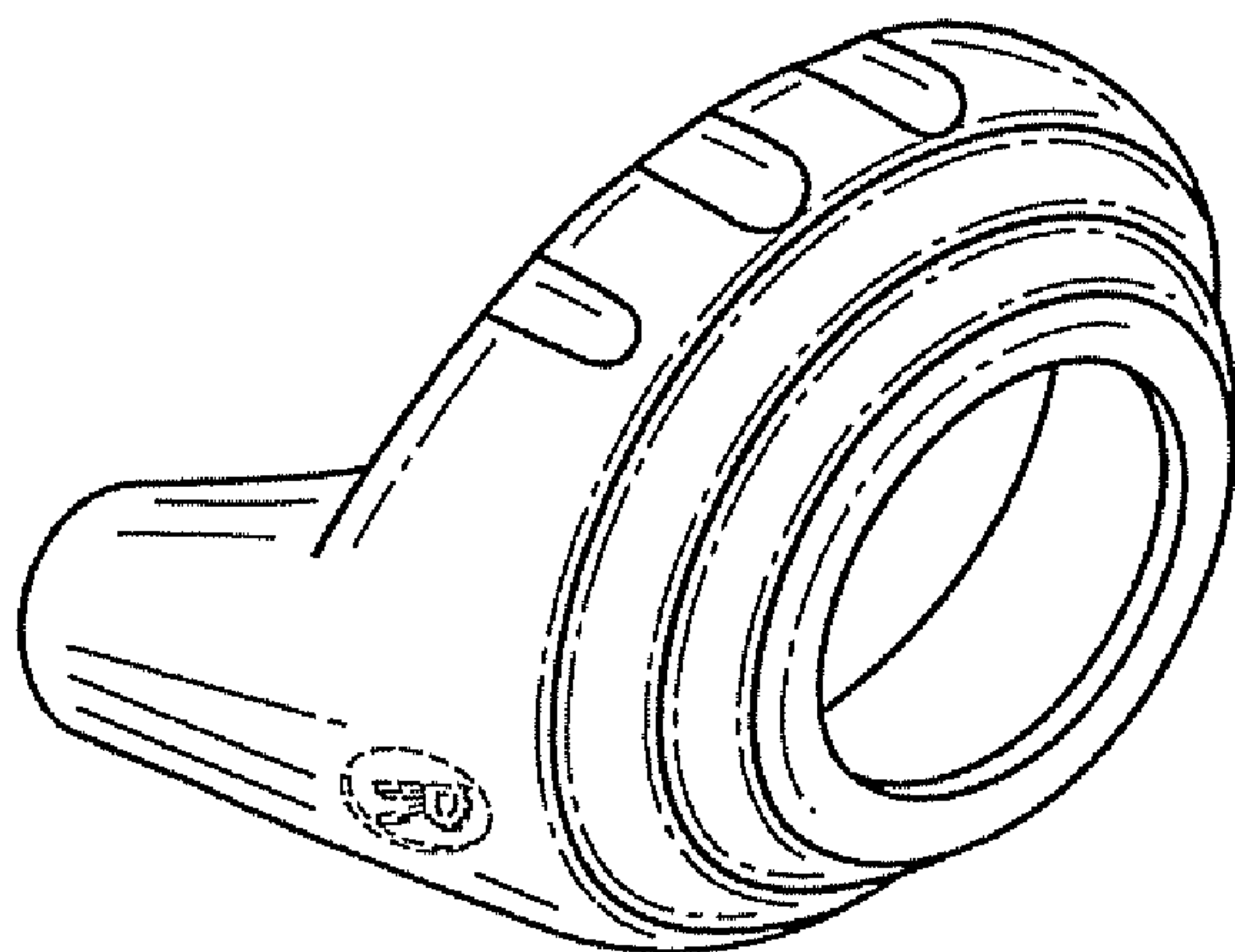


FIG. 2 is a rear perspective view of the first embodiment of the ear bud adapter.

FIG. 13 is a first side view of the second embodiment of the ear bud adapter.

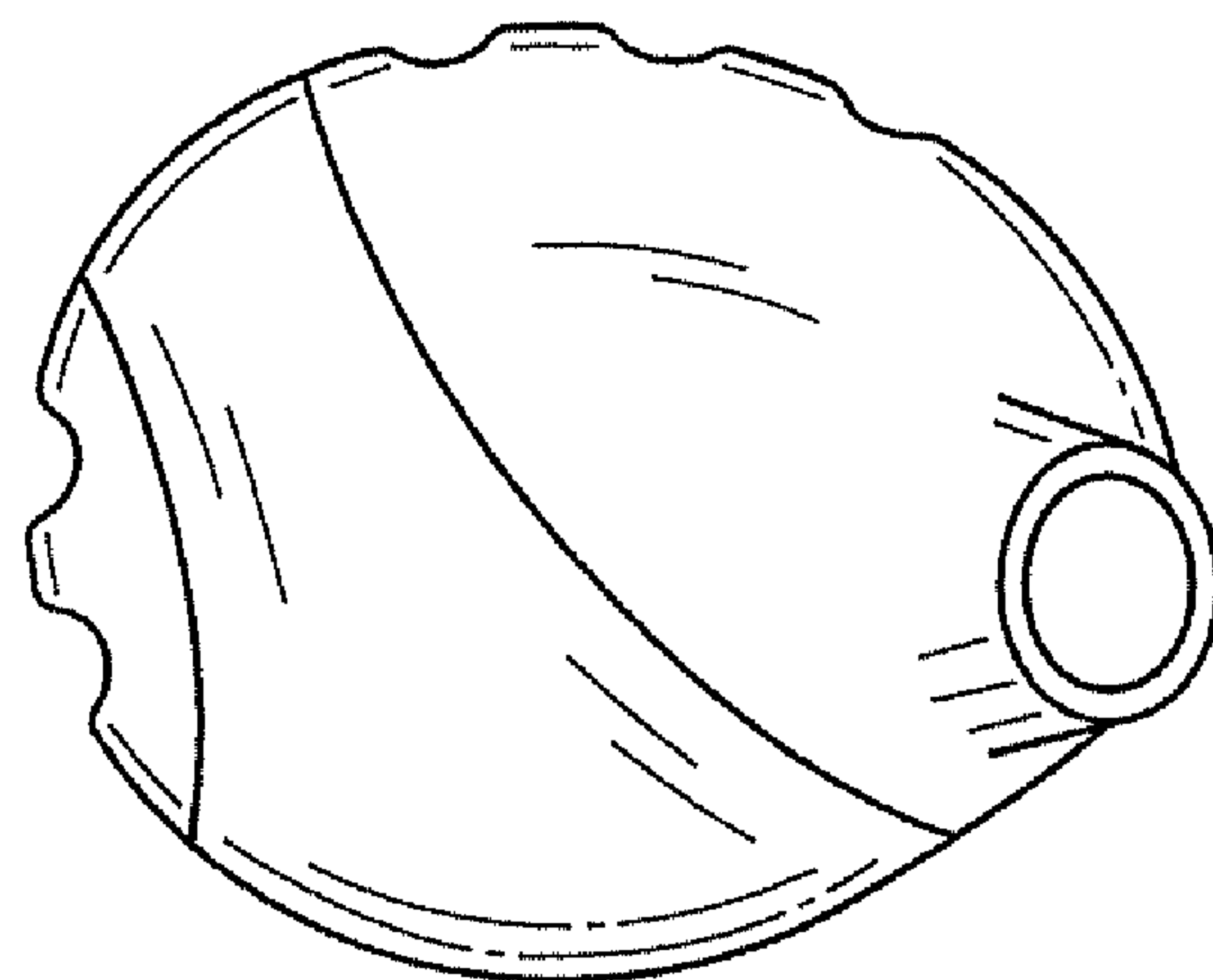
FIG. 14 is a second side view of the second embodiment of the ear bud adapter illustrating the side opposite that illustrated in FIG. 13.

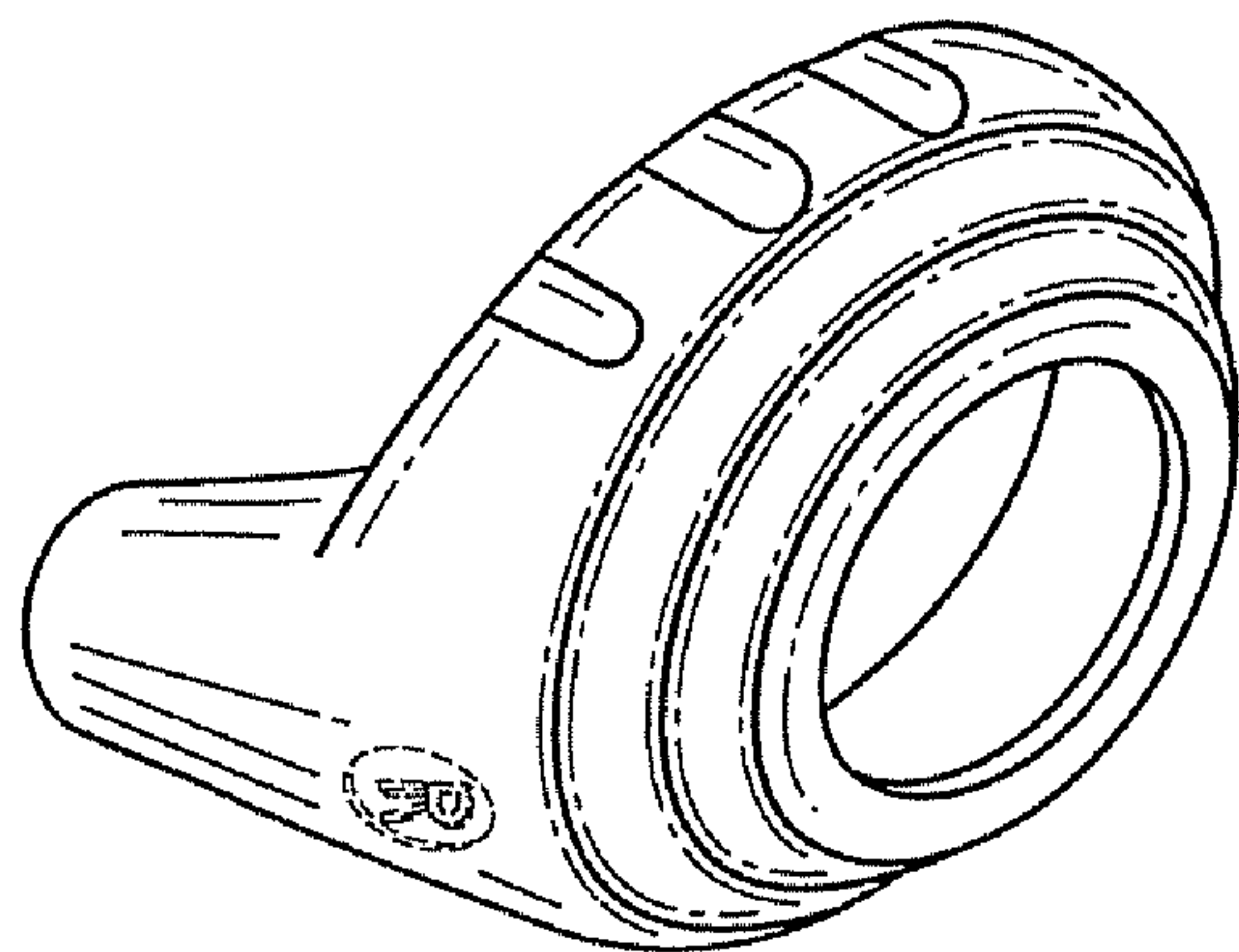

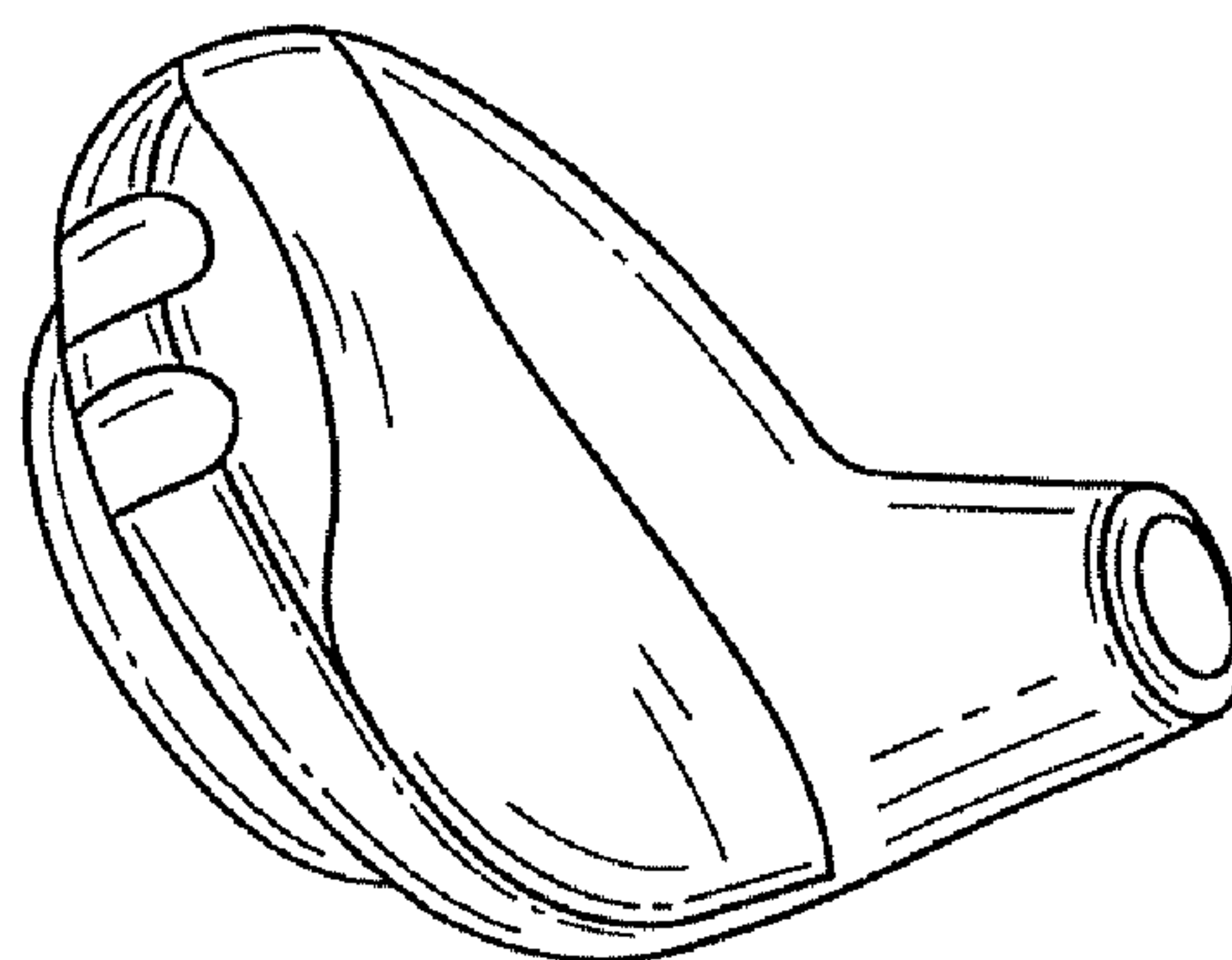

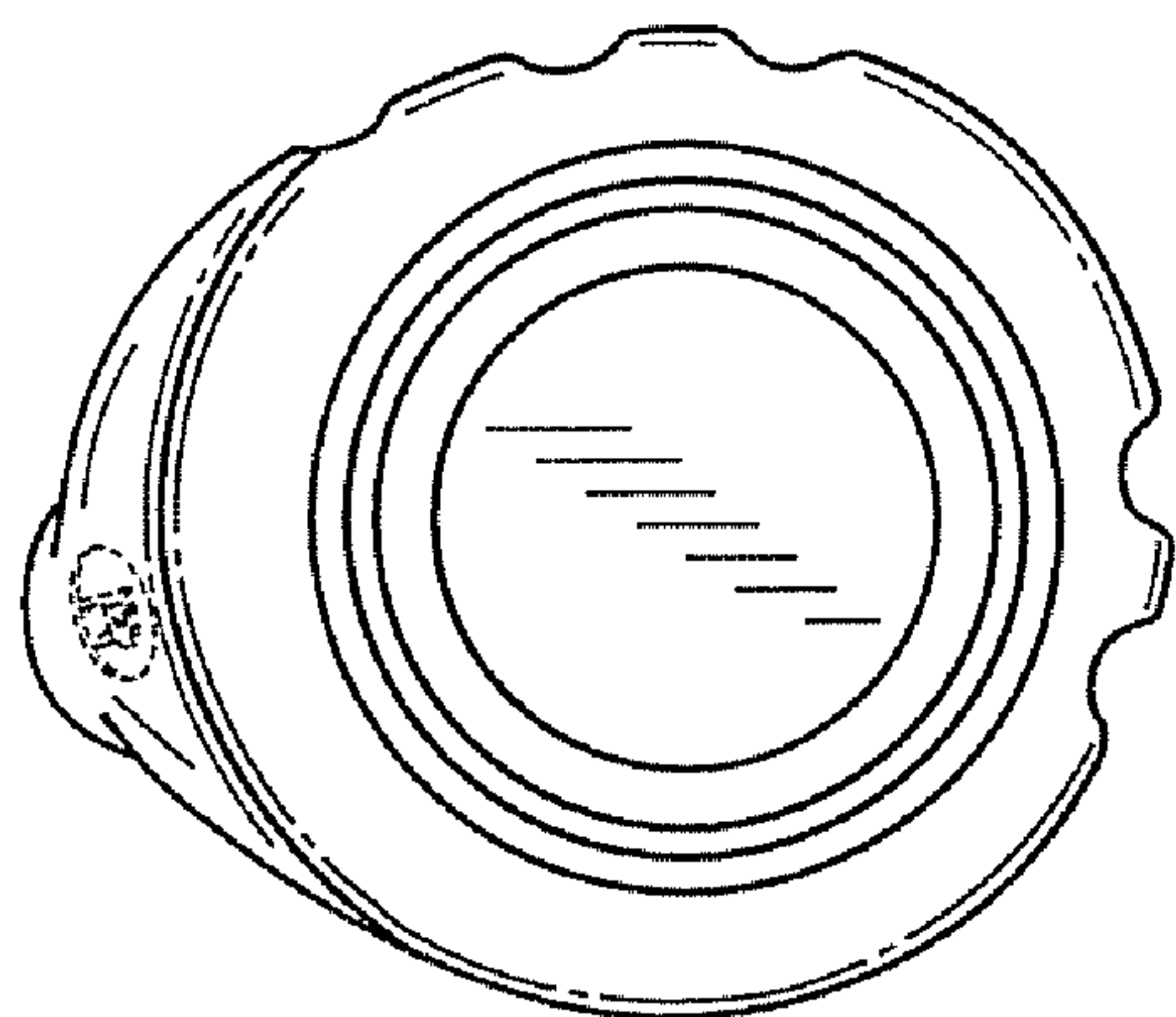

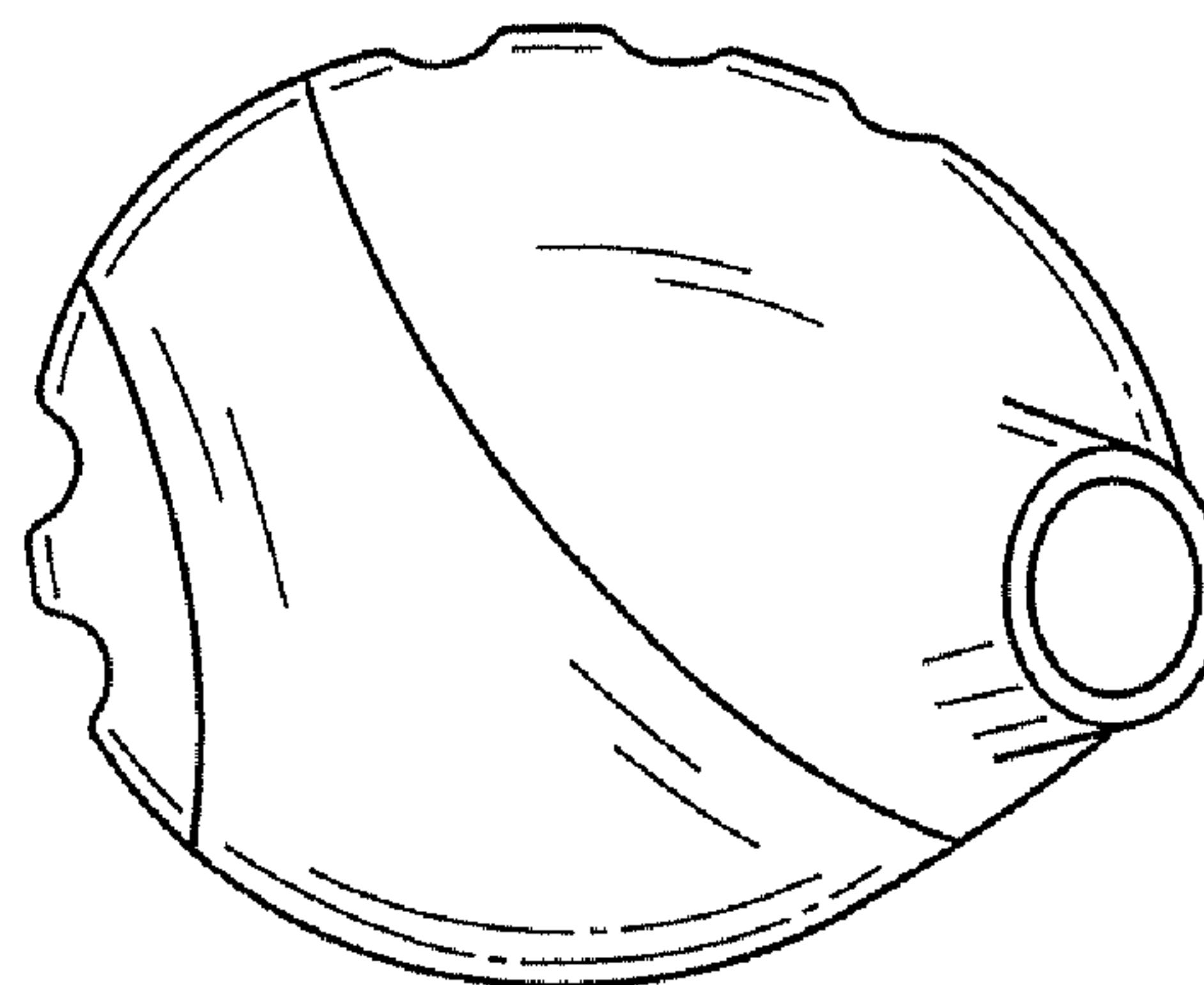

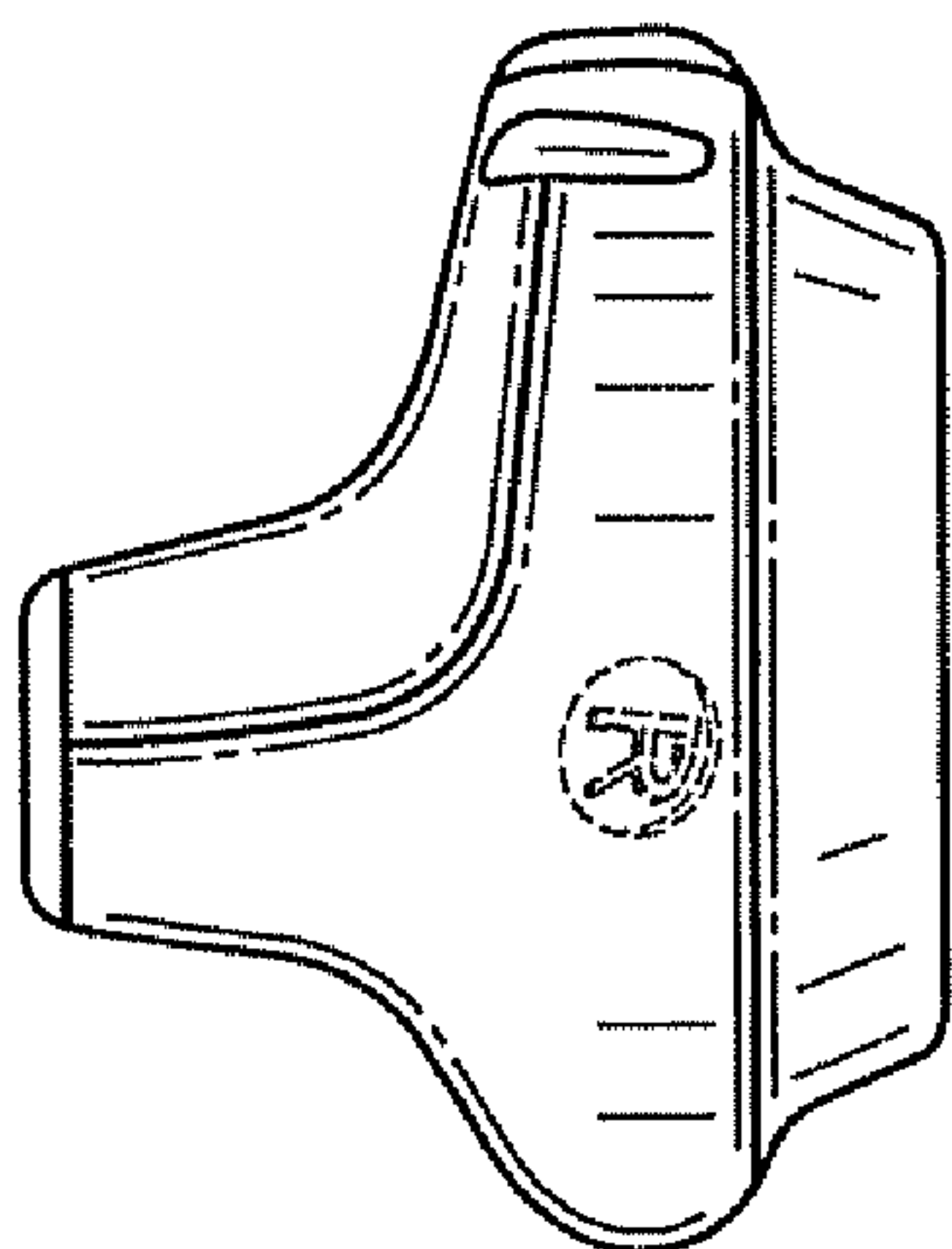

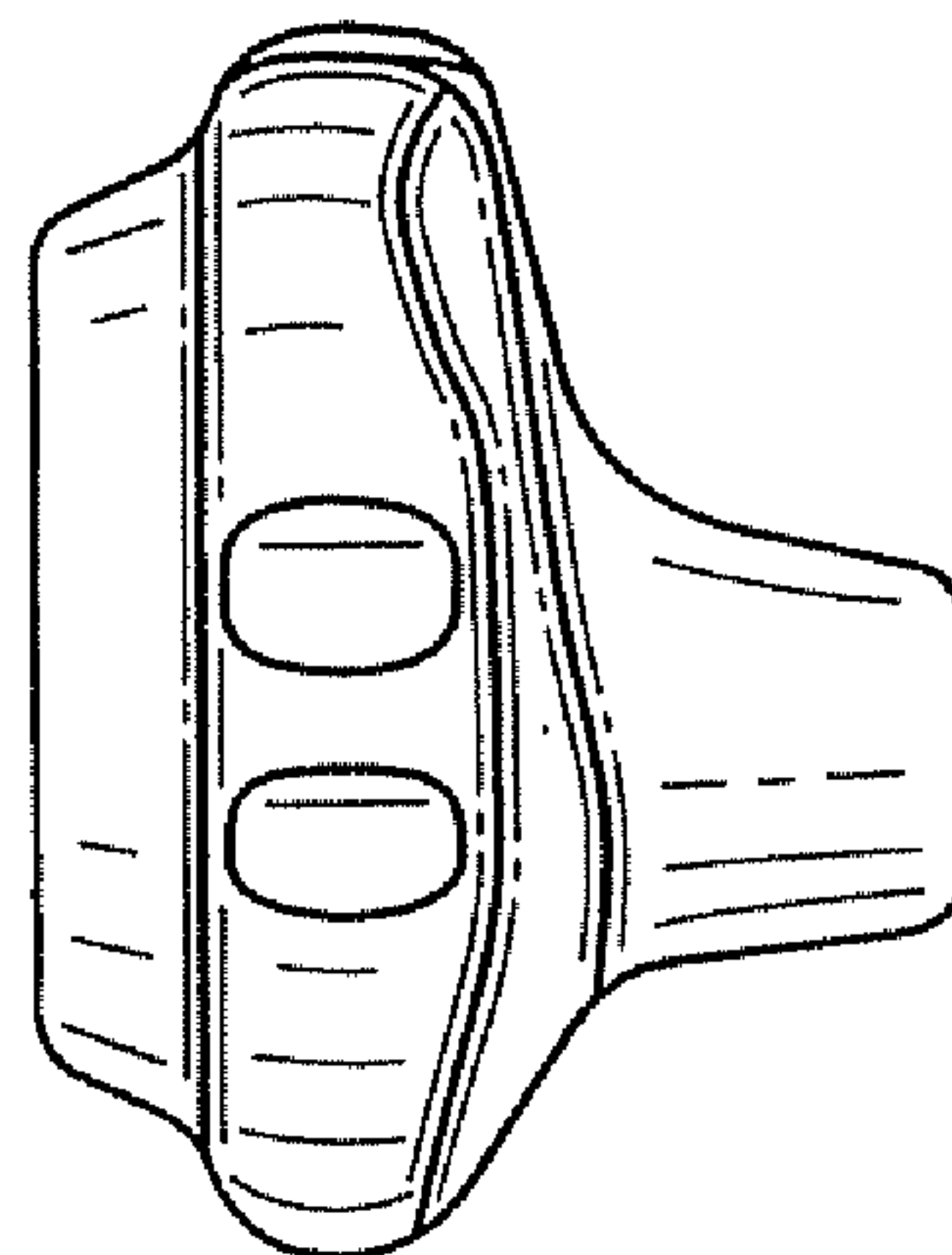

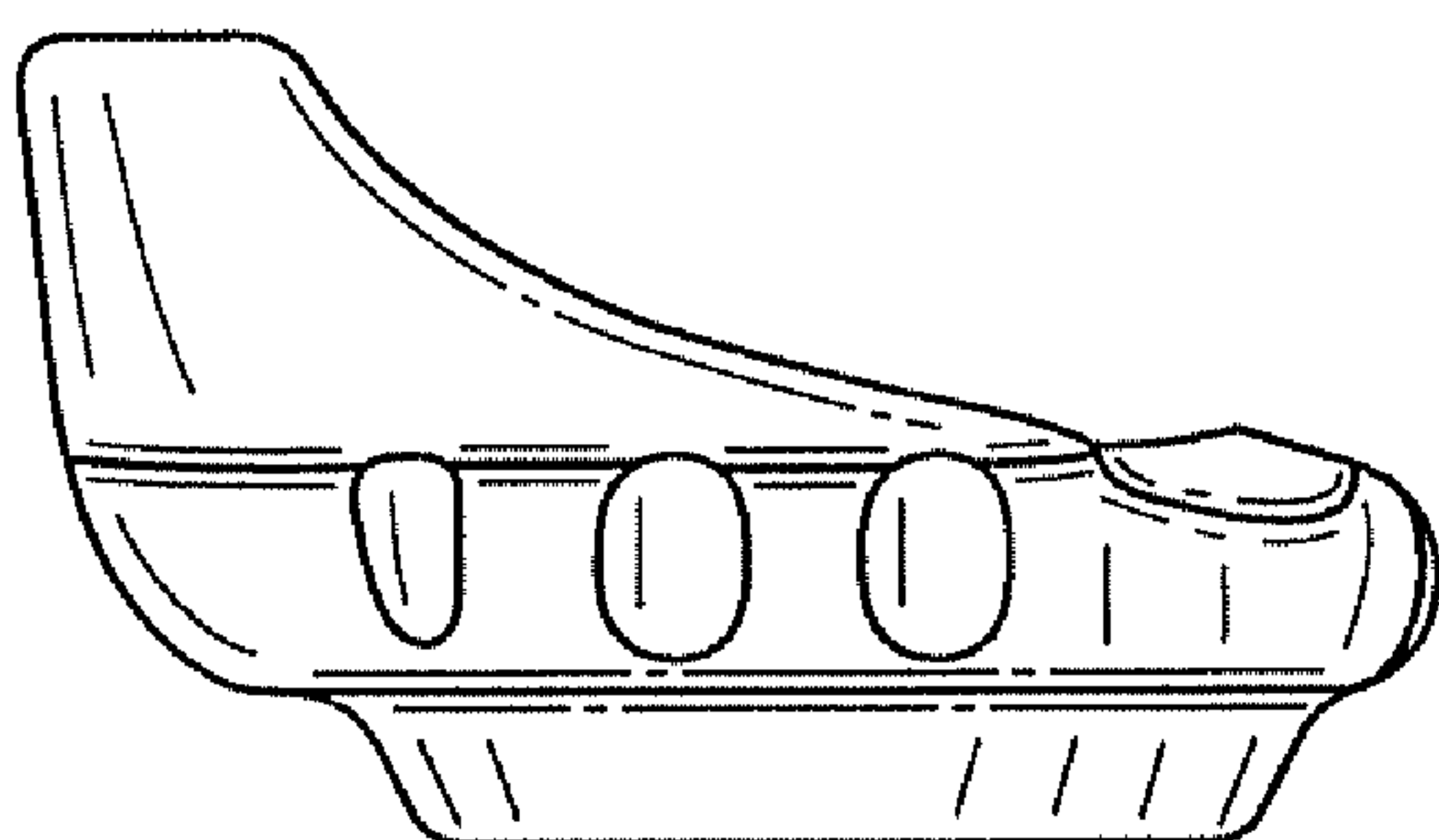

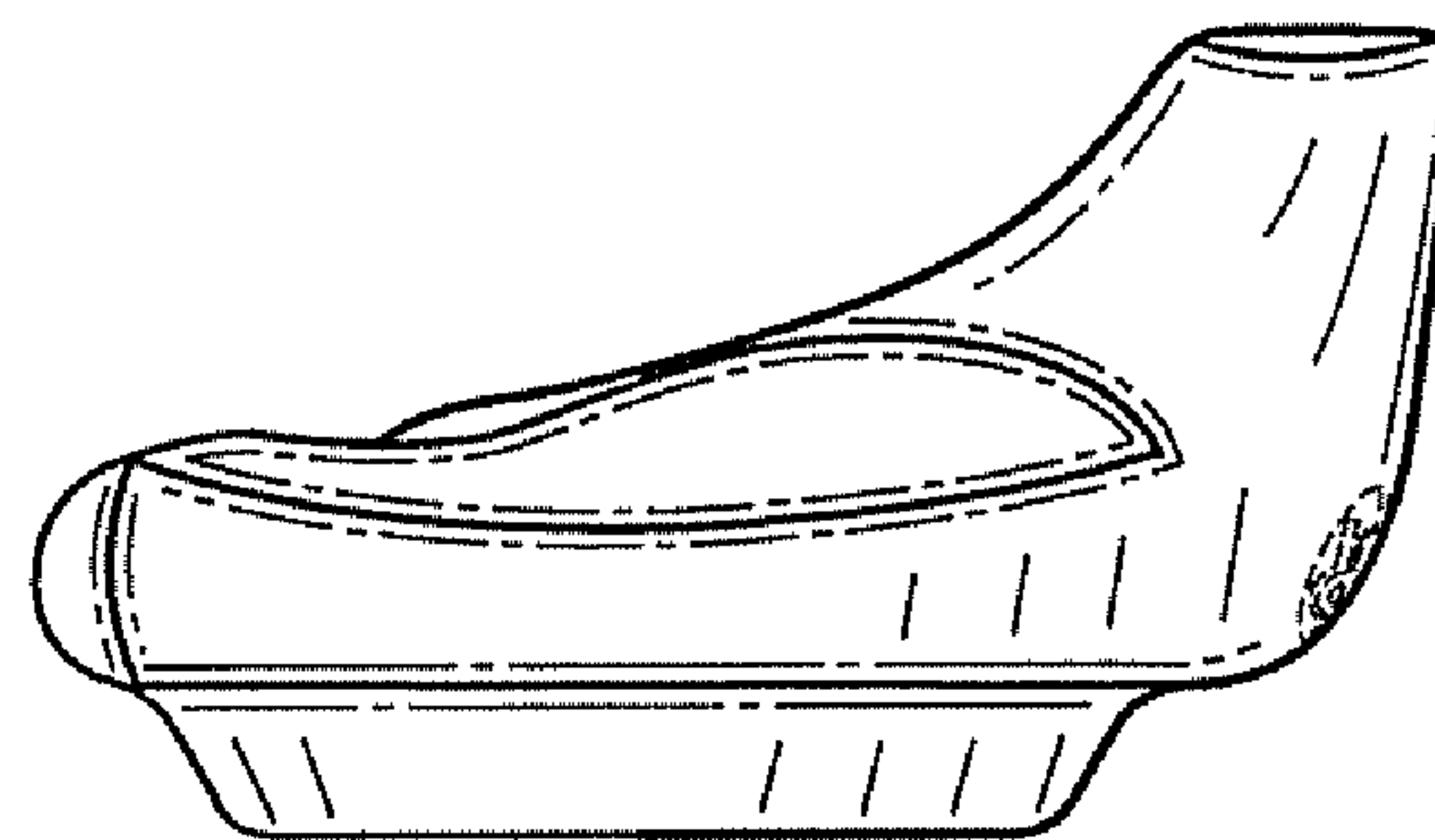

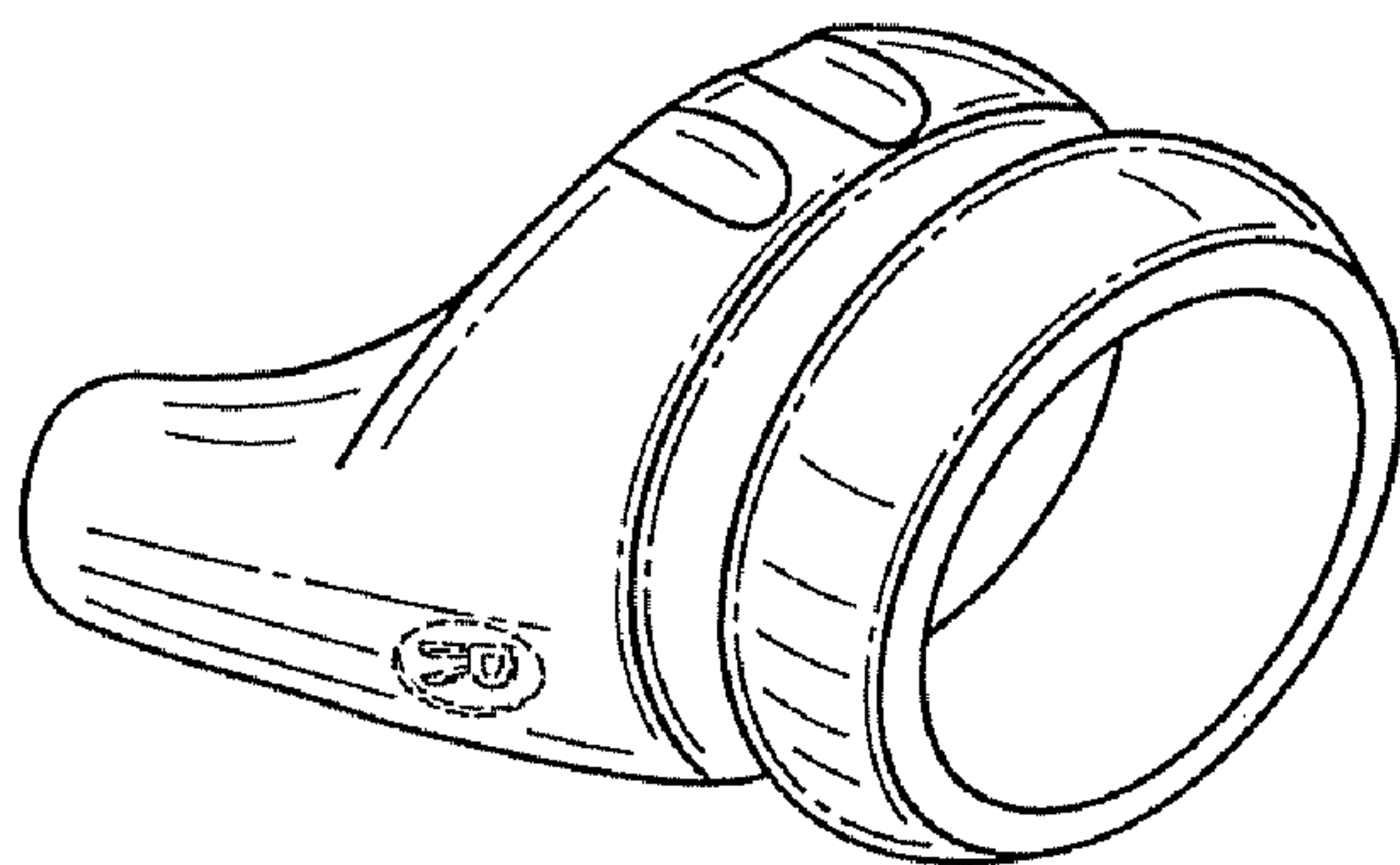

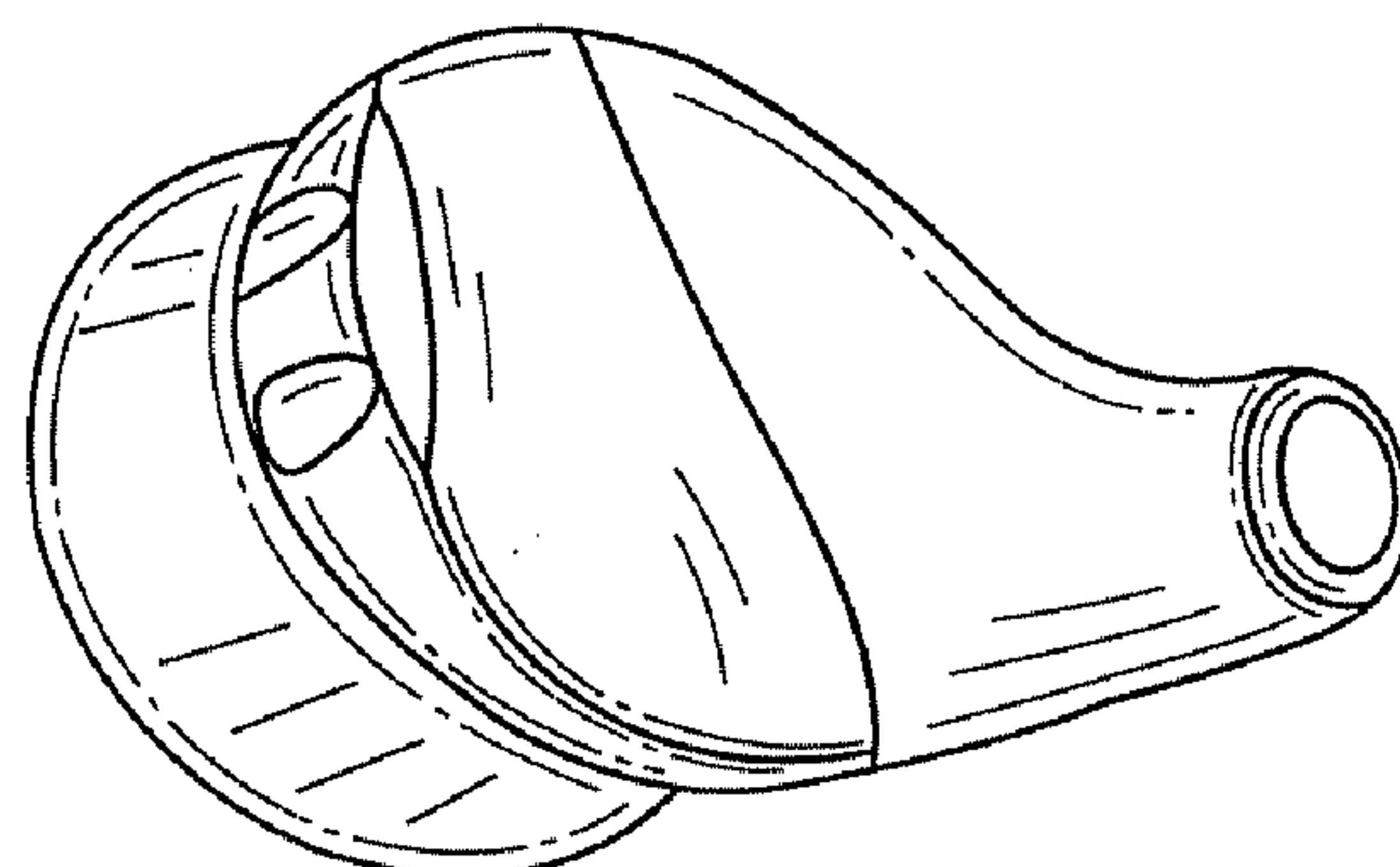

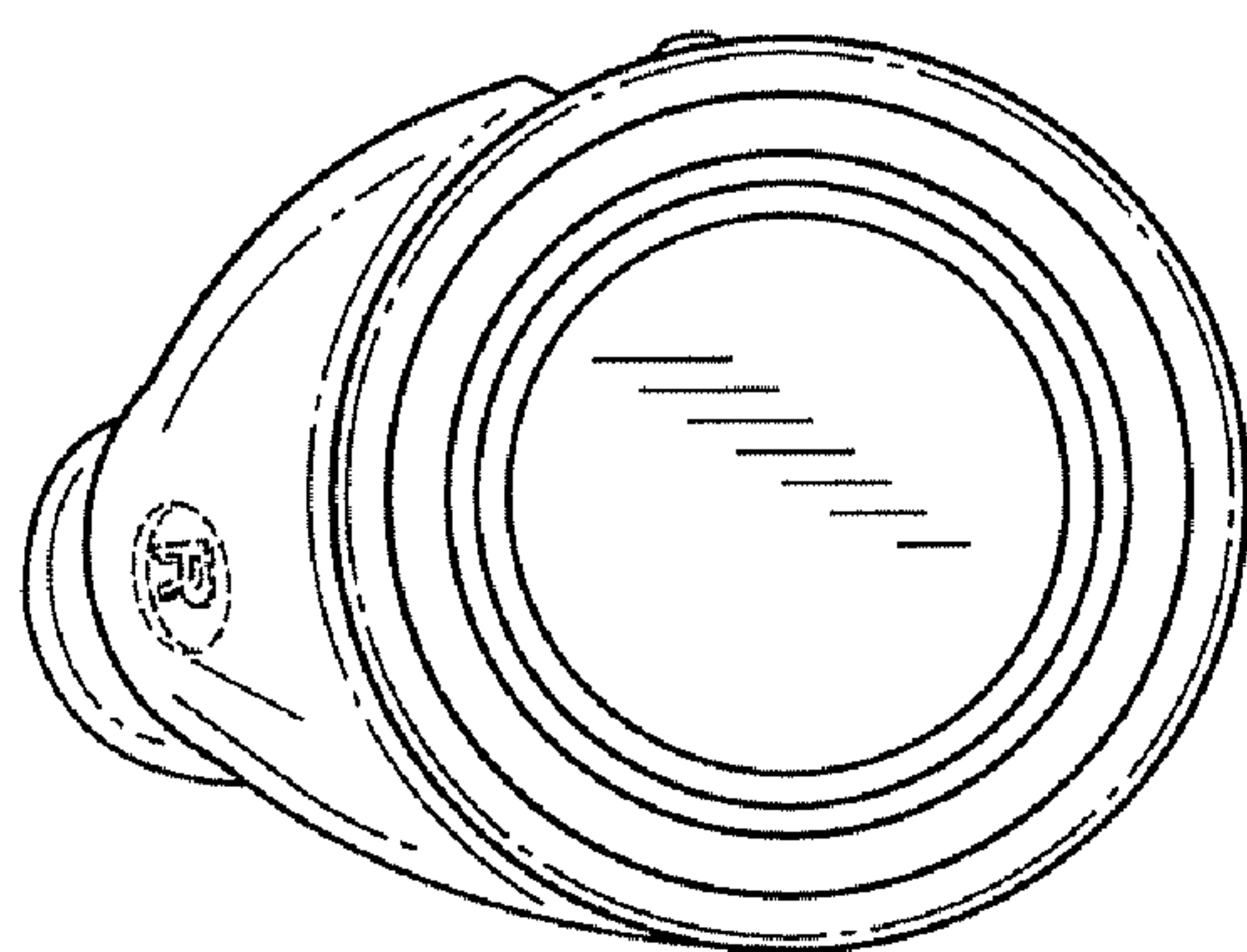

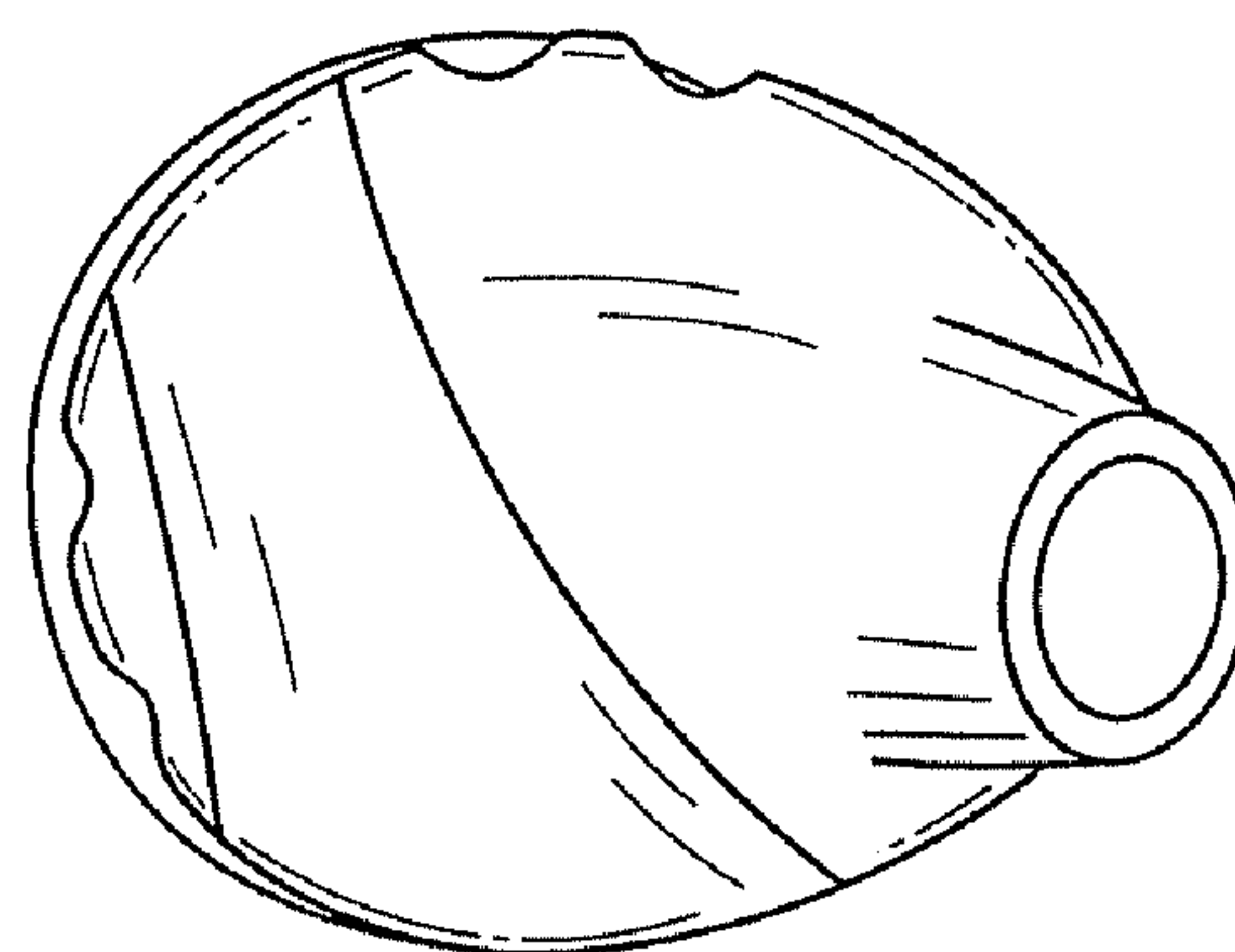

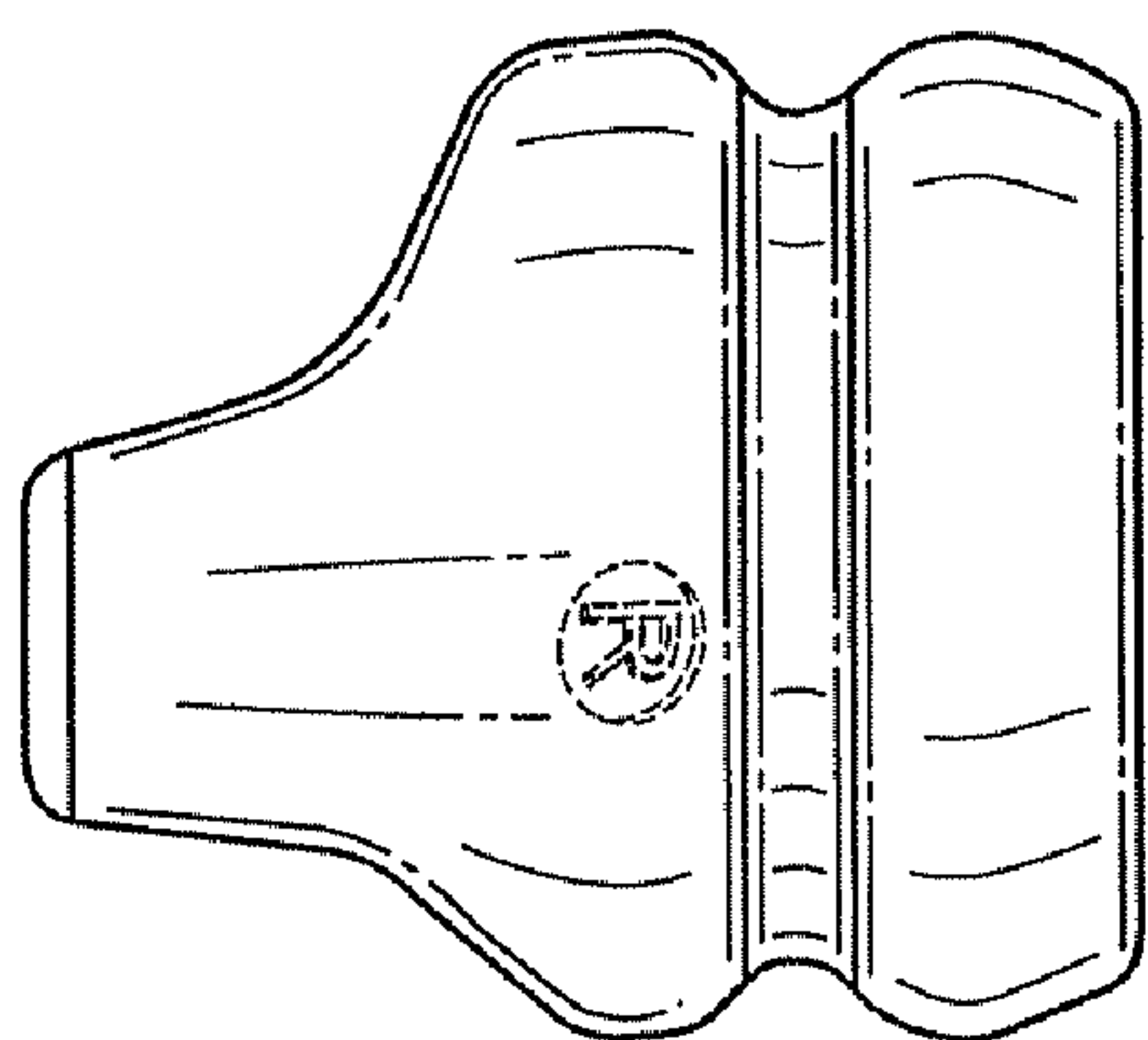

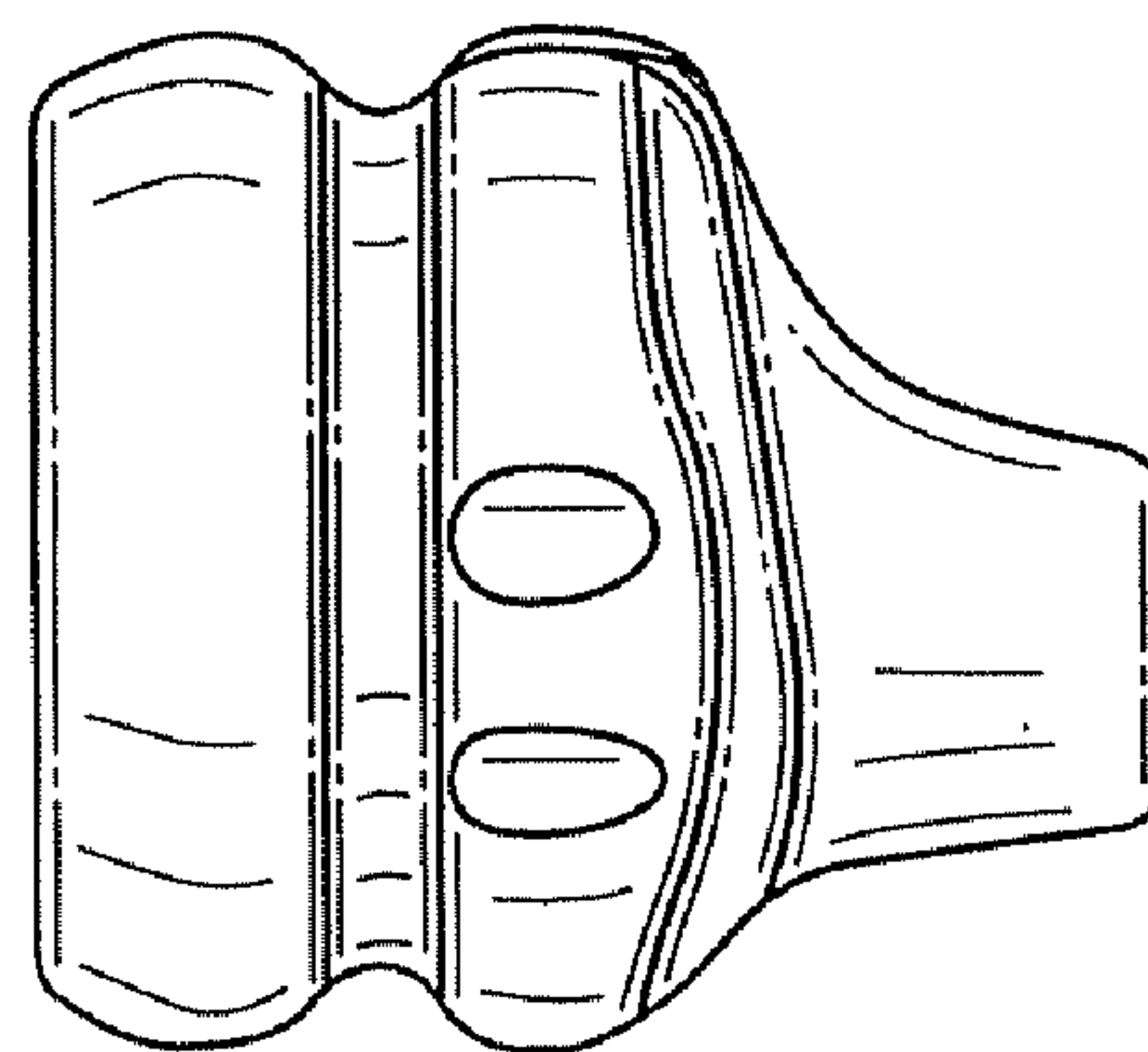

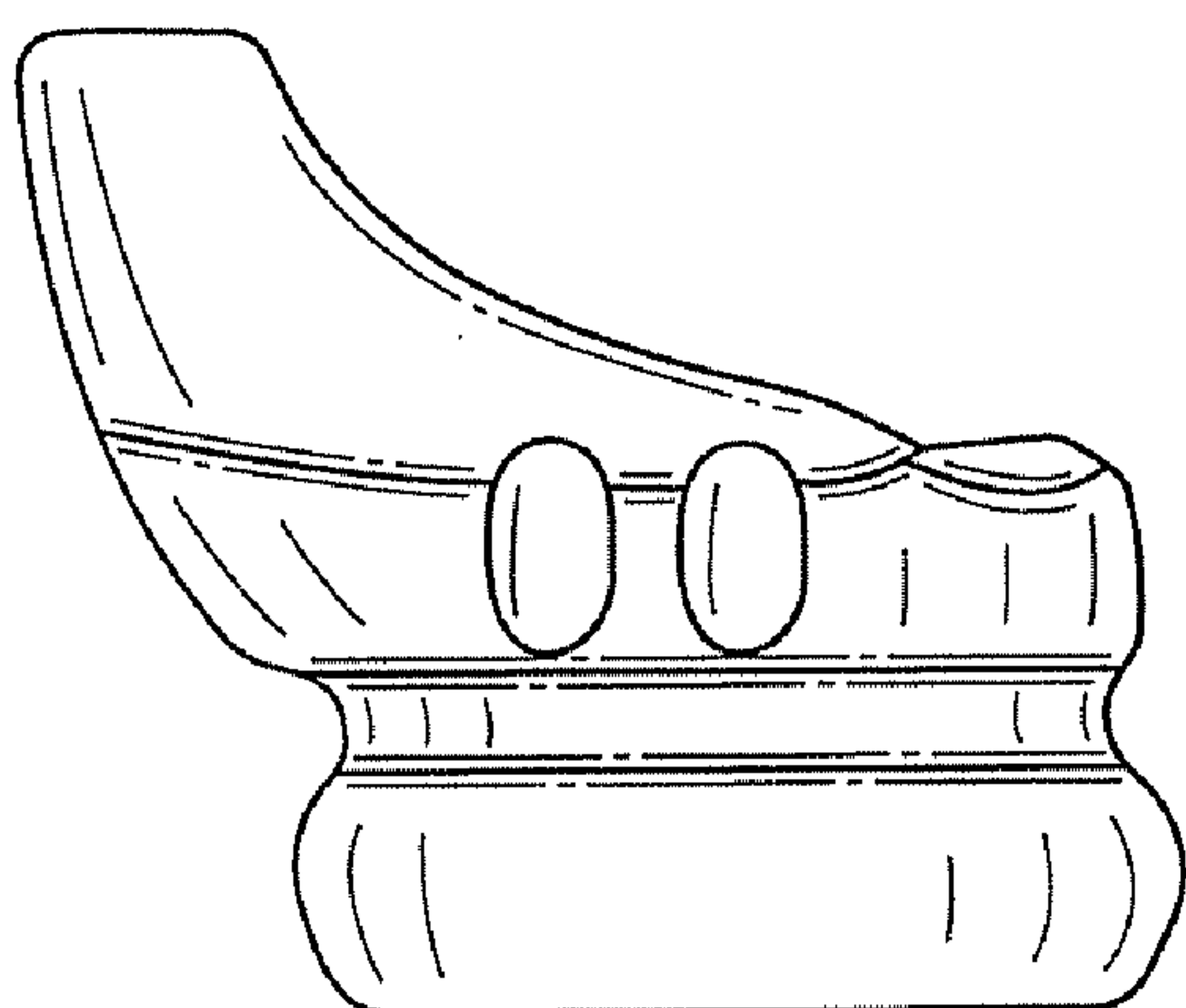

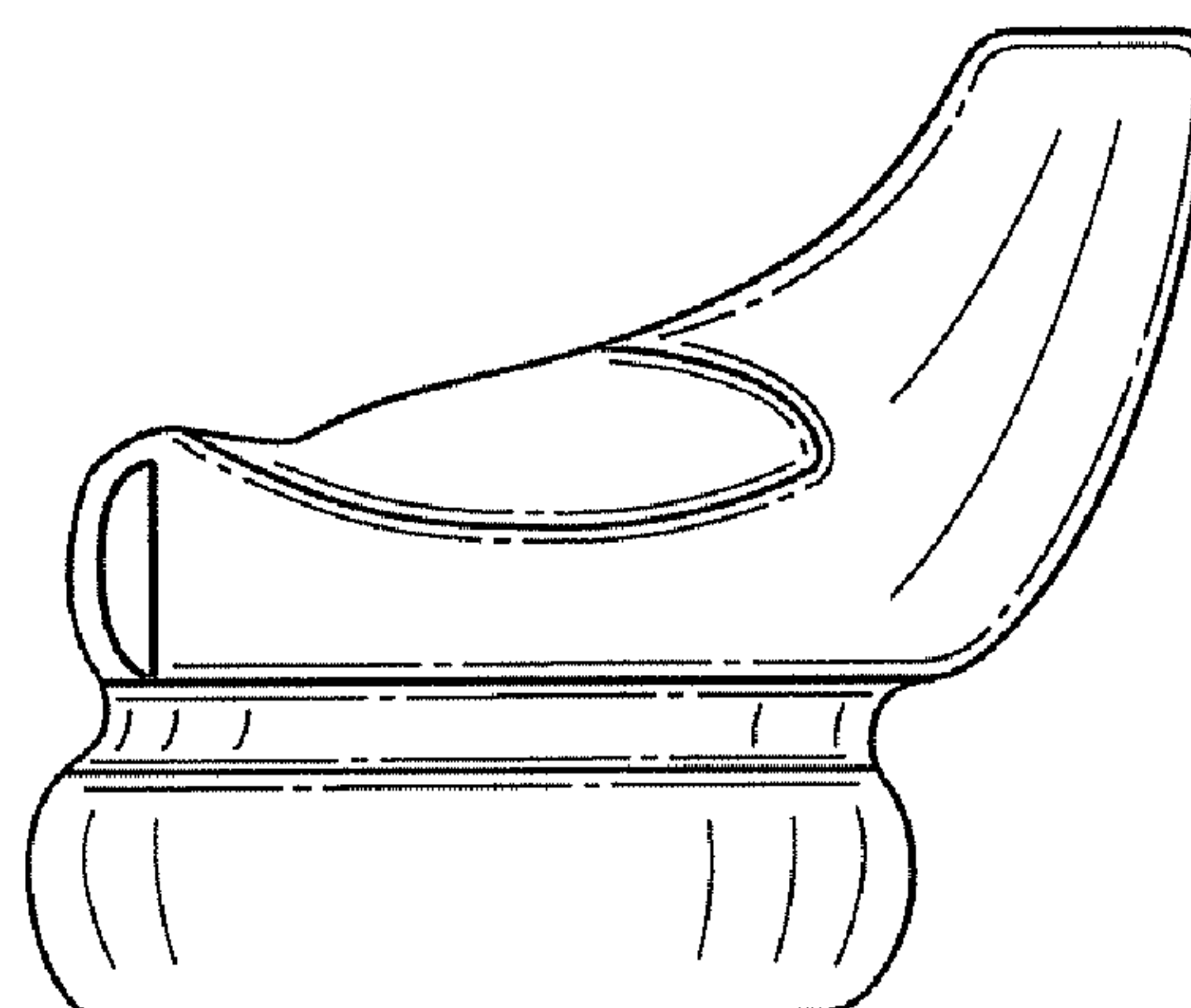
