The ornamental design for an external hard-disk, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an external hard-disk;
FIG. 2 is a front view of the external hard-disk of FIG. 1;
FIG. 3 is a rear view of the external hard-disk of FIG. 1;
FIG. 4 is a left-side view of the external hard-disk of FIG. 1;
FIG. 5 is a right-side view of the external hard-disk of FIG. 1;
FIG. 6 is a top plan view of the external hard-disk of FIG. 1;
FIG. 7 is a bottom plan view of the external hard-disk of FIG. 1; and,

FIG. 8 is a front perspective view of the external hard-disk of FIG. 1, shown with environmental structure.

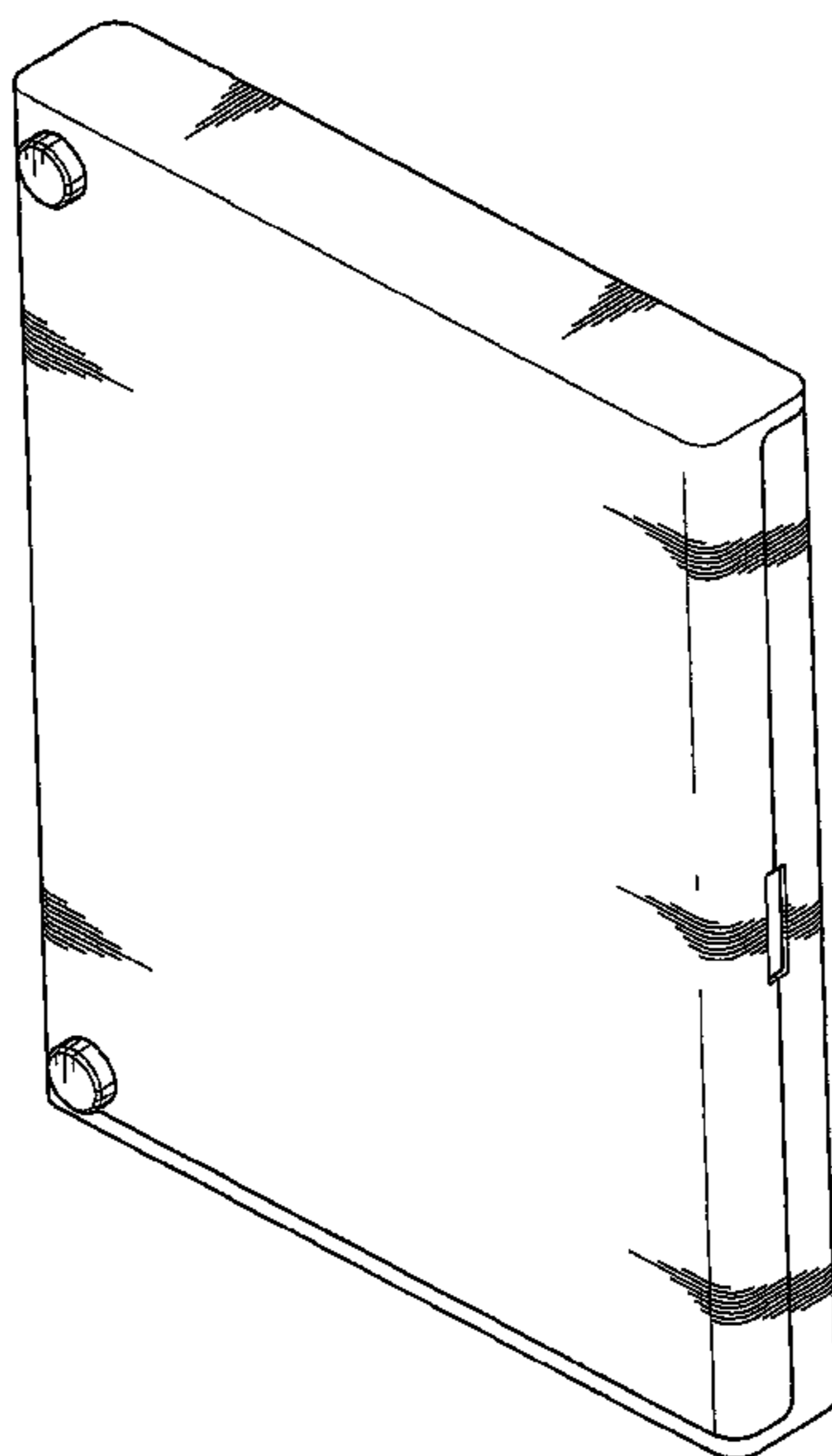

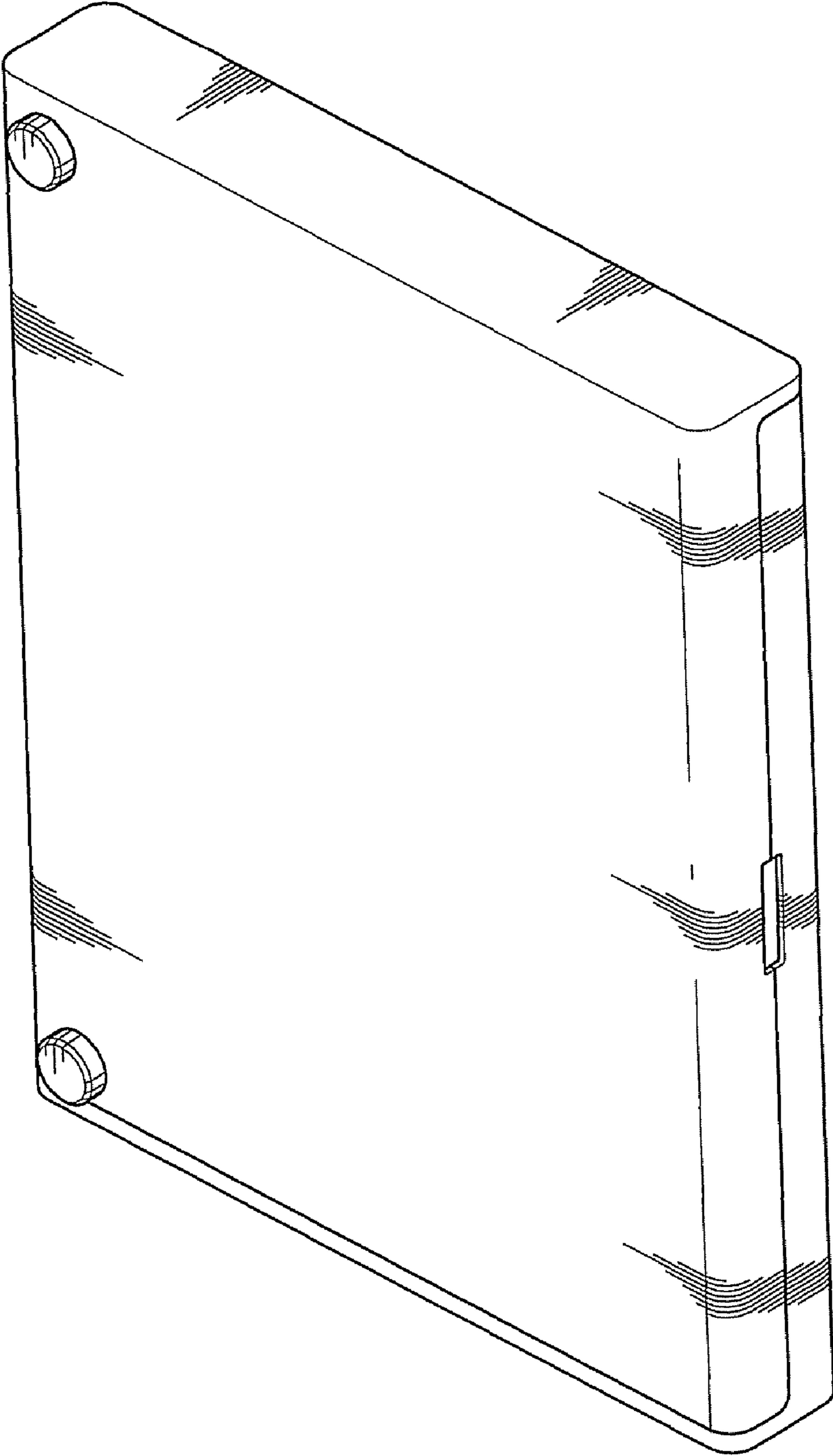

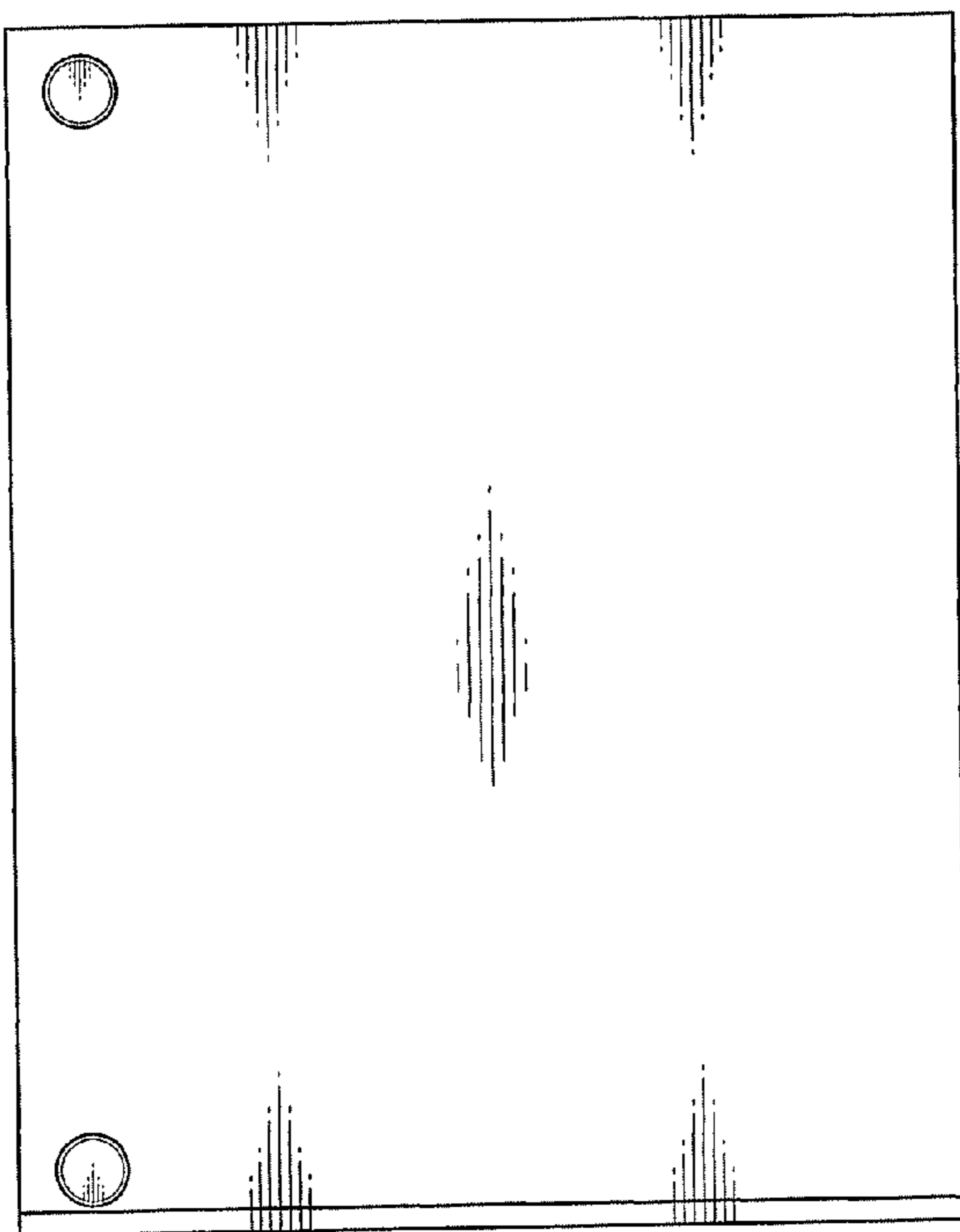

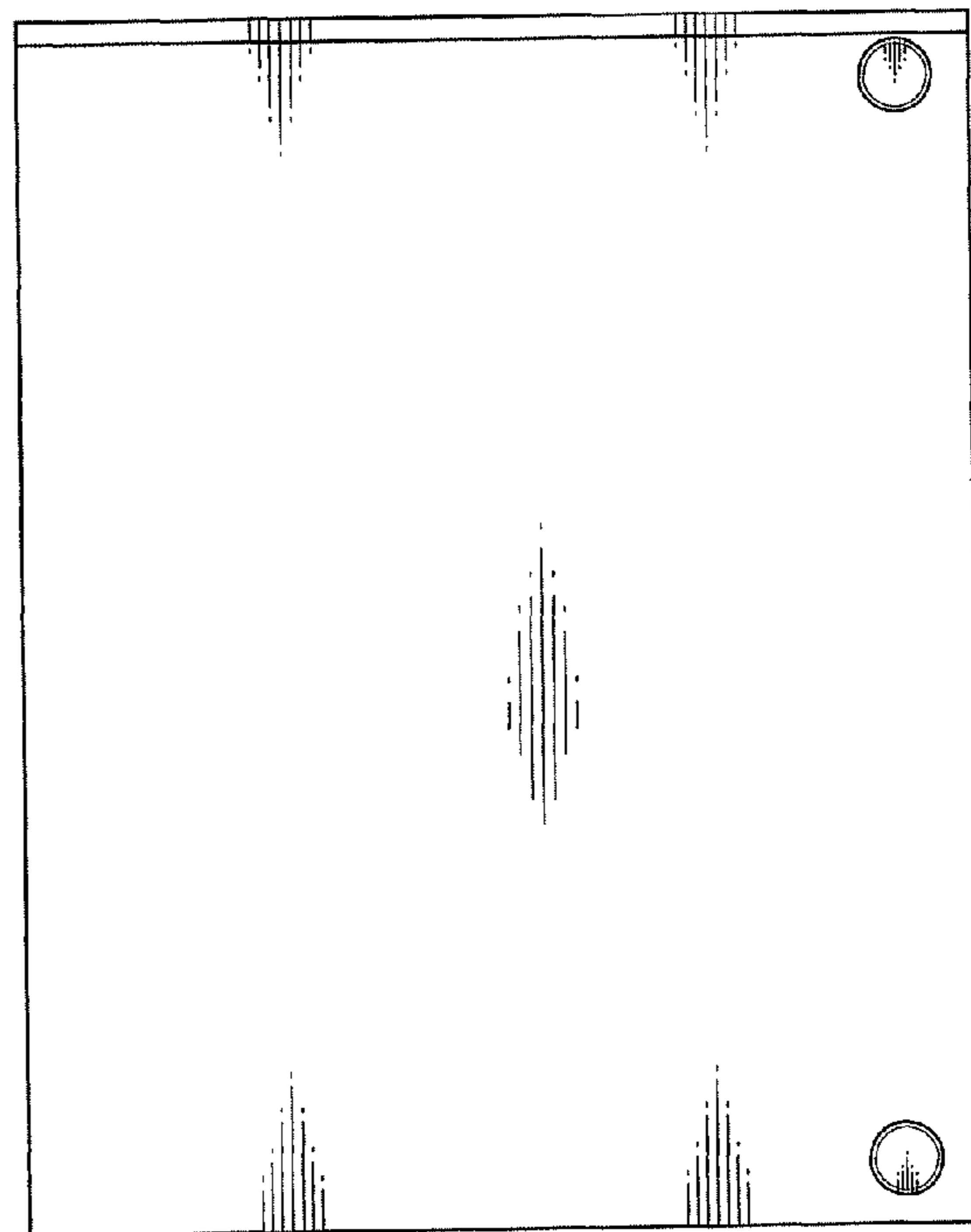

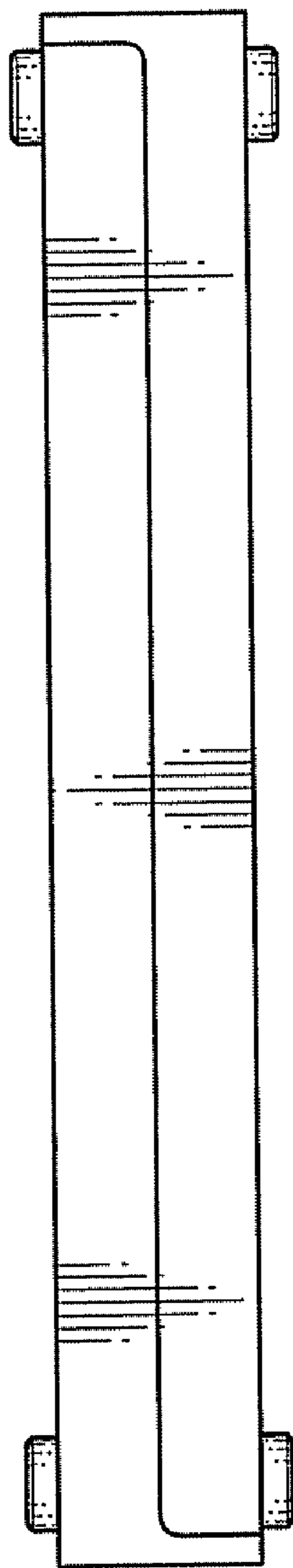

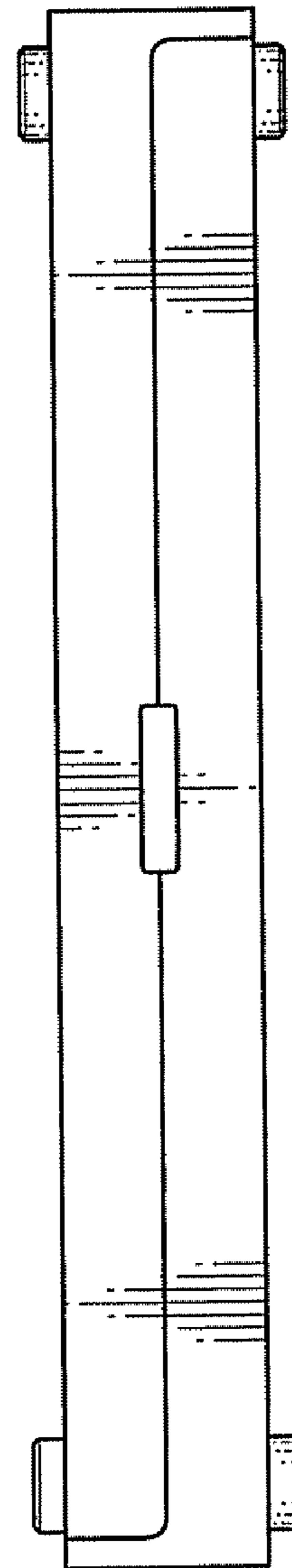

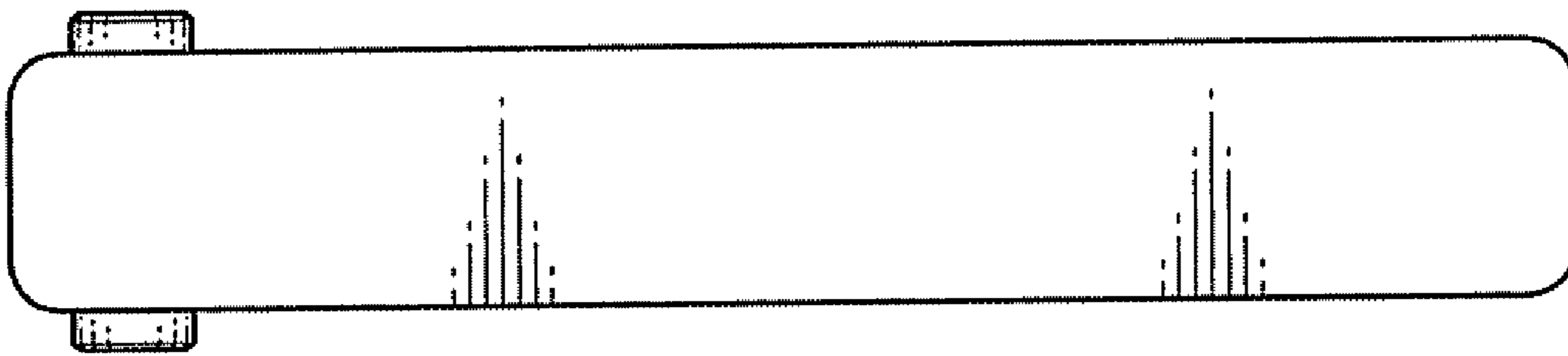

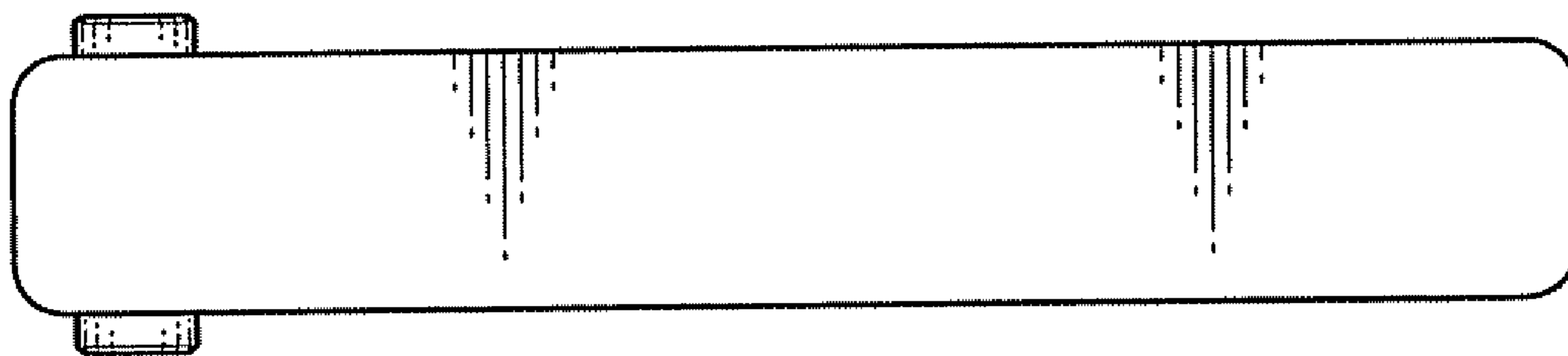
