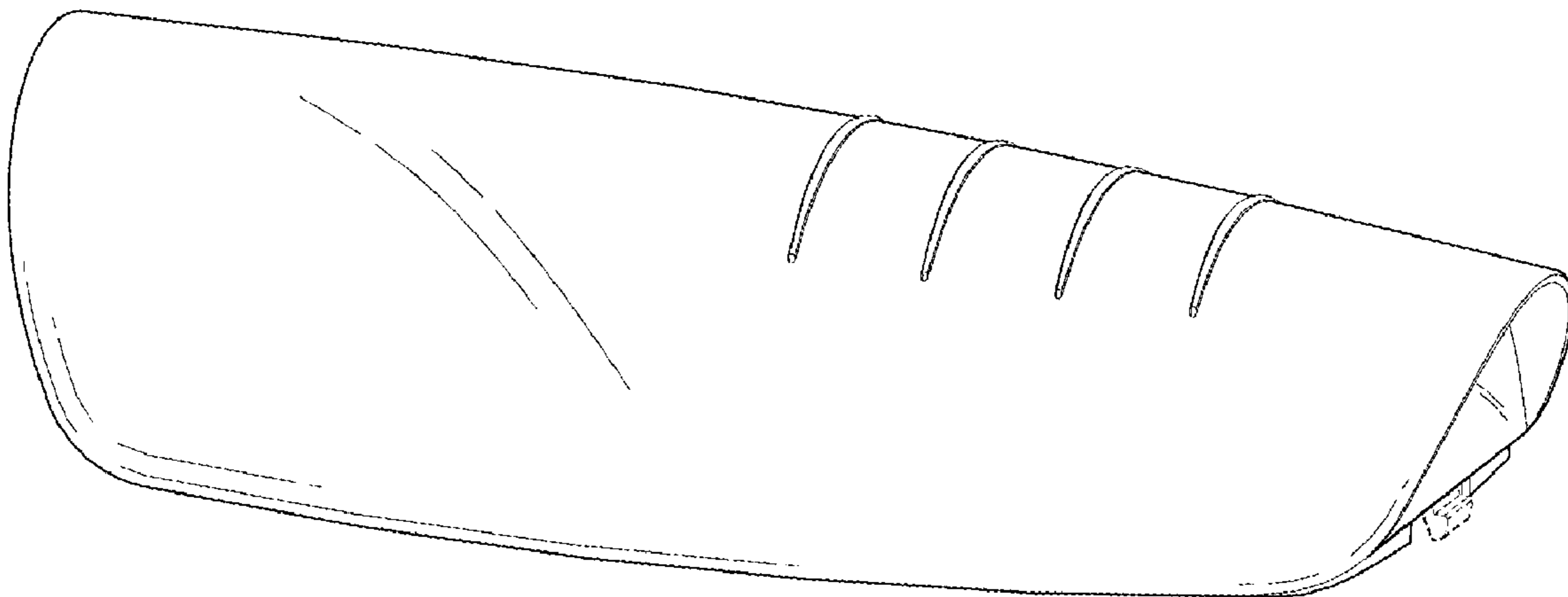

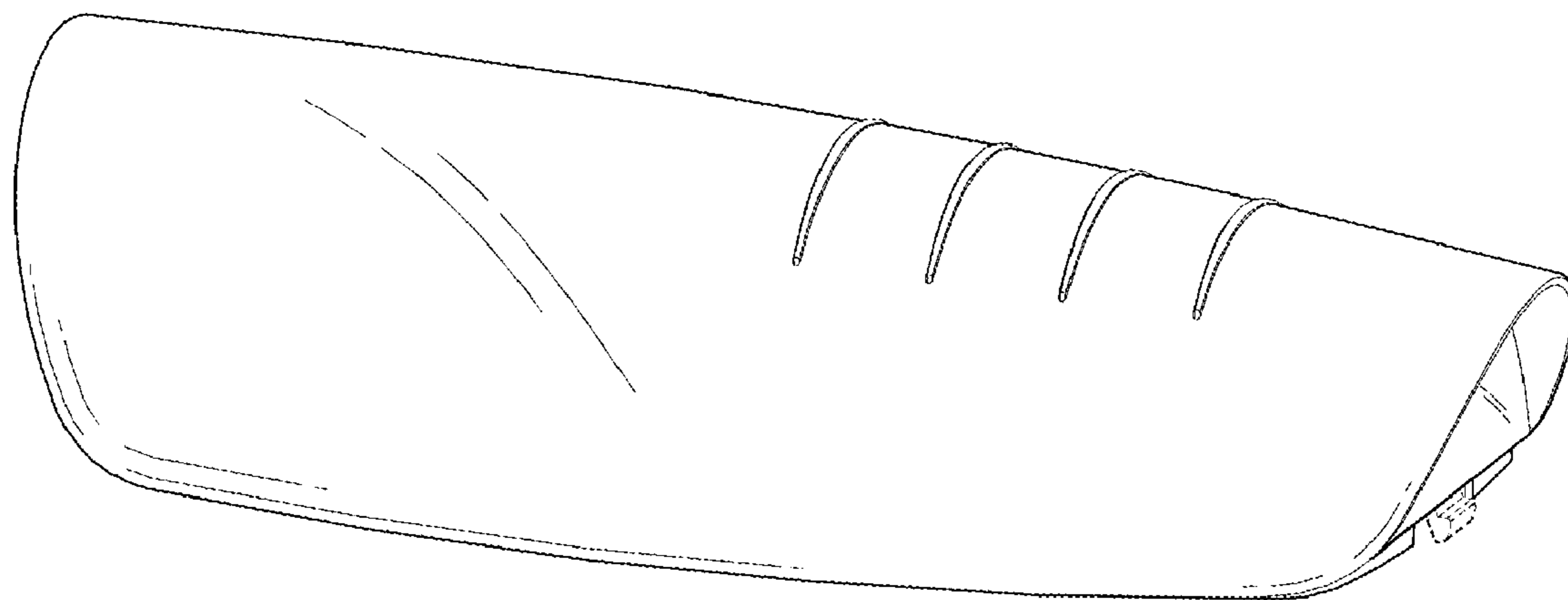

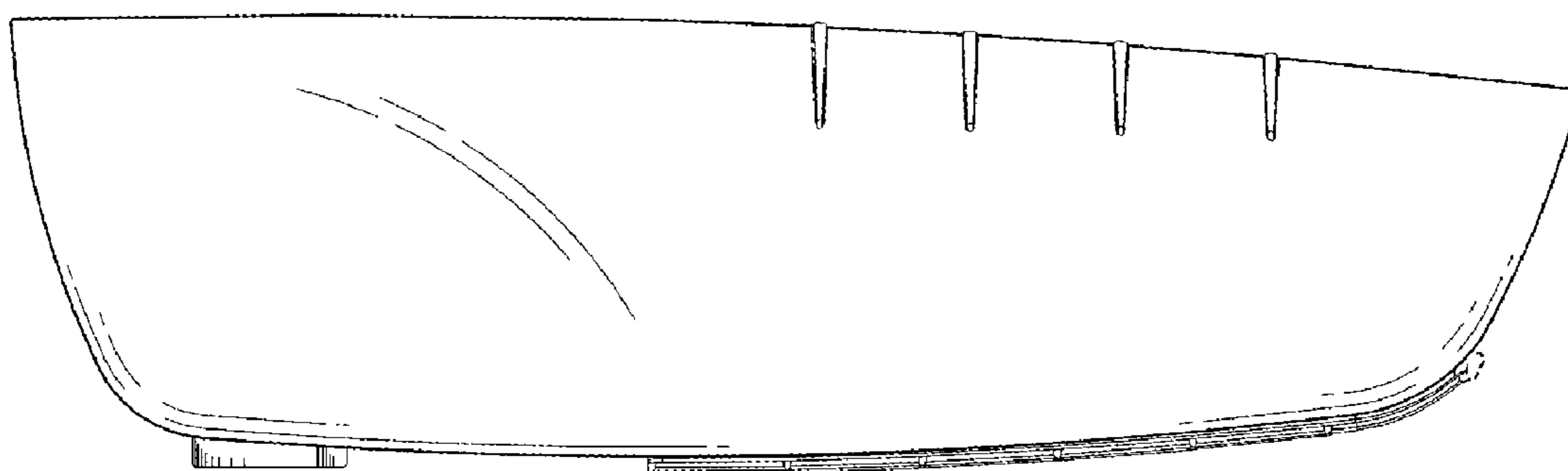
**DESCRIPTION**

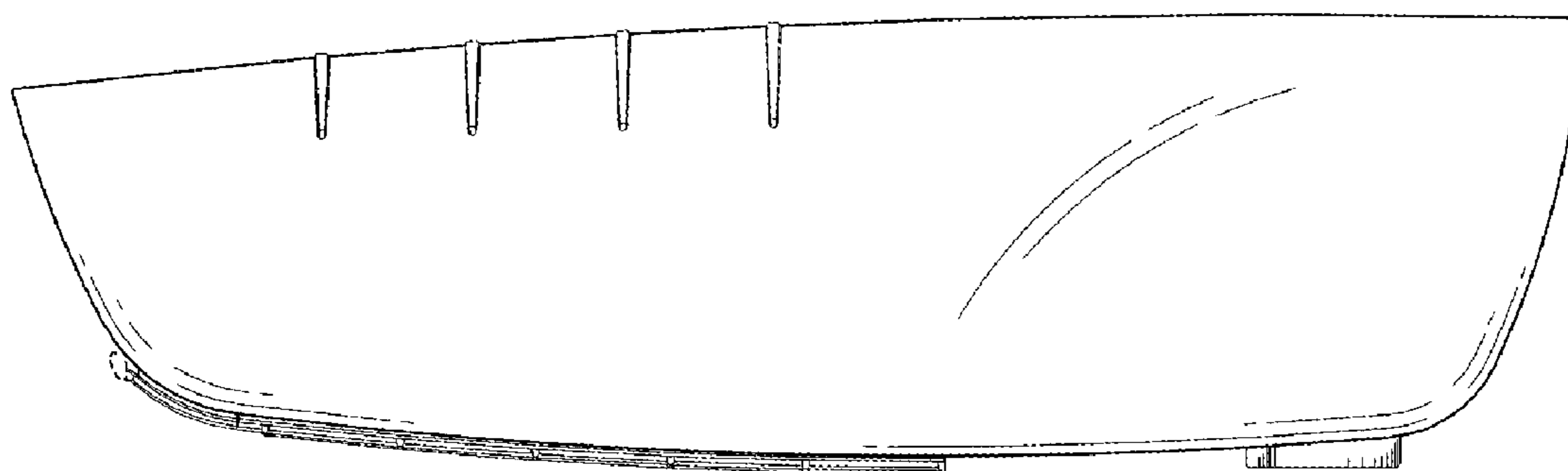




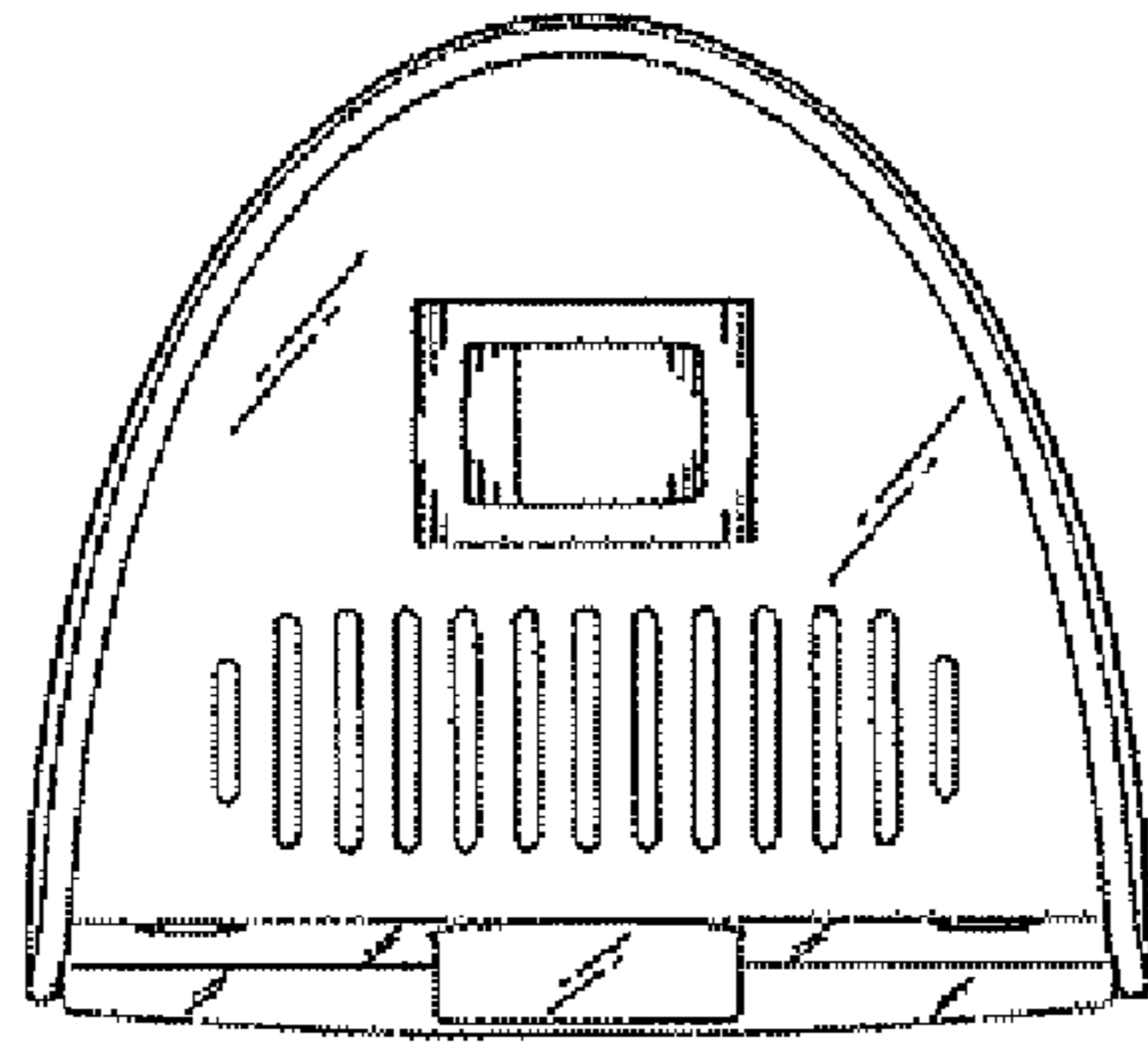

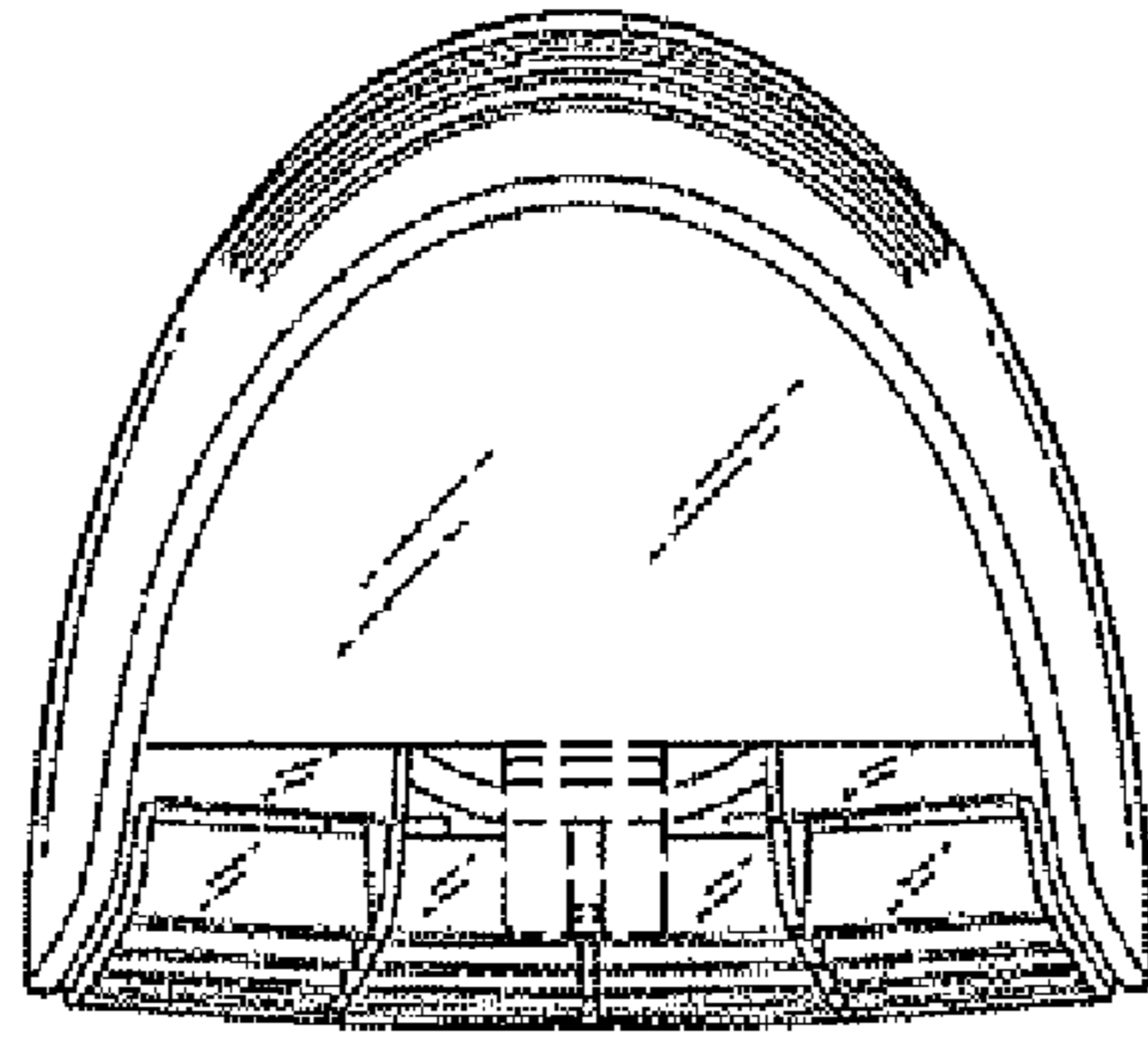

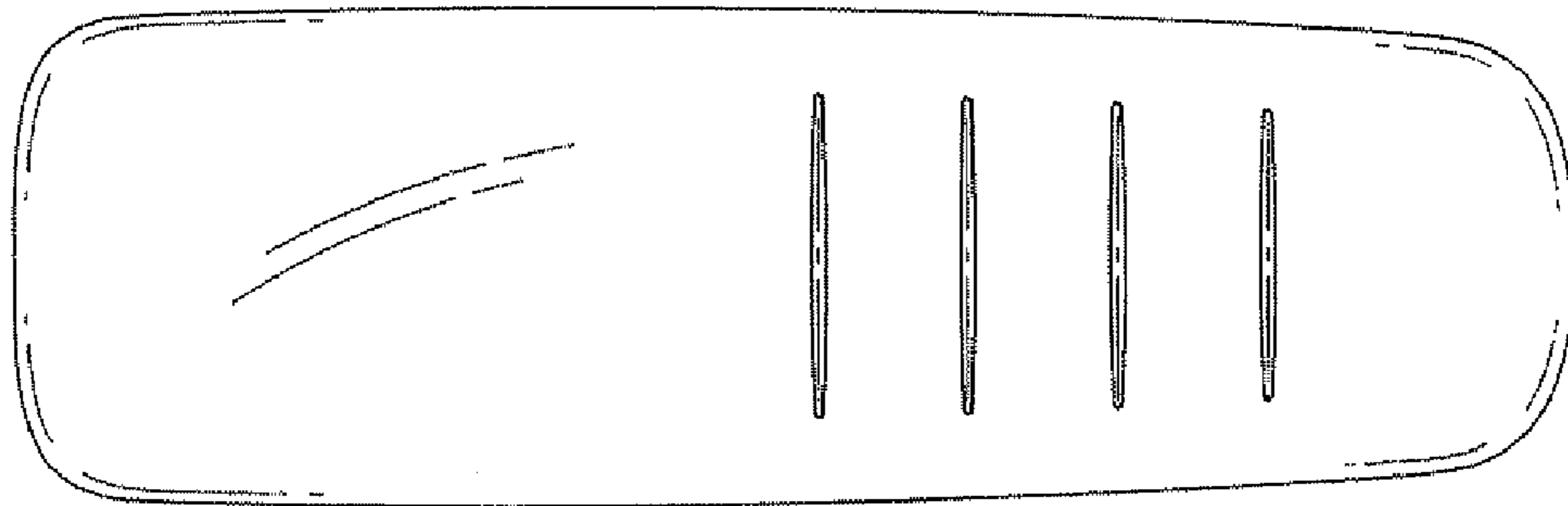

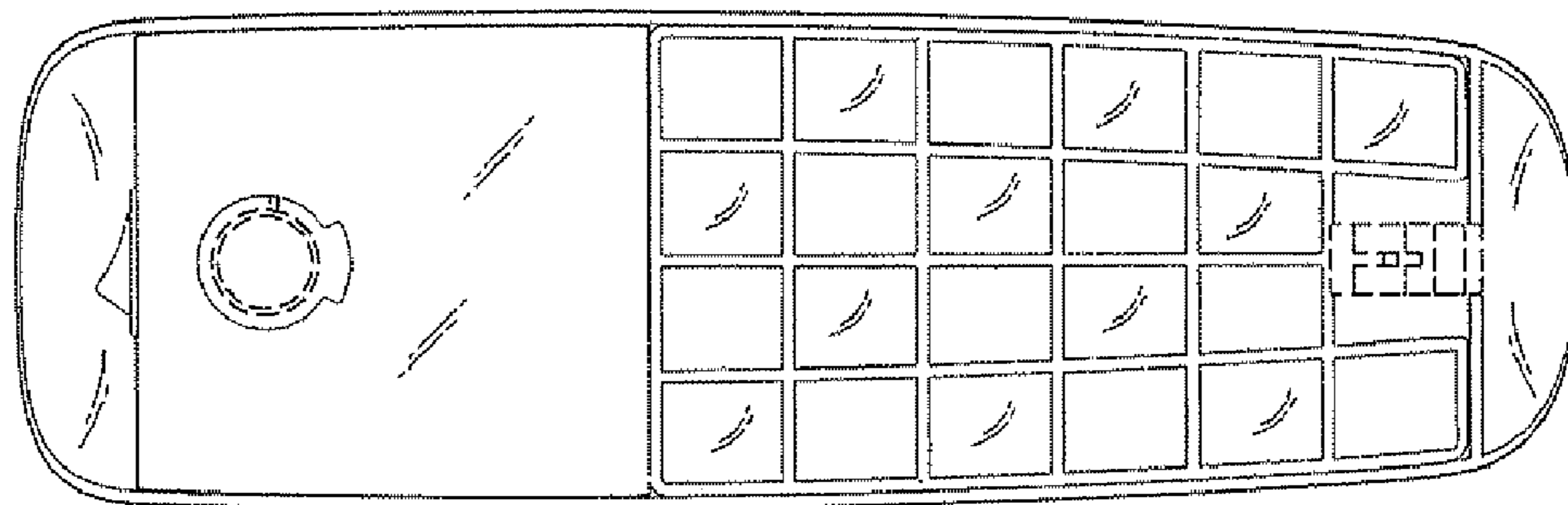
