FIG. 17 is a back view thereof;

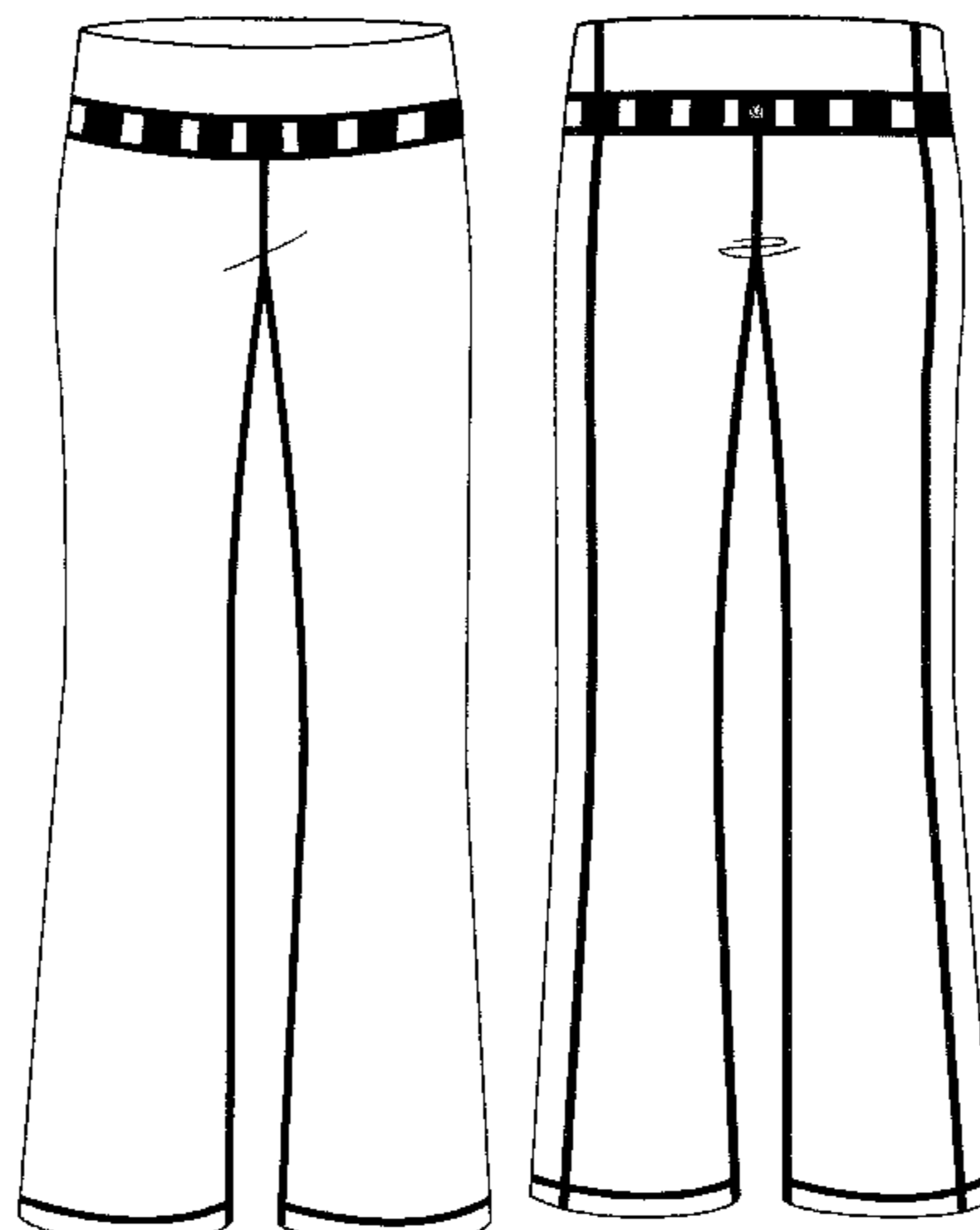
FIG. 18 is a right side view thereof;

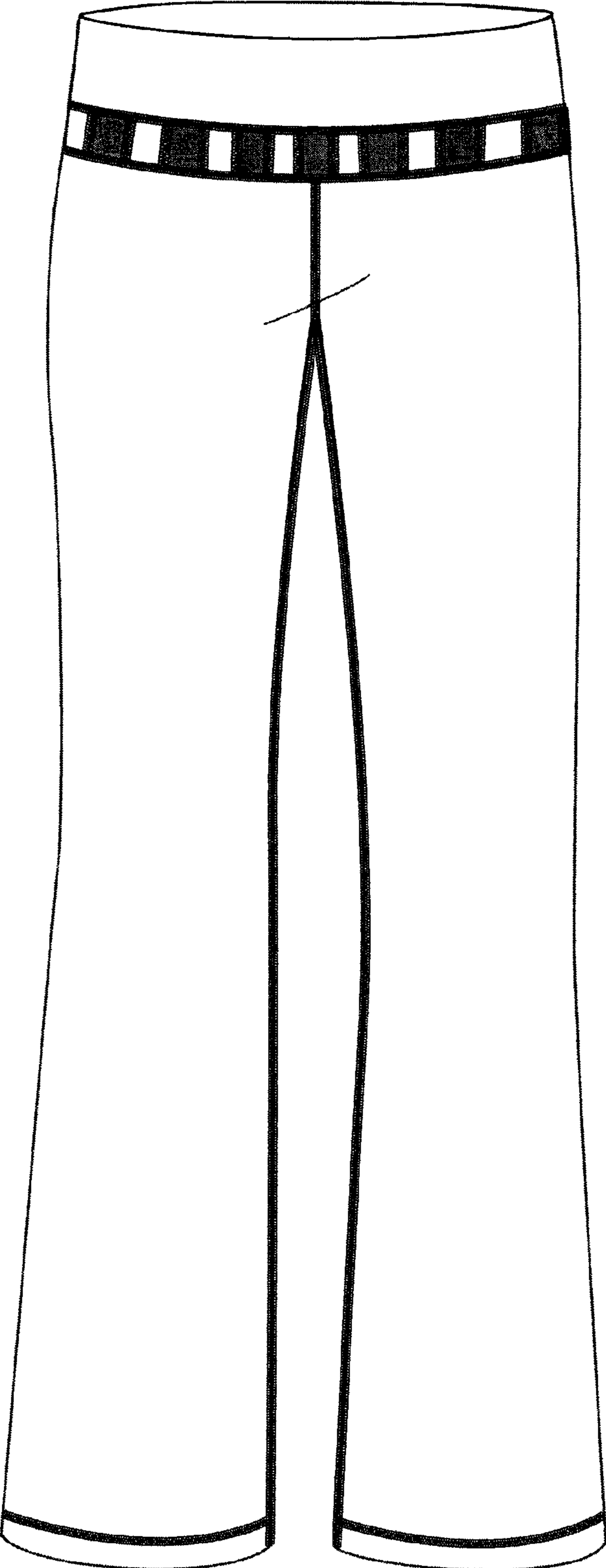

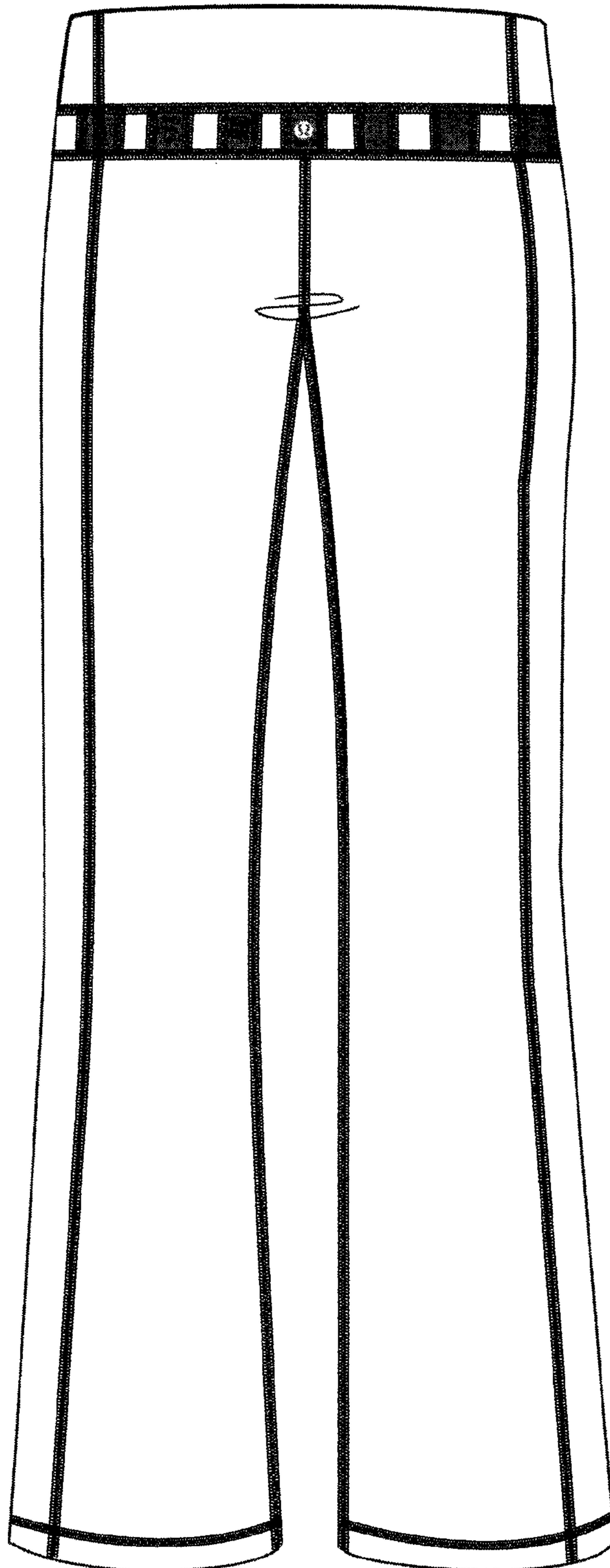

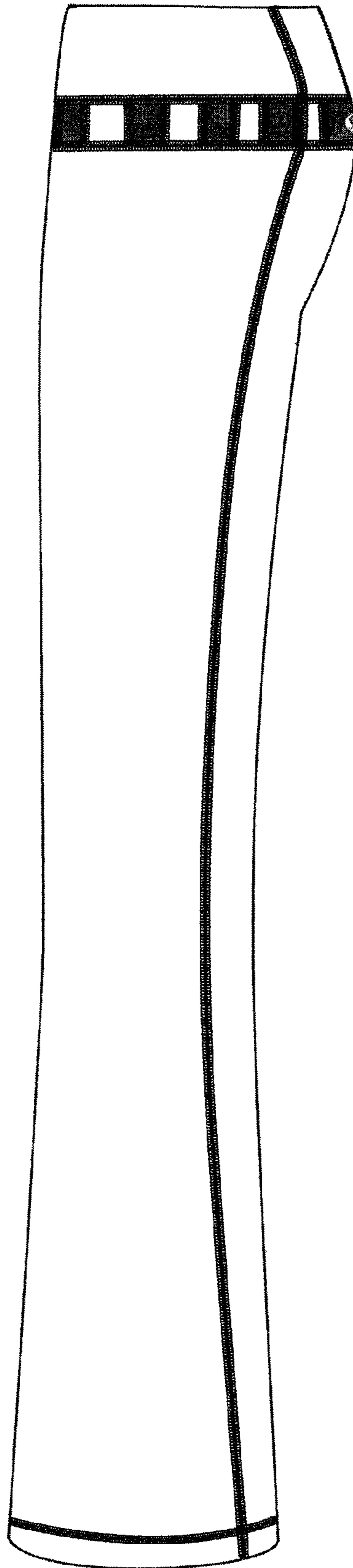

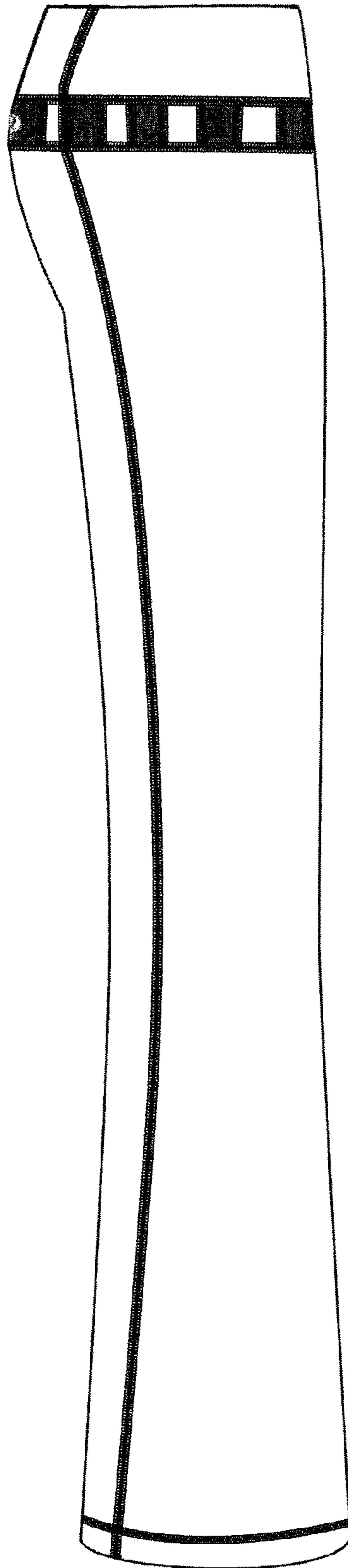

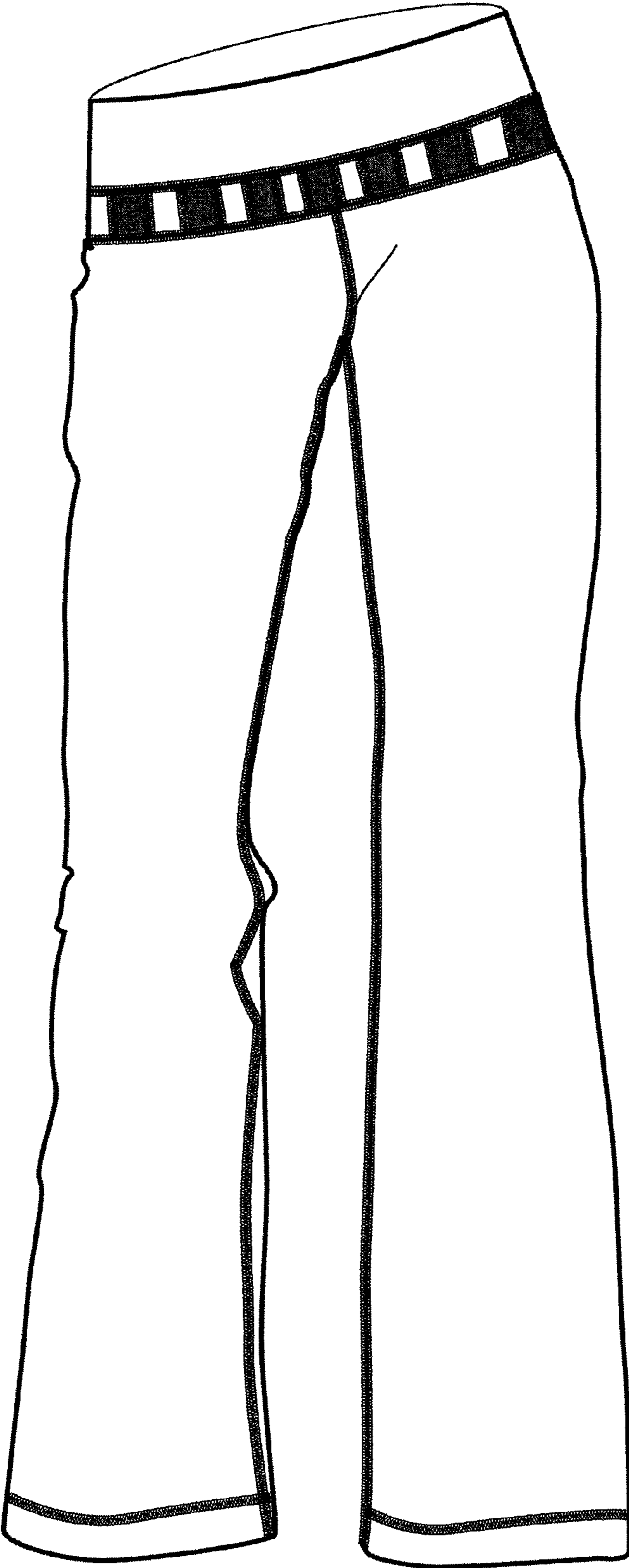

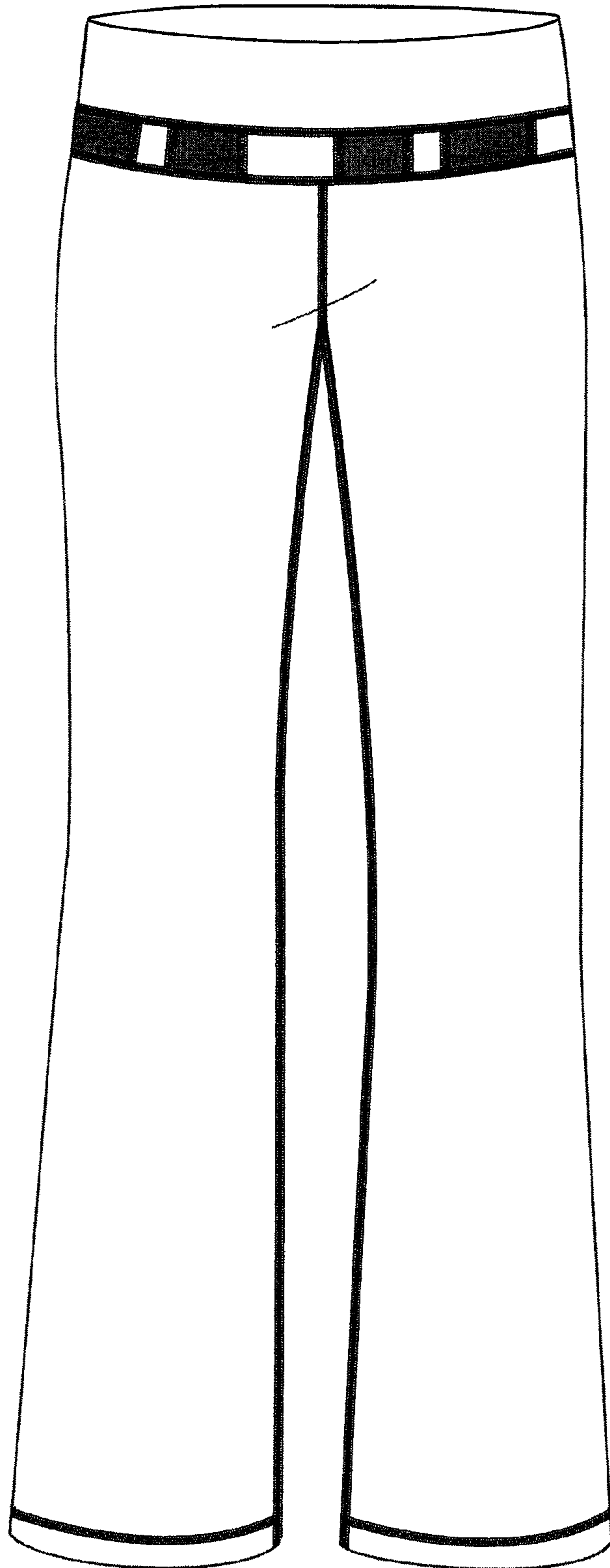

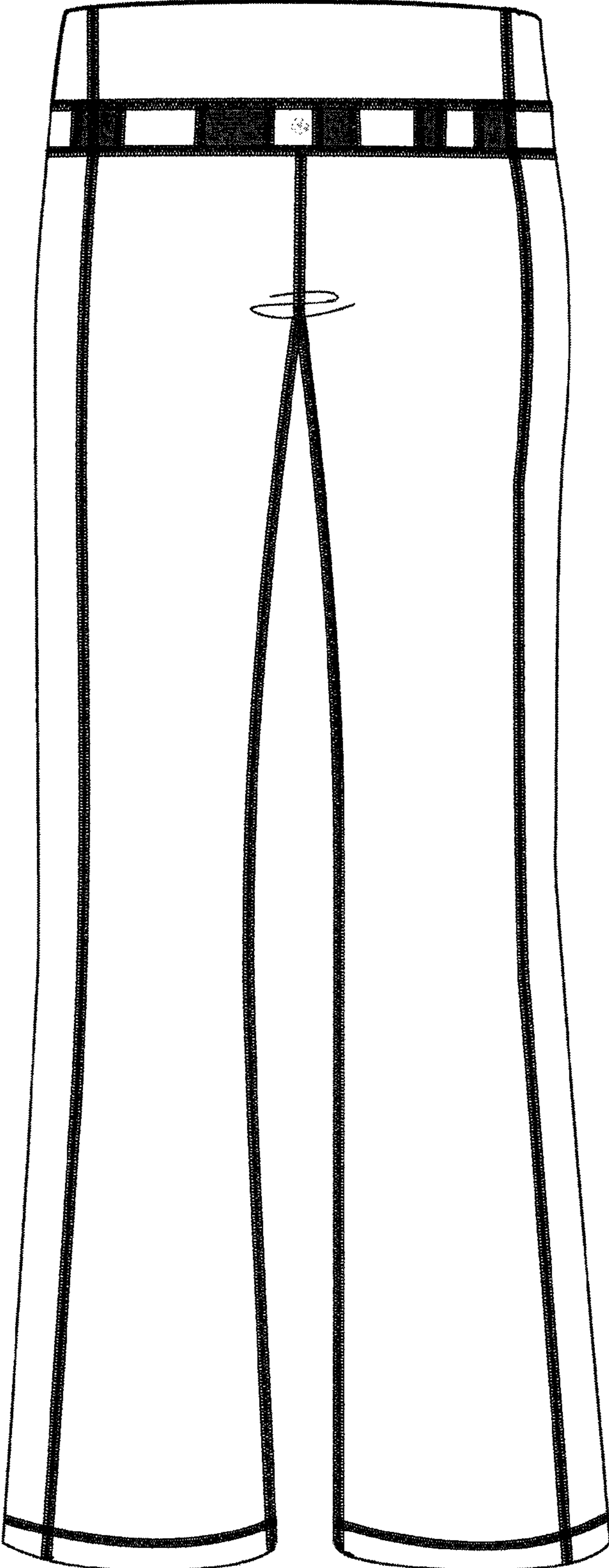

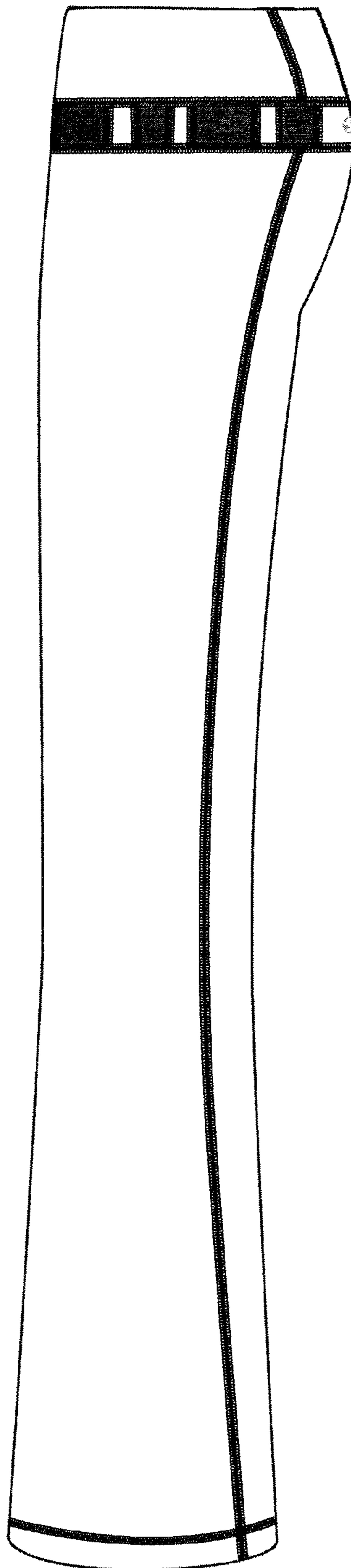




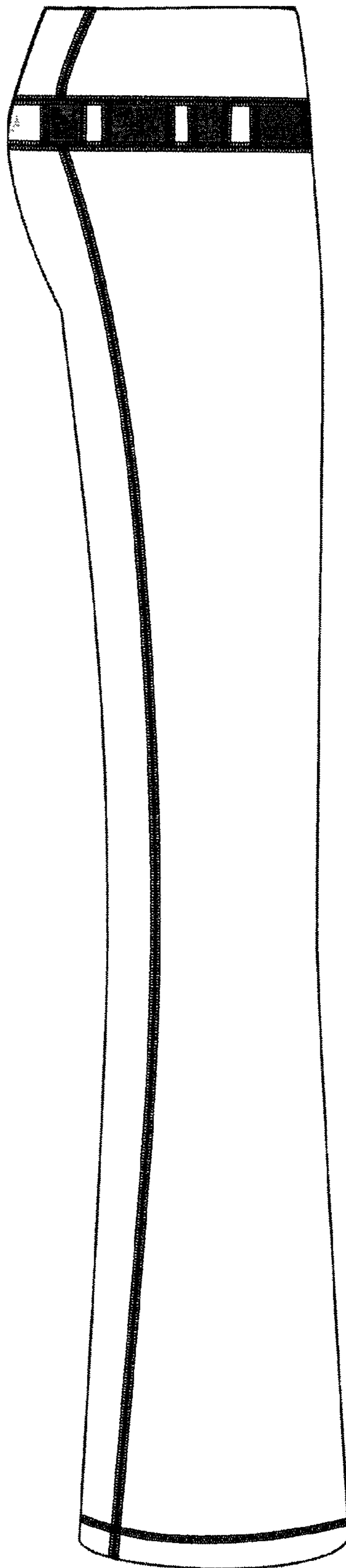

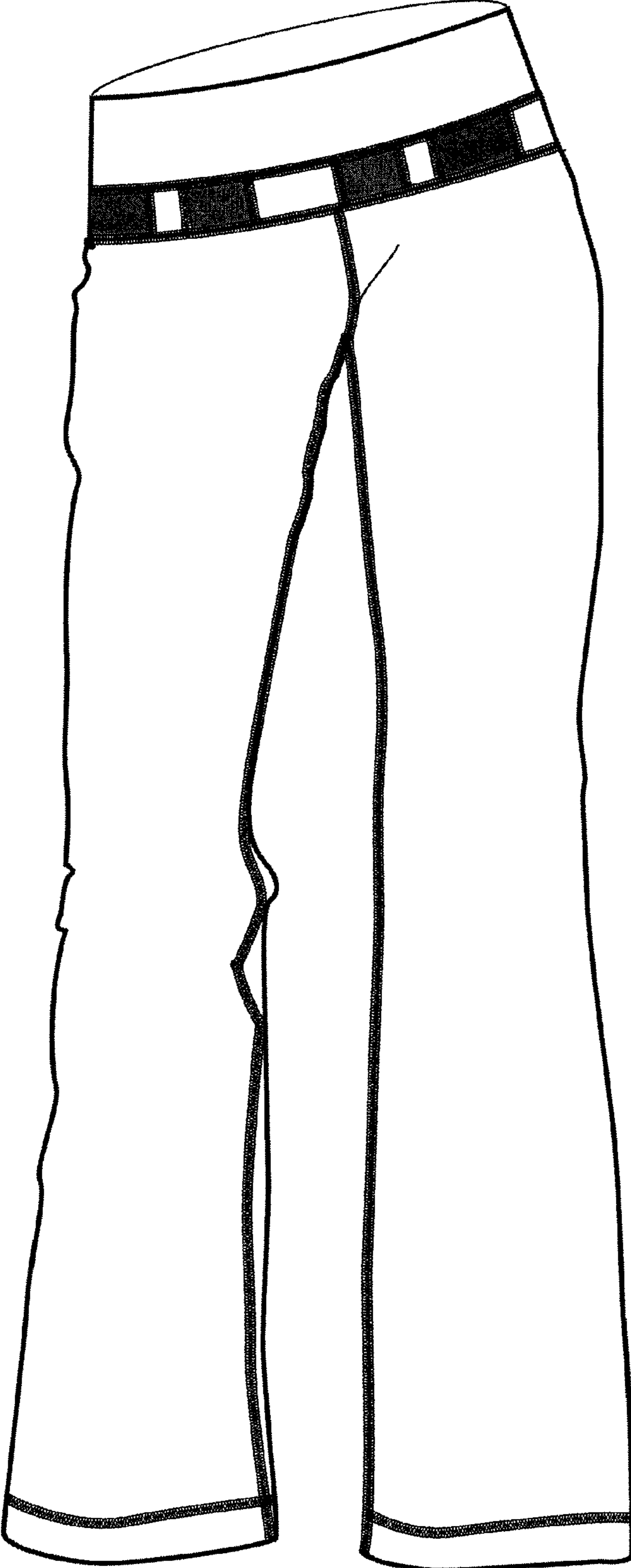

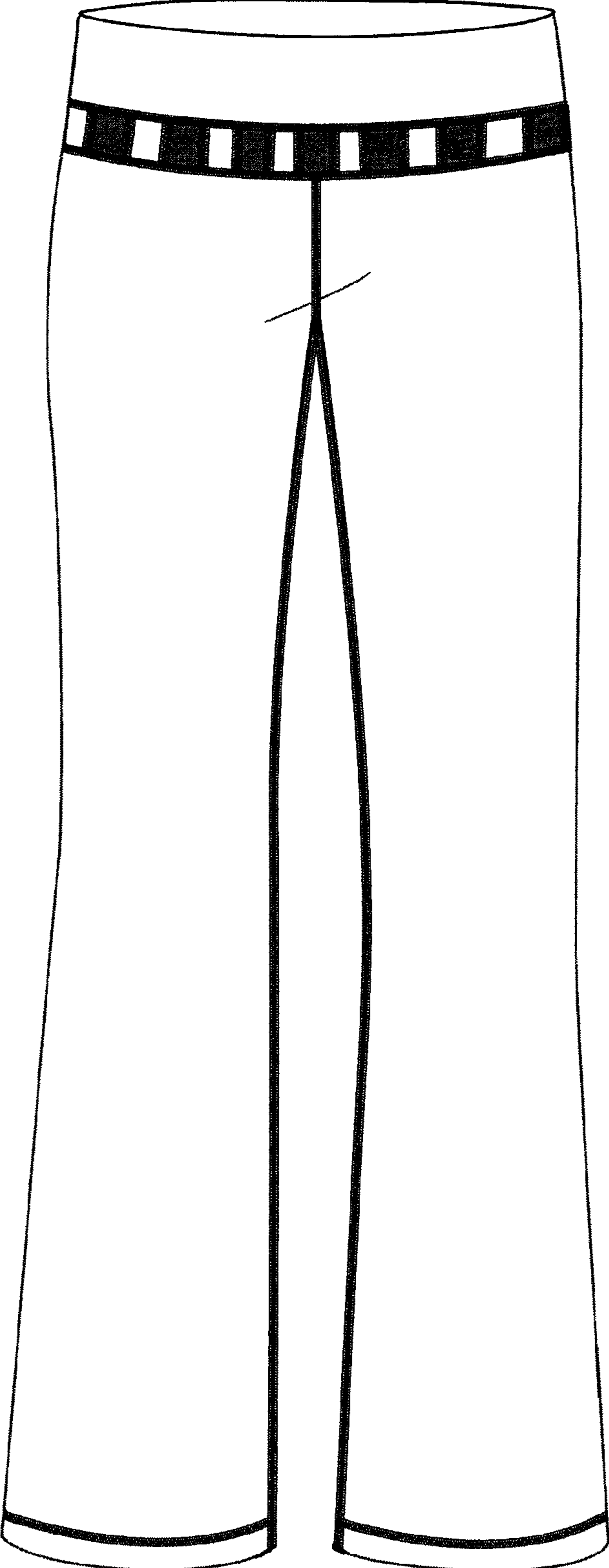

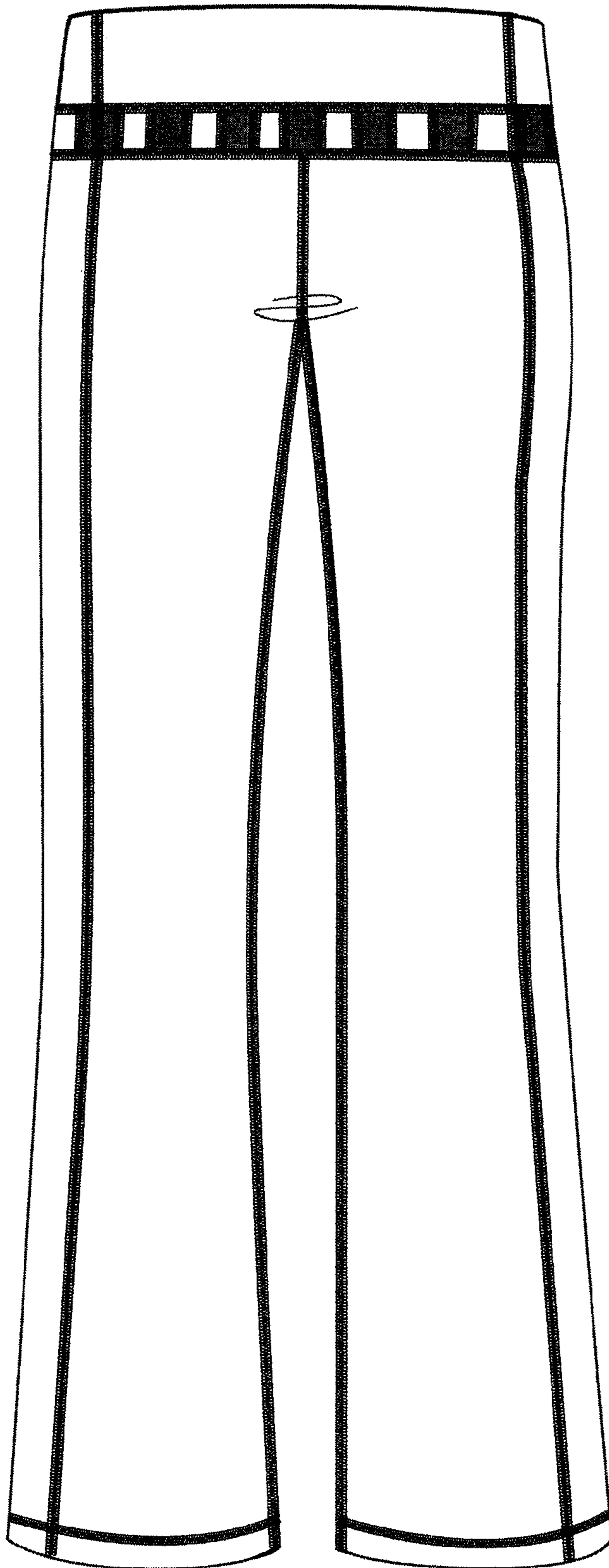

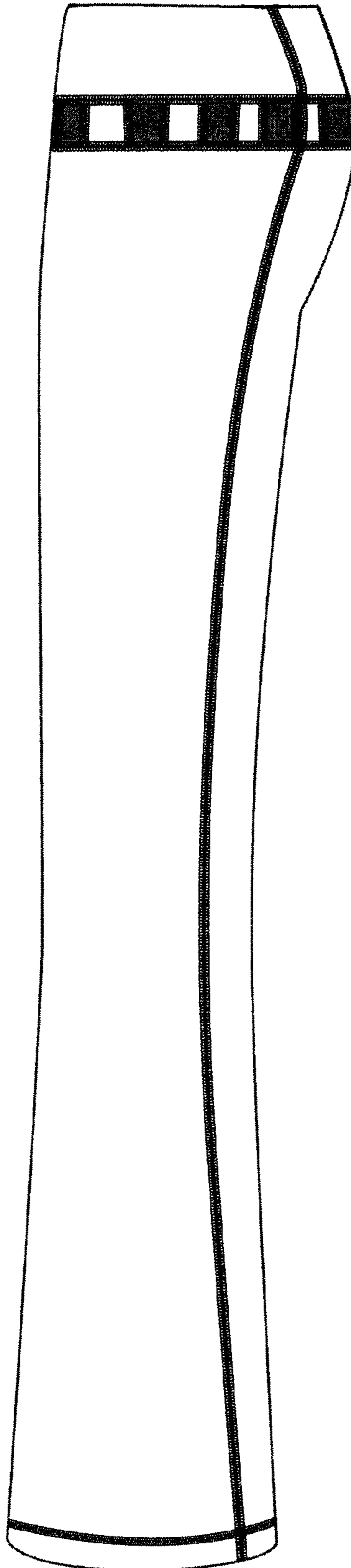

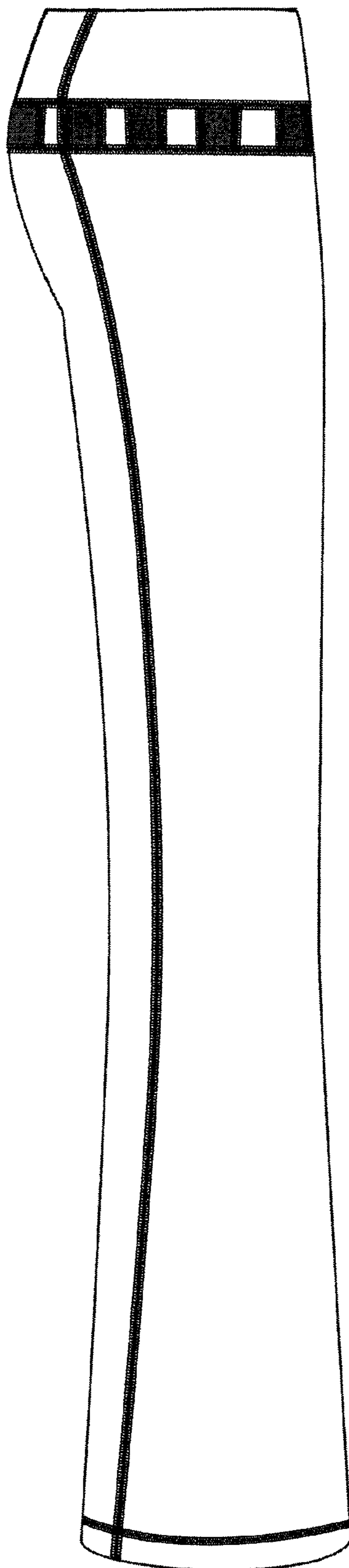

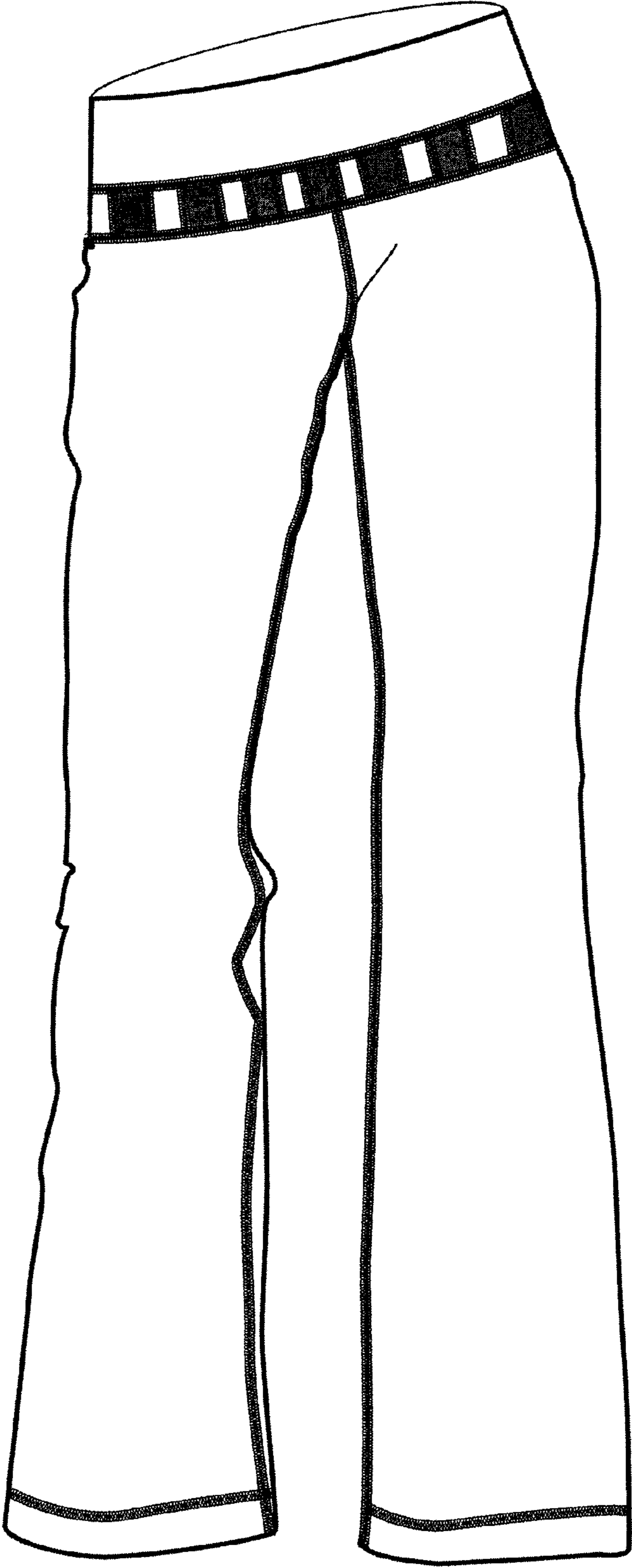

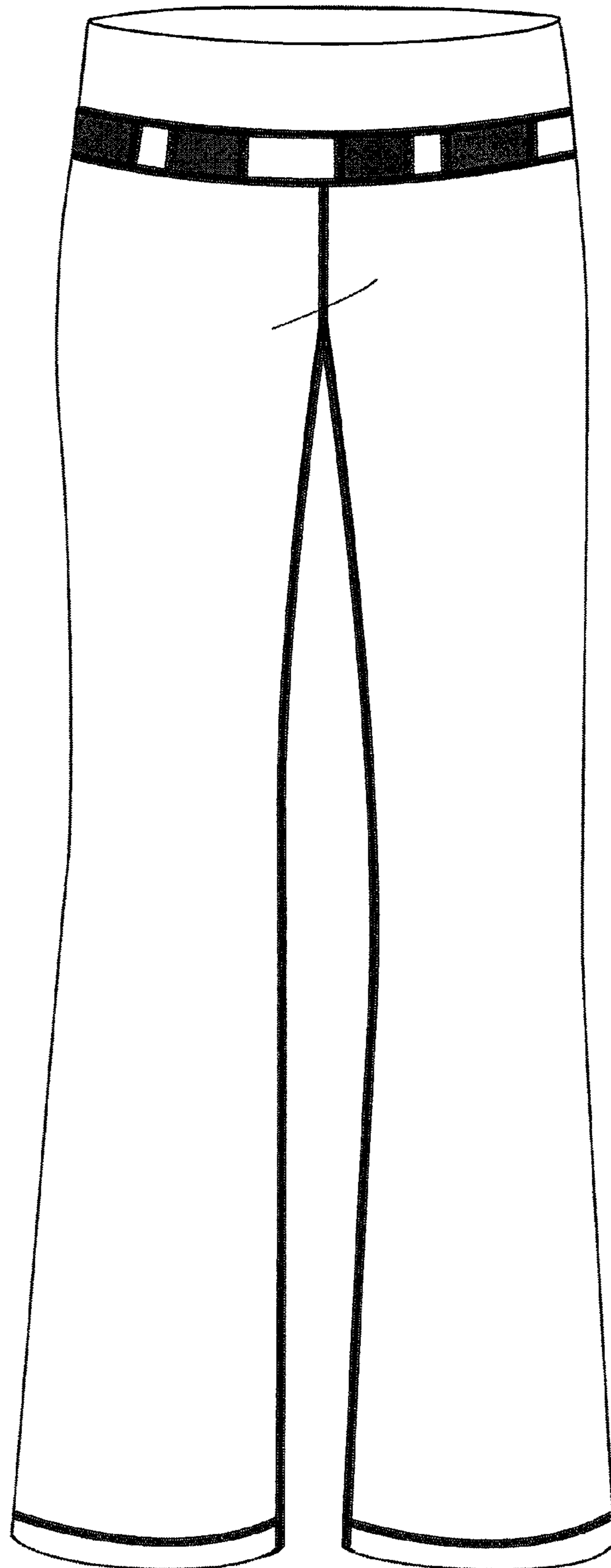




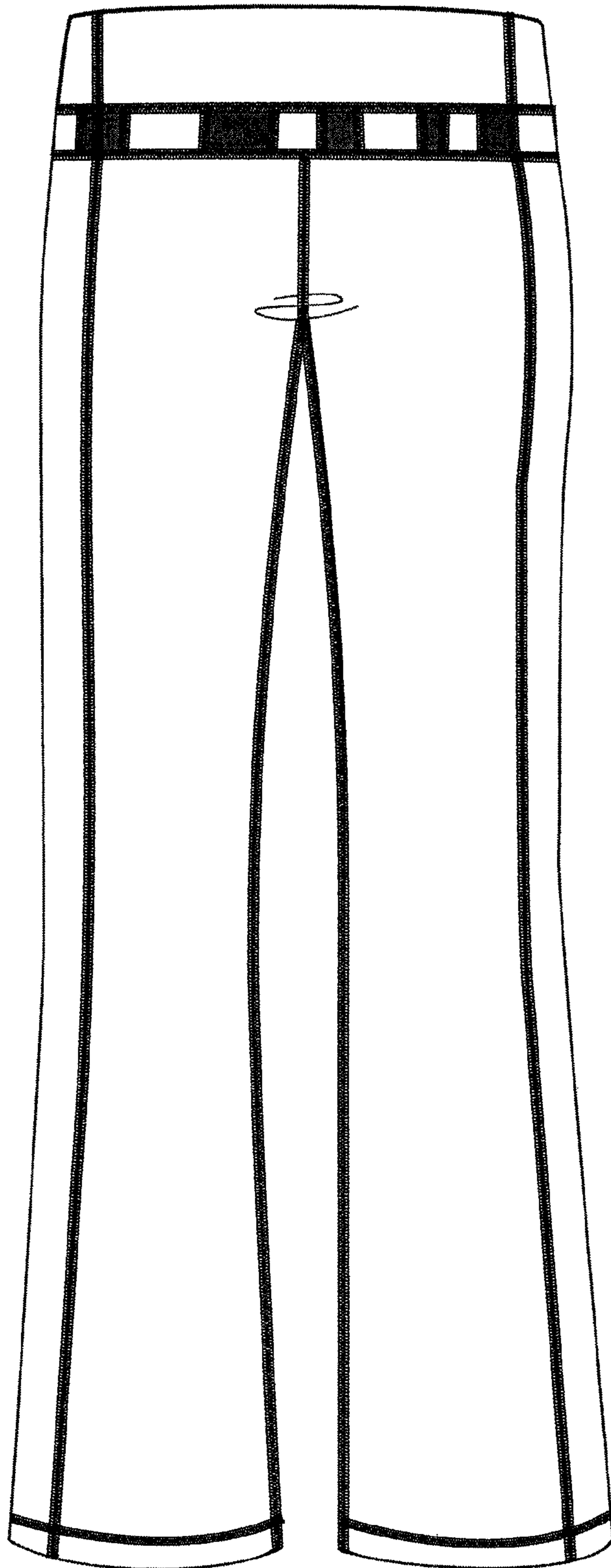

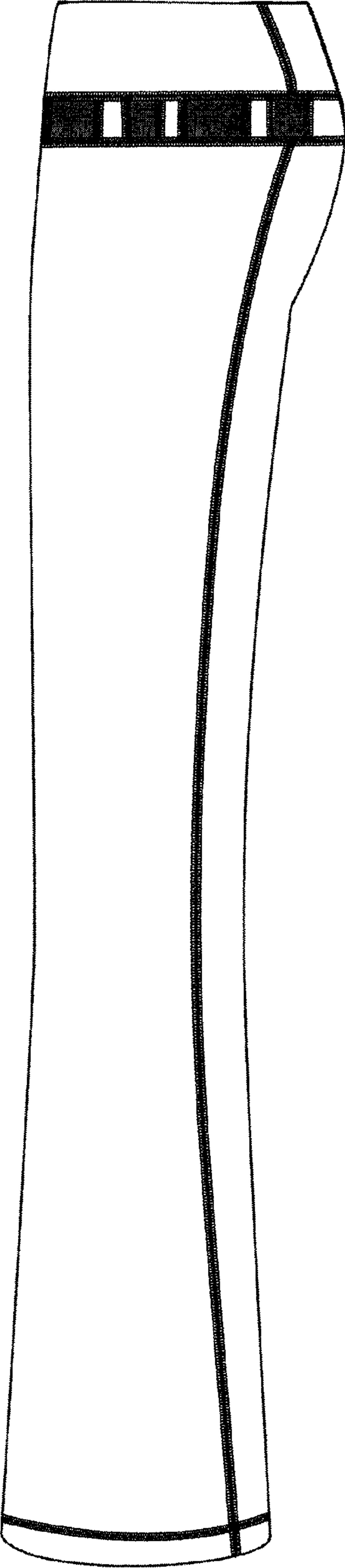

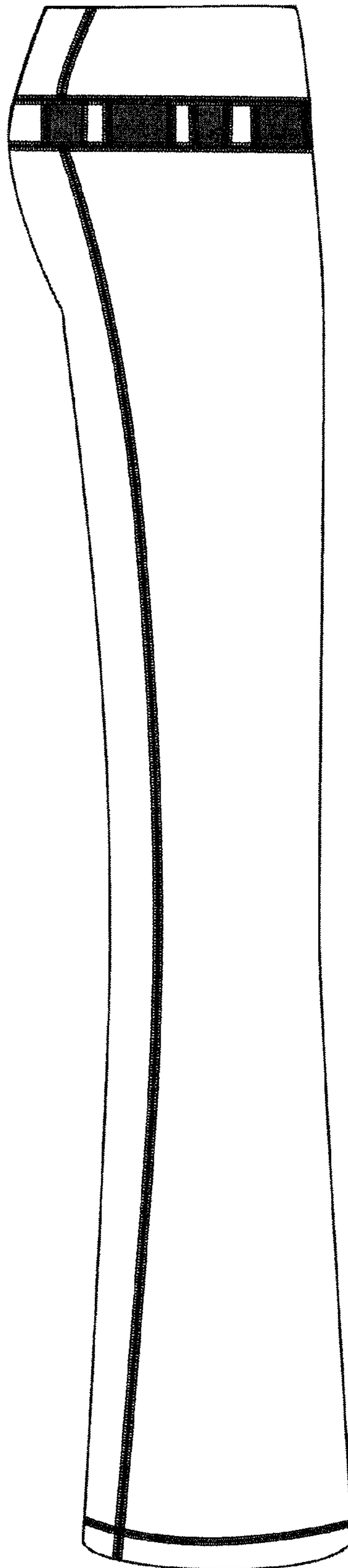
