(57) **CLAIM**

The ornamental design for a “suit”, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a suit showing my new design; the left leg shown slightly extended forward;

FIG. 2 is a front view of the suit;

FIG. 3 is a rear view of the suit;

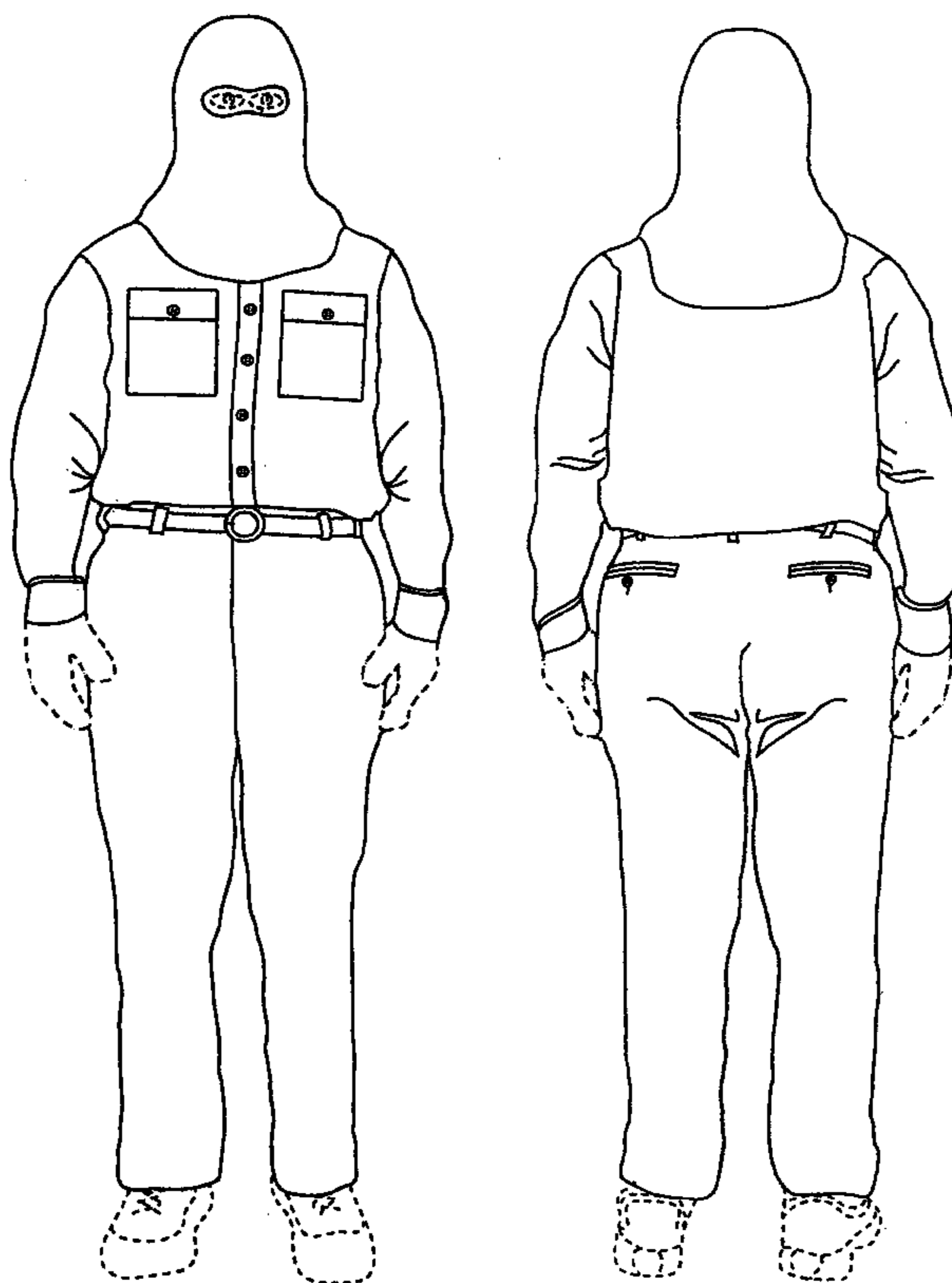
FIG. 4 is a right side view of the suit, the left side view being a mirror image of the right side view of the suit;

FIG. 5 is a top view of the suit; and,

FIG. 6 is a bottom view of the suit.

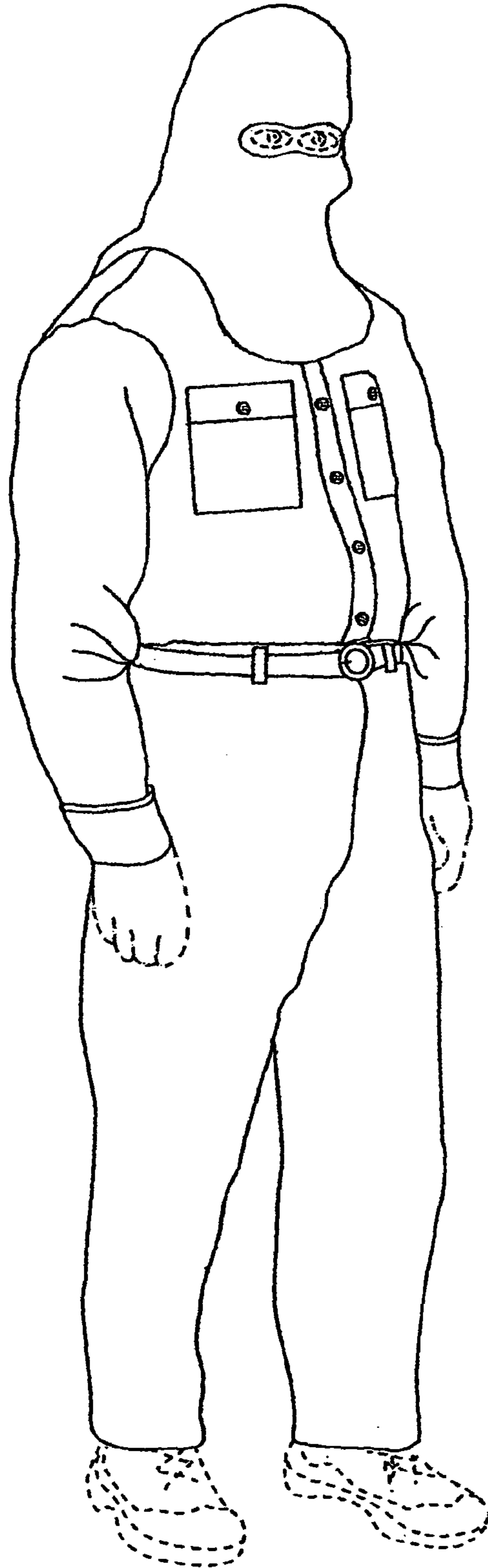

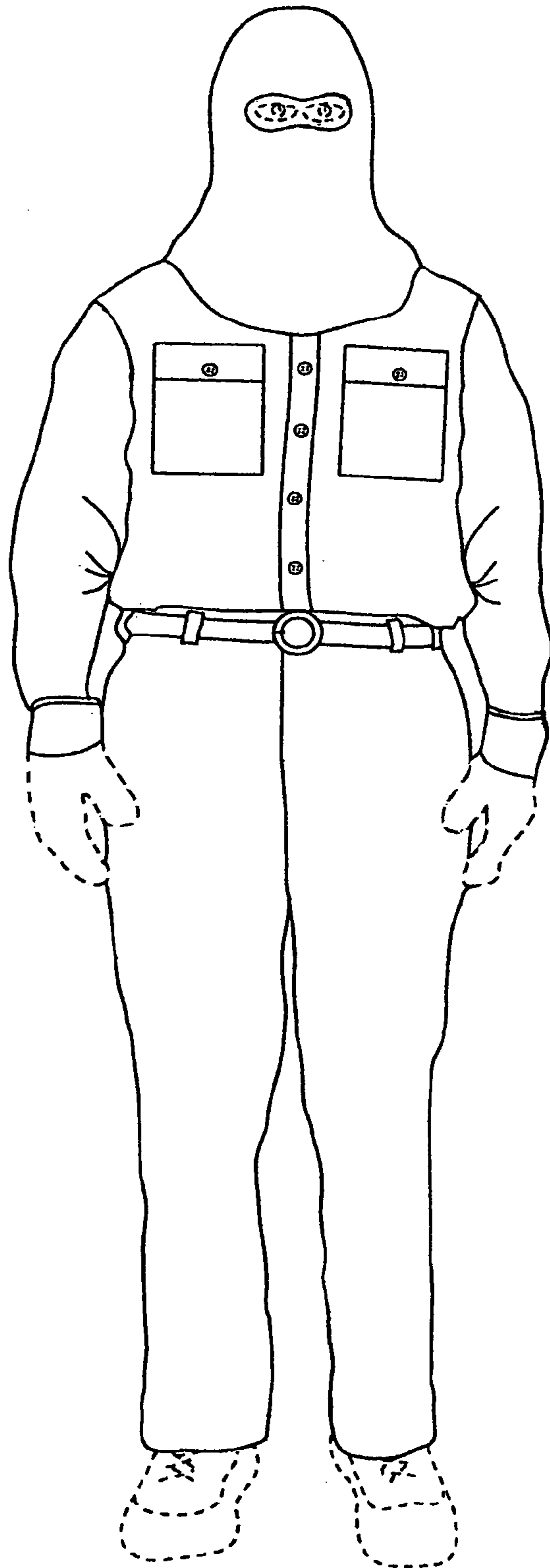

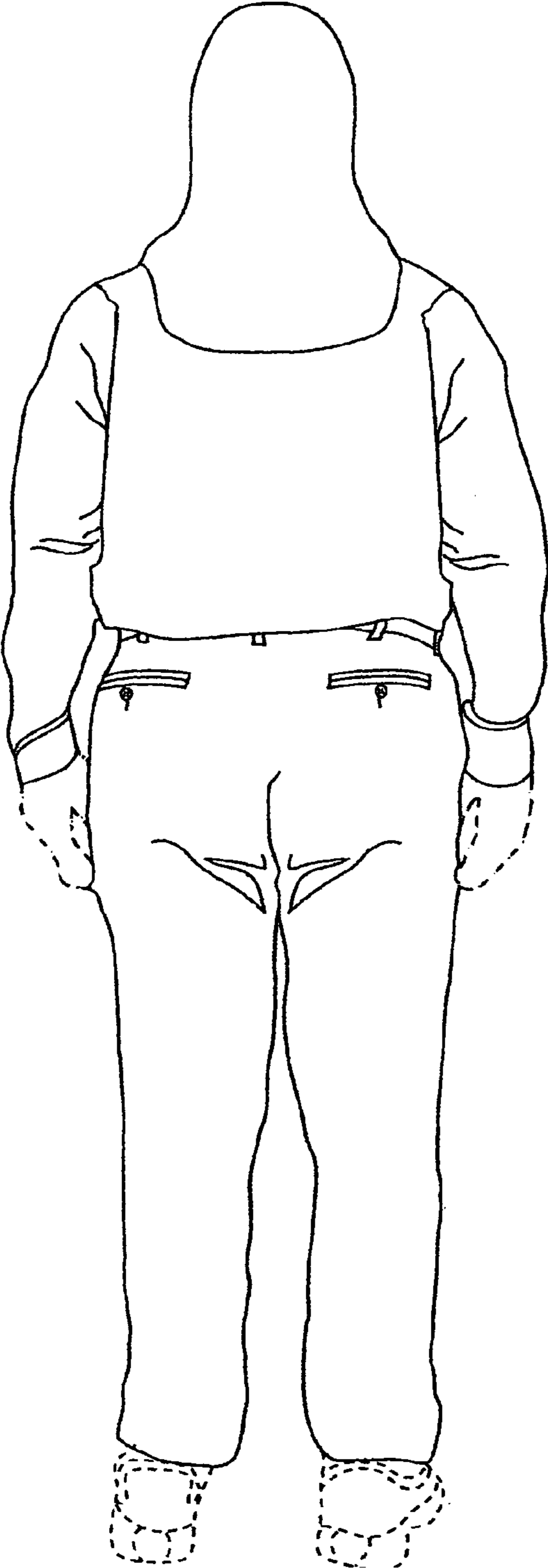

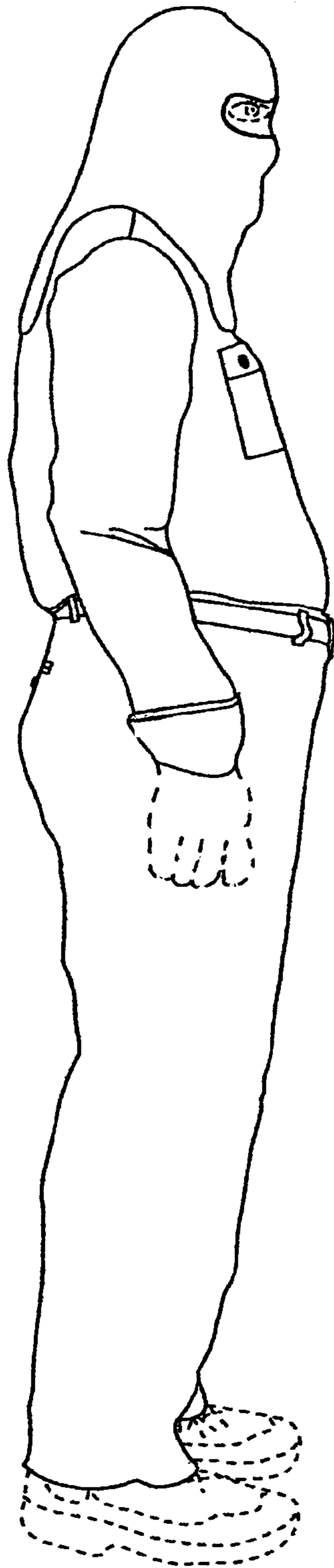

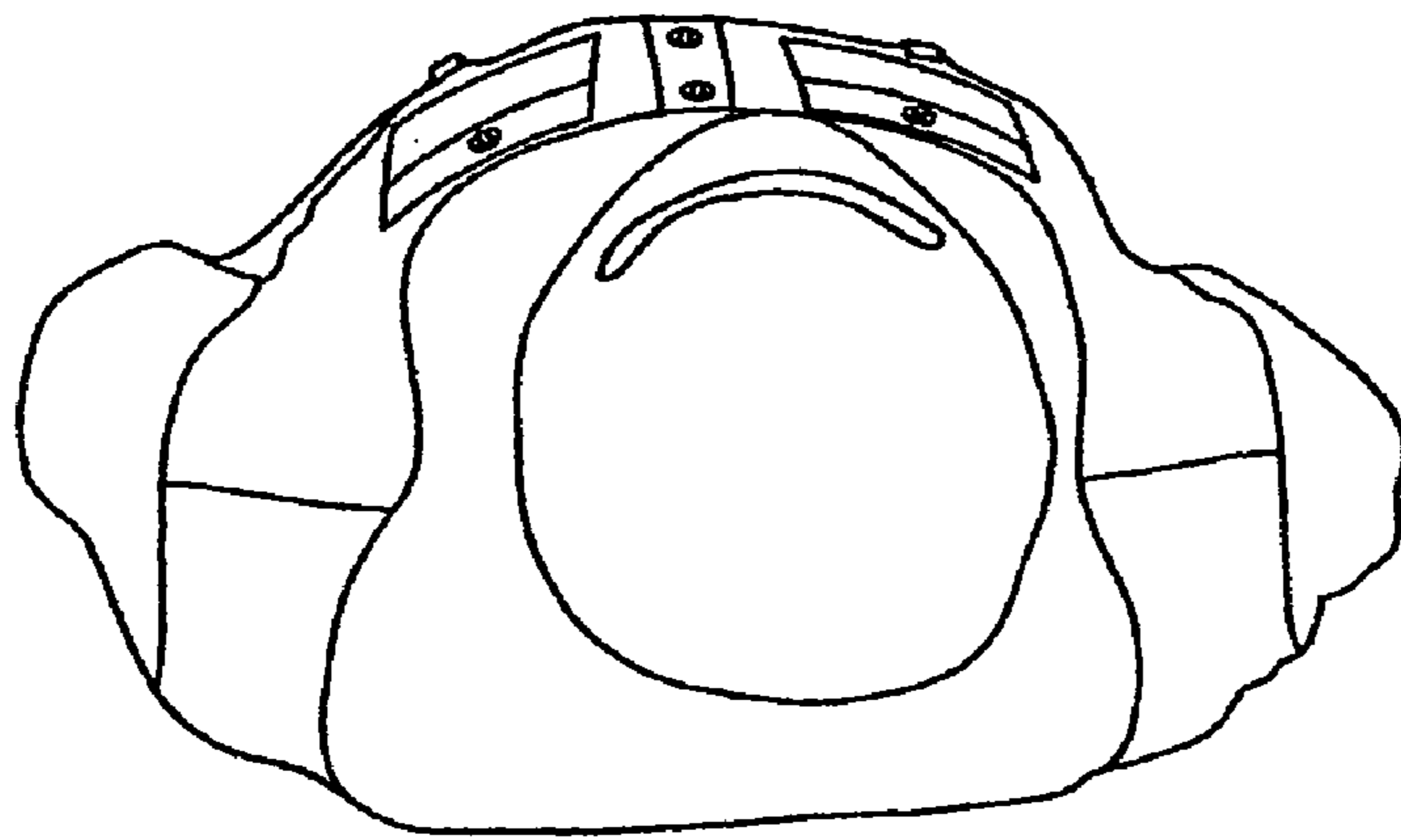

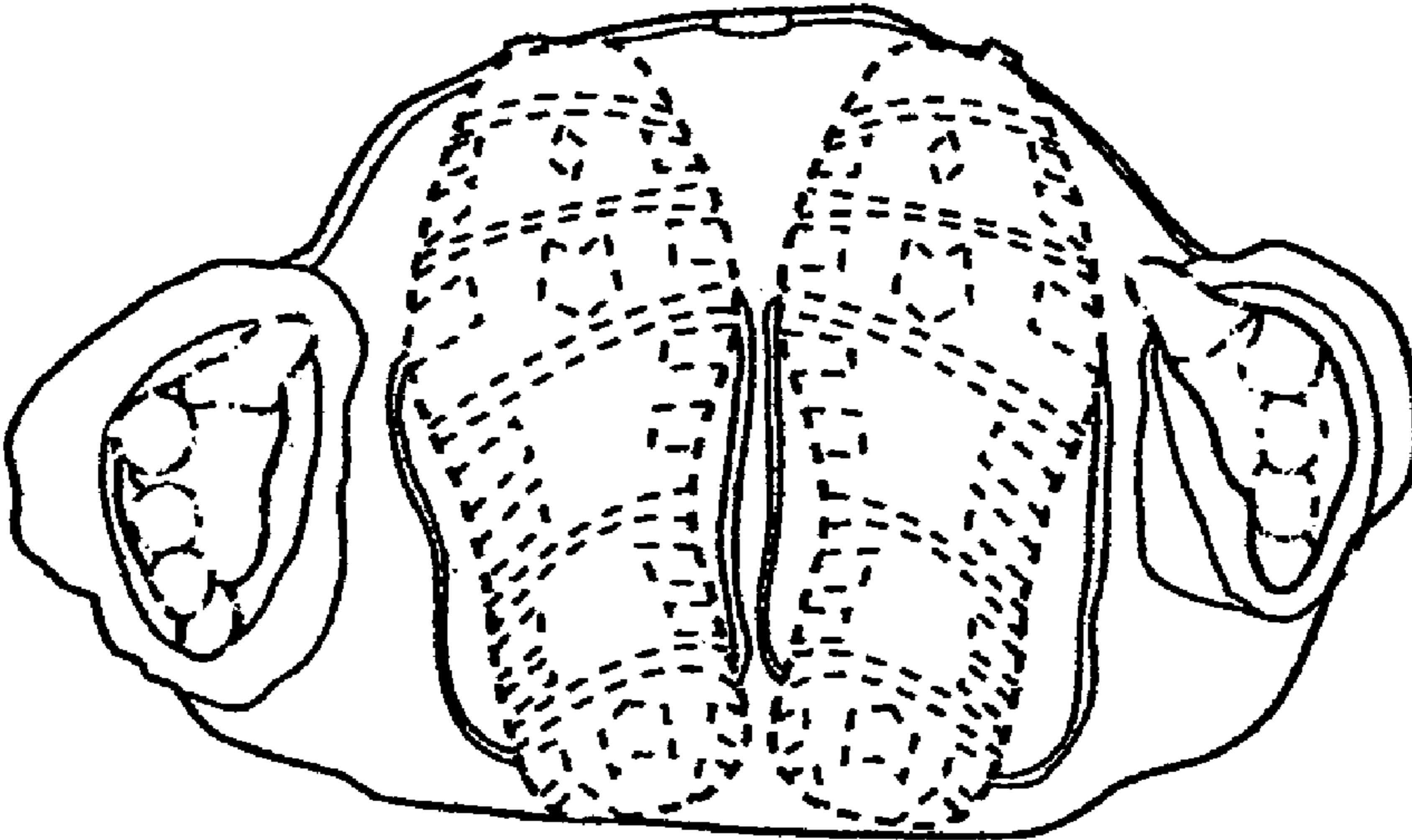
