DESCRIPTION

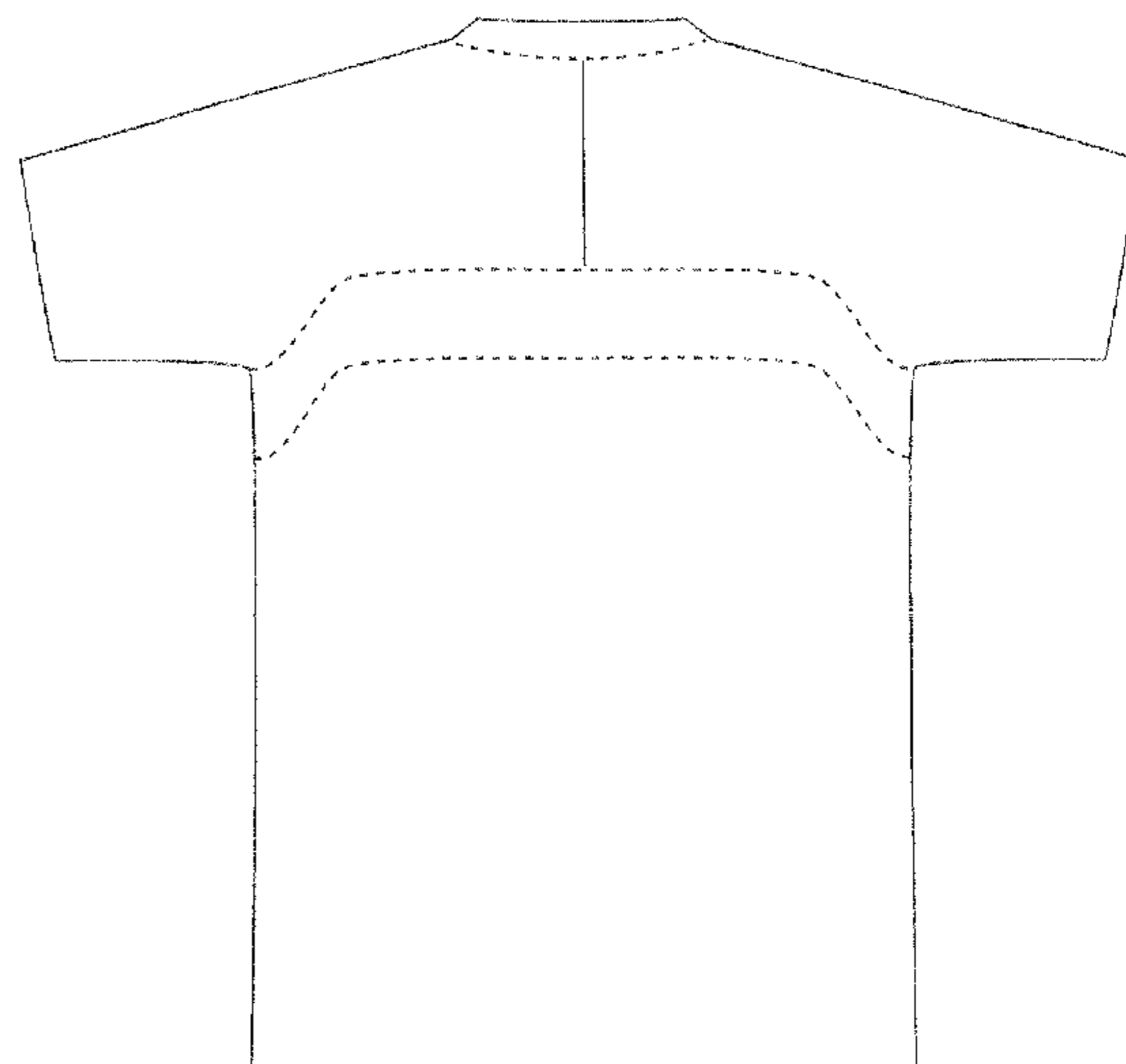
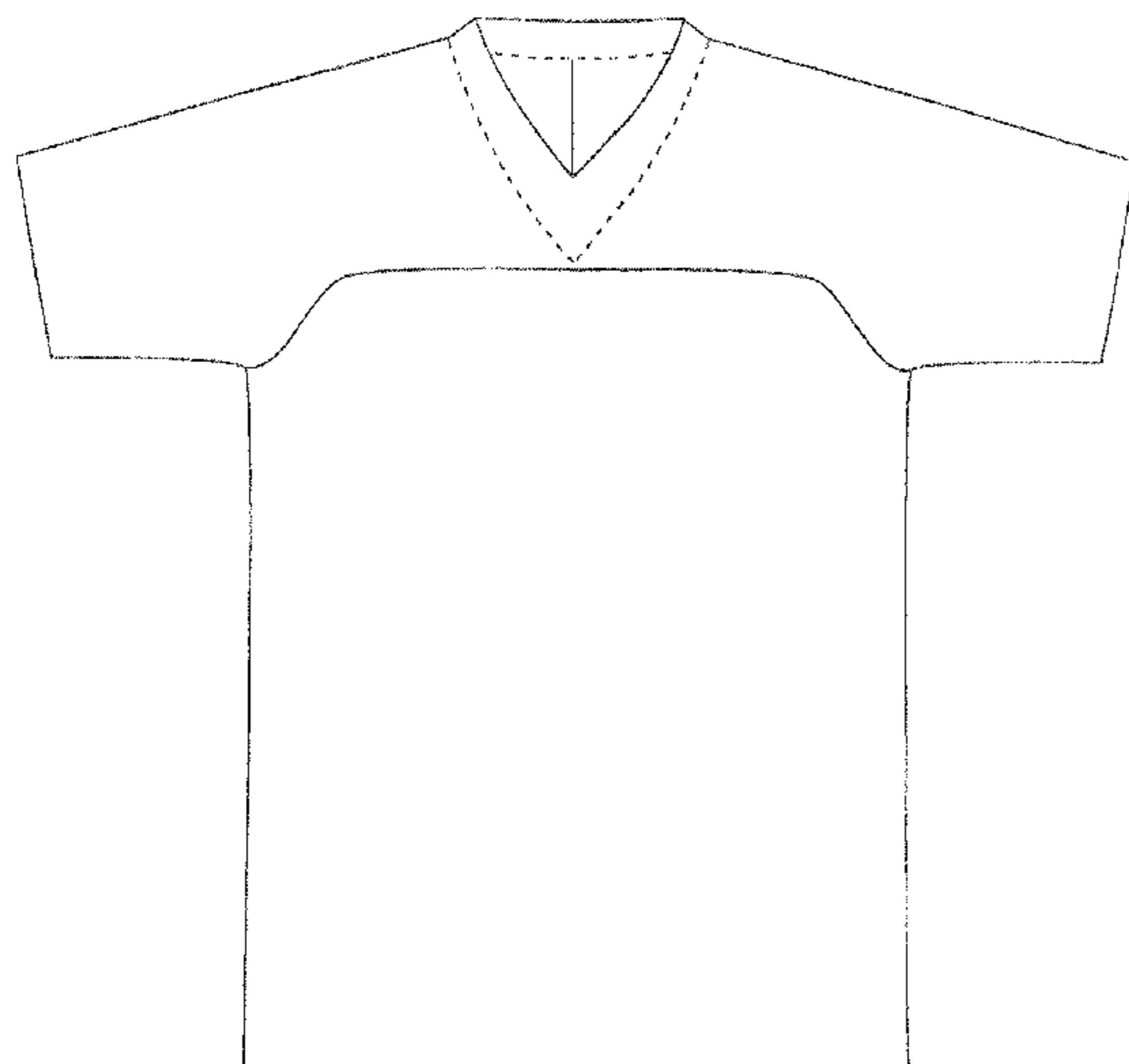
FIG. 1 is a front view of a surgical scrub V-neck shirt with panels showing our new design;

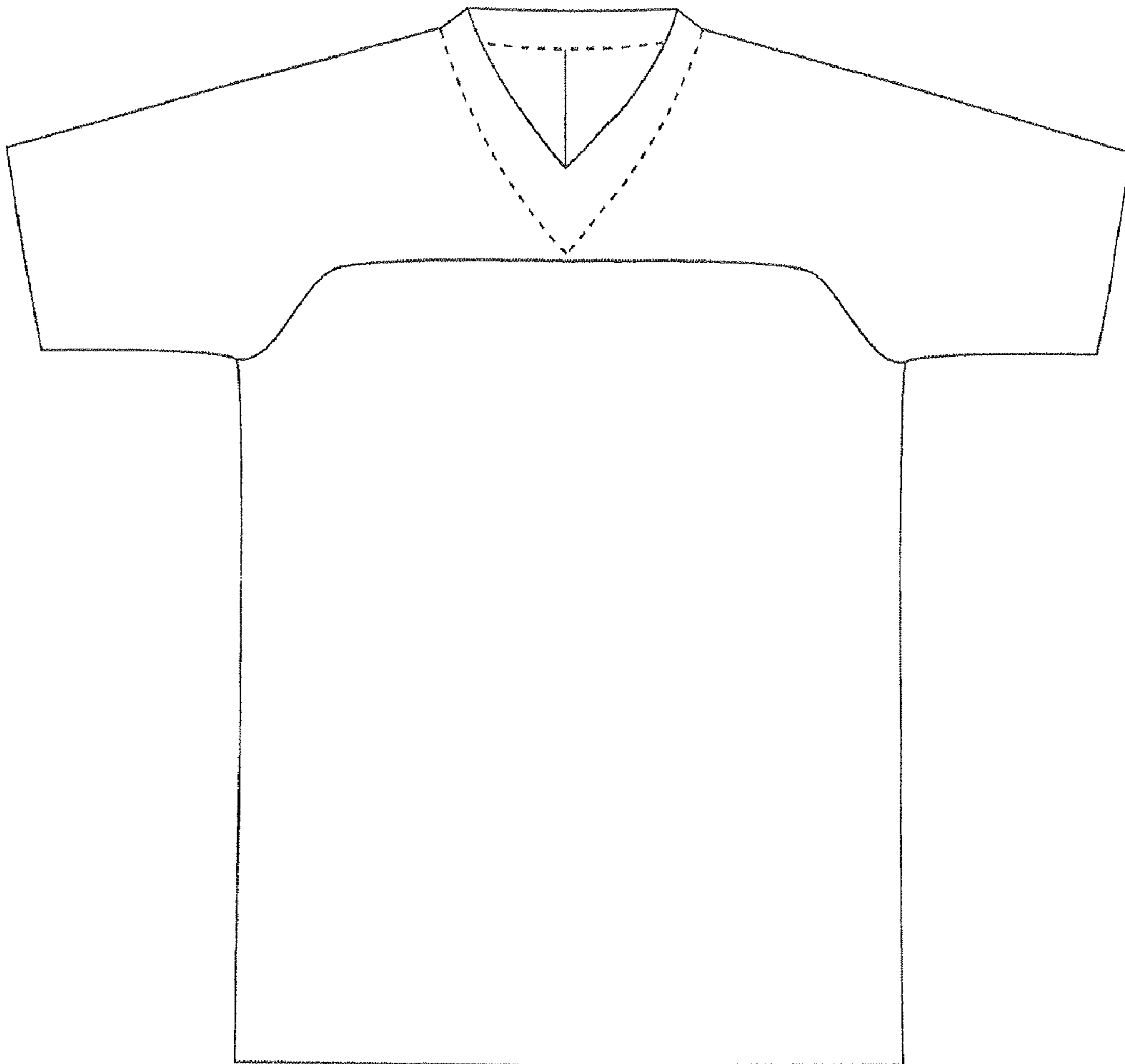

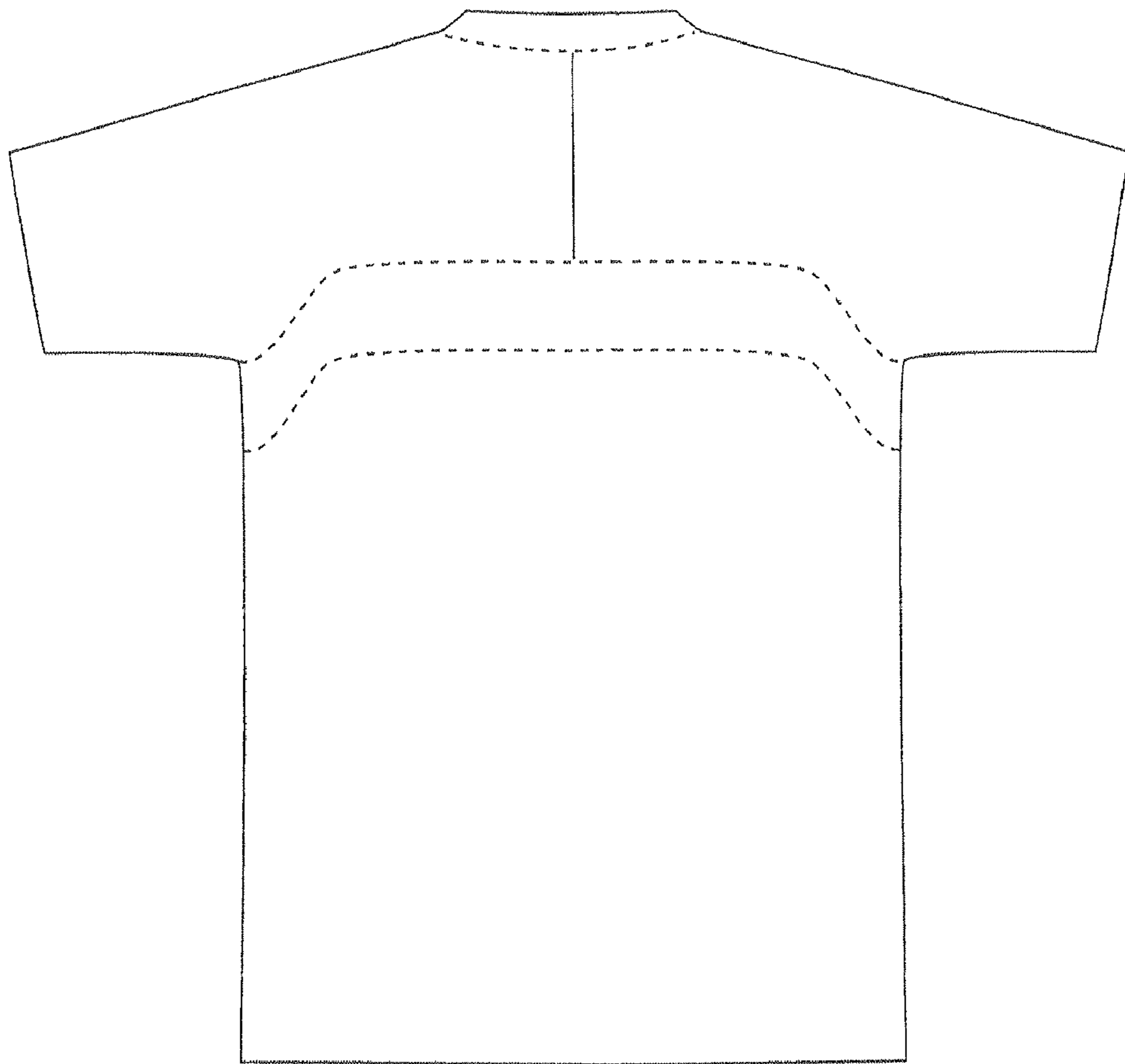
