The ornamental design for a pants pocket, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a pants pocket of a first embodiment of the present invention.

FIG. 2 is an elevational front view of the first embodiment in FIG. 1.

FIG. 3 is a top view of the first embodiment in FIG. 2.

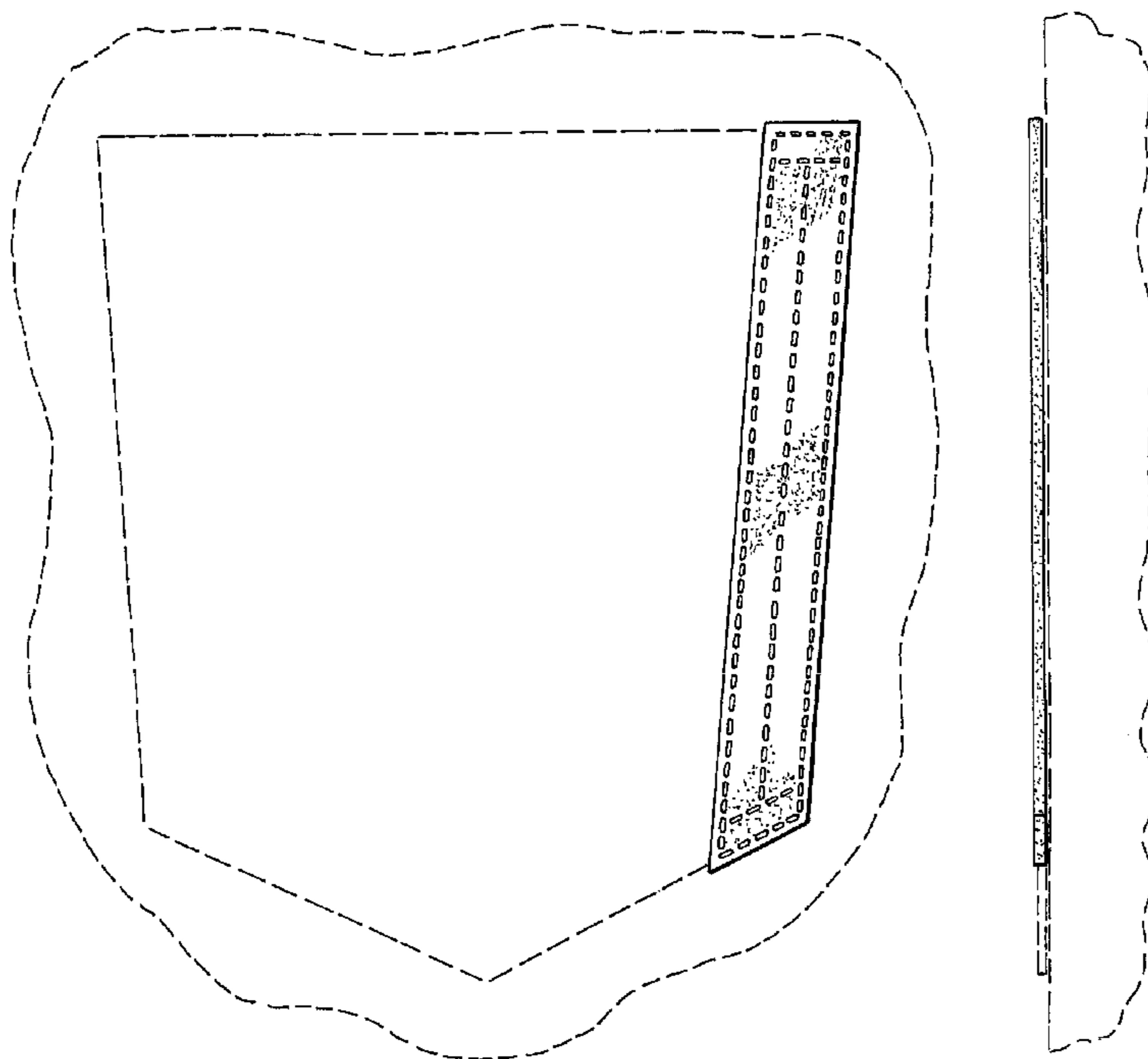
FIG. 4 is a bottom view of the first embodiment in FIG. 2.

FIG. 5 is an elevational left side view of the first embodiment in FIG. 2; and,

FIG. 6 is an elevational right side view of the first embodiment in FIG. 2.

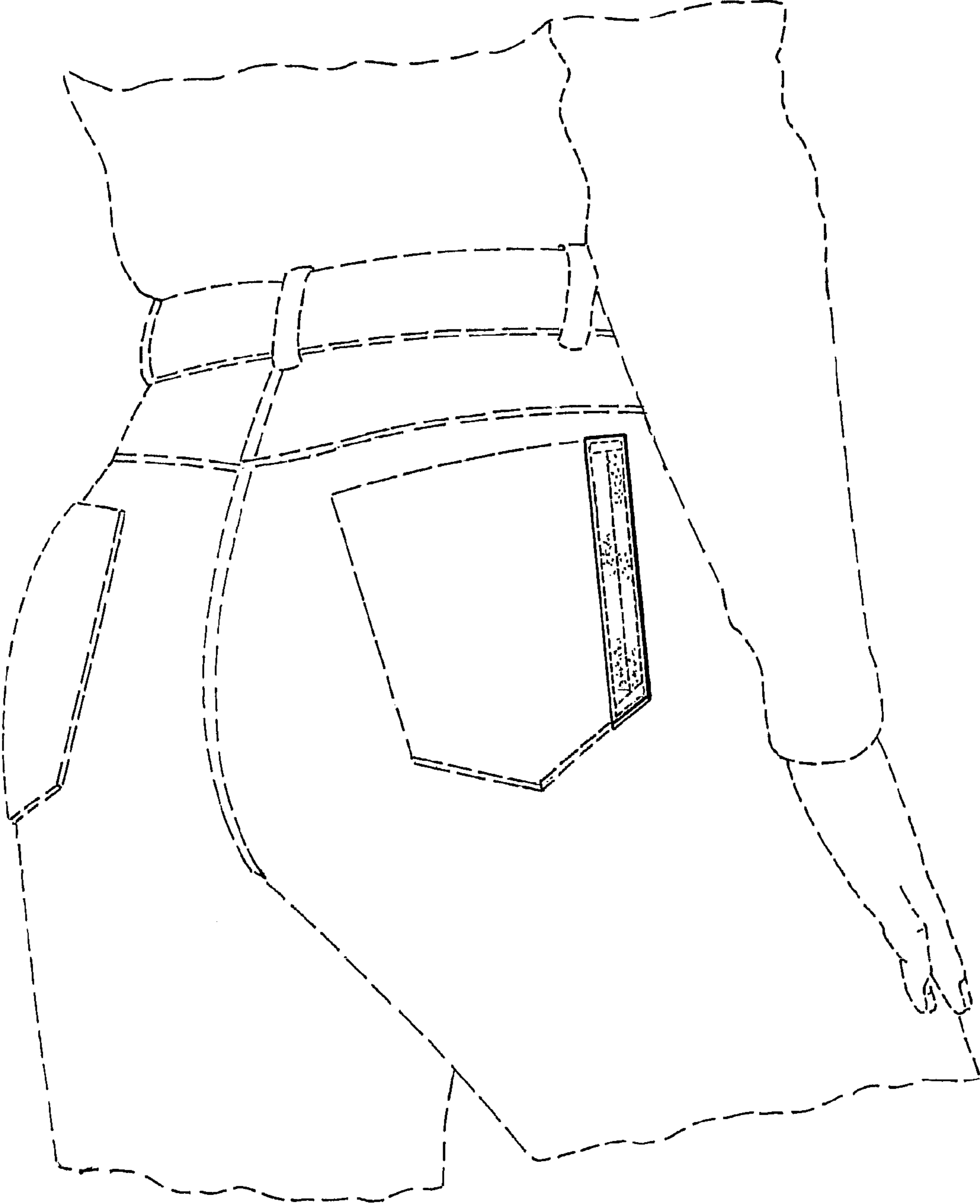

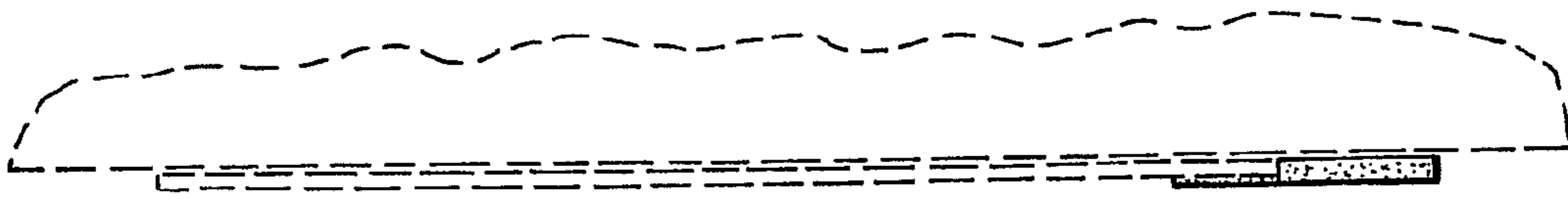
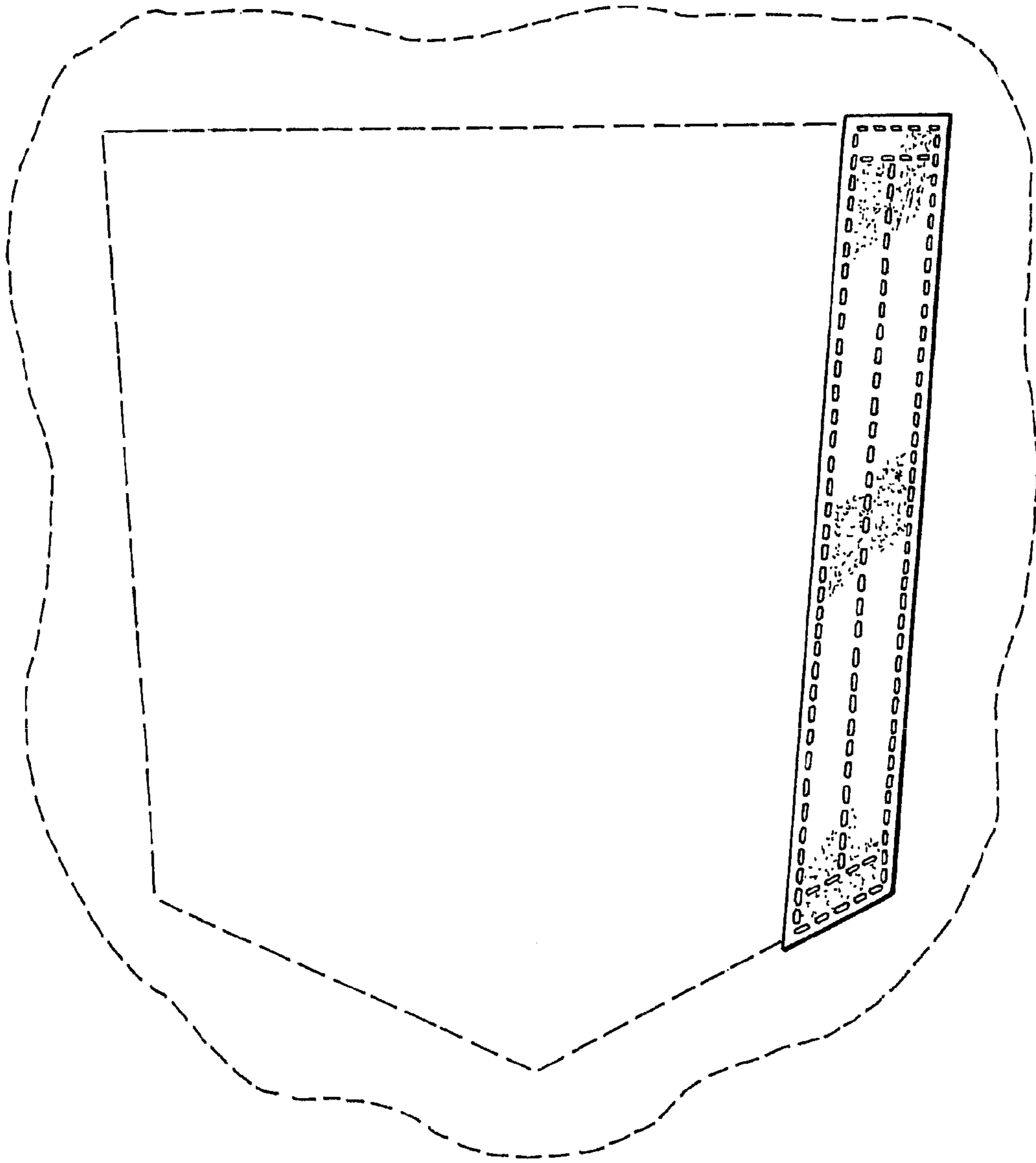

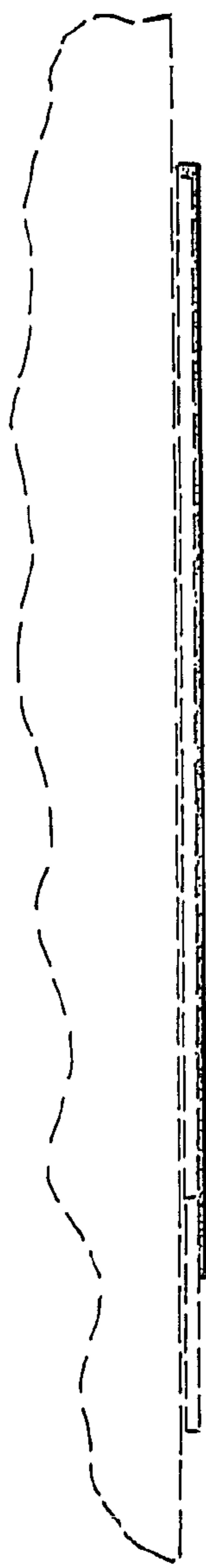

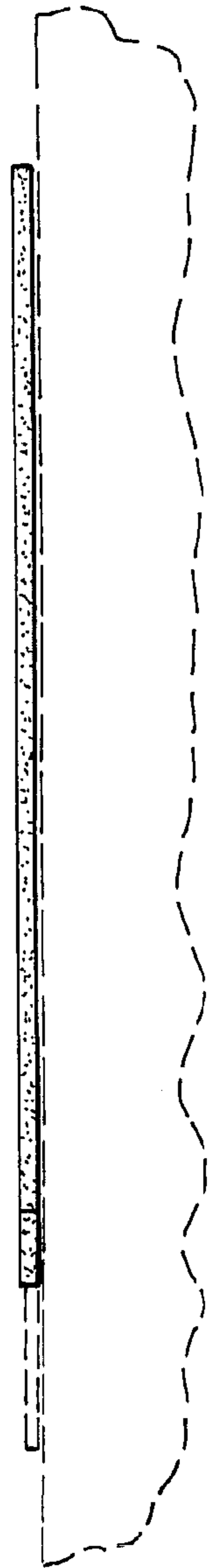

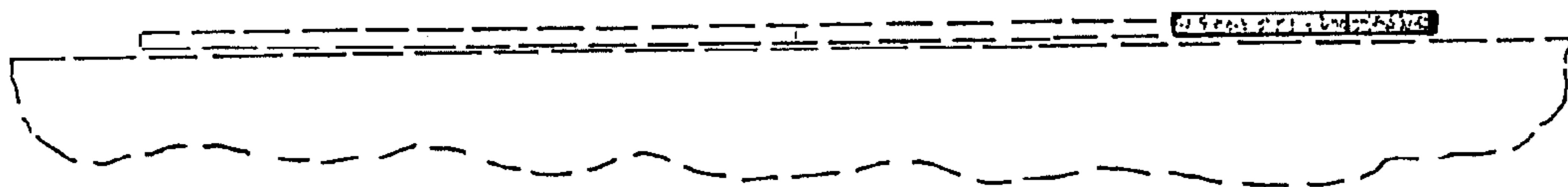
