(57) **CLAIM**

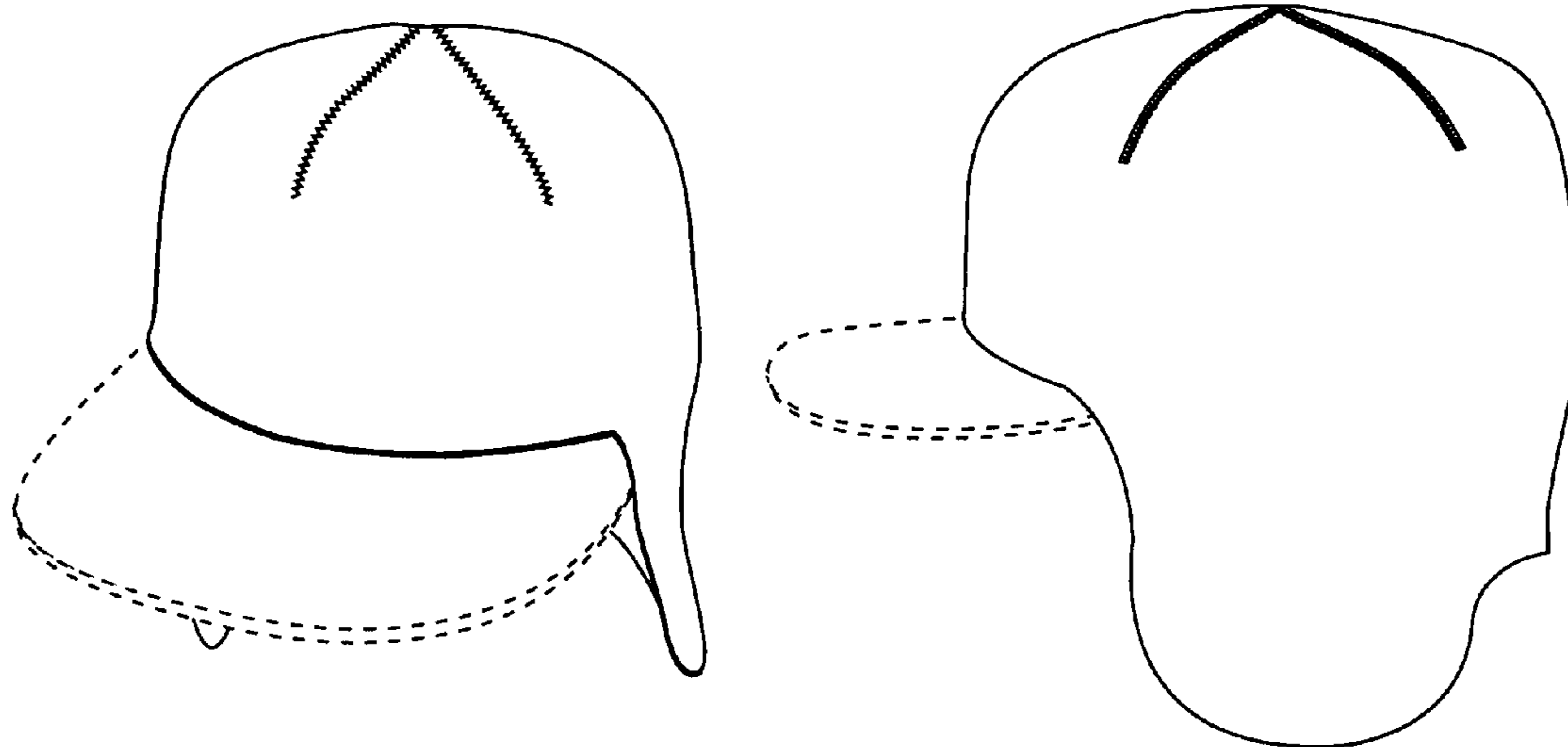
Applicants claim the ornamental design for a cap cover, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the cap cover, shown on a cap. FIG. 2 is a top view of the cap cover shown in FIG. 1. FIG. 3 is a bottom view of the cap cover shown in FIG. 1. FIG. 4 is a left side view of the cap cover shown in FIG. 1. FIG. 5 is a right side view of the cap cover shown in FIG. 1. FIG. 6 is a front view of the cap cover shown in FIG. 1; and, FIG. 7 is a rear view of the cap cover shown in FIG. 1.

The portions of a baseball-style cap shown in broken lines are included for the purpose of illustrating environmental matter and form no part of the claimed design.

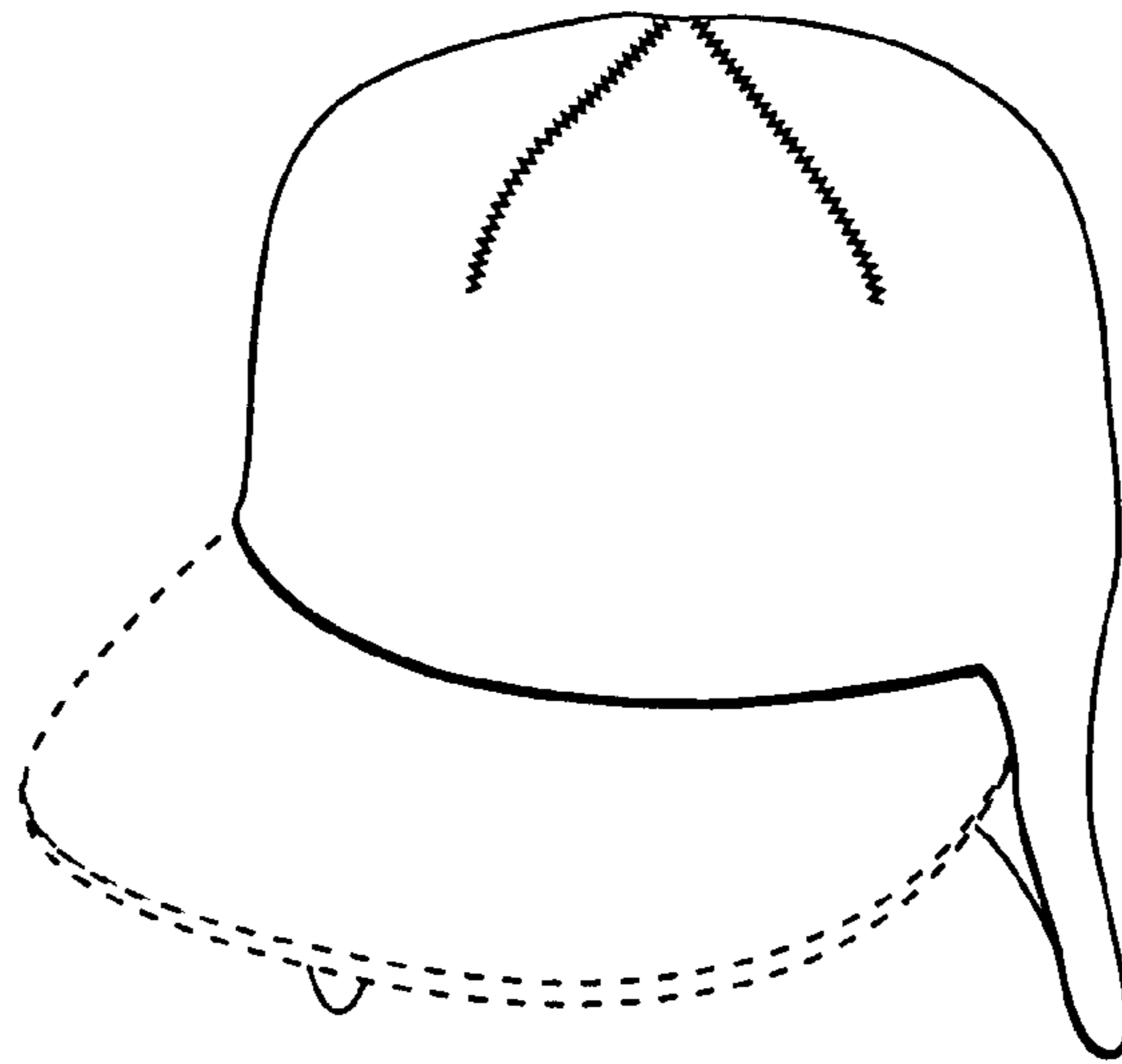

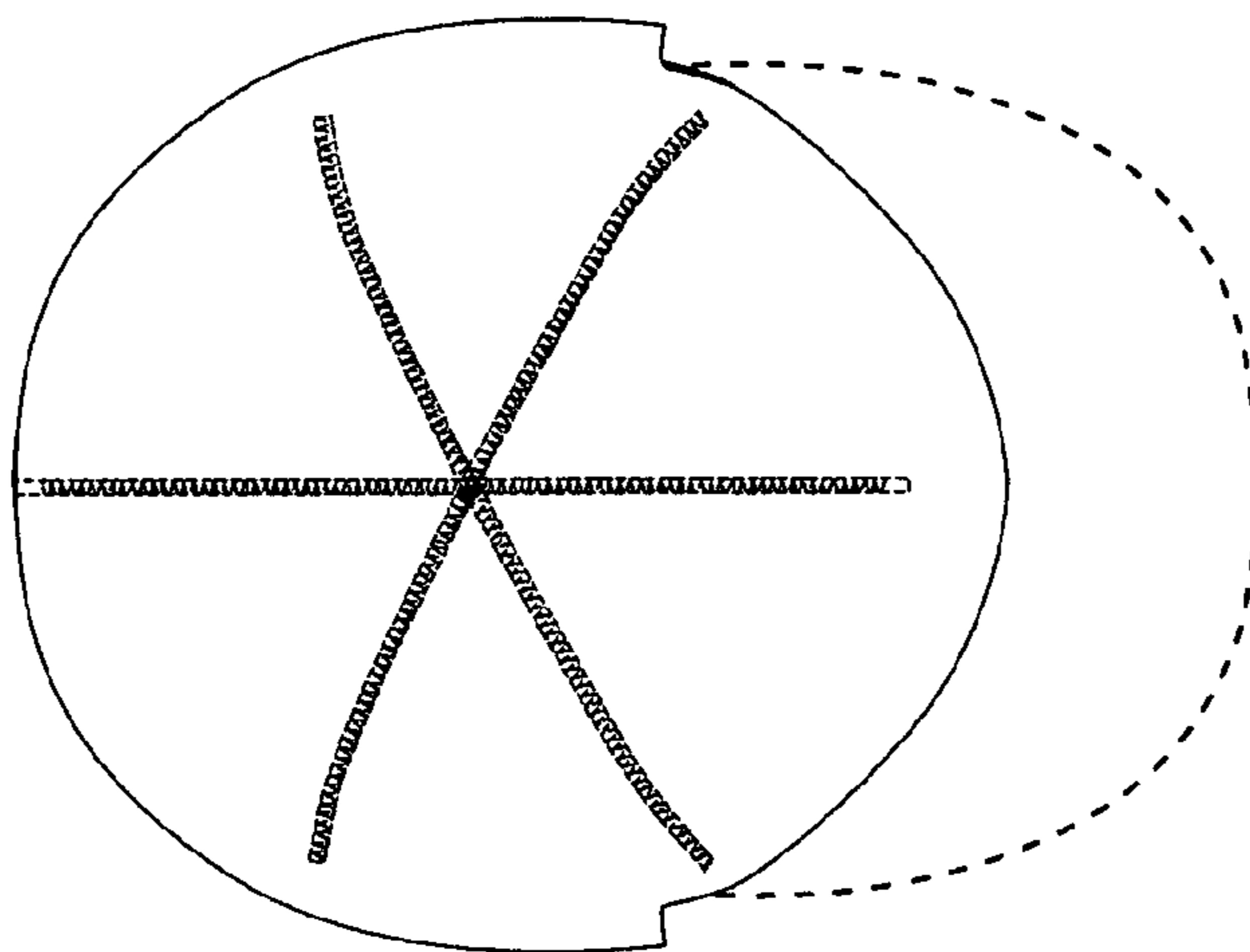

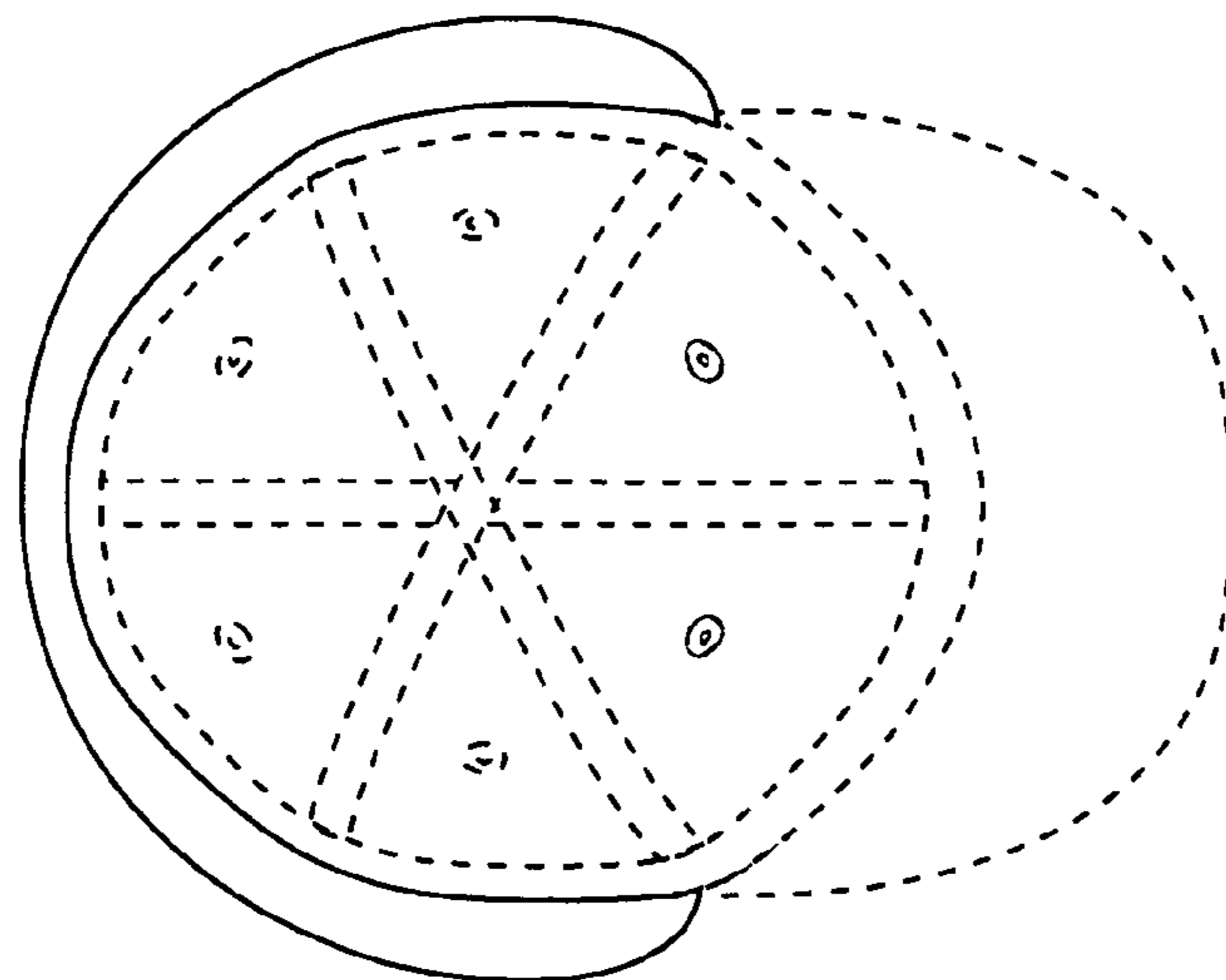

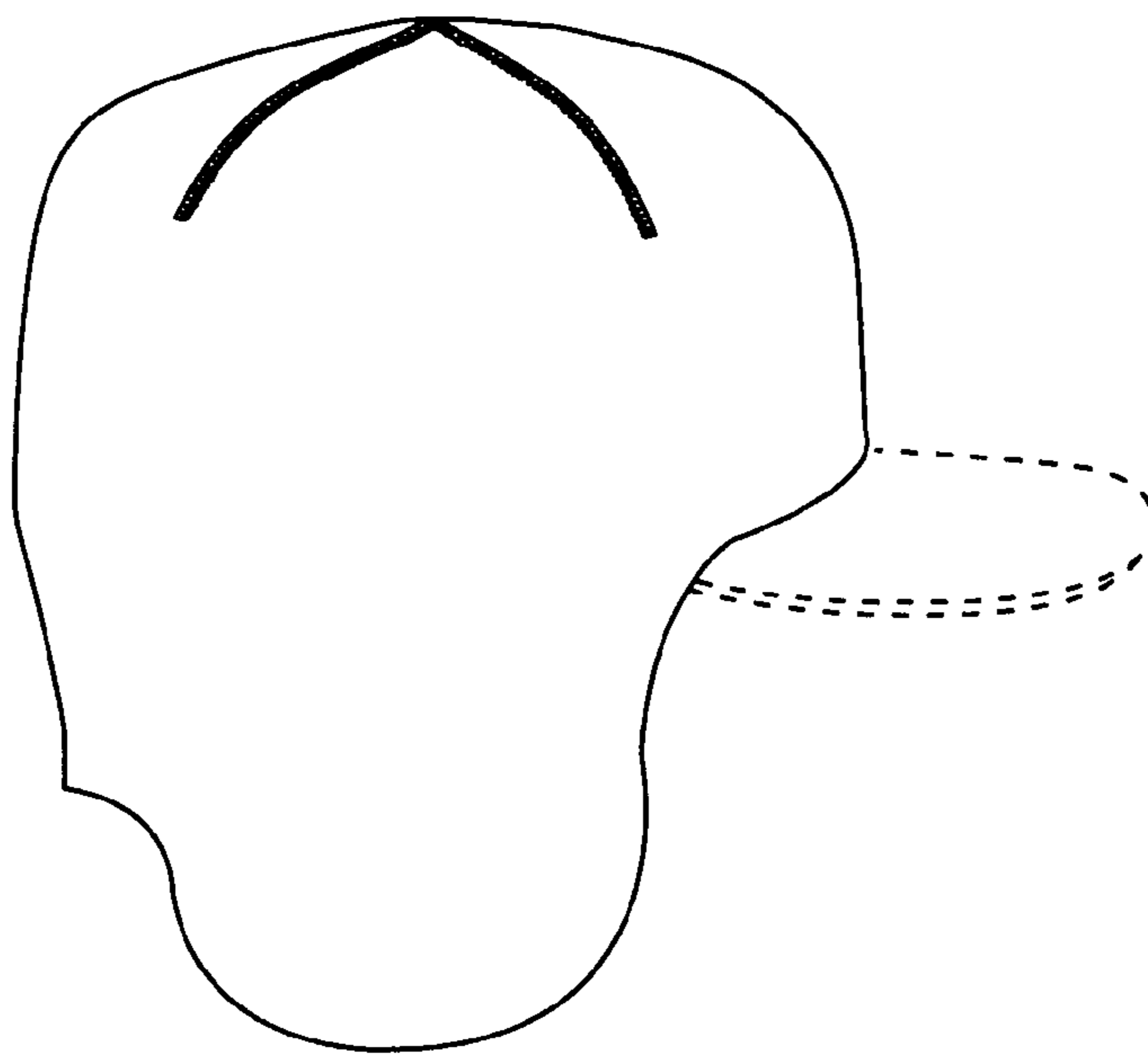

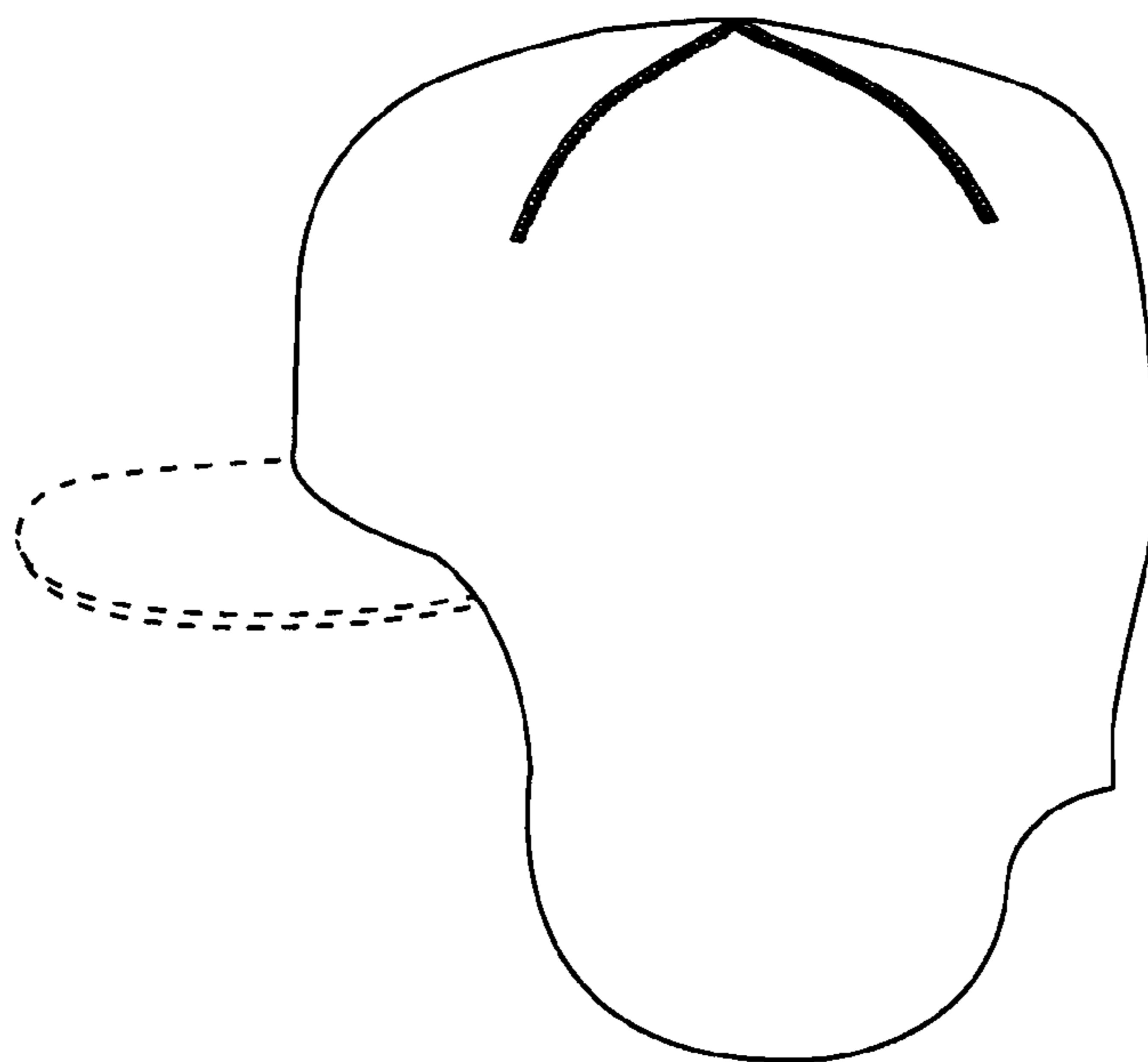

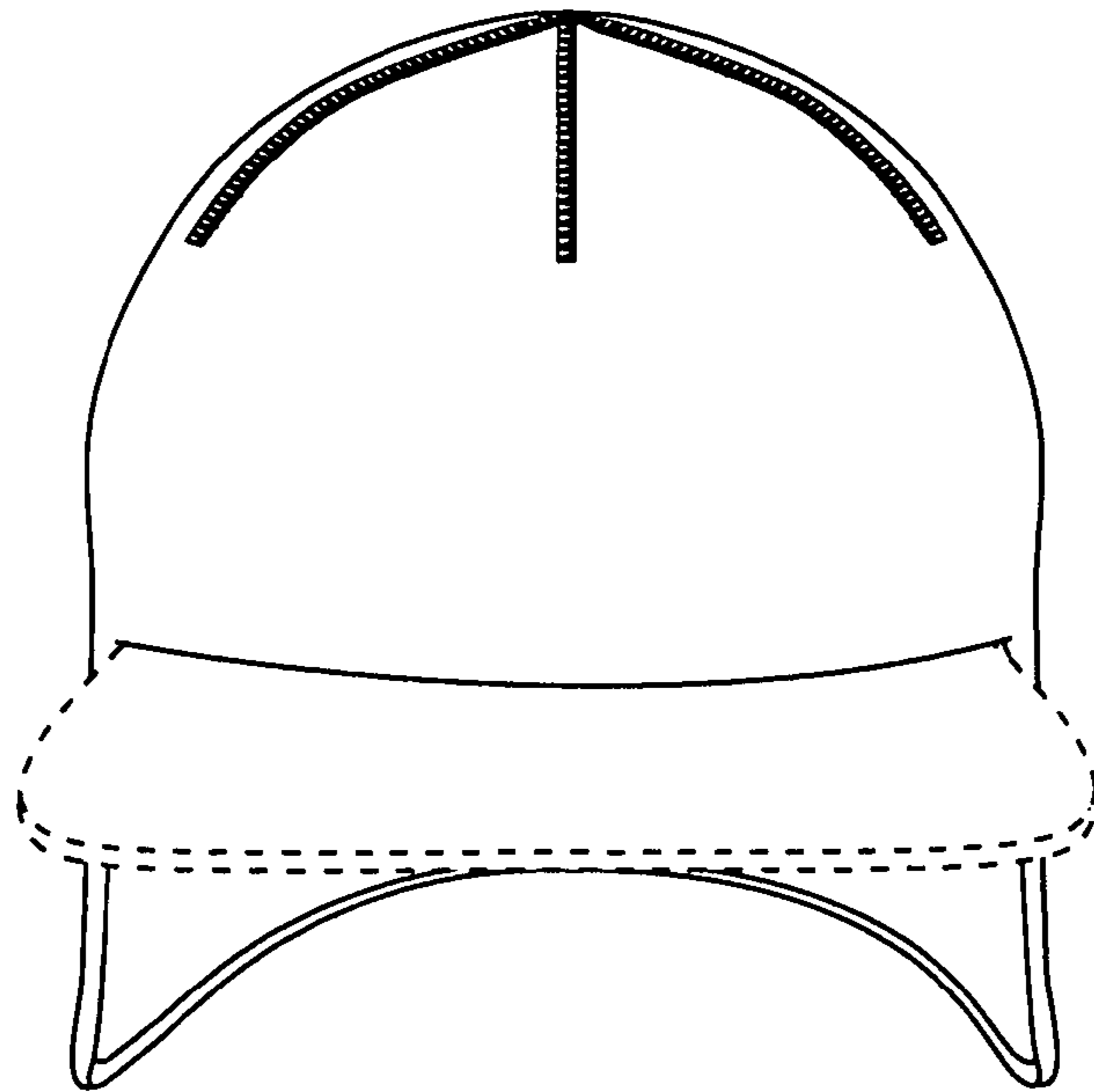

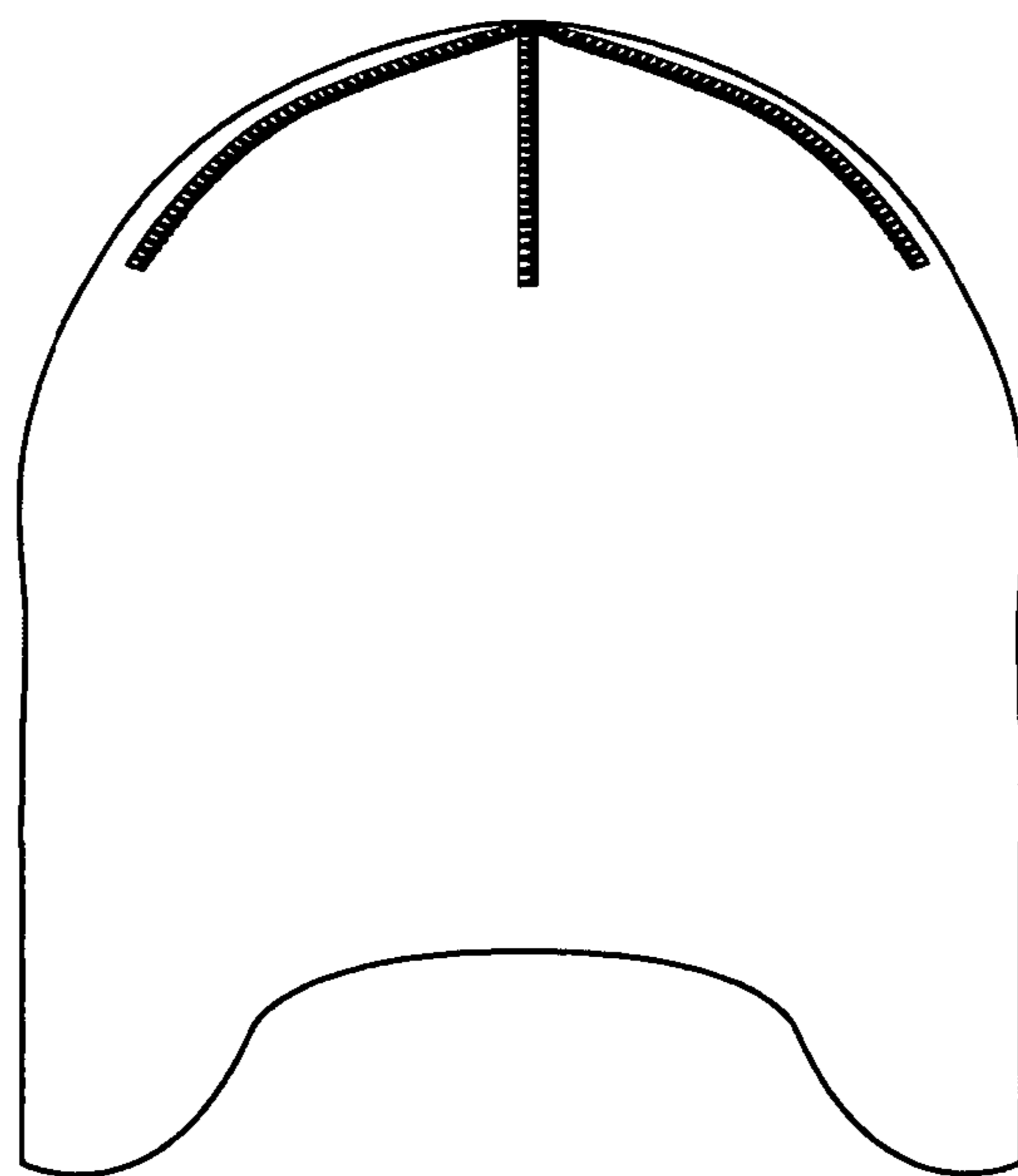
