FIG. 10 is an enlarged view of the shotgun holster showing the trigger guard and operating handle in abutment with the holster; and,

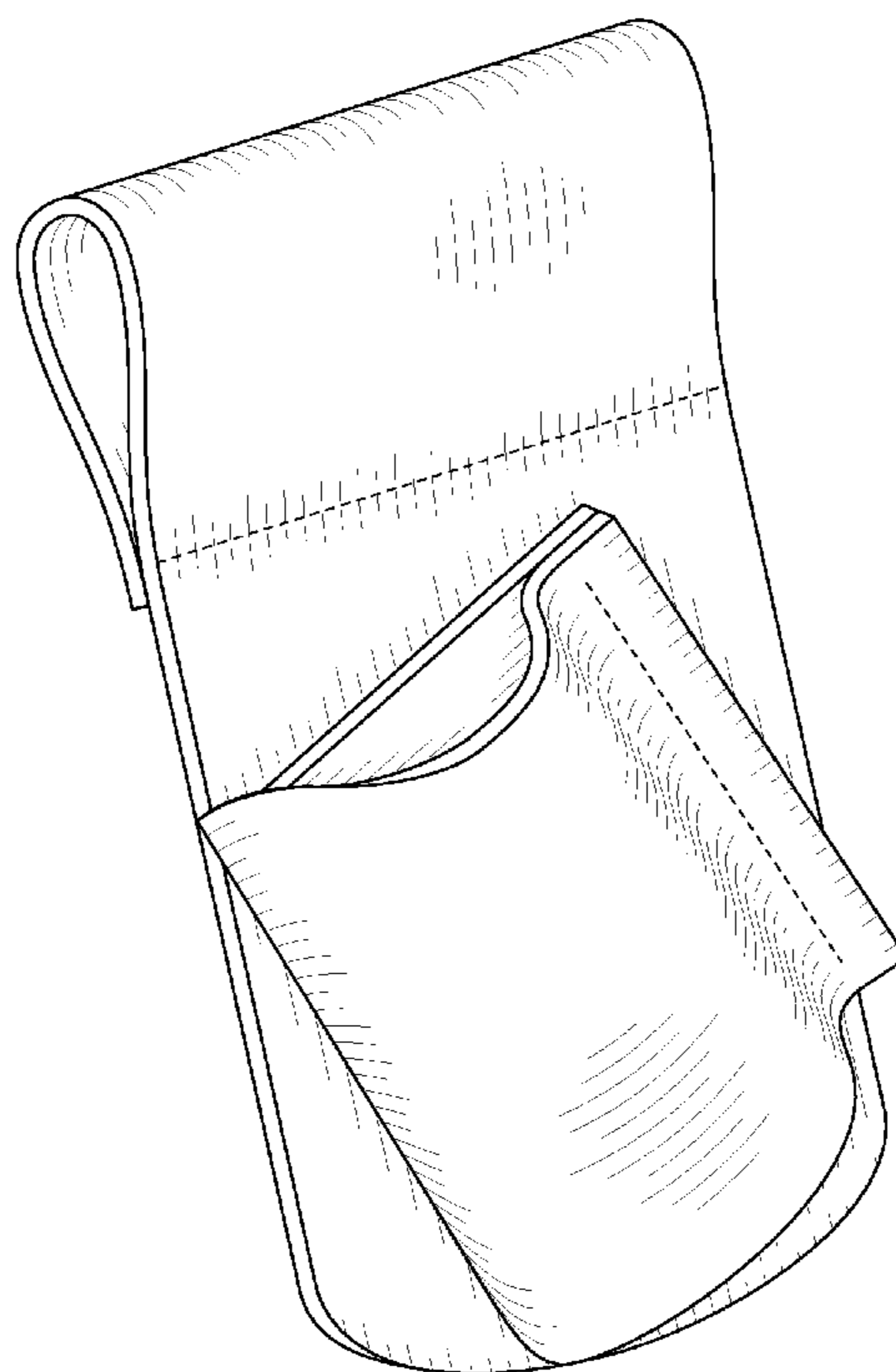
FIG. 11 is an additional perspective view of the shotgun holster.

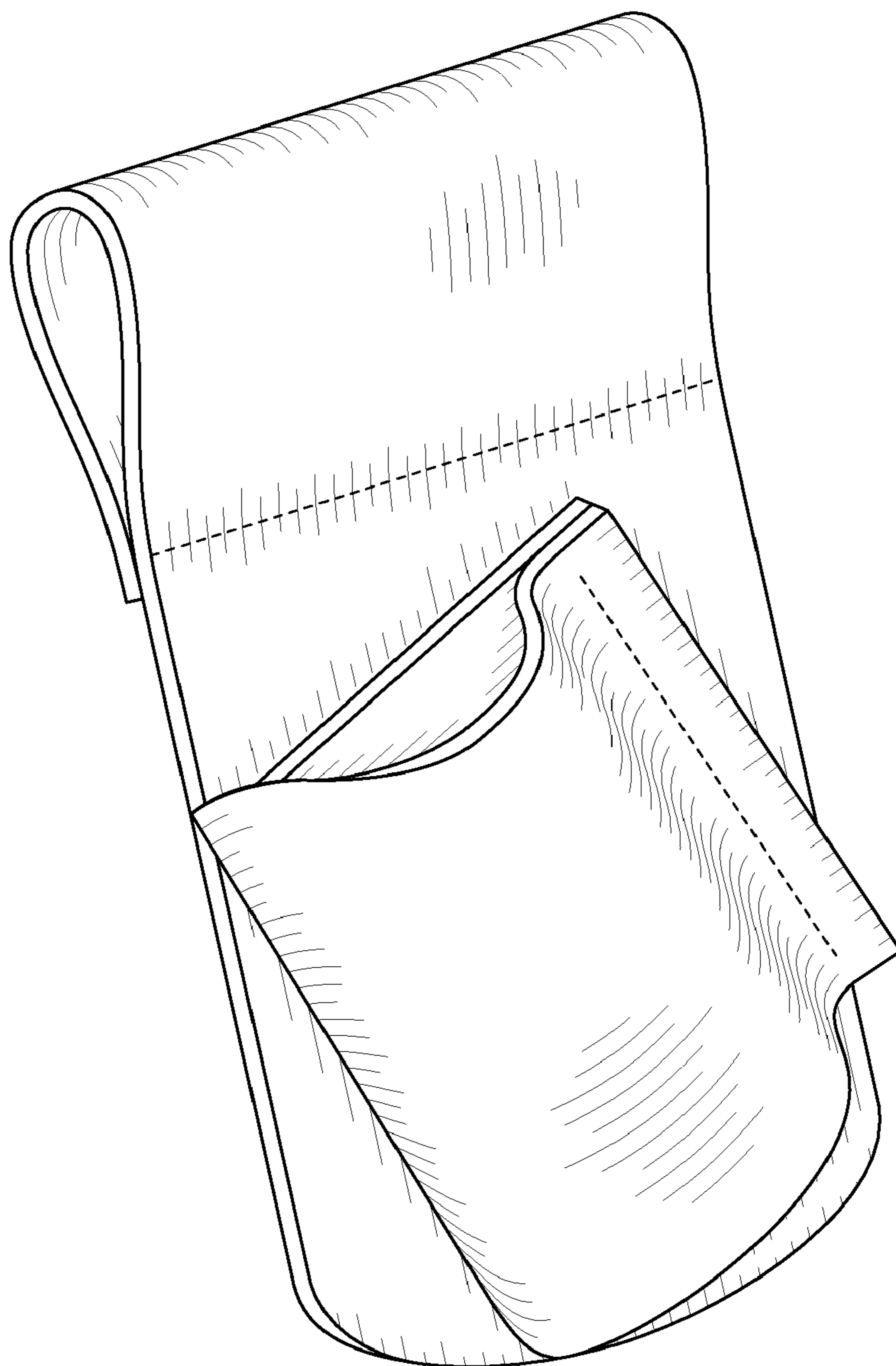

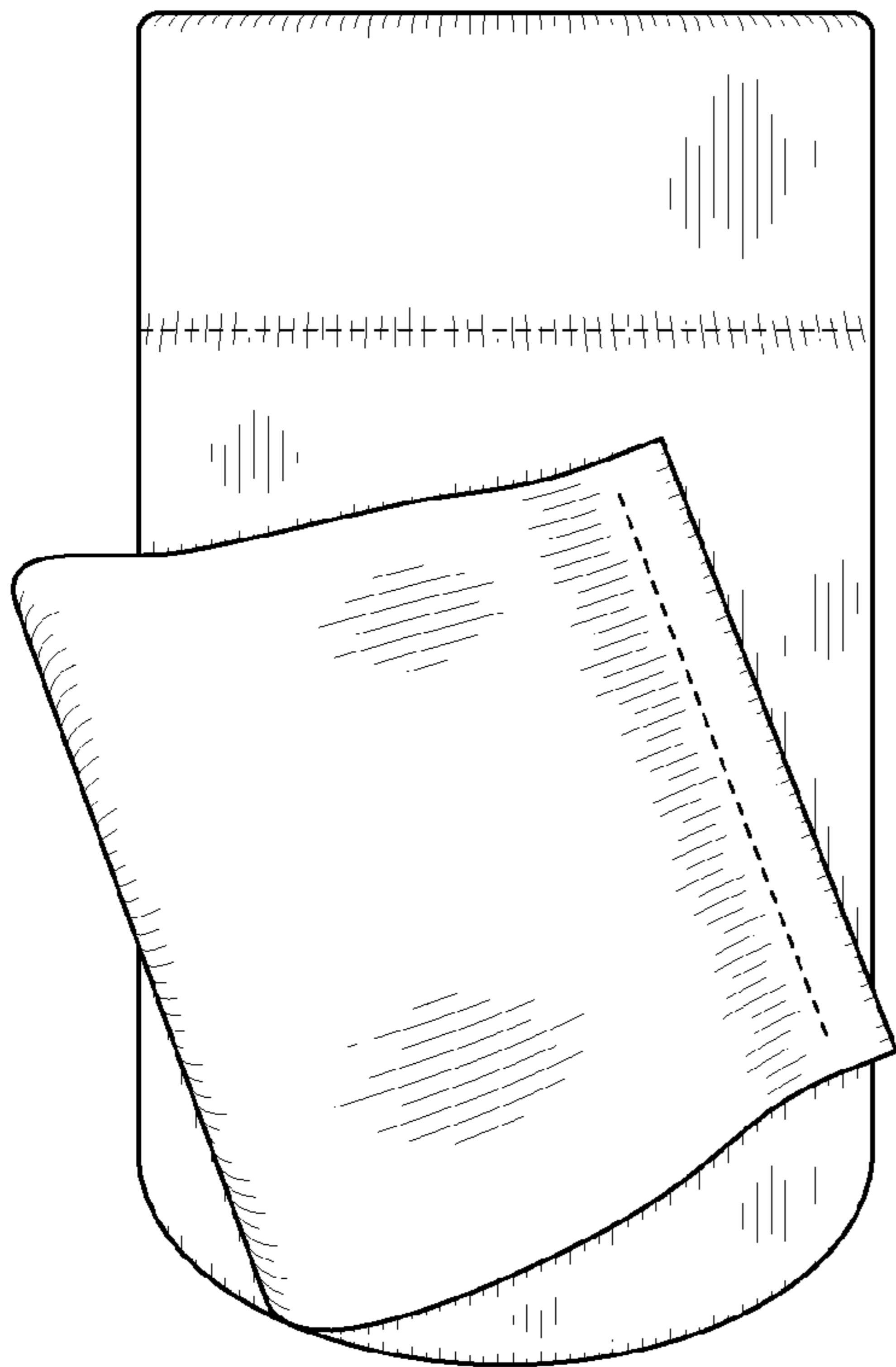

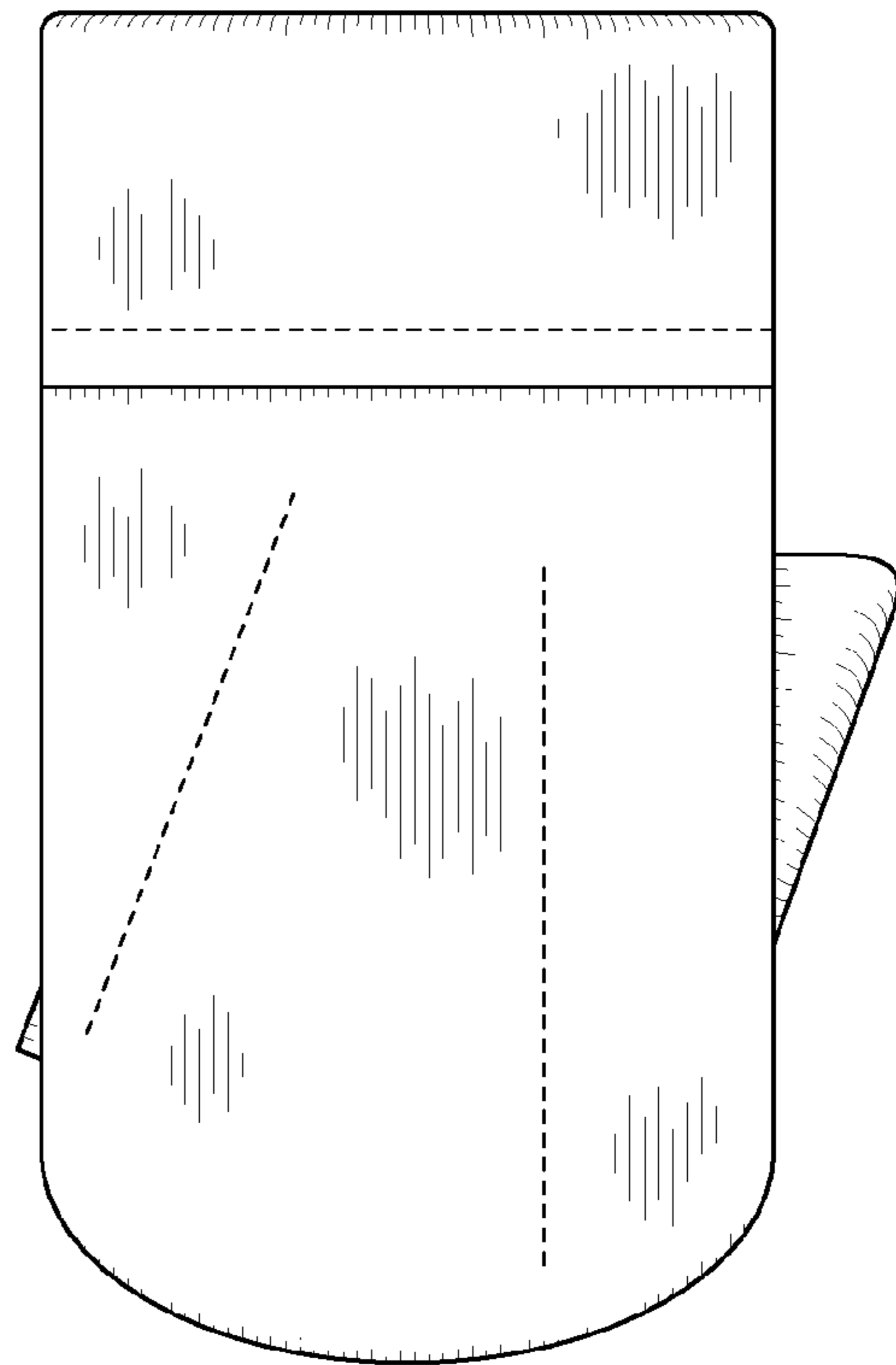

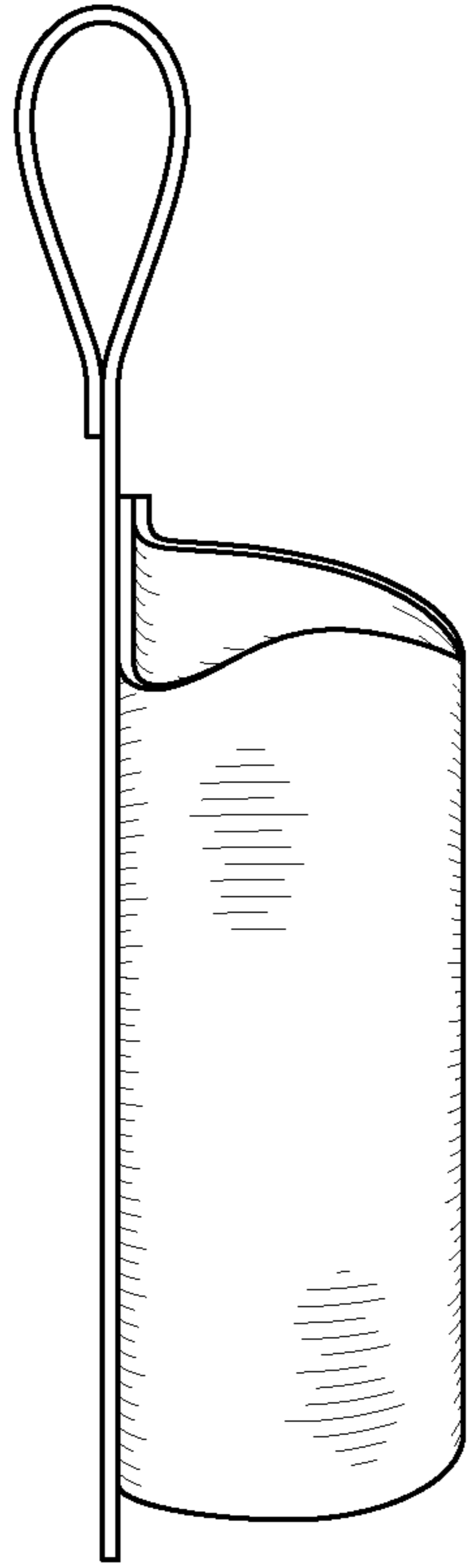

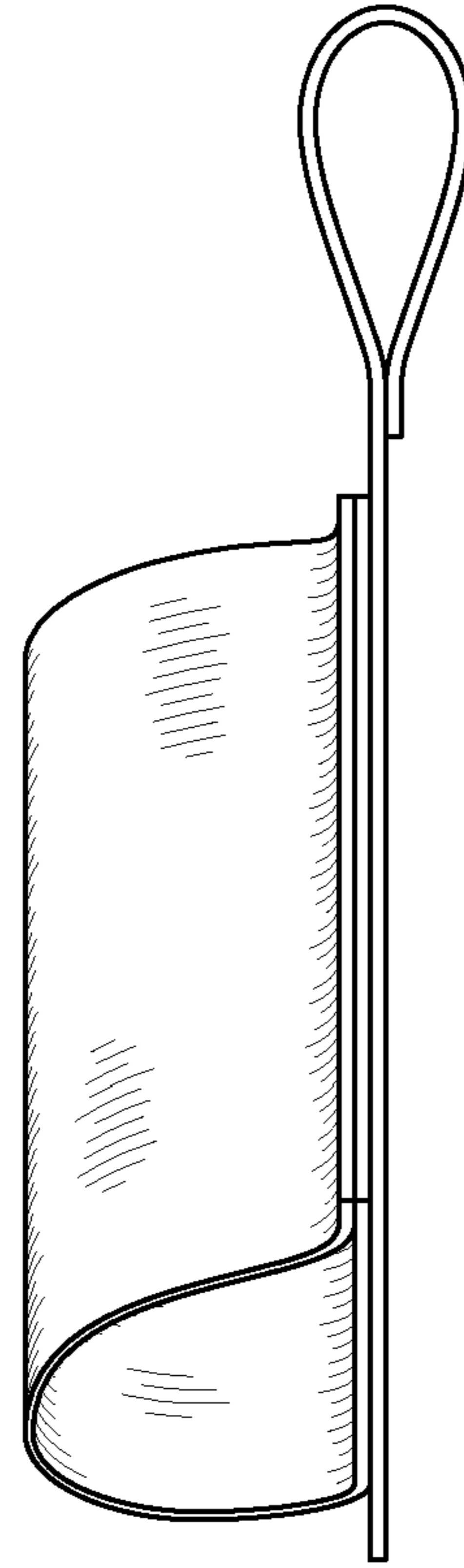

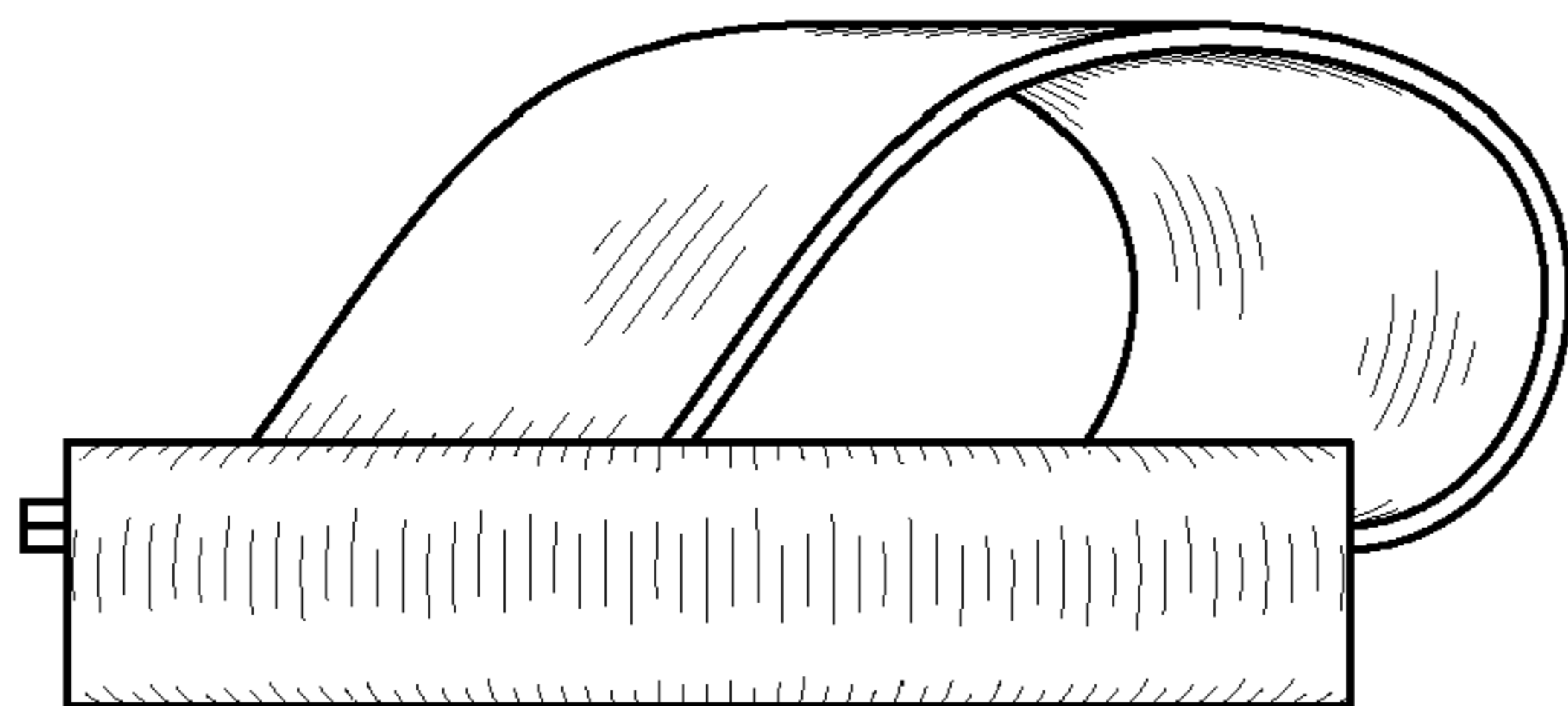

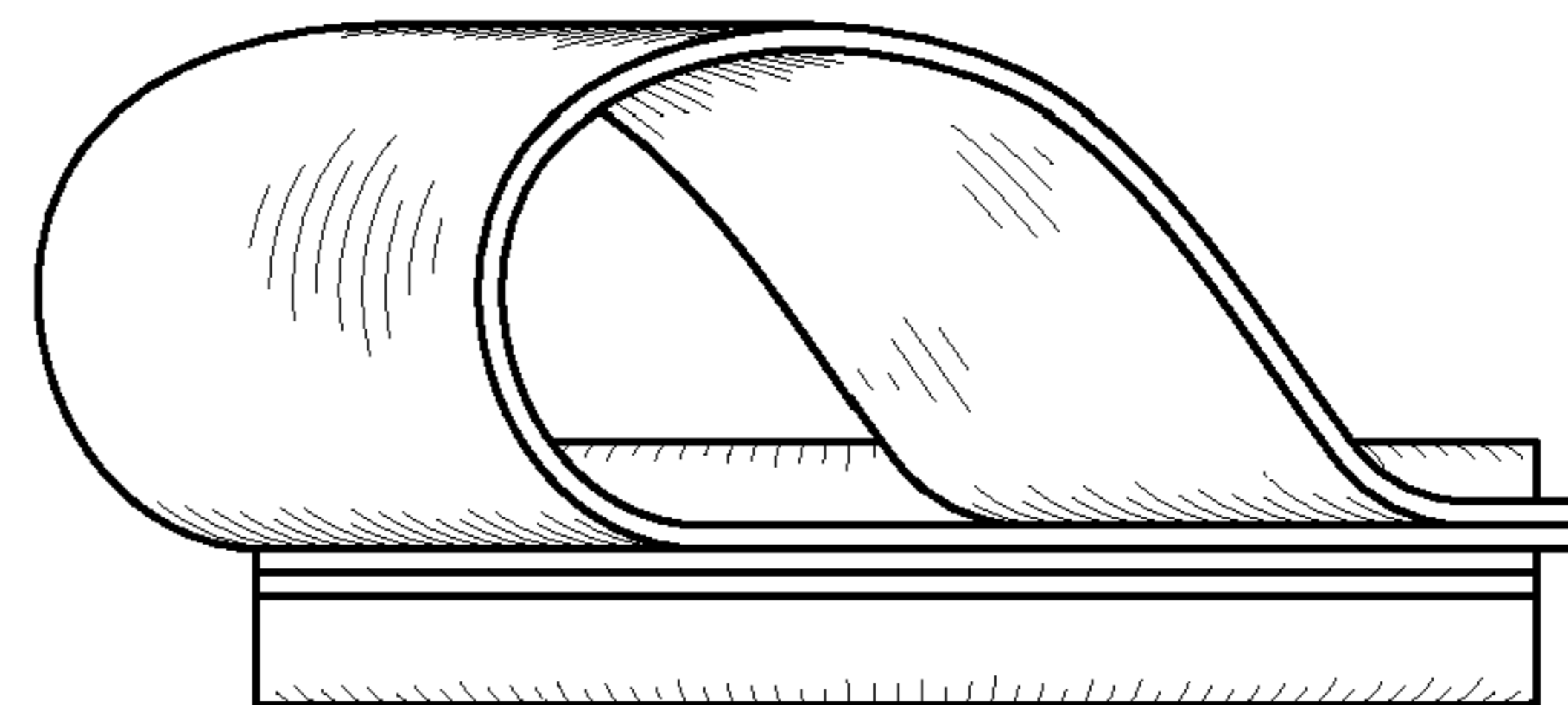

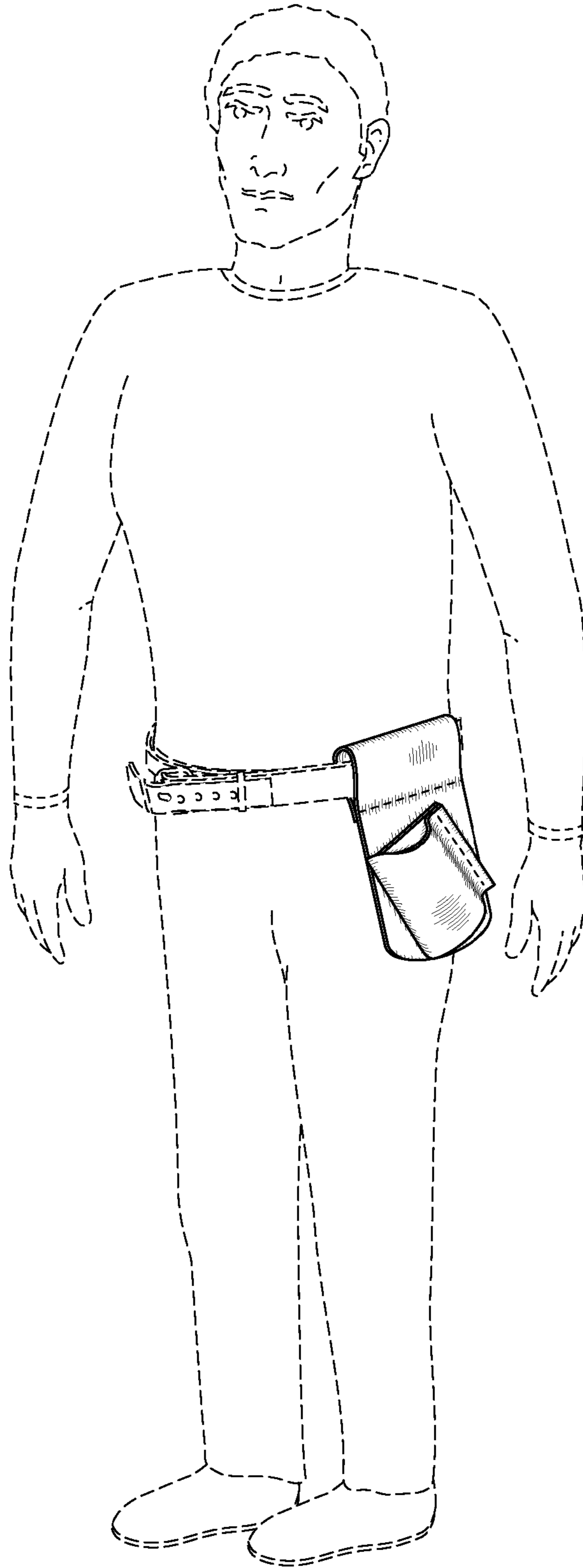

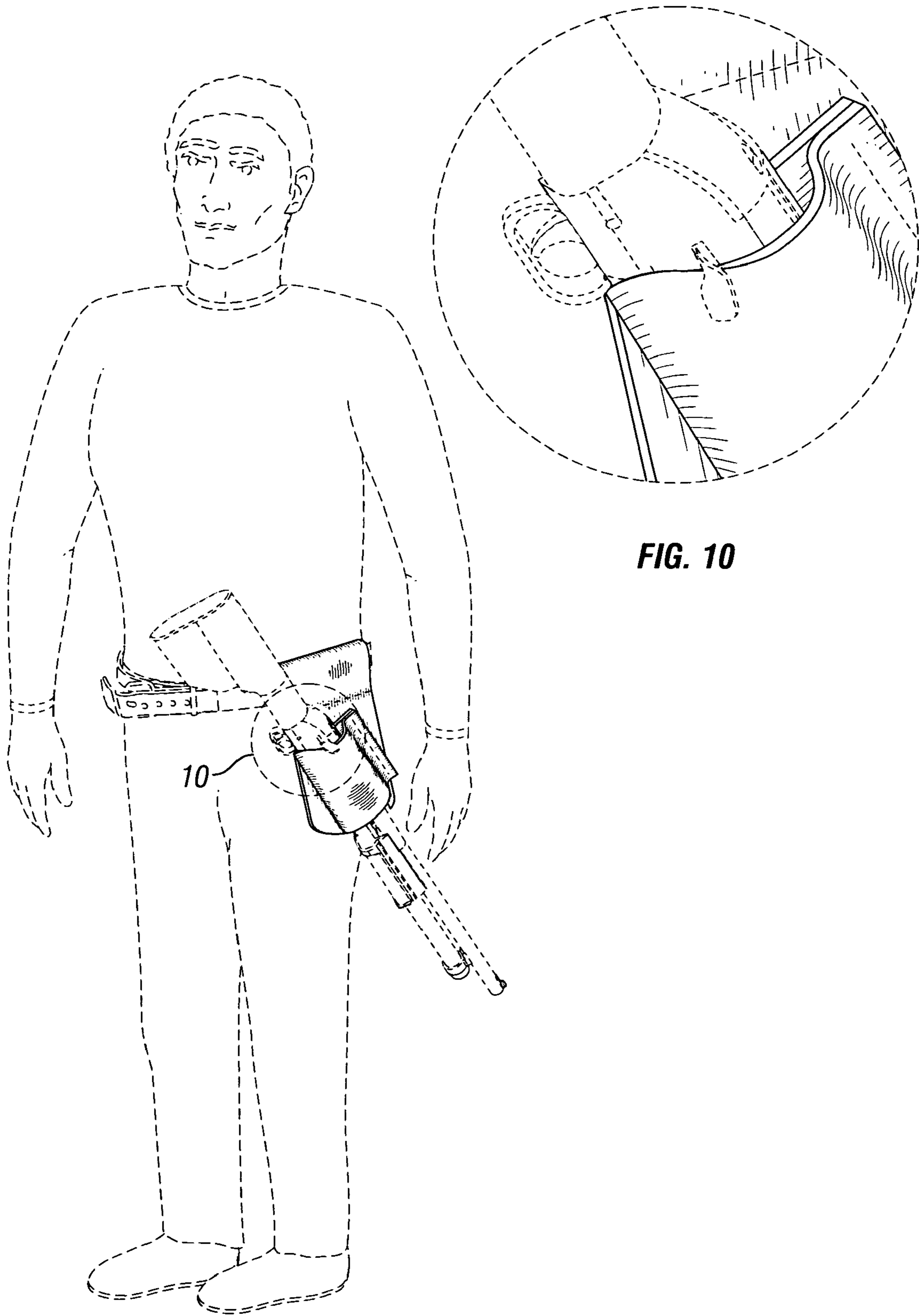

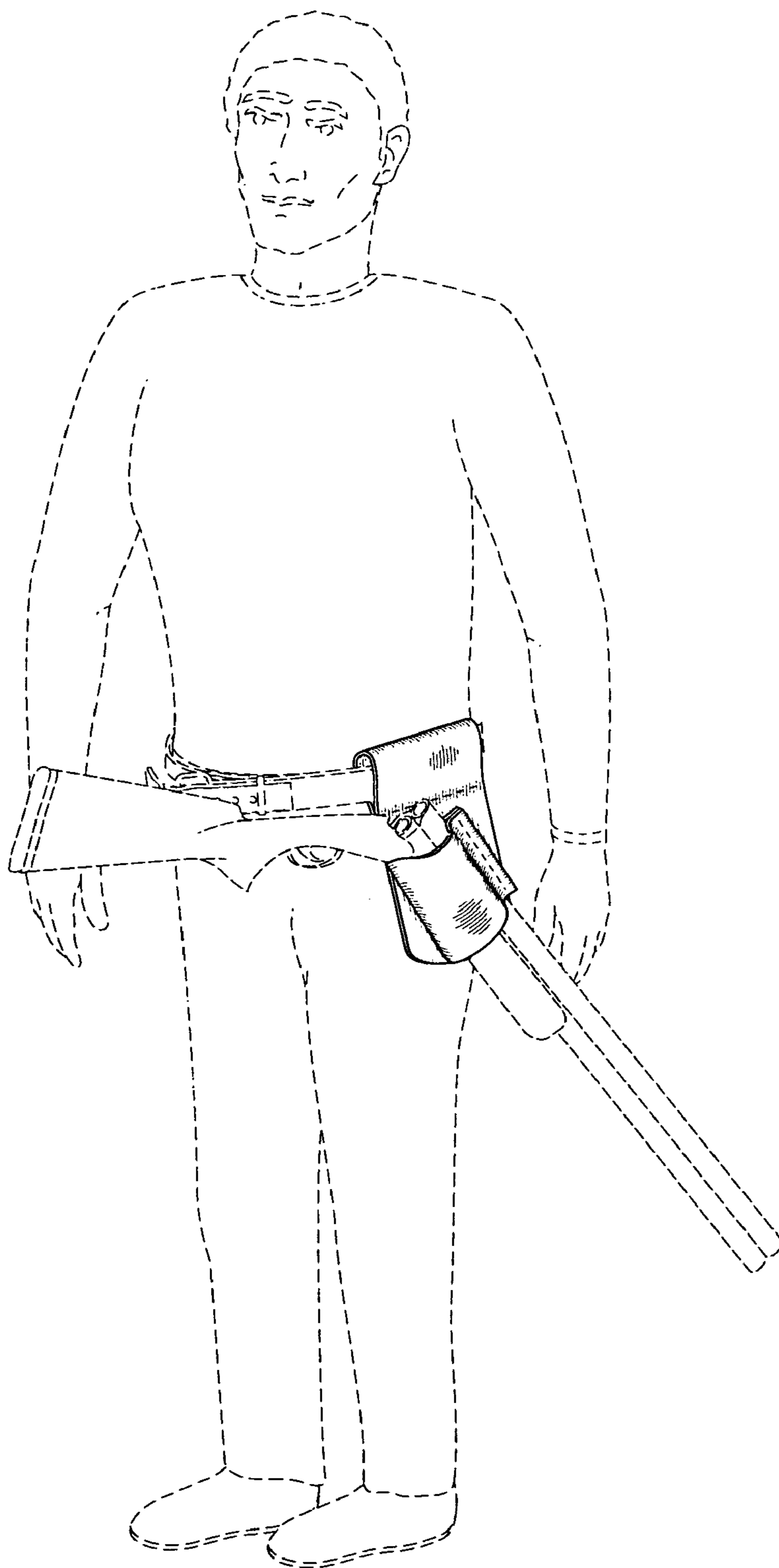
