The ornamental design for a microwave oven, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a microwave oven showing my new design;

FIG. 2 is a front elevation view thereof;

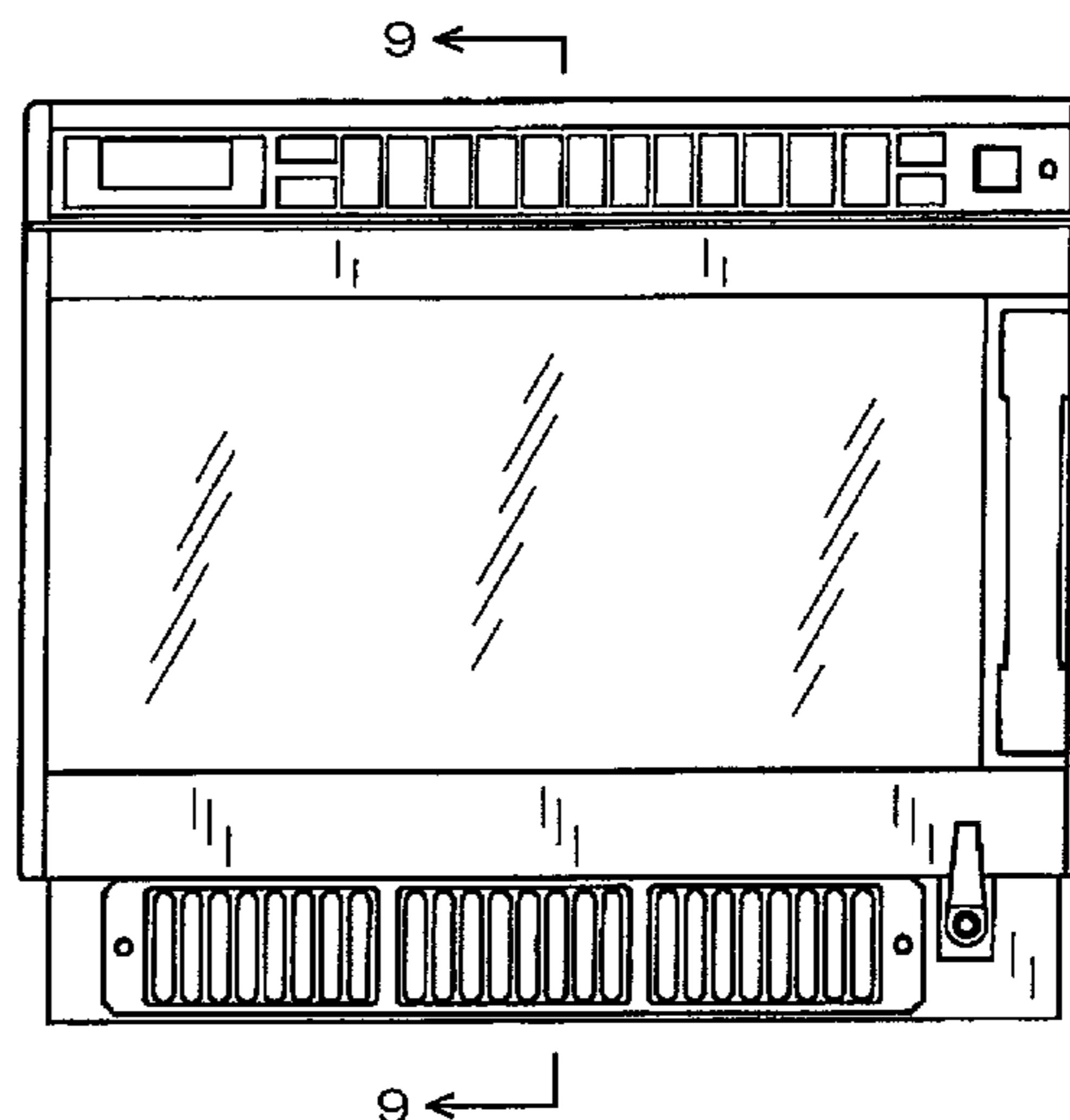
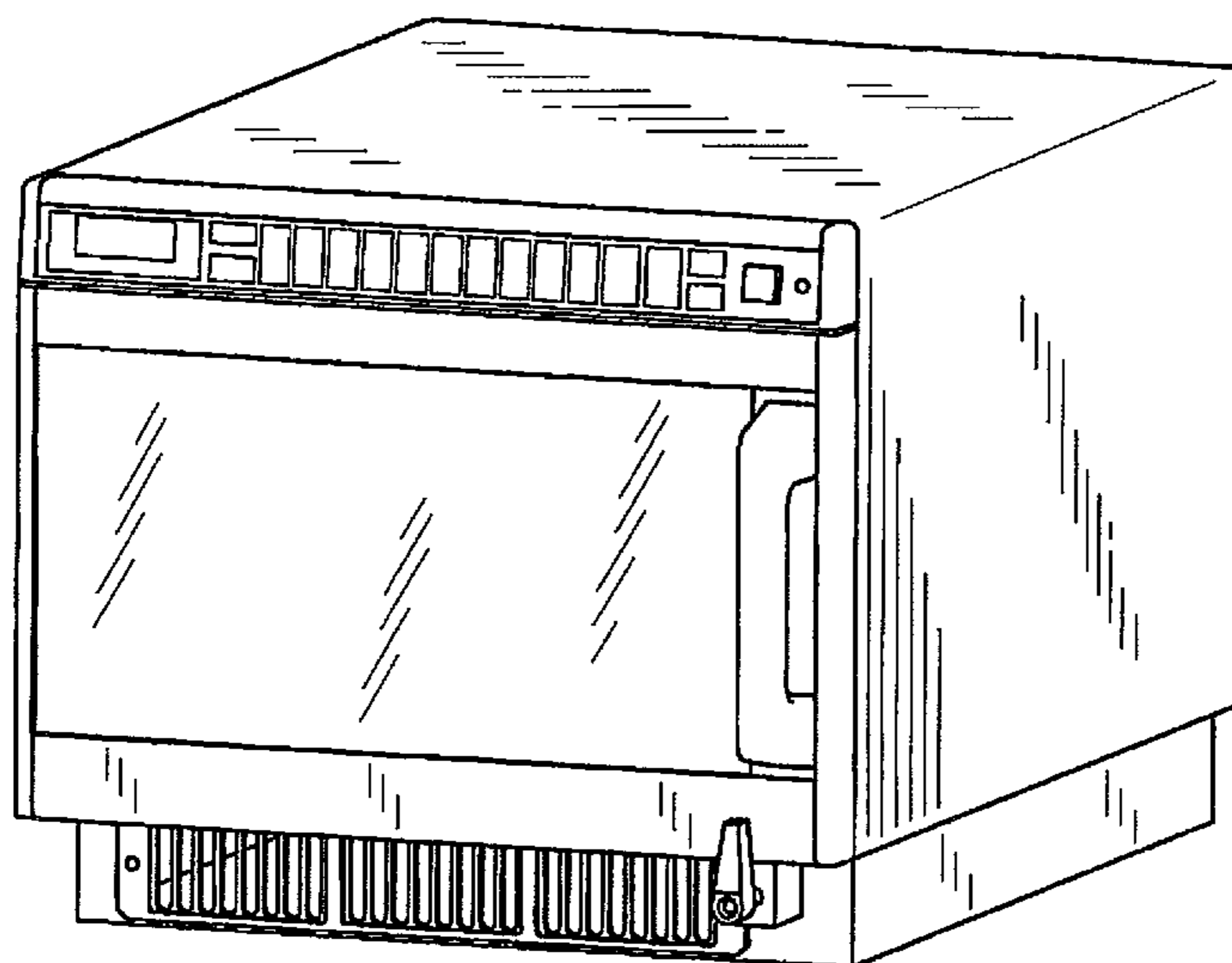

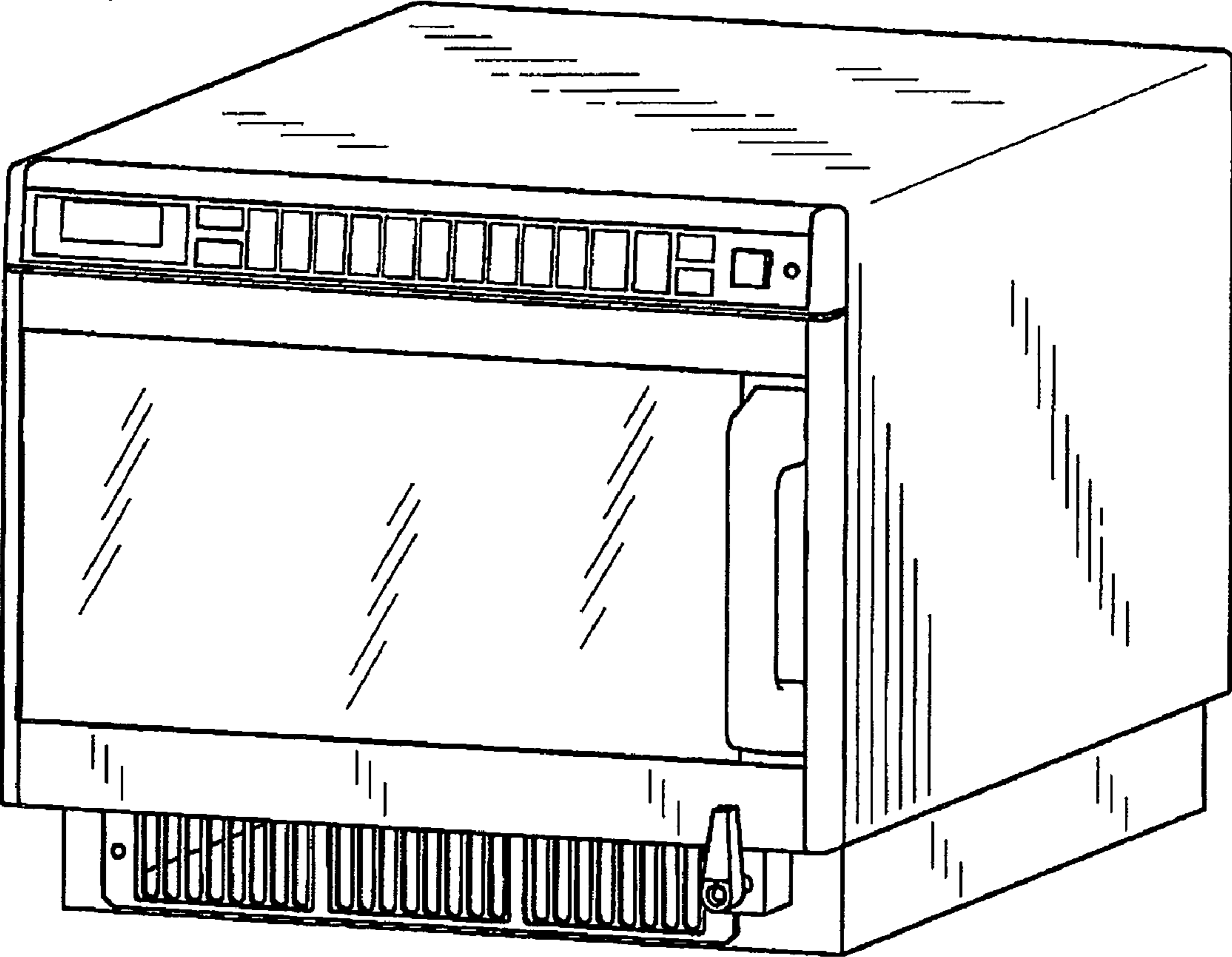

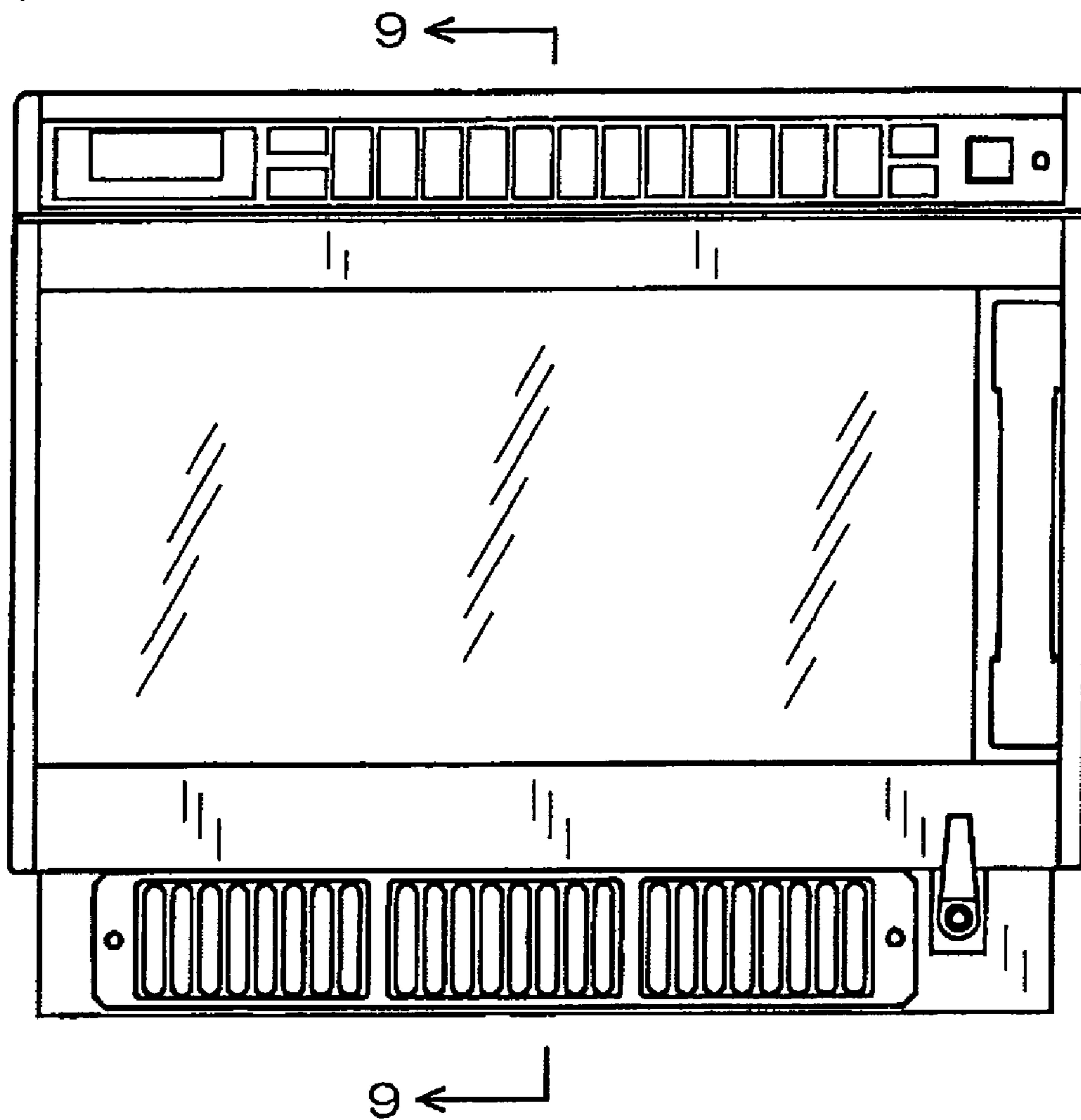

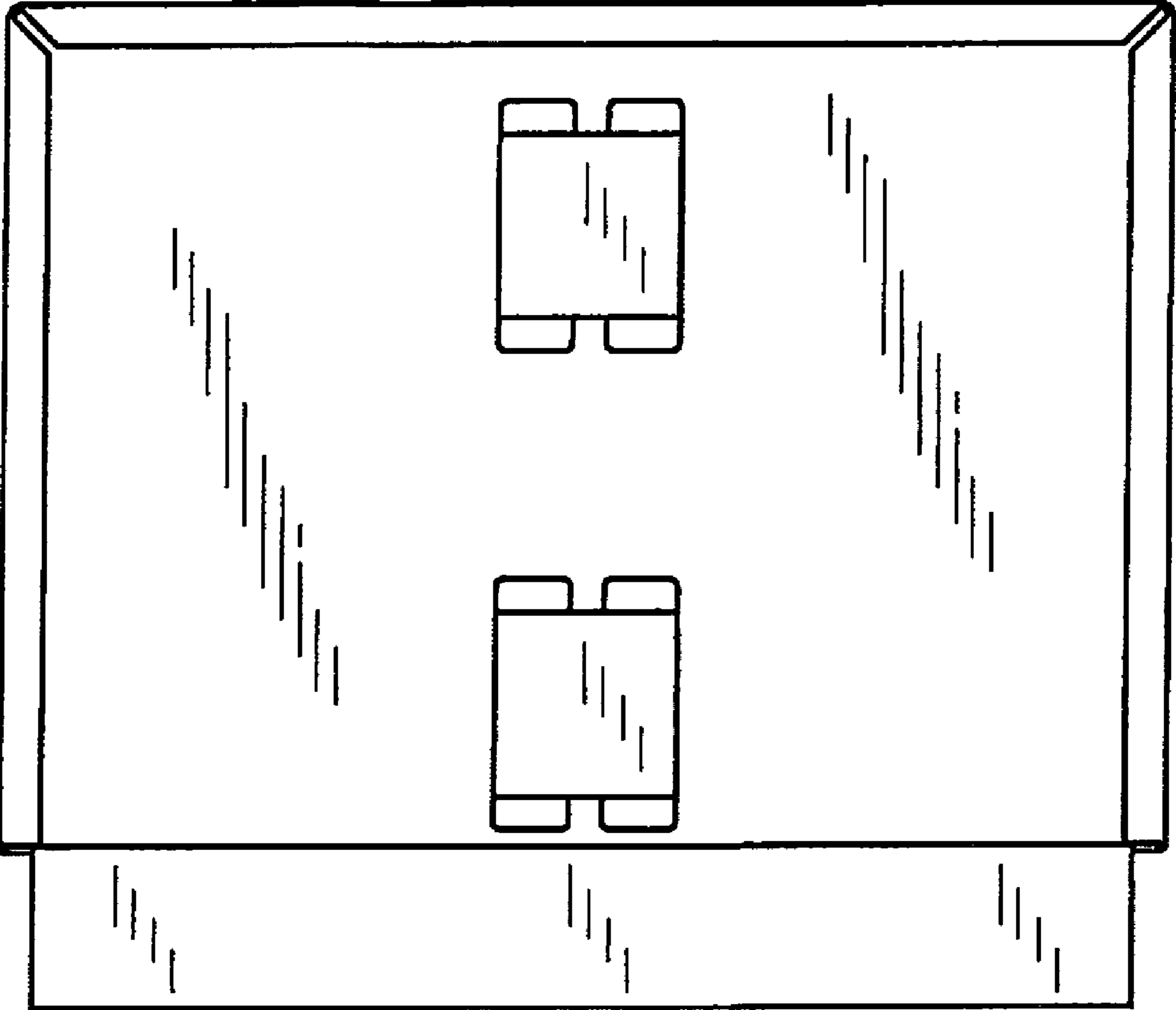

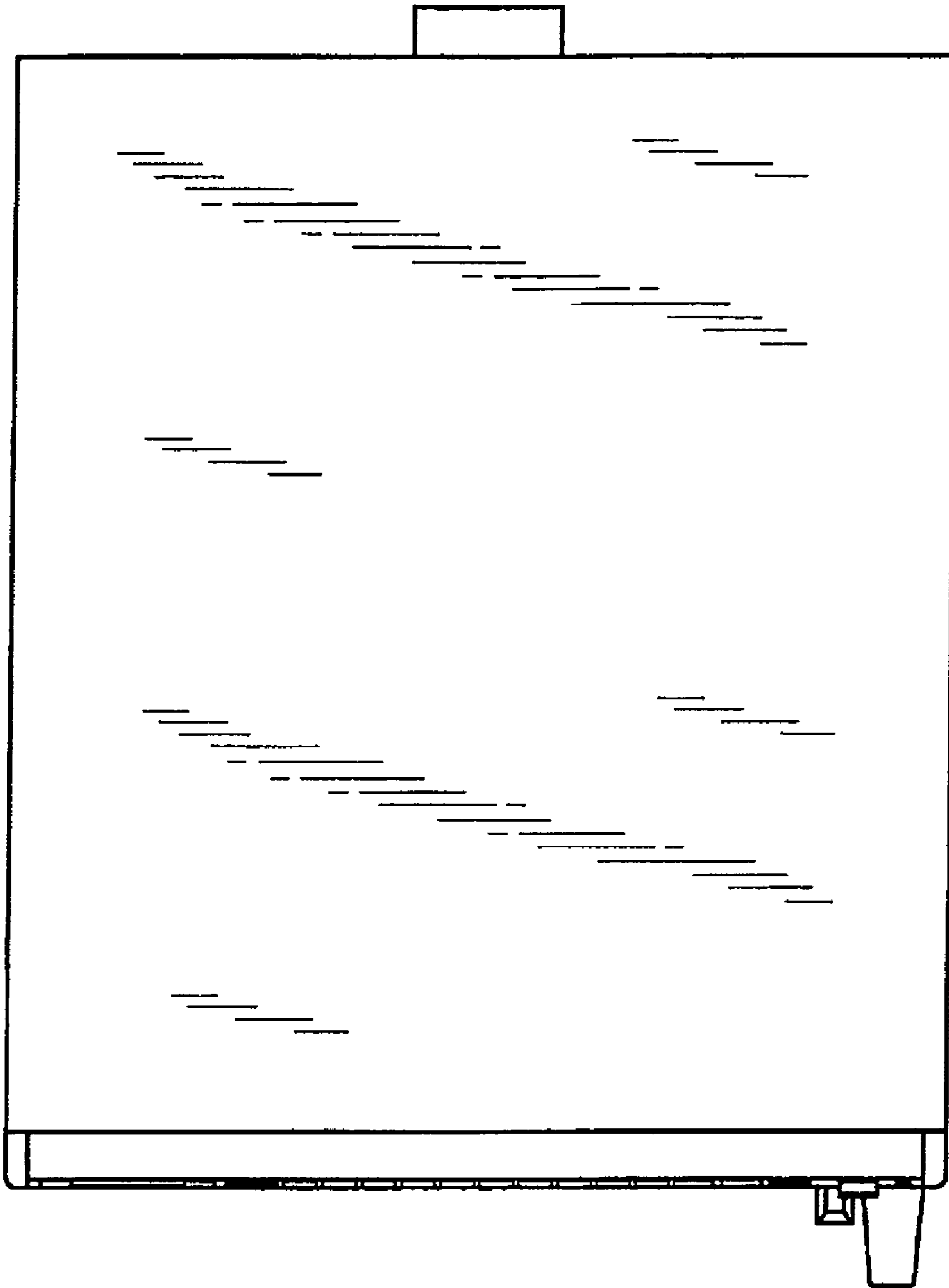

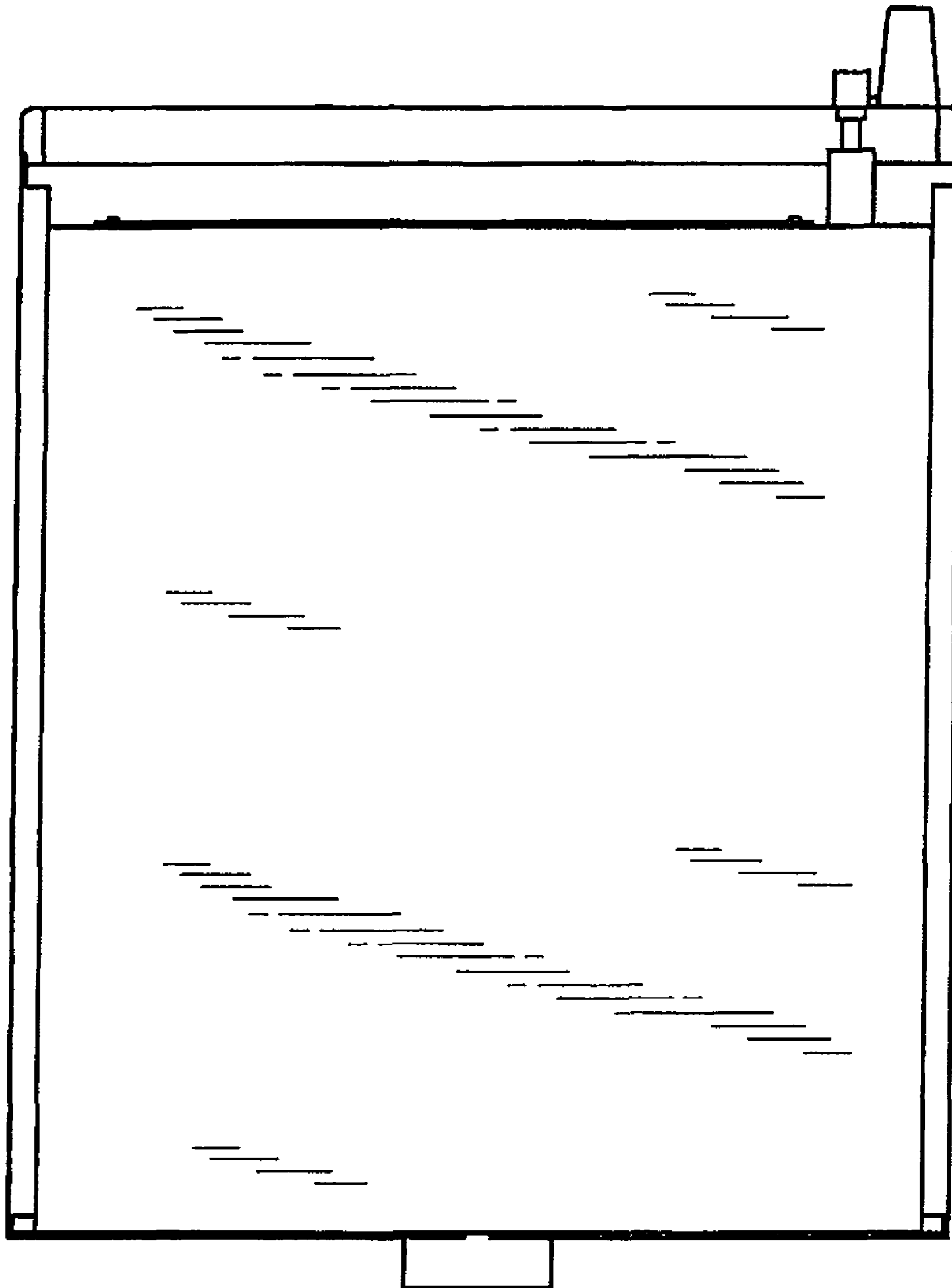

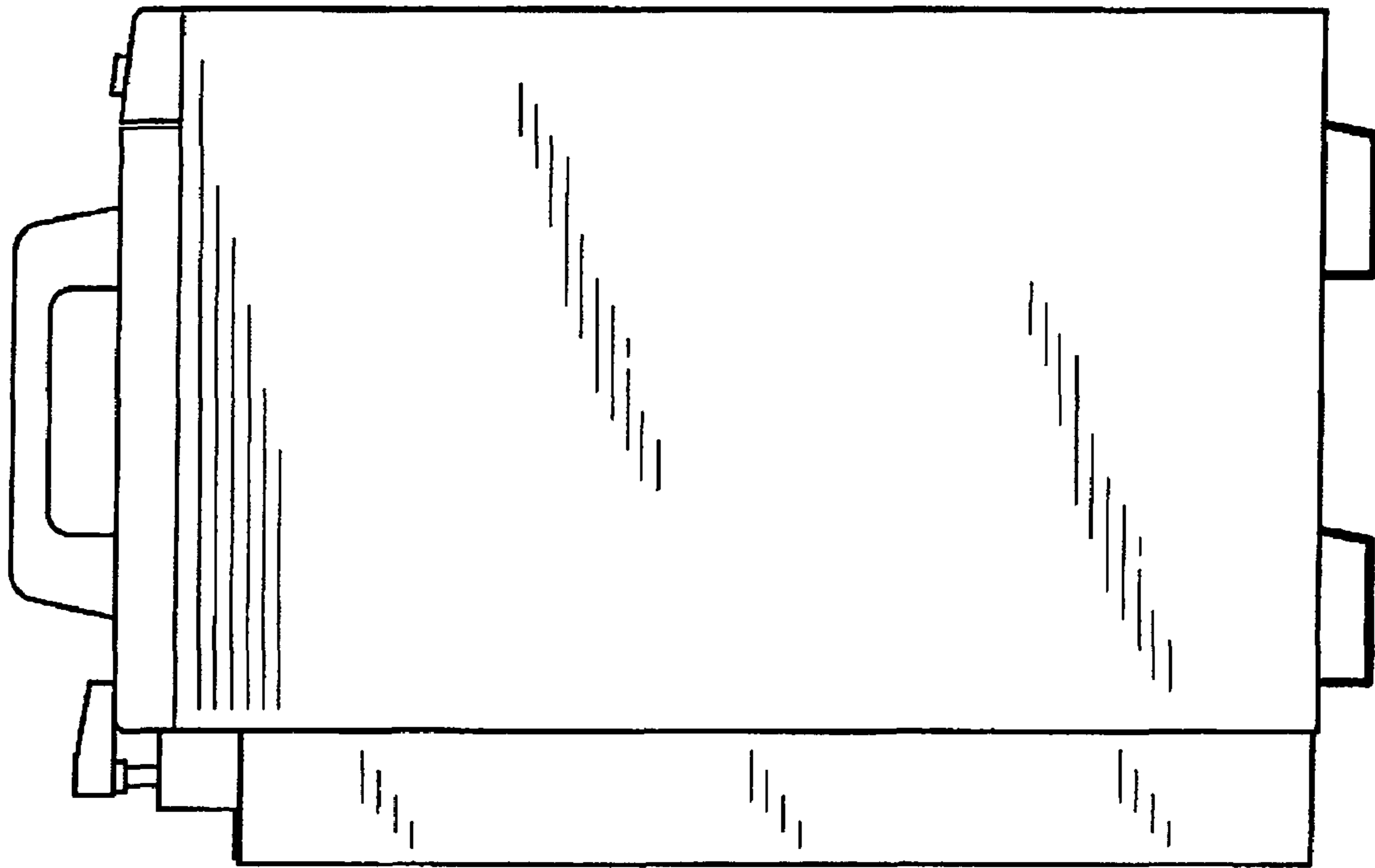

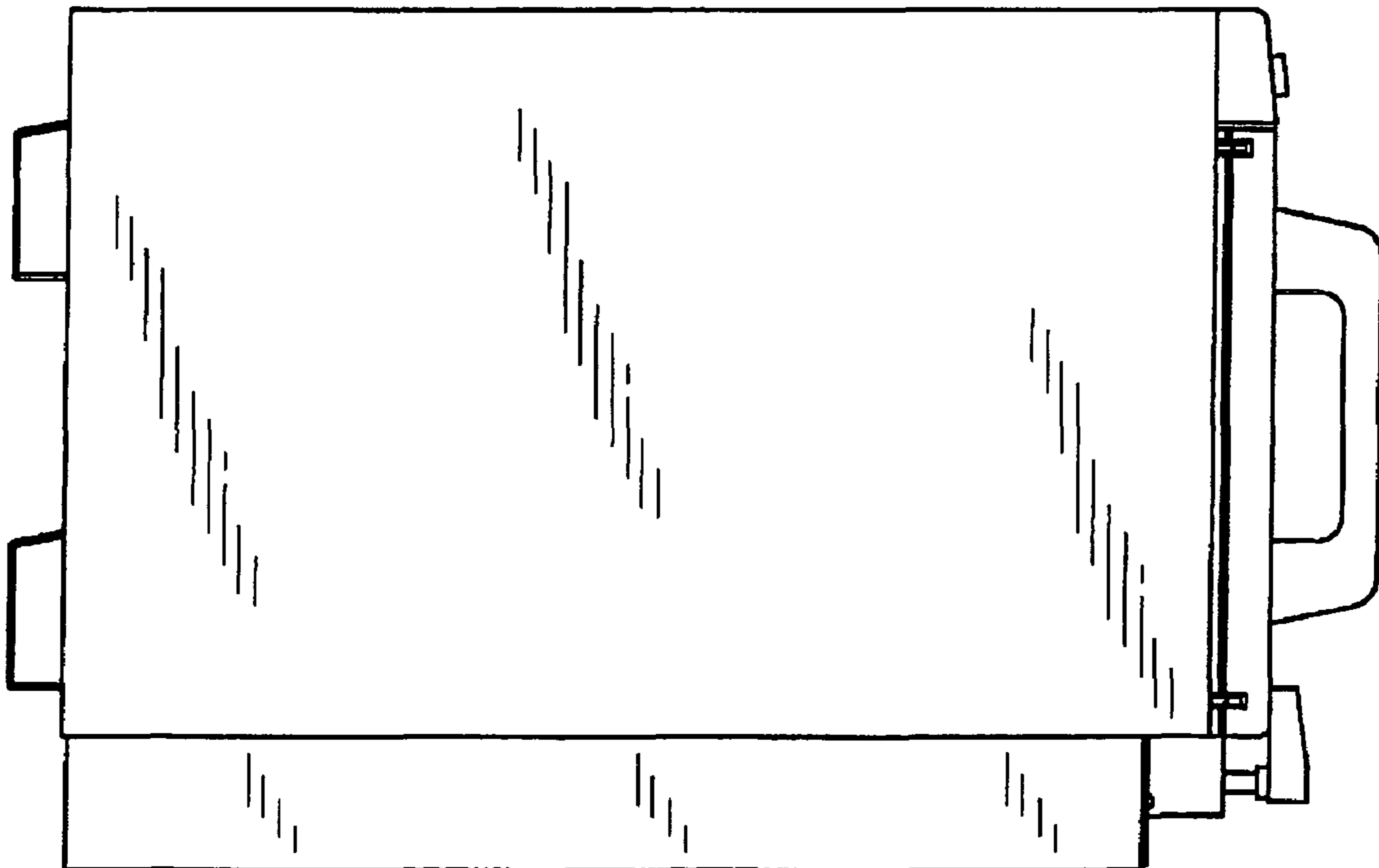

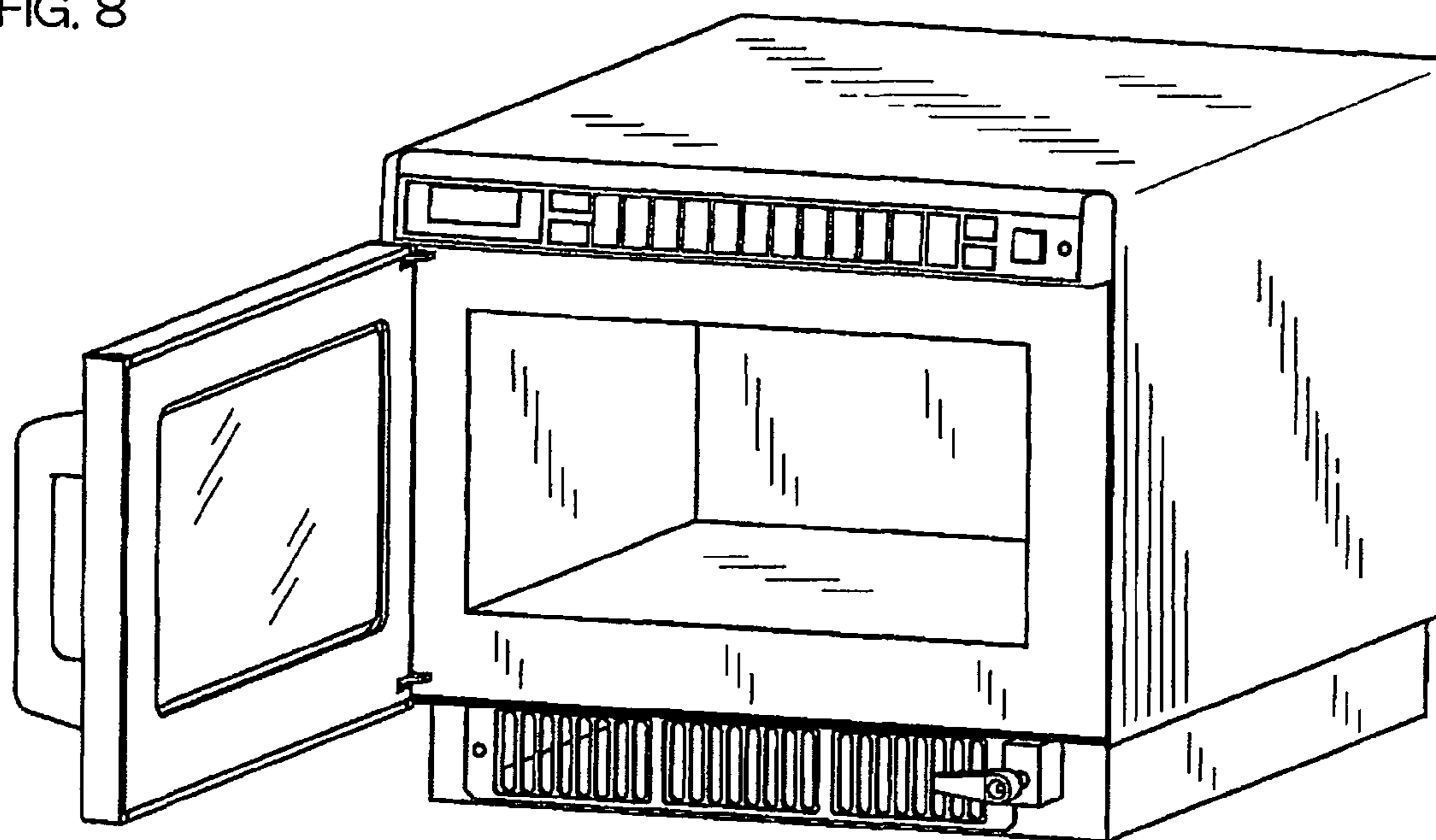
