FIG. 3 is a rear view of the cooking vessel shown in FIG. 1;

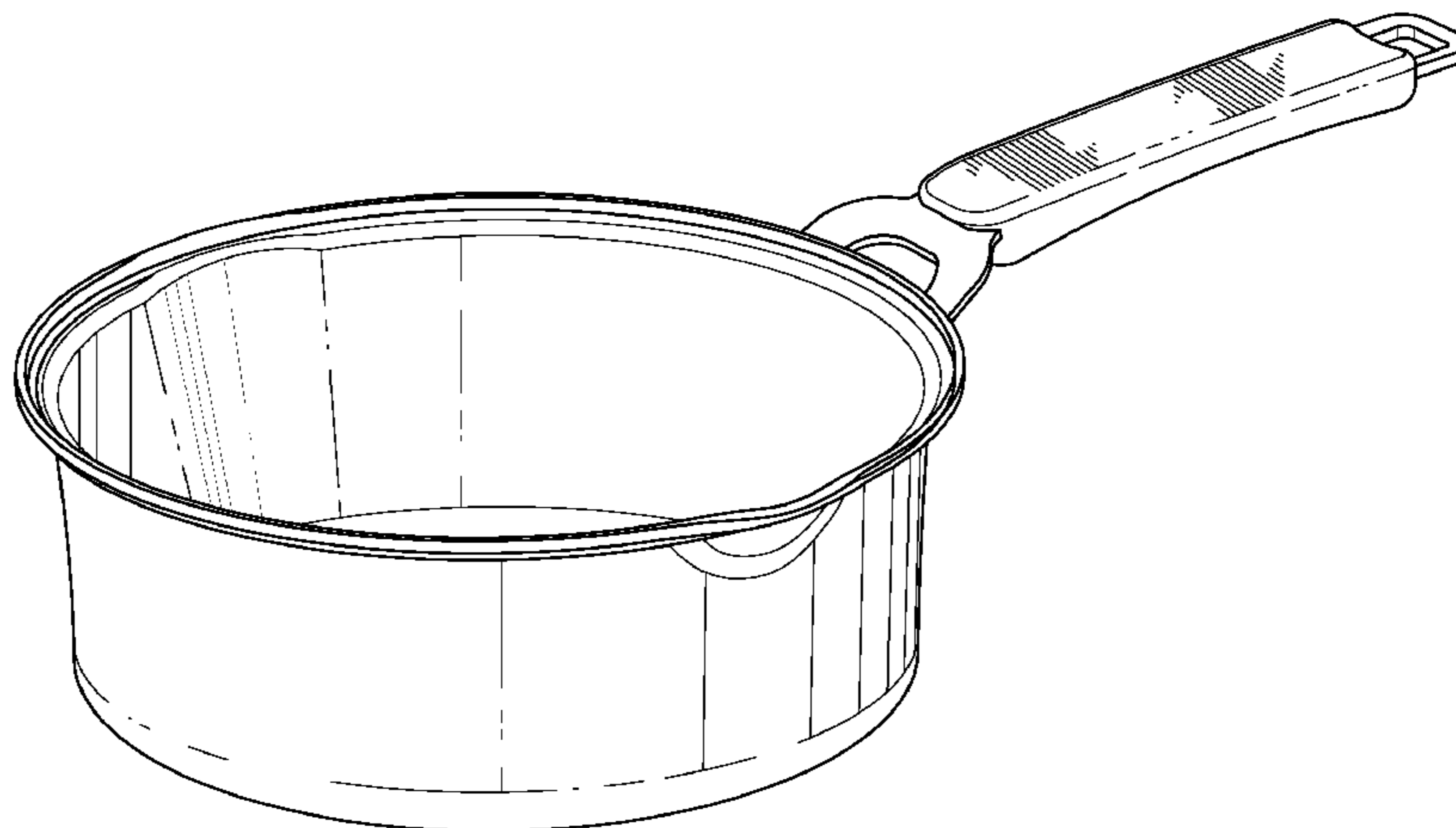
FIG. 4 is a top view of the cooking vessel shown in FIG. 1;

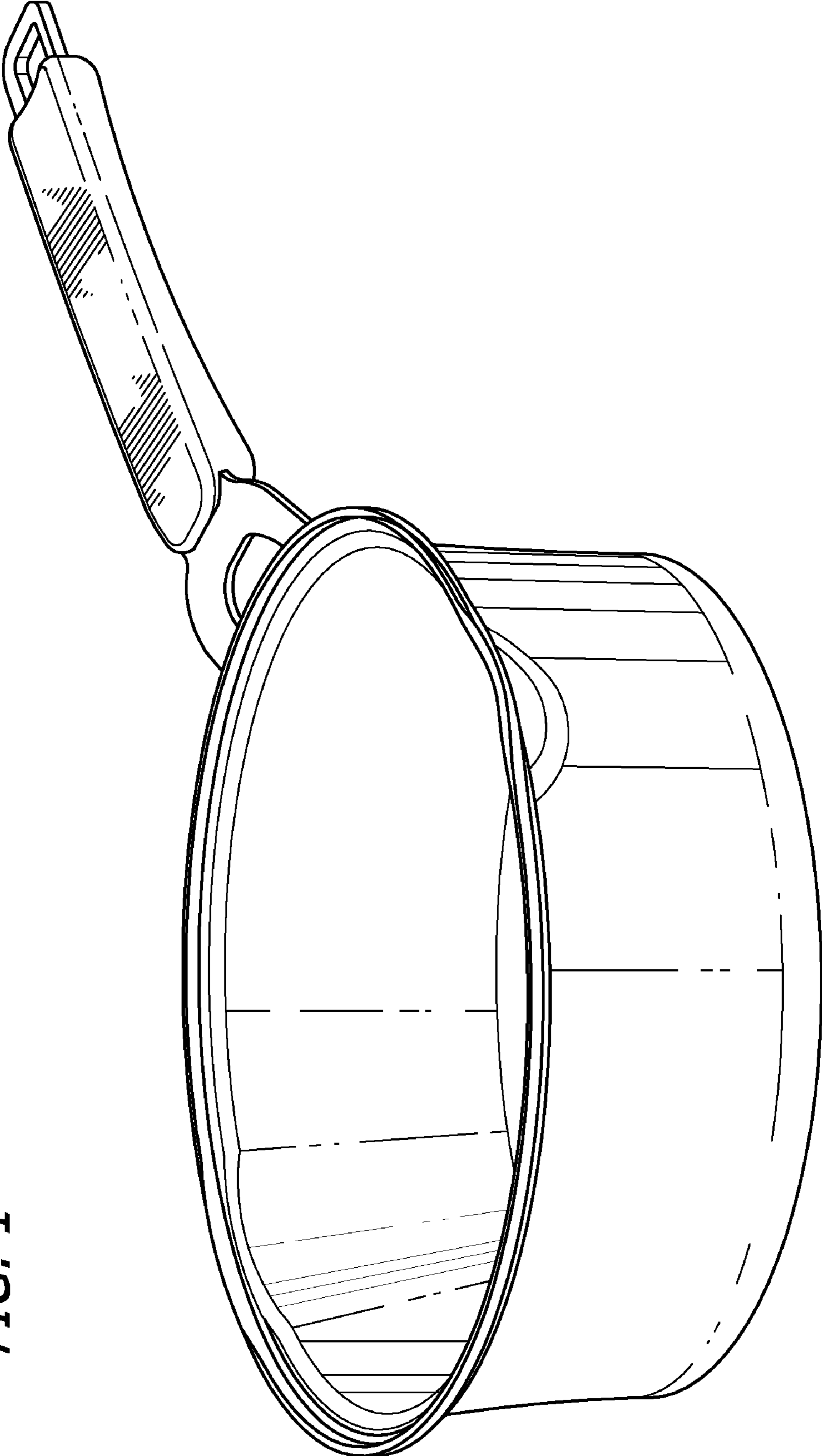

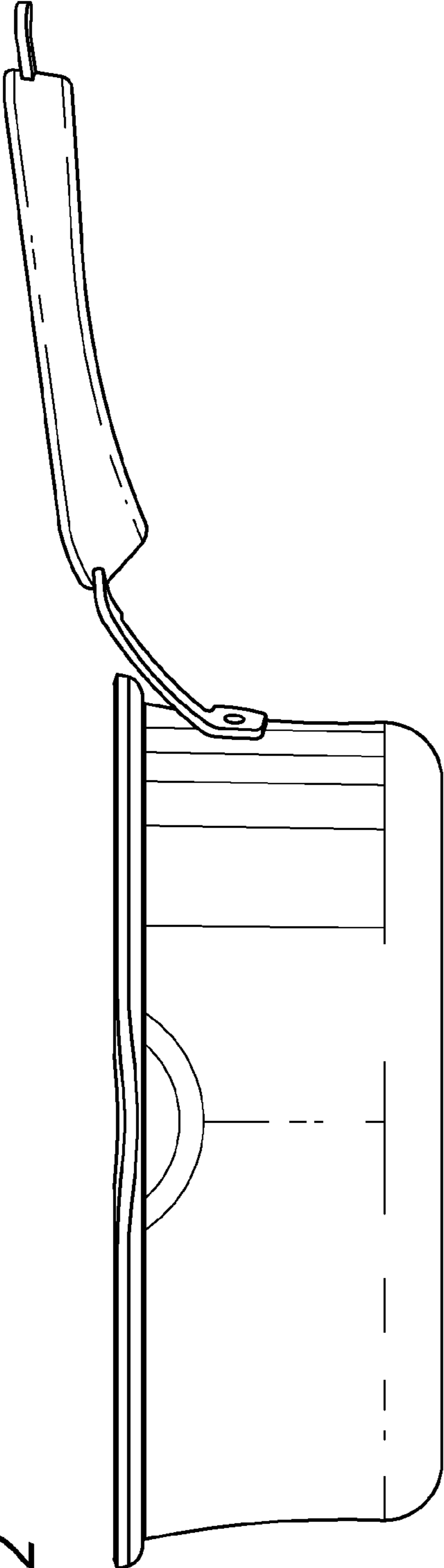
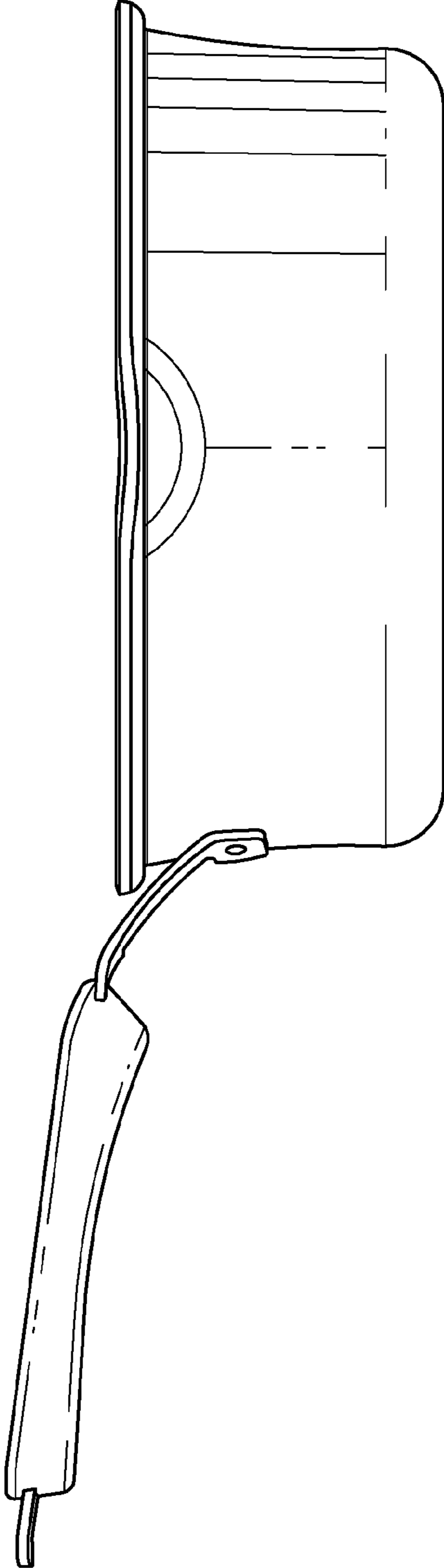

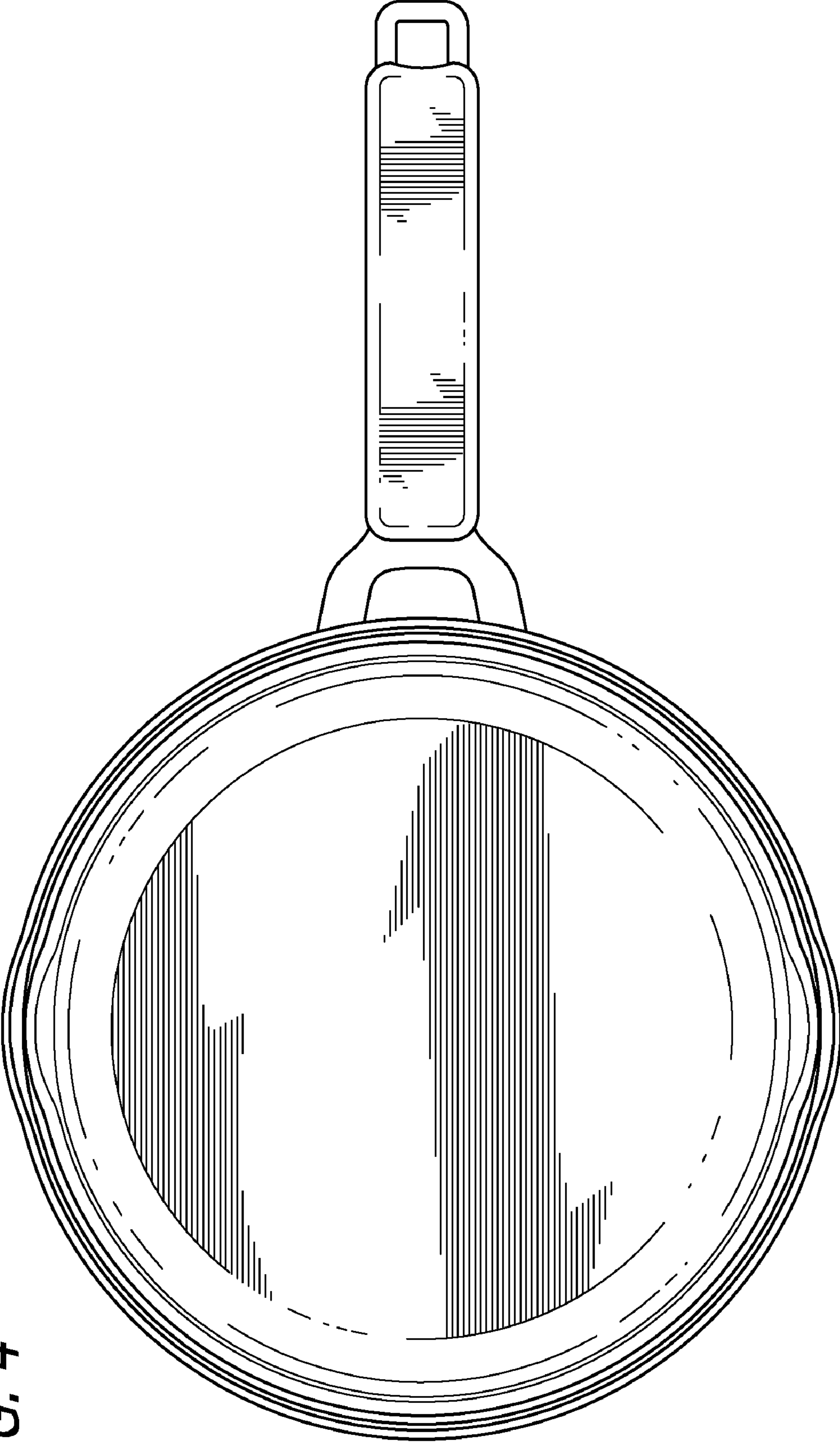

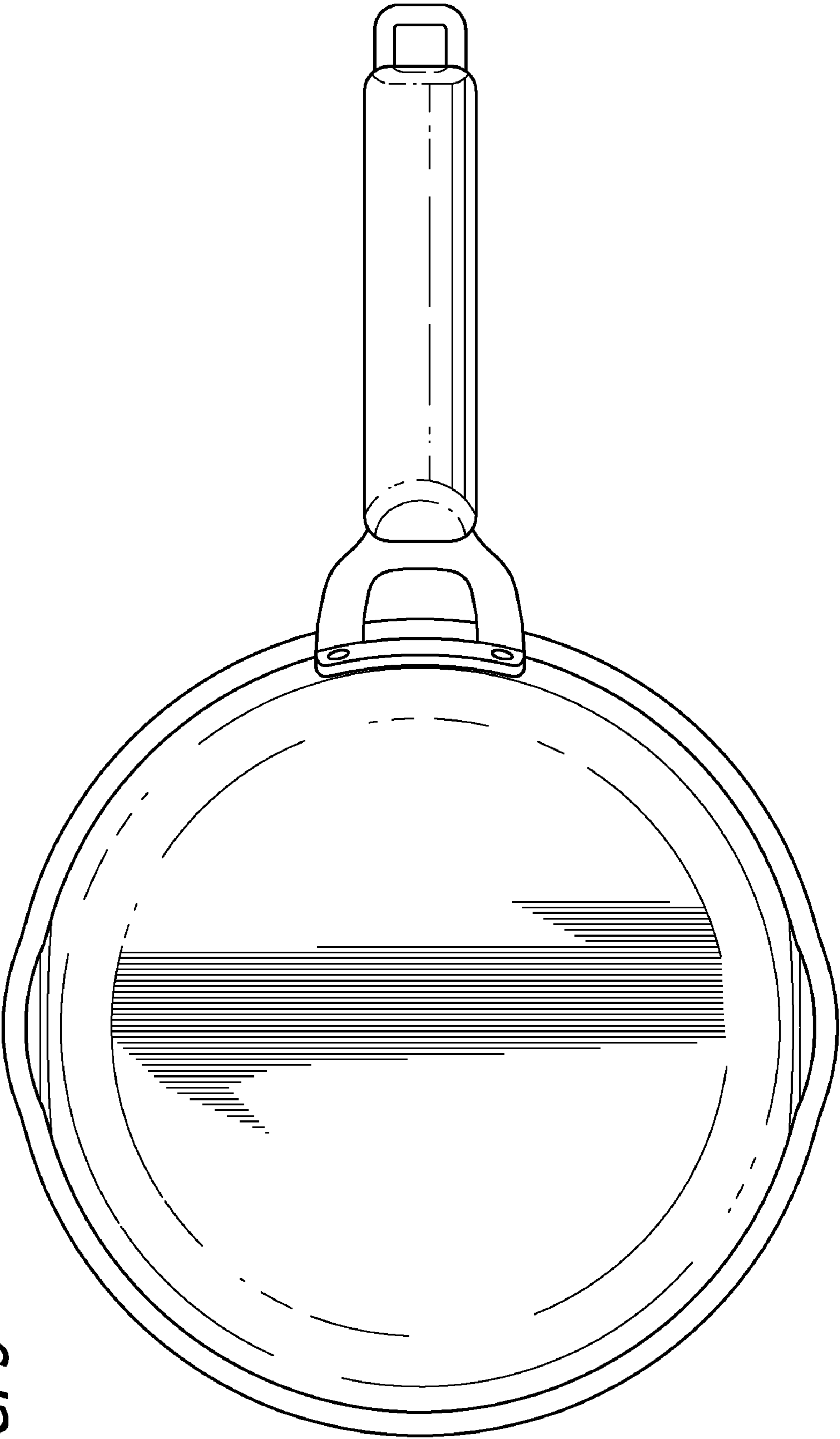
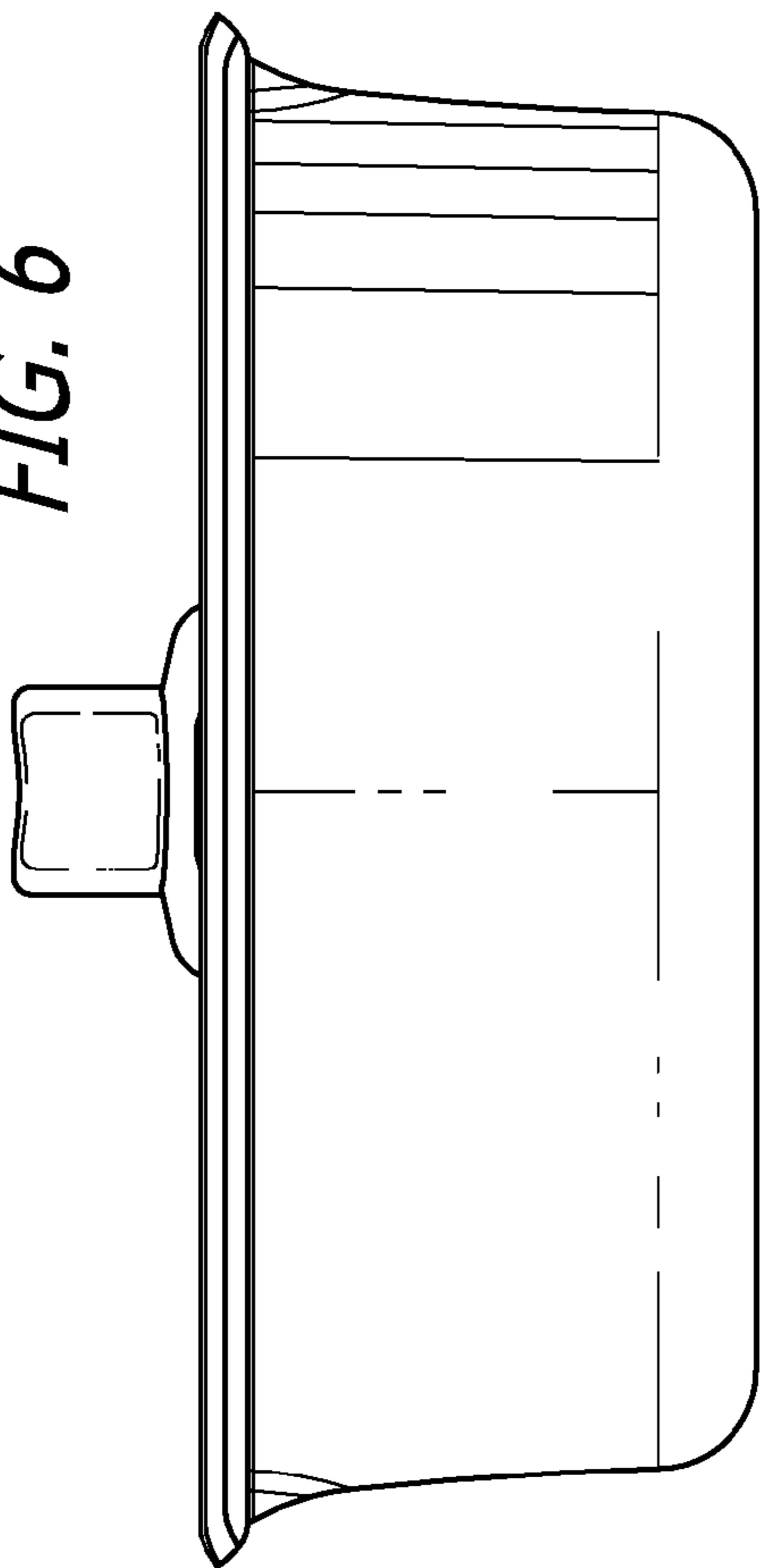
