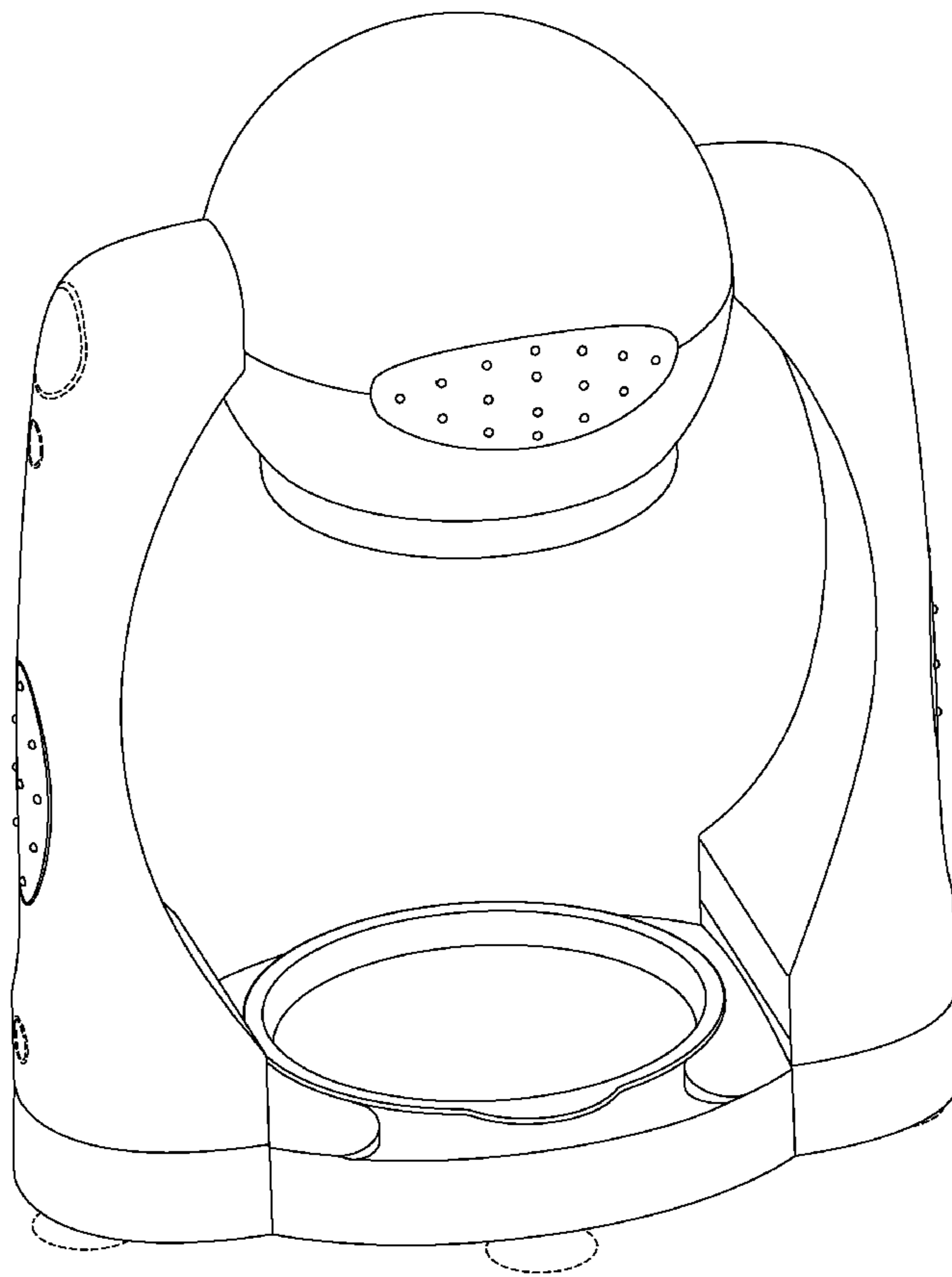
The ornamental design for a smoothie maker, as shown and described.

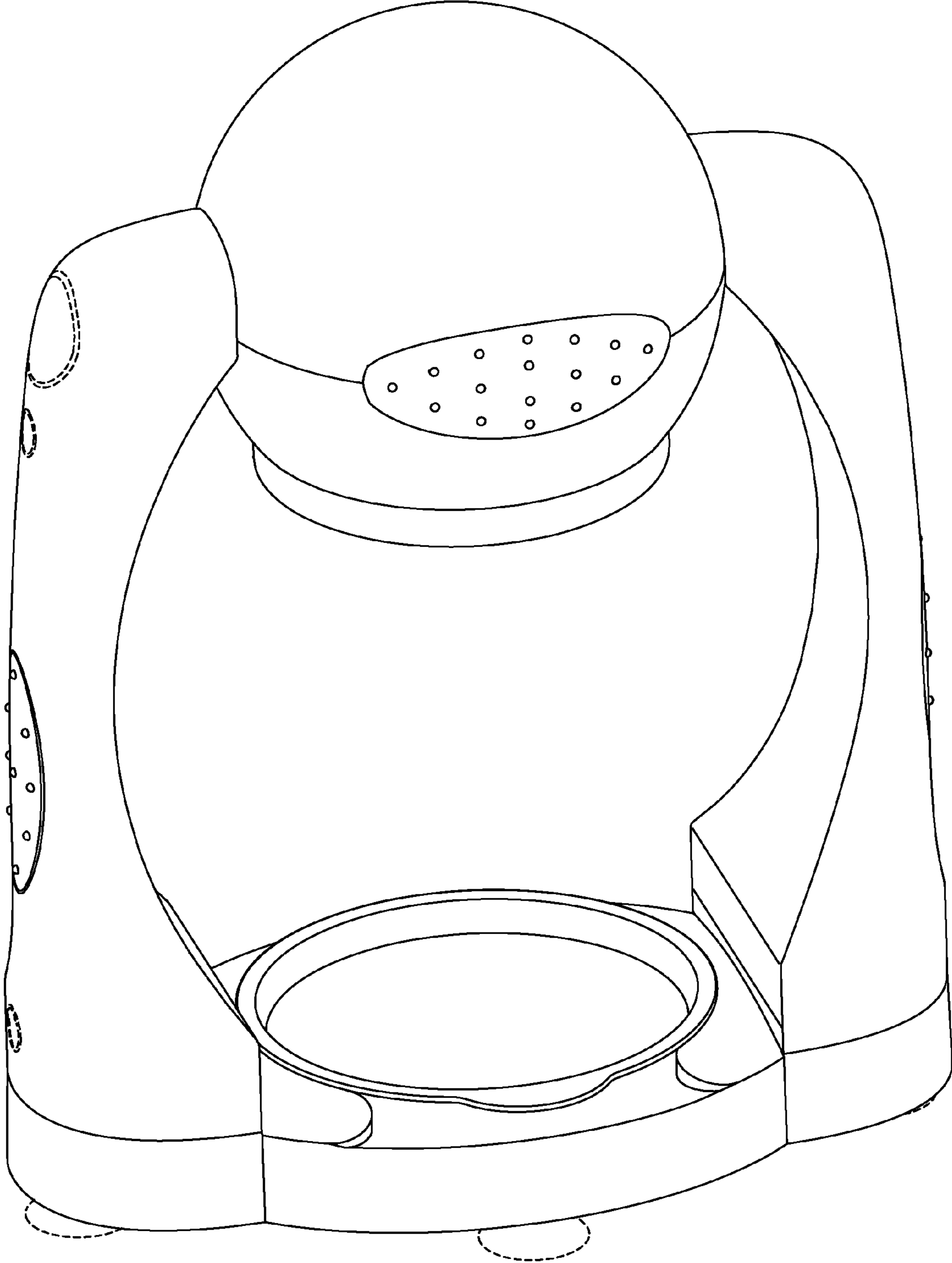

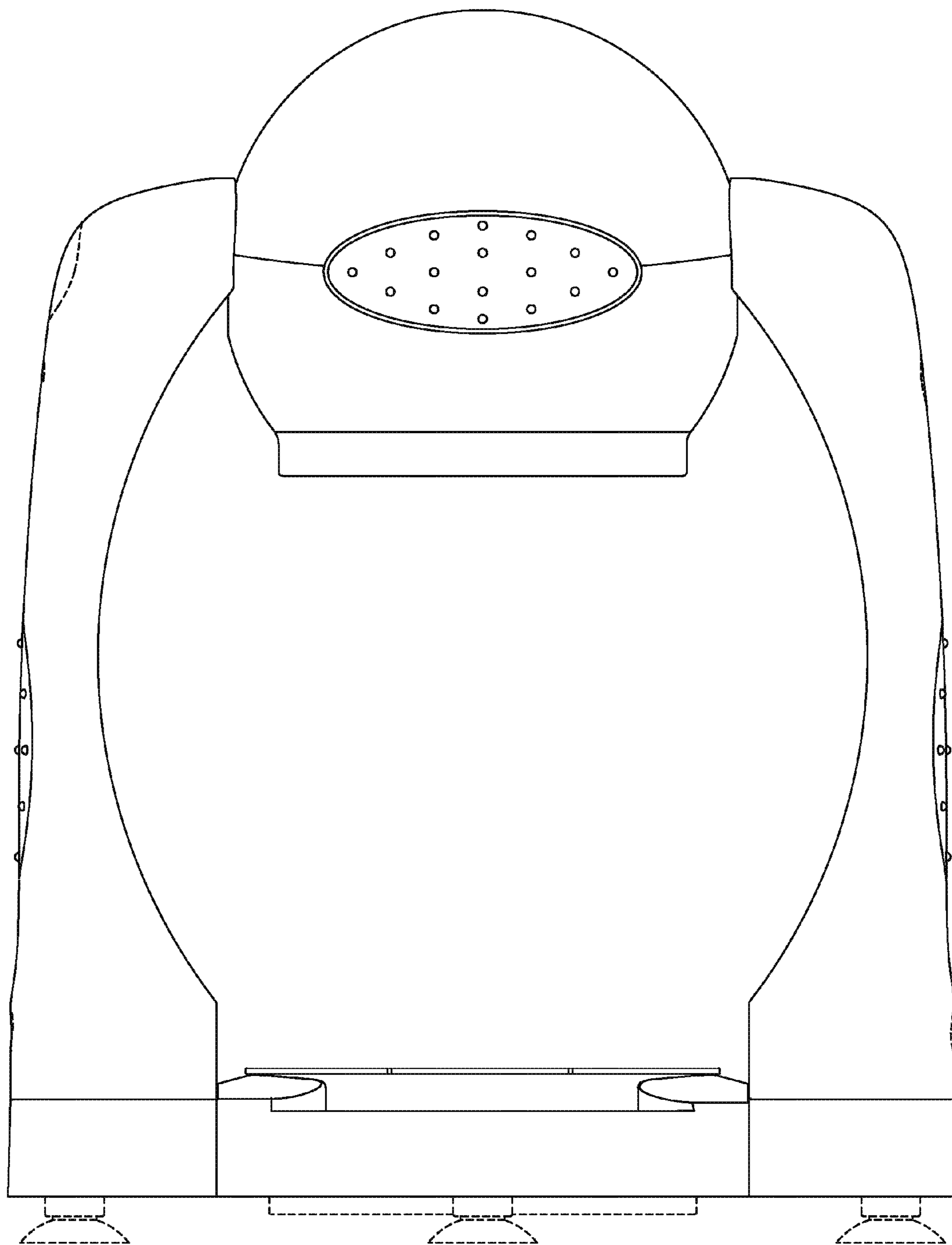

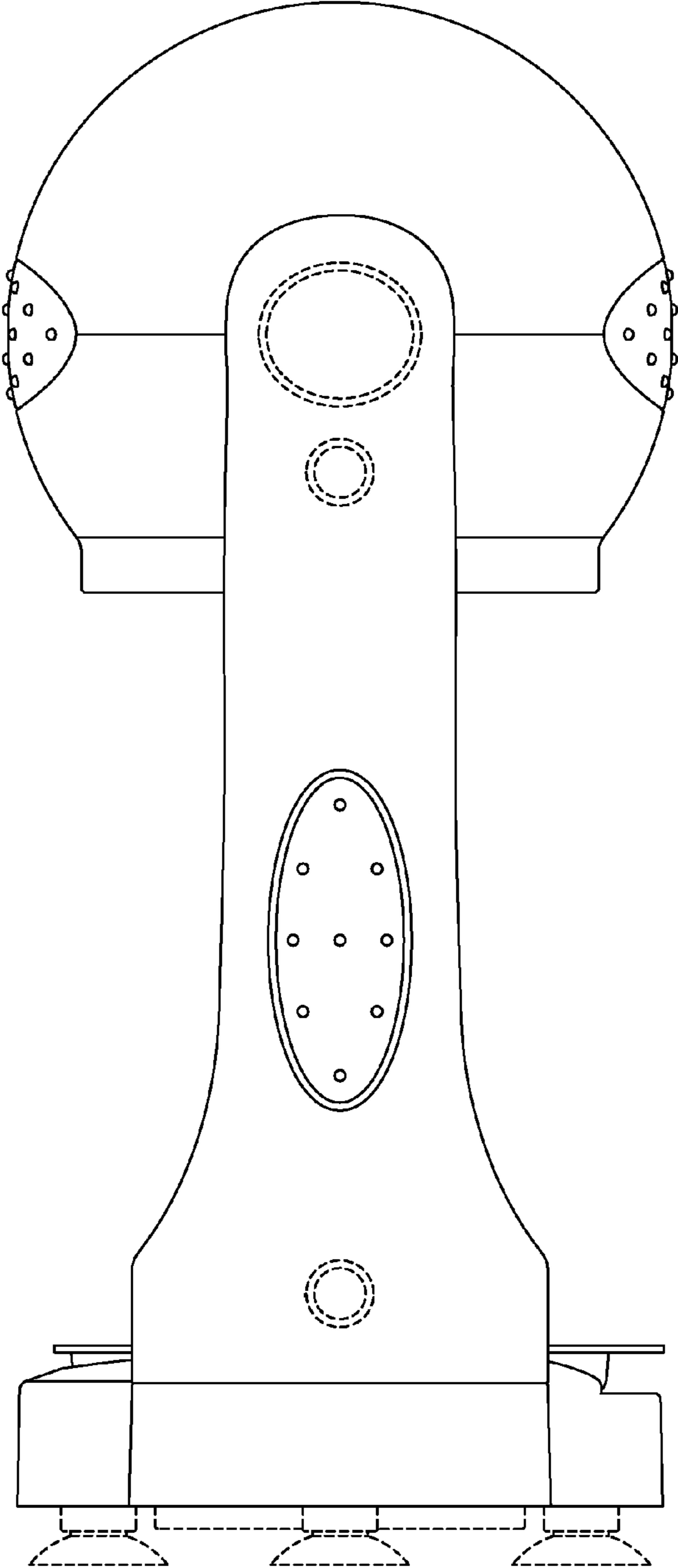

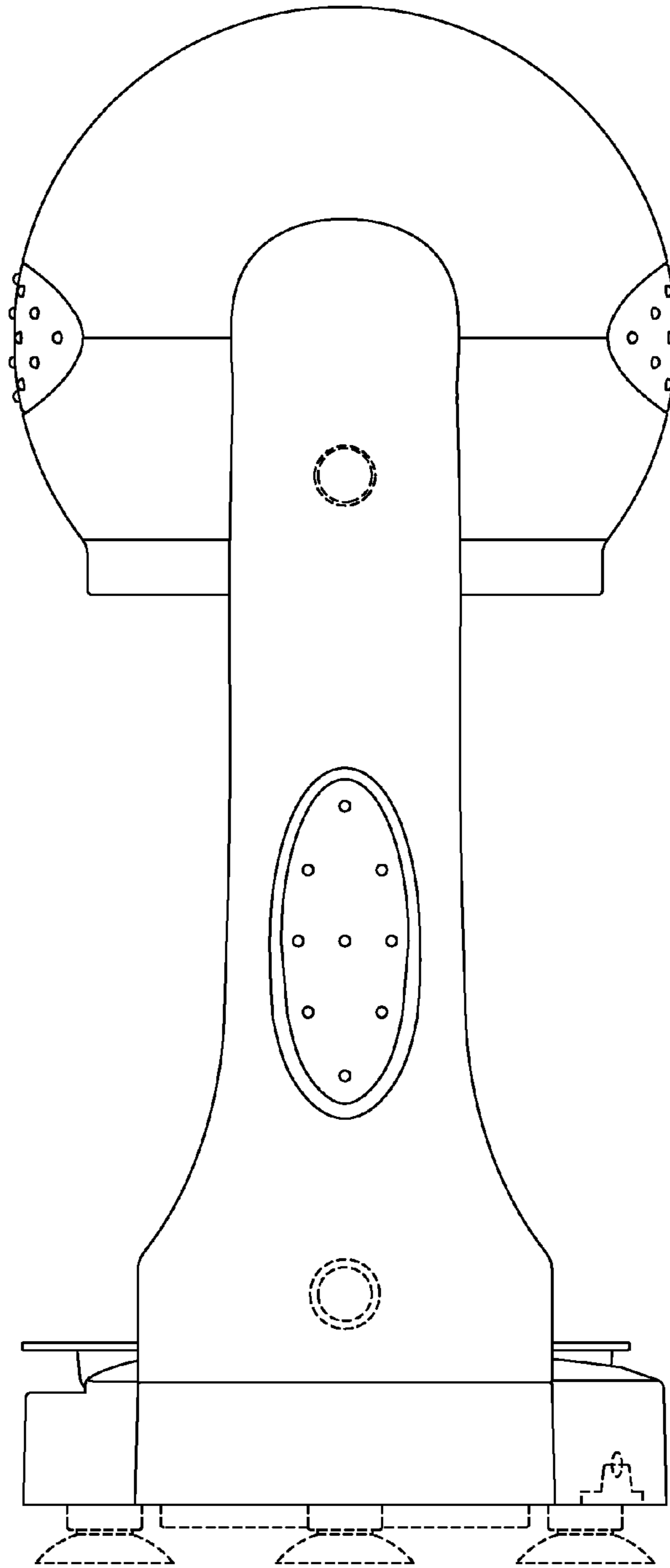

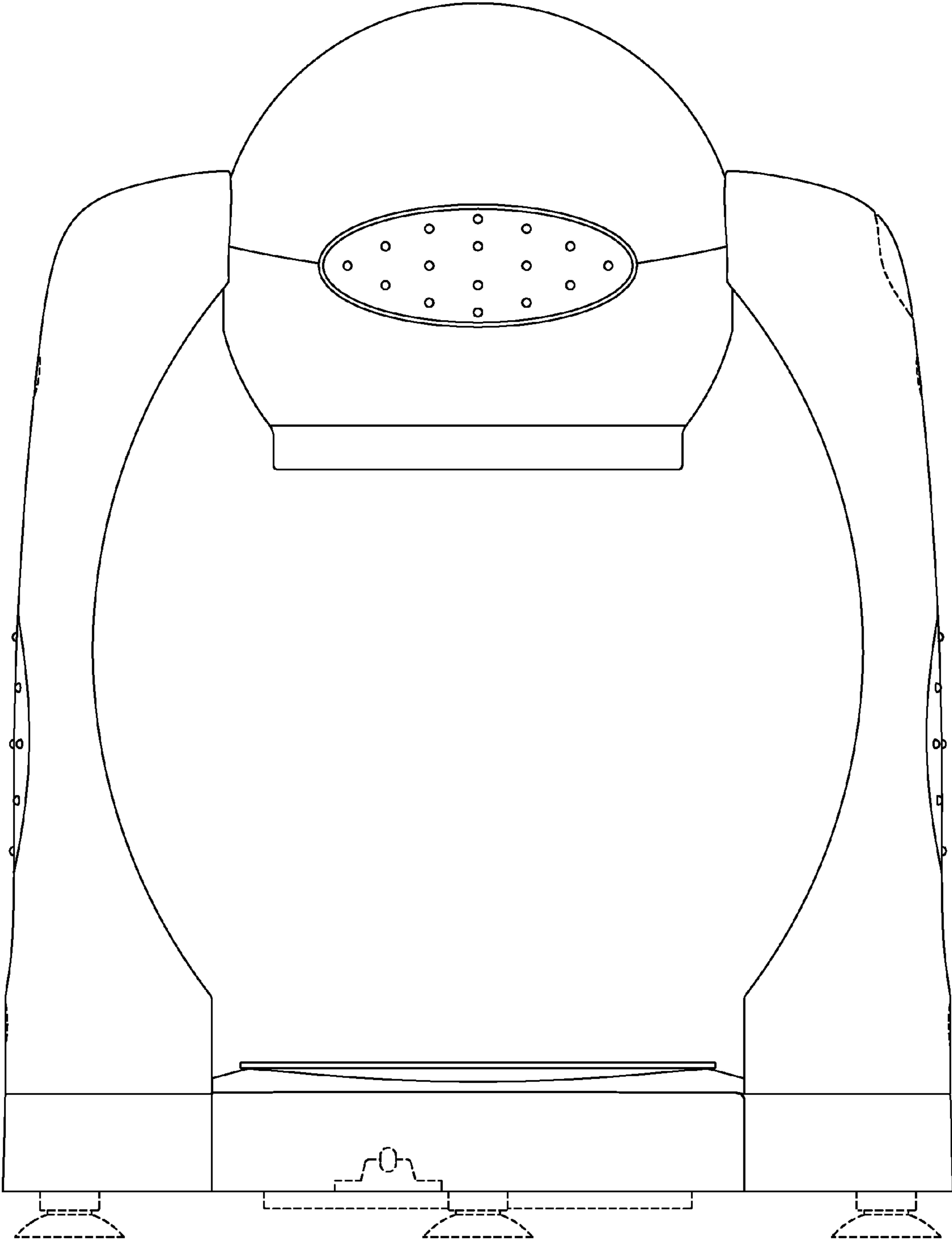

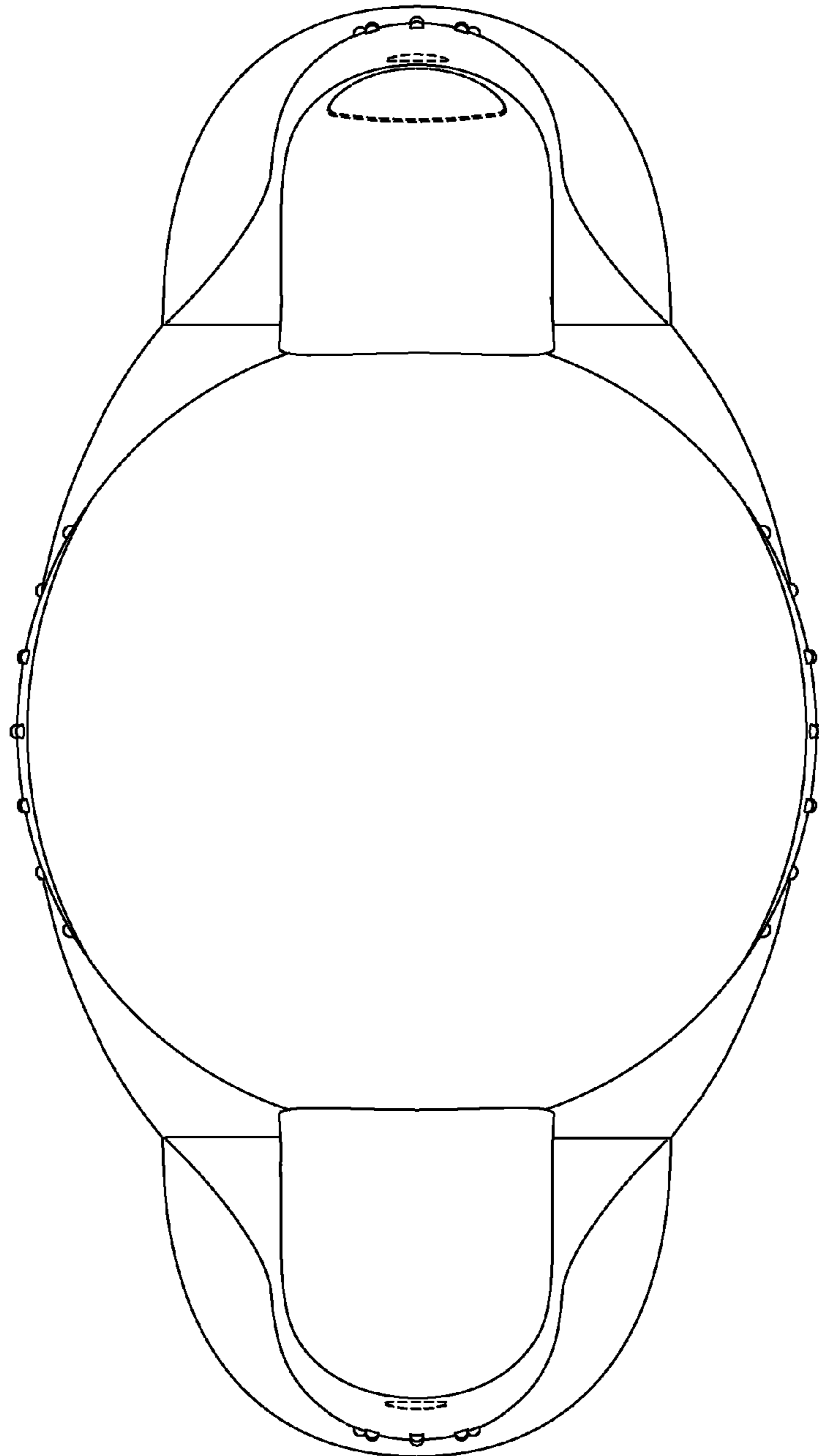
