(57) **CLAIM**

The ornamental design for a plate, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a plate showing our new design;

FIG. 2 is a bottom, perspective view thereof;

FIG. 3 is a top view thereof;

FIG. 4 is a bottom view thereof;

FIG. 5 is a right side view thereof, the left side view being a mirror image of the right side view;

FIG. 6 is a front view thereof;

FIG. 7 is a rear view thereof; and,

FIG. 8 is a cross-sectional view thereof taken about the line 8—8 illustrated in FIG. 3.

FIG. 9 is a top perspective view of a modified embodiment of the design shown in FIGS. 1 through 8 with the partially drawn surface texture representing an overall pattern;

FIG. 10 is a bottom, perspective view thereof;

FIG. 11 is a top view thereof;

FIG. 12 is a bottom view thereof;

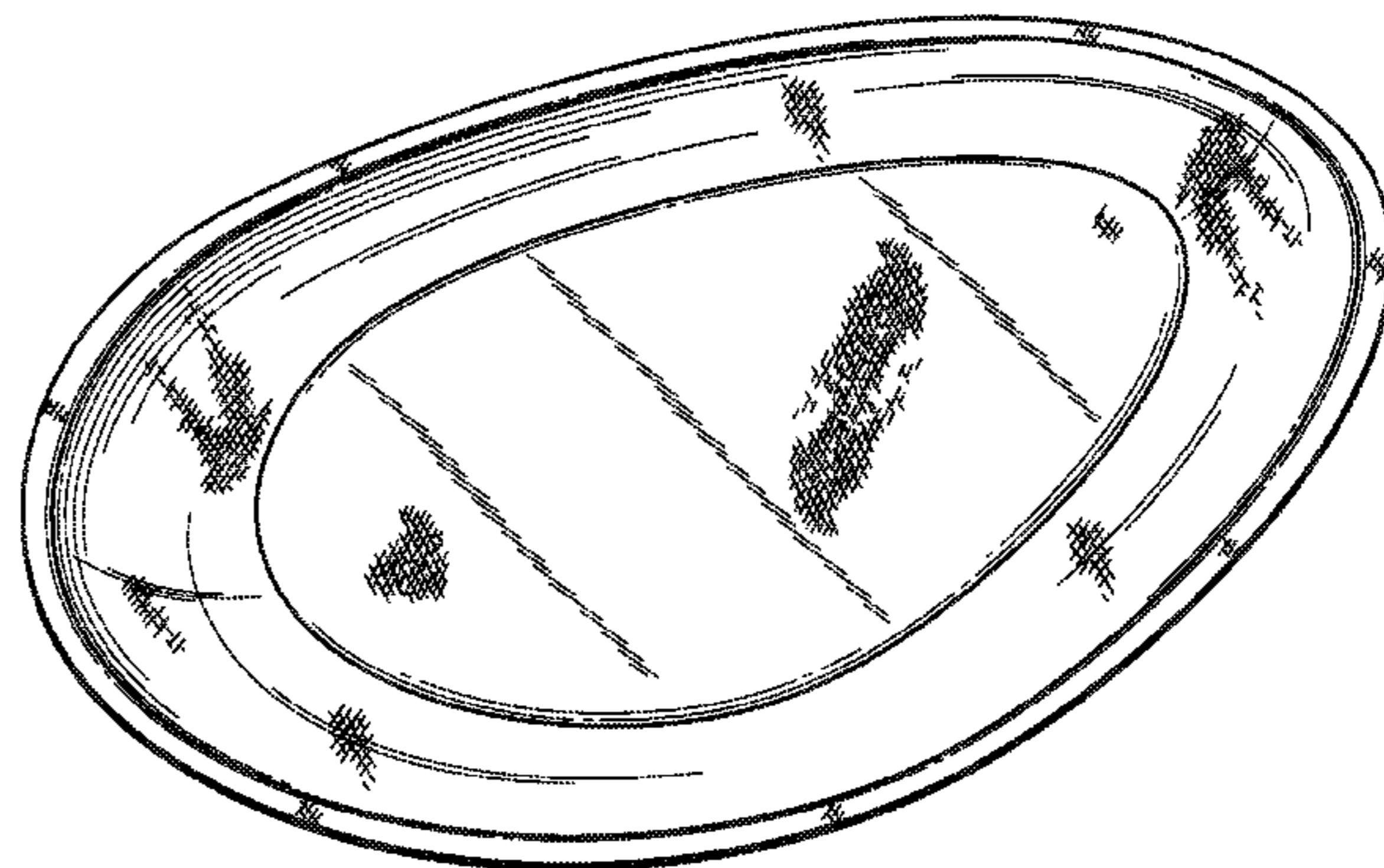
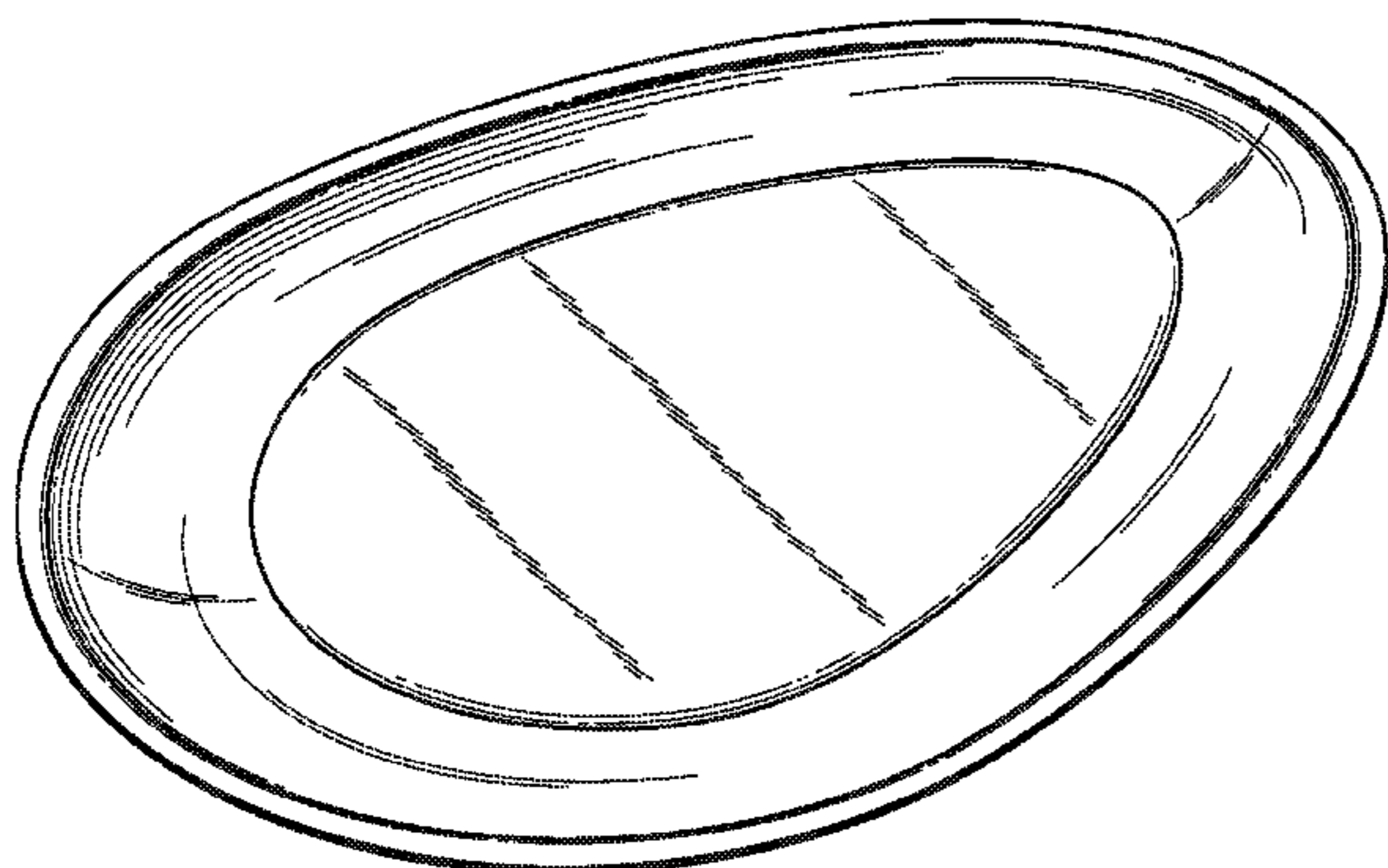
FIG. 13 is a right side view thereof, the left side view being a mirror image of the right side view;

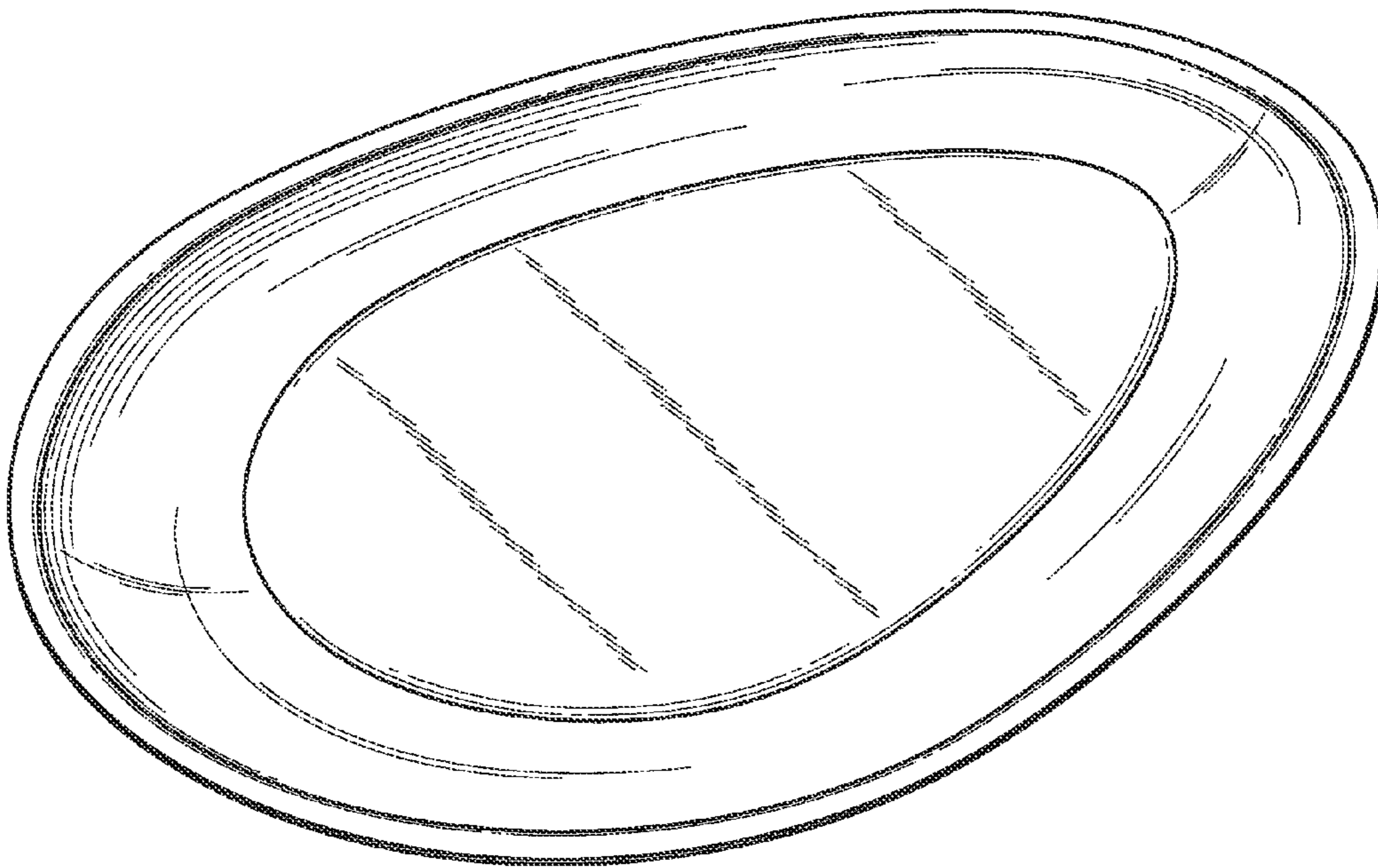

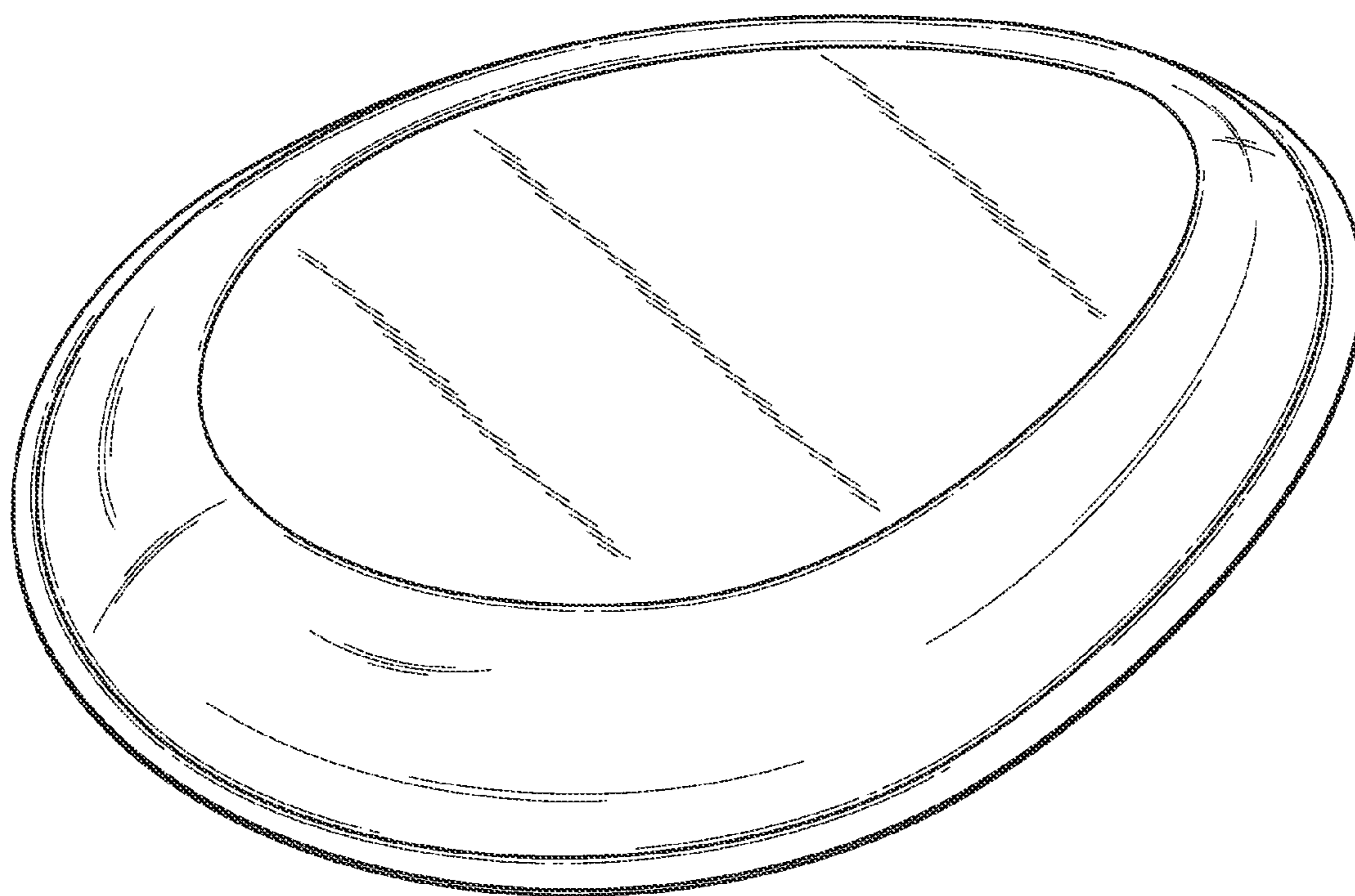

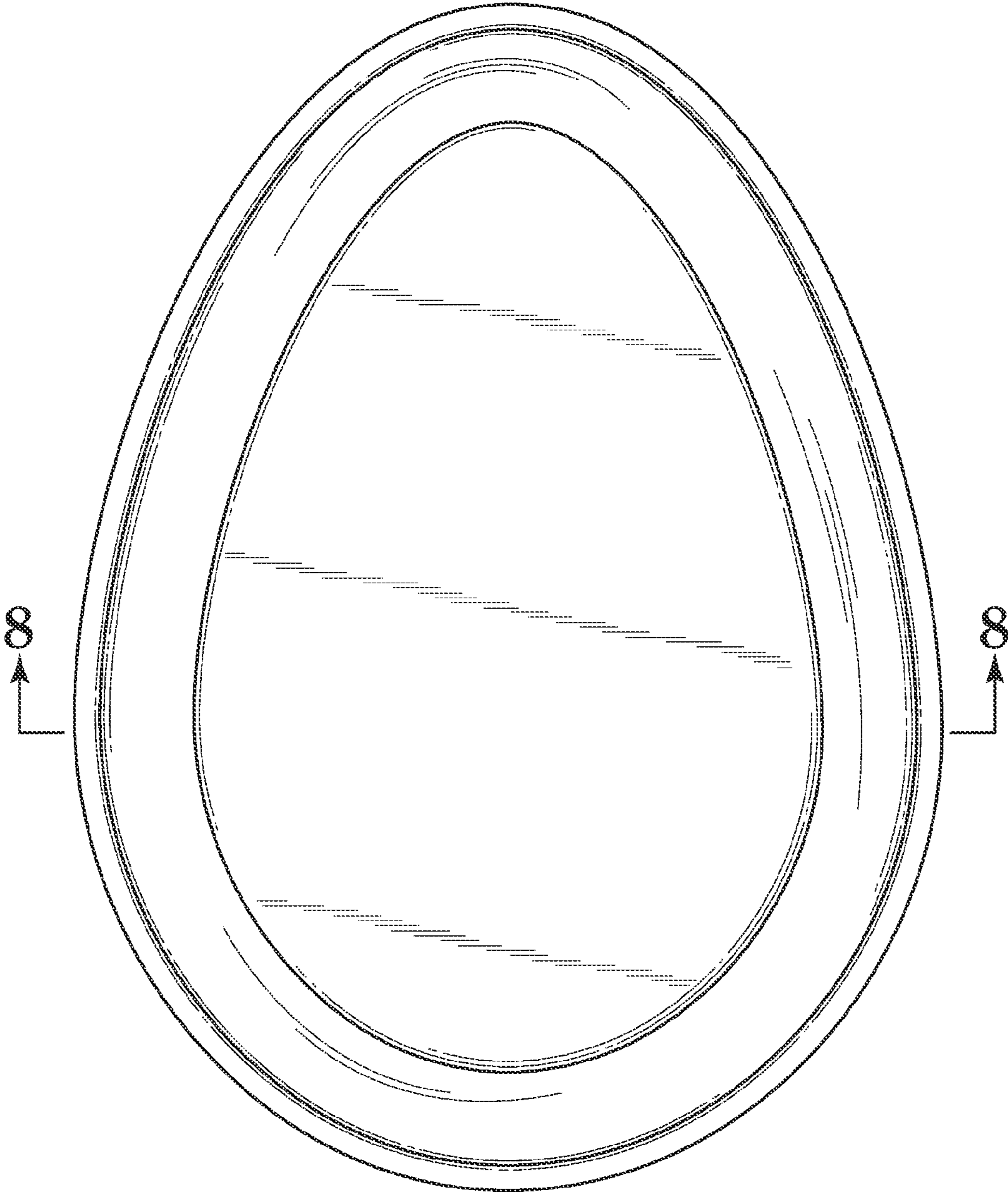

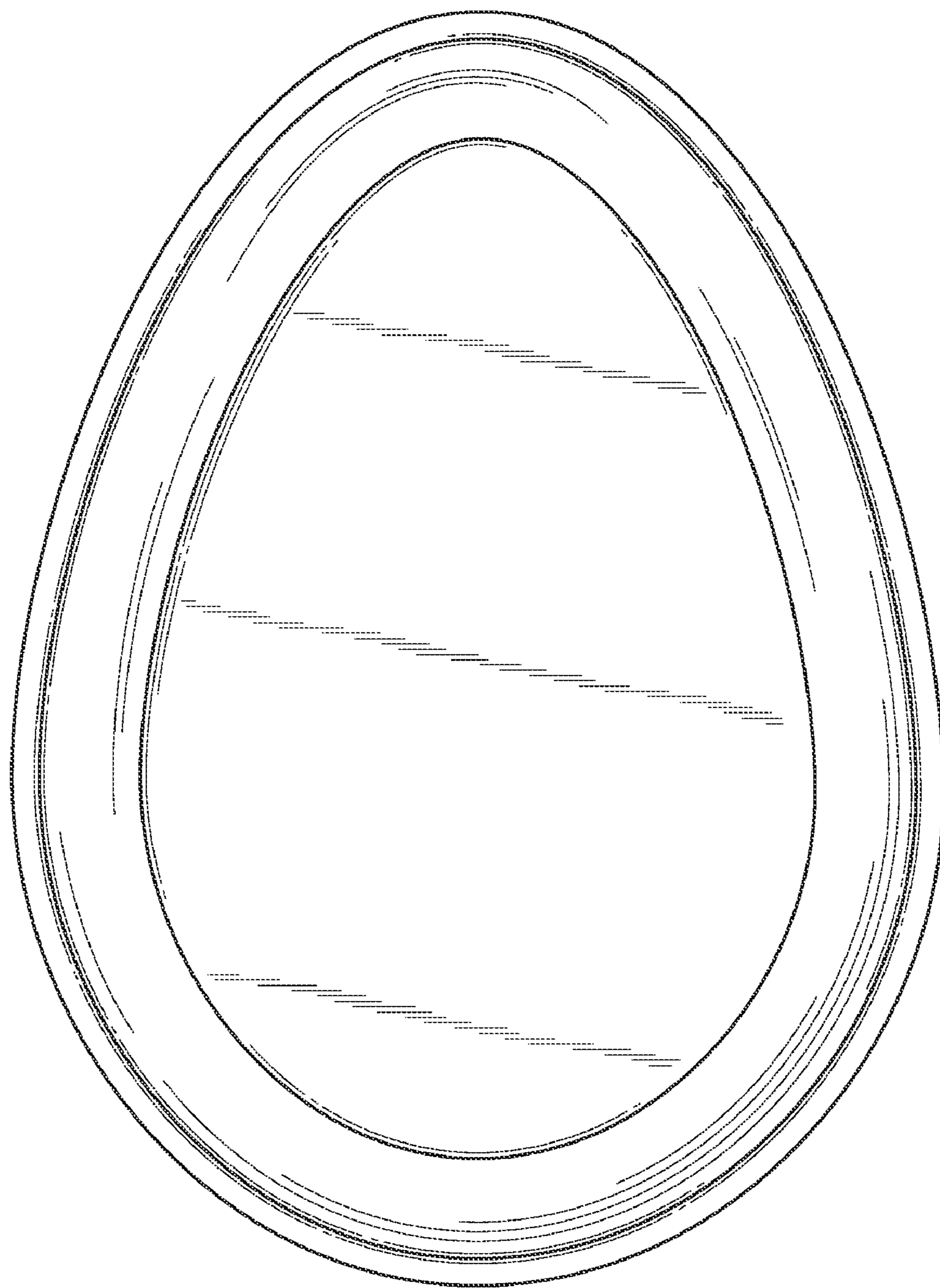

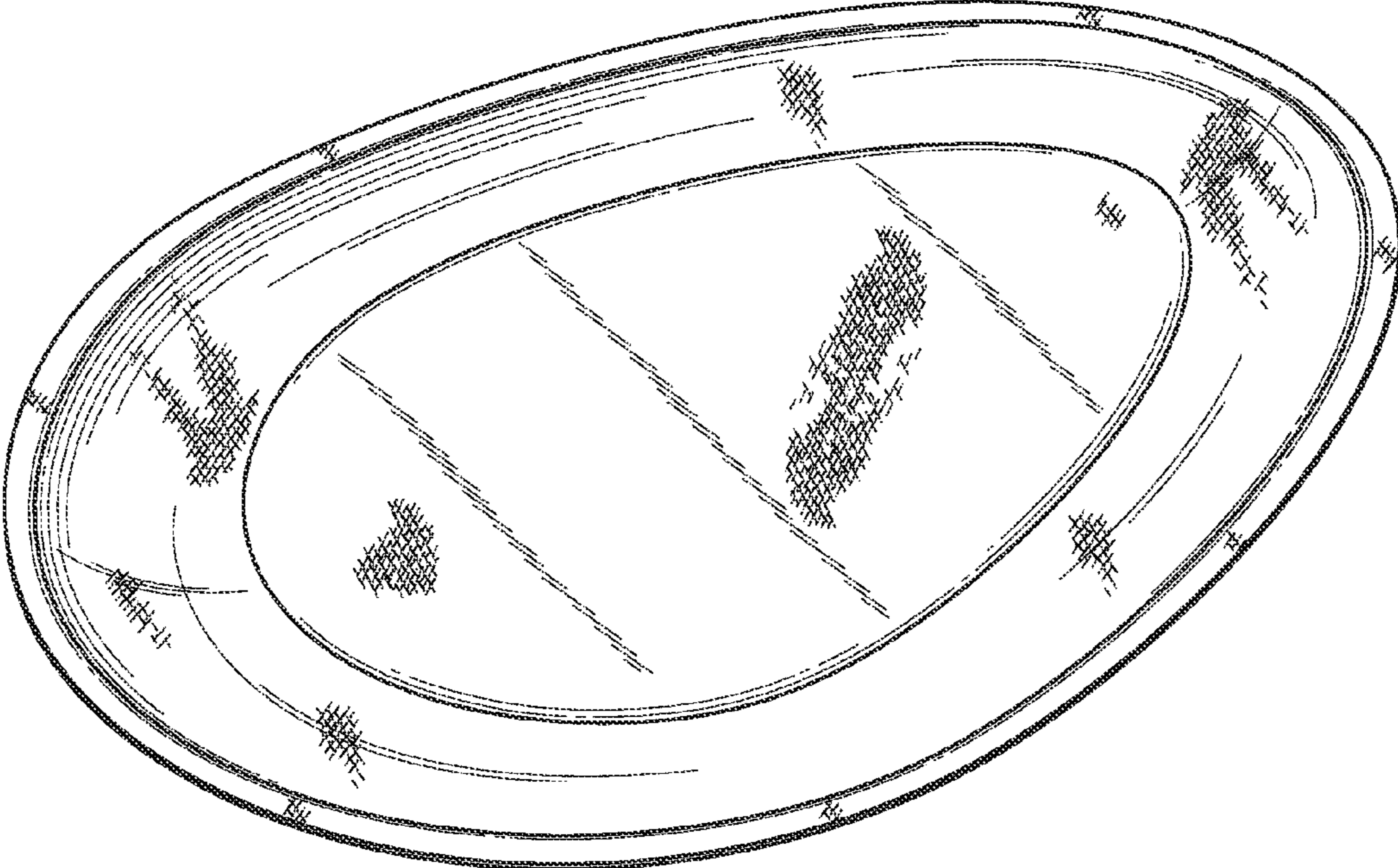

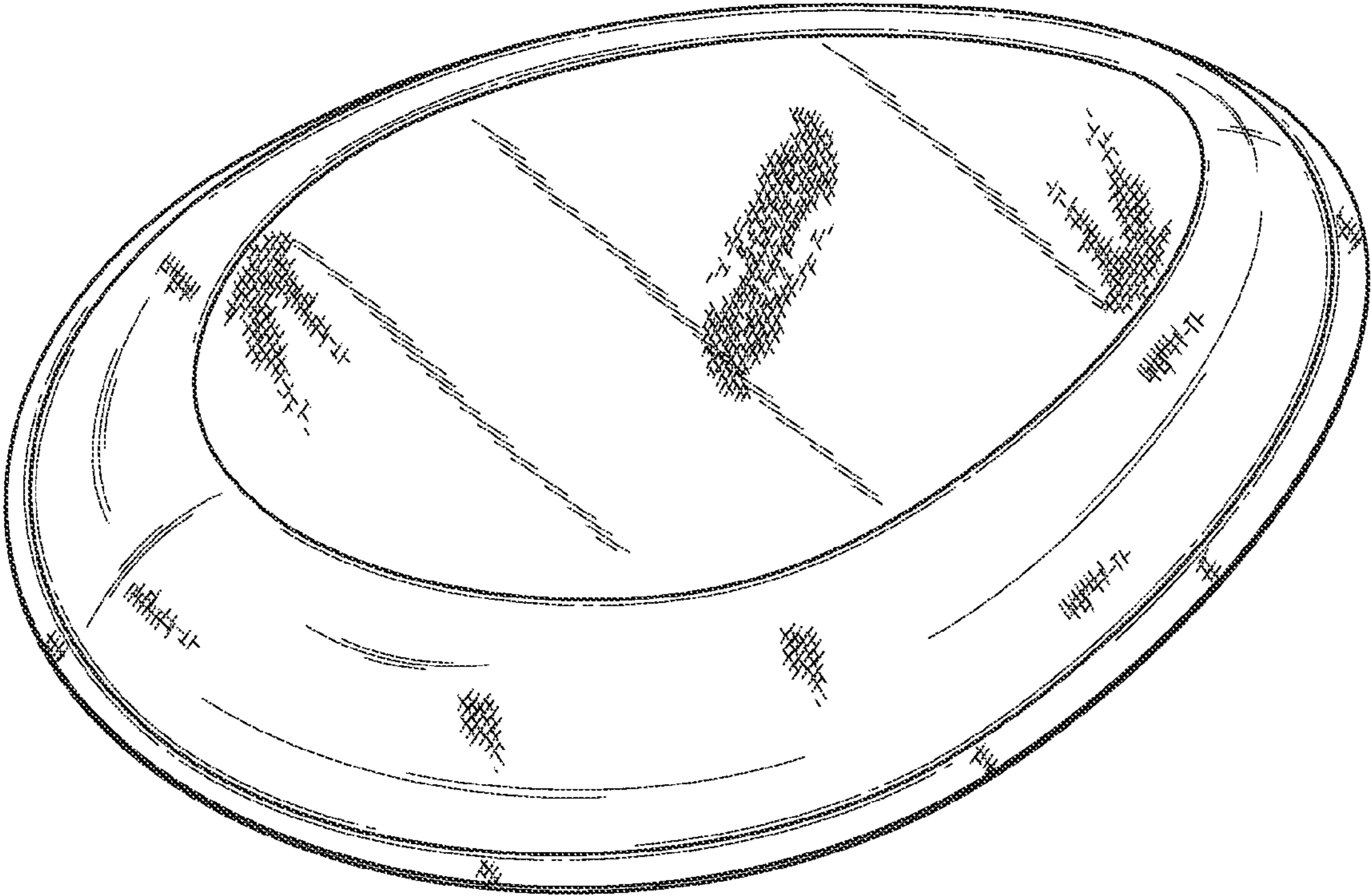

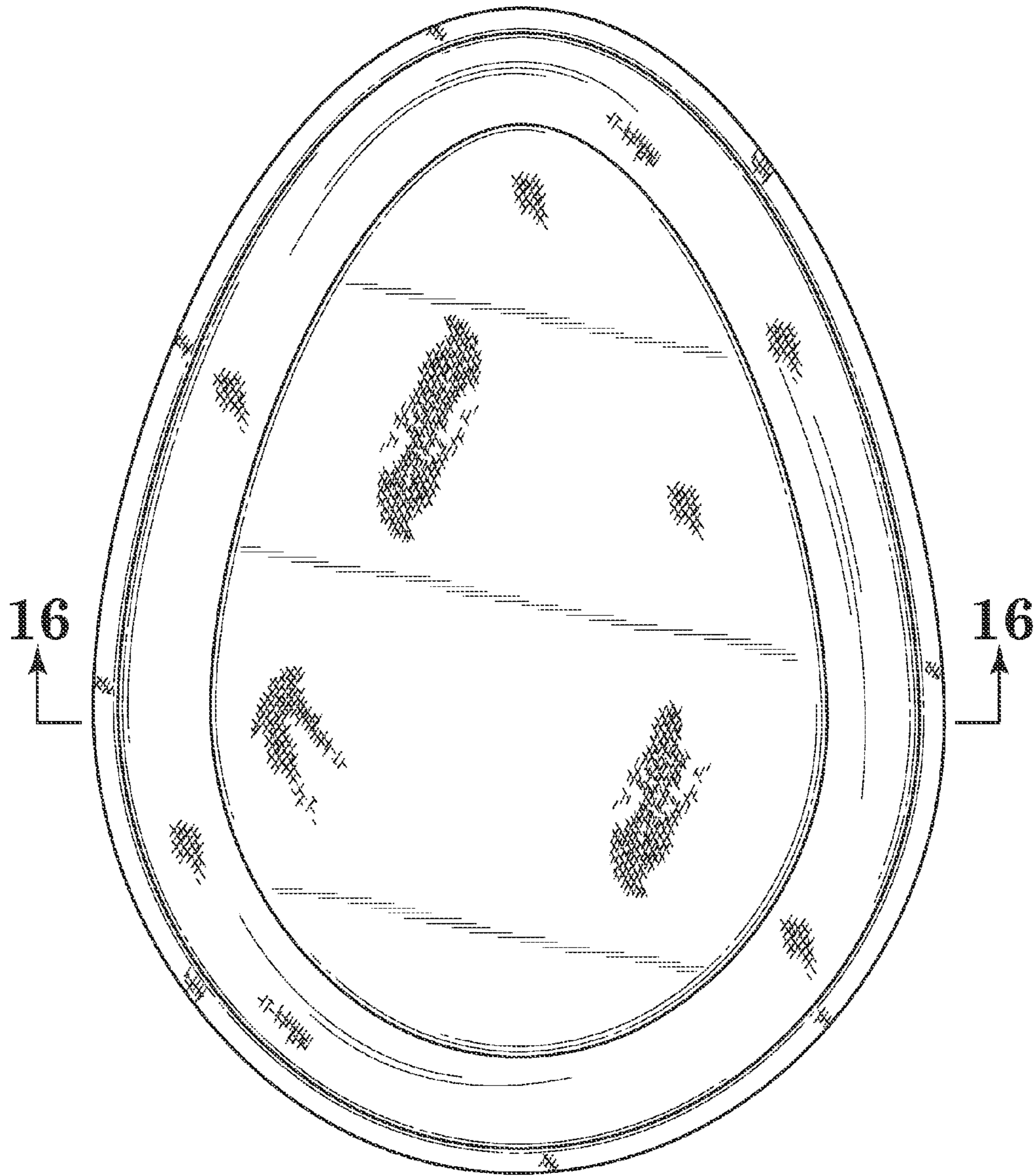

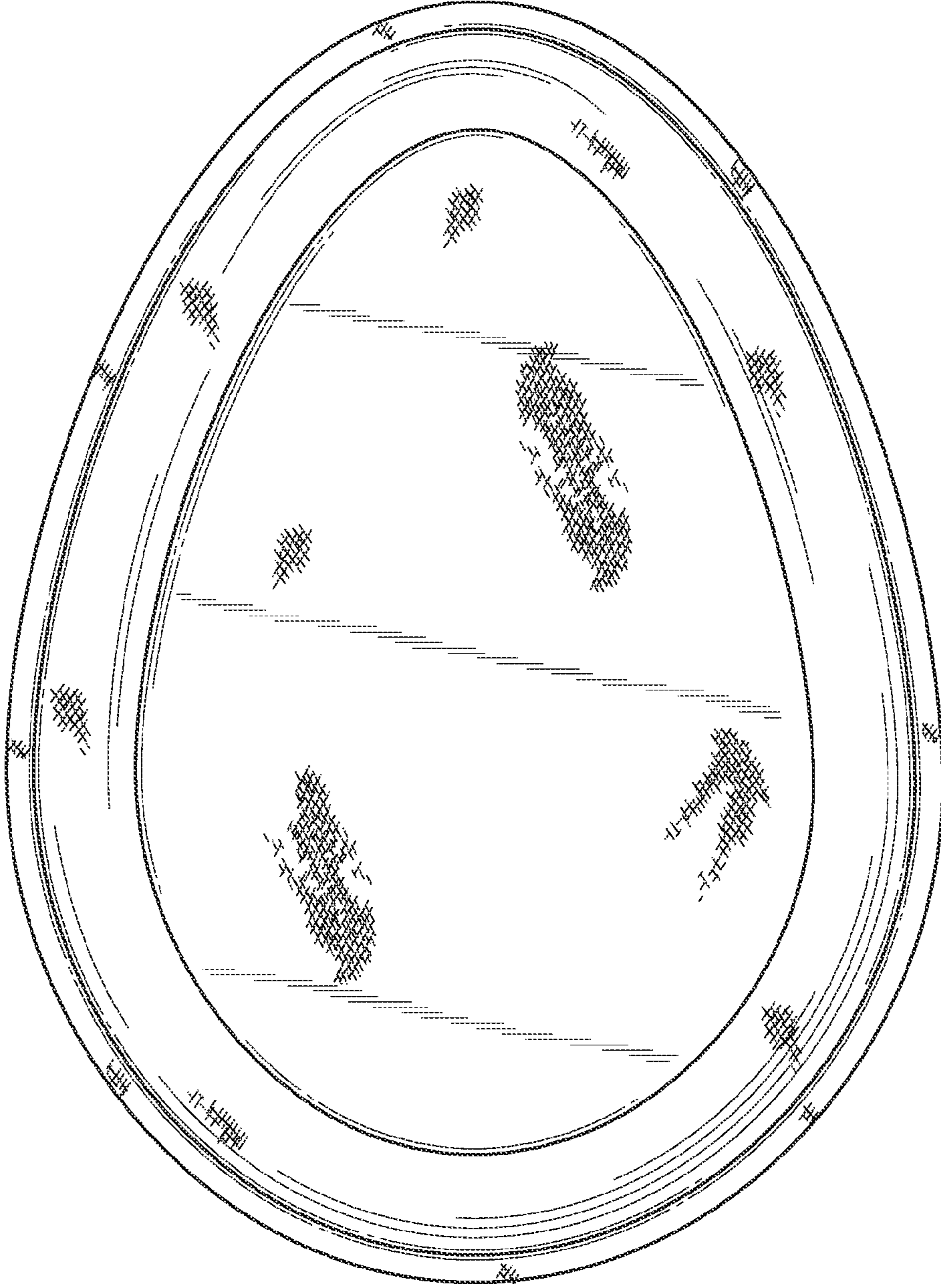

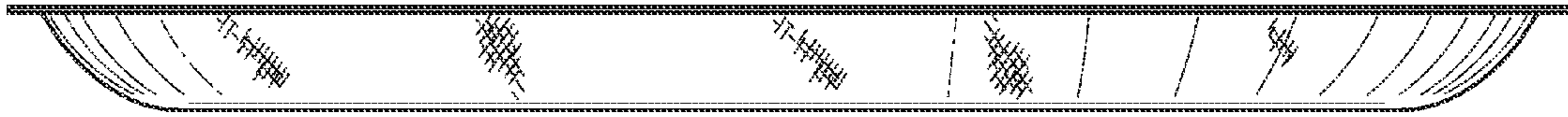
