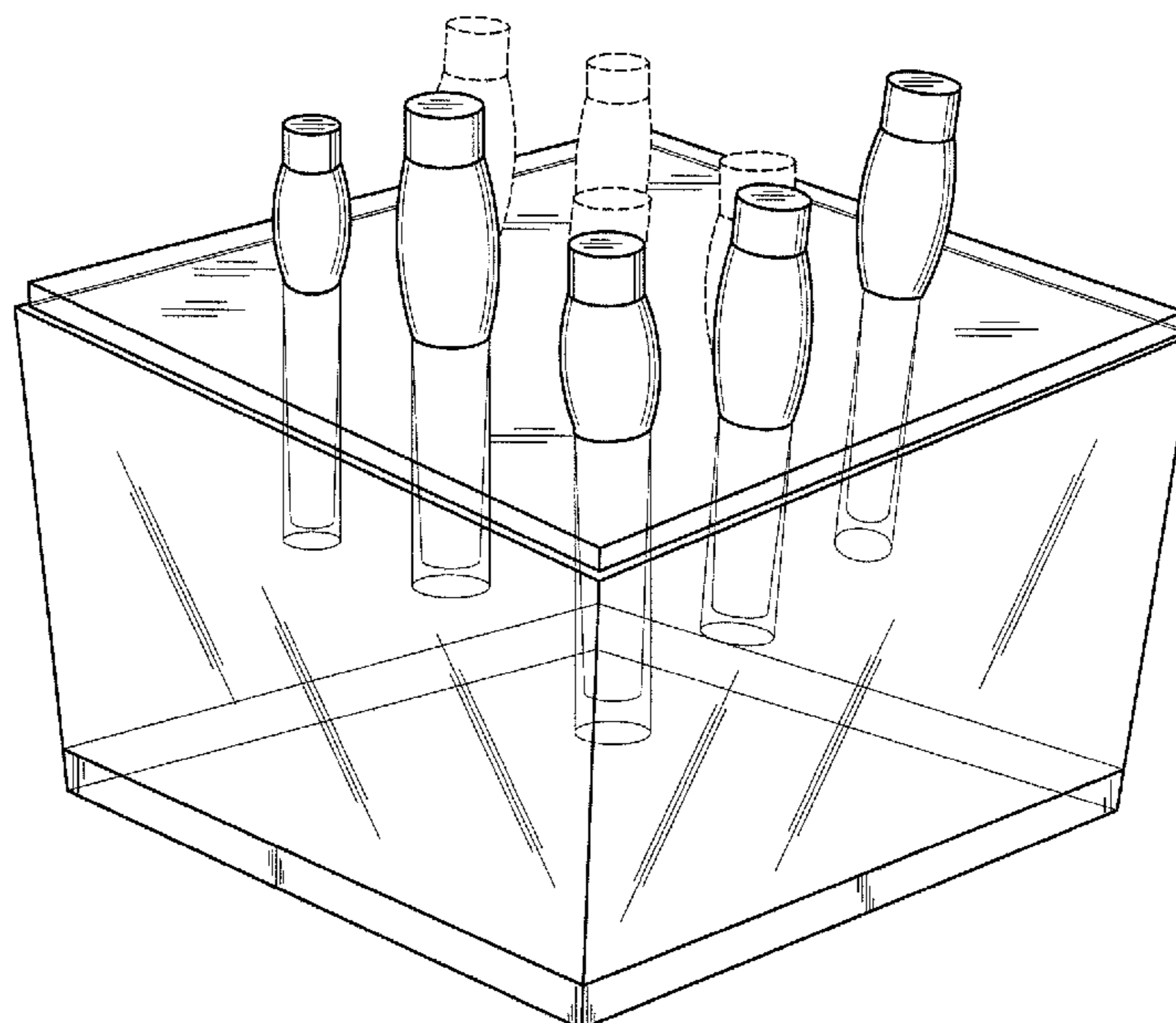
The ornamental design for a cosmetic product packaging, as shown and described.
