FIG. 5 is a front view thereof;

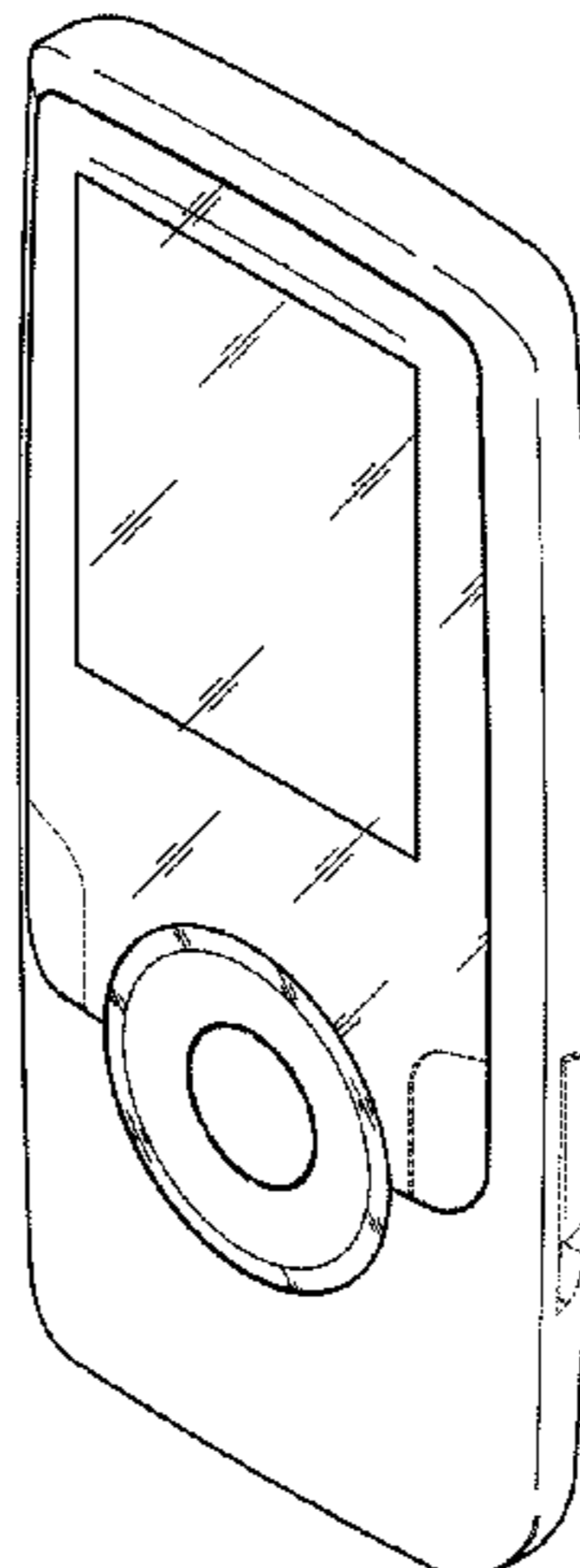
FIG. 6 is a right side view thereof;

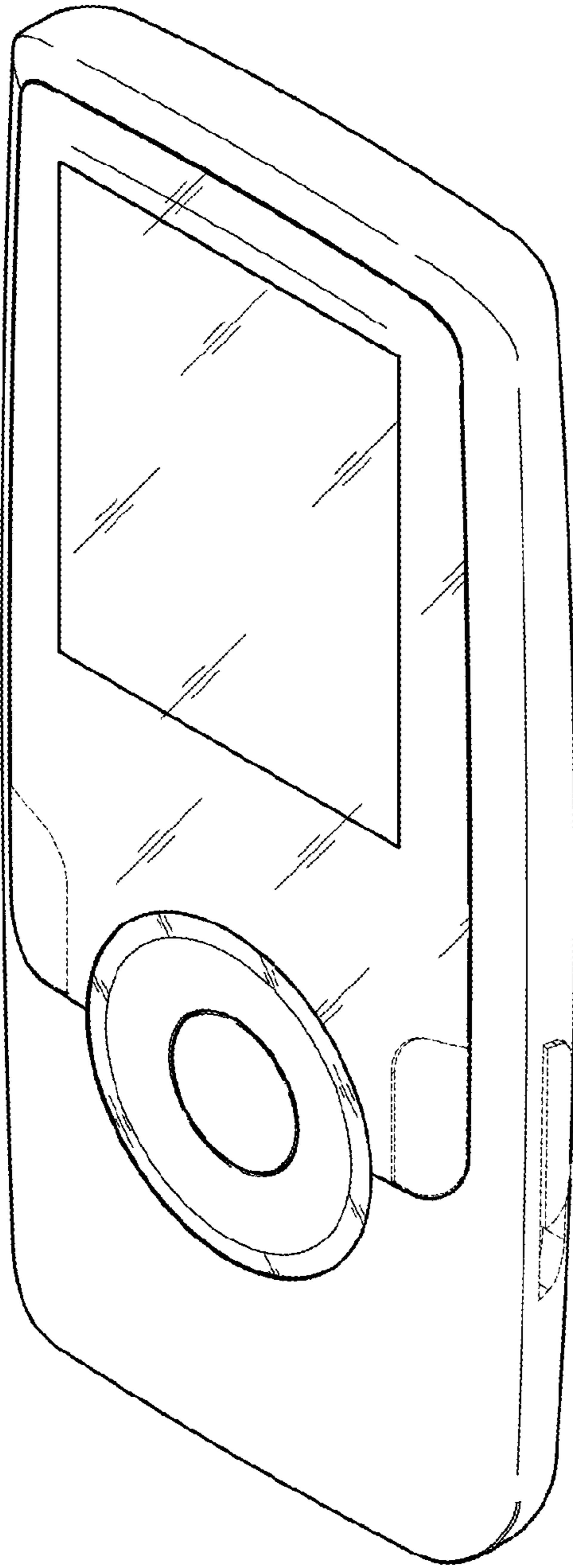

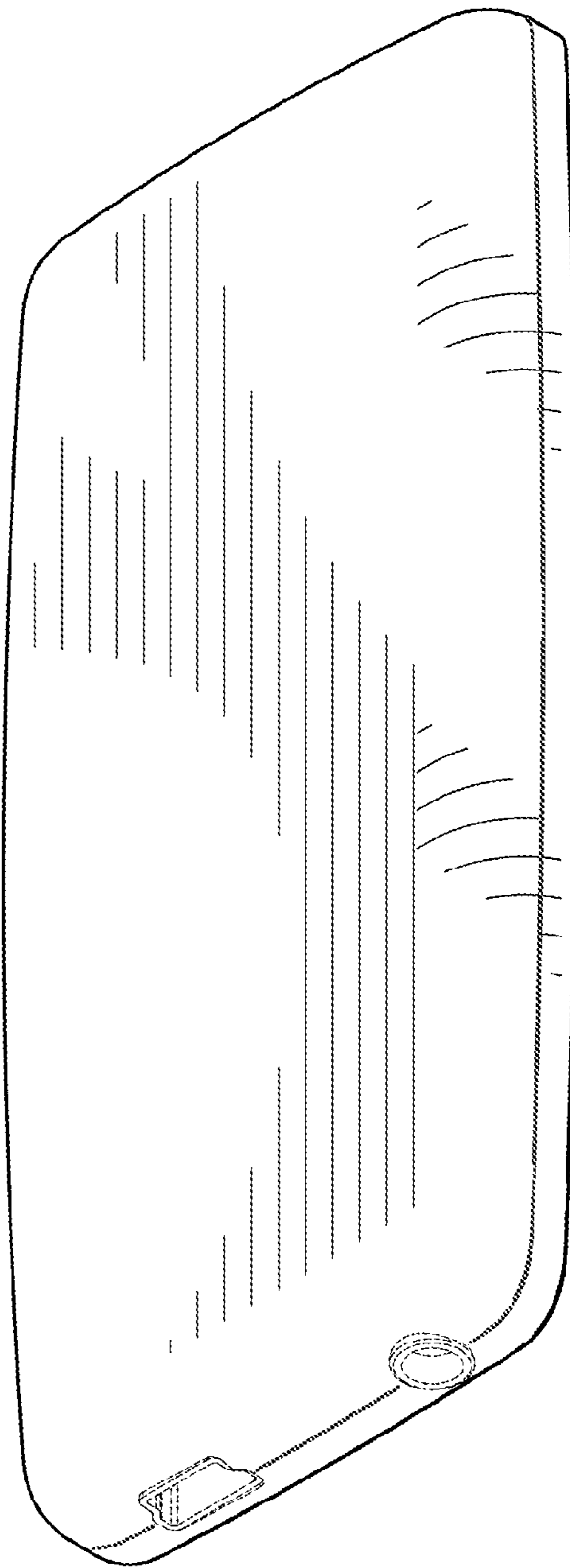

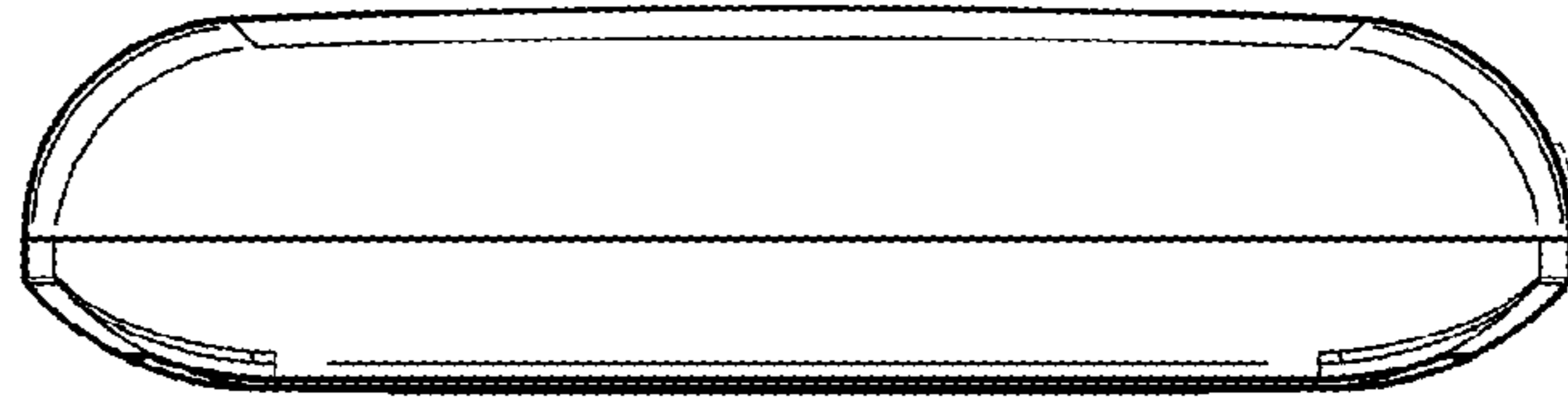

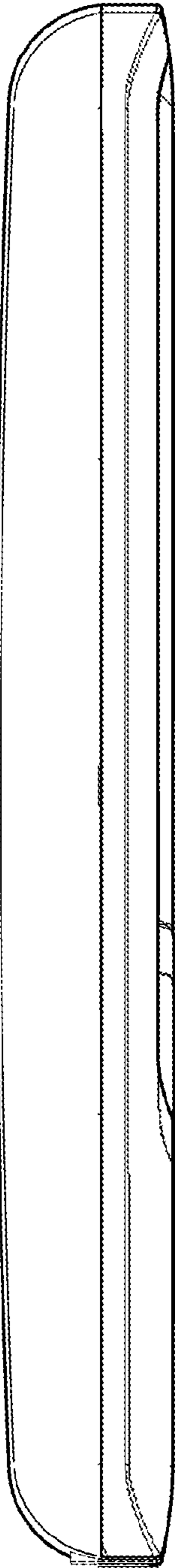

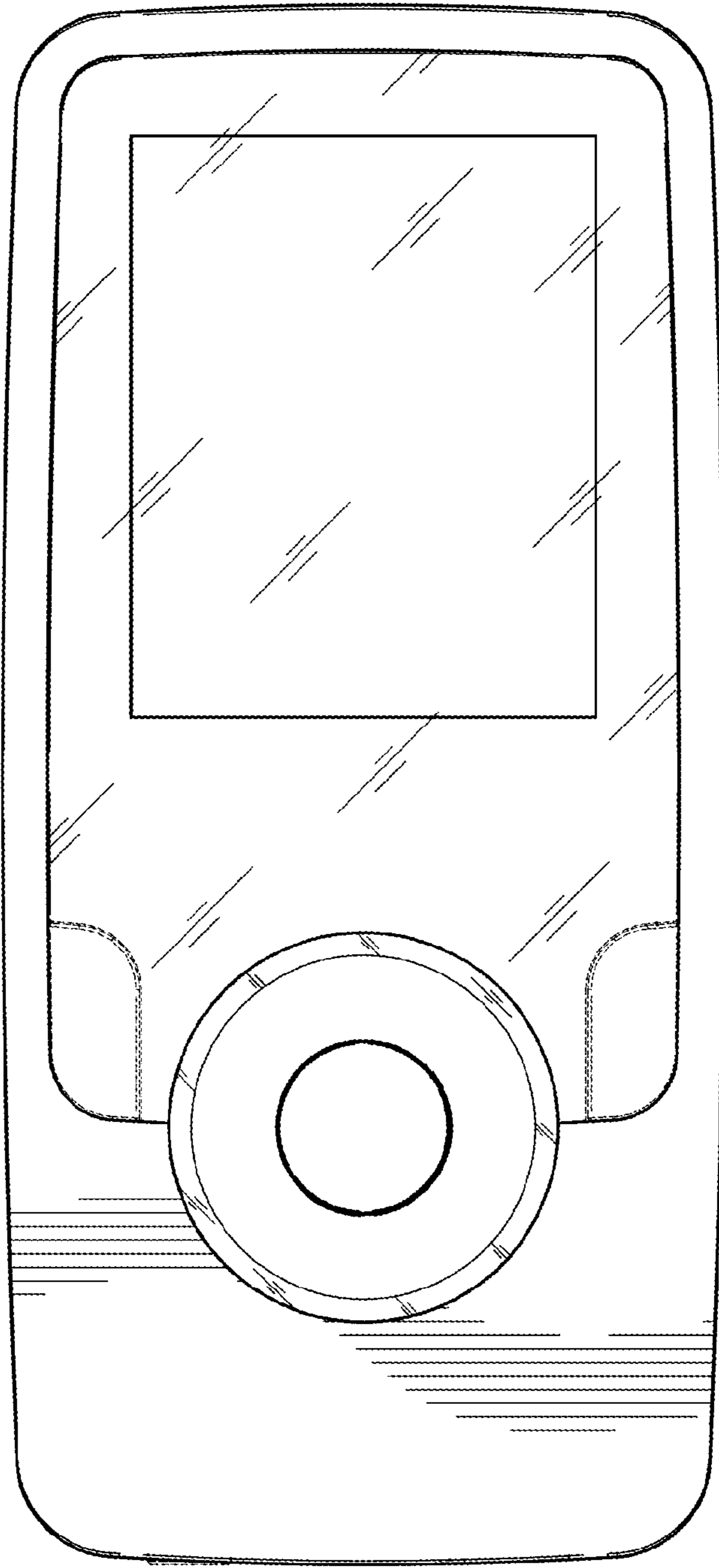

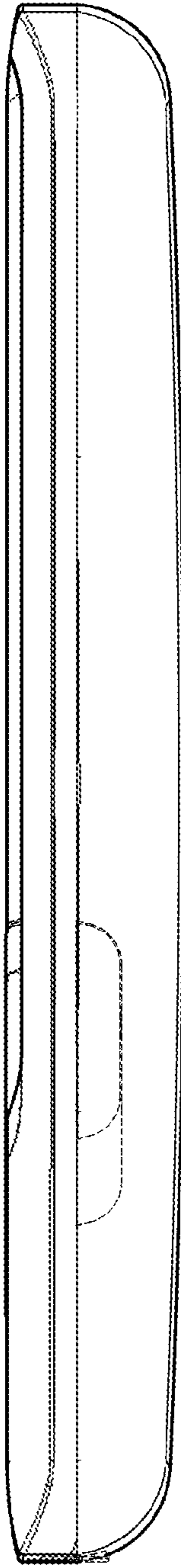

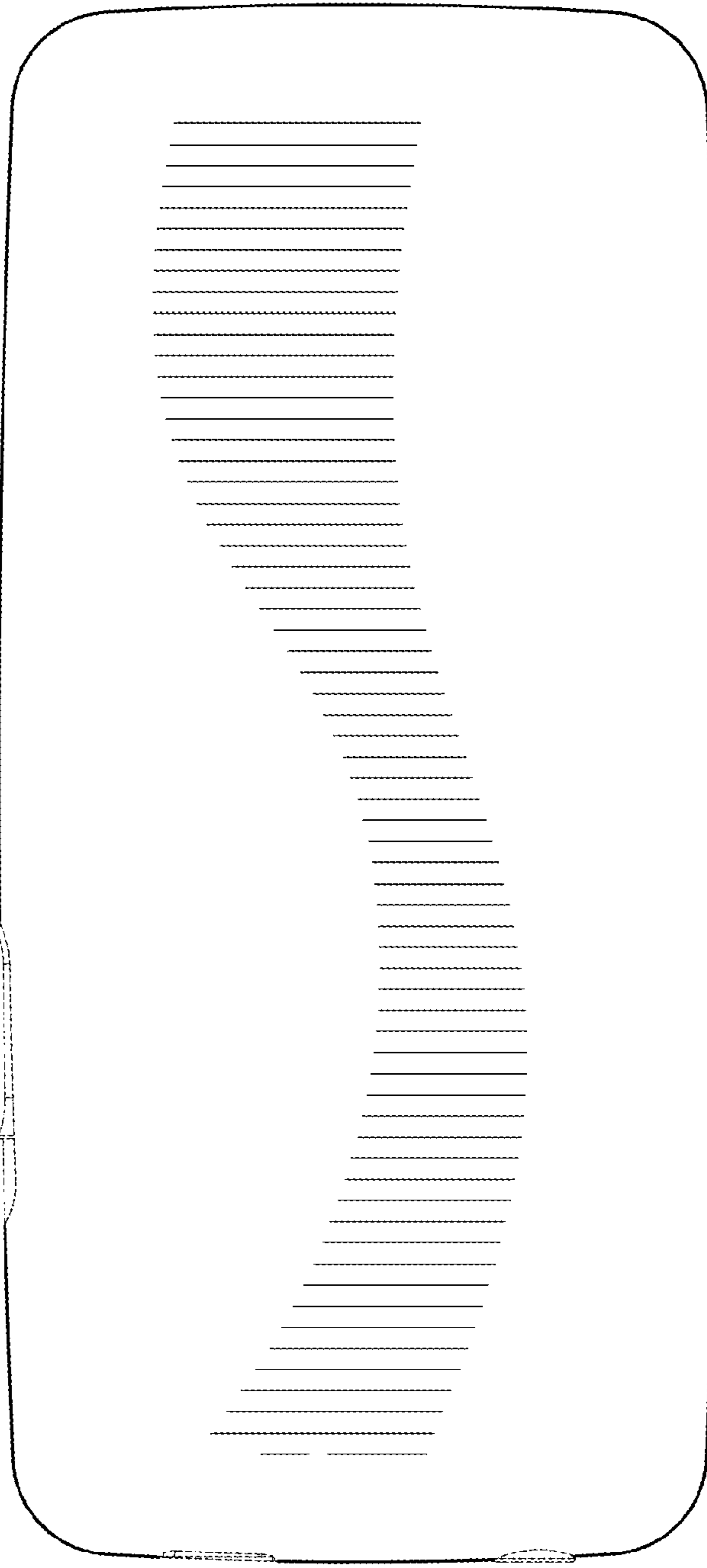

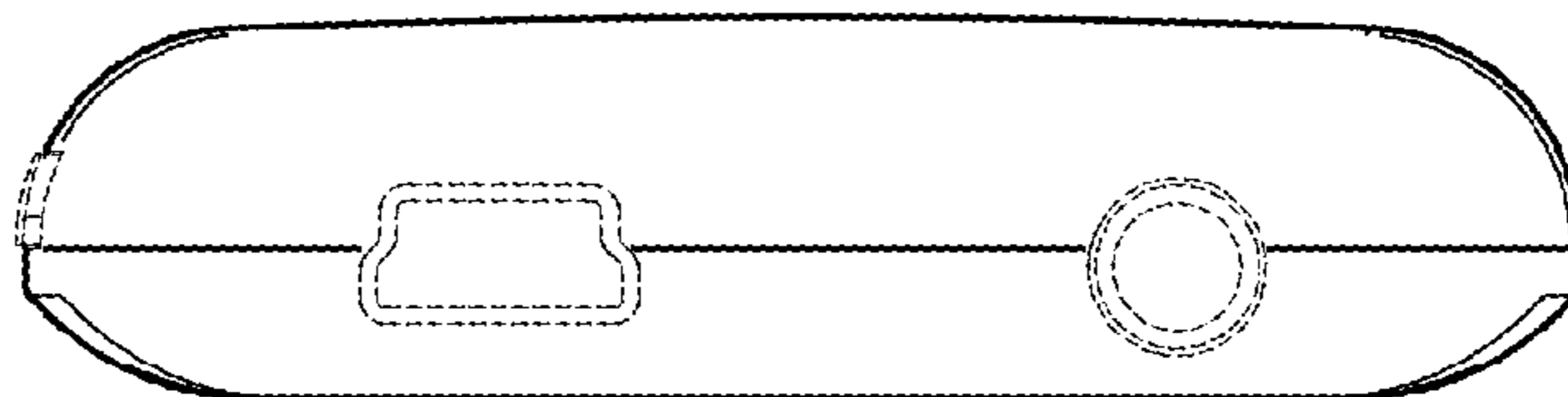
