FIG. 4 is a top view thereof;

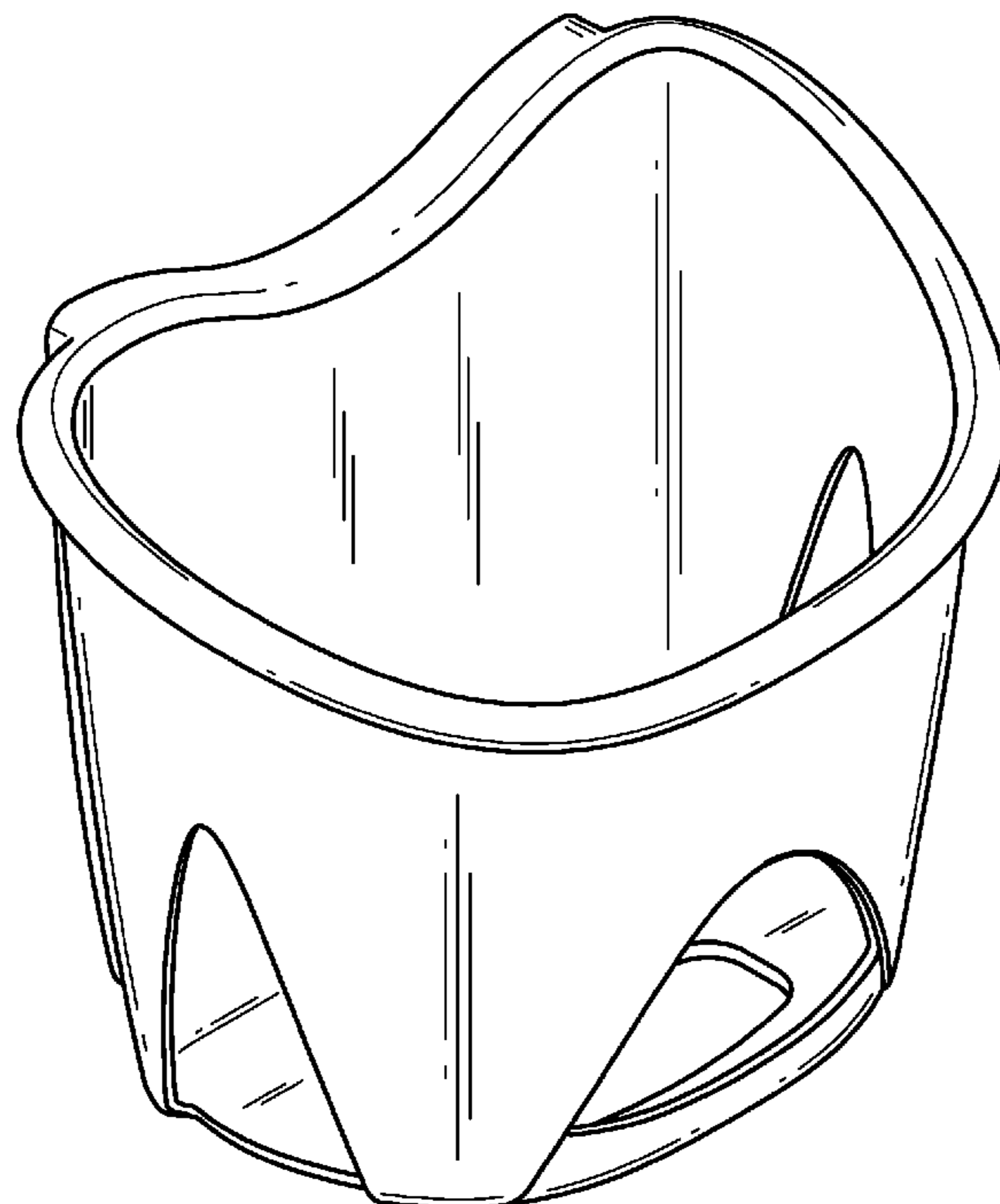
FIG. 5 is a bottom view thereof;

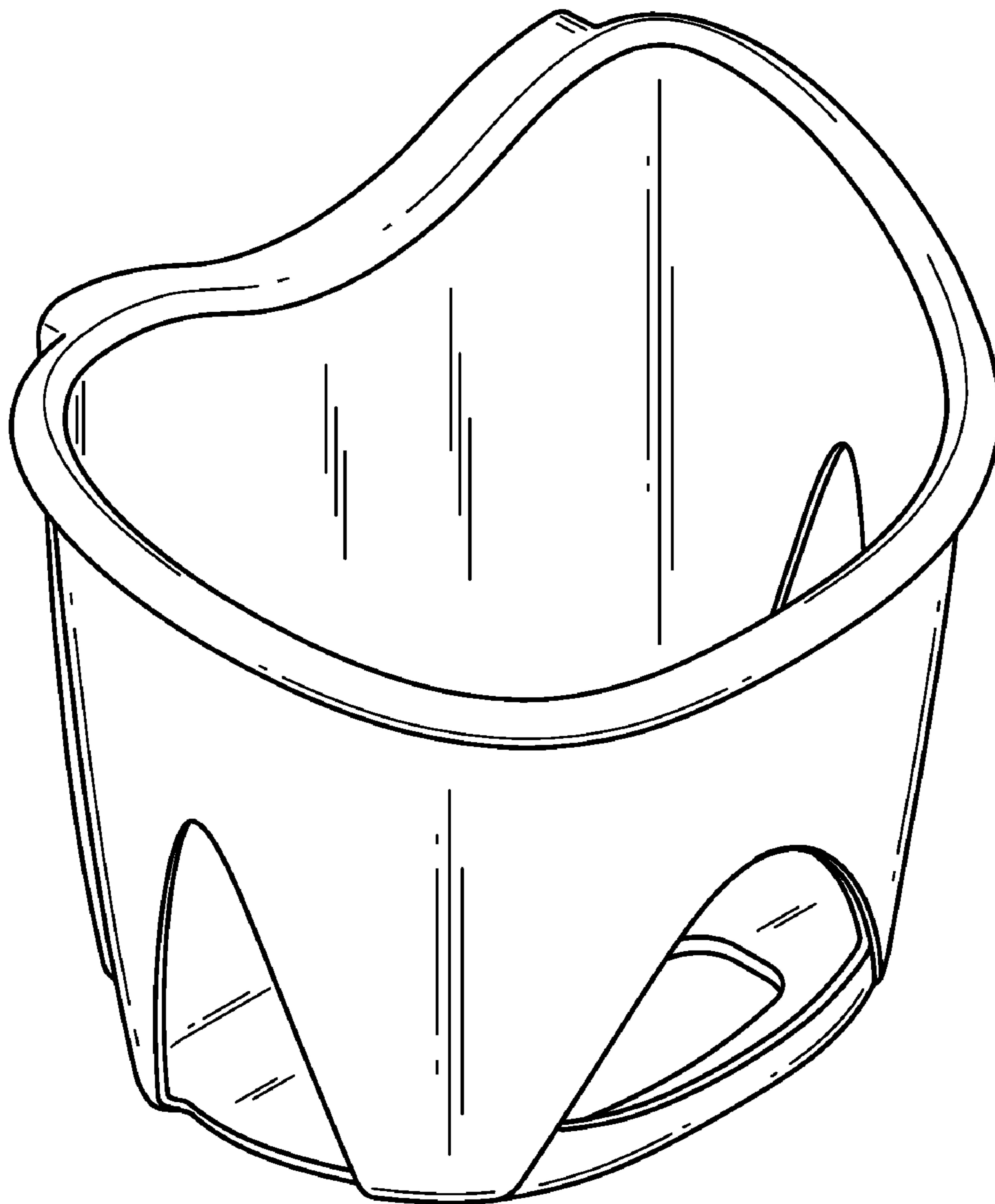
FIG. 6 is a right side view thereof; and,

FIG. 7 is a left side view thereof.

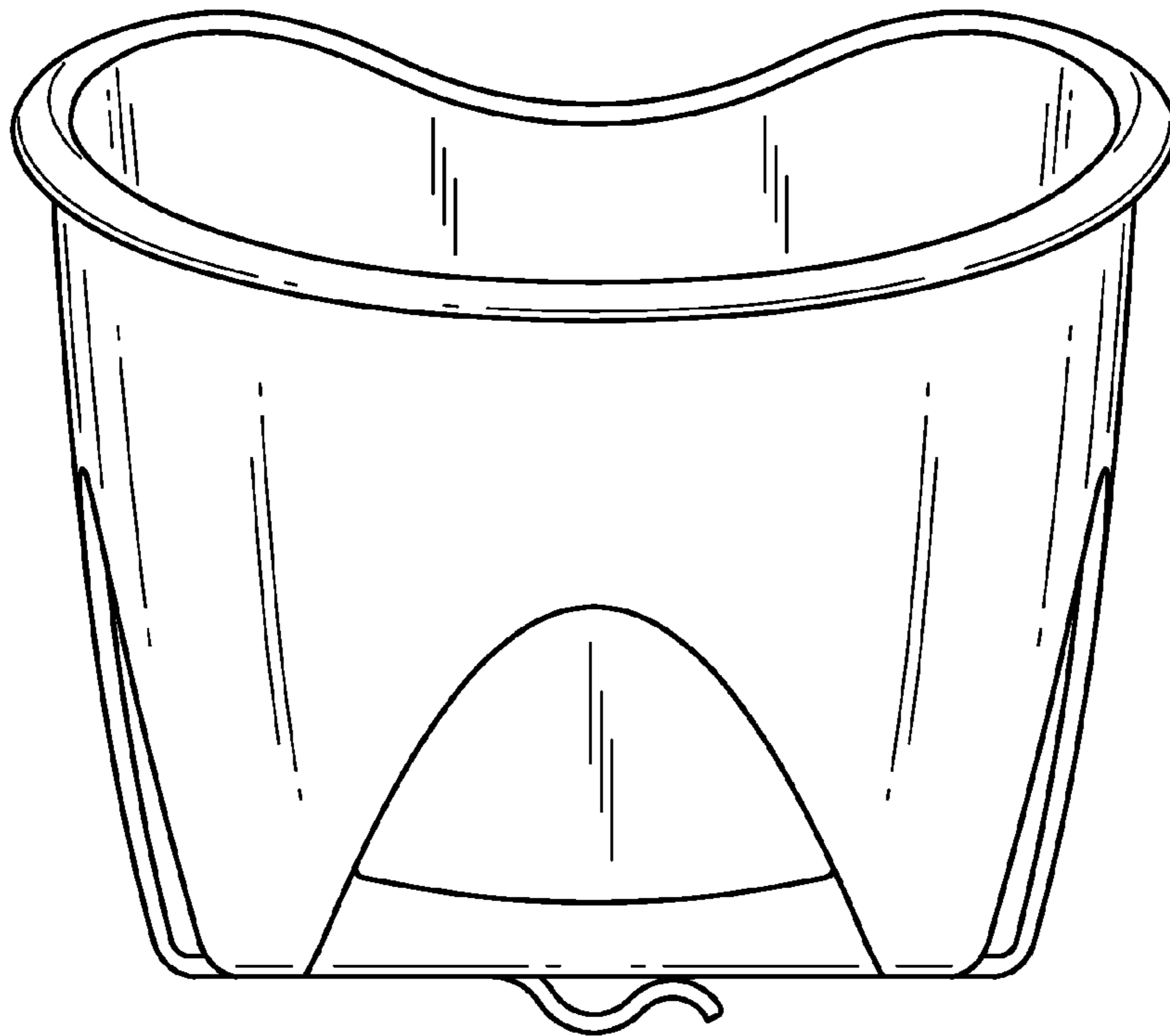
The broken line showing portions of a wall mountable cell phone holder is included for illustrating environmental structure and forms no part of the claimed design.

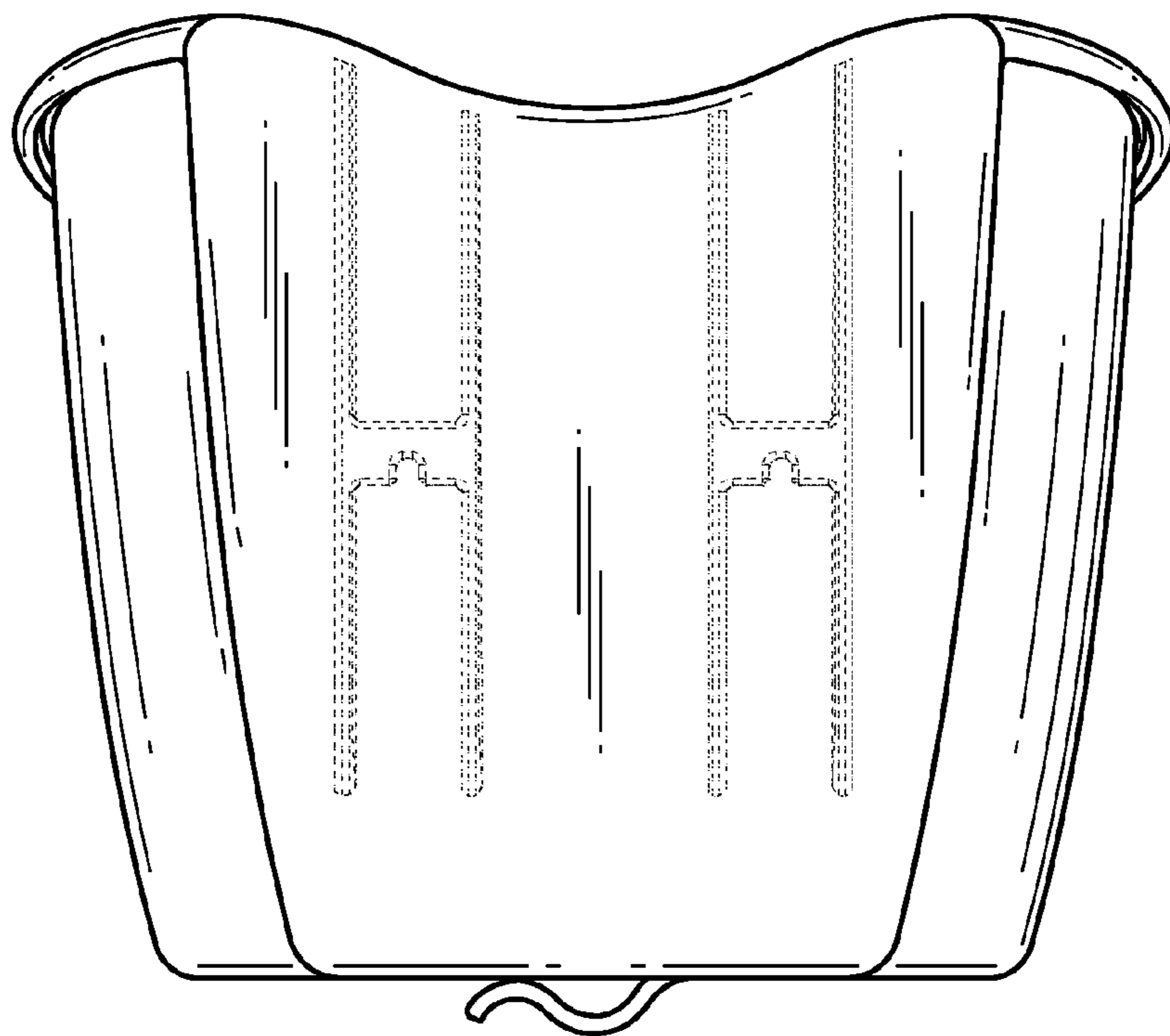




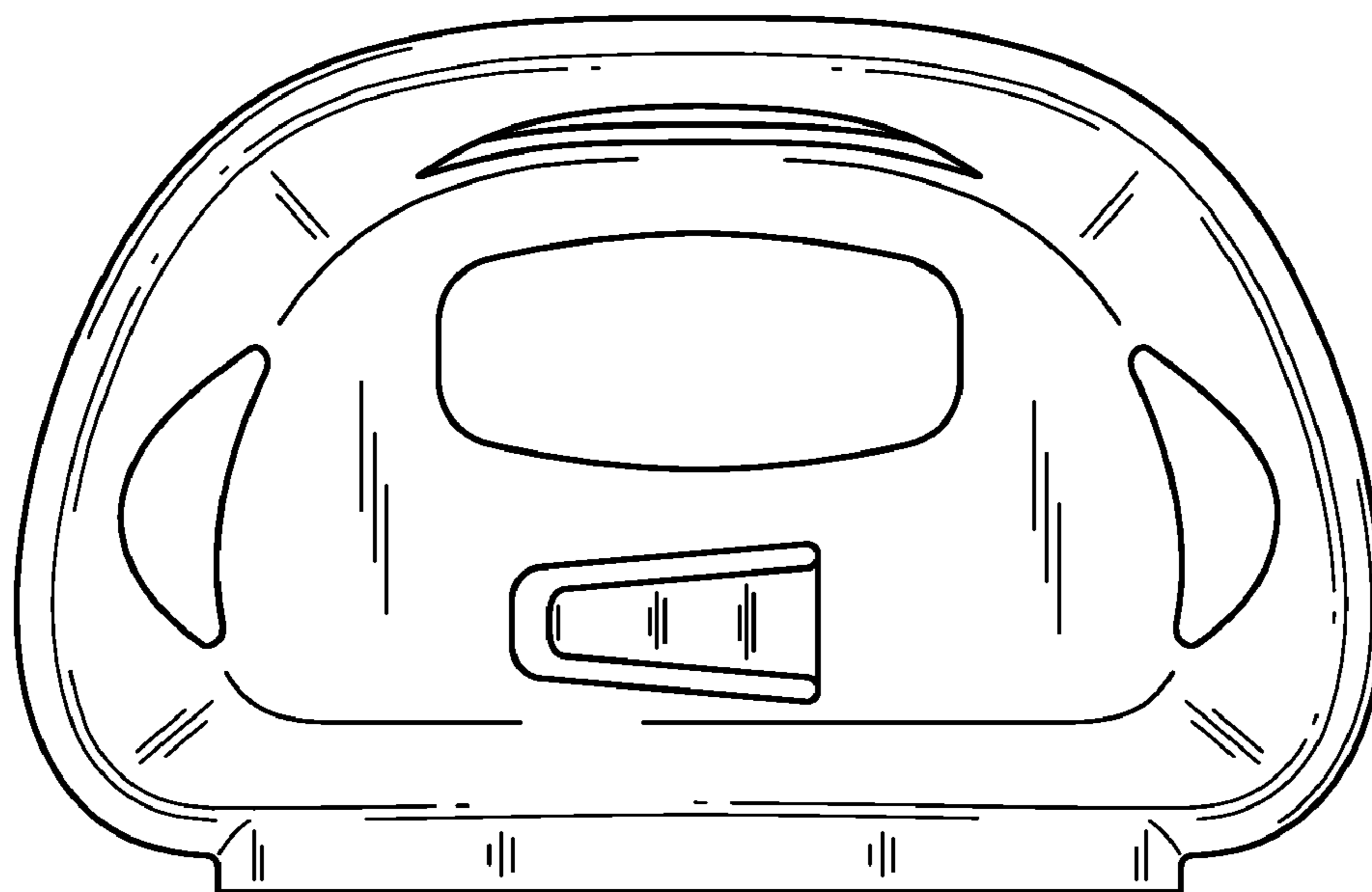

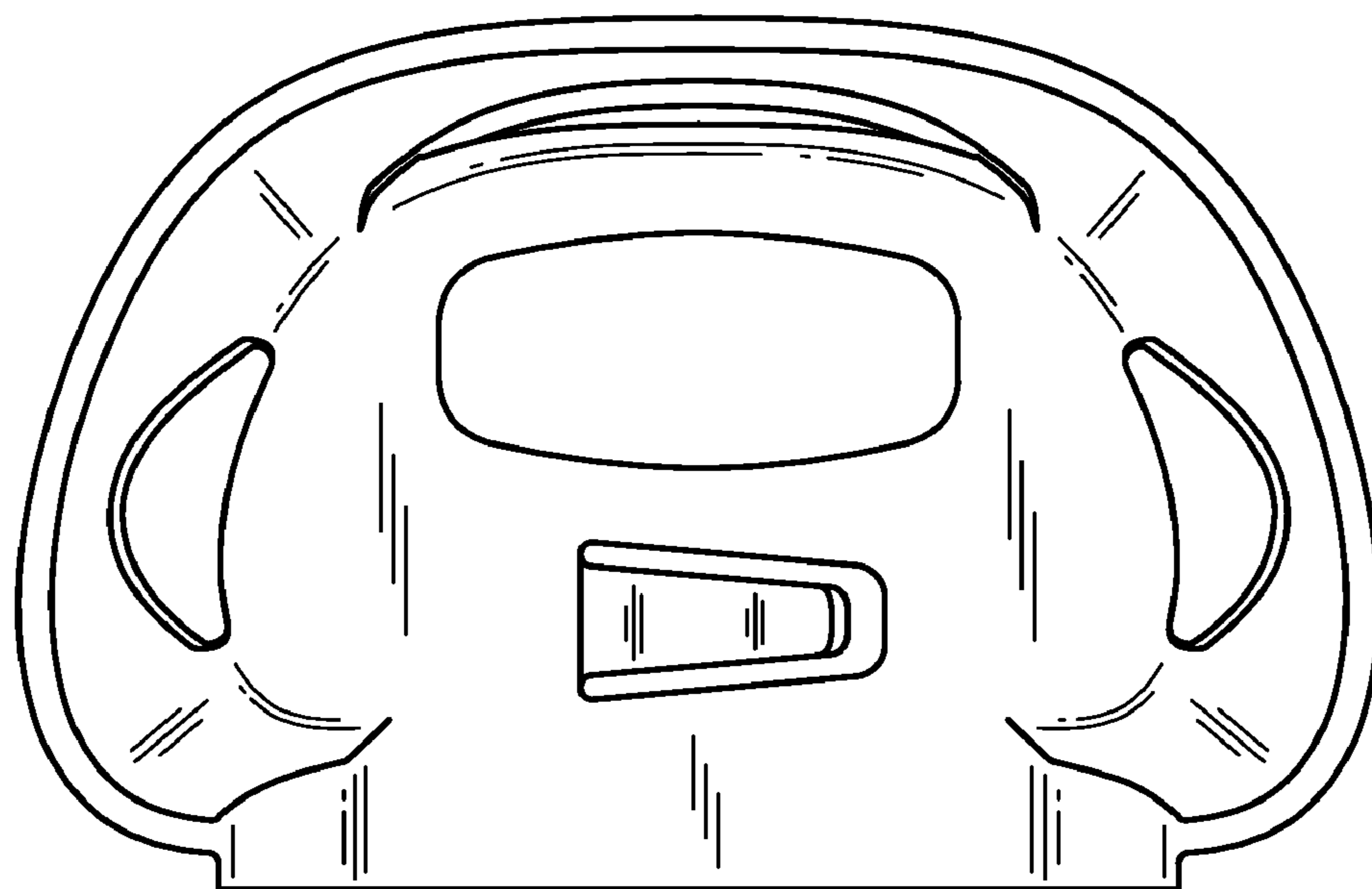

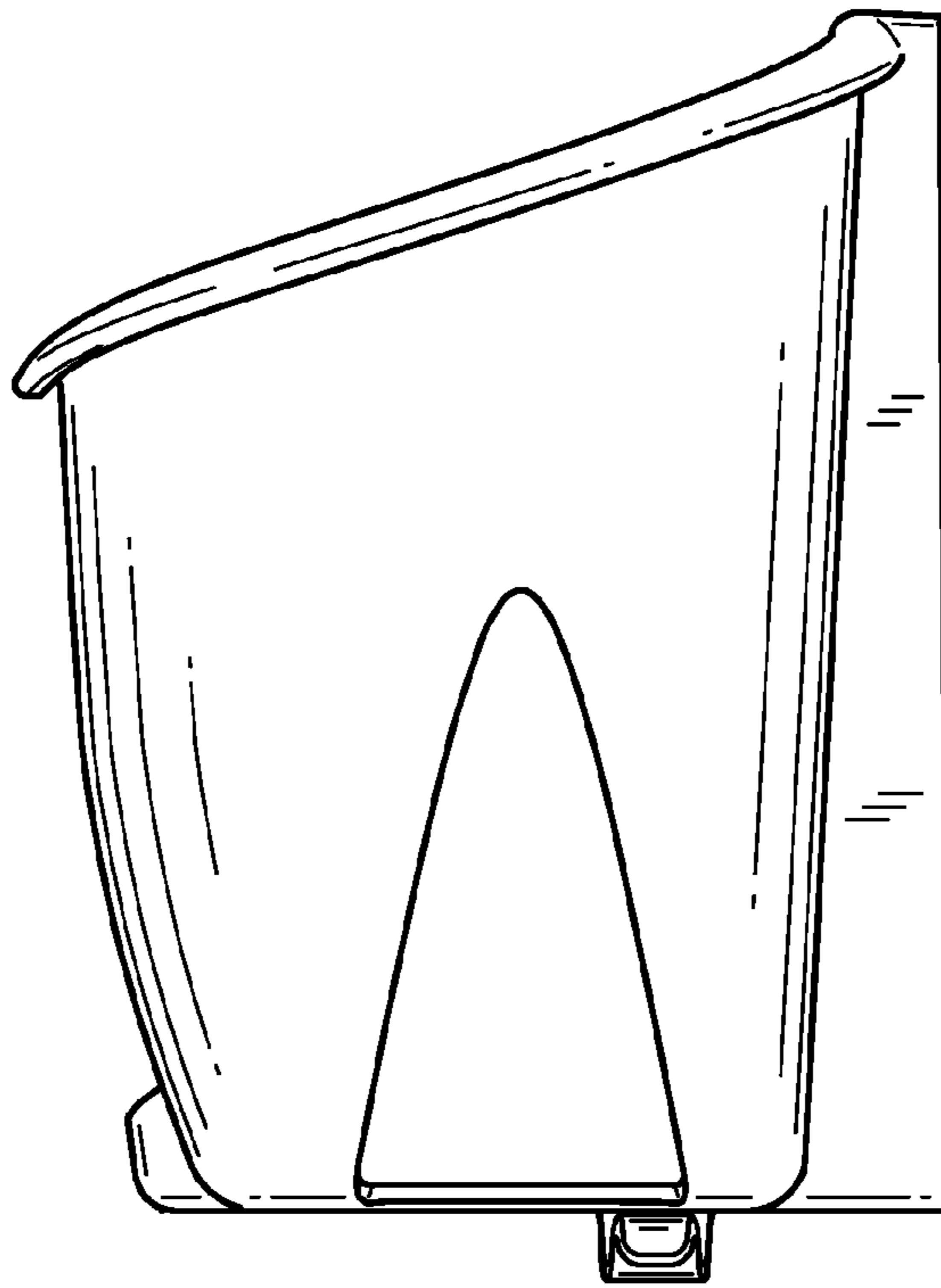

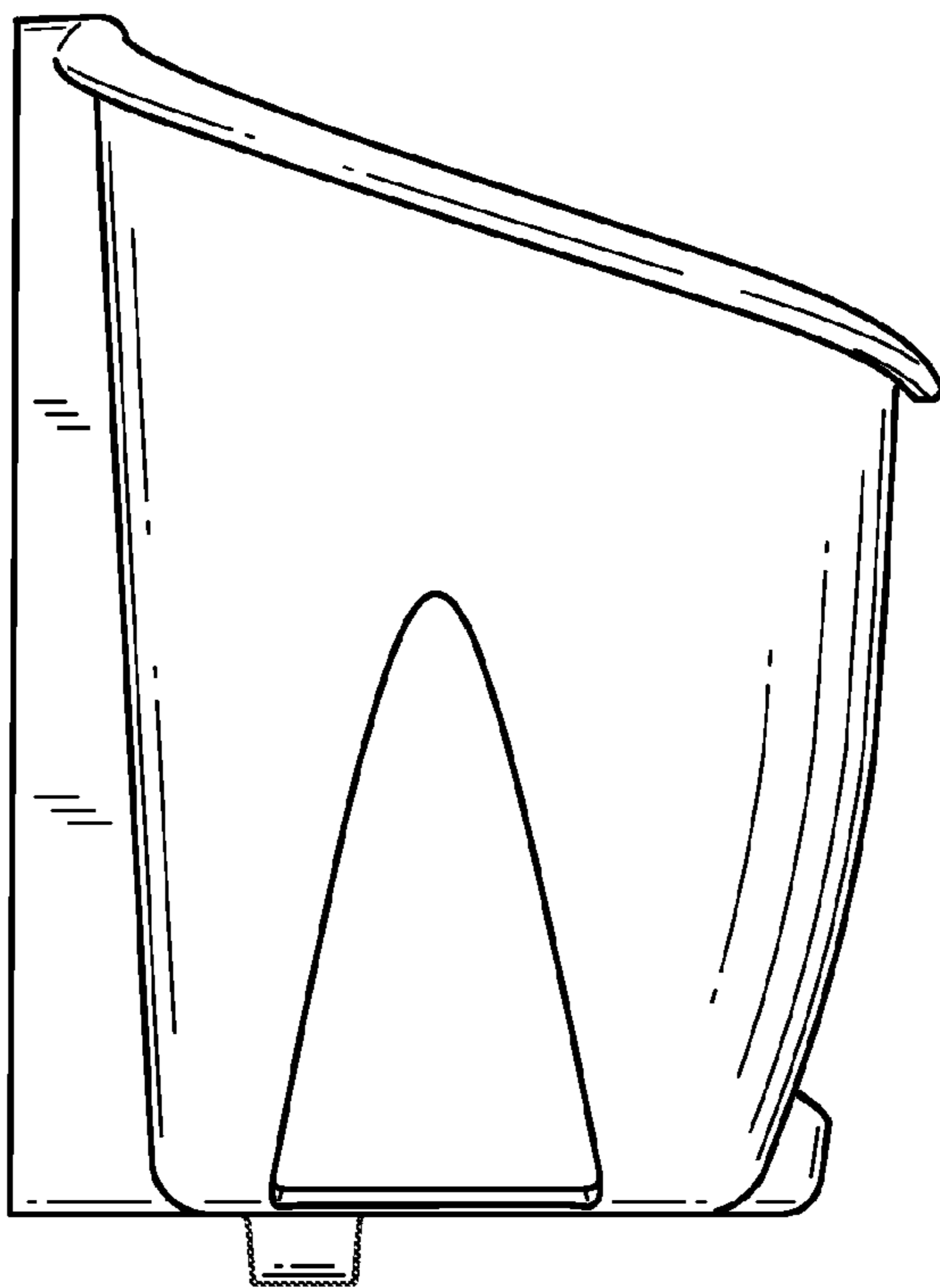
