FIG. 4 is a front view of a fourth embodiment thereof.

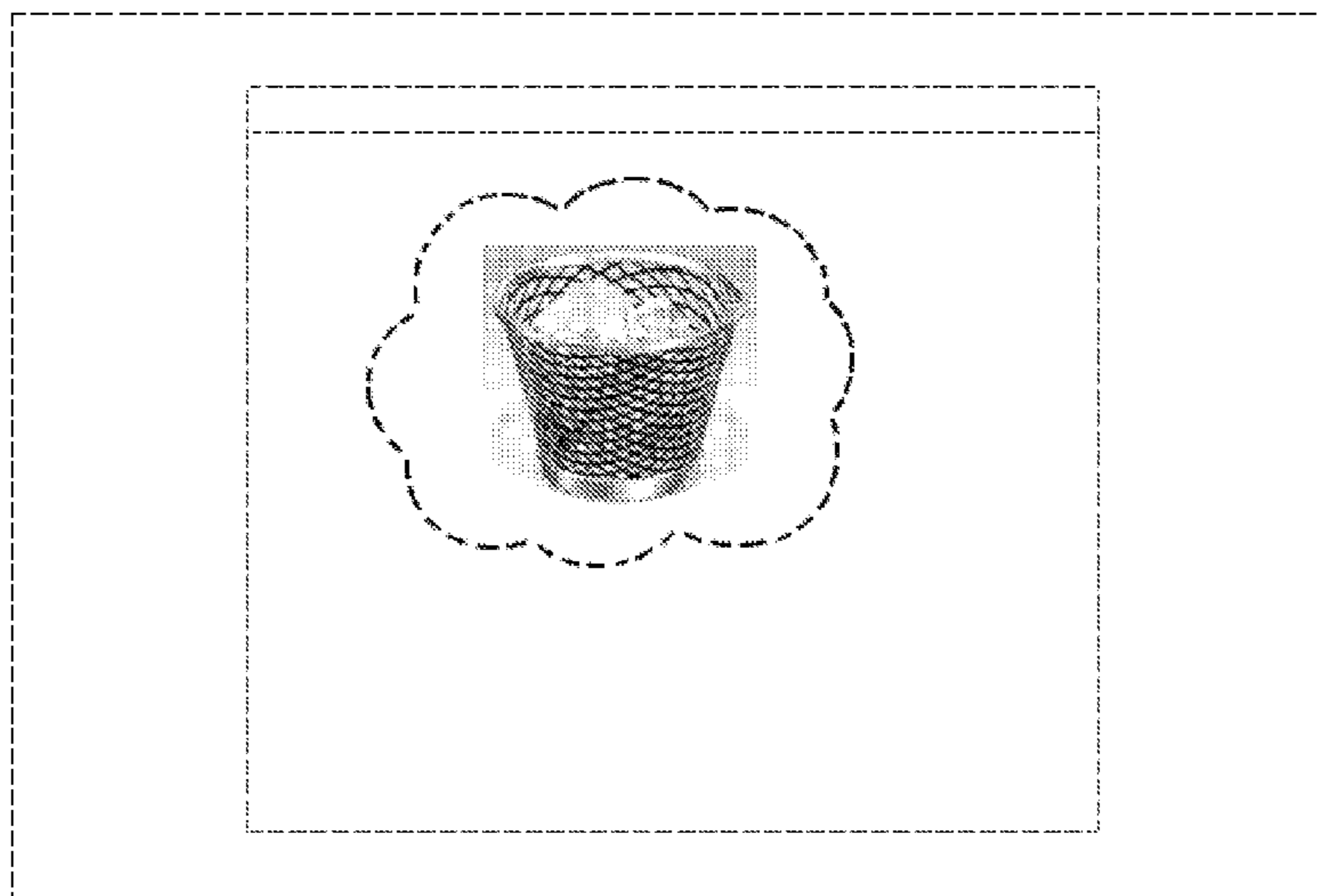
FIG. 5 is a front view of a fifth embodiment thereof.

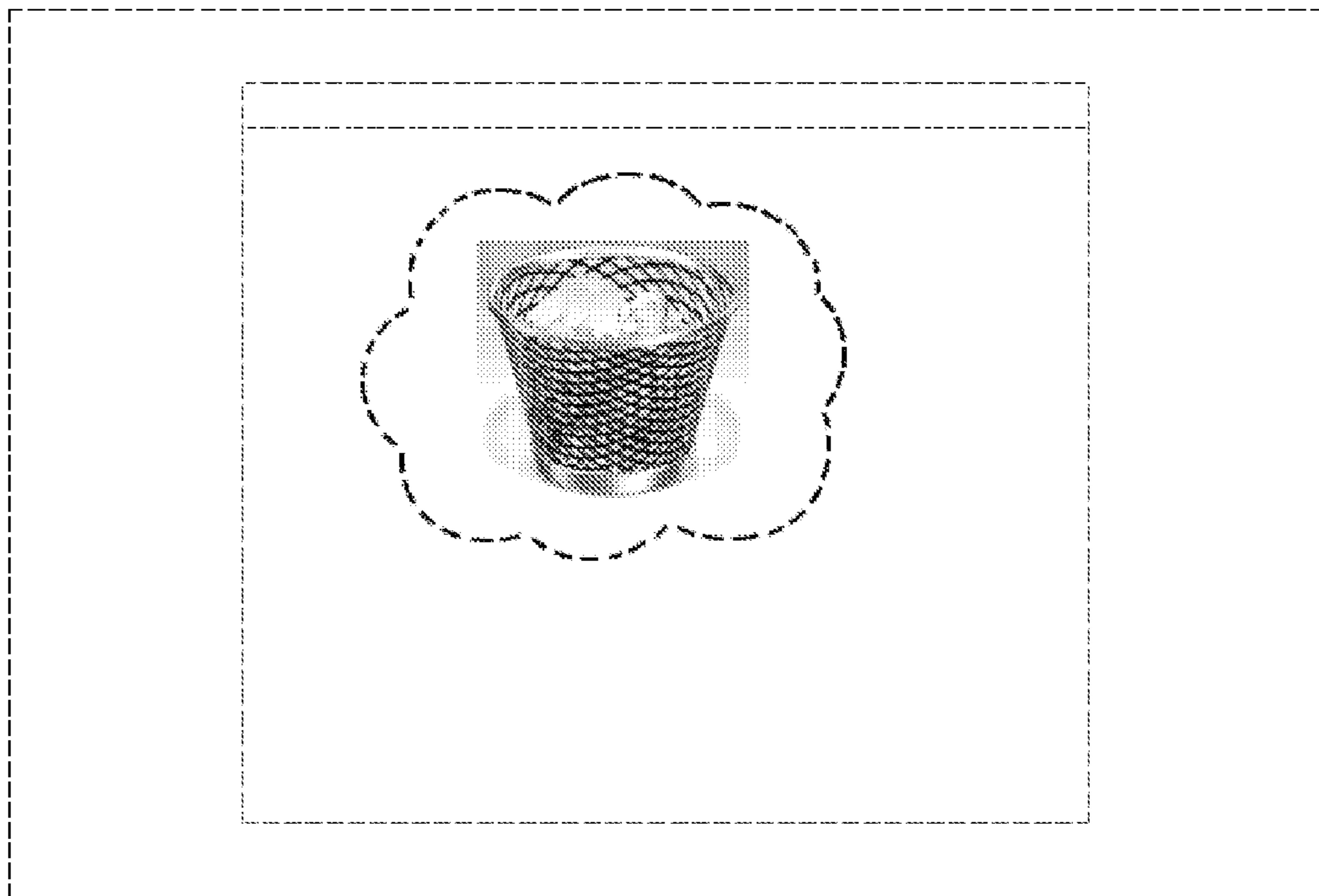

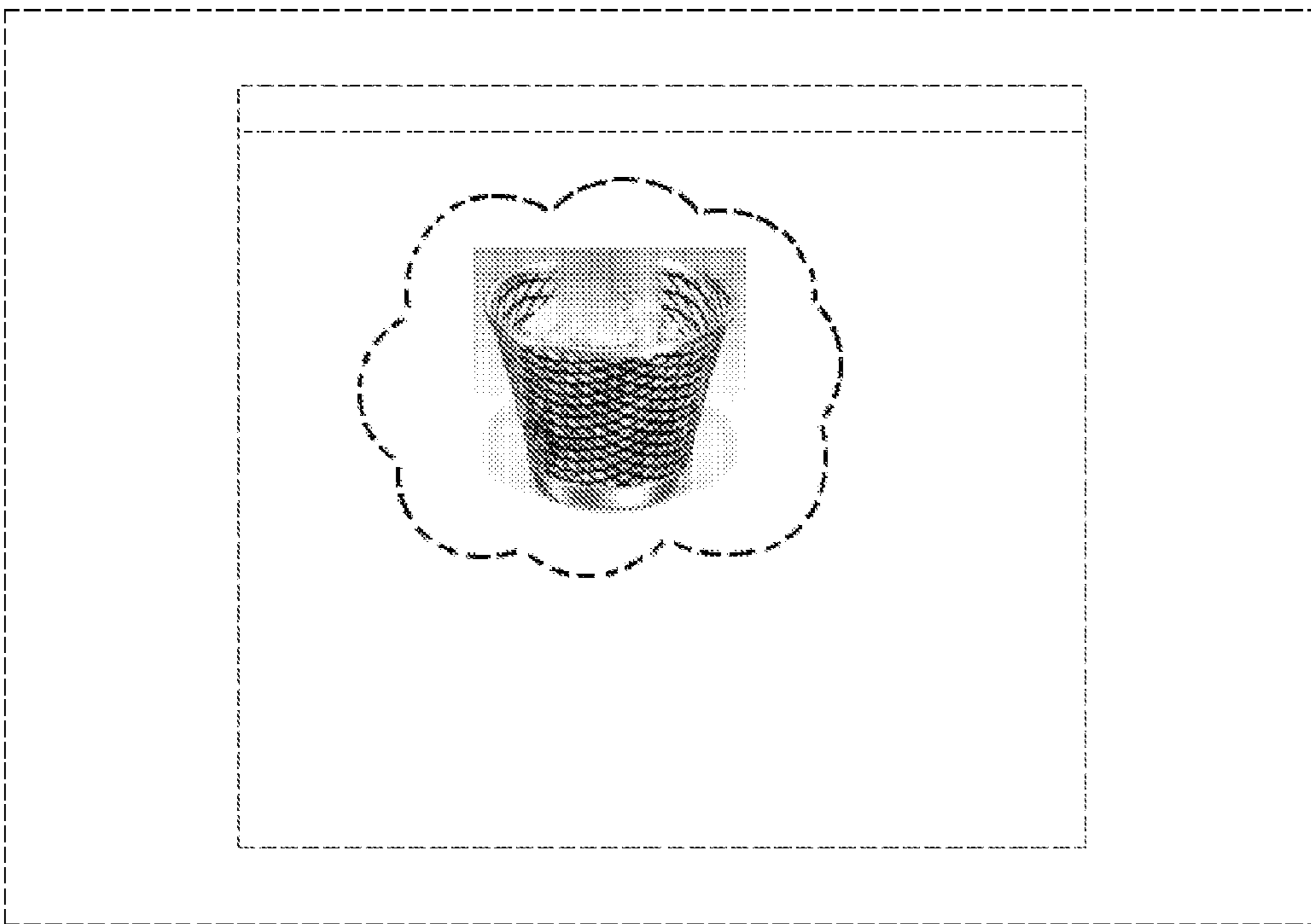

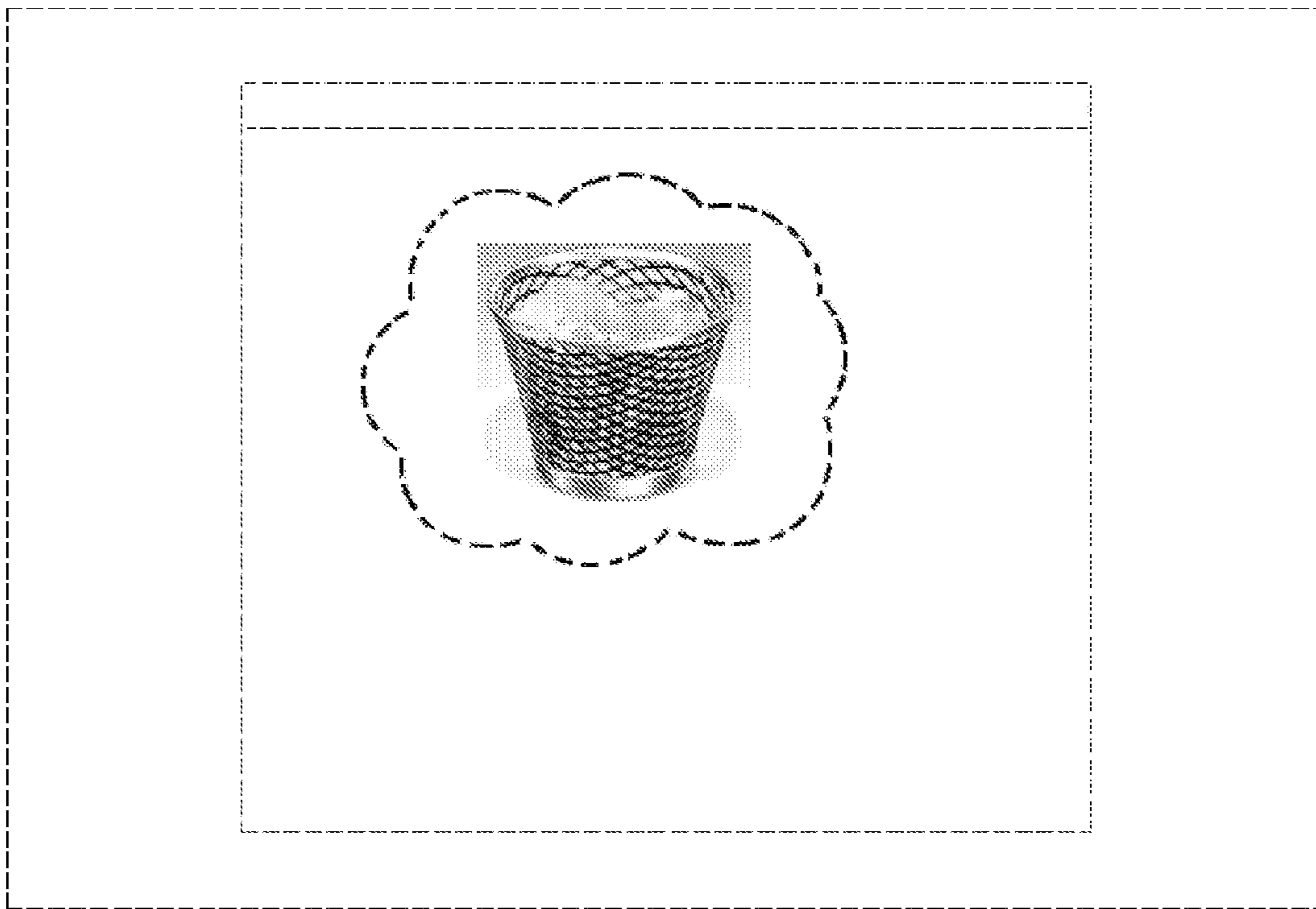

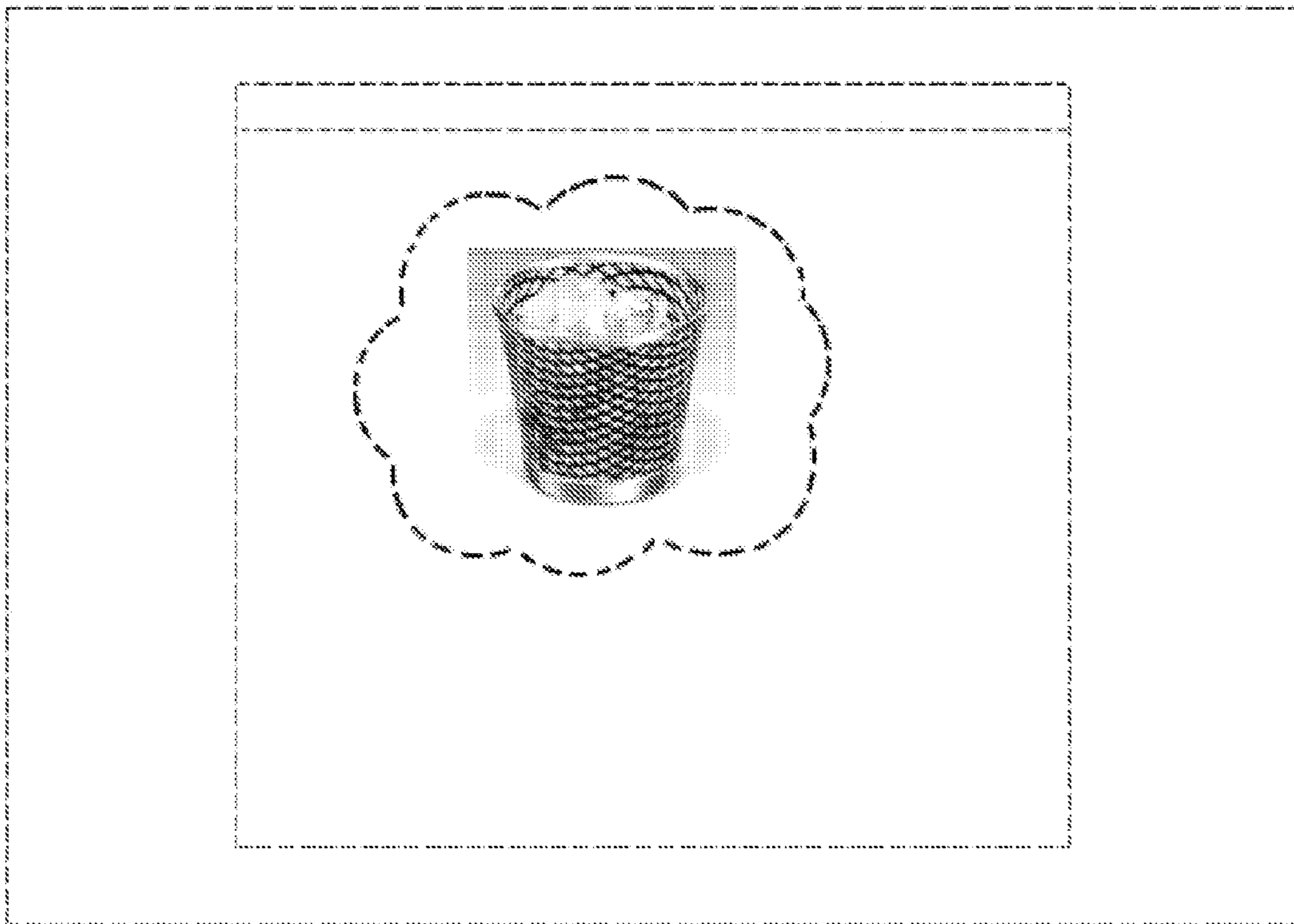

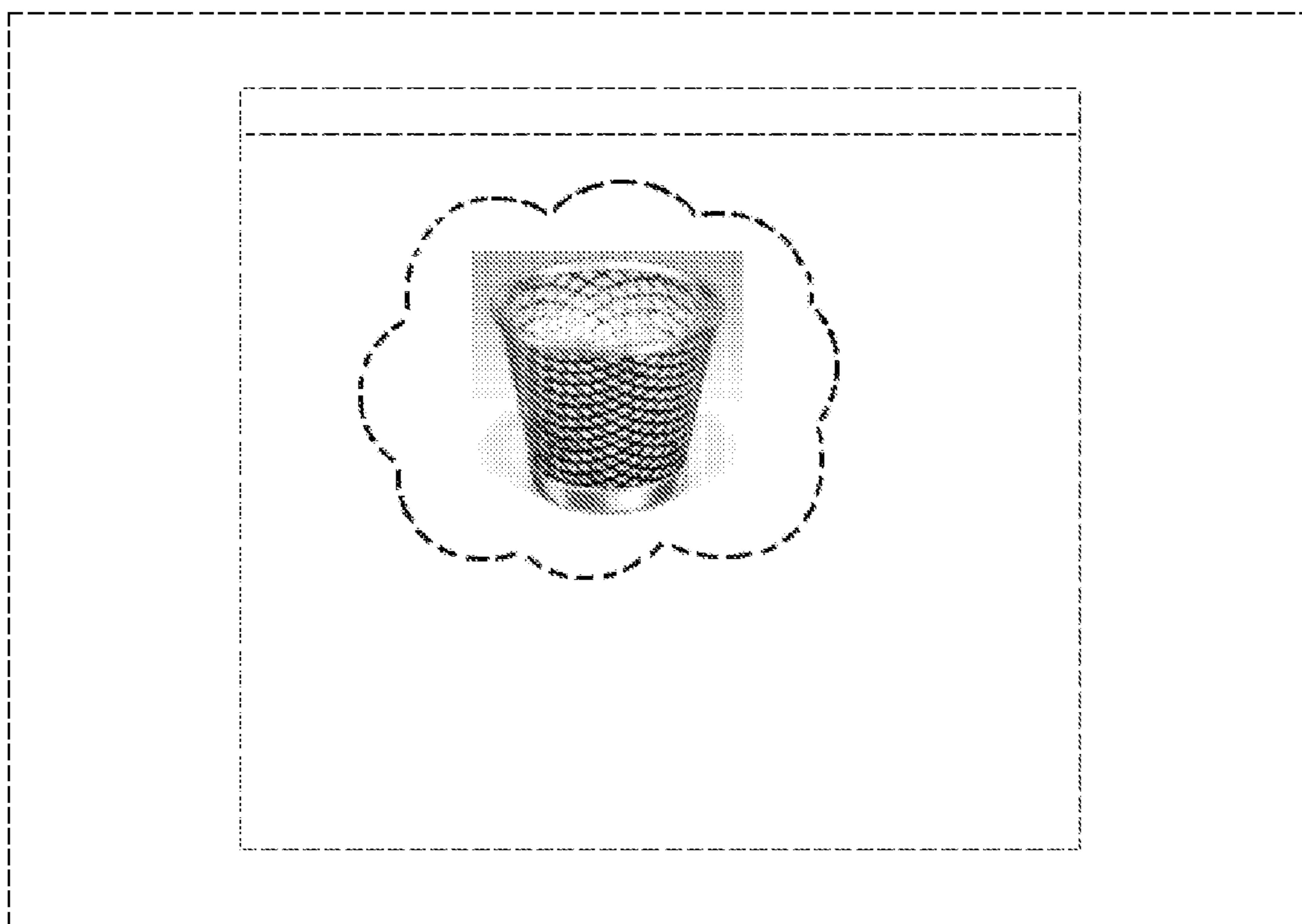
