**DESCRIPTION**

FIG. 1 is a front side bottom perspective view of the pen clip and cap showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a right side elevational view thereof which is a mirror image of the left side thereof;

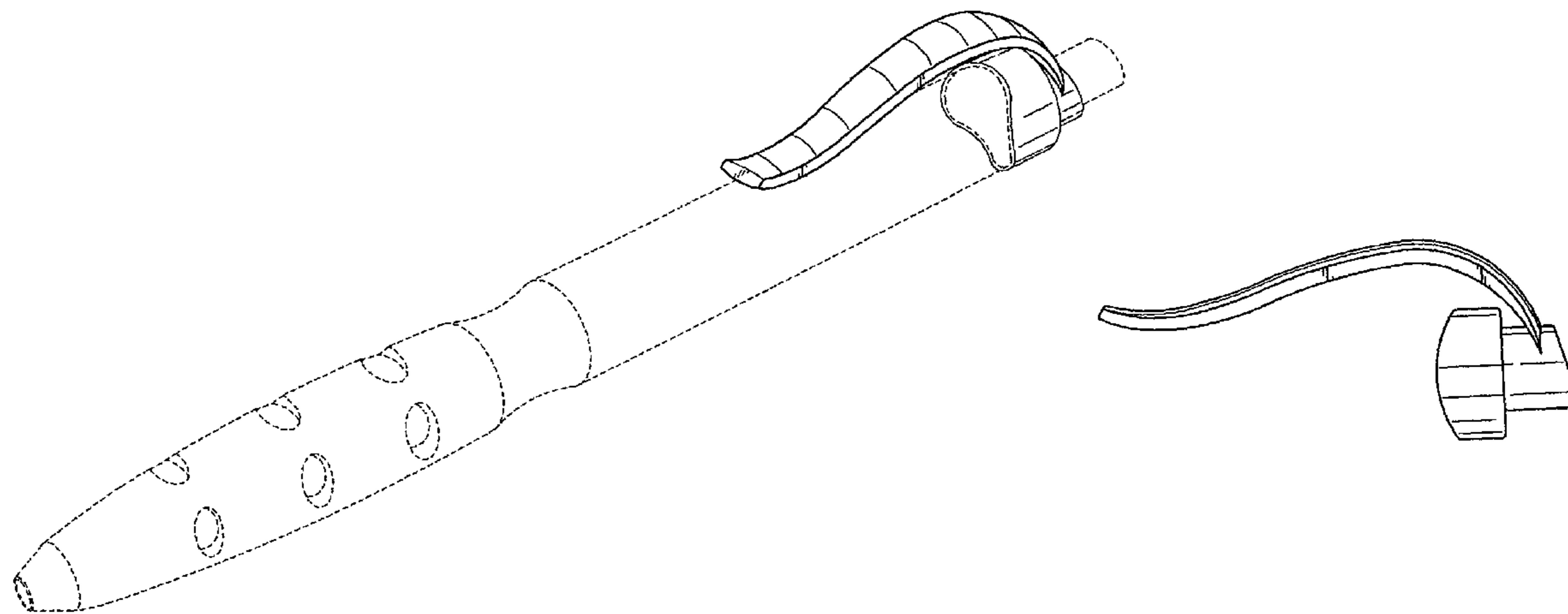
FIG. 4 is a top plan view thereof;

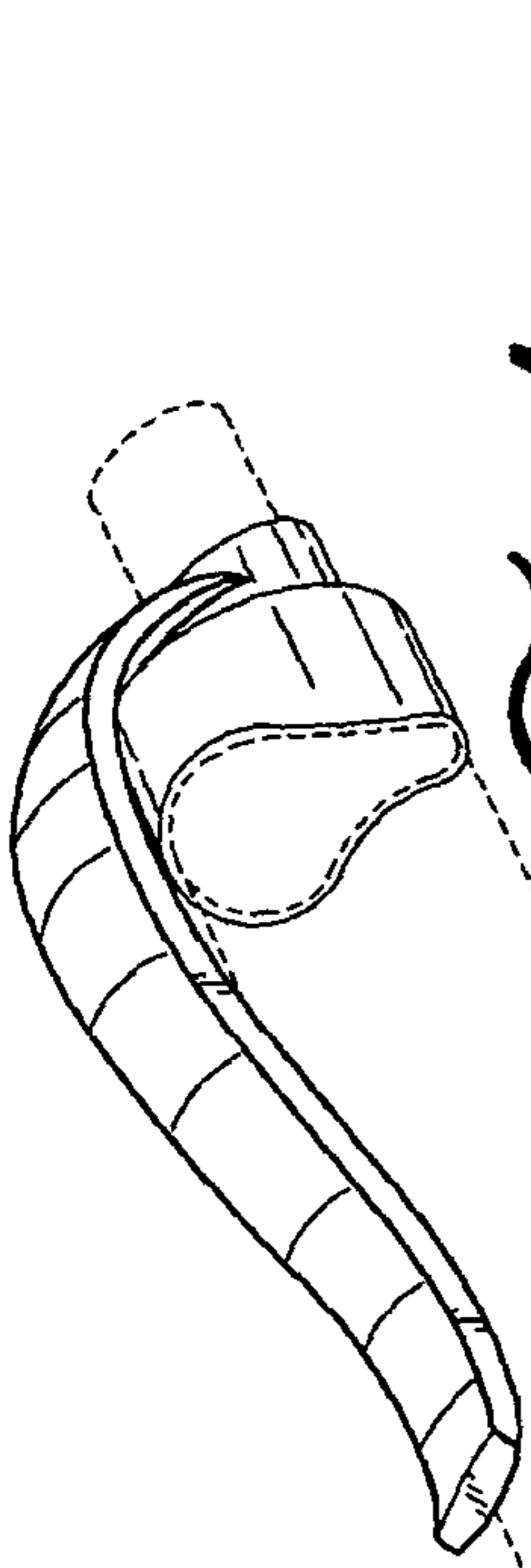

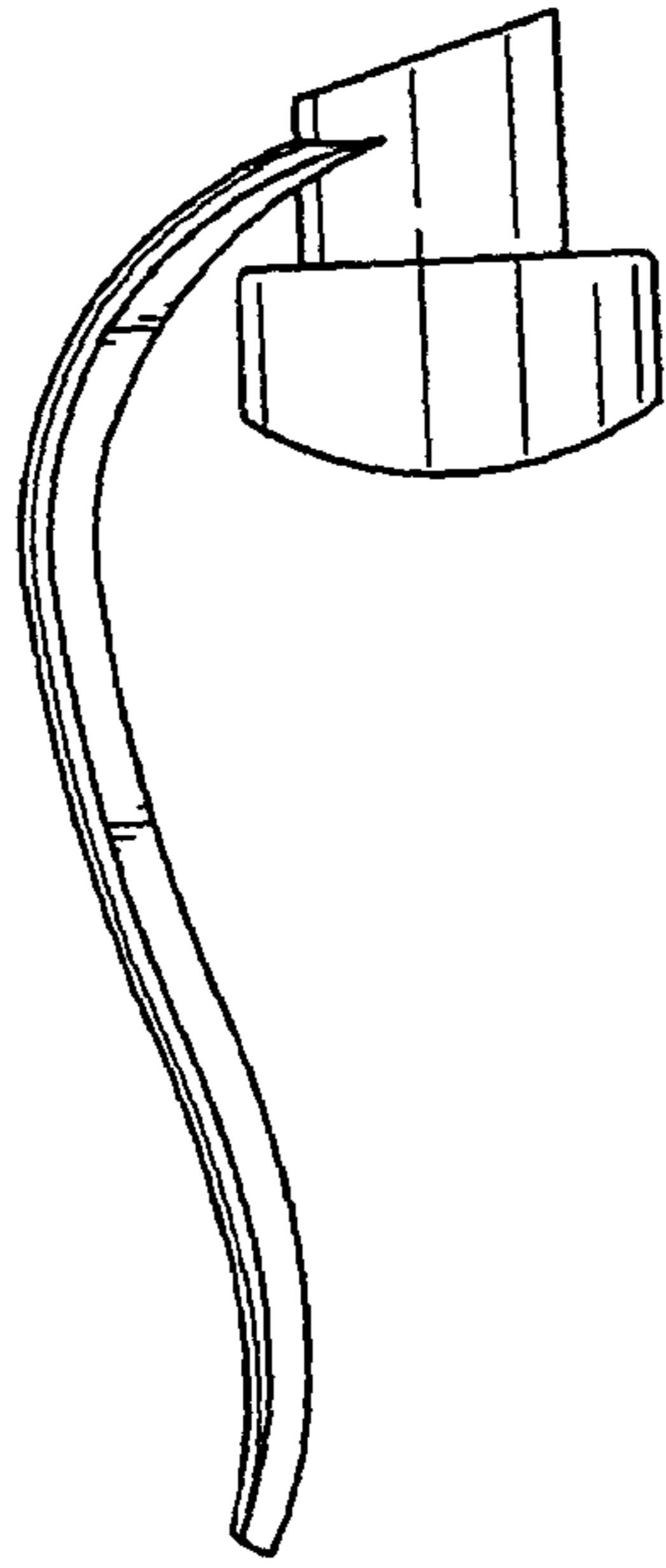

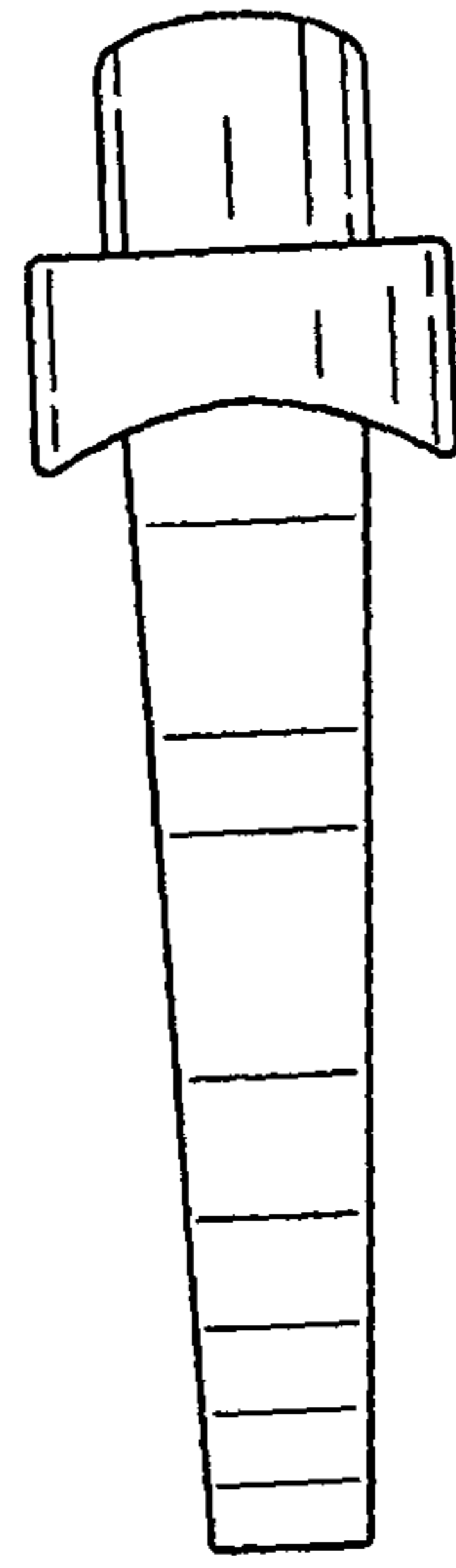

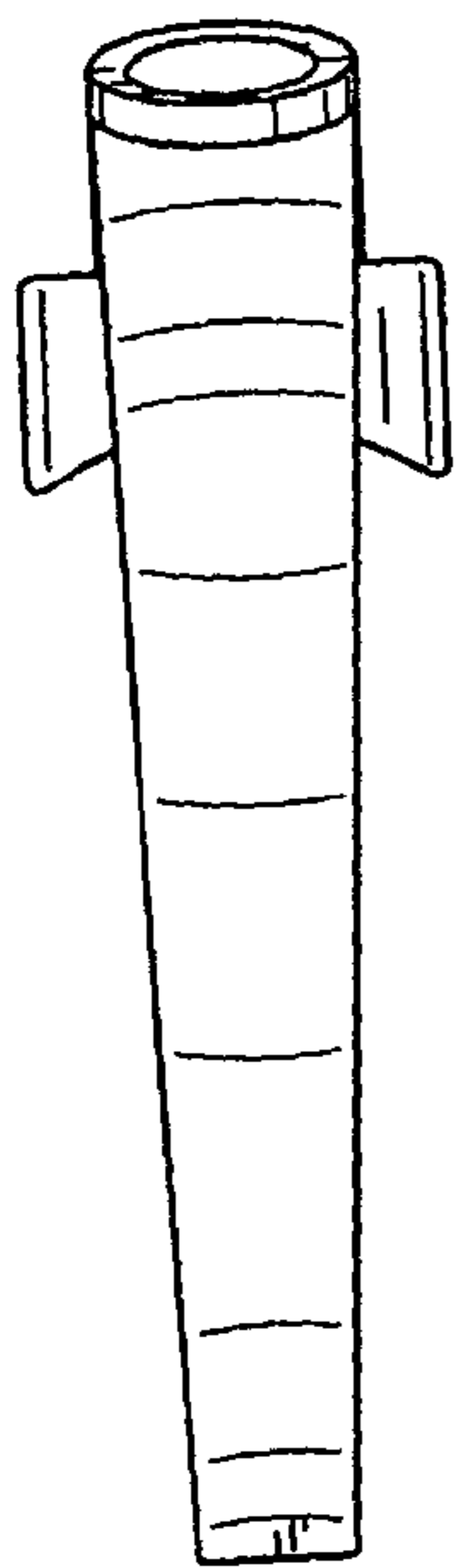

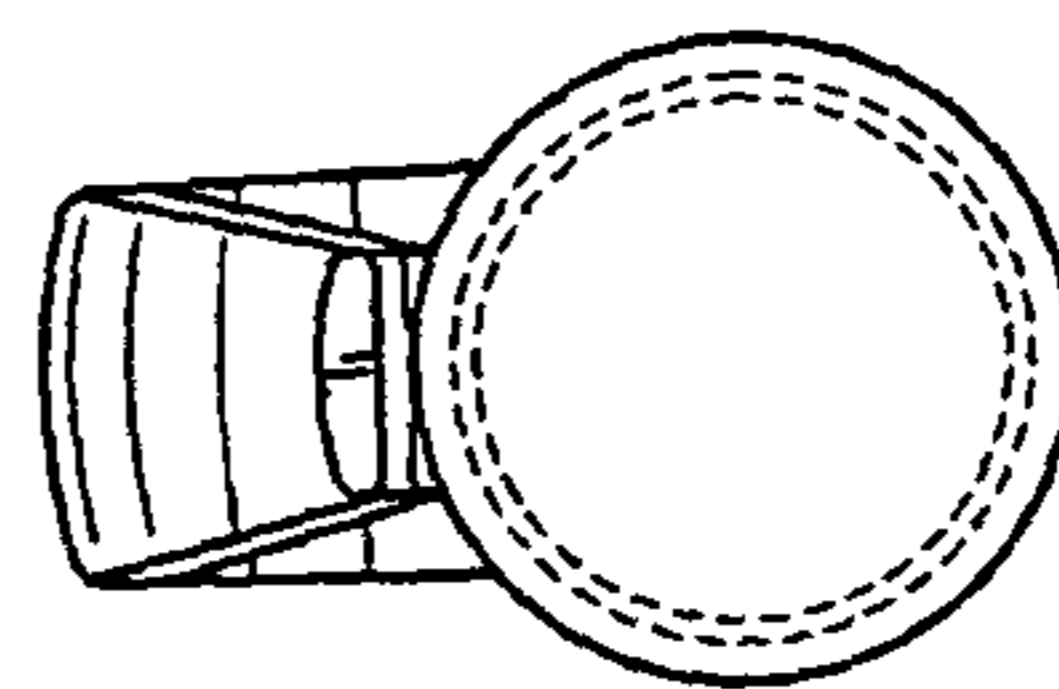
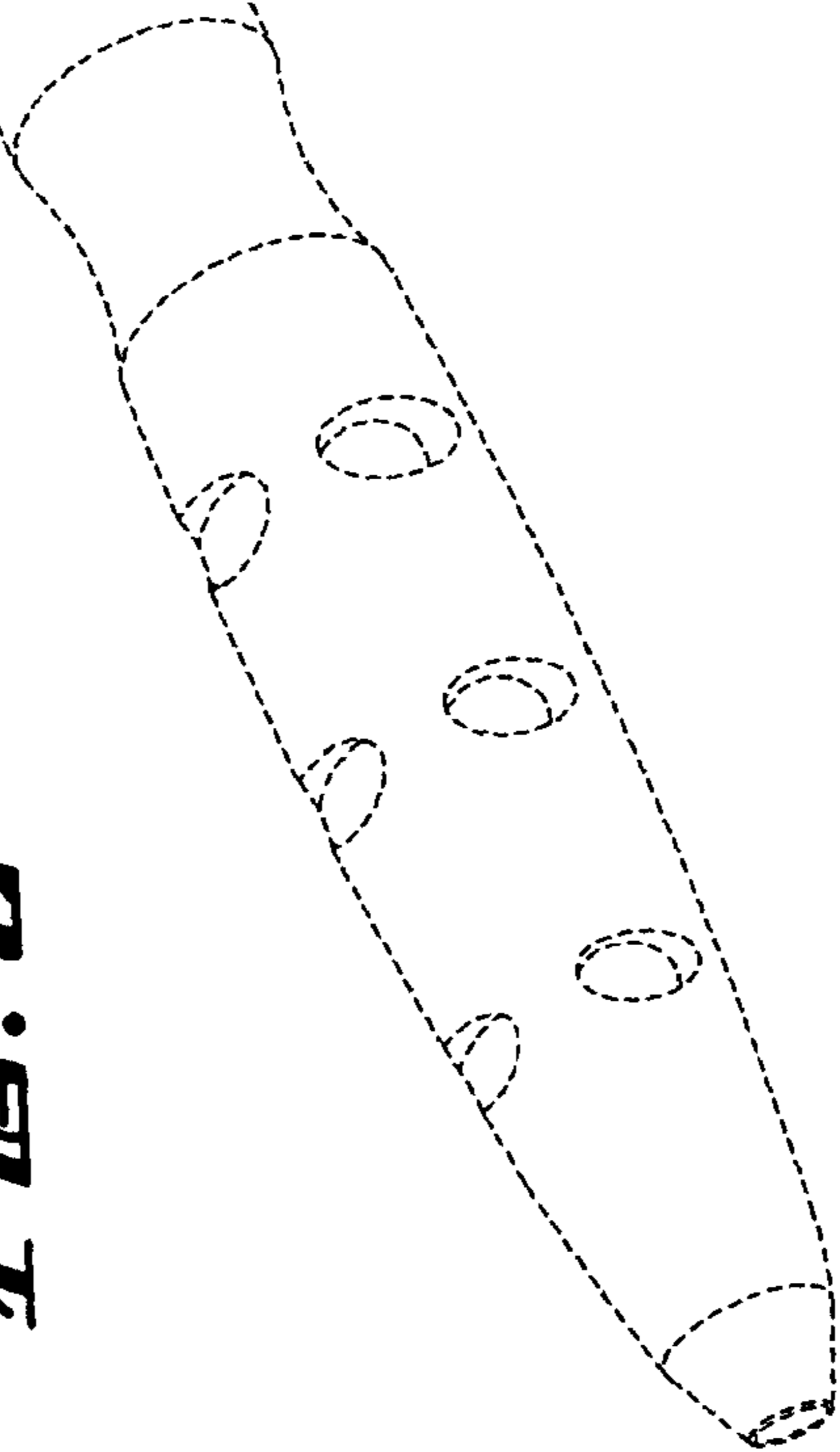

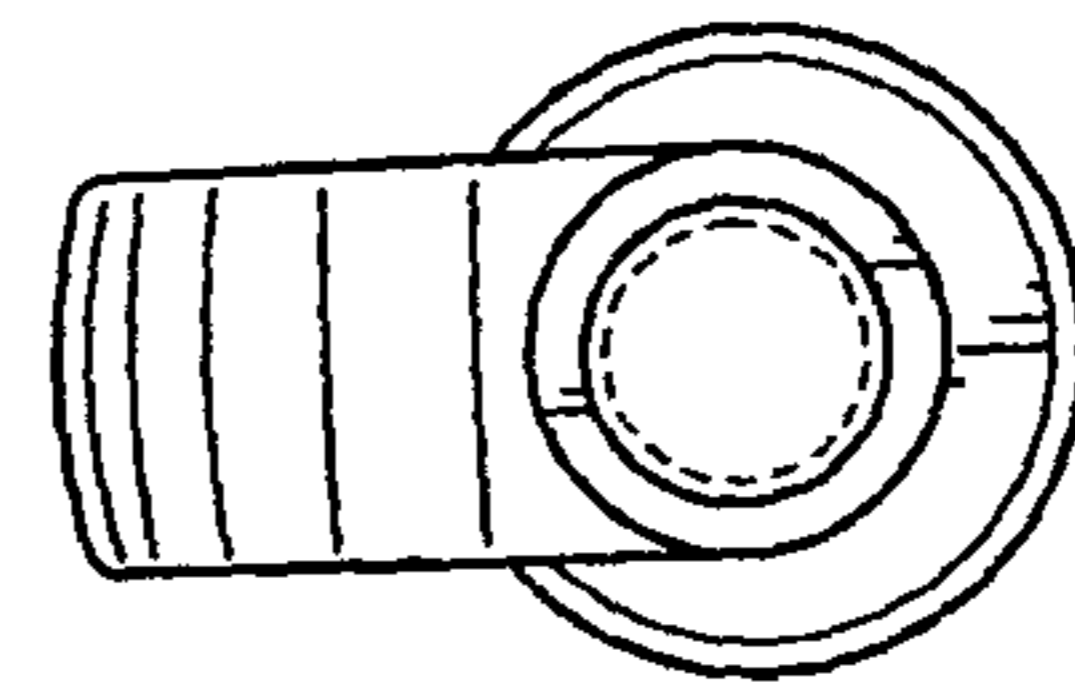
