2 thereof; and,

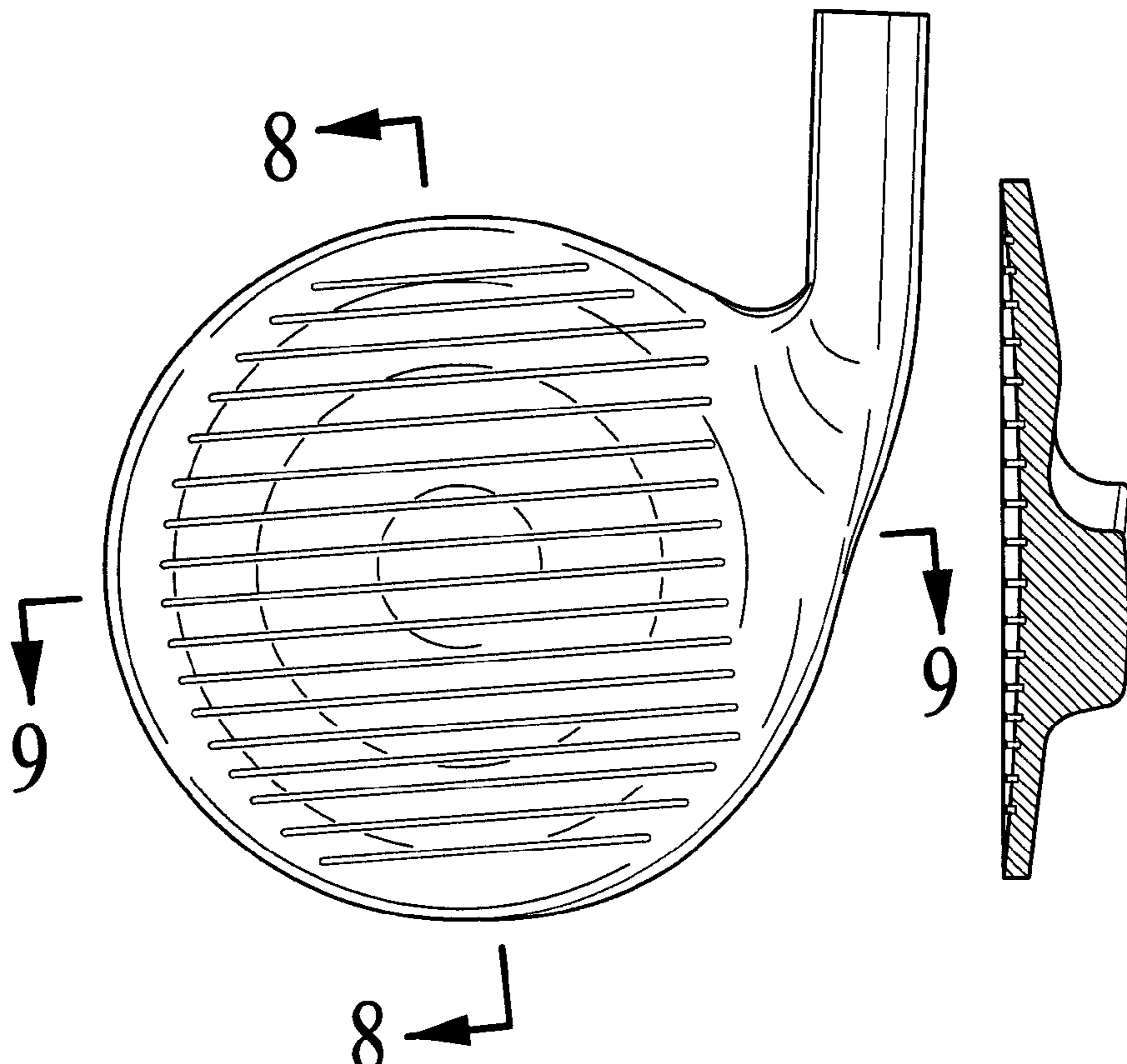
FIG. 9 is a cross-sectional view taken along line 9—9 of FIG.
2 thereof.

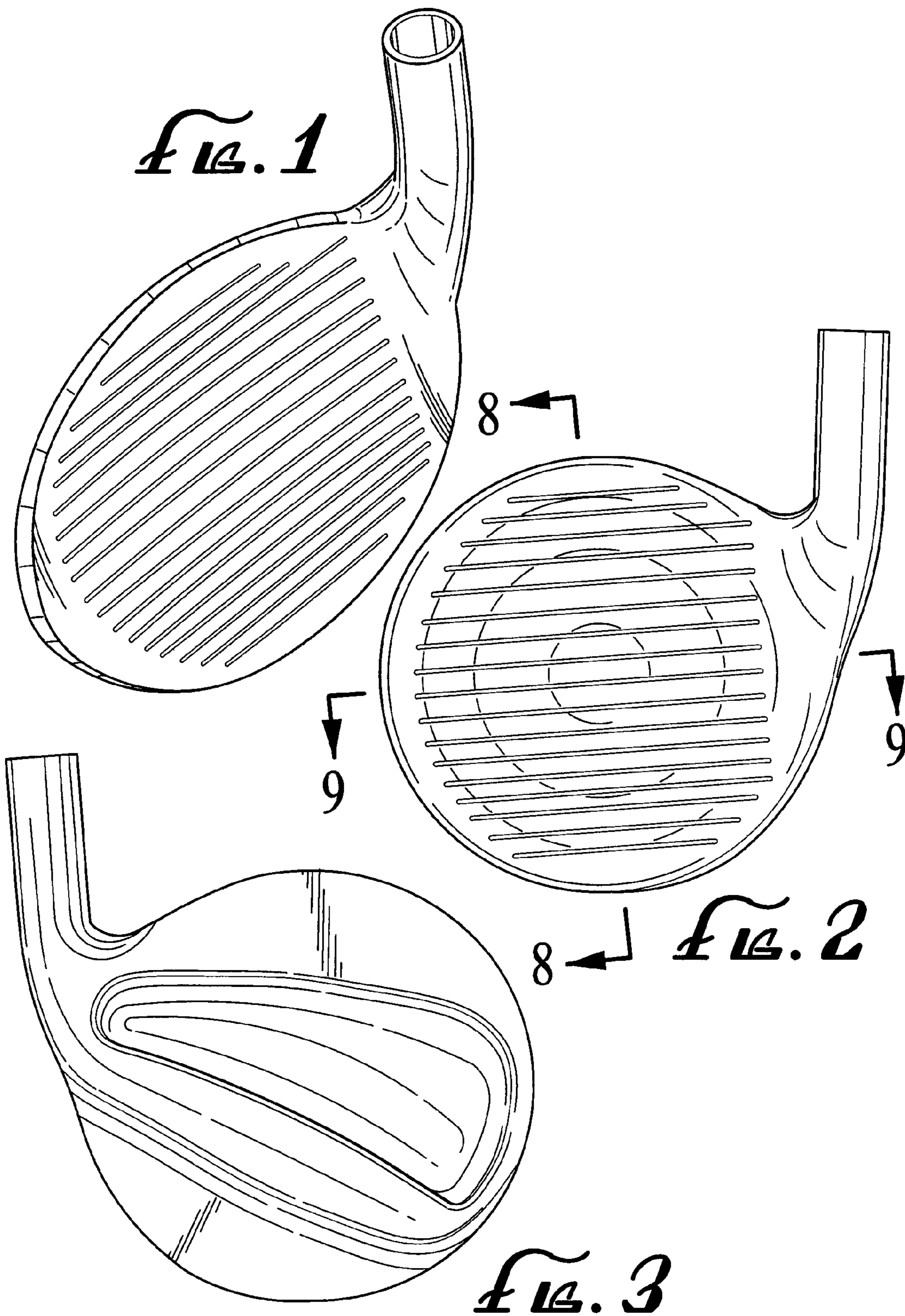

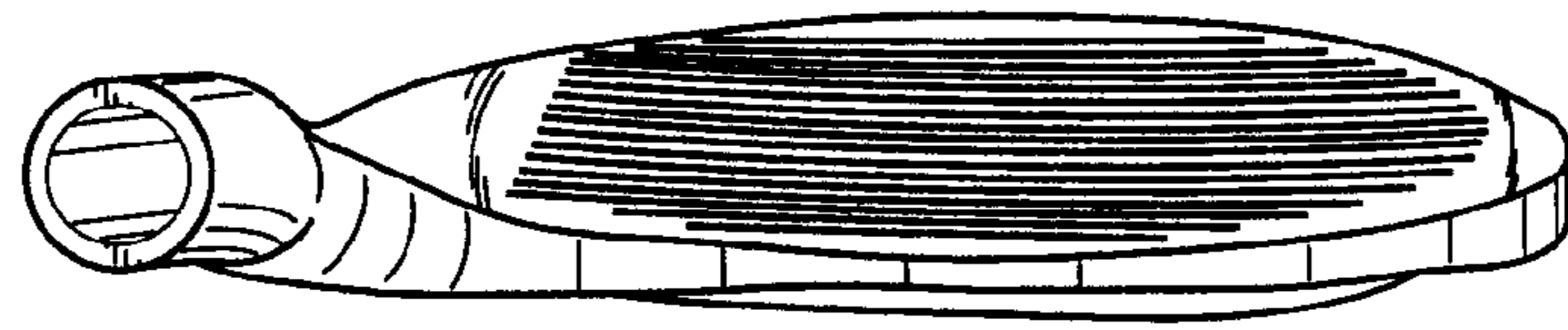

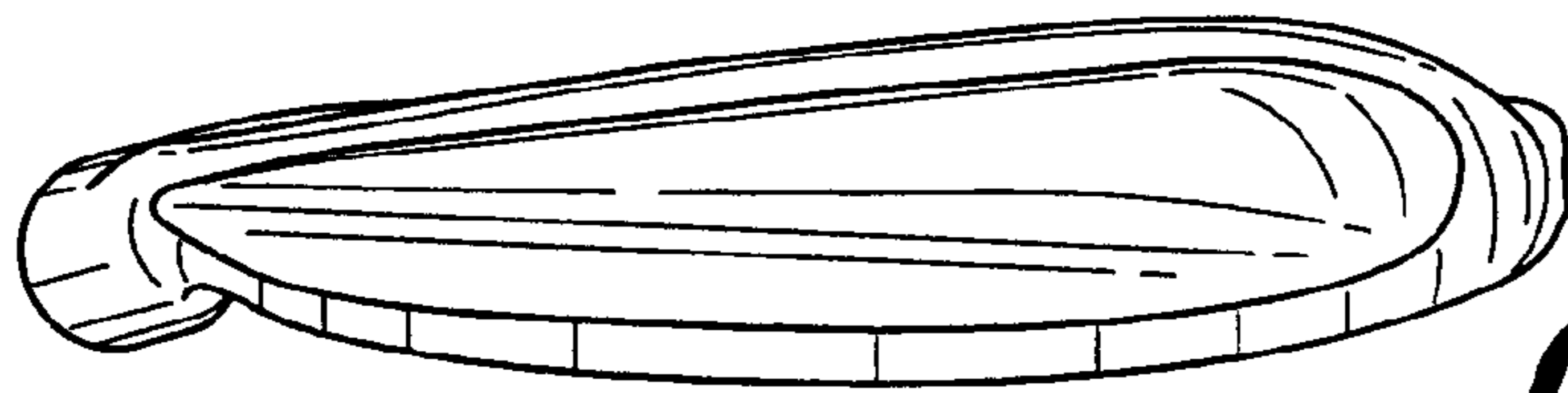

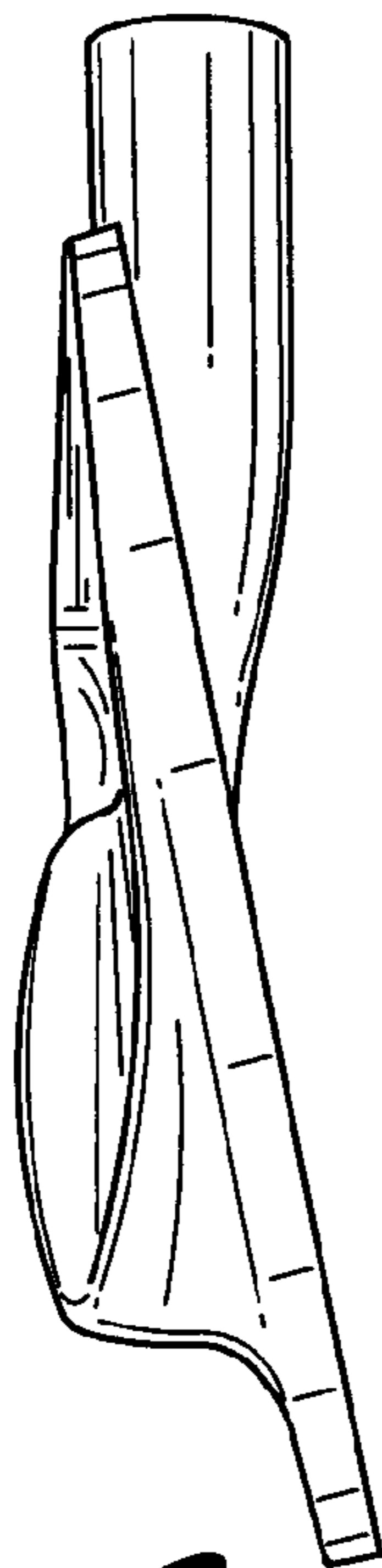

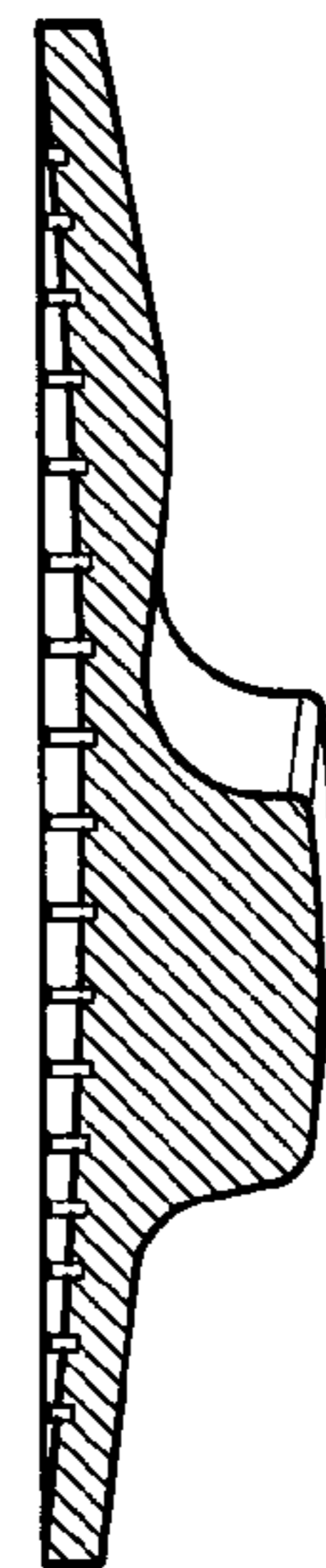

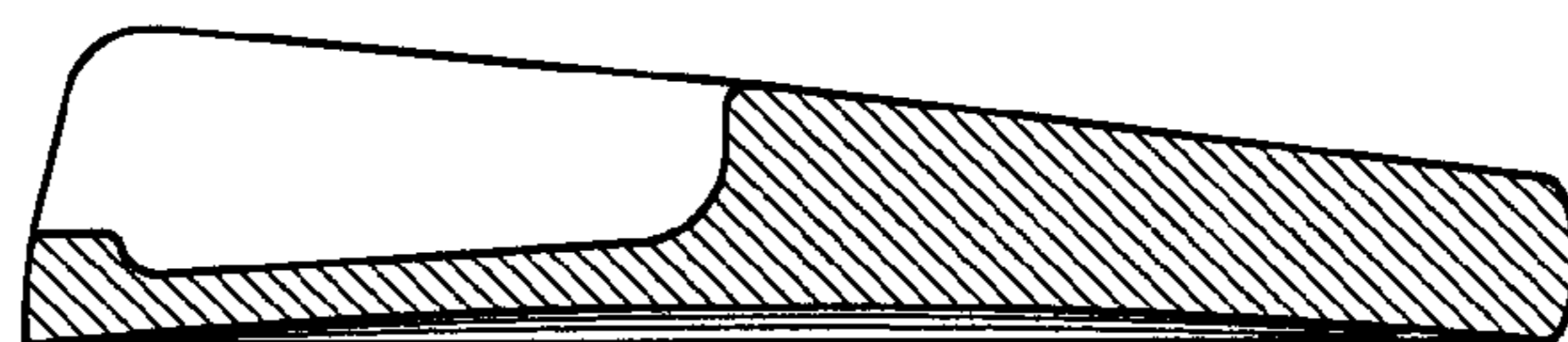
