(57) **CLAIM**

We claim the ornamental design for a combined light hardening apparatus and base unit therefor, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of the combined light hardening apparatus and base unit therefor showing our new design;

FIG. 2 is a front elevational view of the design shown in FIG. 1;

FIG. 3 is a right side elevational view of the design shown in FIG. 1;

FIG. 4 is a top plan view of the design shown in FIG. 1;

FIG. 5 is a left side elevational view of the design shown in FIG. 1;

FIG. 6 is a rear view of the design shown in FIG. 1;

FIG. 7 is a bottom view of the design shown in FIG. 1, the structural environment being shown in broken lines;

FIG. 8 is a perspective view of the base unit of the combined light hardening apparatus and base unit therefor showing our new design;

FIG. 9 is a front elevational view of the design shown in FIG. 8;

FIG. 10 is a right side elevational view of the design shown in FIG. 8;

FIG. 11 is a top plan view of the design shown in FIG. 8;

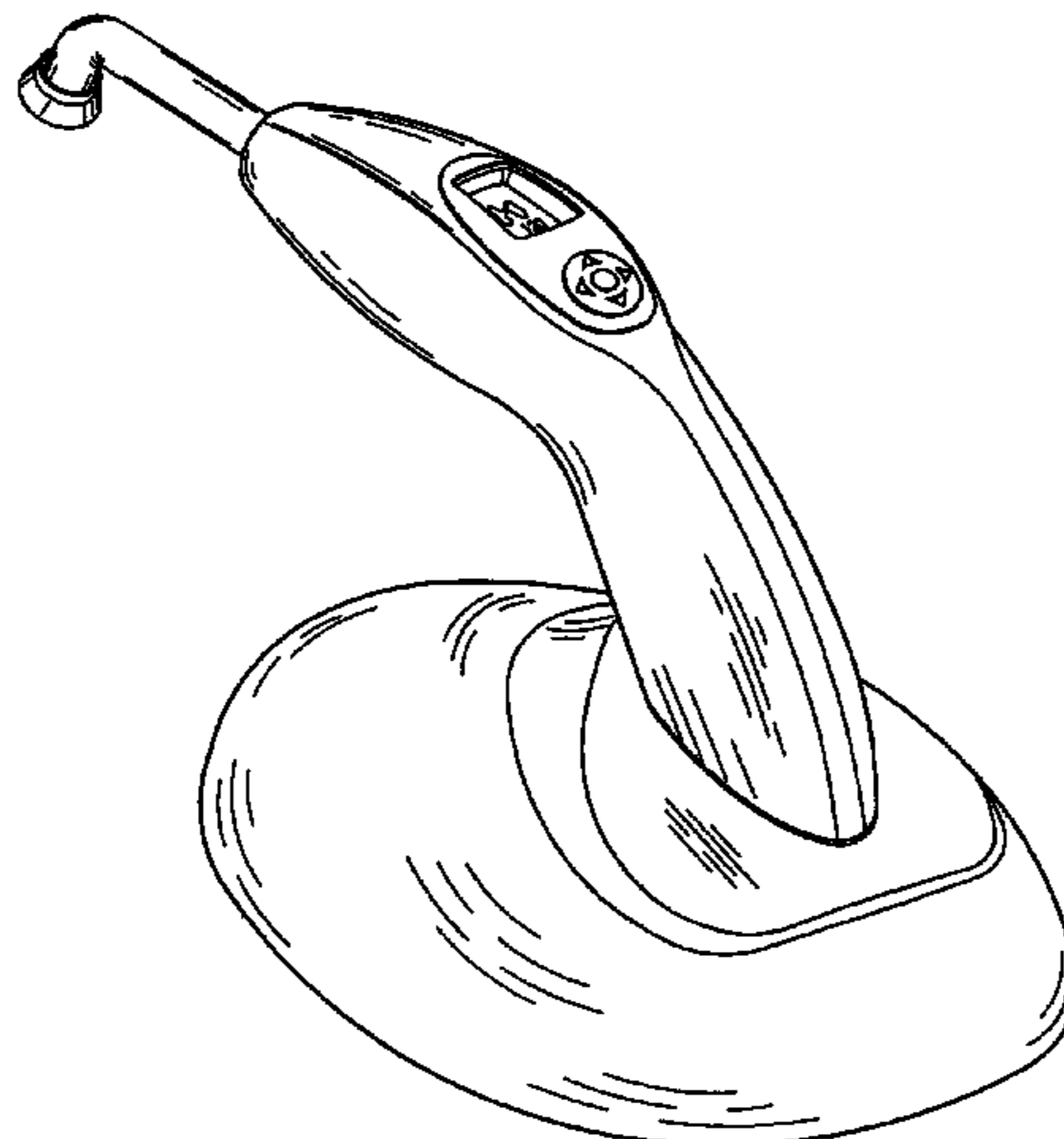
FIG. 12 is a left side elevational view of the design shown in FIG. 8;

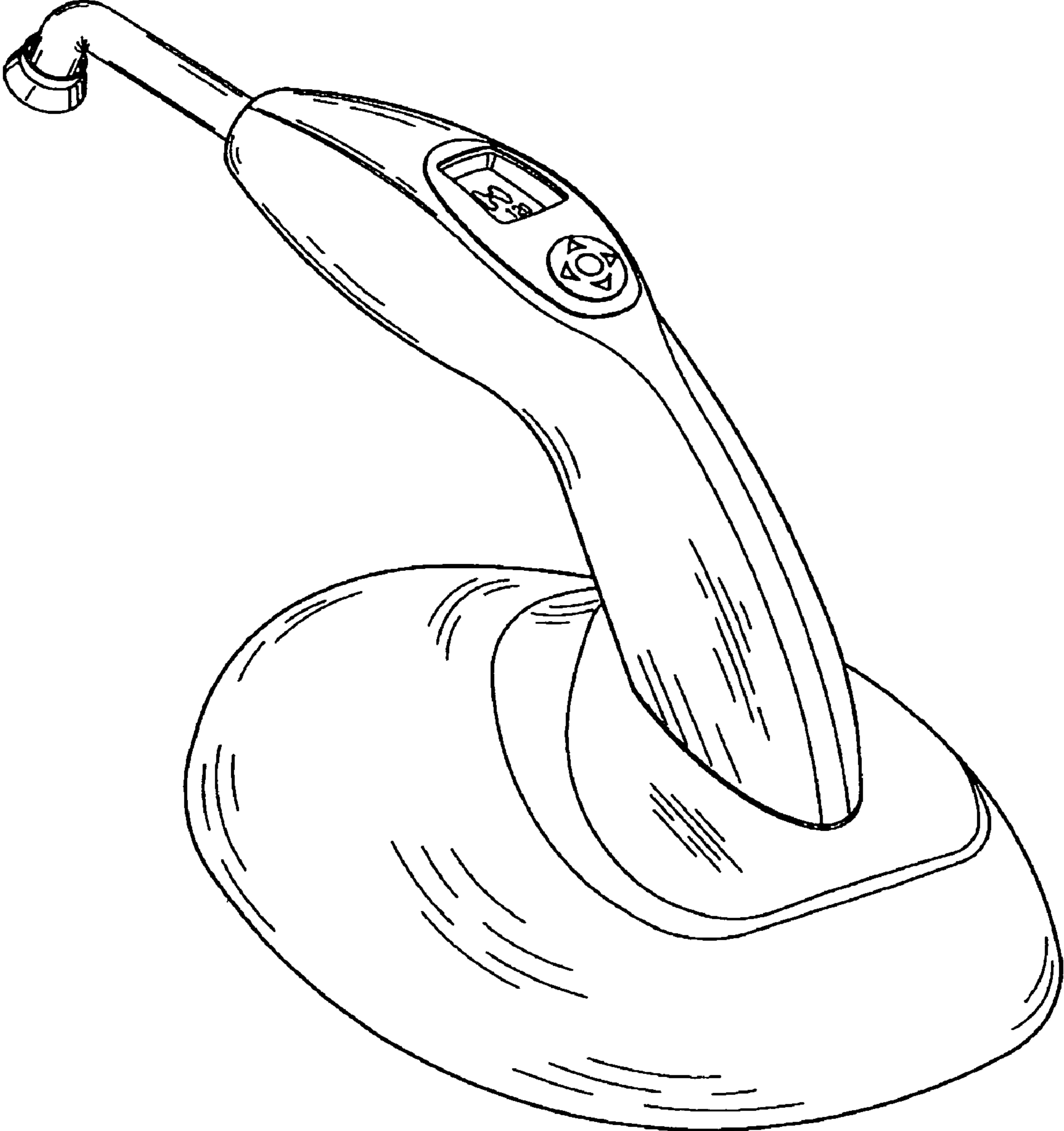

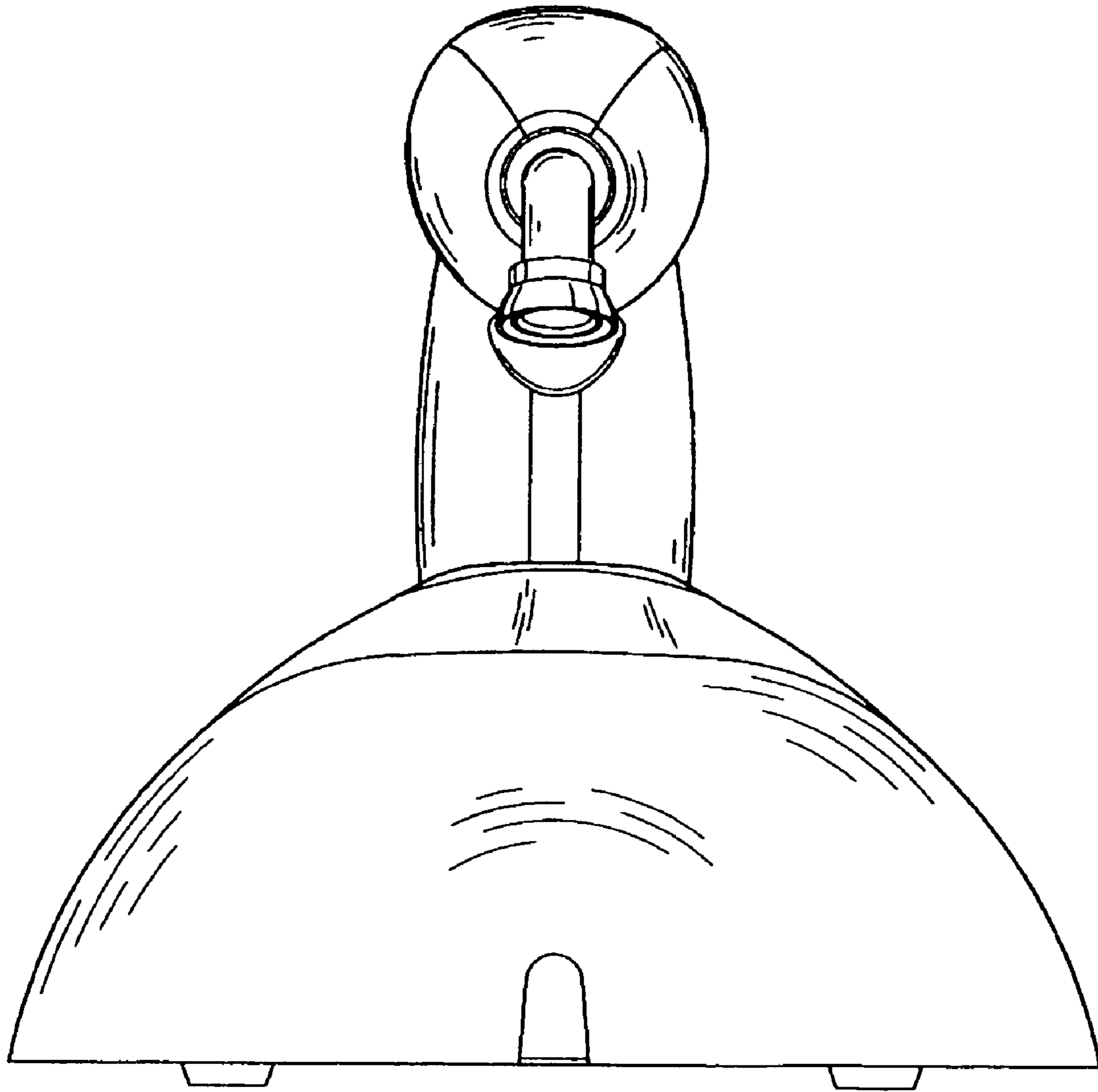

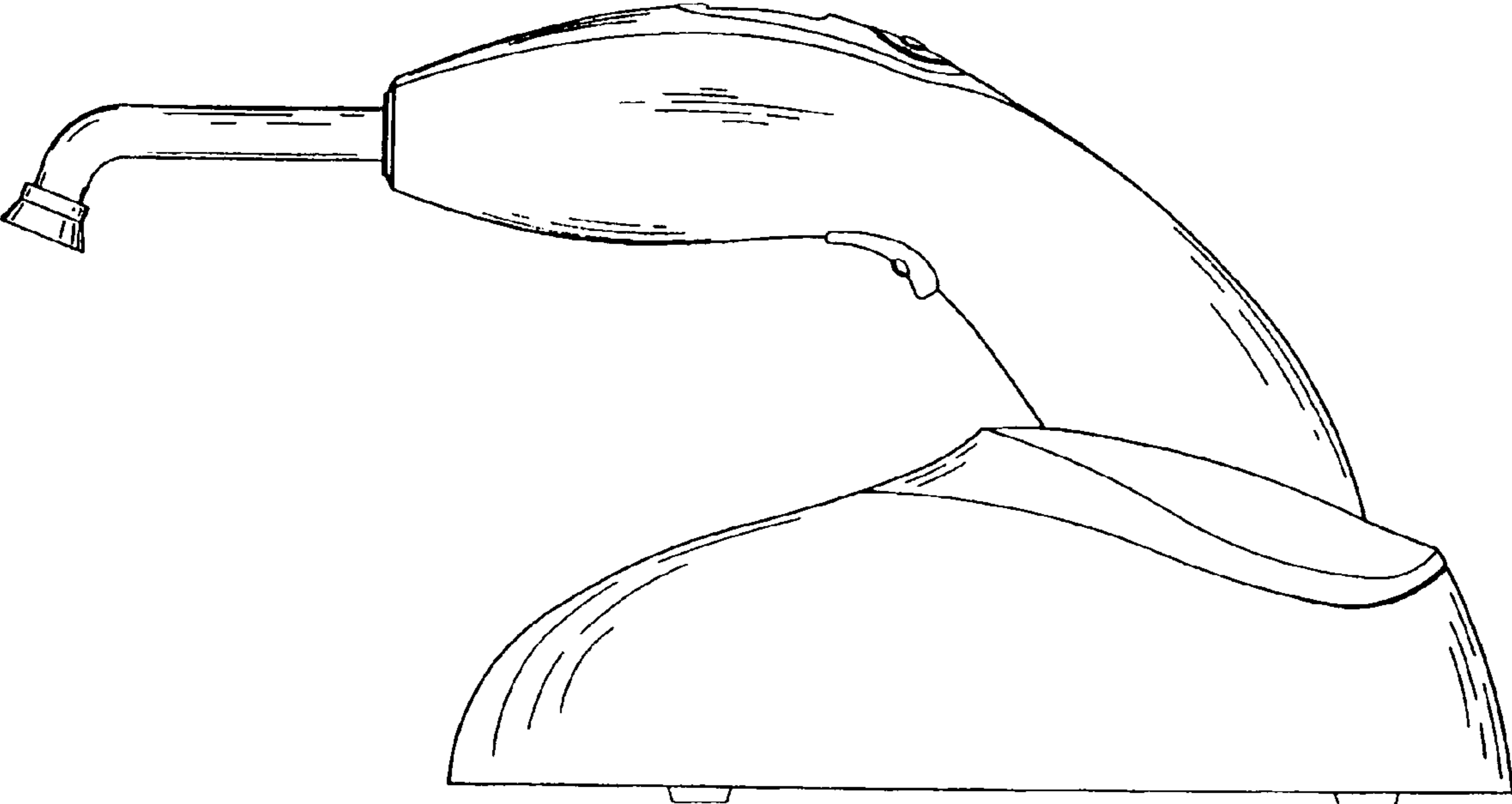

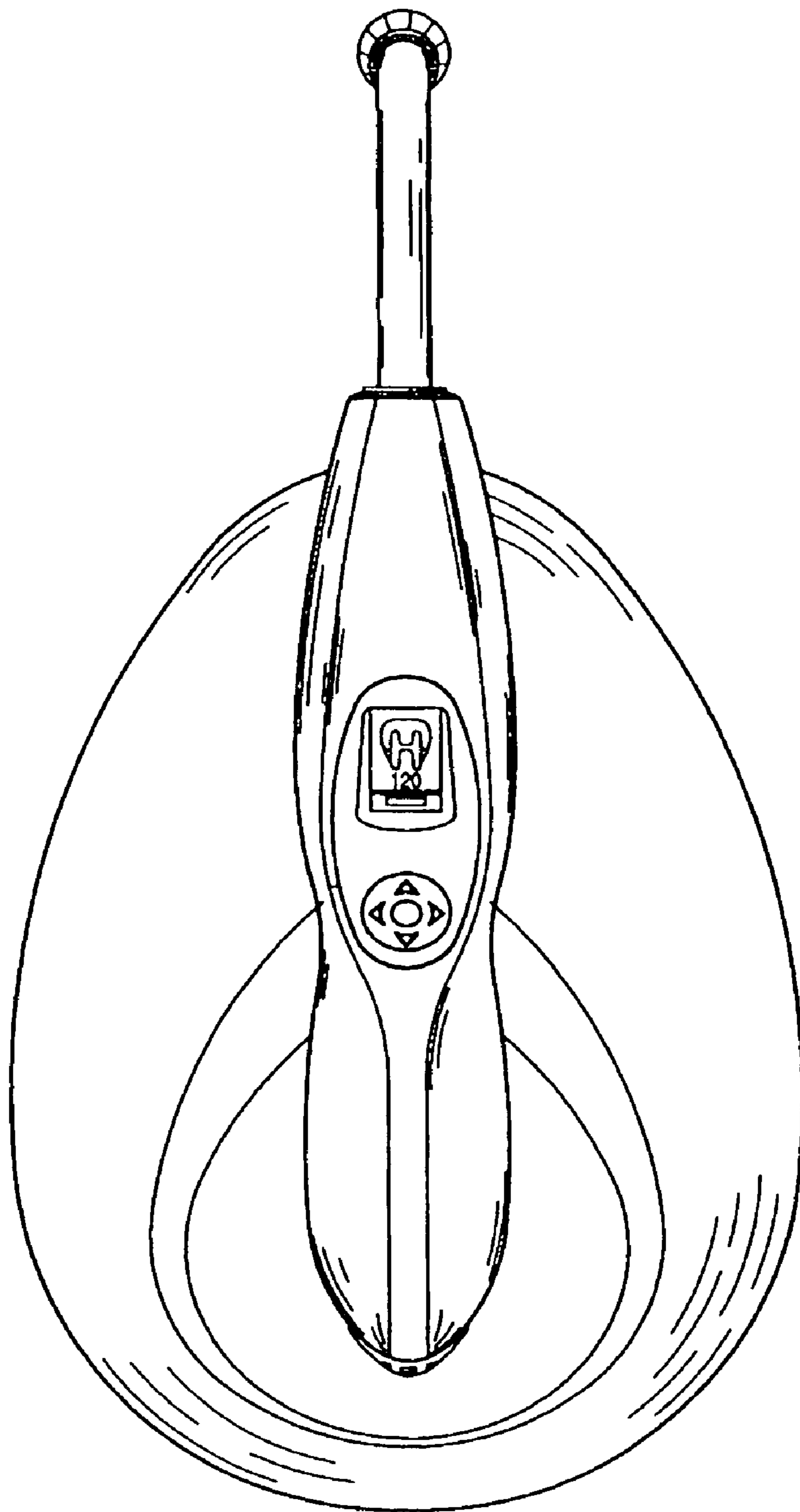

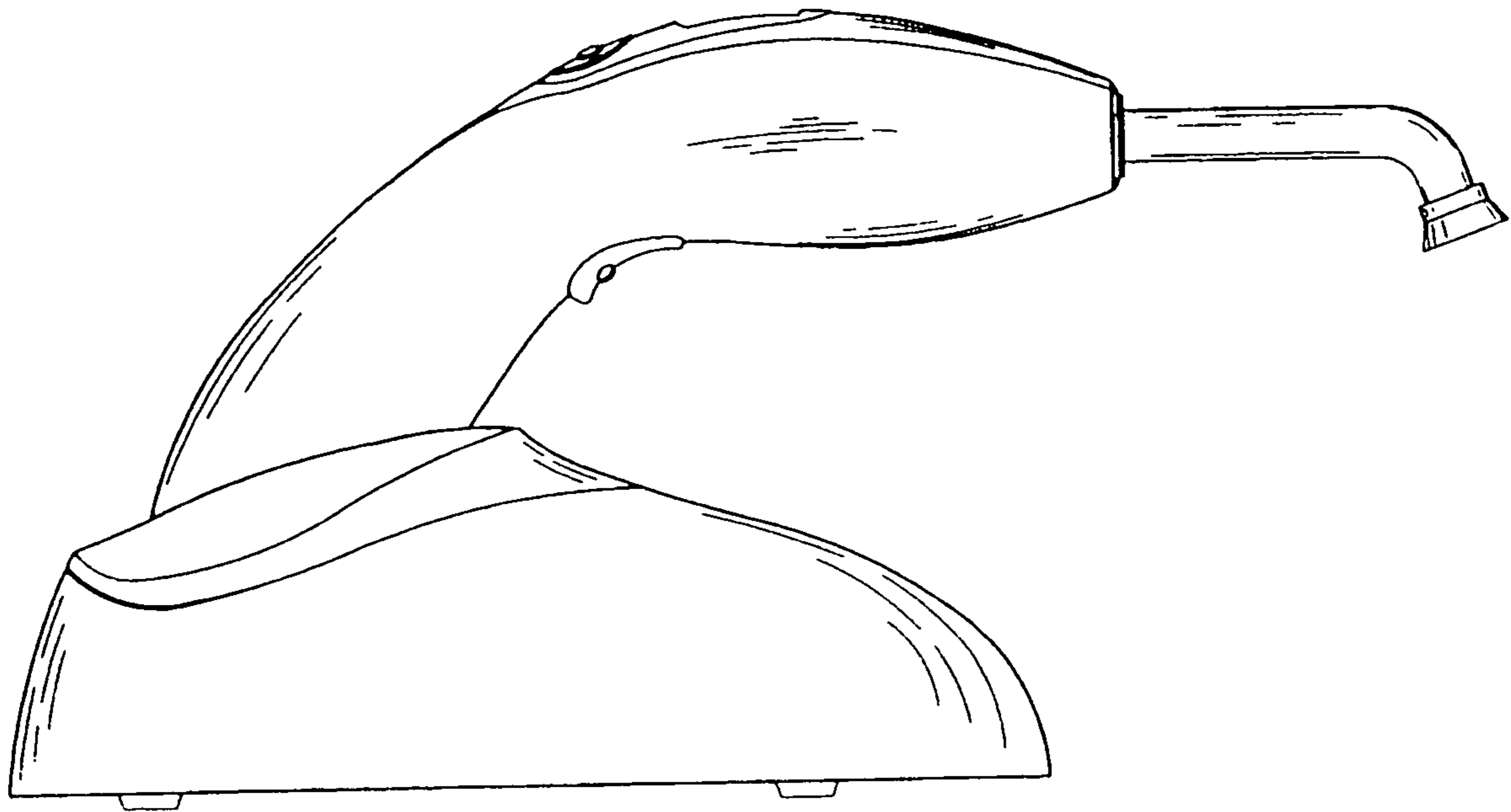

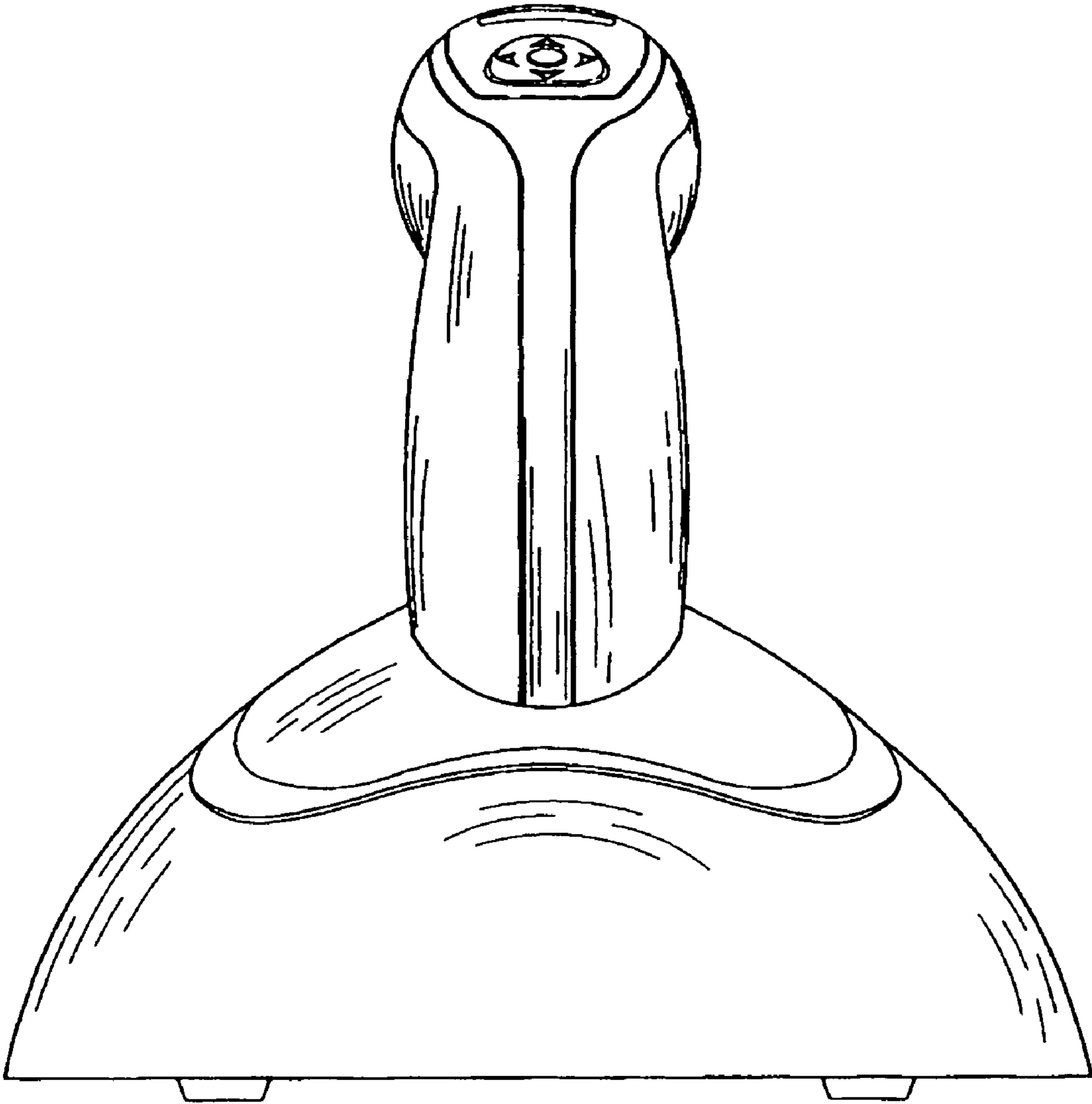

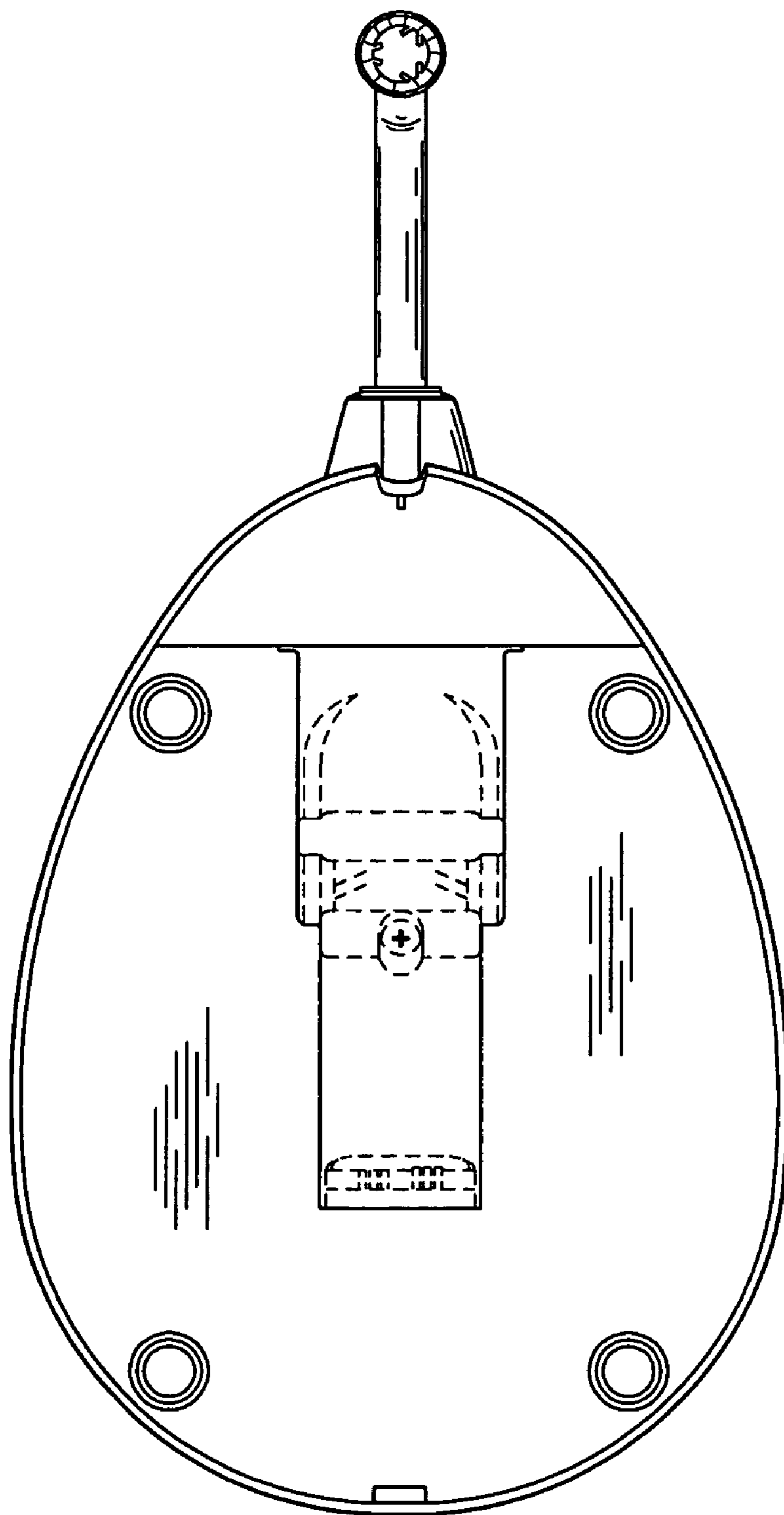

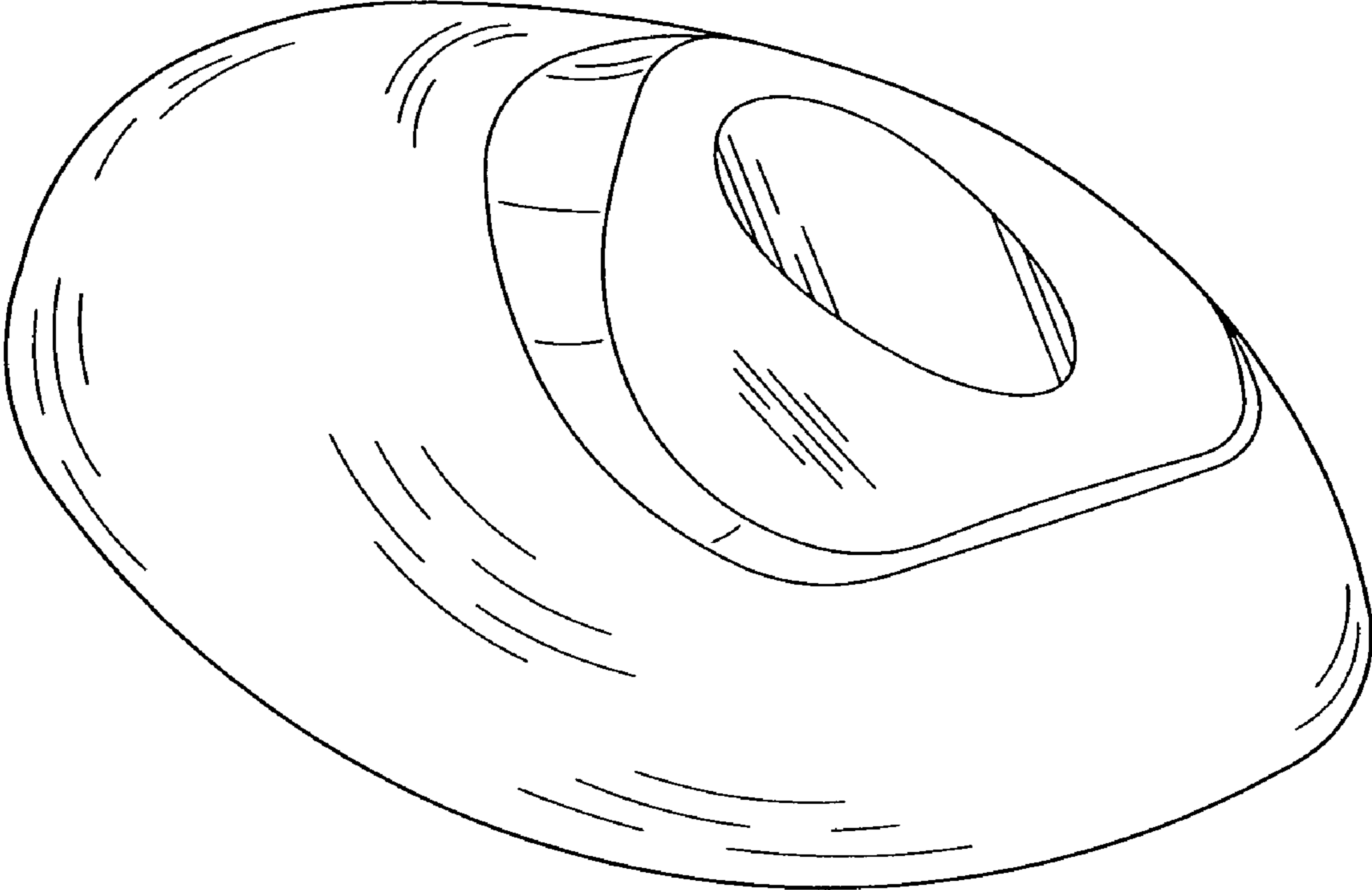

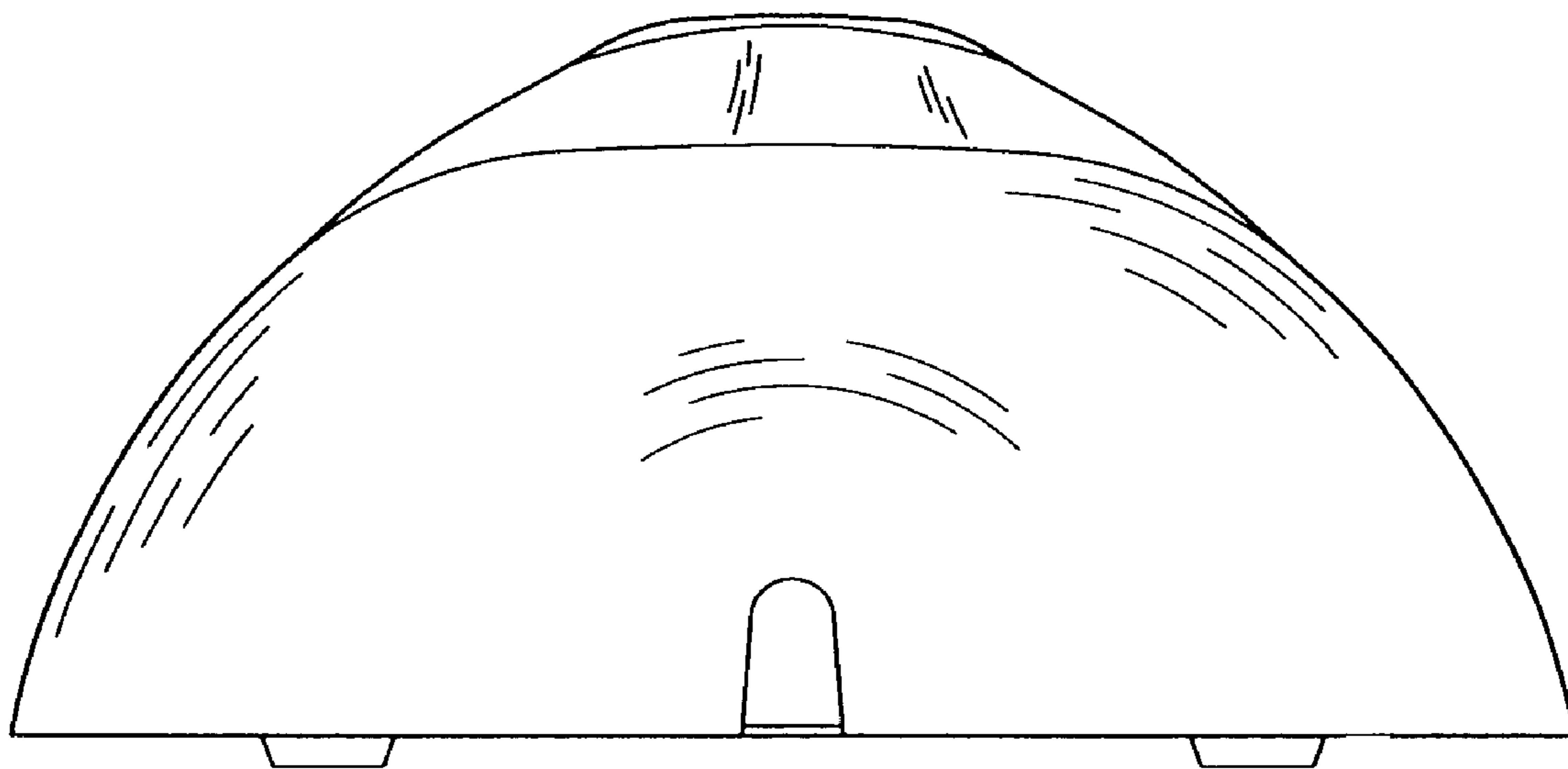

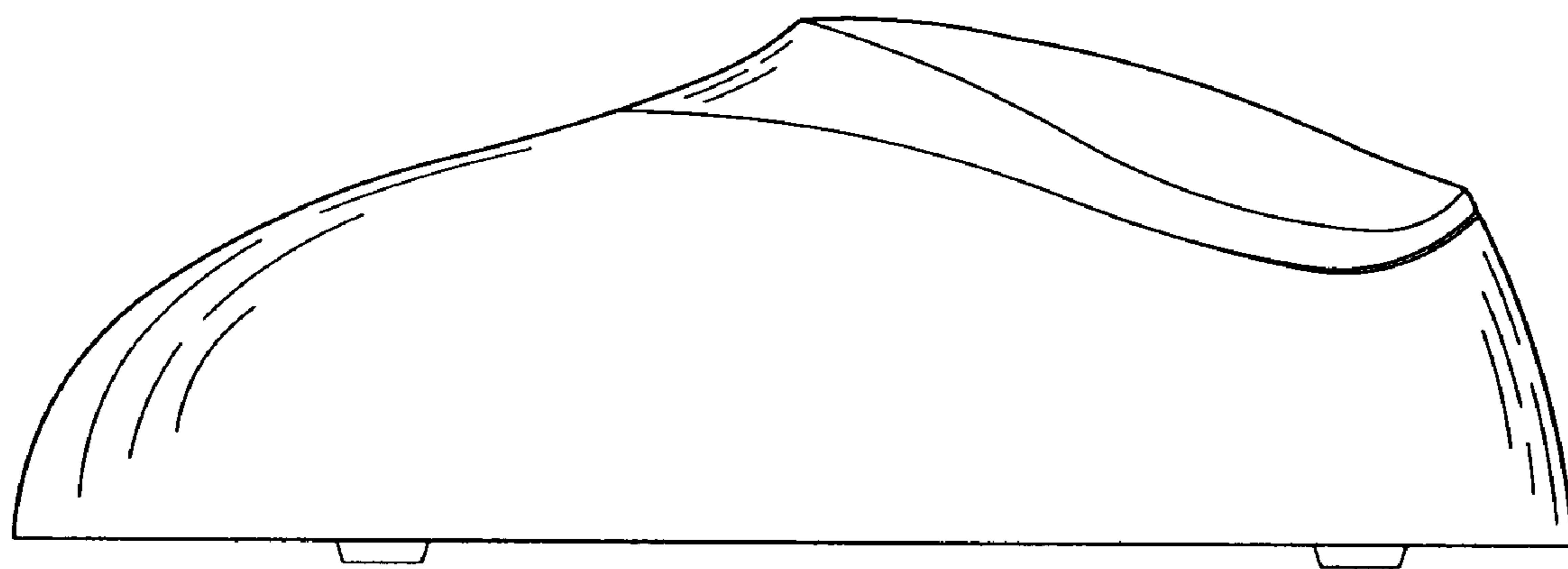

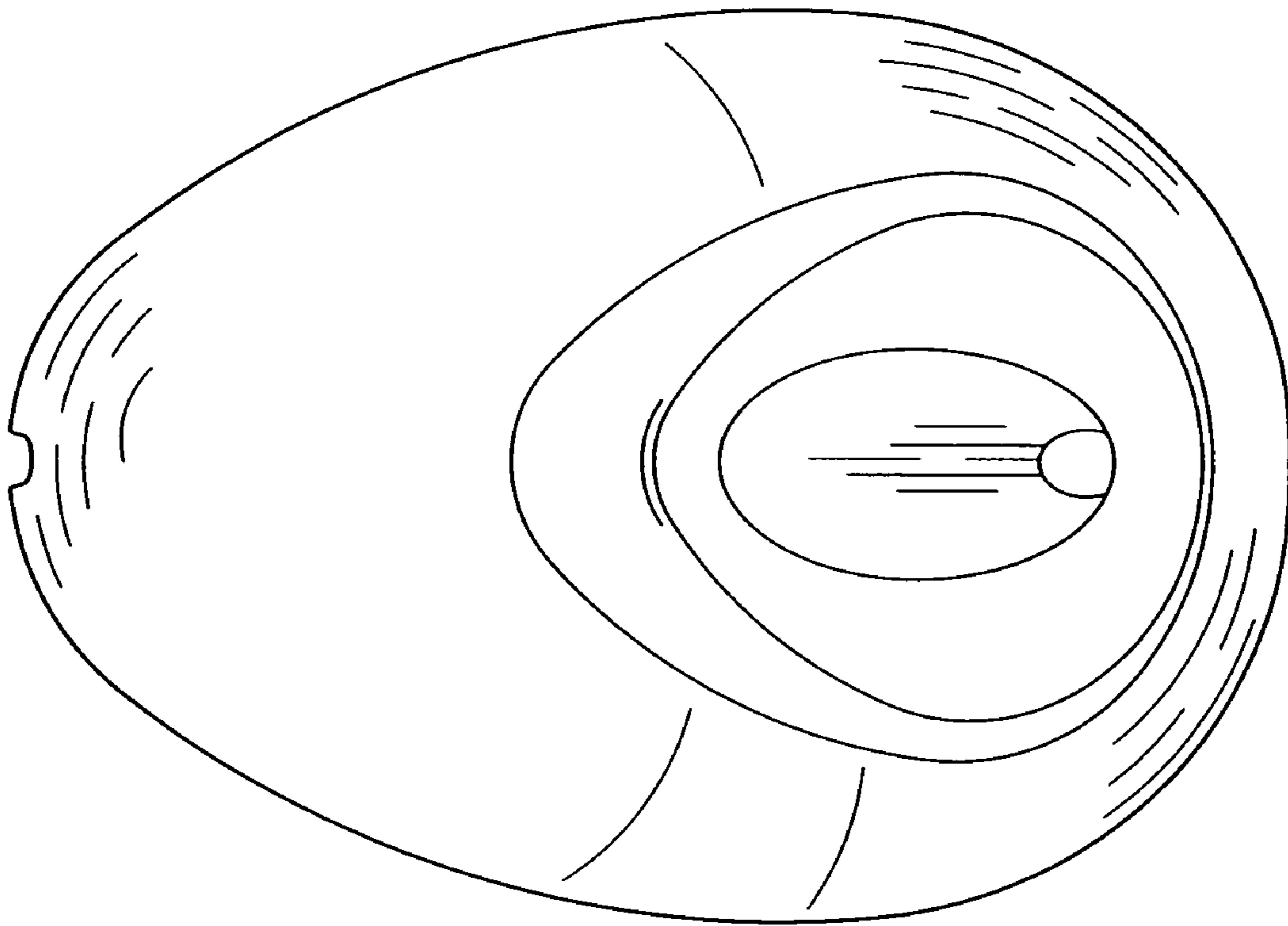

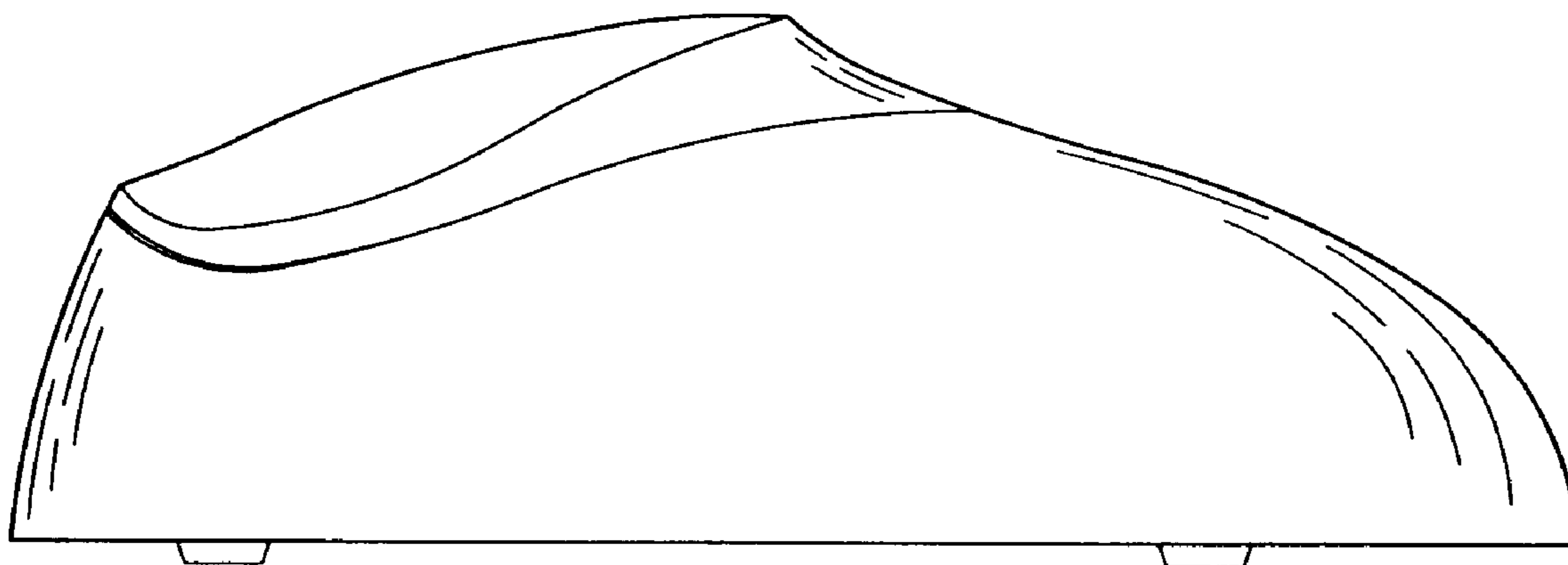

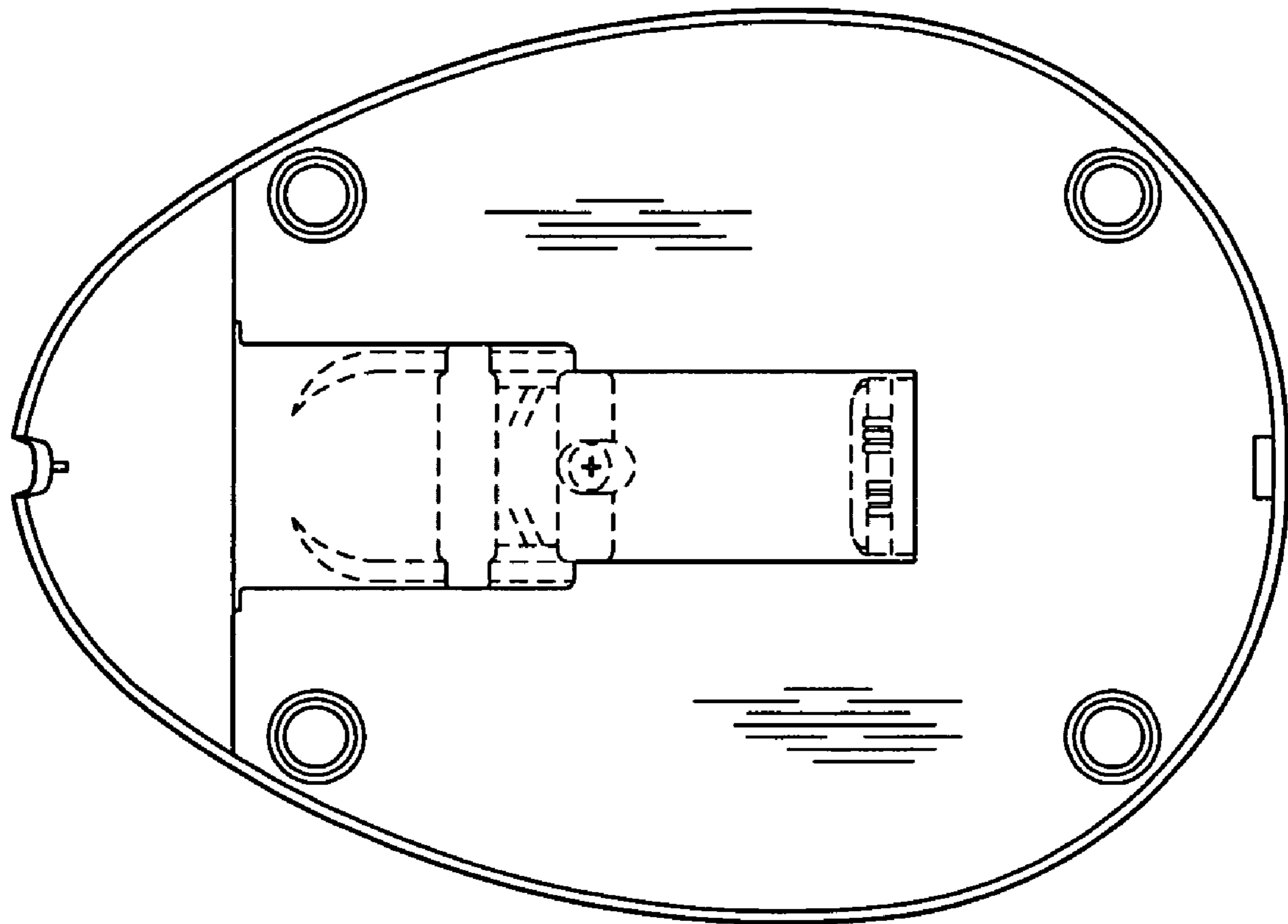

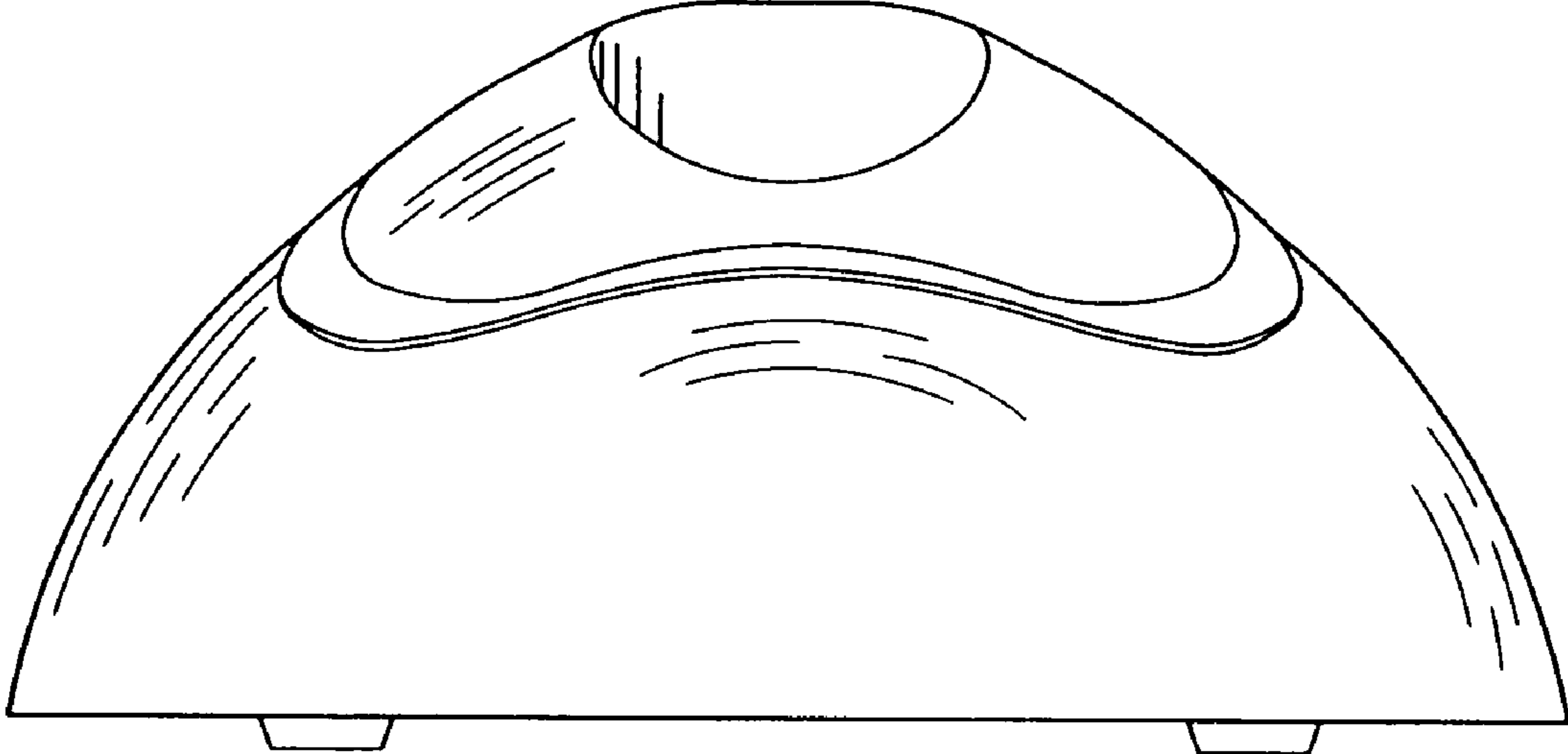
