The ornamental design for a two chamber tissue container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a two chamber tissue container in accordance with an embodiment of the present invention;

FIG. 2 is a front view thereof;

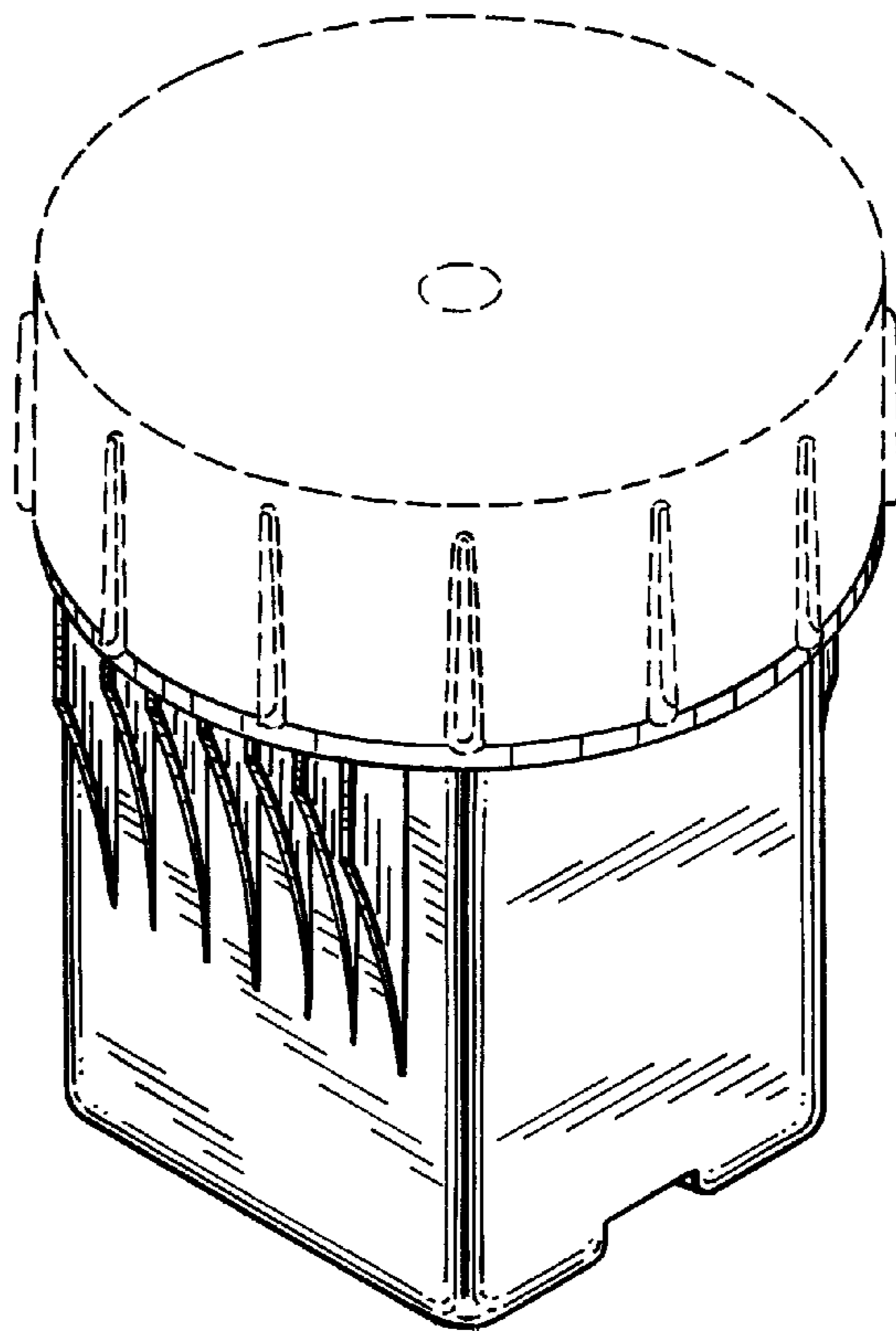
FIG. 3 is a left side view thereof, the right side view being a mirror image;

FIG. 4 is a rear view thereof; and,

FIG. 5 is a bottom plan view thereof.

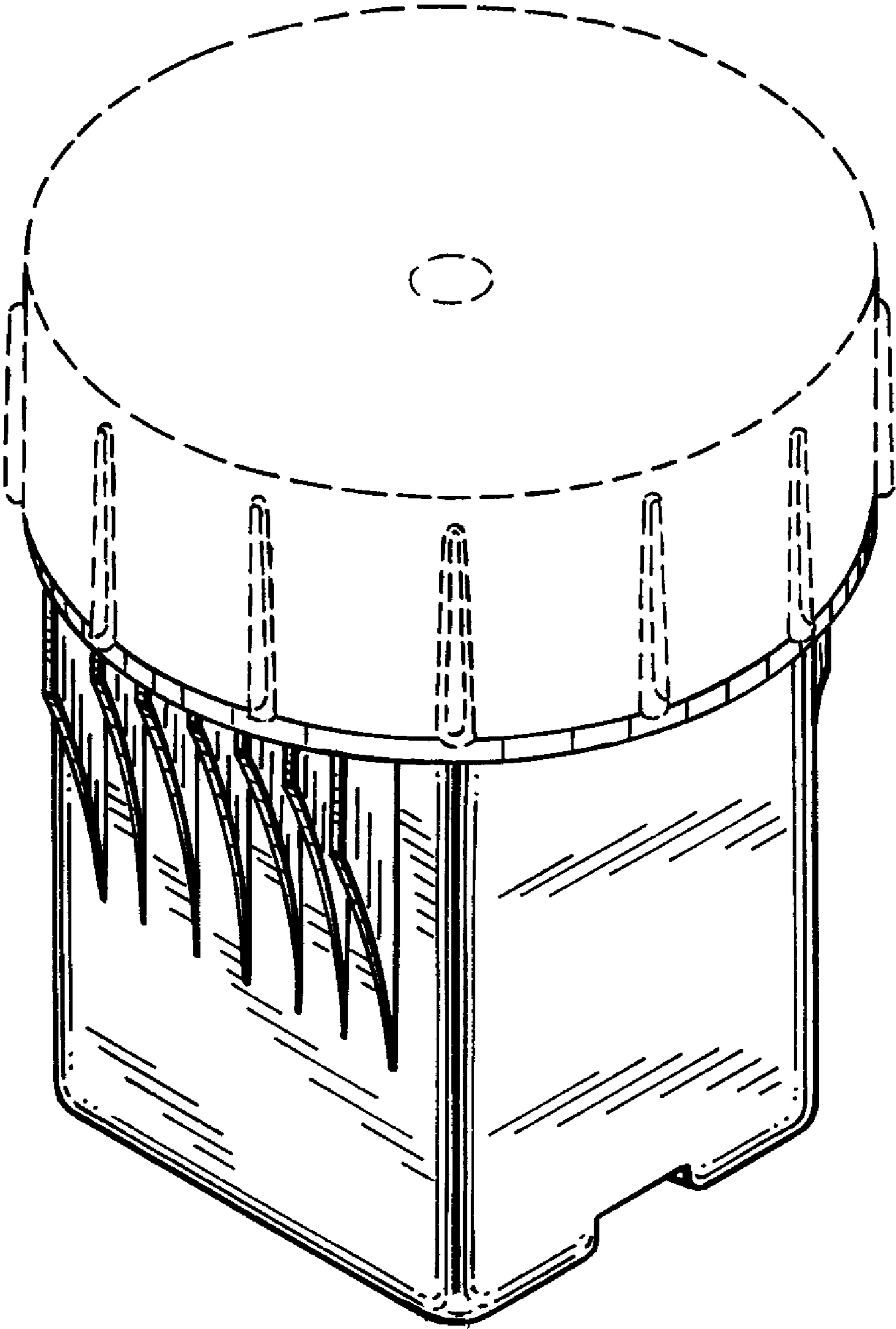

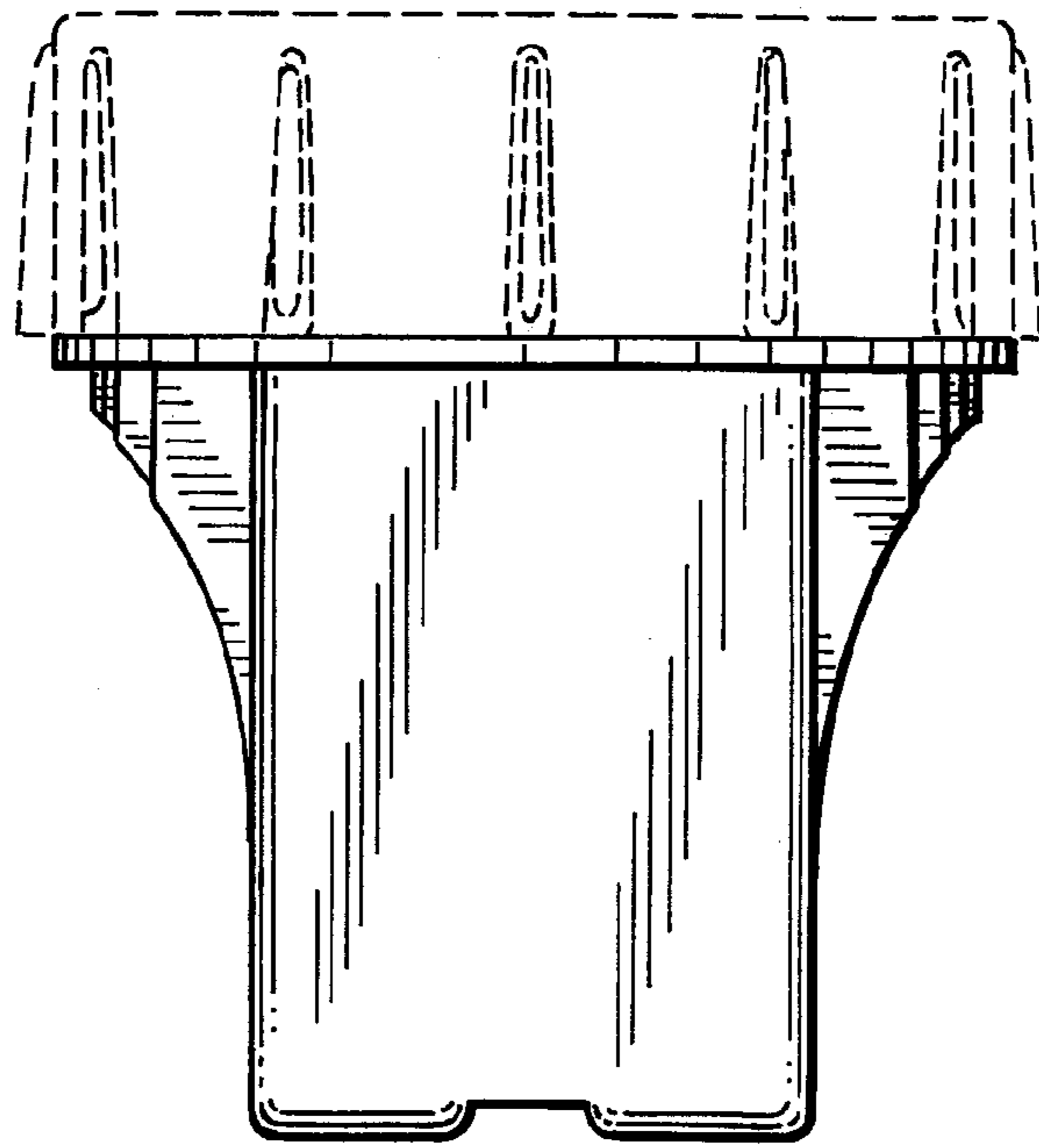

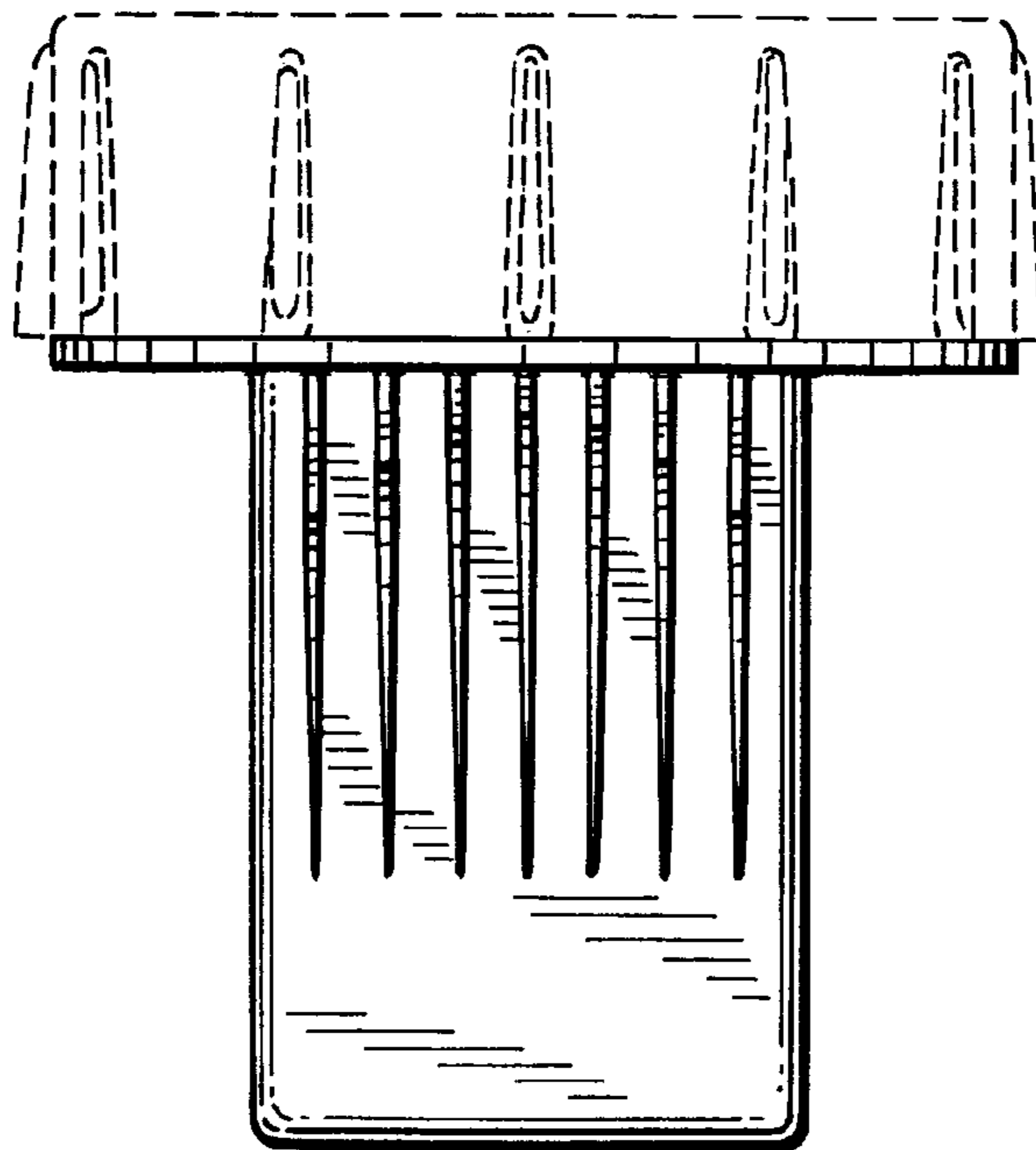

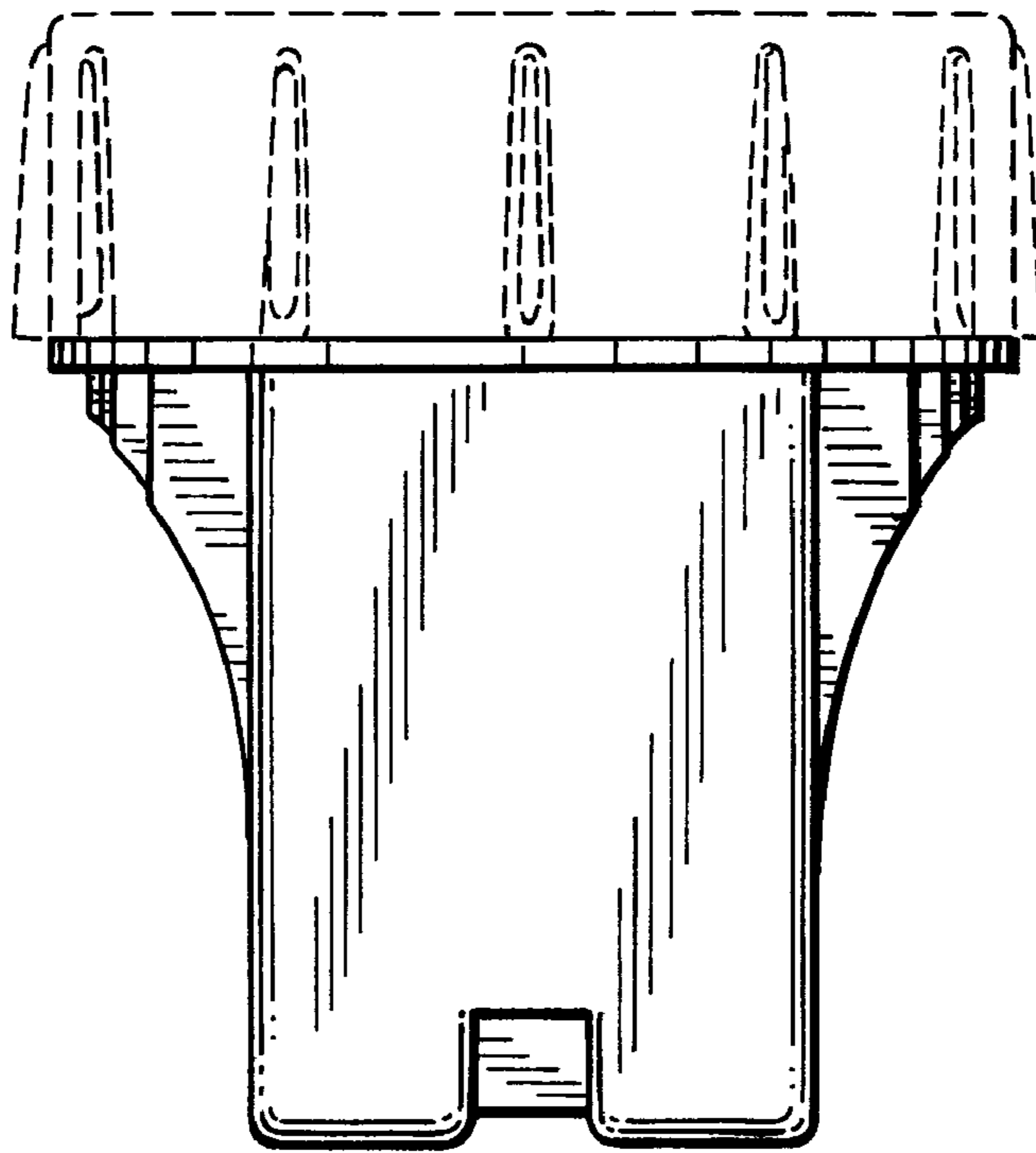

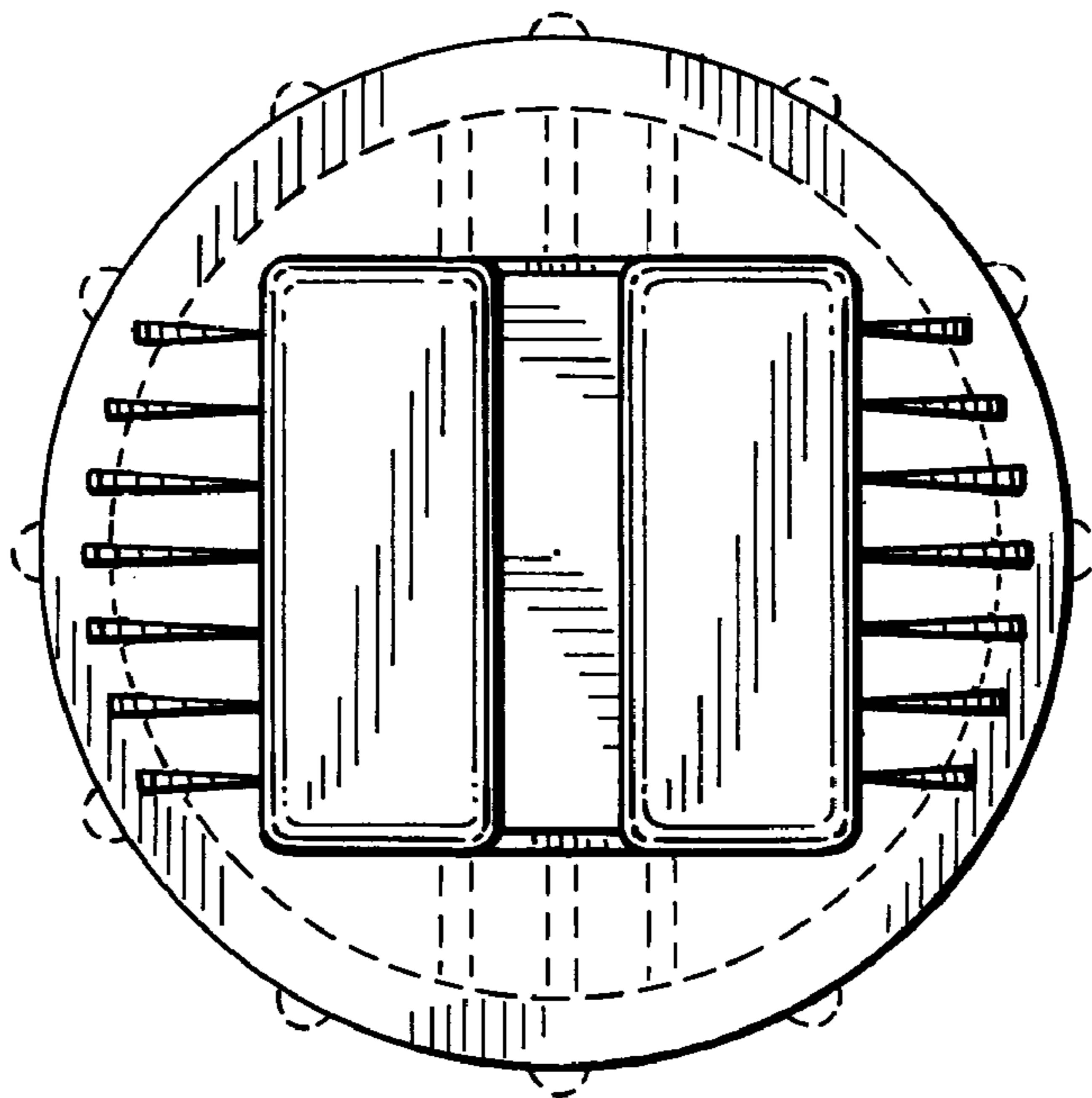
