(57) **CLAIM**

The ornamental design for a paver tile combination, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the paver tile combination of the invention;

FIG. 2 is a plan view of the paver tile combination illustrated in FIG. 1;

FIG. 3 is a front elevation of the paver tile combination illustrated in FIG. 1;

FIG. 4 is a left side elevation of the paver tile combination illustrated in FIG. 1;

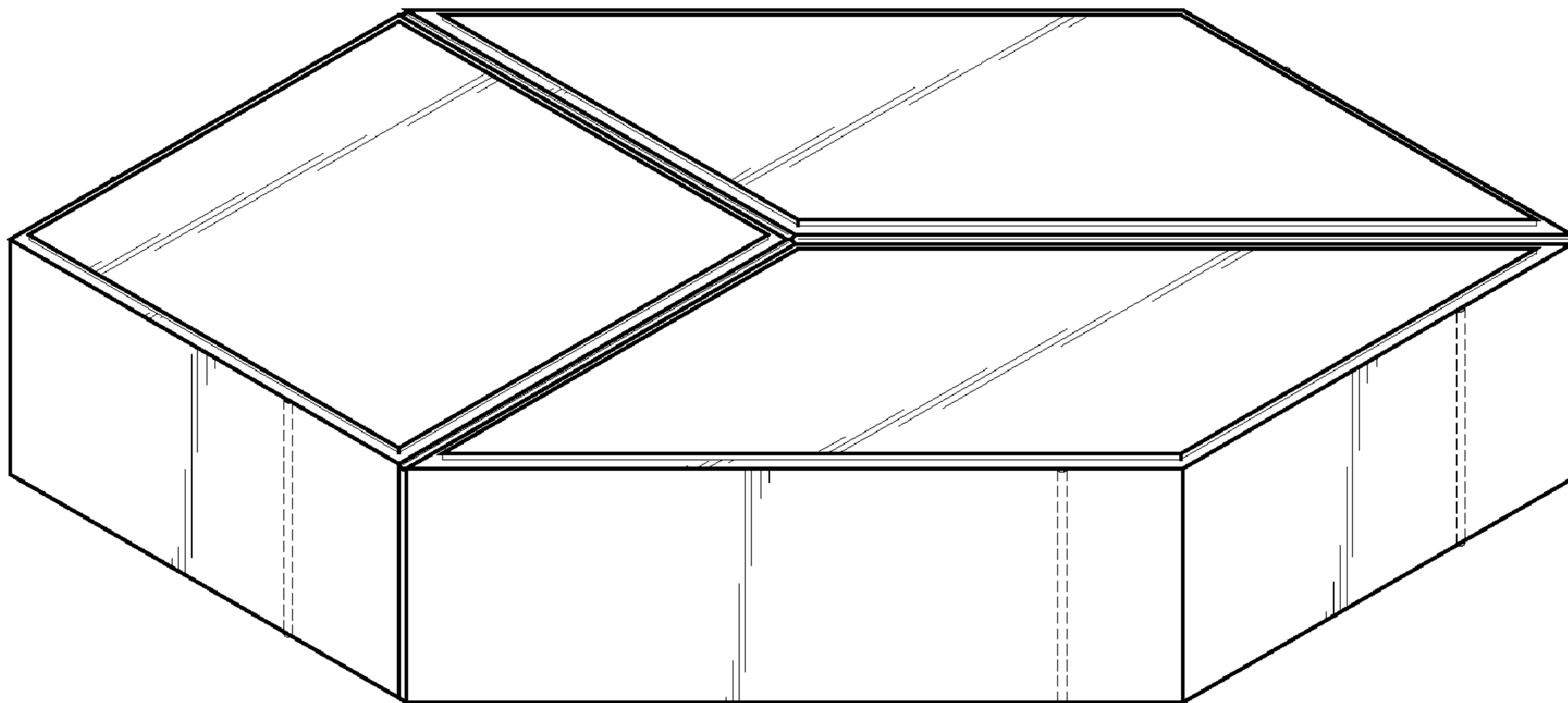
FIG. 5 is a right side elevation of the paver tile combination illustrated in FIG. 1;

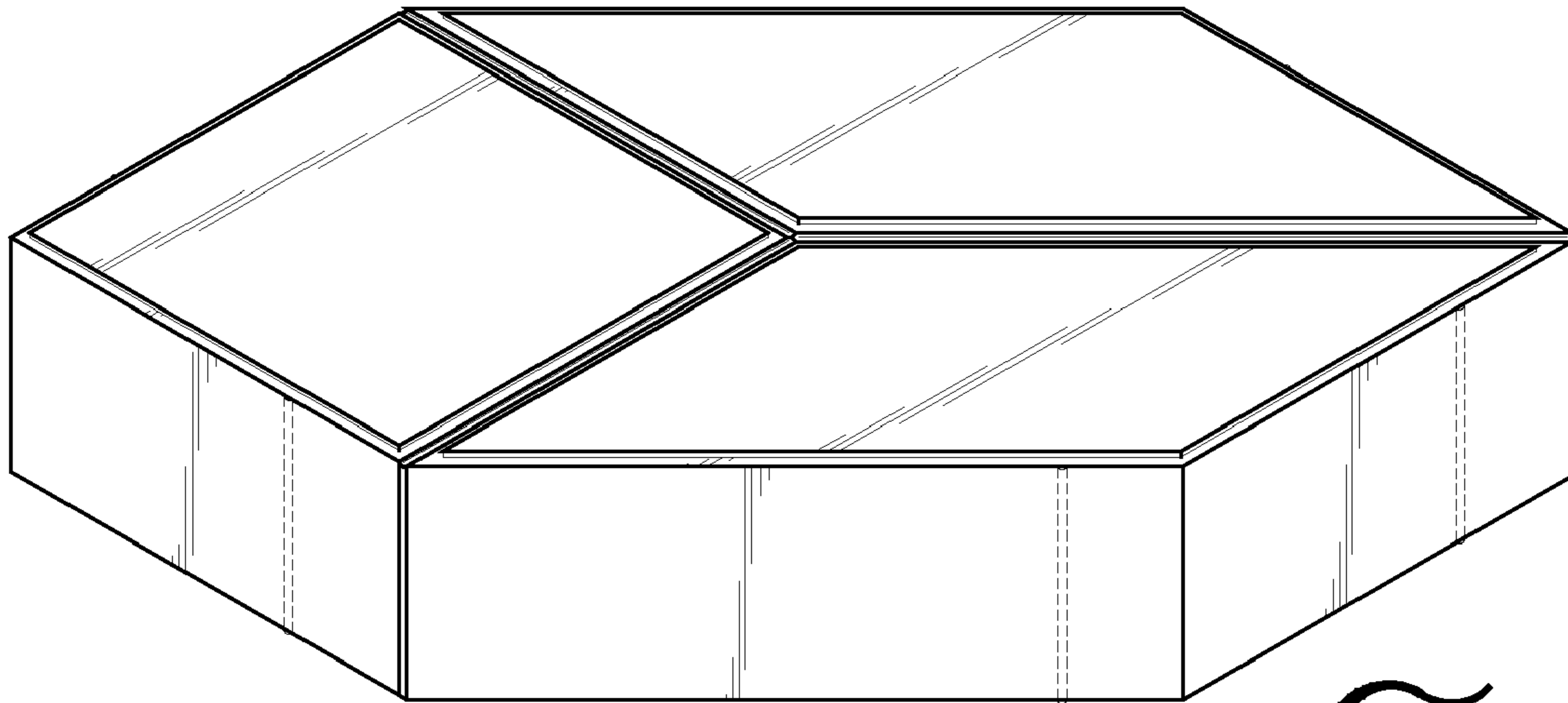

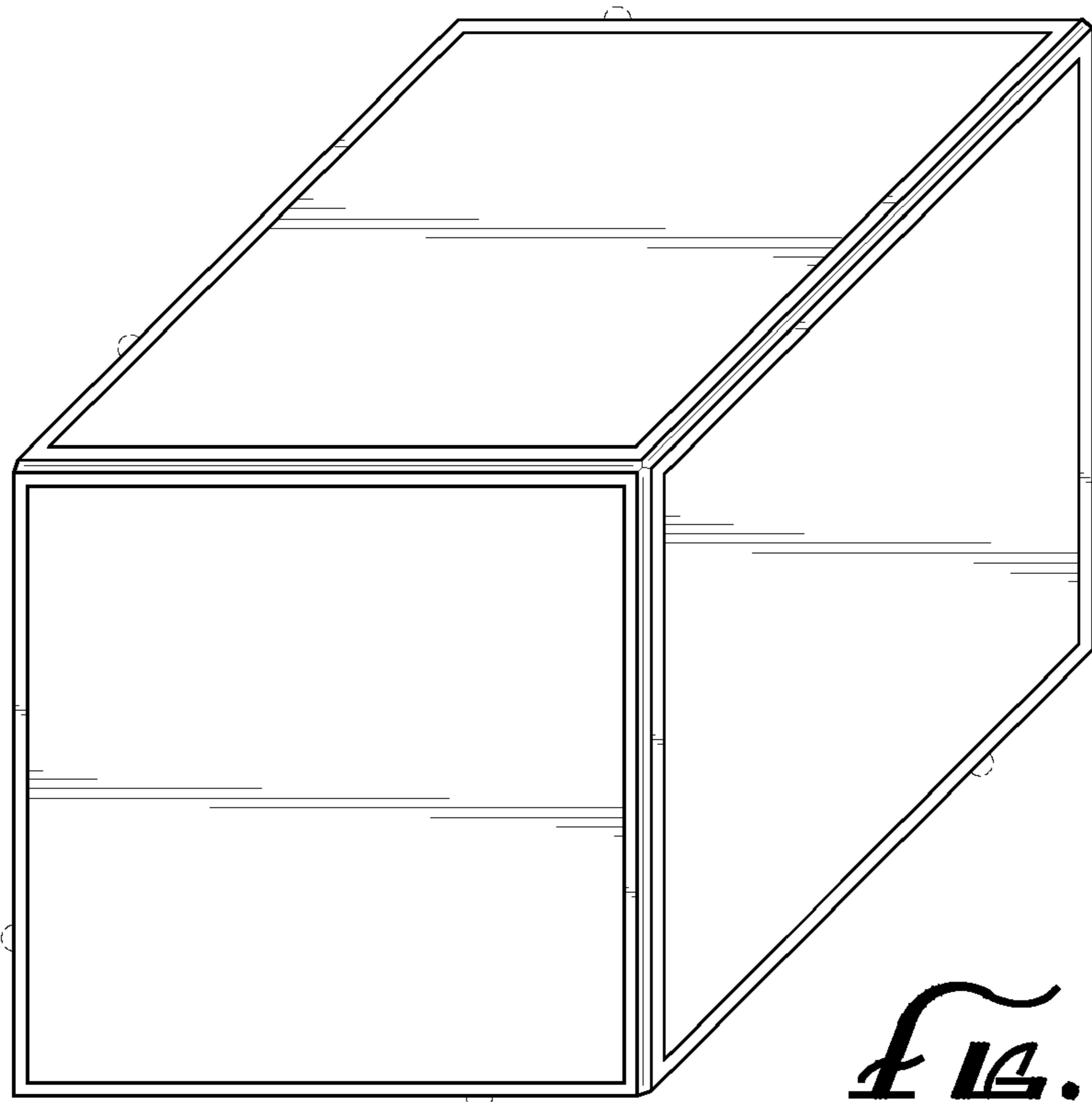

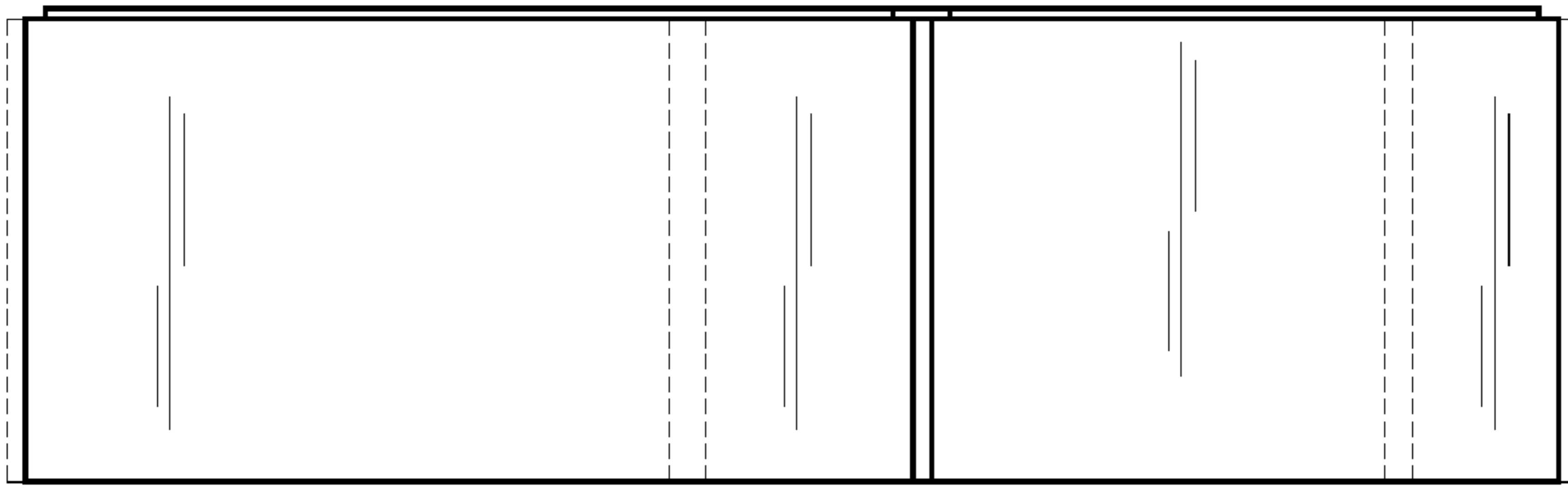

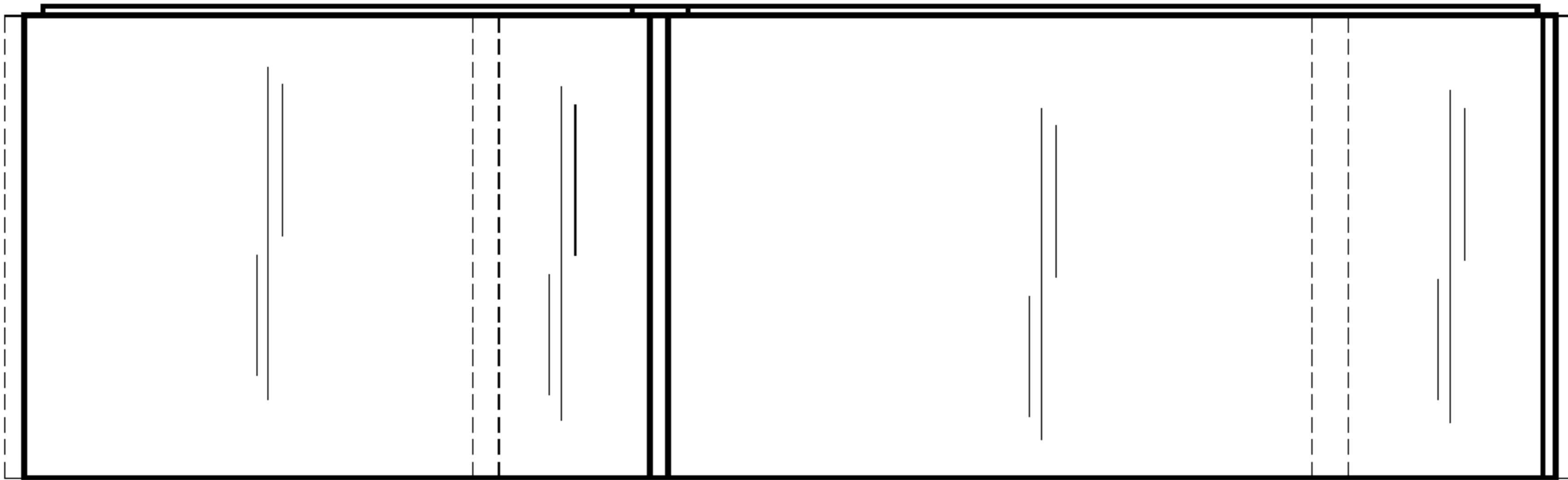

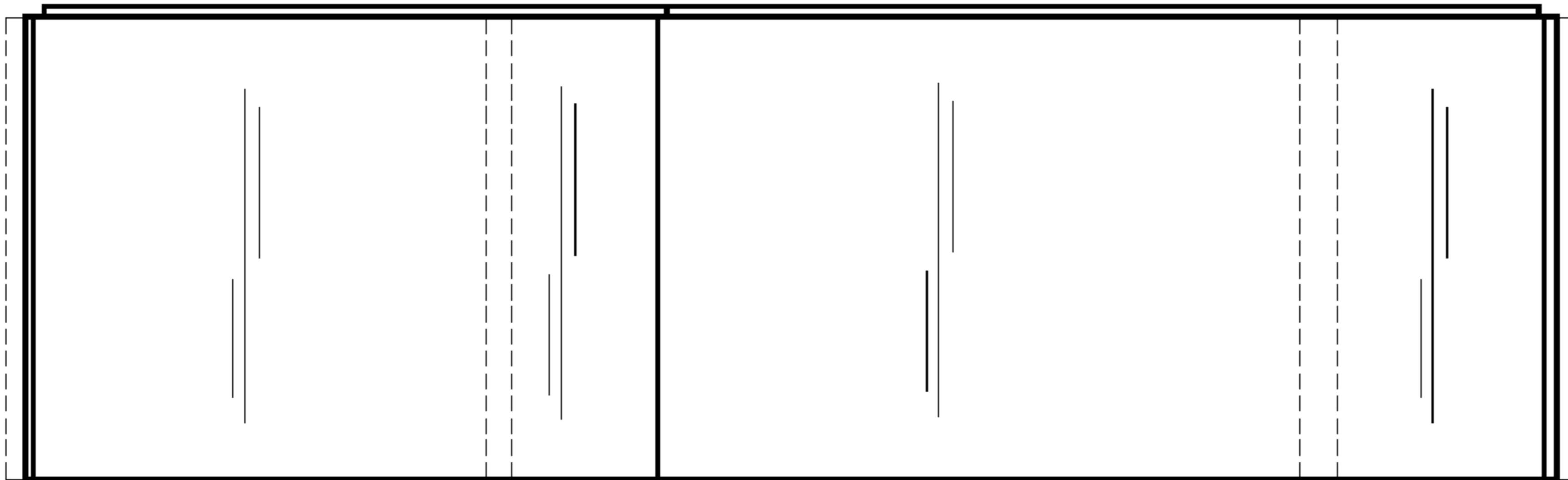

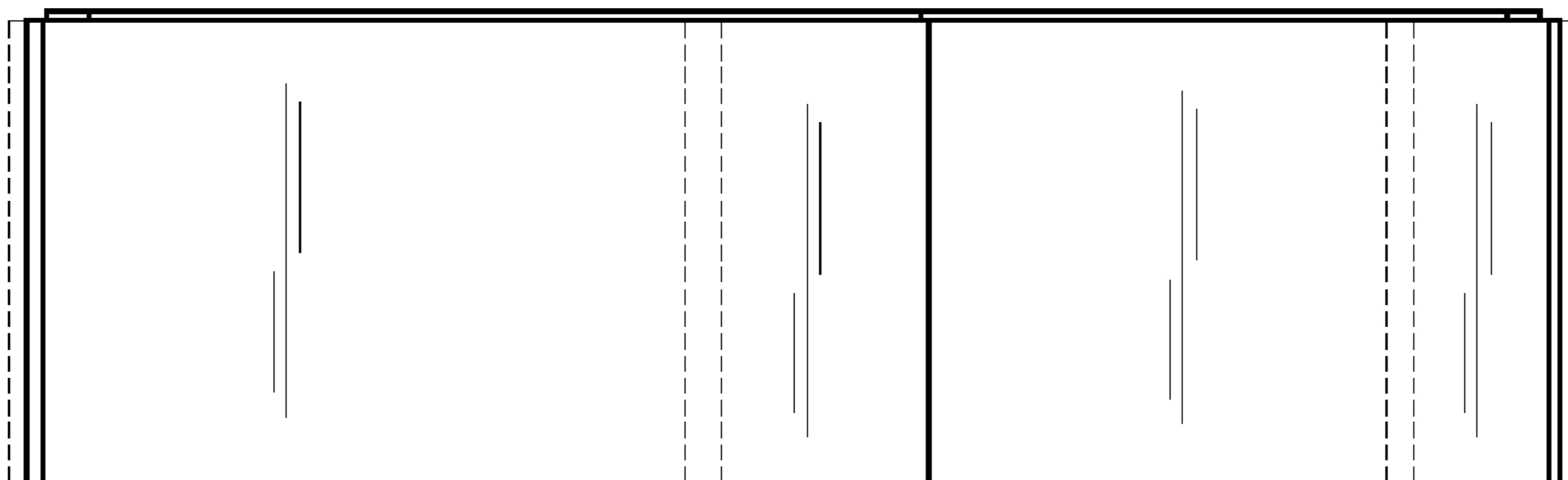

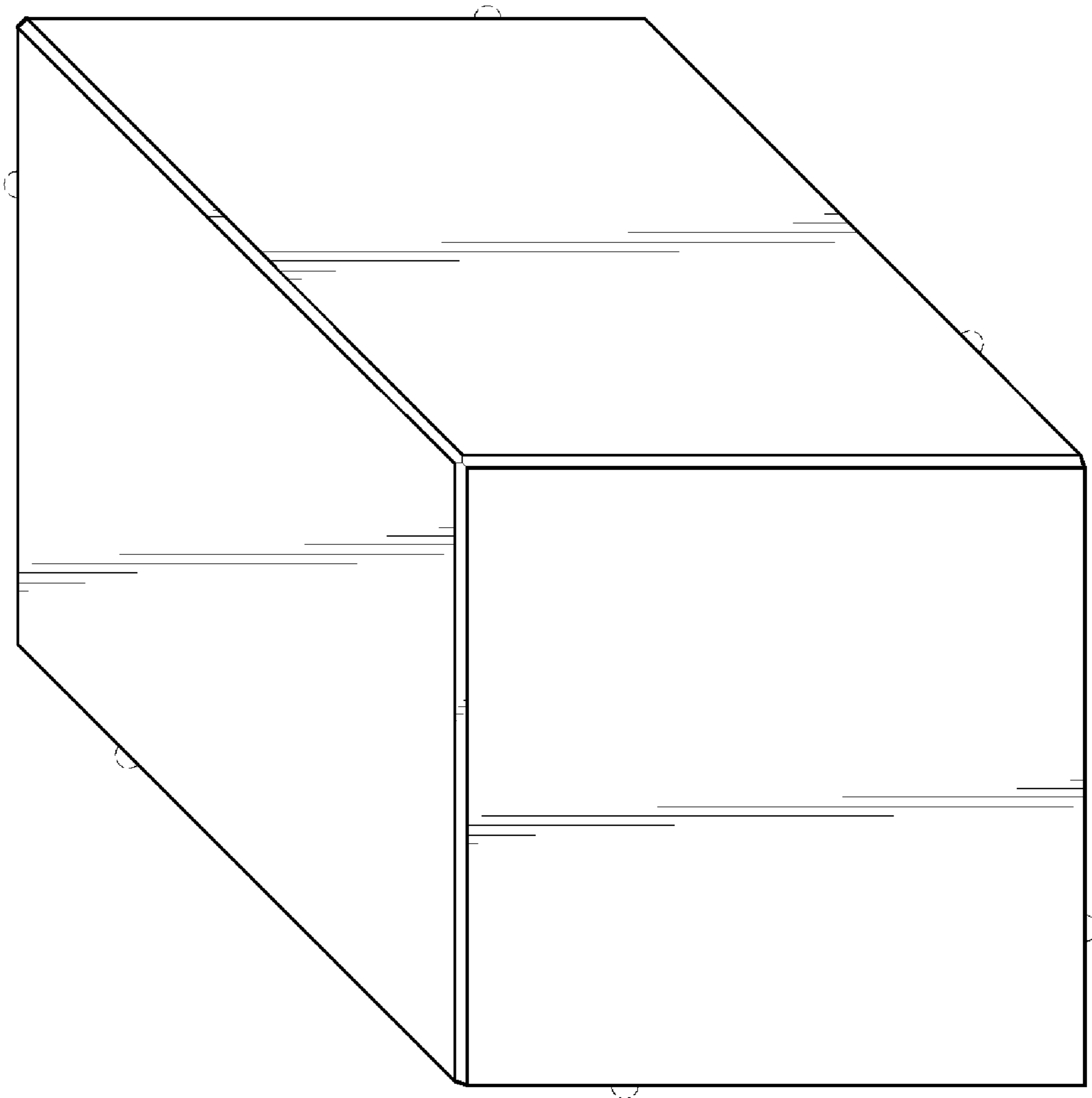
