FIG. 2: is a left side view of the design shown in FIG. 1, wherein the right side view is a mirror image thereof;

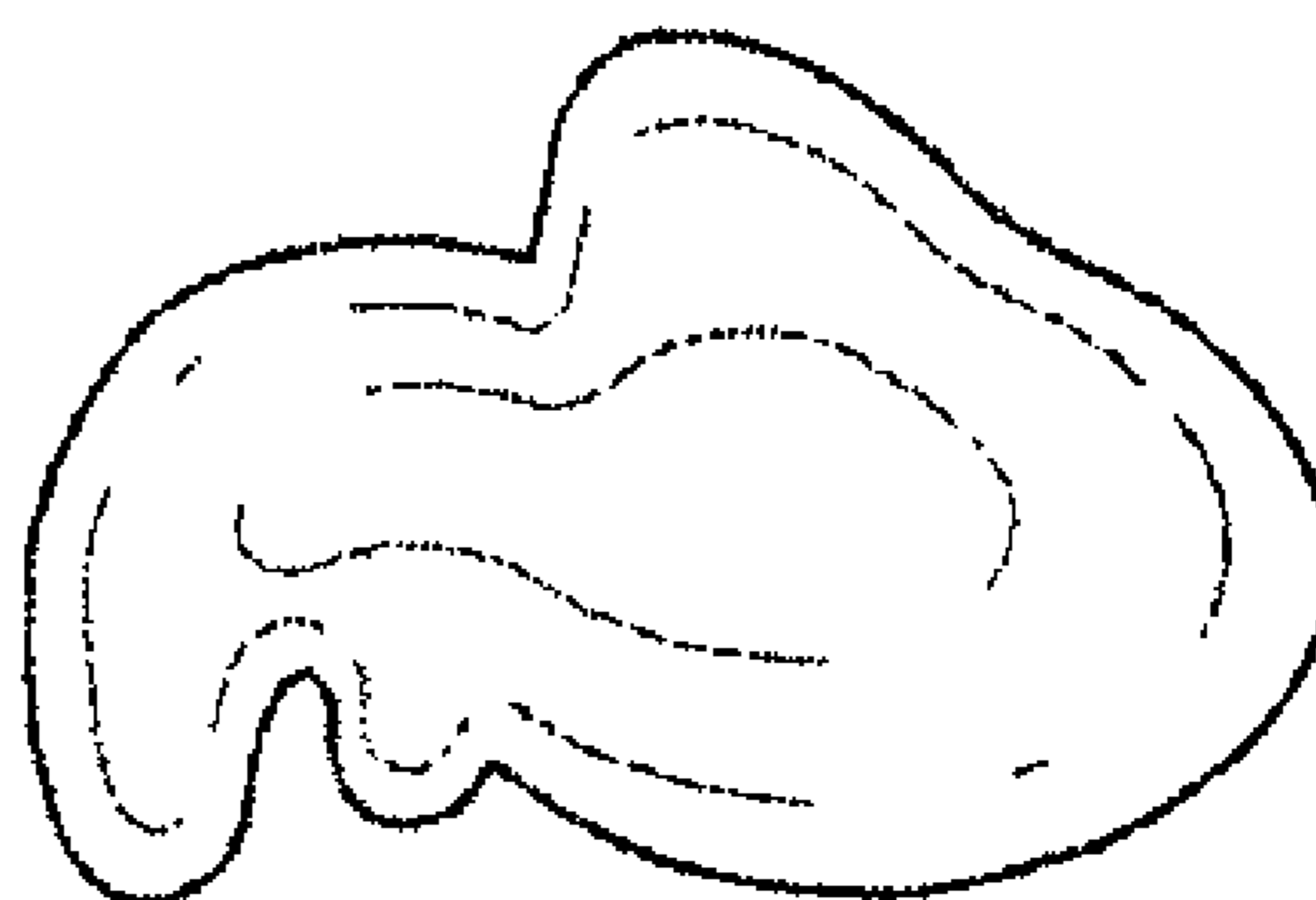
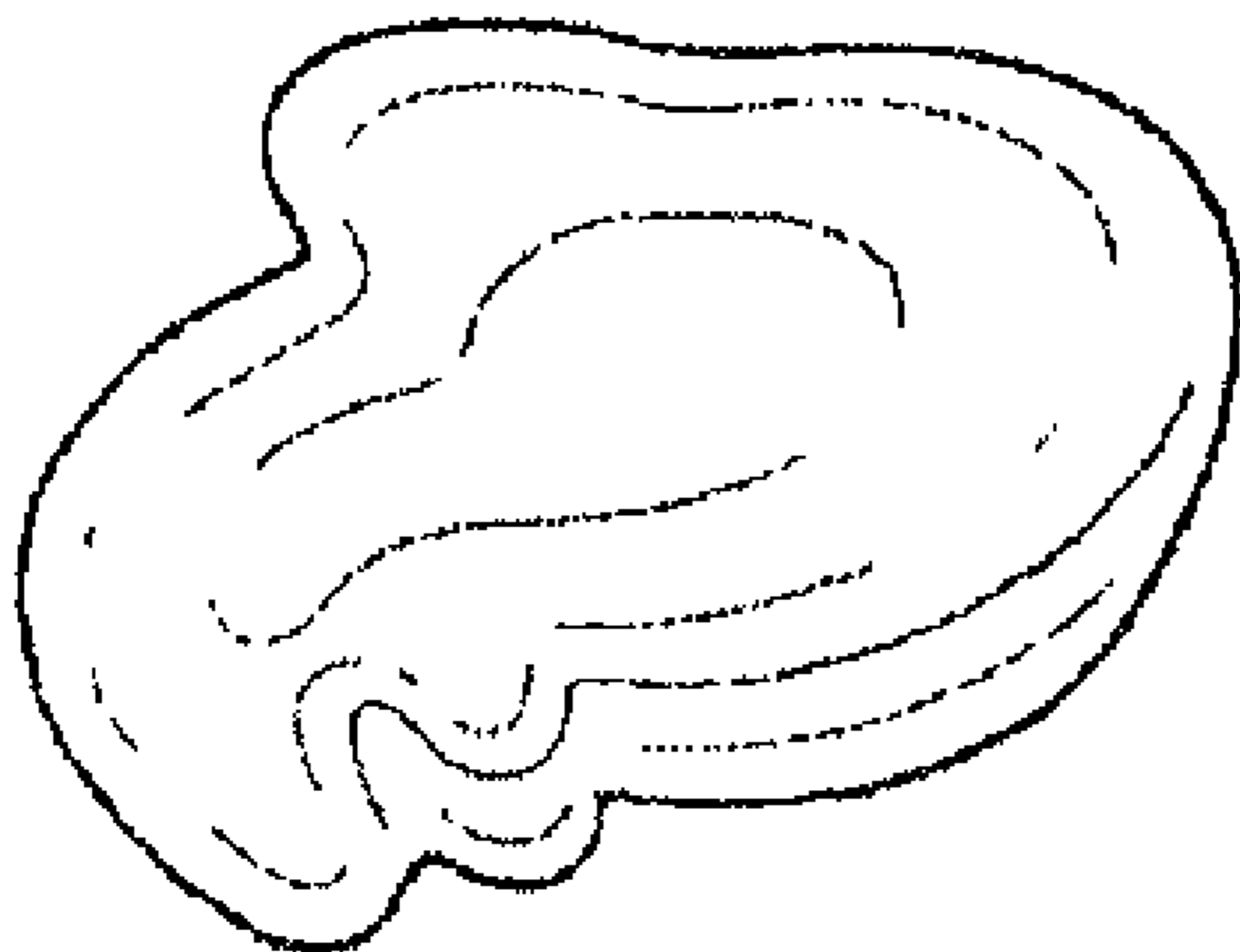
FIG. 3: is a rear view of the design shown in FIG. 1;

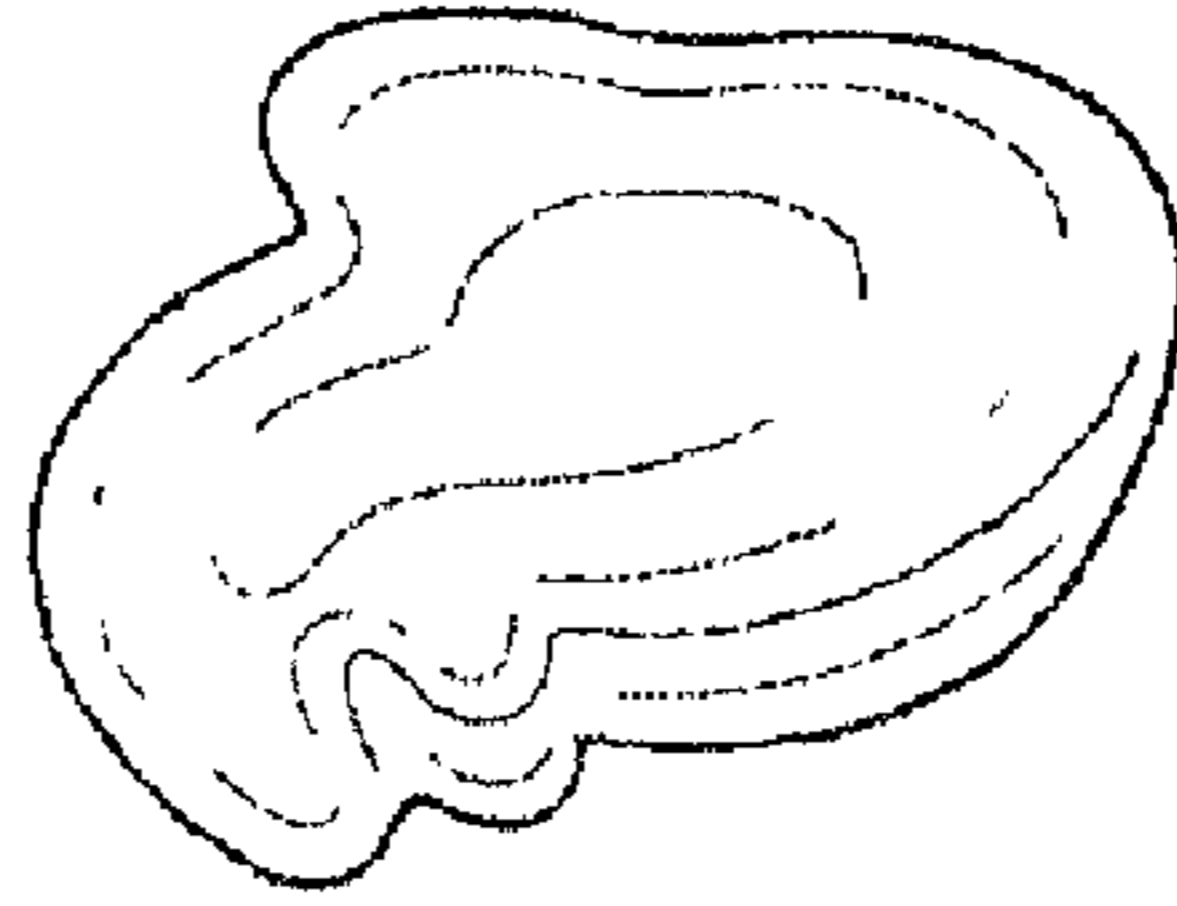

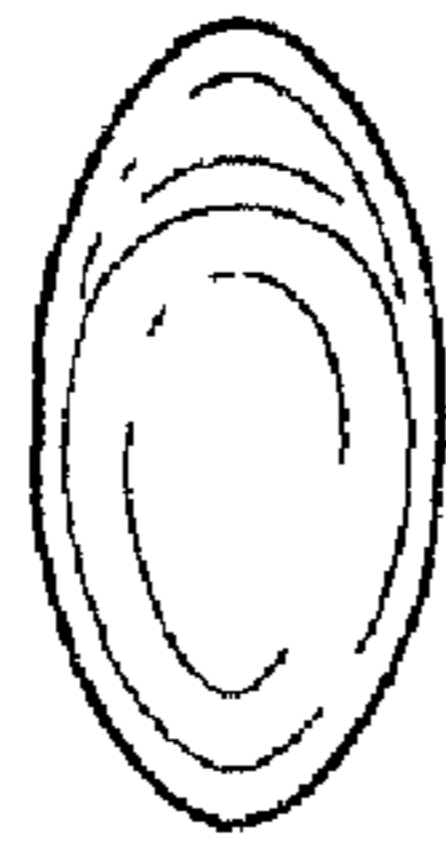

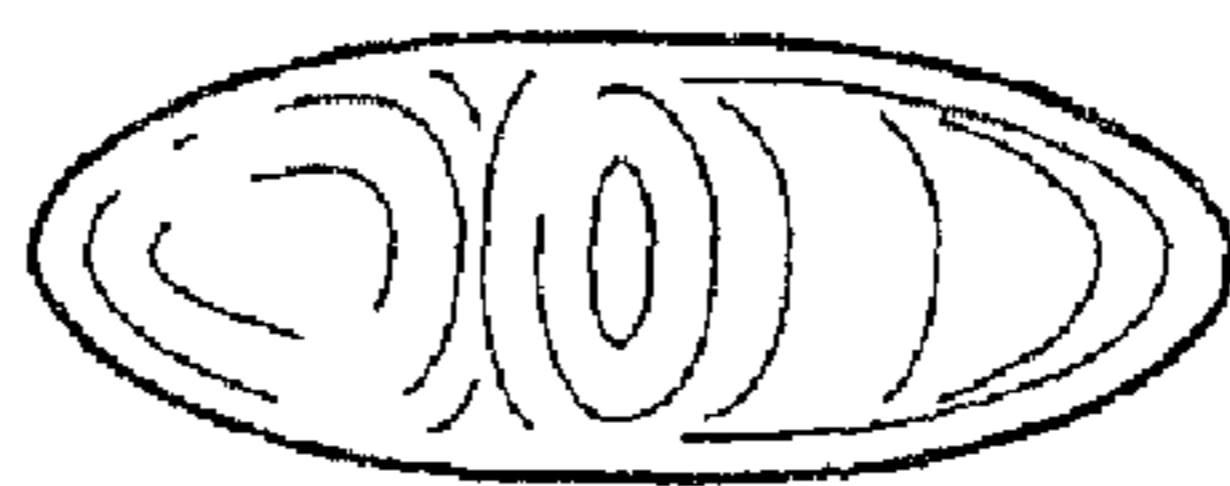
