FIG. 6 is a left side elevational view thereof; and,

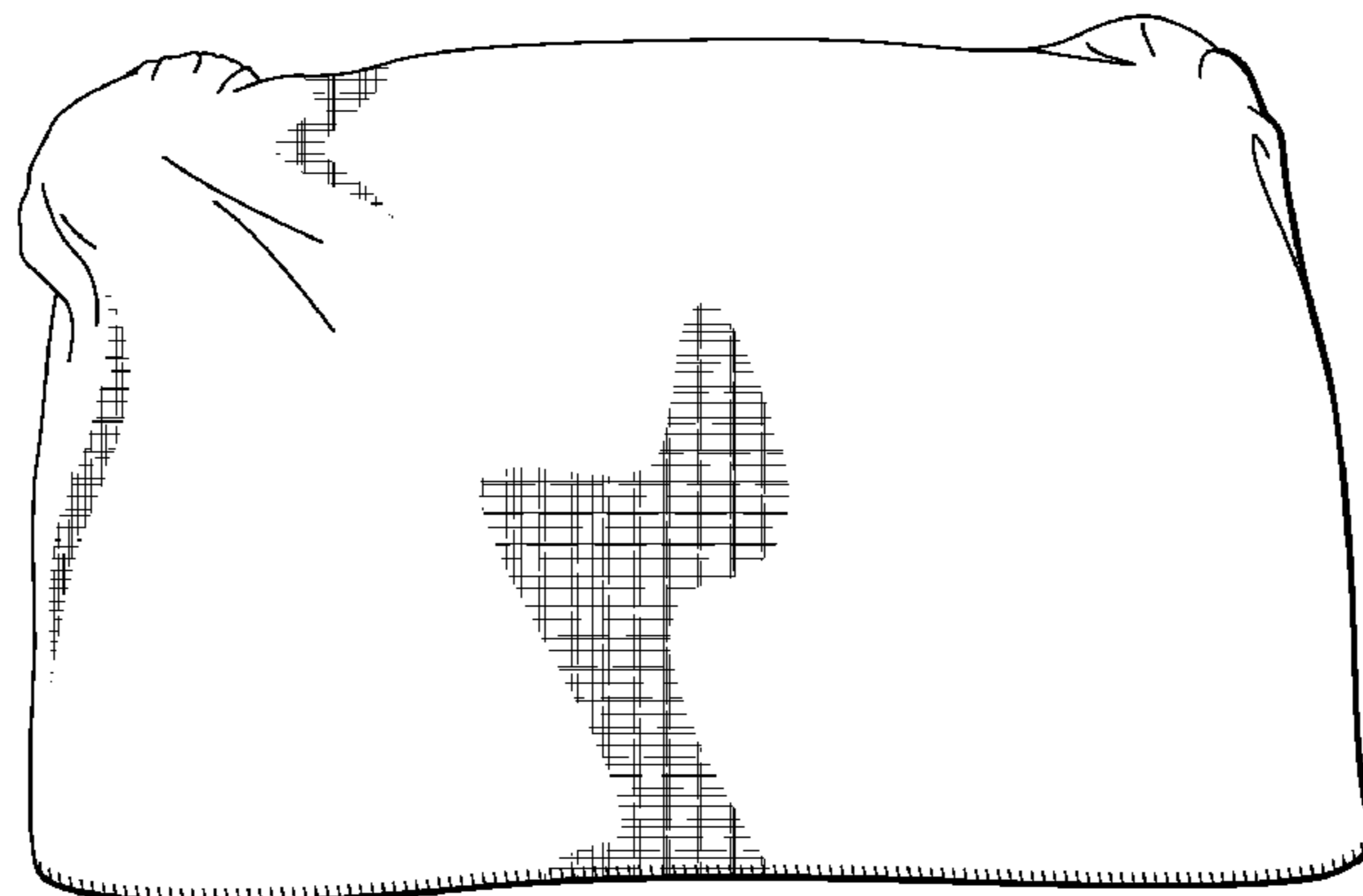
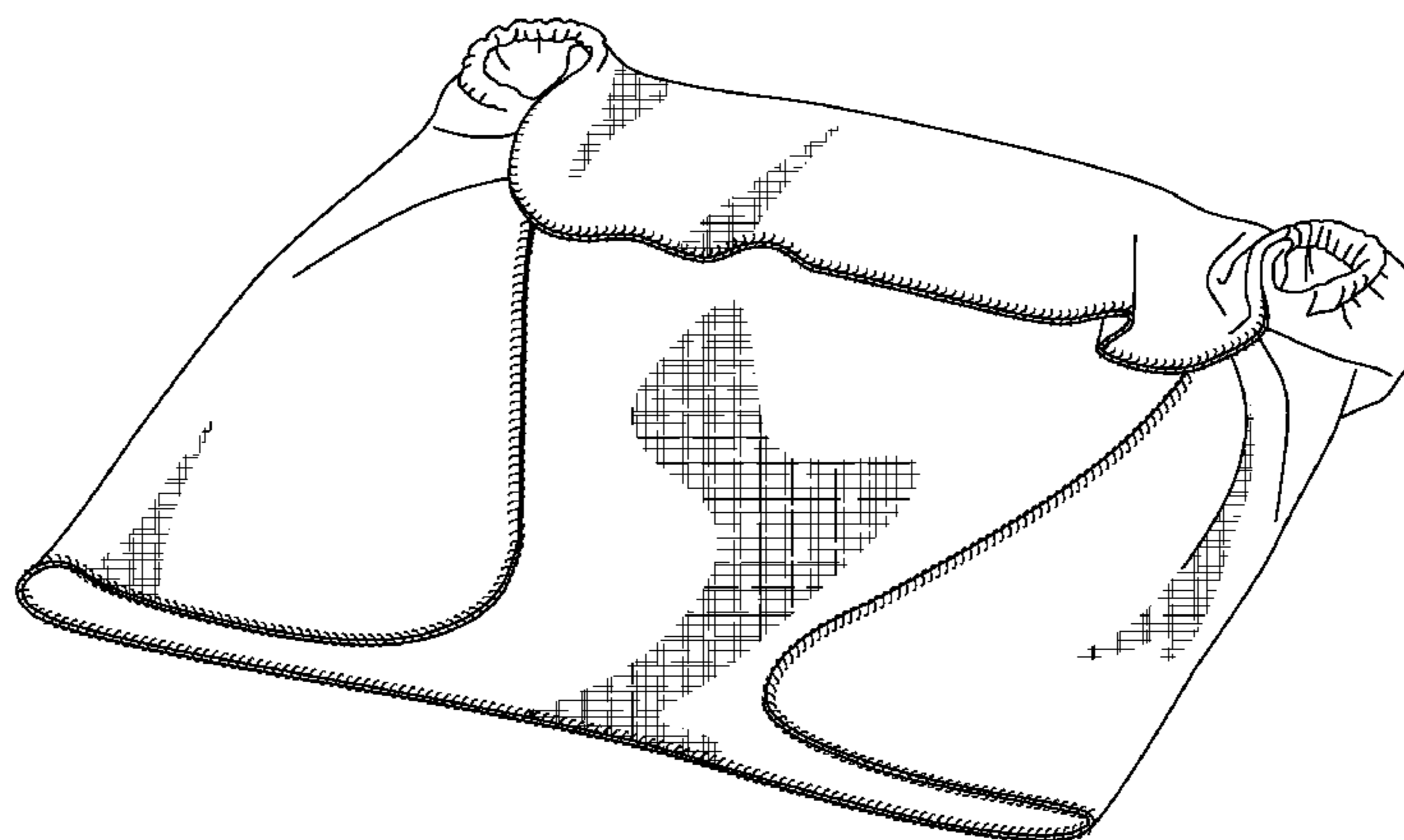
FIG. 7 is a right side elevational view thereof.

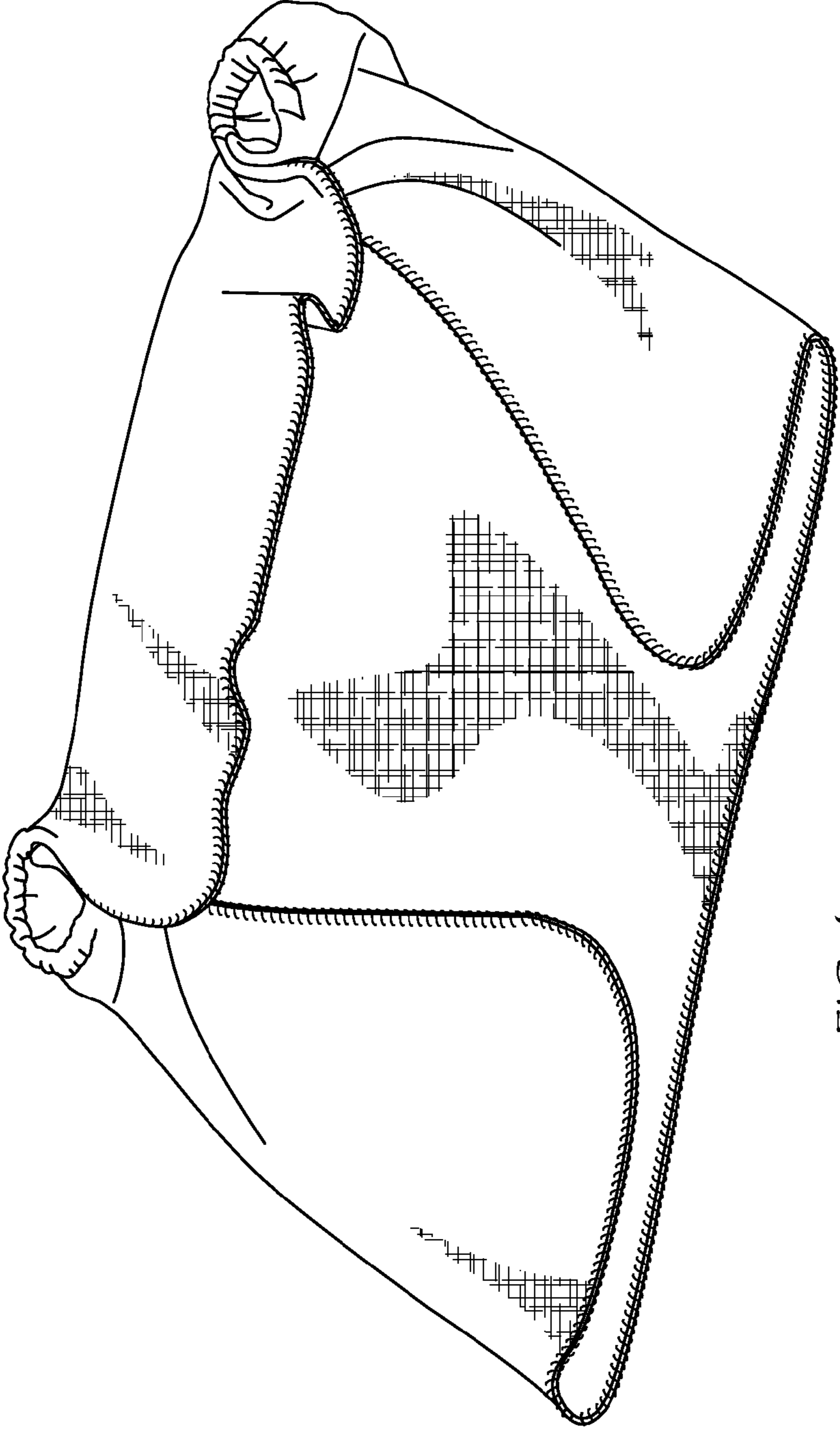

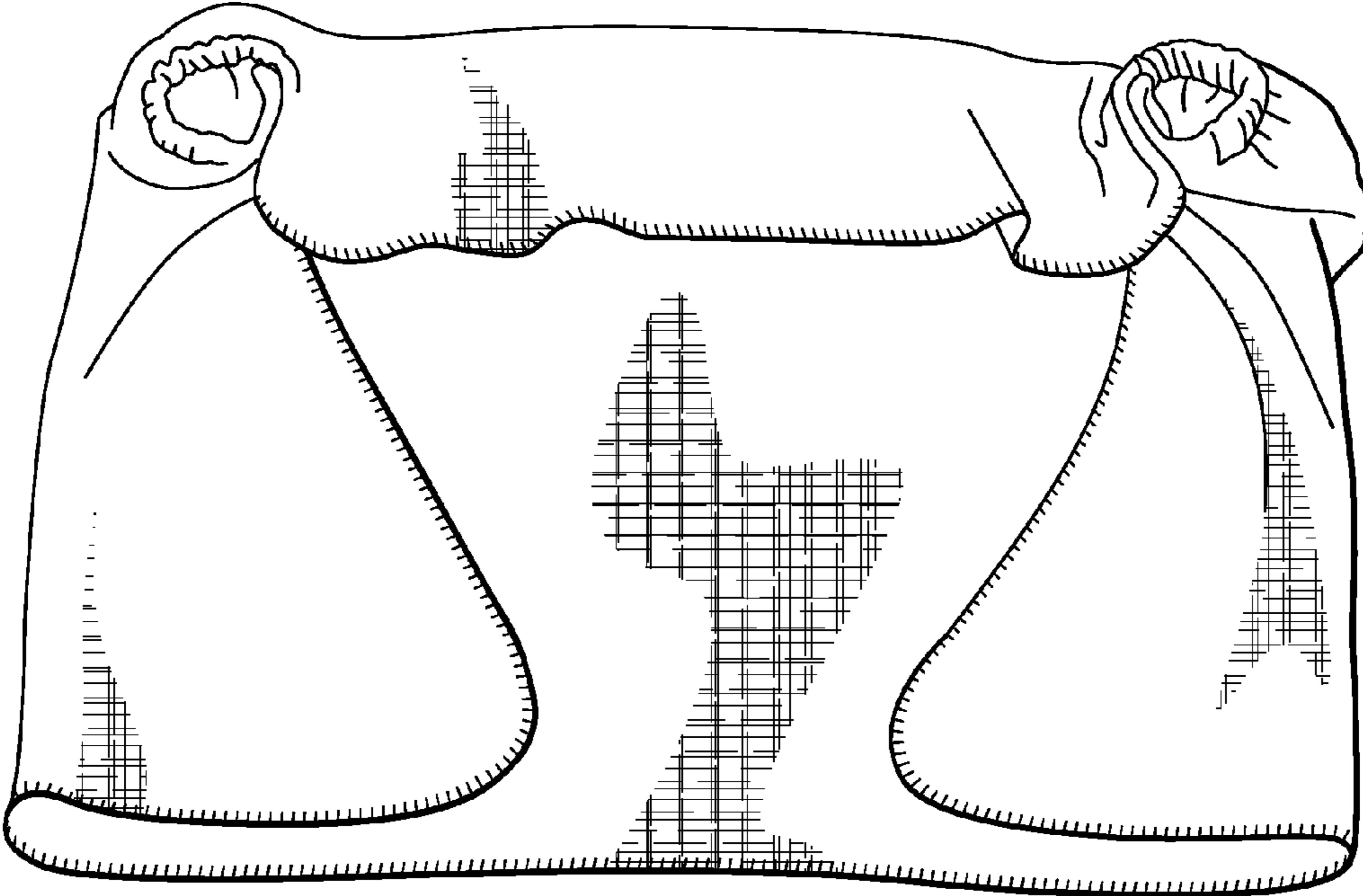

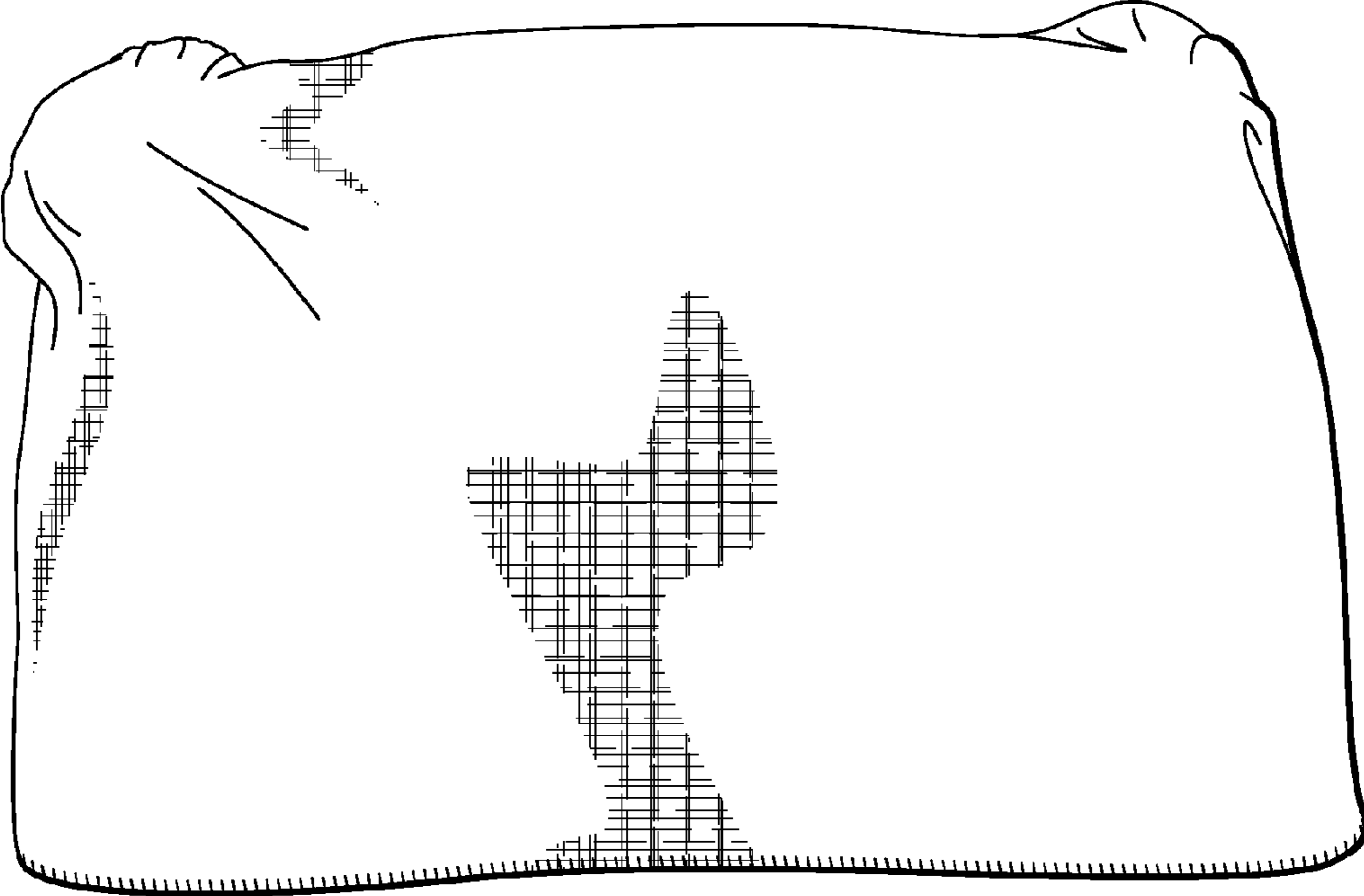

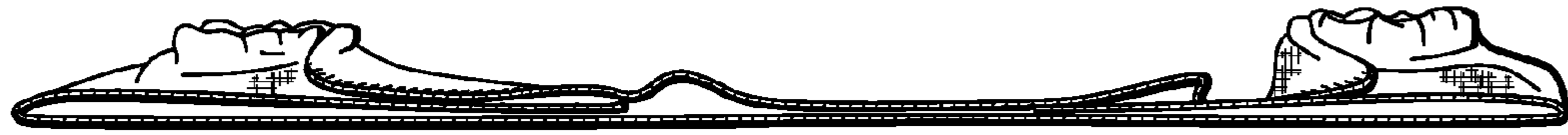

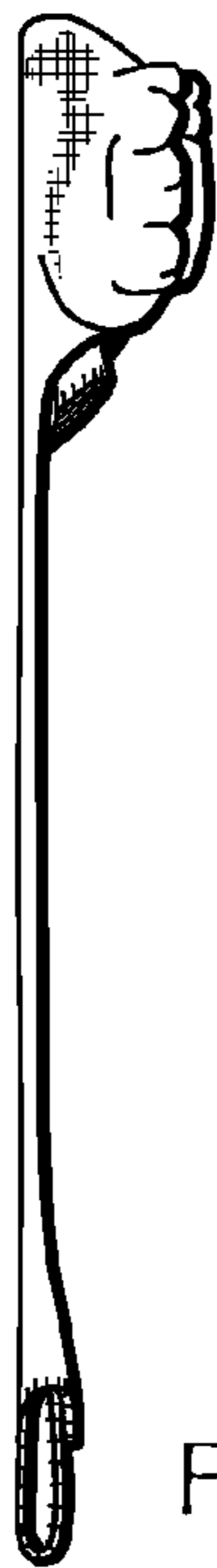
