(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a lateral side view of a shoe showing my new design;

FIG. 2 is a medial side view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a front view thereof;

FIG. 5 is a lateral side view of the shoe of FIGS. 1-4 with the disclaimed stitching removed for clarity;

FIG. 6 is a medial side view thereof;

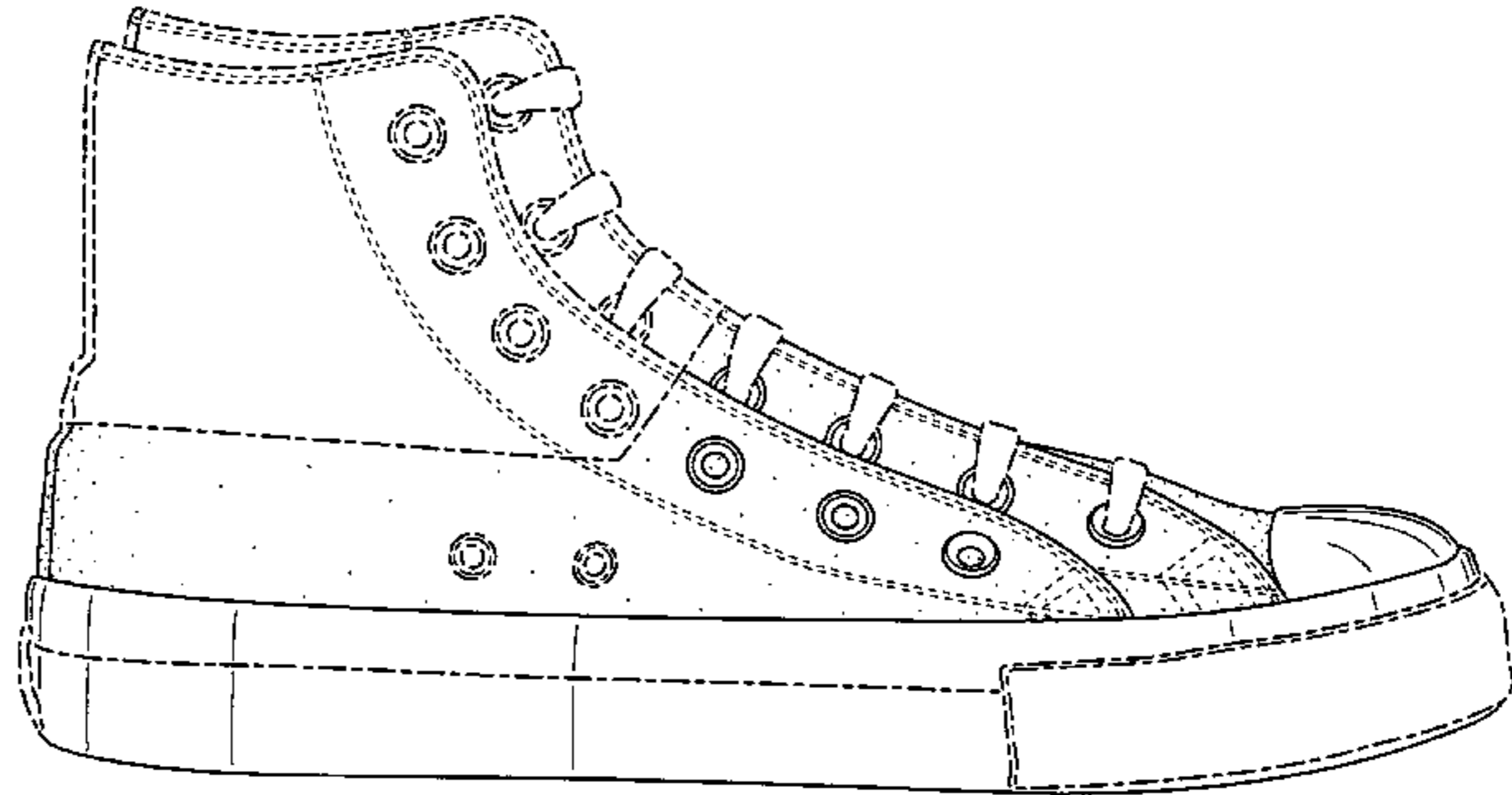
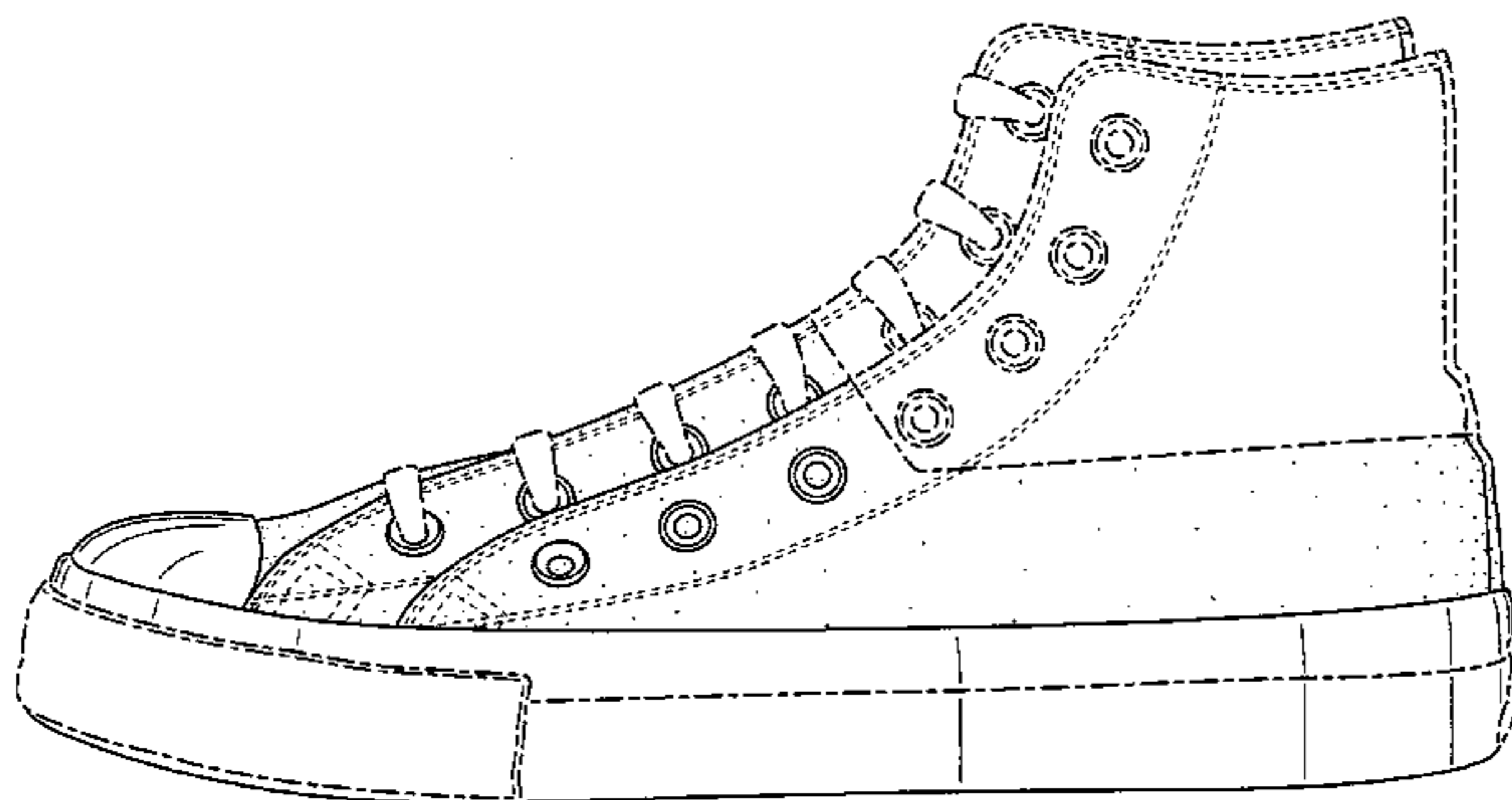
FIG. 7 is a rear view thereof; and,

FIG. 8 is a front view thereof.

The even broken lines within the shaded area of FIGS. 1-4 represent disclaimed stitching and form no part of the claimed design. The uneven broken lines immediately adjacent to the shaded area of FIGS. 1-8 represent unclaimed boundaries of the design.

The uneven broken line showing of remainder of the shoe in FIGS. 1-8 is for environmental purposes only and forms no part of the claimed design.

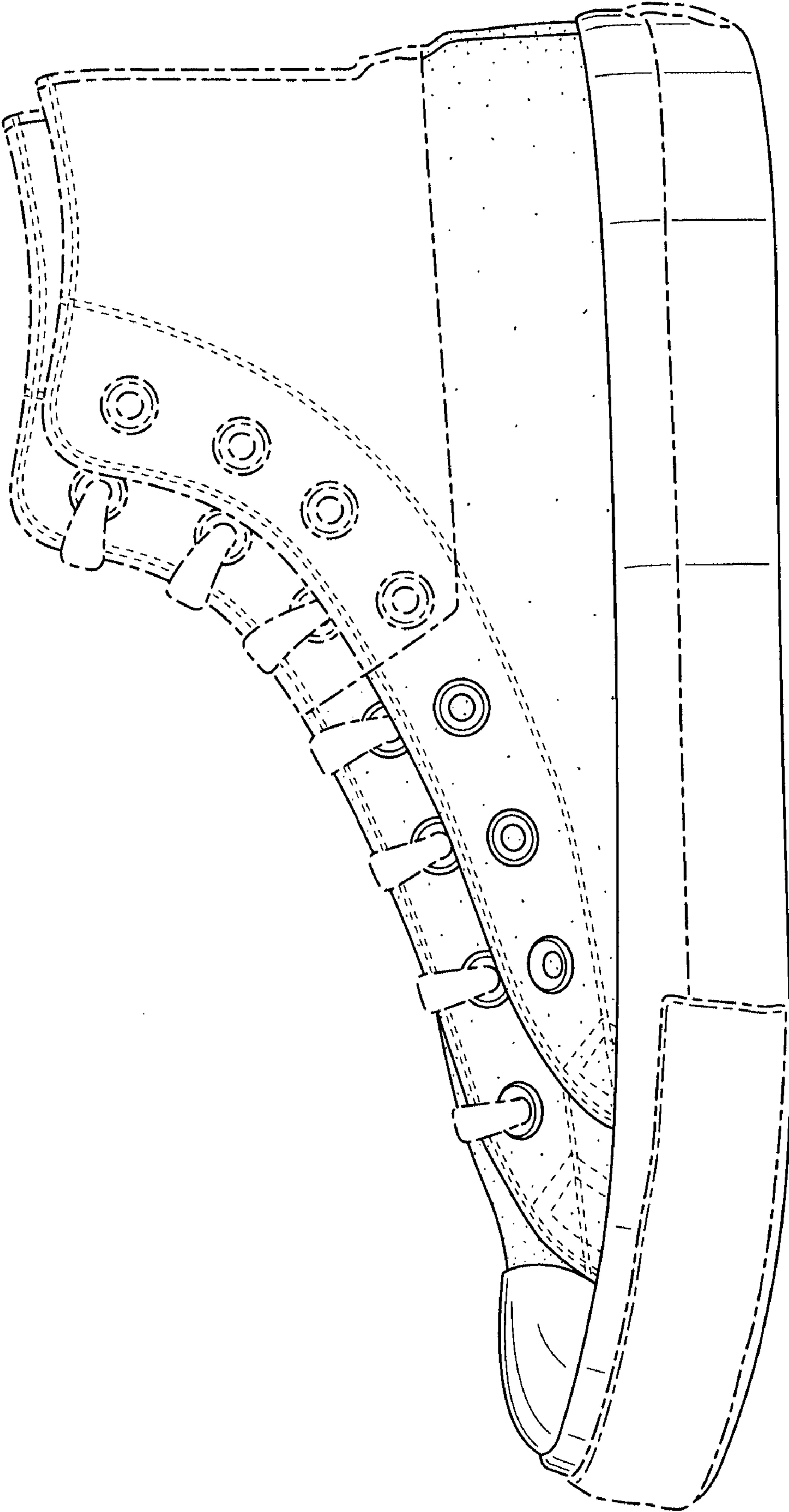

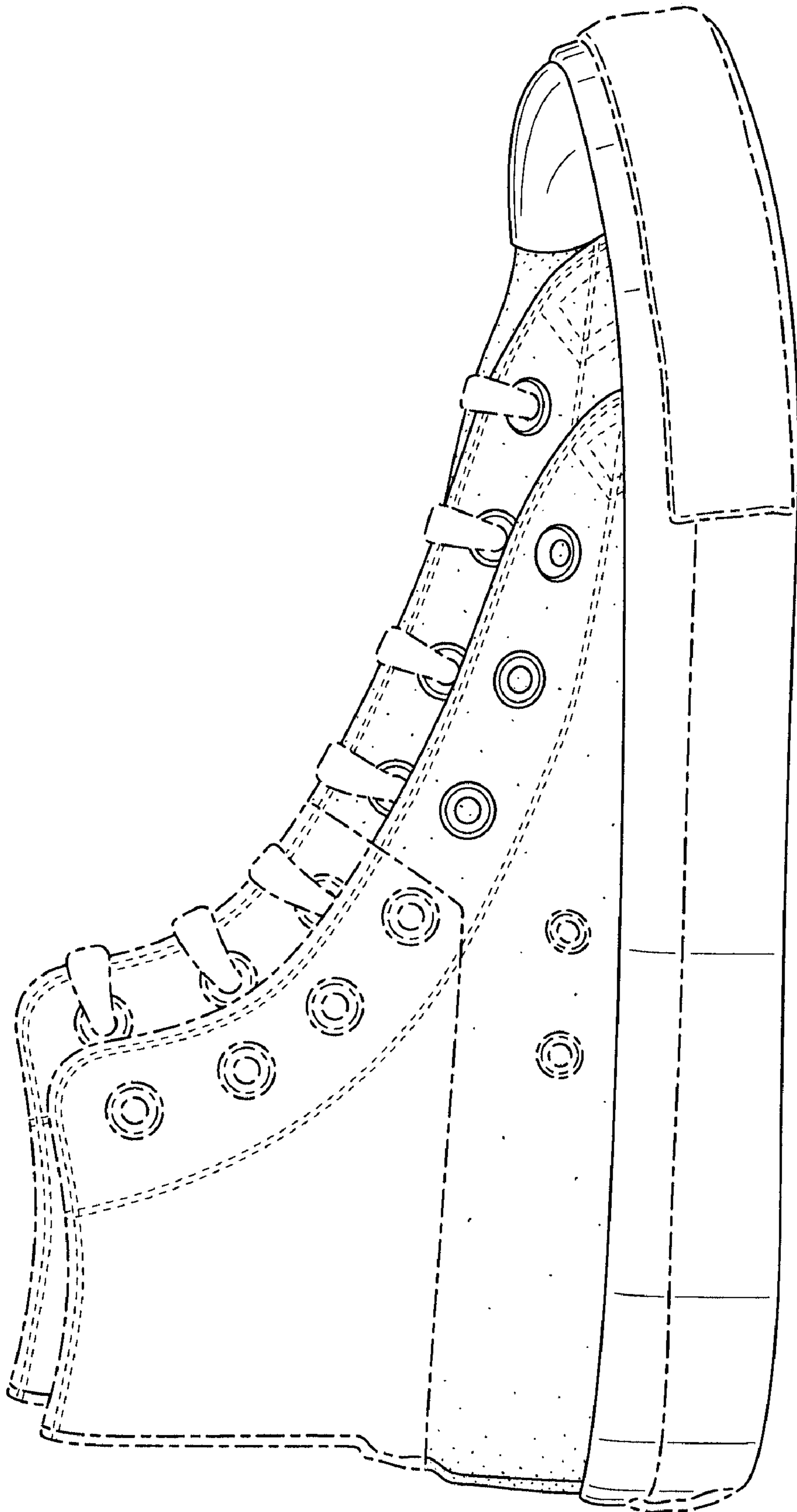

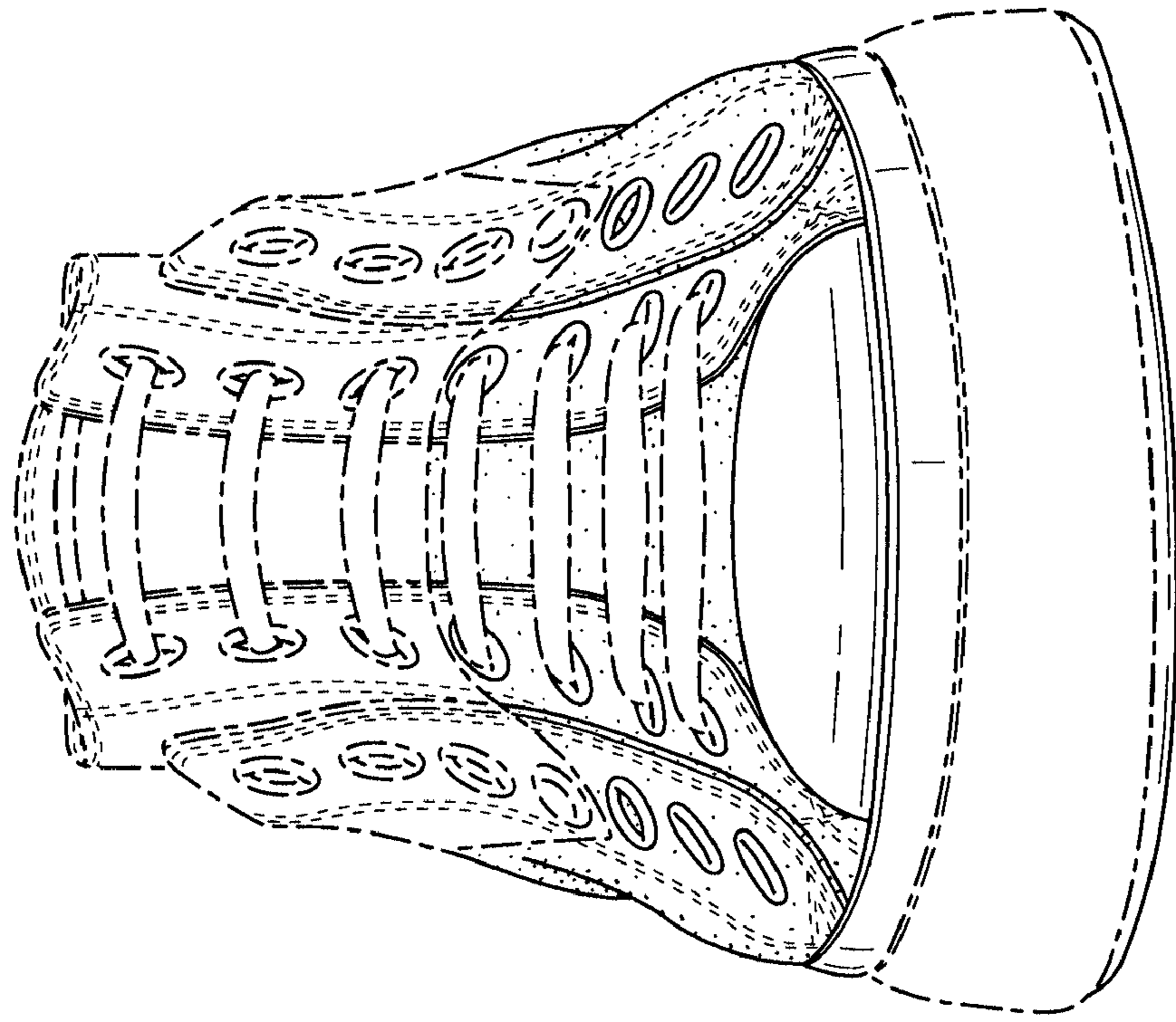

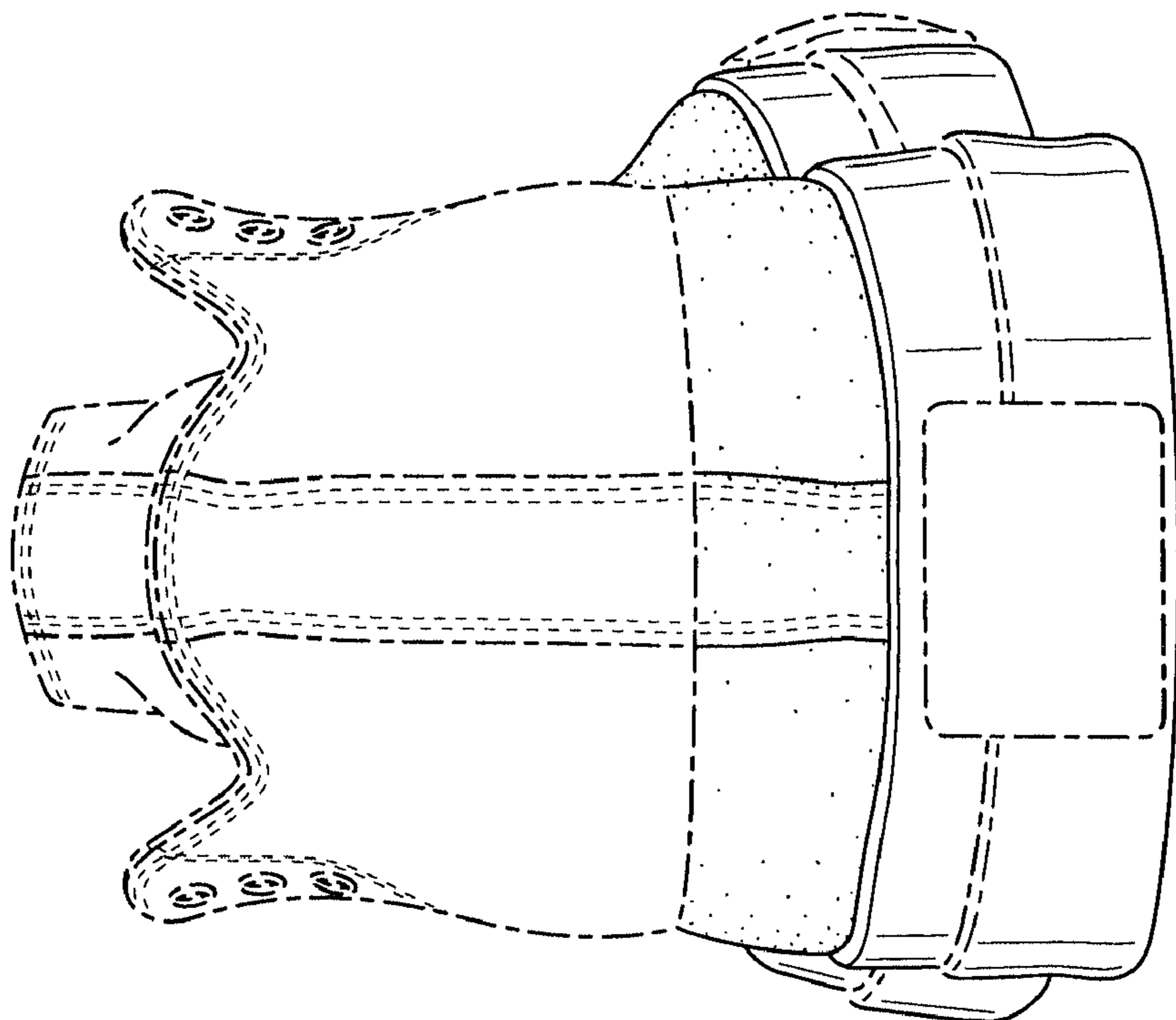

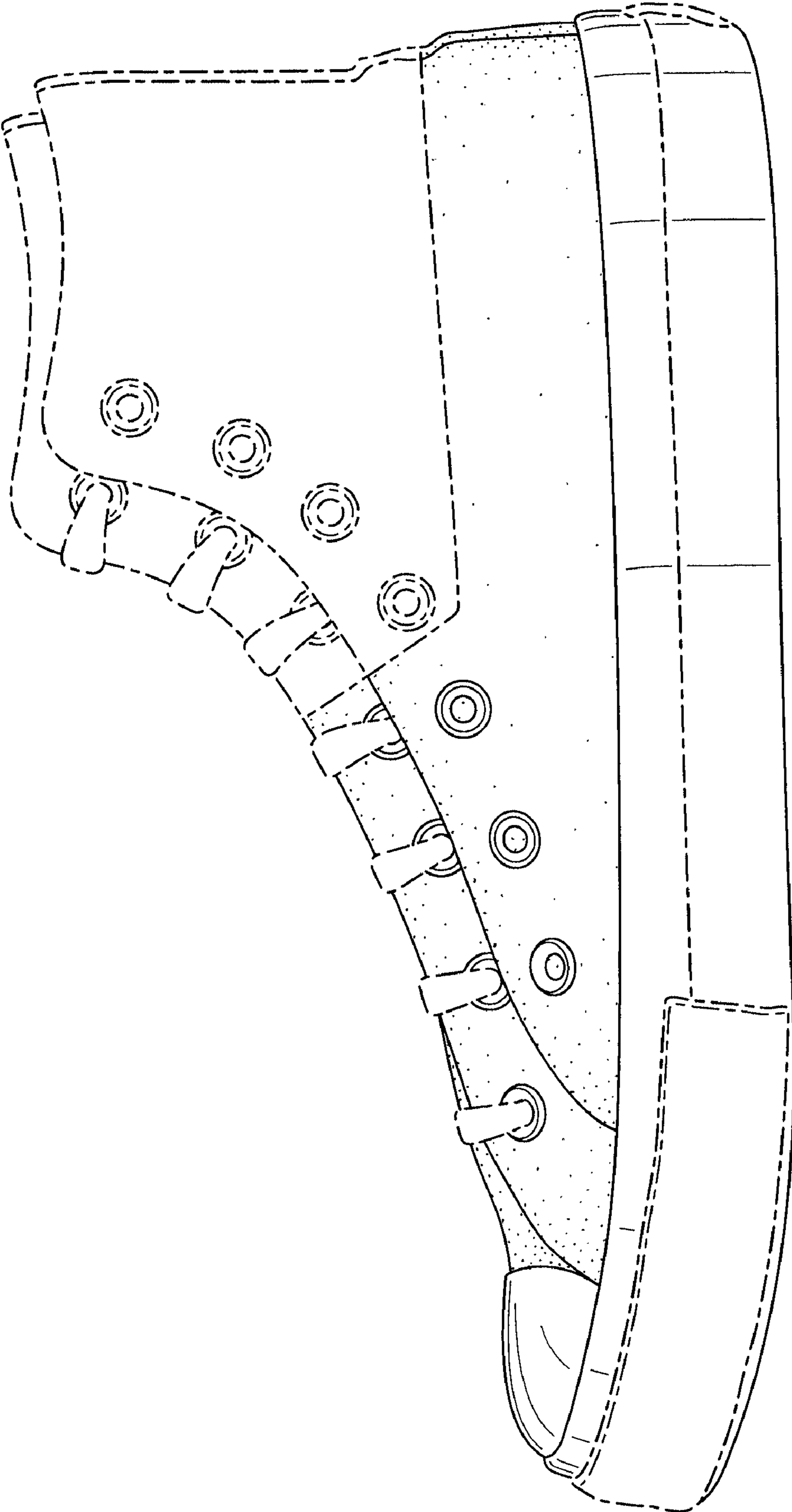

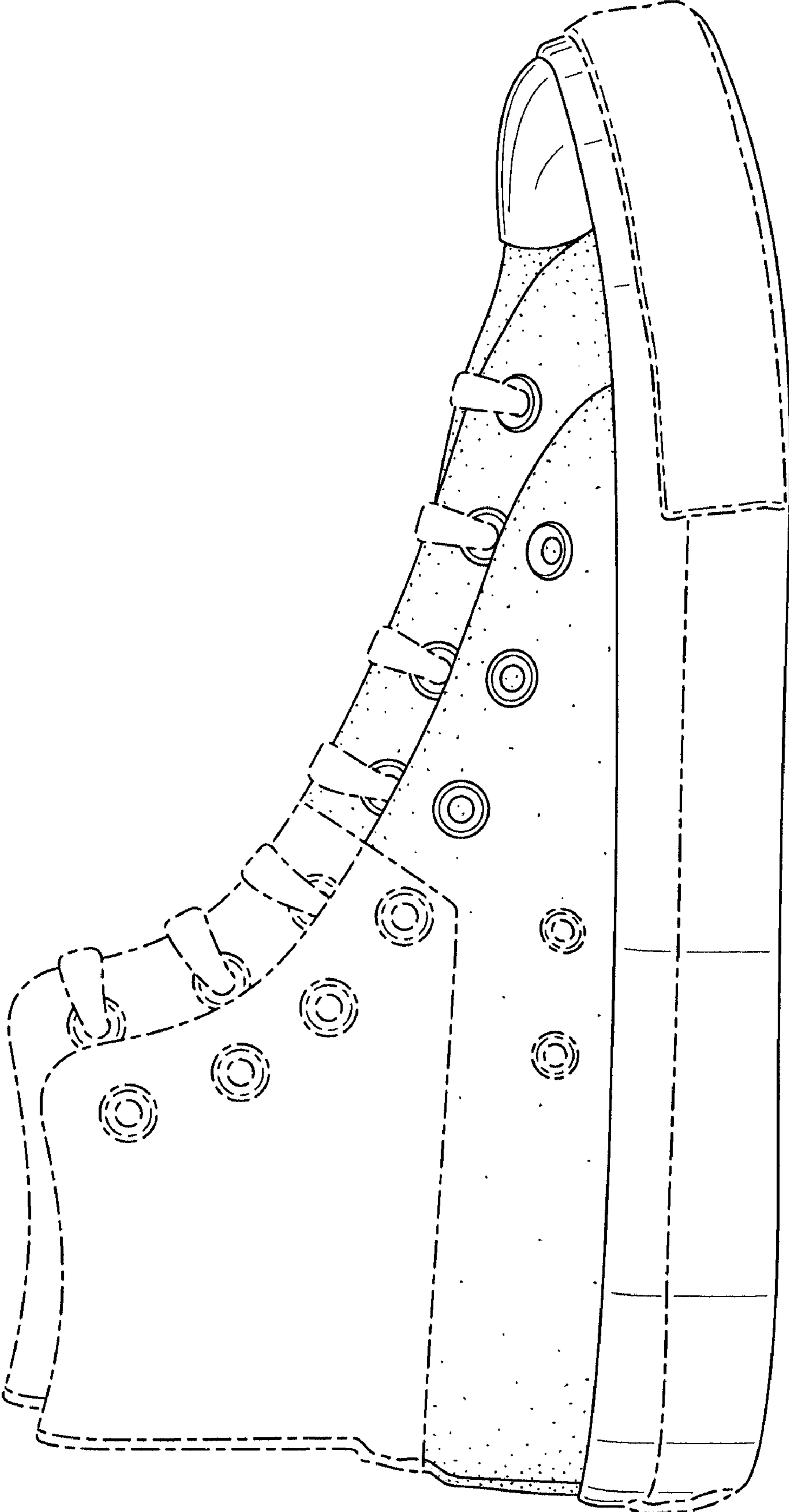

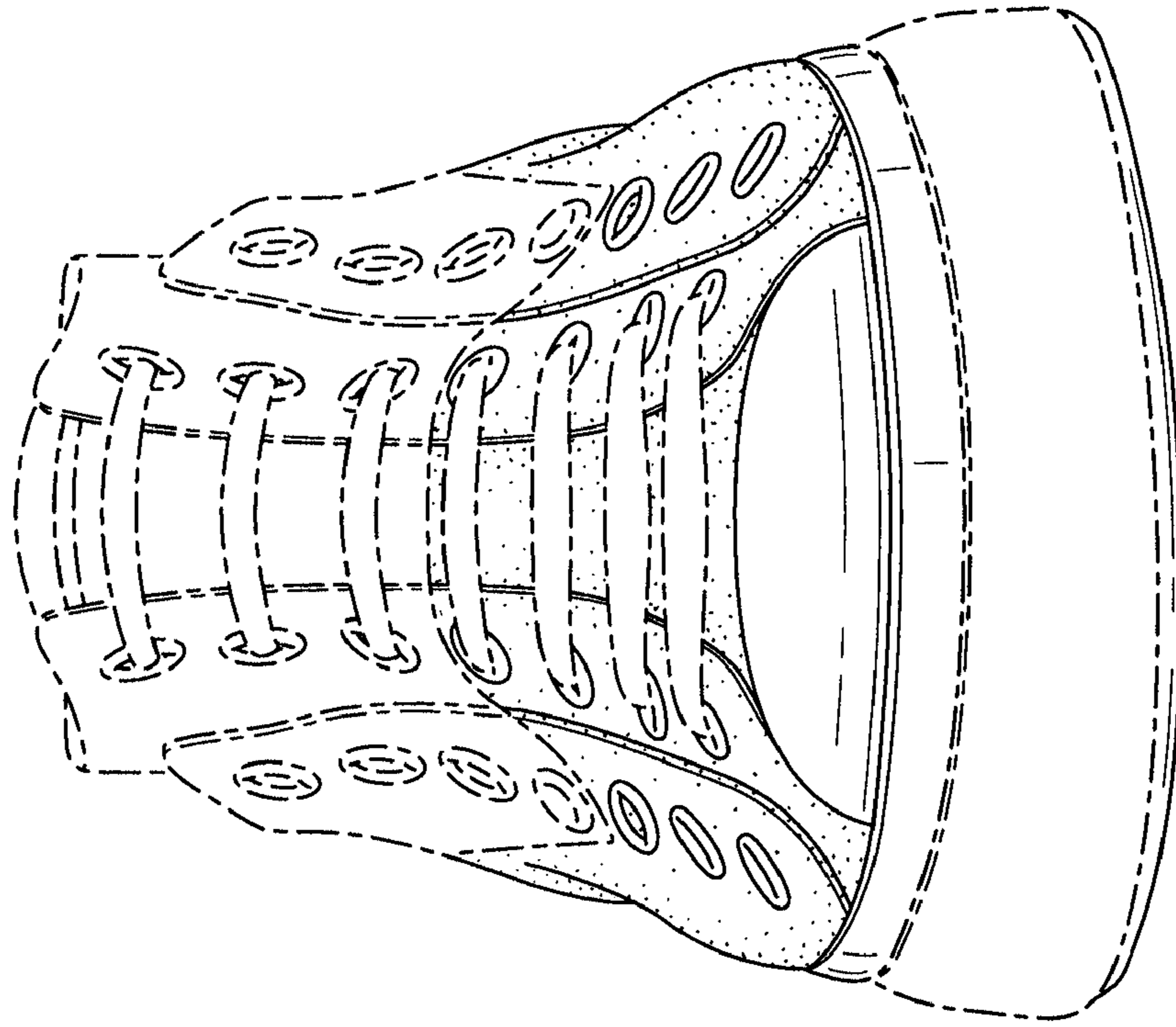

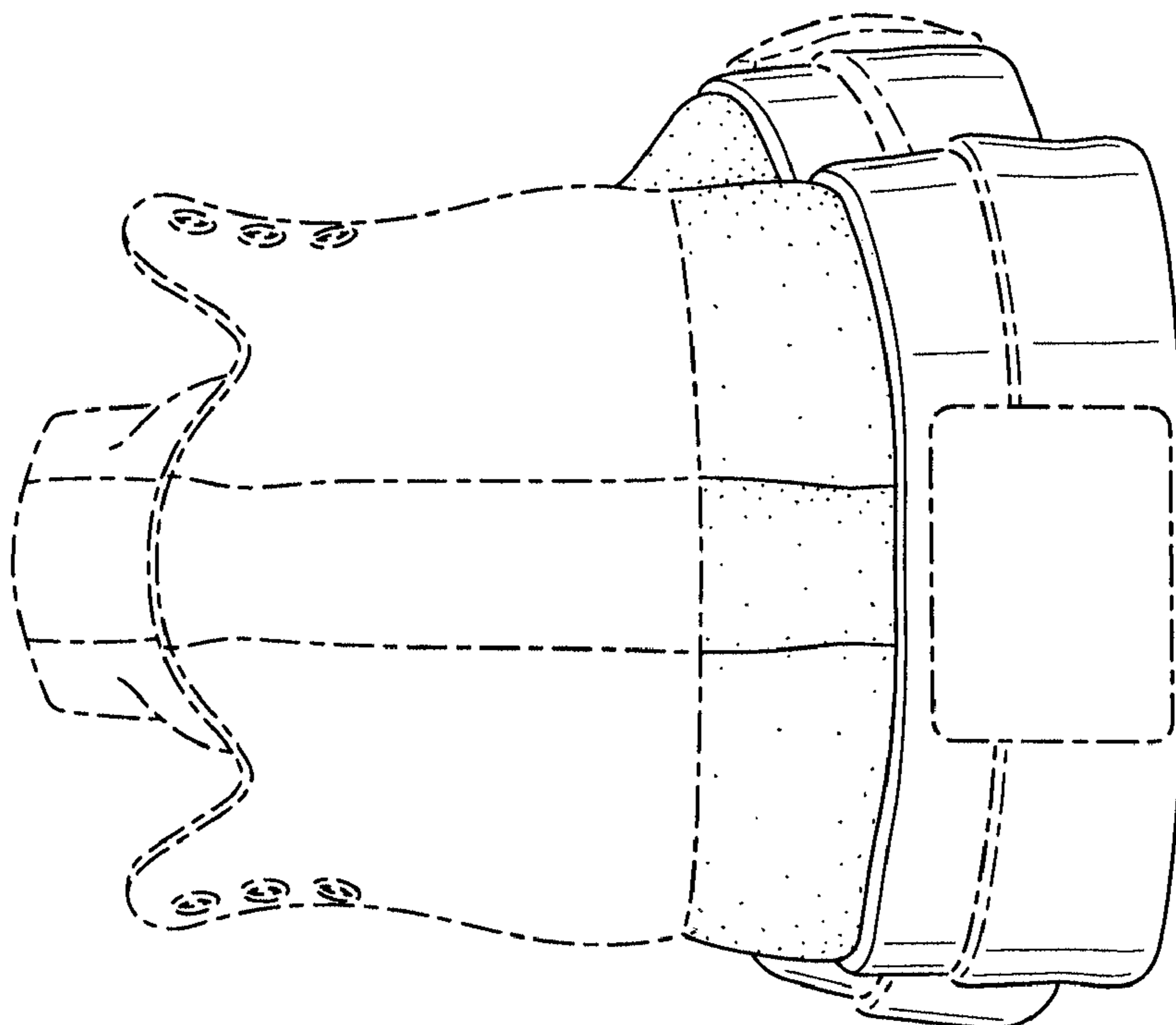
