(57) **CLAIM**

The ornamental design for a gate-leg table, as shown and described.

**DESCRIPTION**

FIG. 1 is a side view of a gate-leg table showing my new design, the other side being a mirror image thereof;

FIG. 2 is a first end view thereof;

FIG. 3 is a second end view thereof;

FIG. 4 is a top plan thereof;

FIG. 5 is a bottom plan view thereof with the legs being in an extended position;

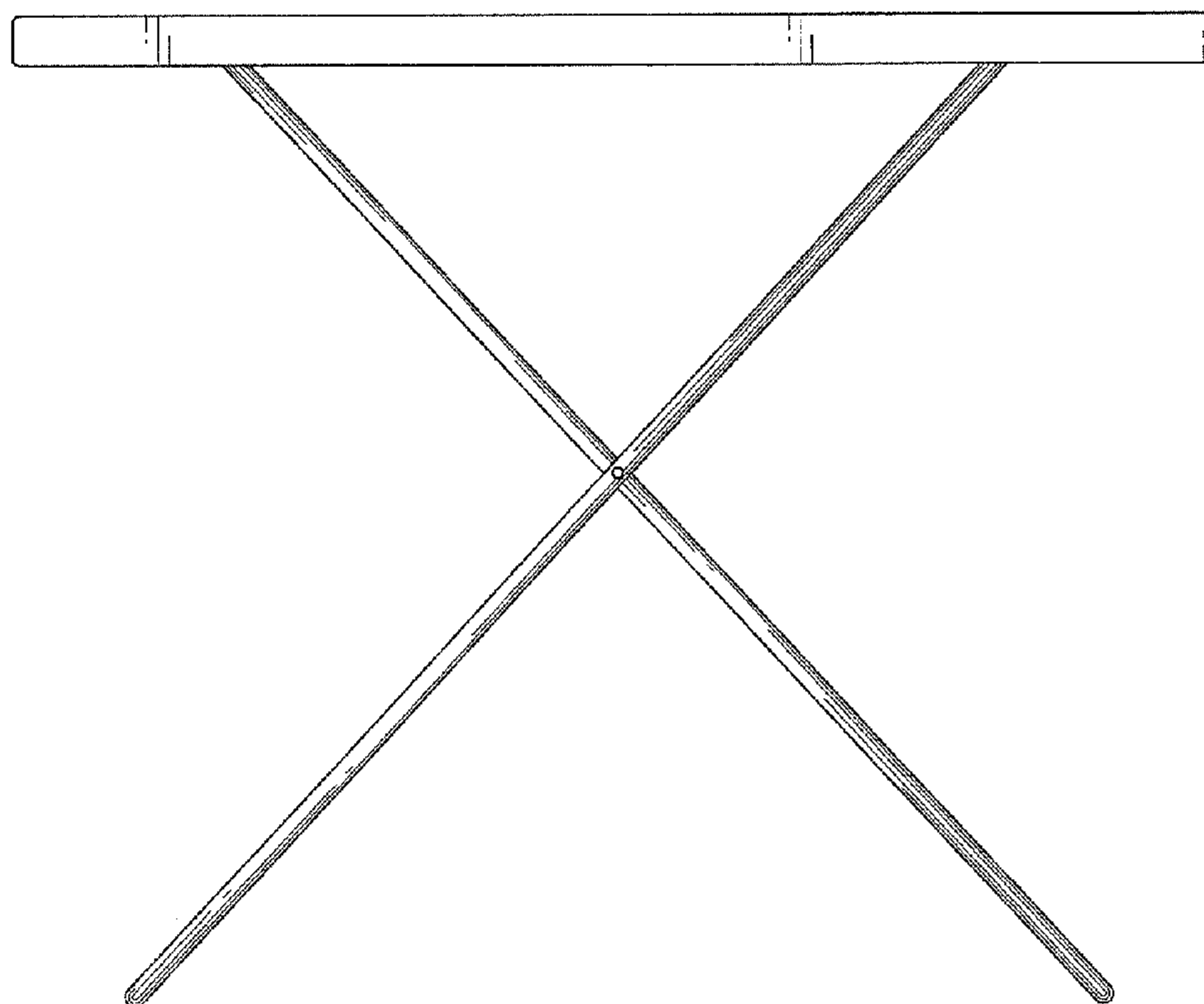
FIG. 6 is a bottom plan view thereof with the legs being in a folded position;

FIG. 7 is a top and side perspective view thereof with the legs in the extended position; and,

FIG. 8 is a bottom and side perspective view thereof with the legs in the extended position.

The broken lines of FIGS. 5, 6 and 8 illustrating a contour of a bottom face of the table are for illustrative purposes only and form no part of the claimed design.

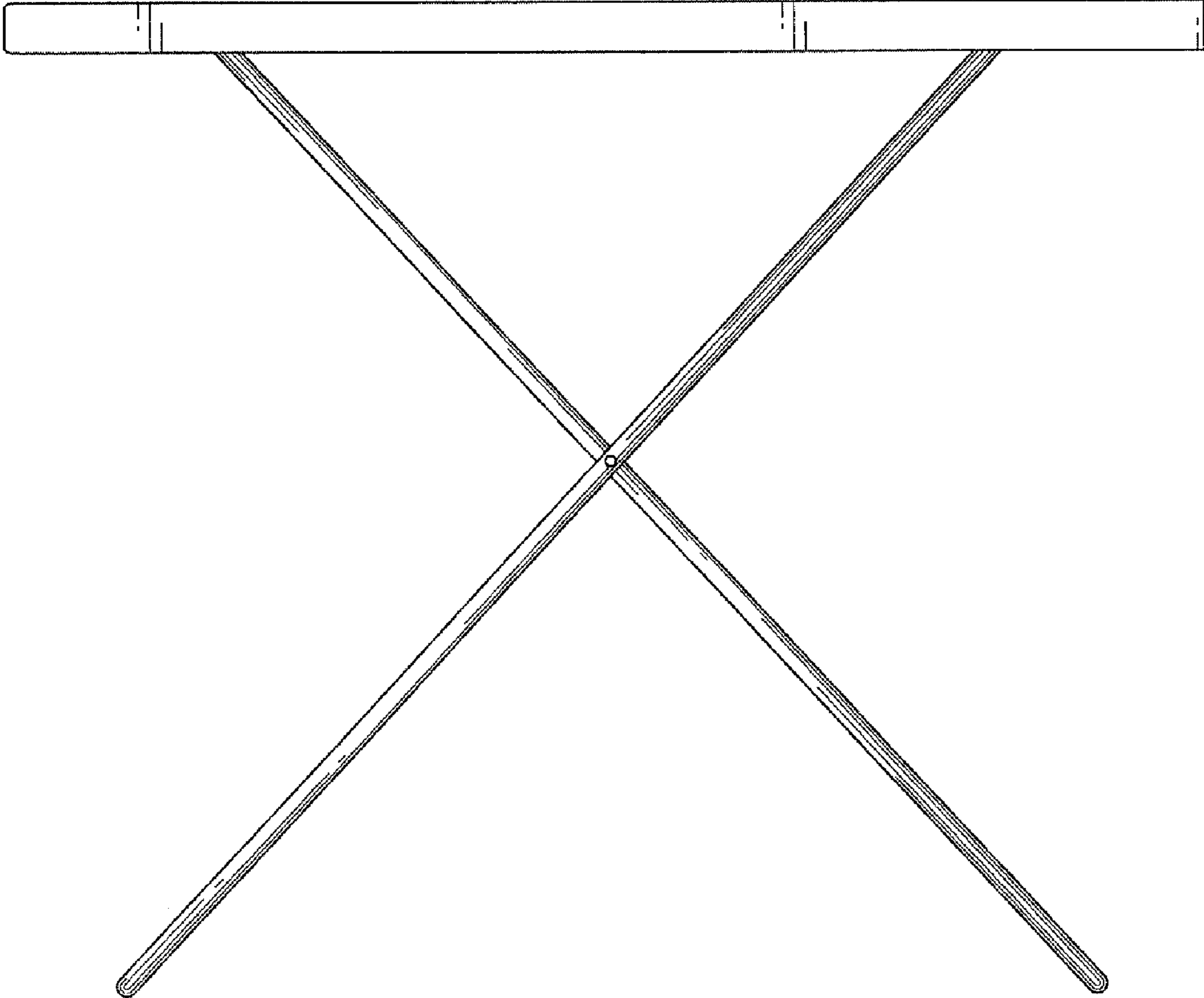

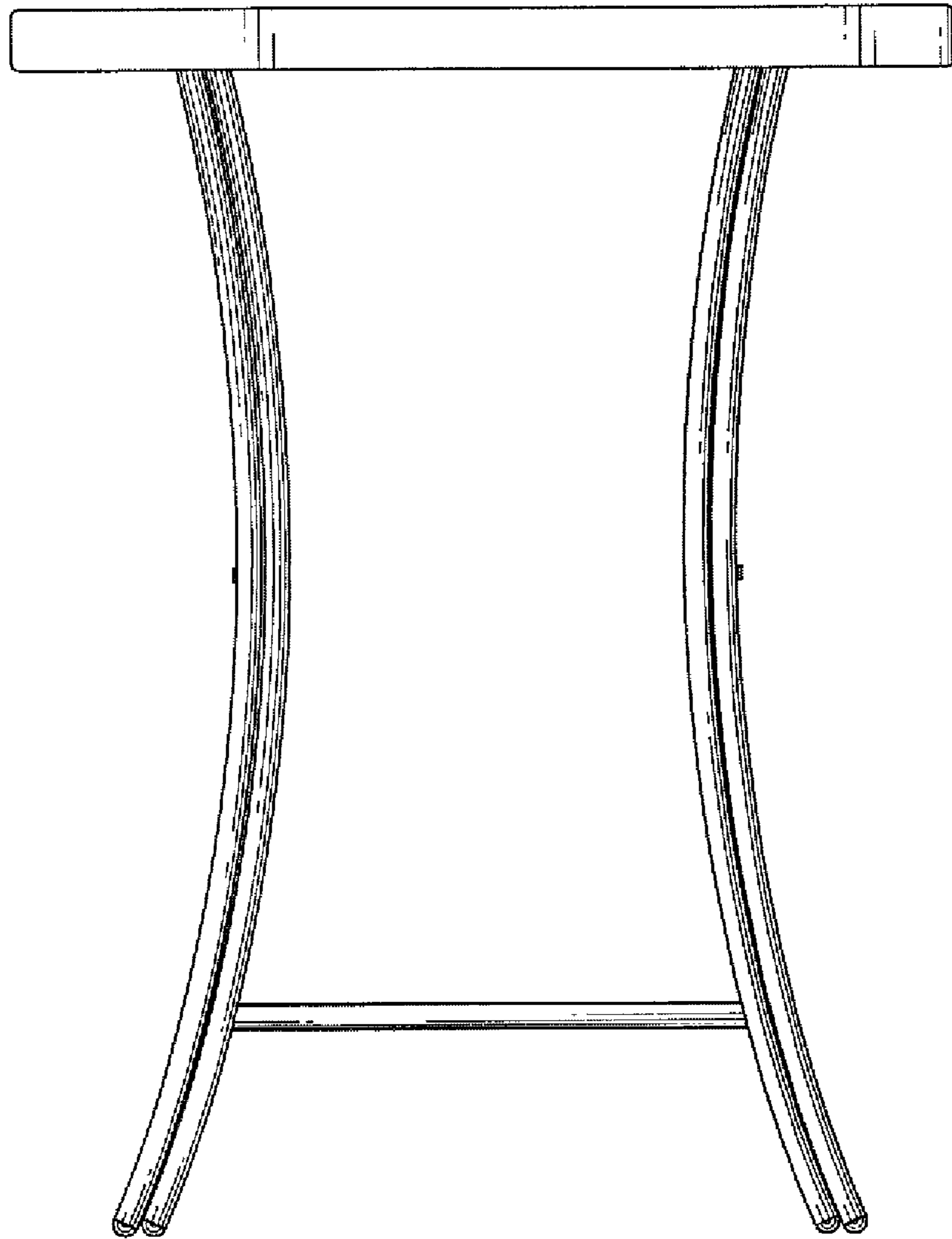

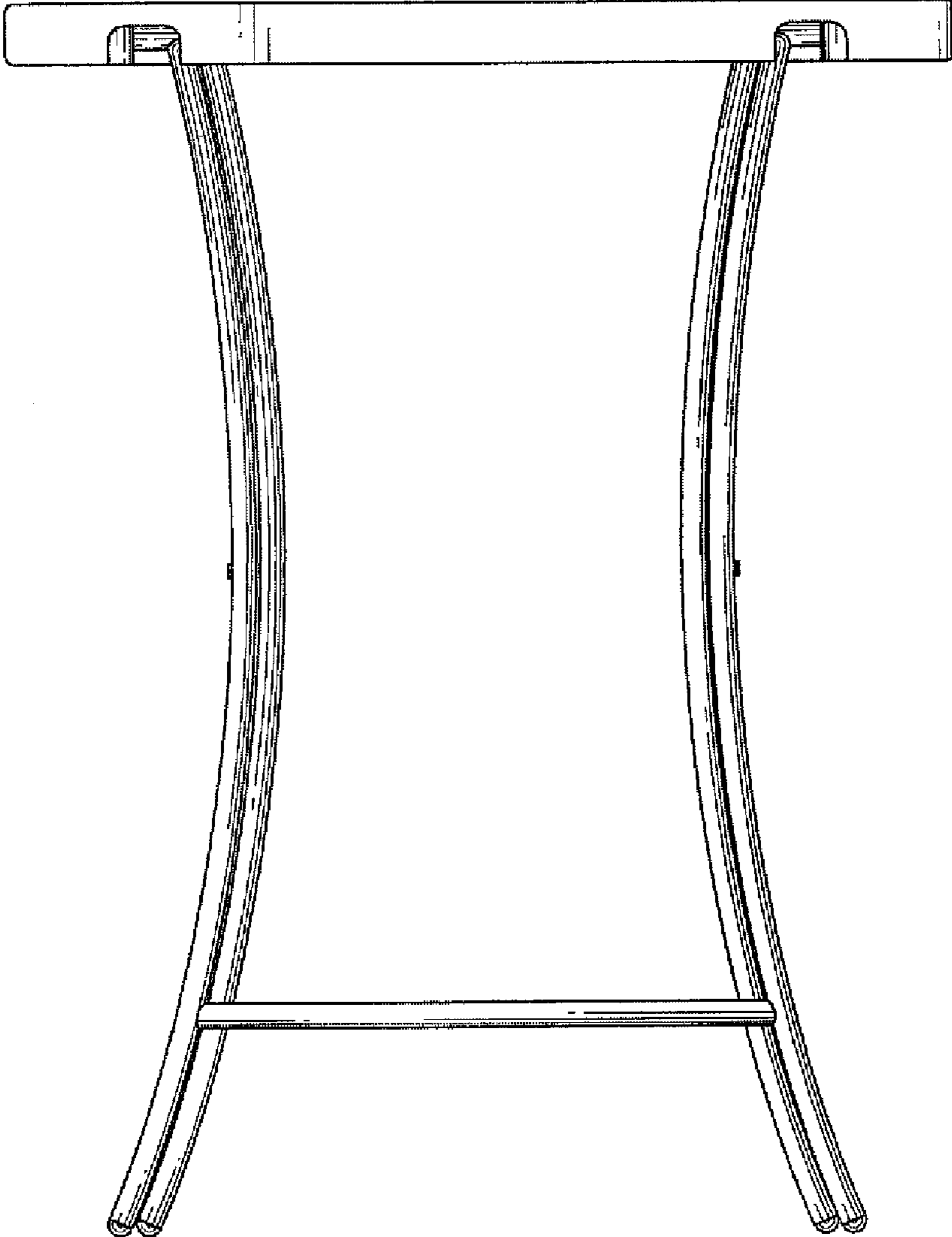

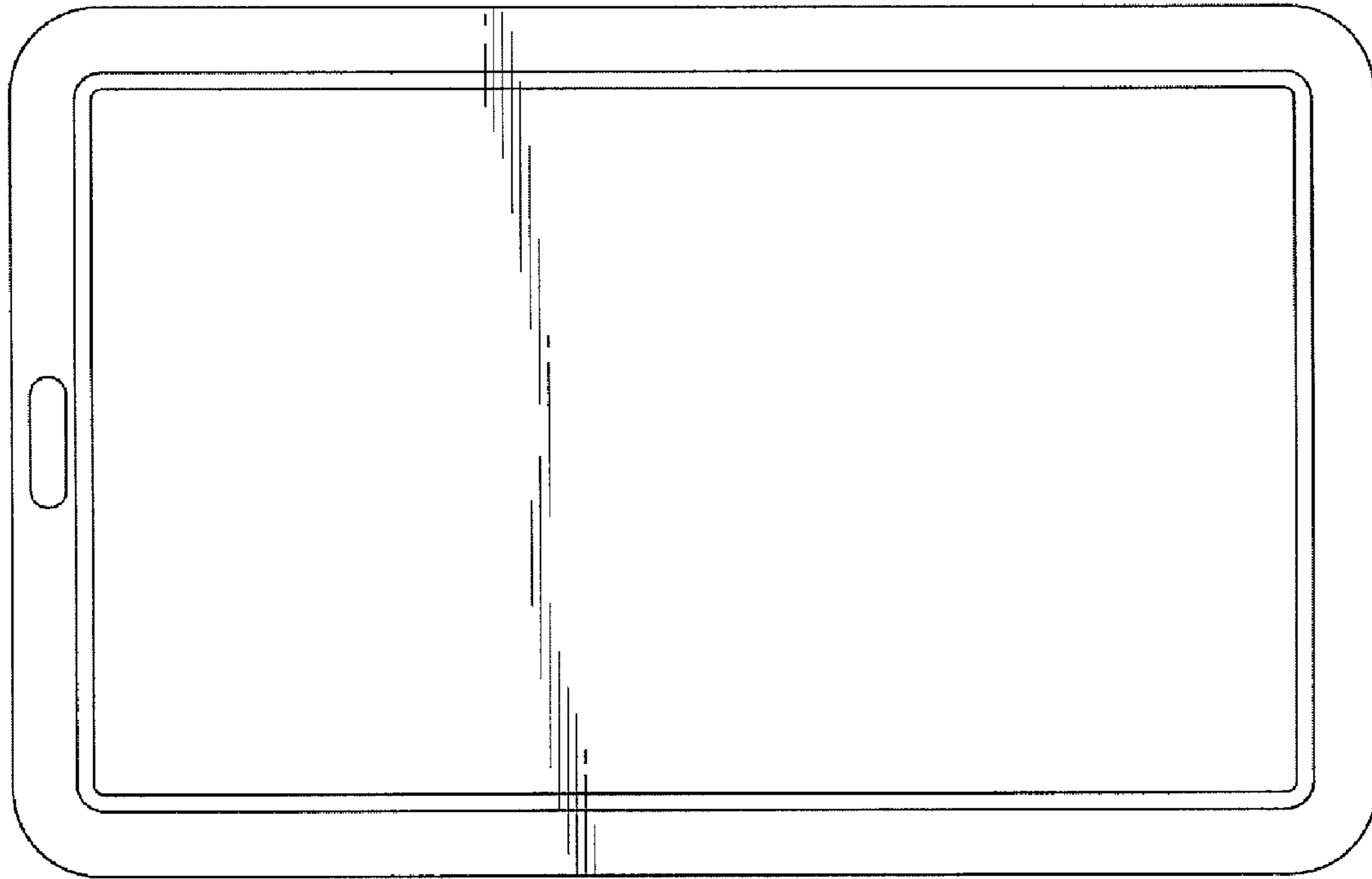

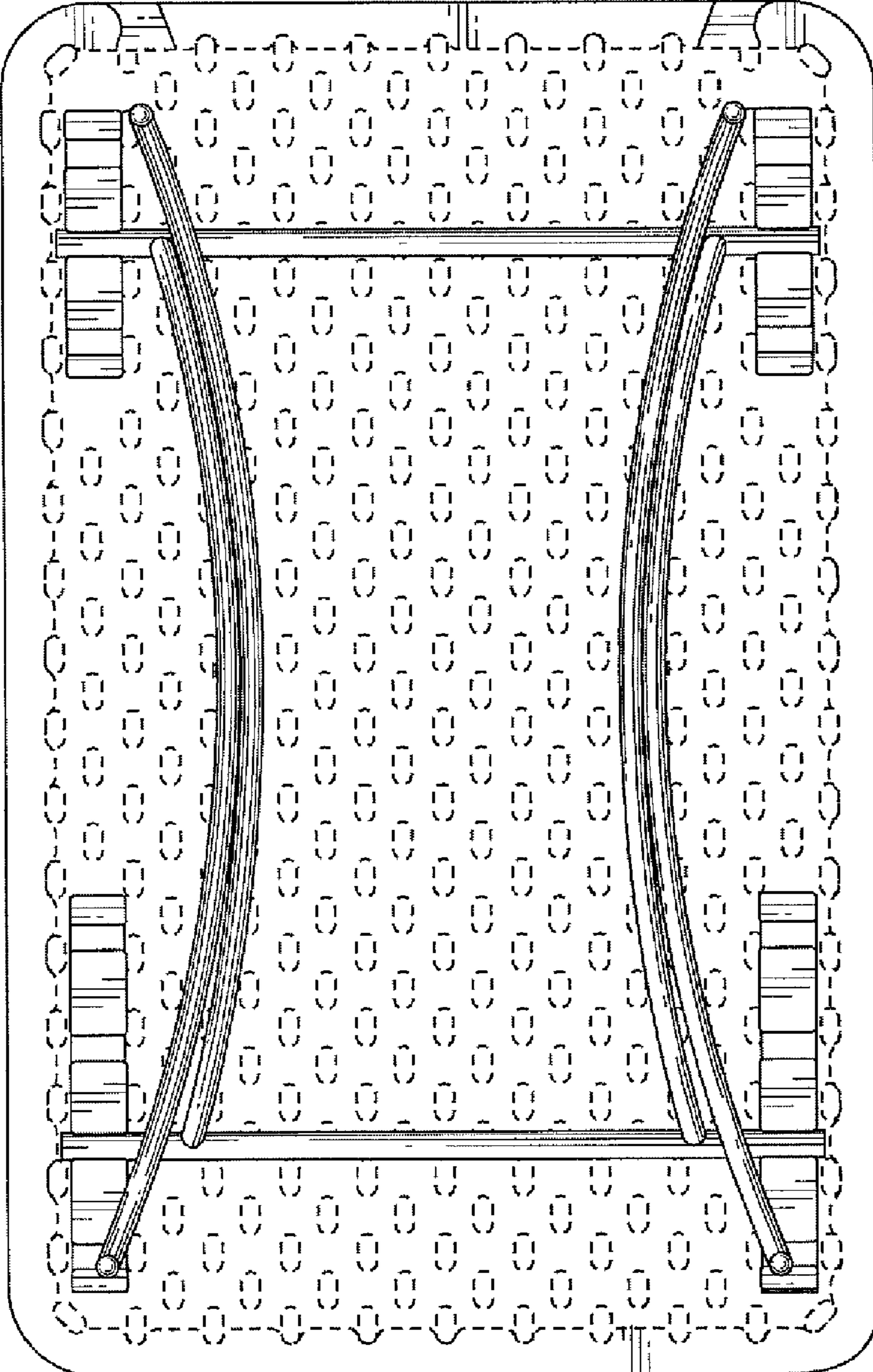

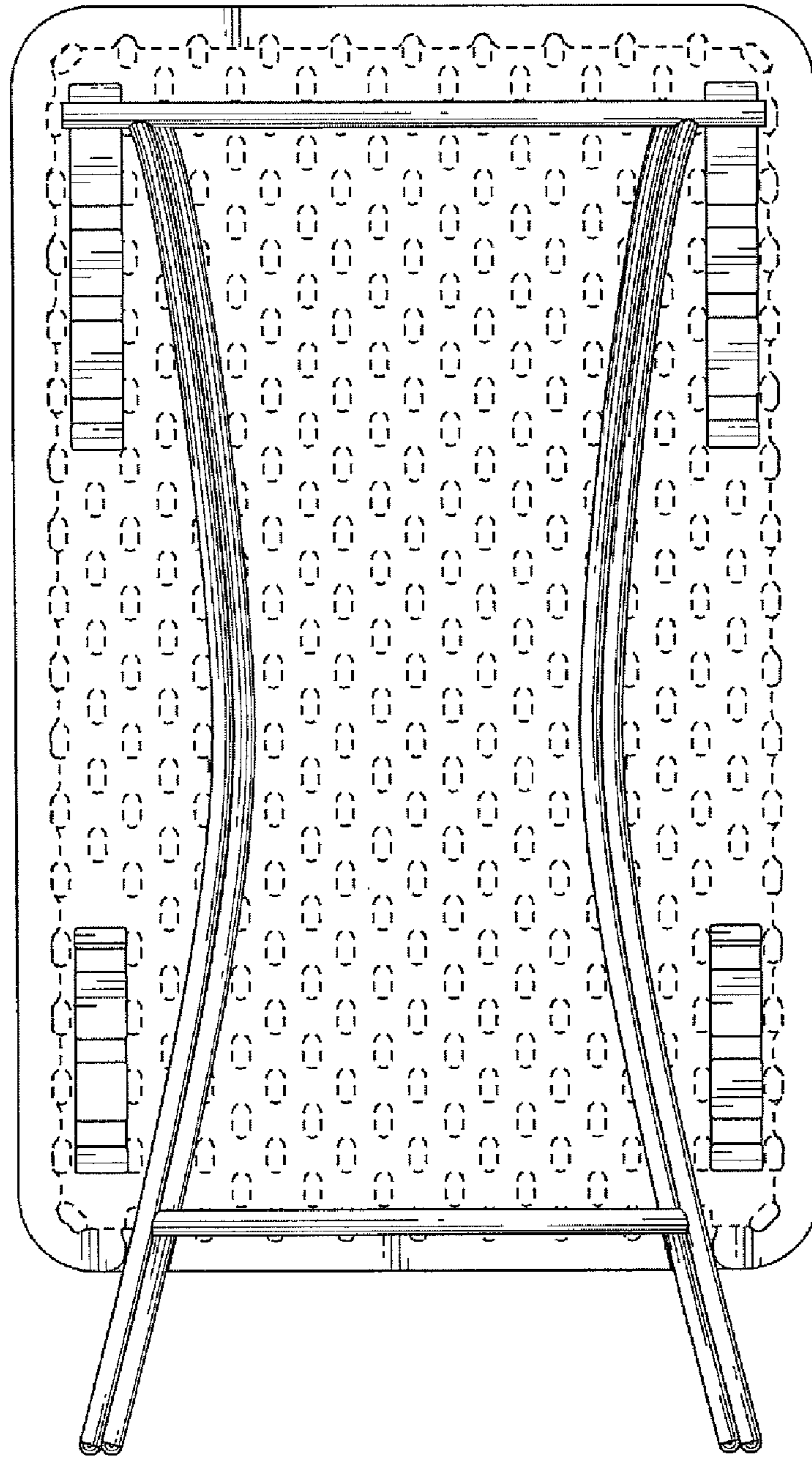

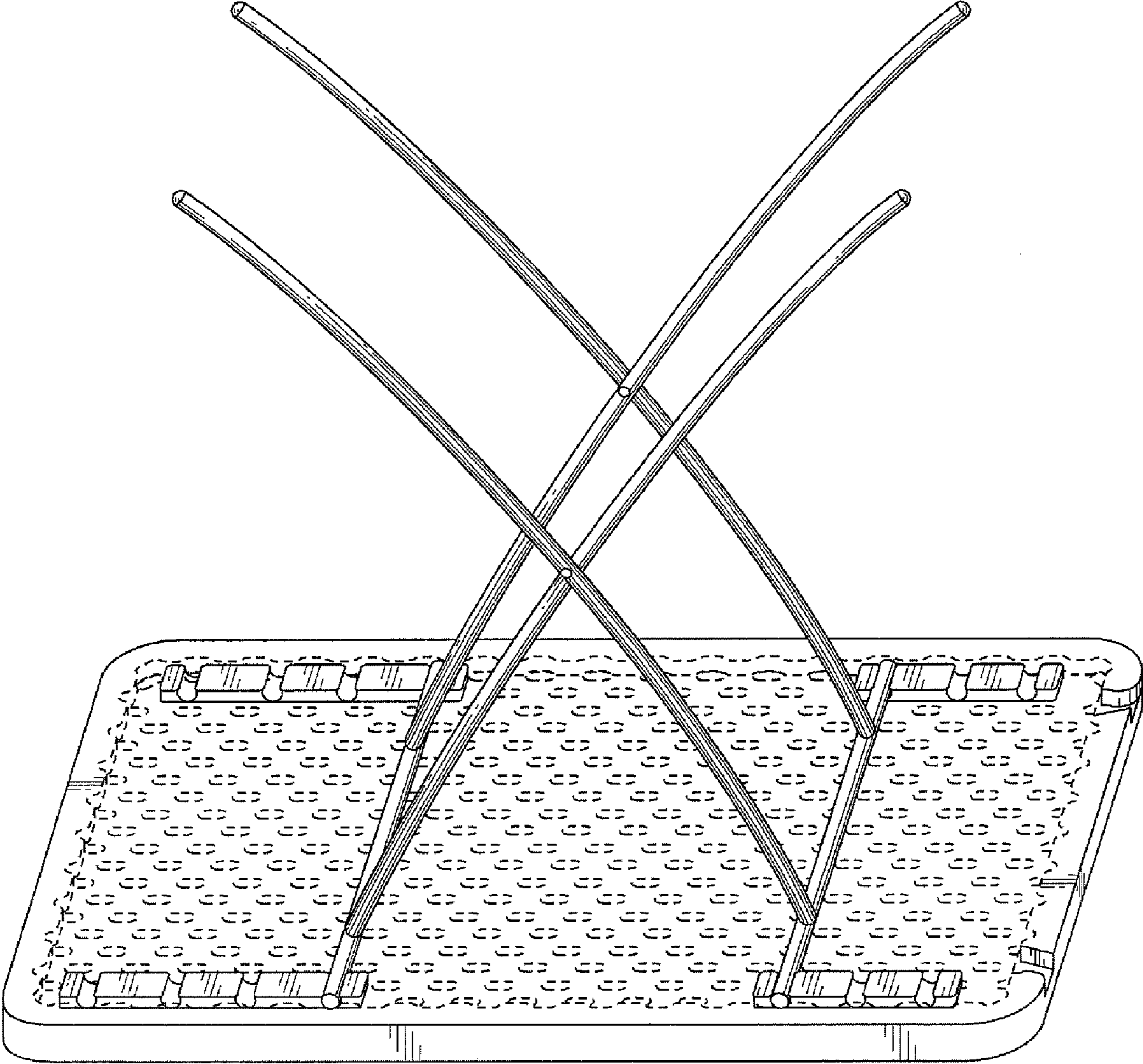
