**DESCRIPTION**

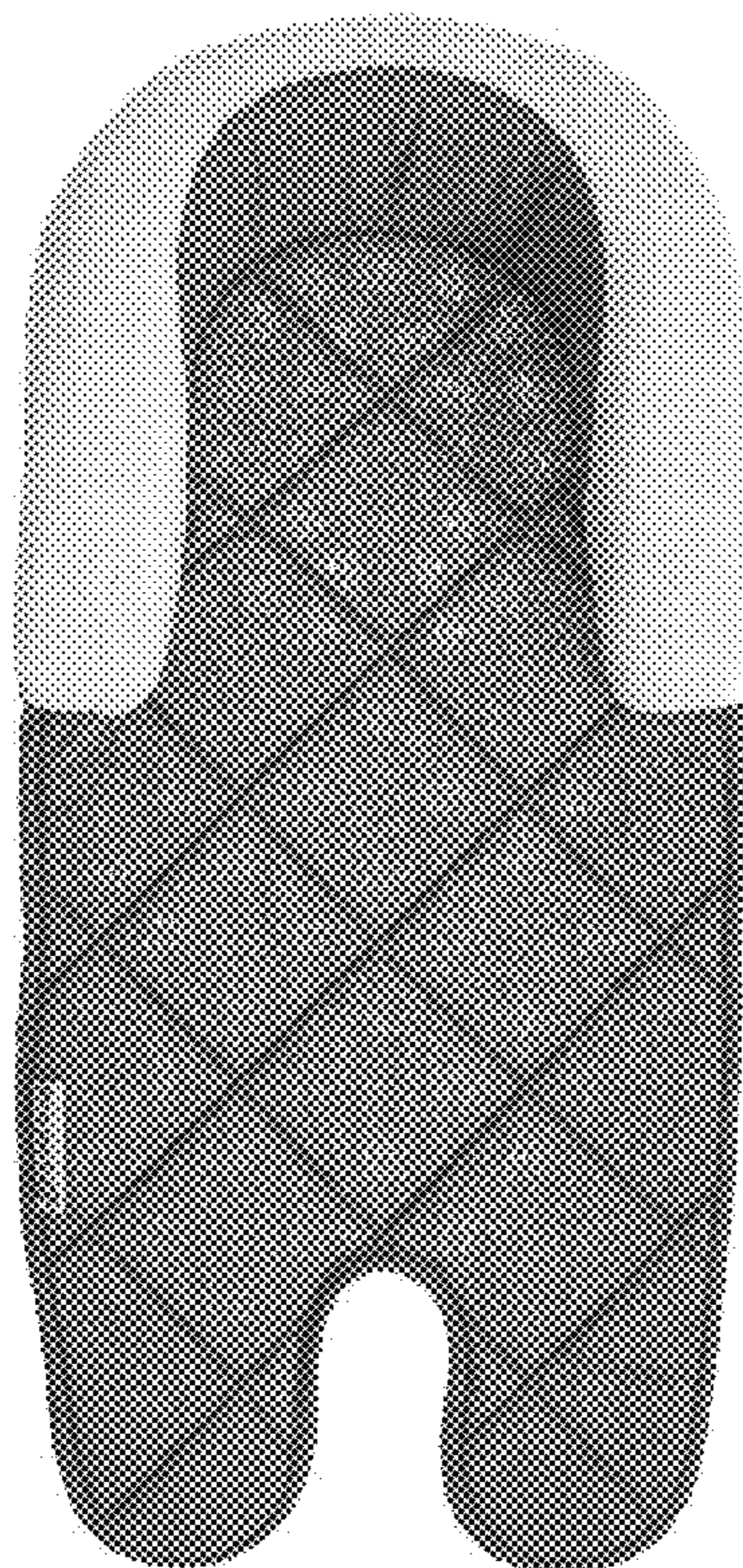
FIG. 1 is a front elevational view showing our new design;

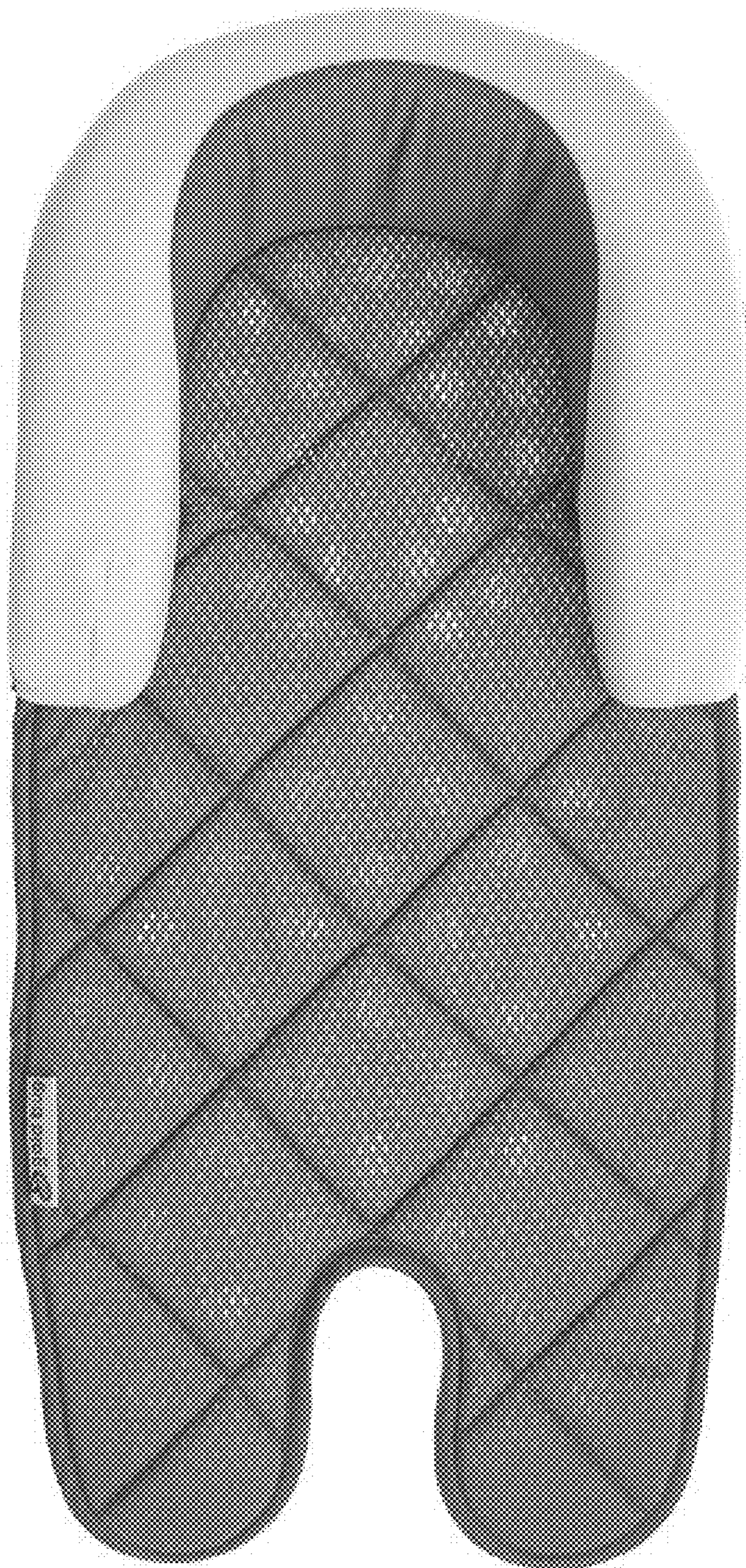

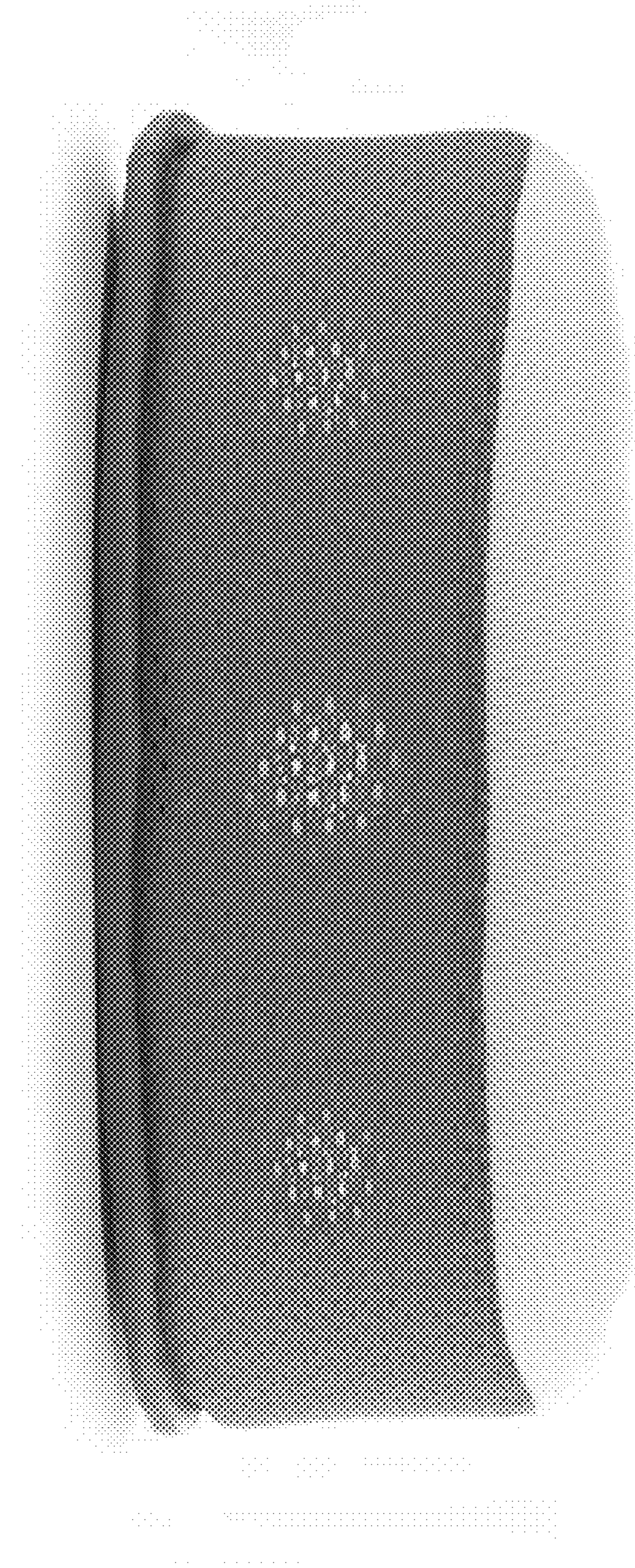

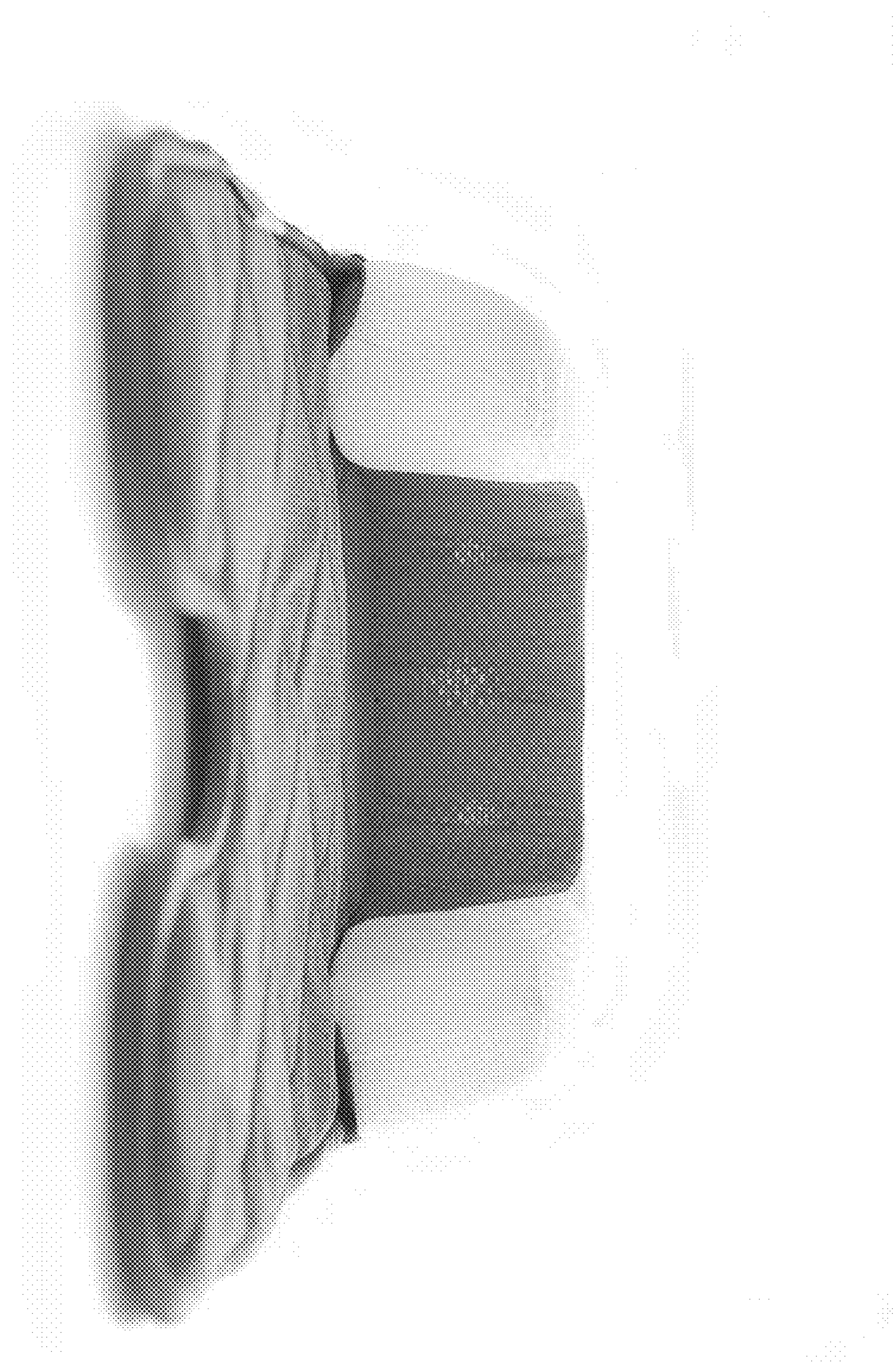

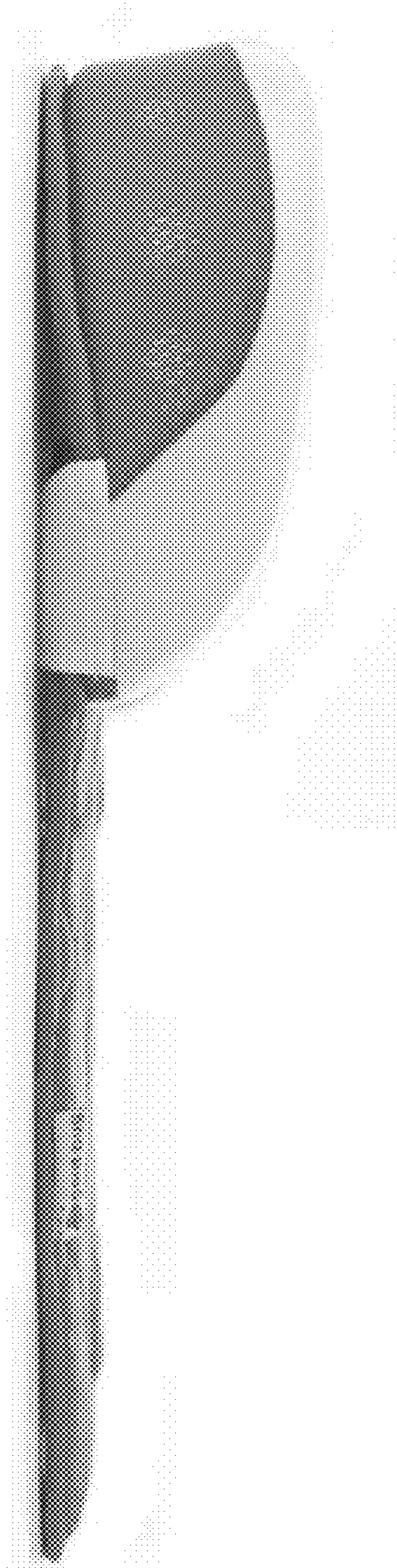
