FIG. 11 is a top view of the article shown in FIG. 7; and,

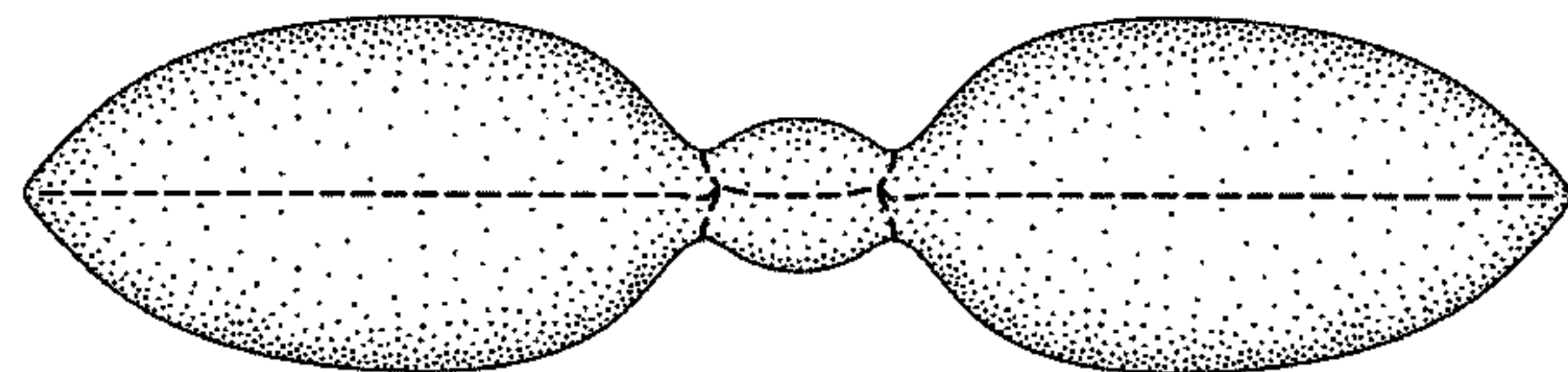
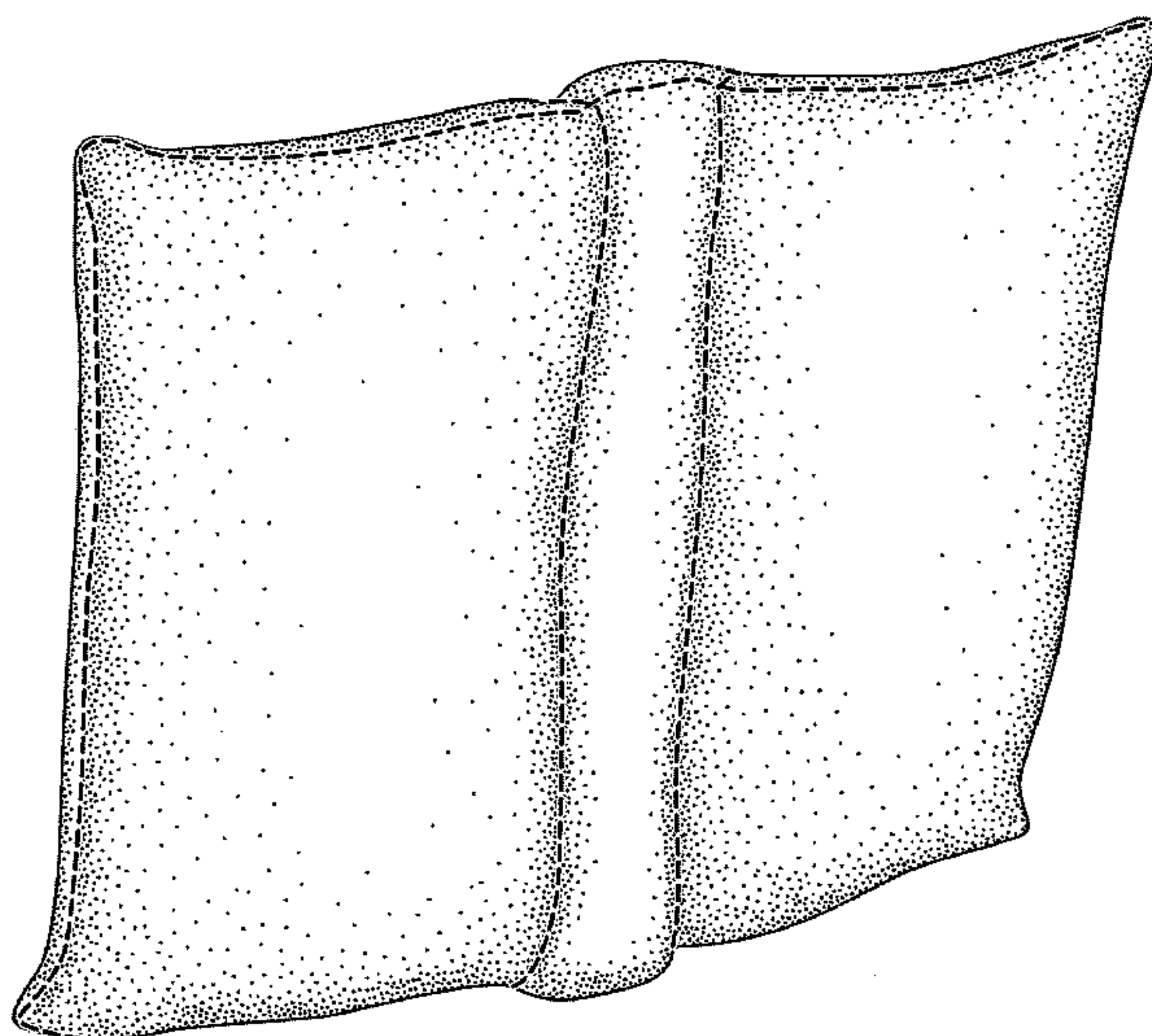
FIG. 12 is a view showing the article in use by a seated person (in phantom lines).

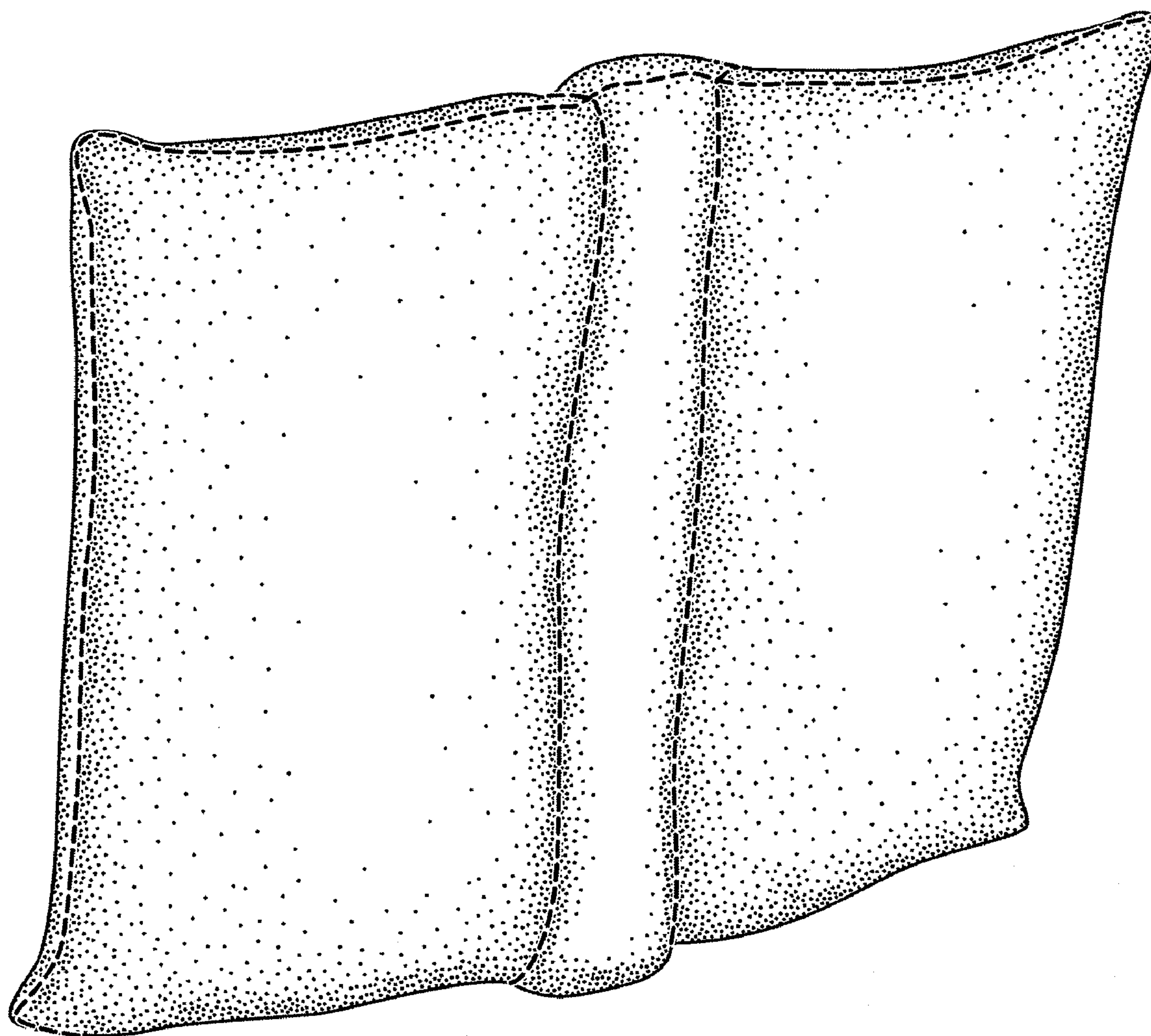

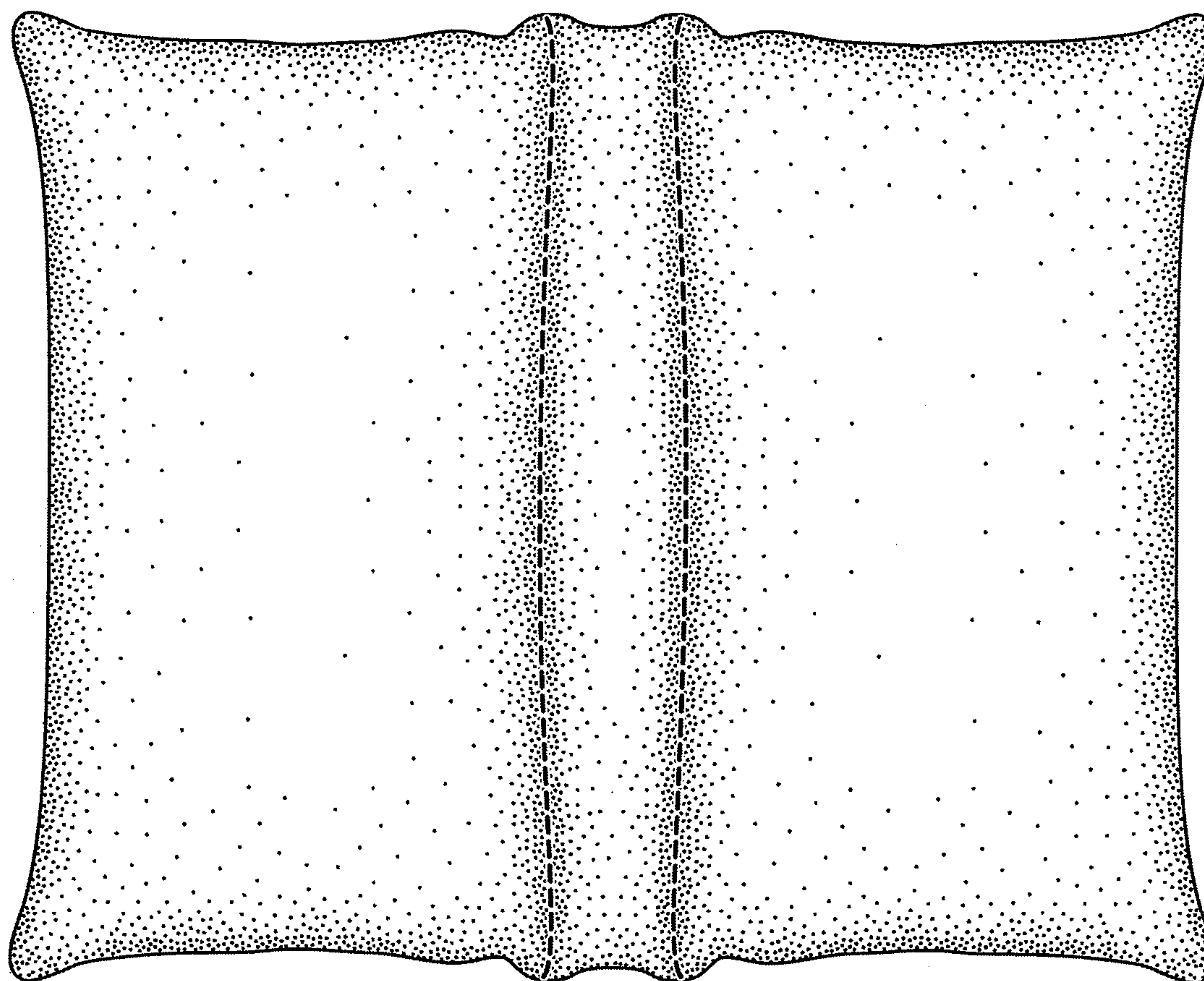

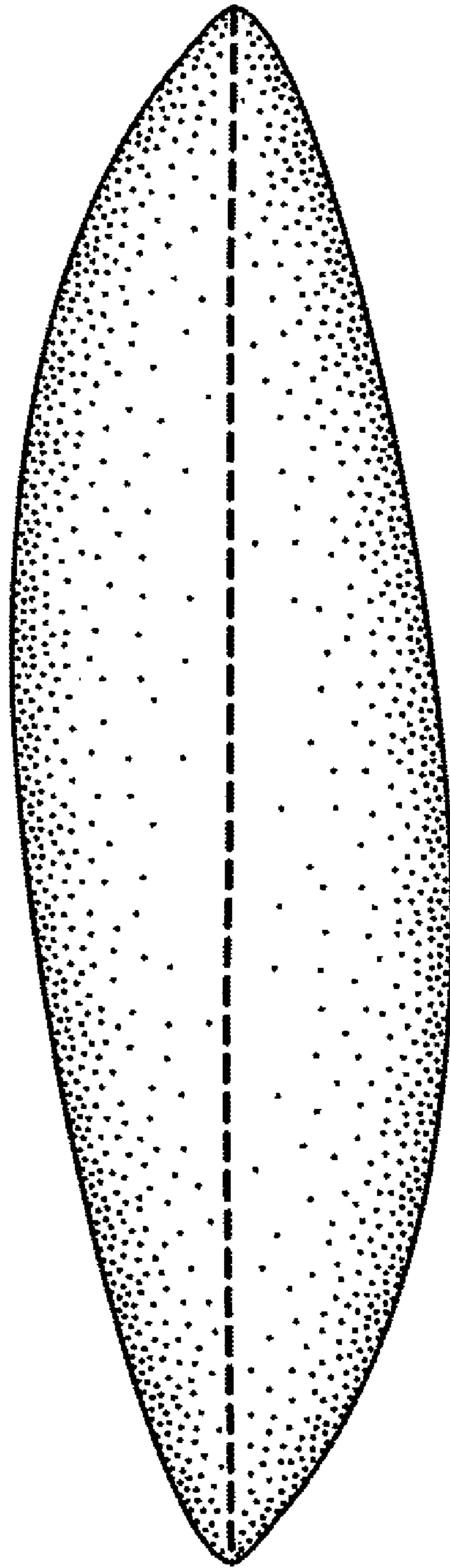

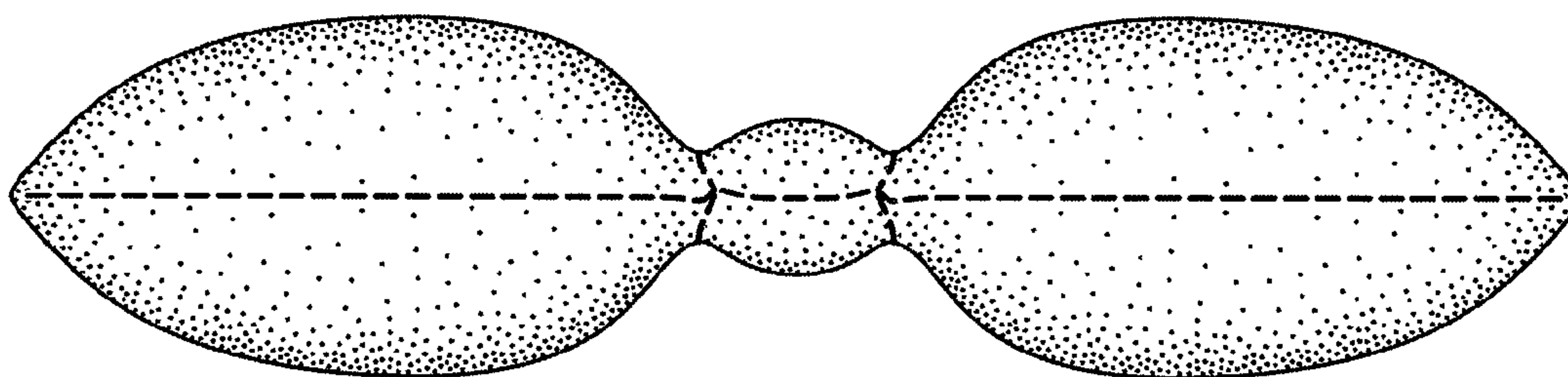

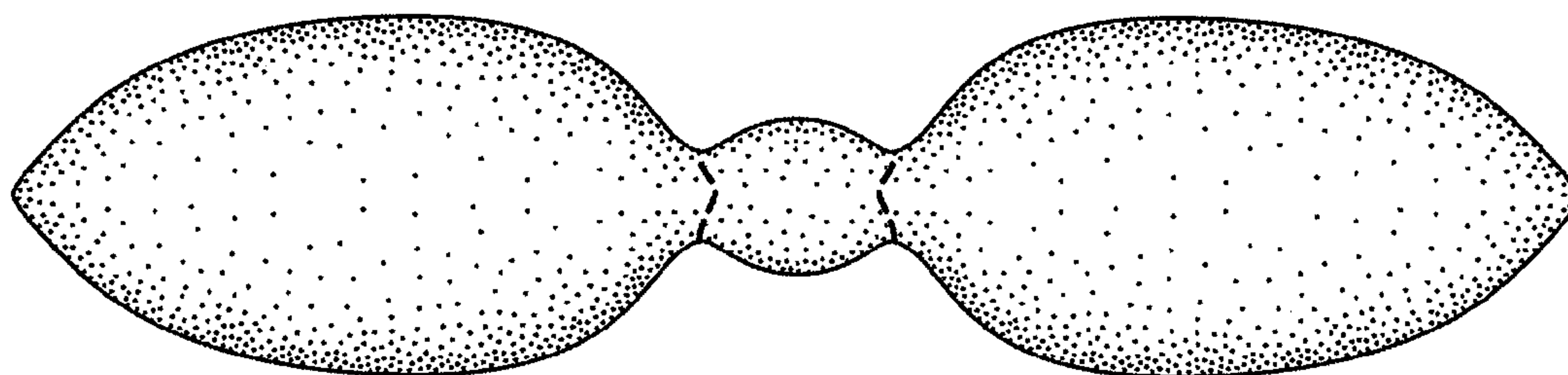

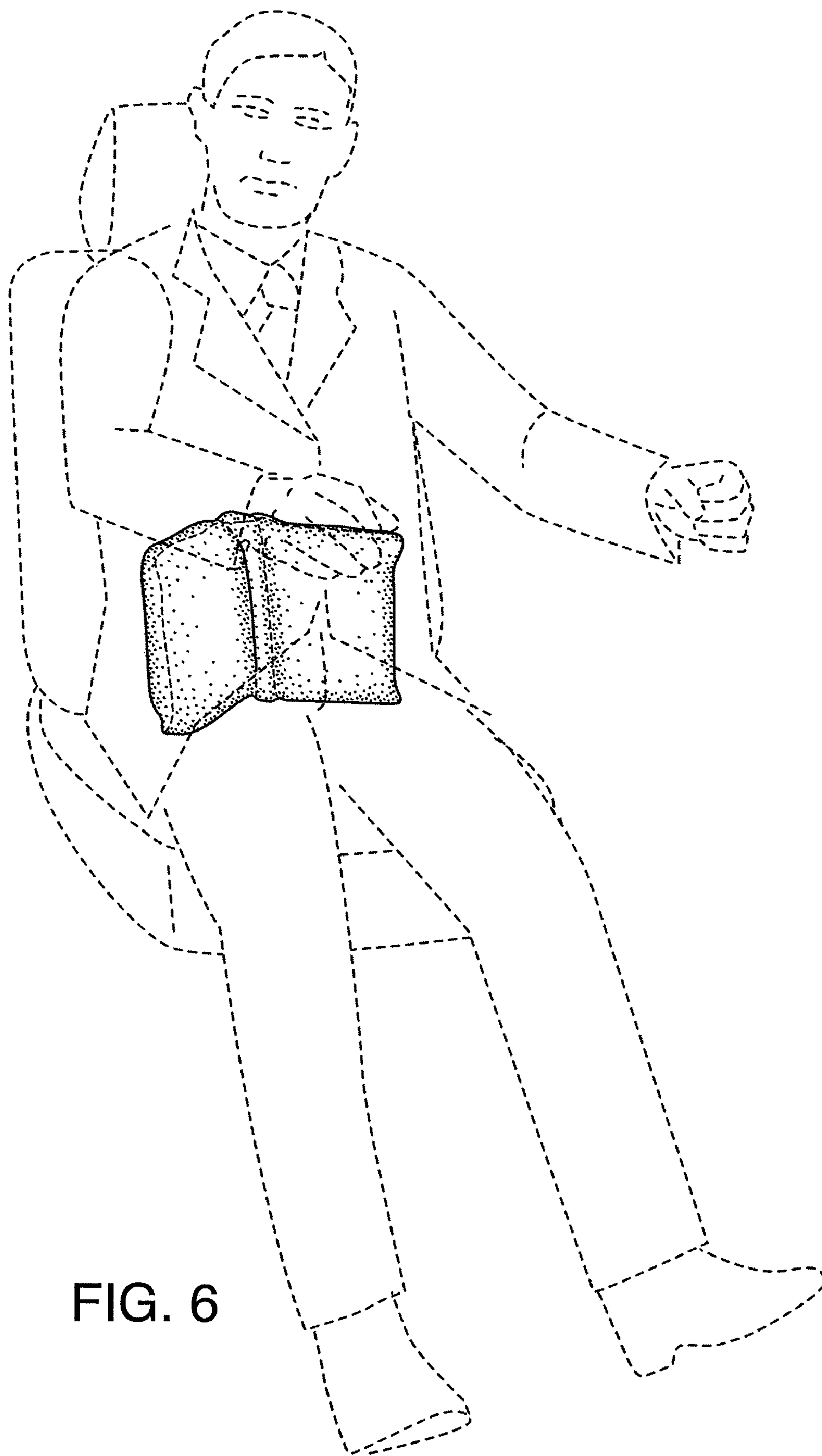

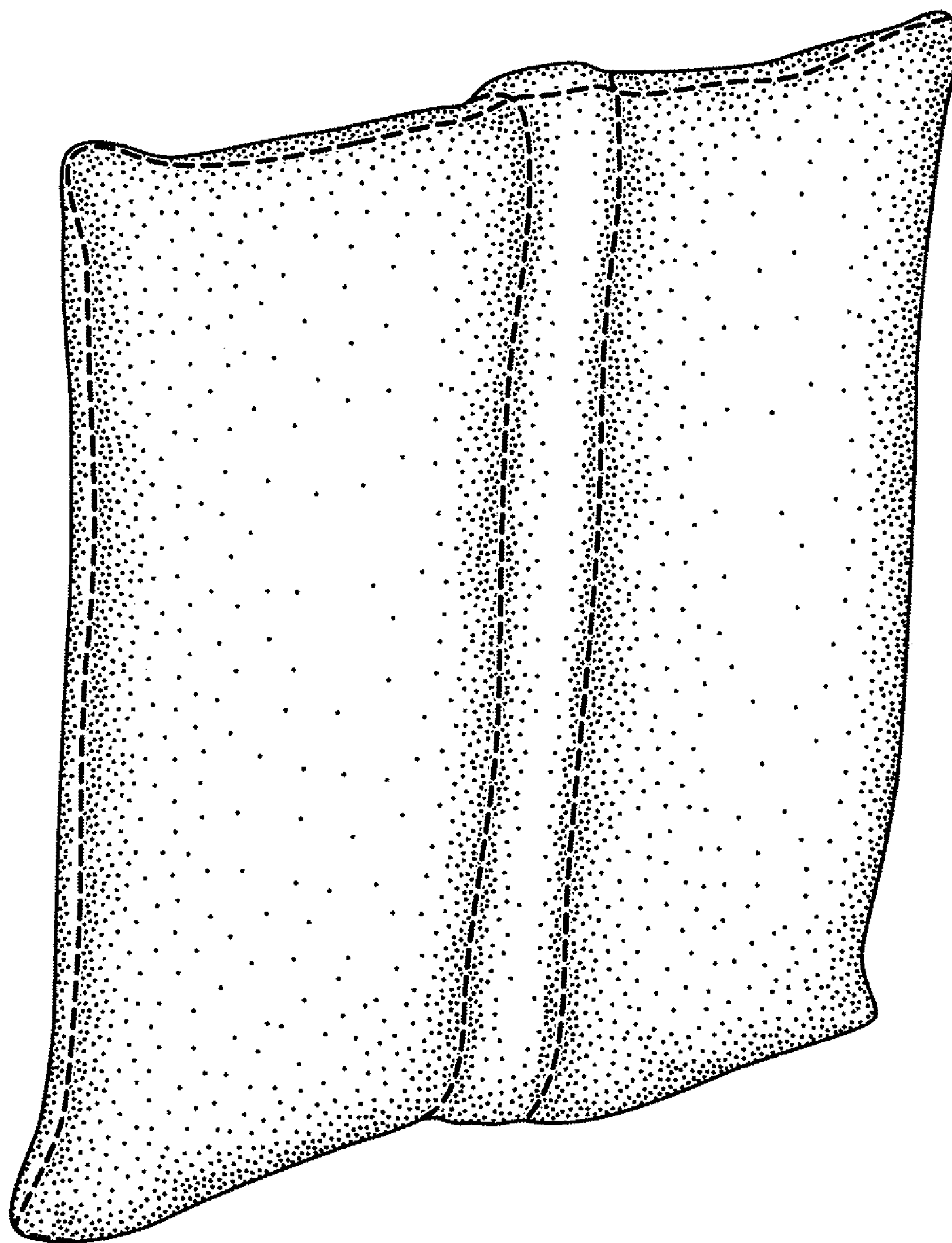

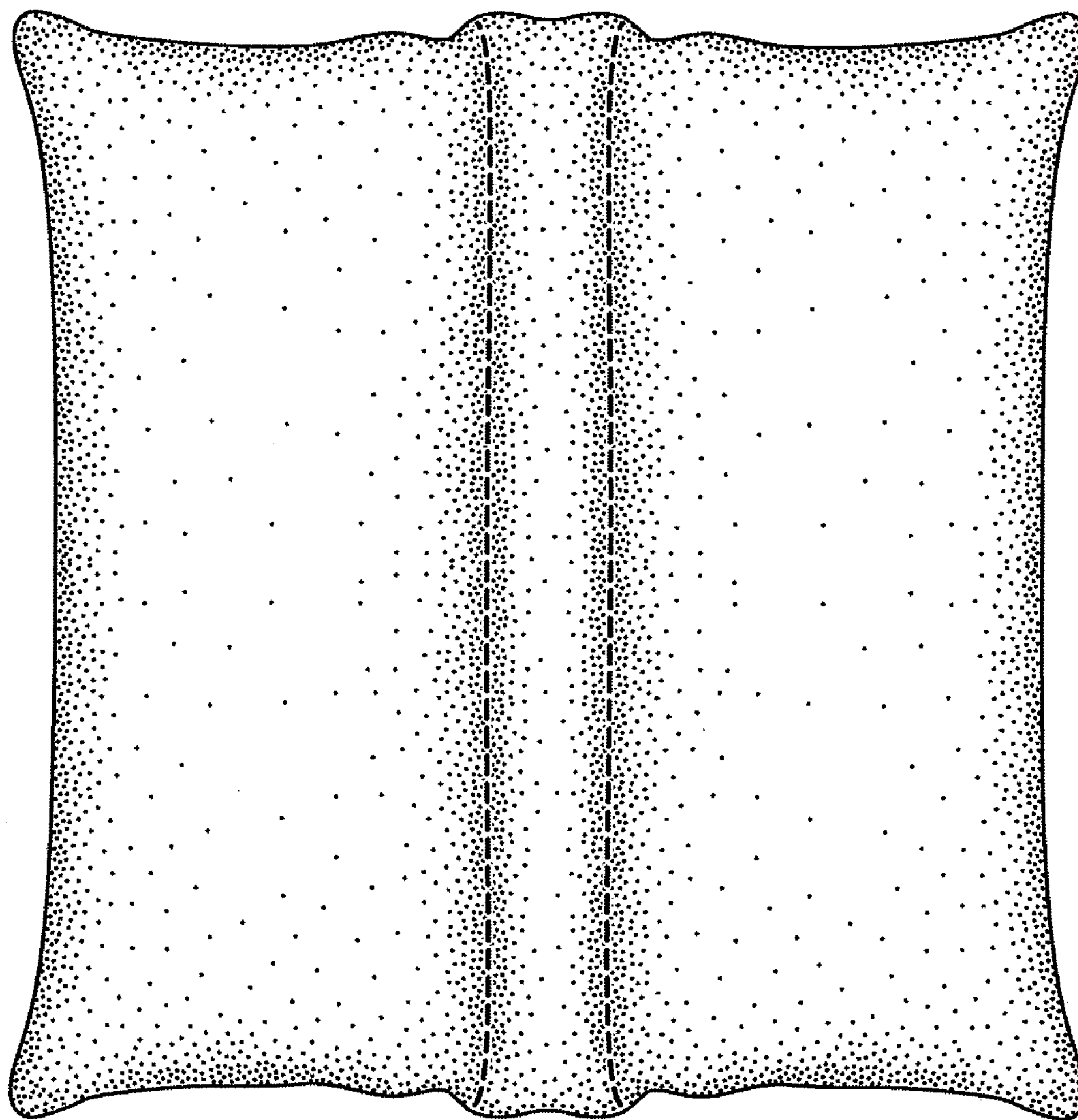

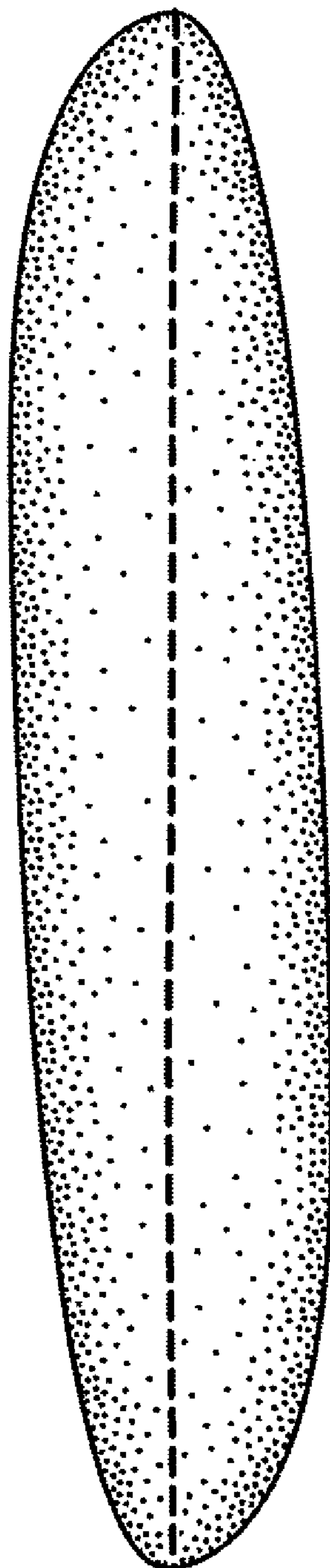

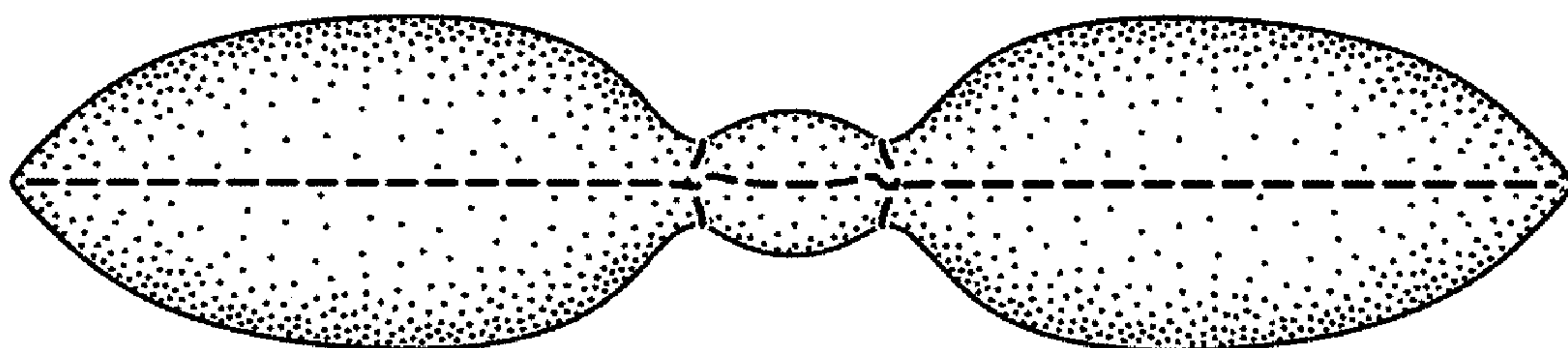

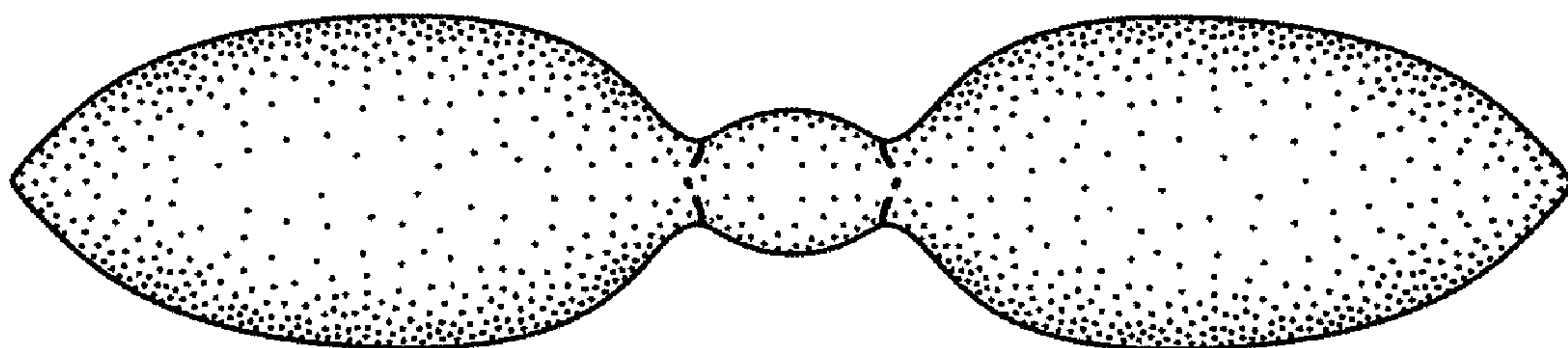

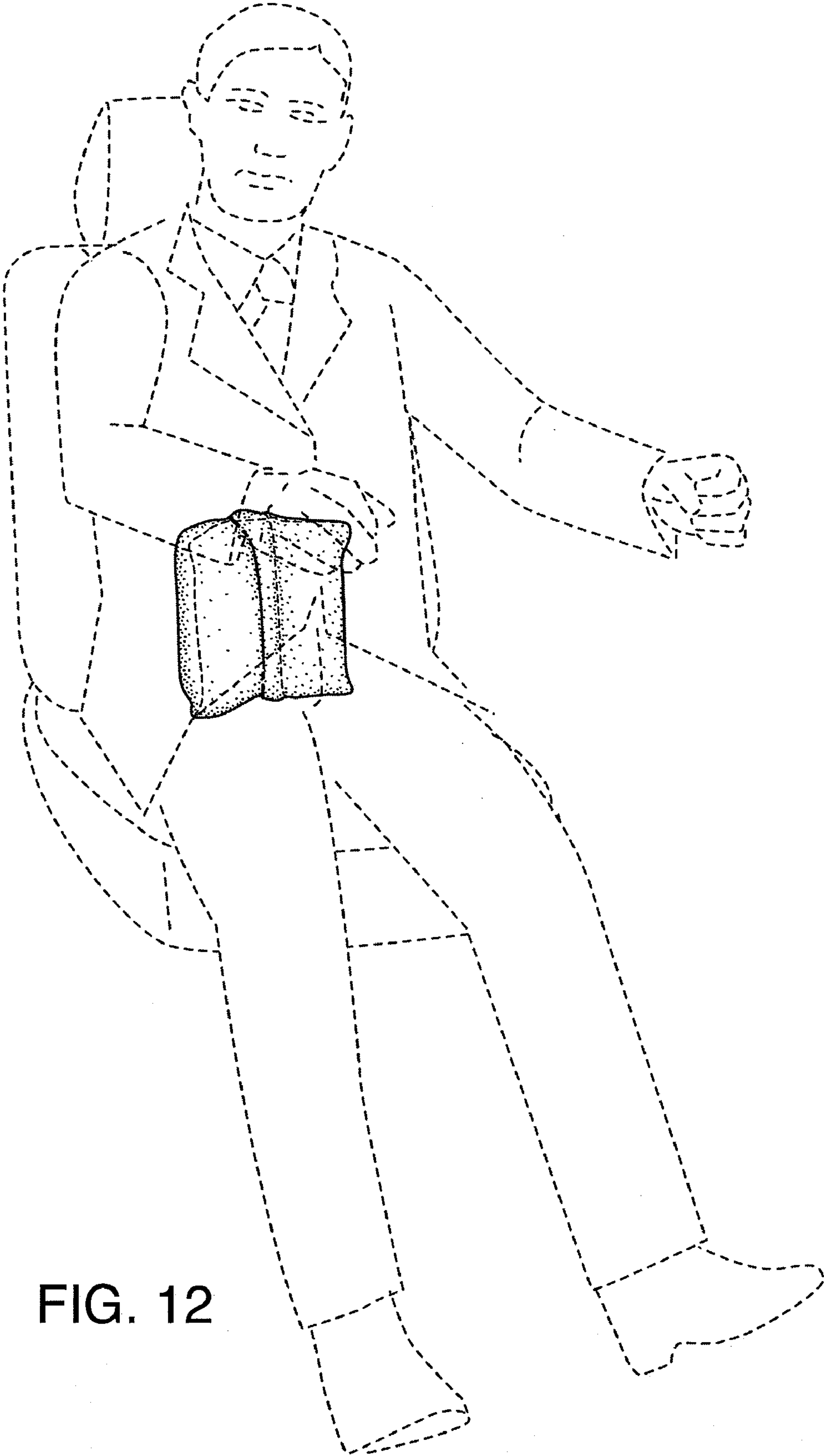
