FIG. 7 is a bottom plan view of the design therefor.

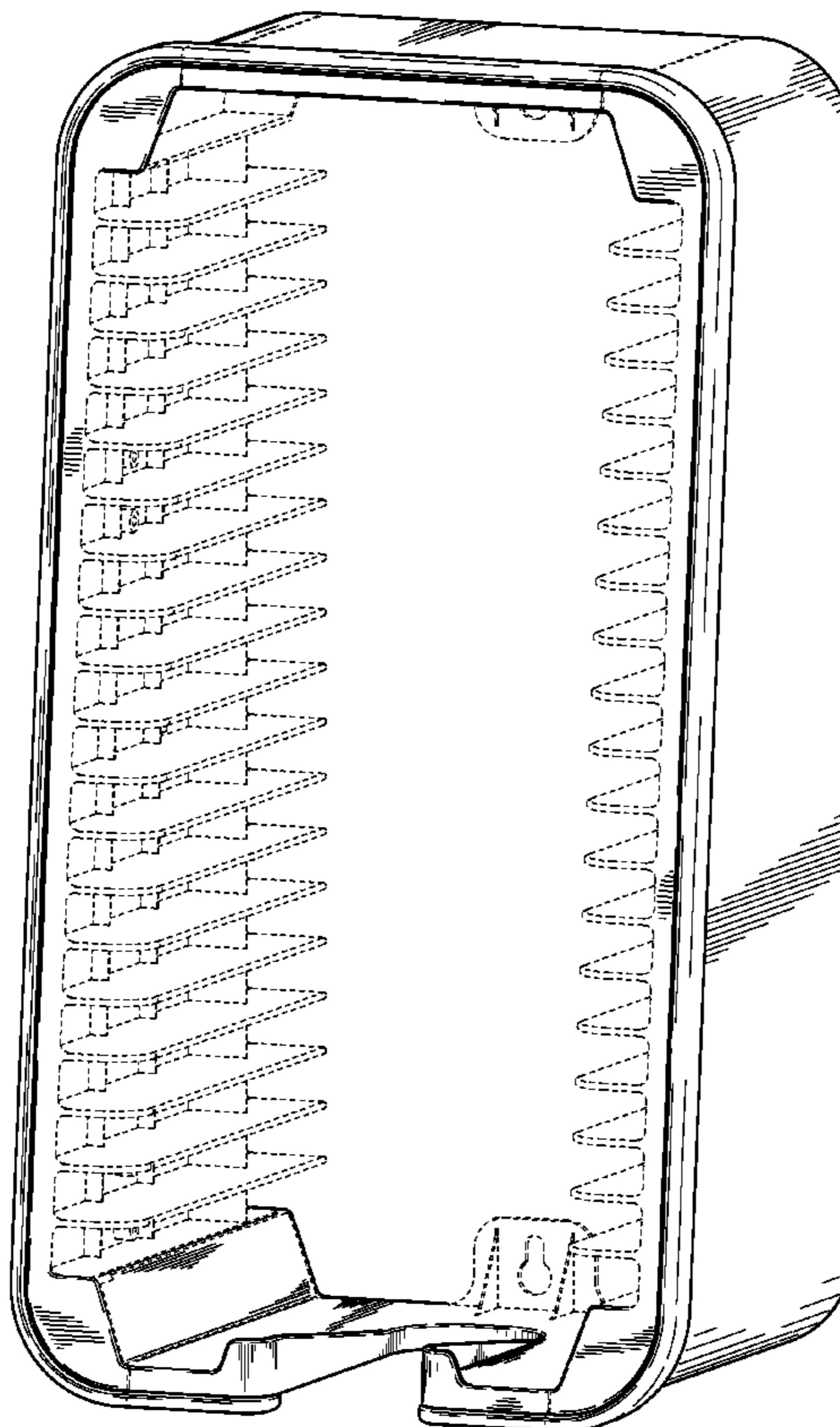

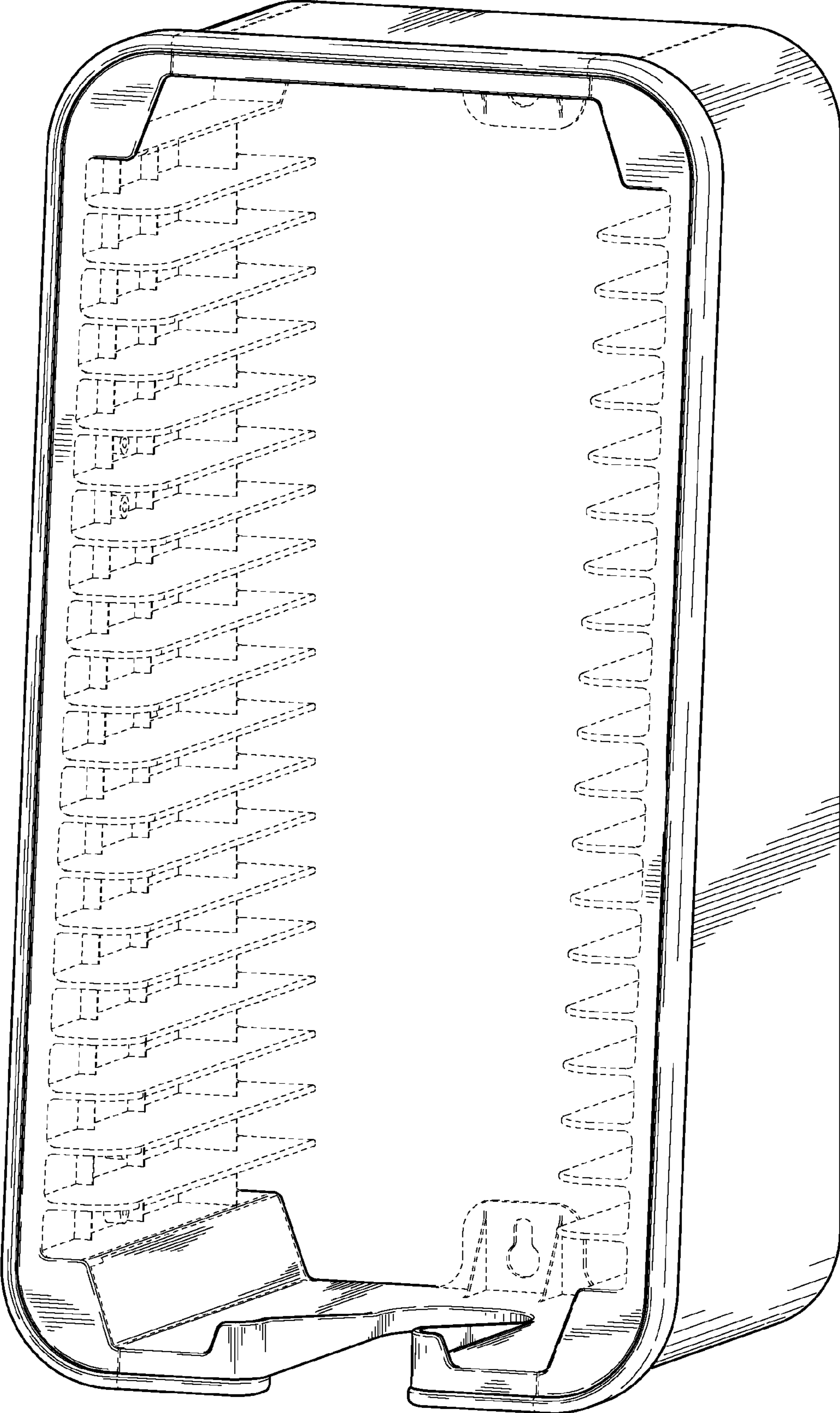

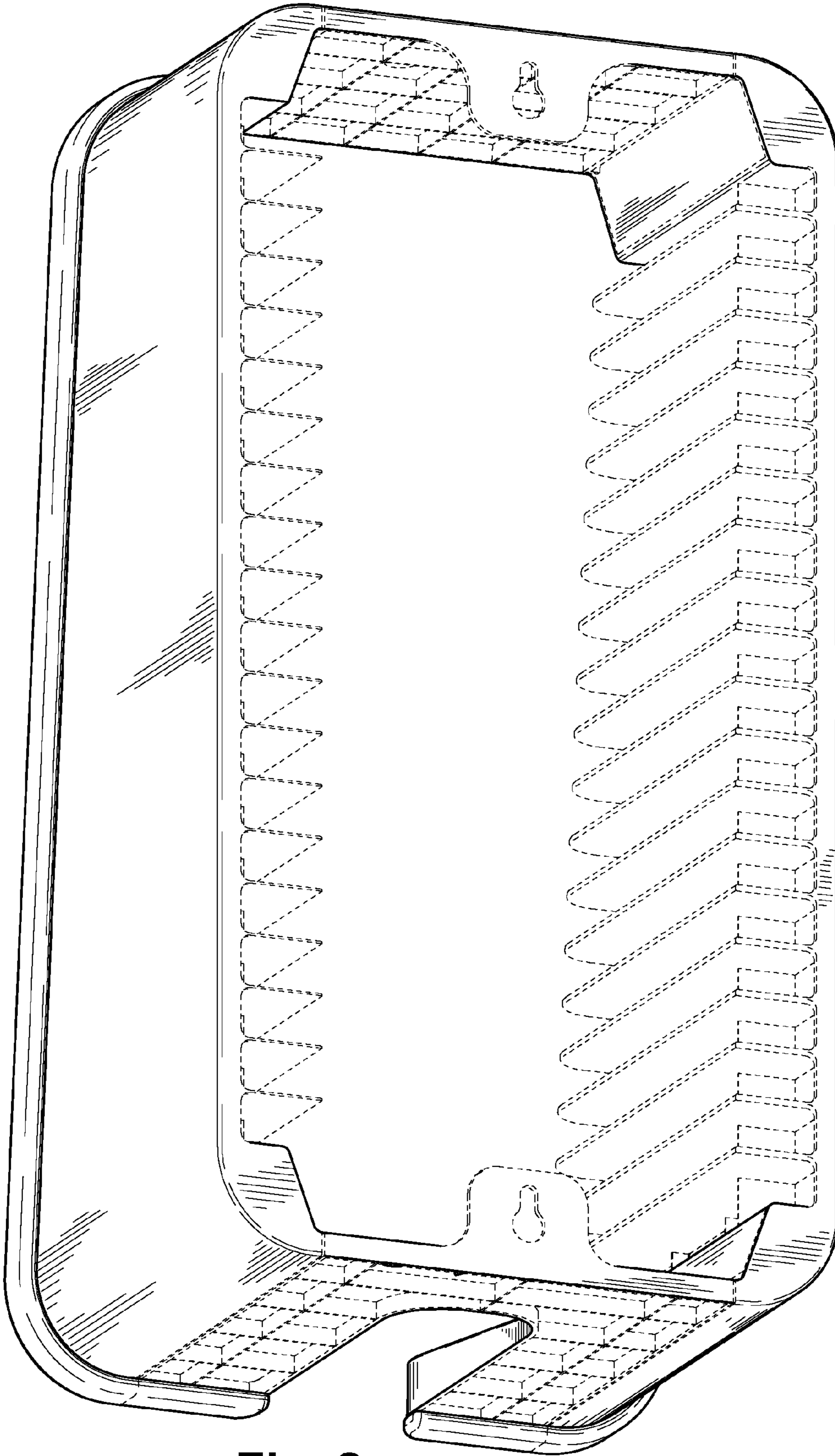

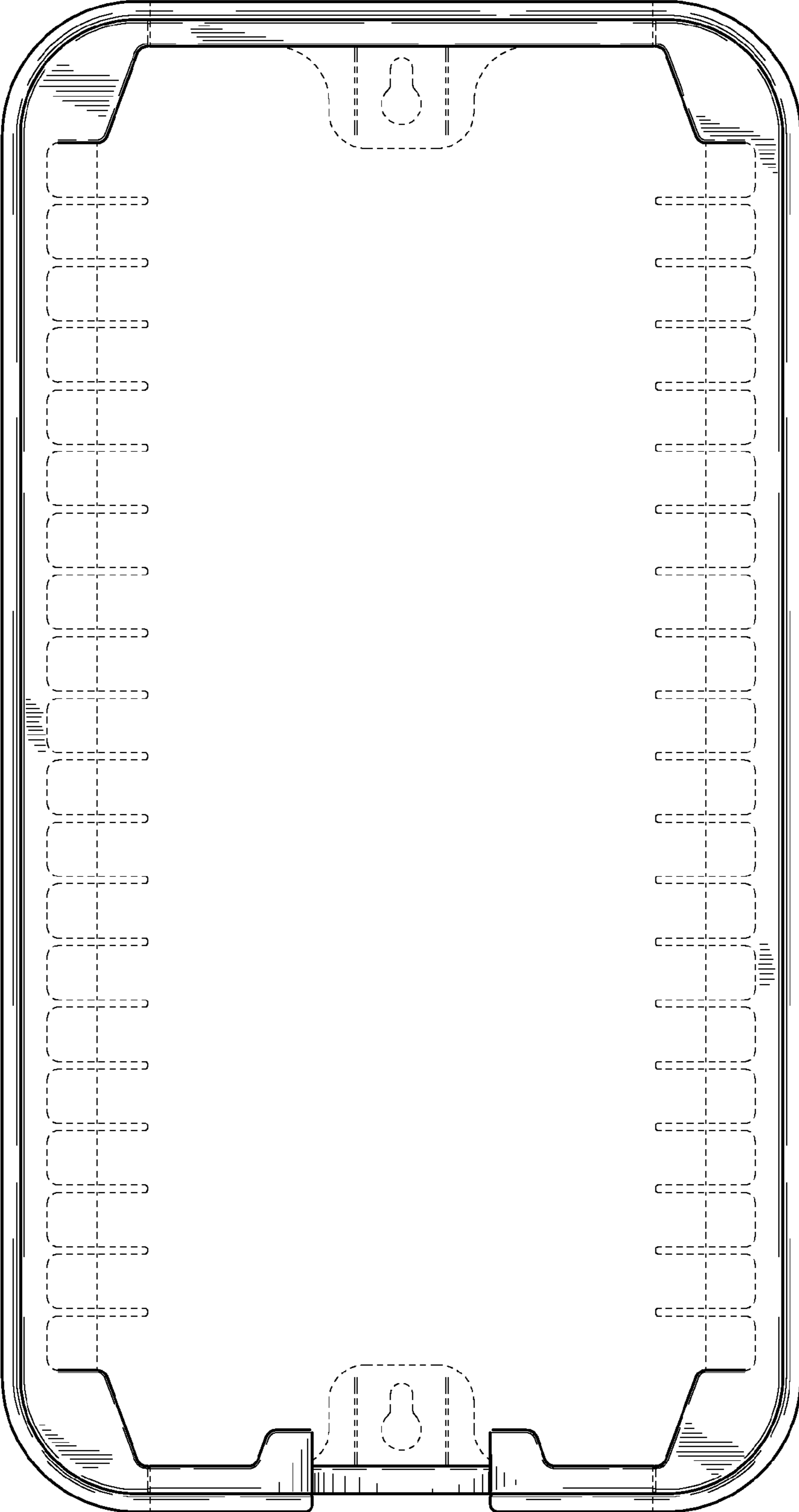

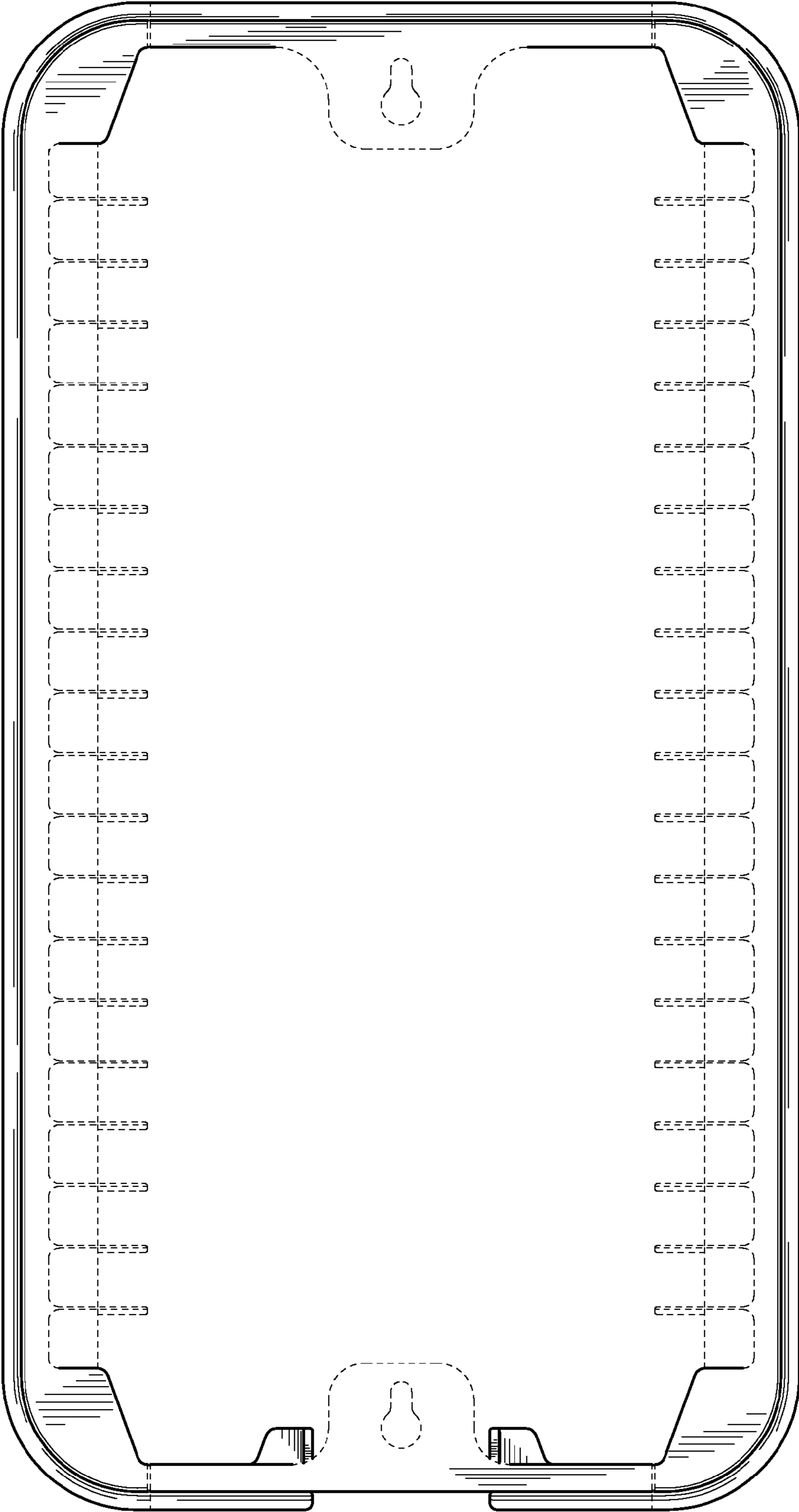

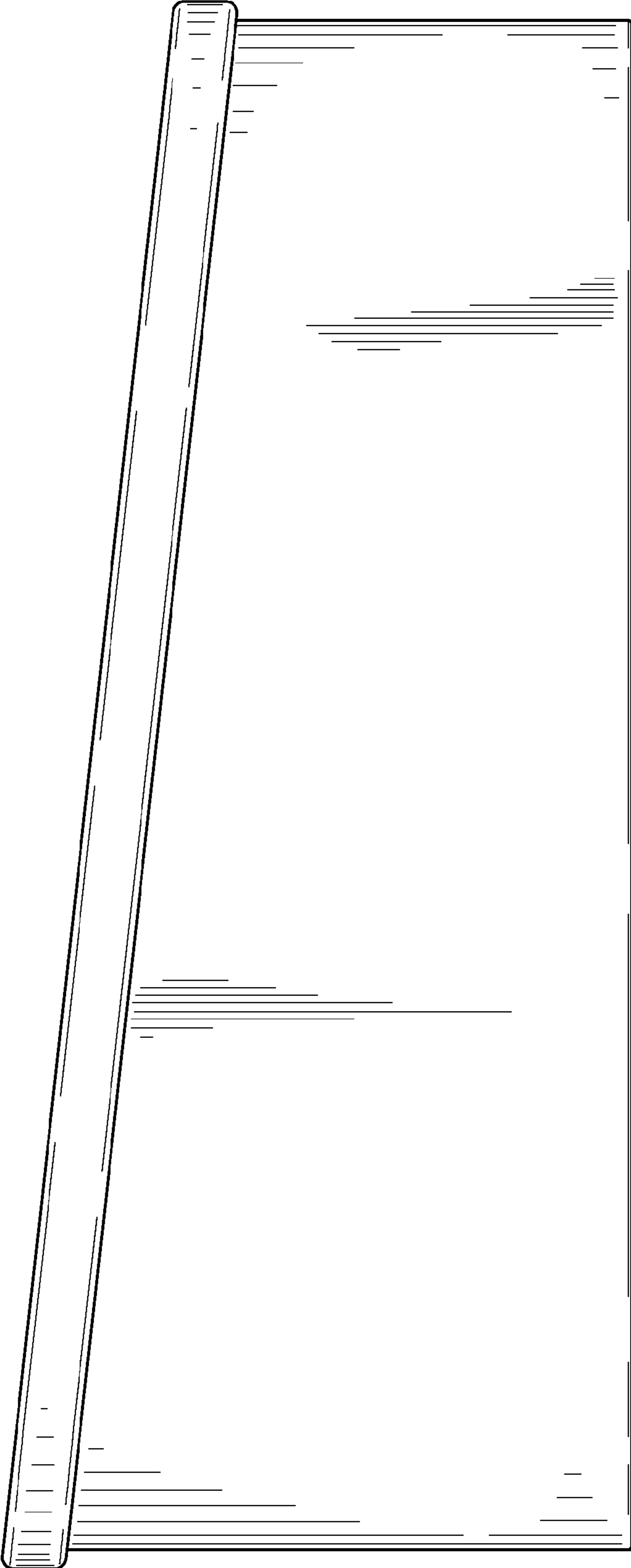

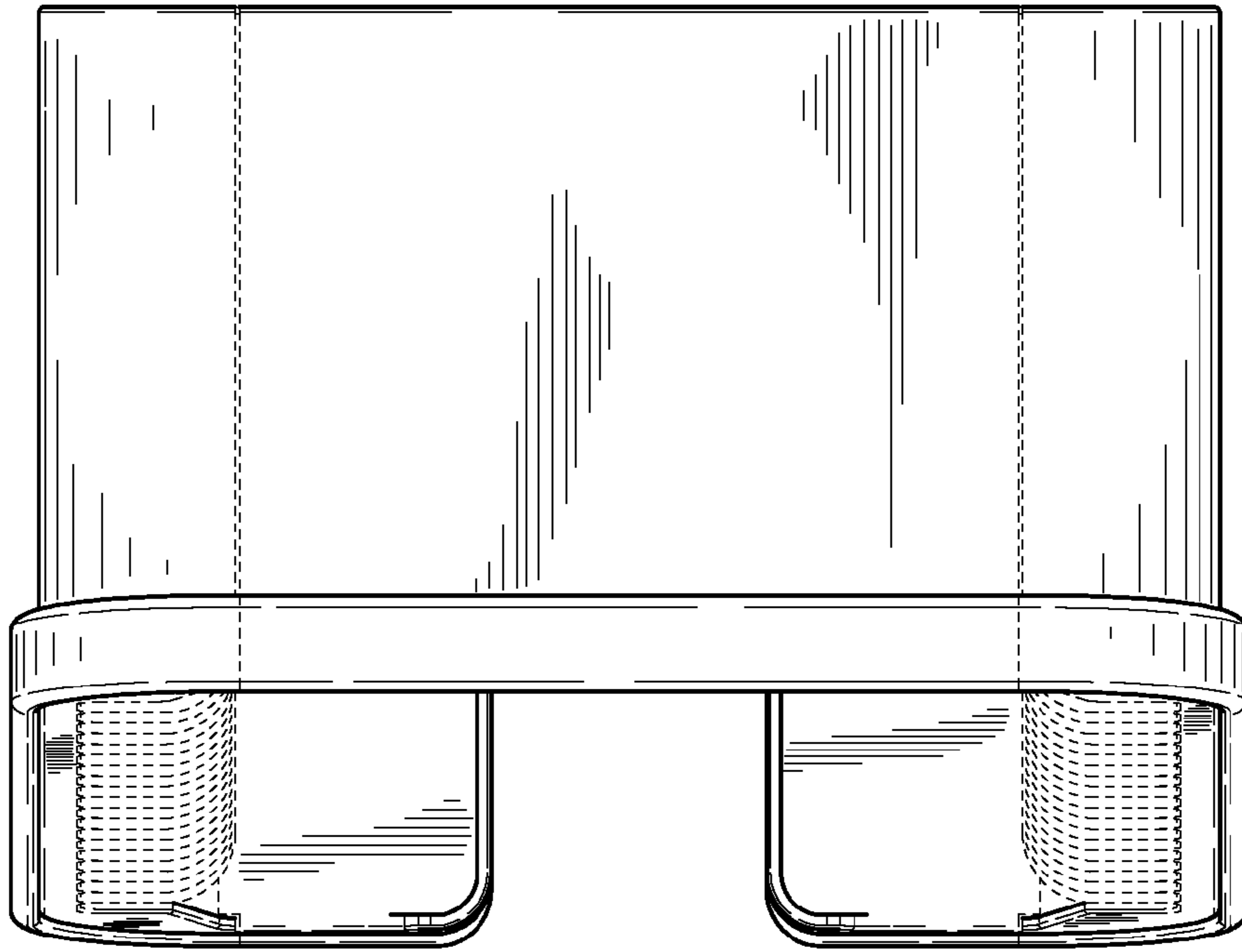

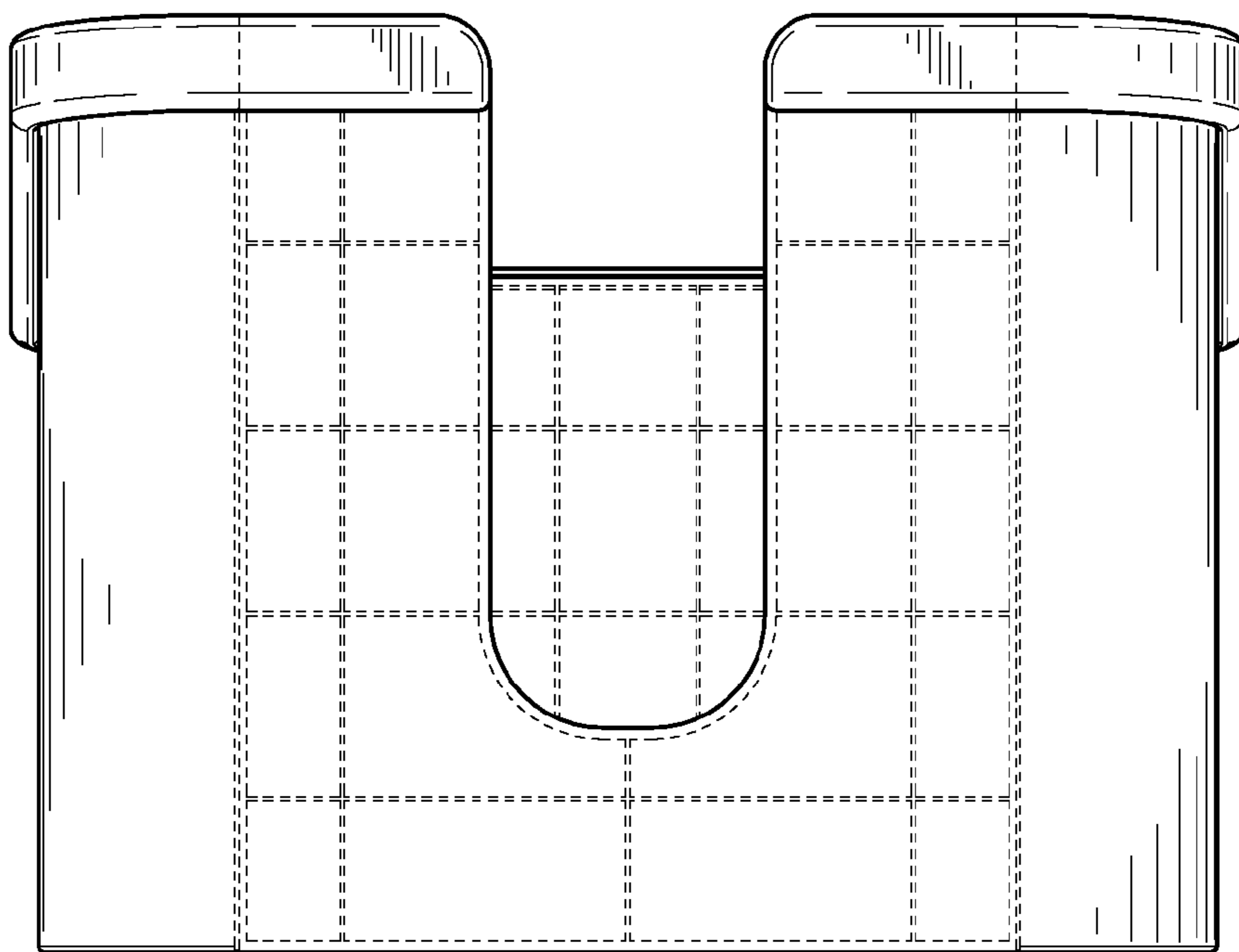
