I claim the ornamental design for a container, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, and left side perspective view showing the claimed design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a left side elevational view thereof, the right side elevational view being a mirror image;

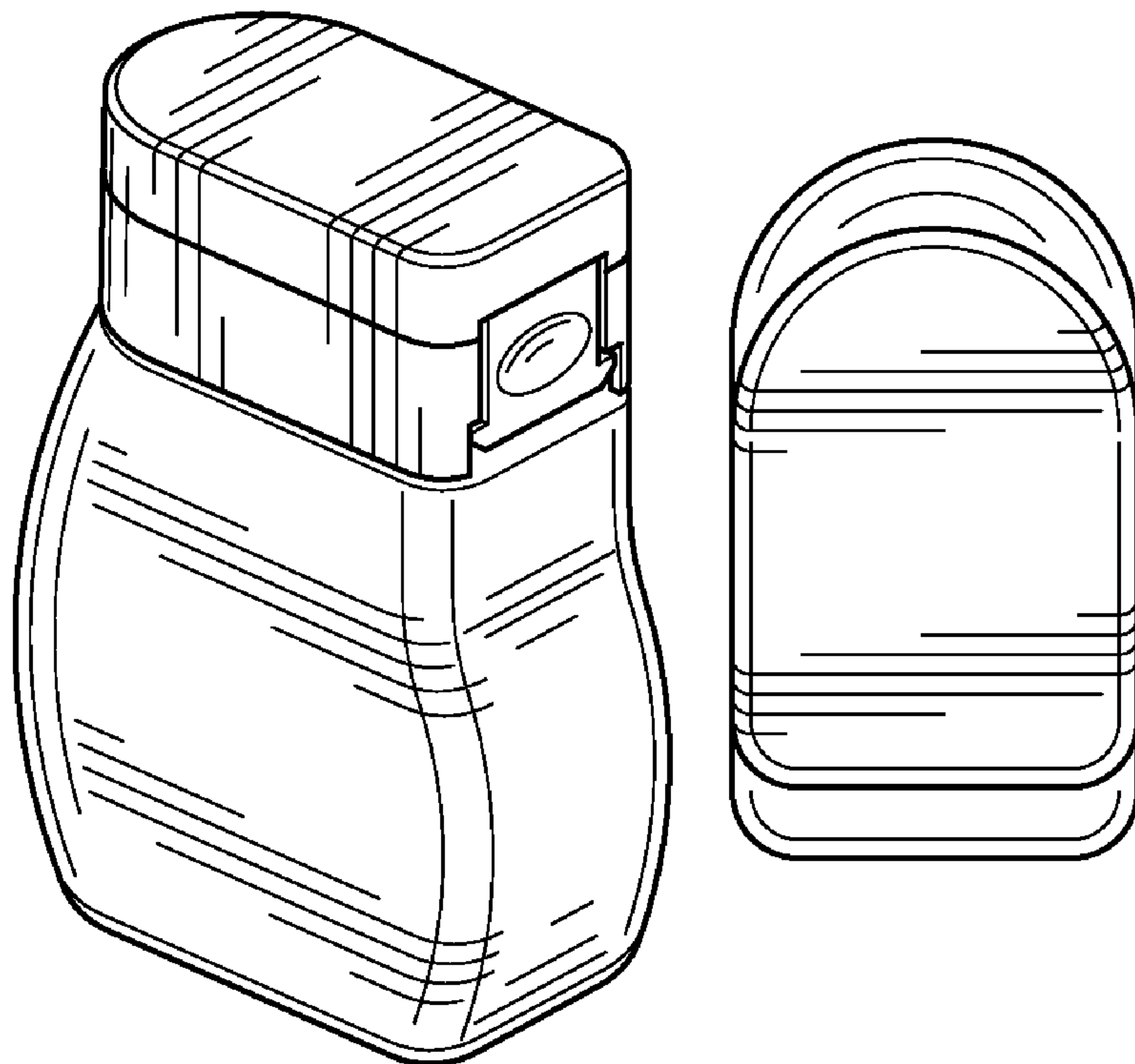
FIG. 4 is a rear elevational view thereof;

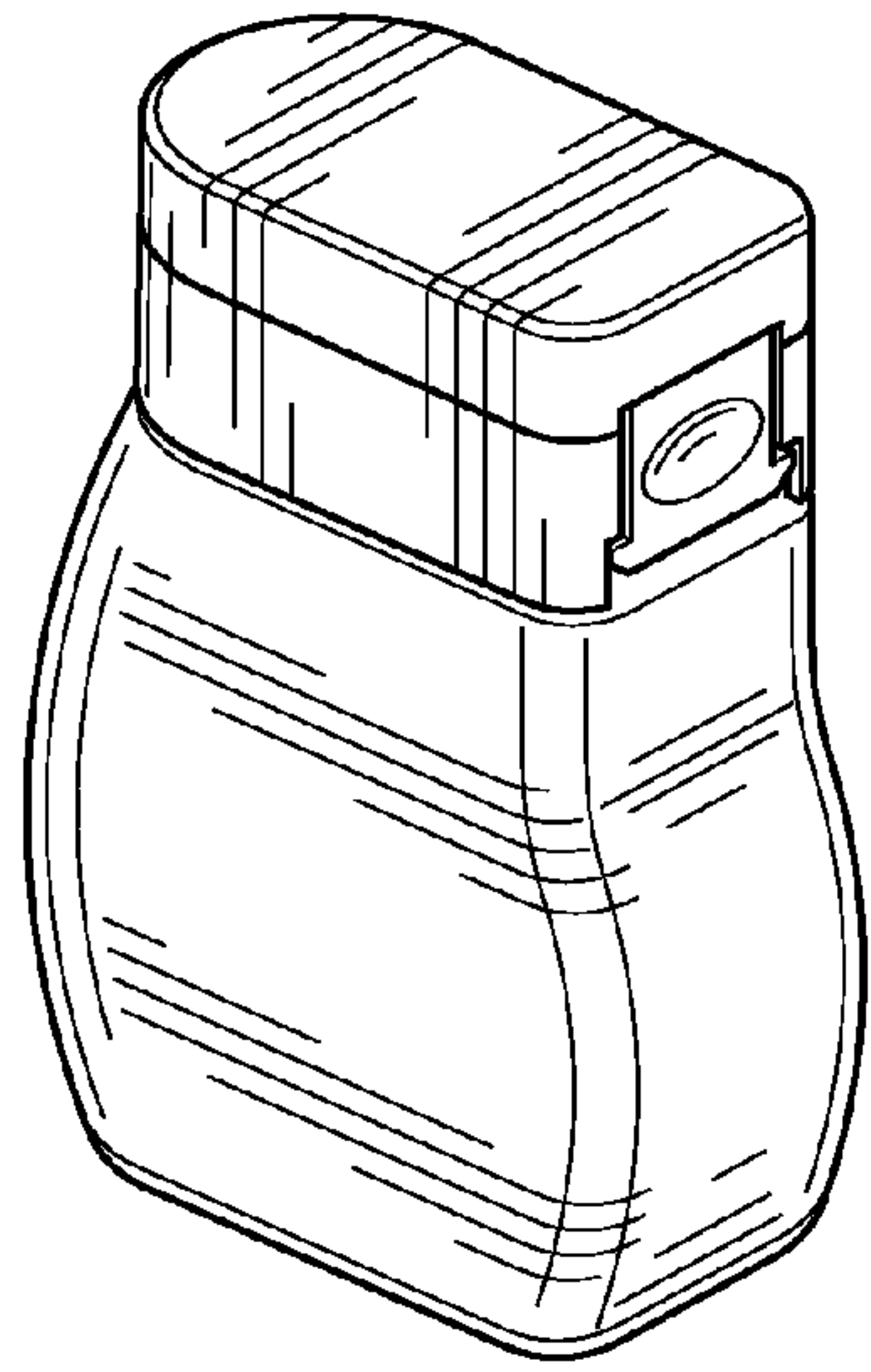

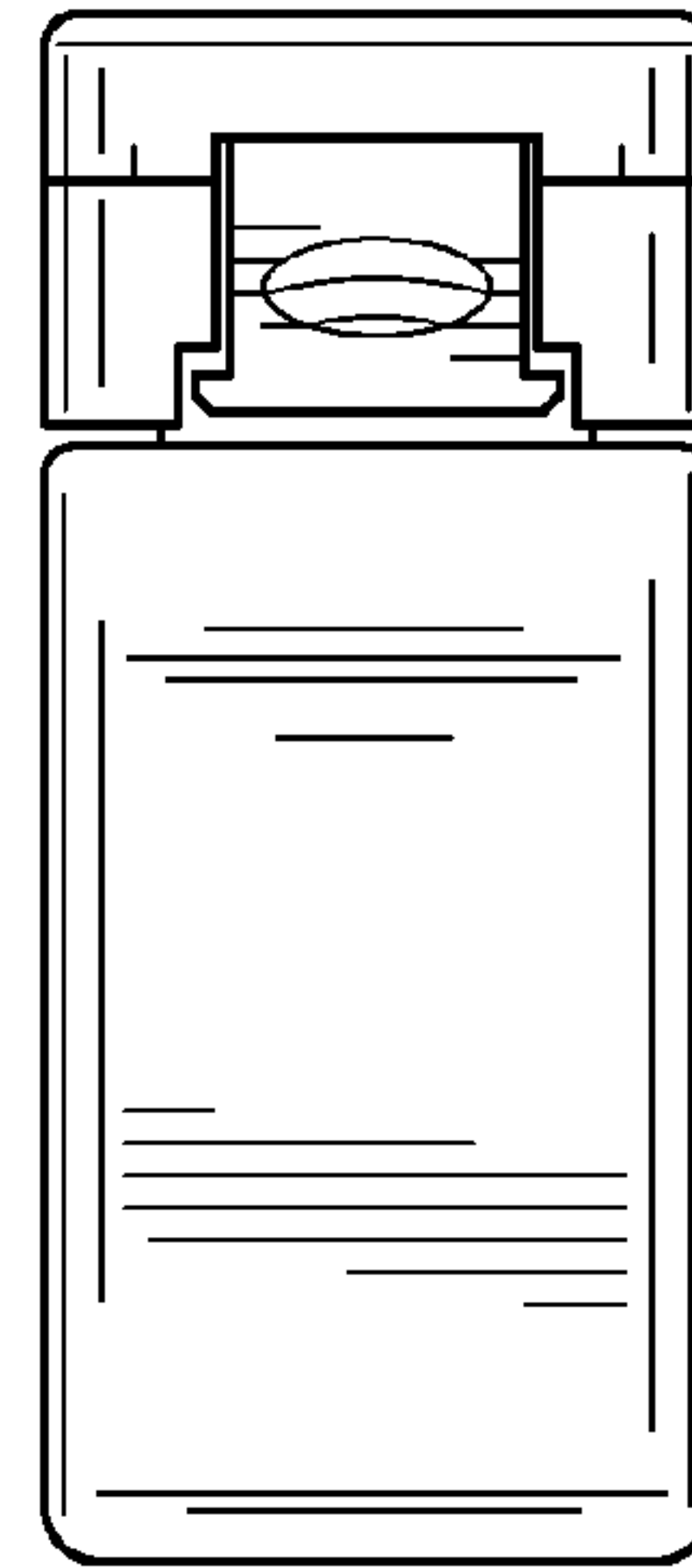

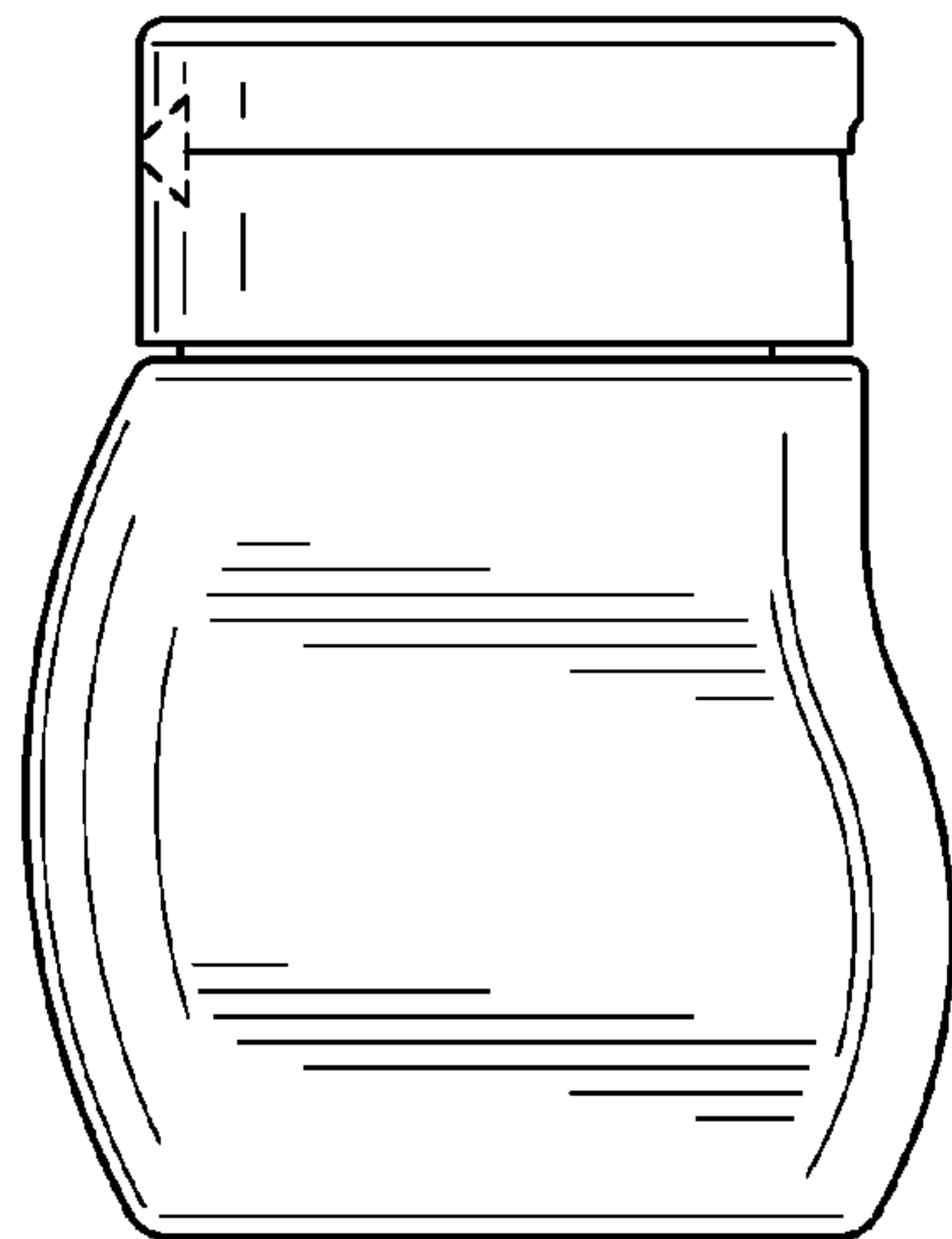

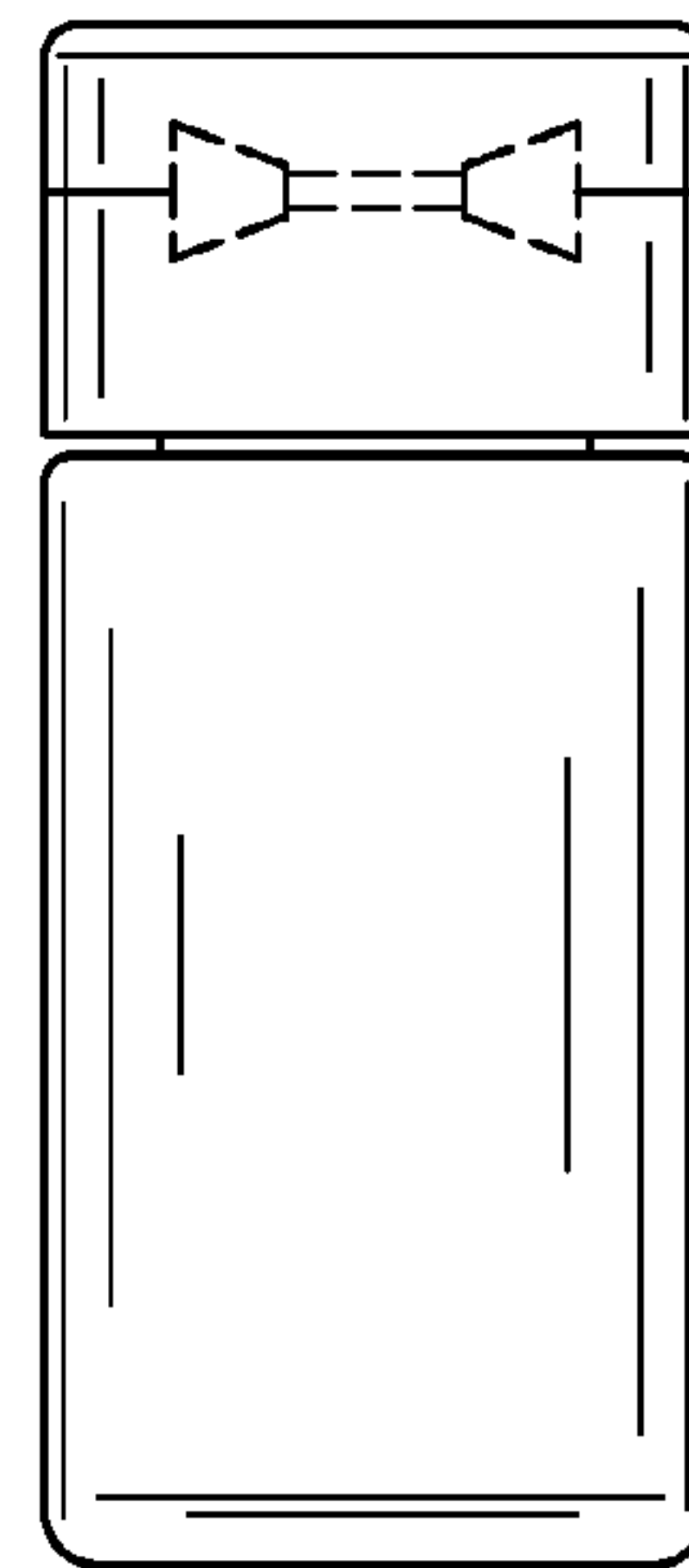

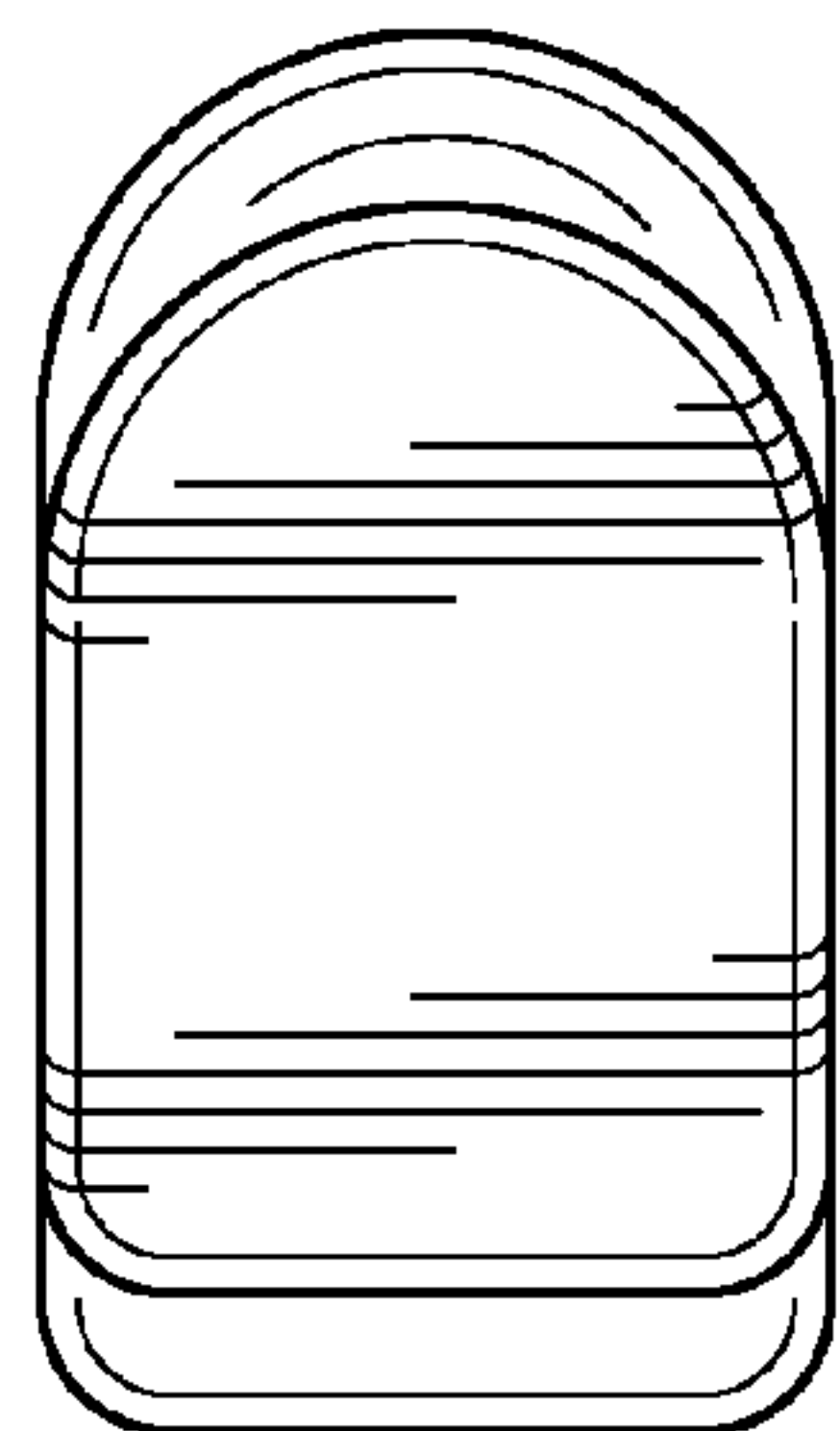

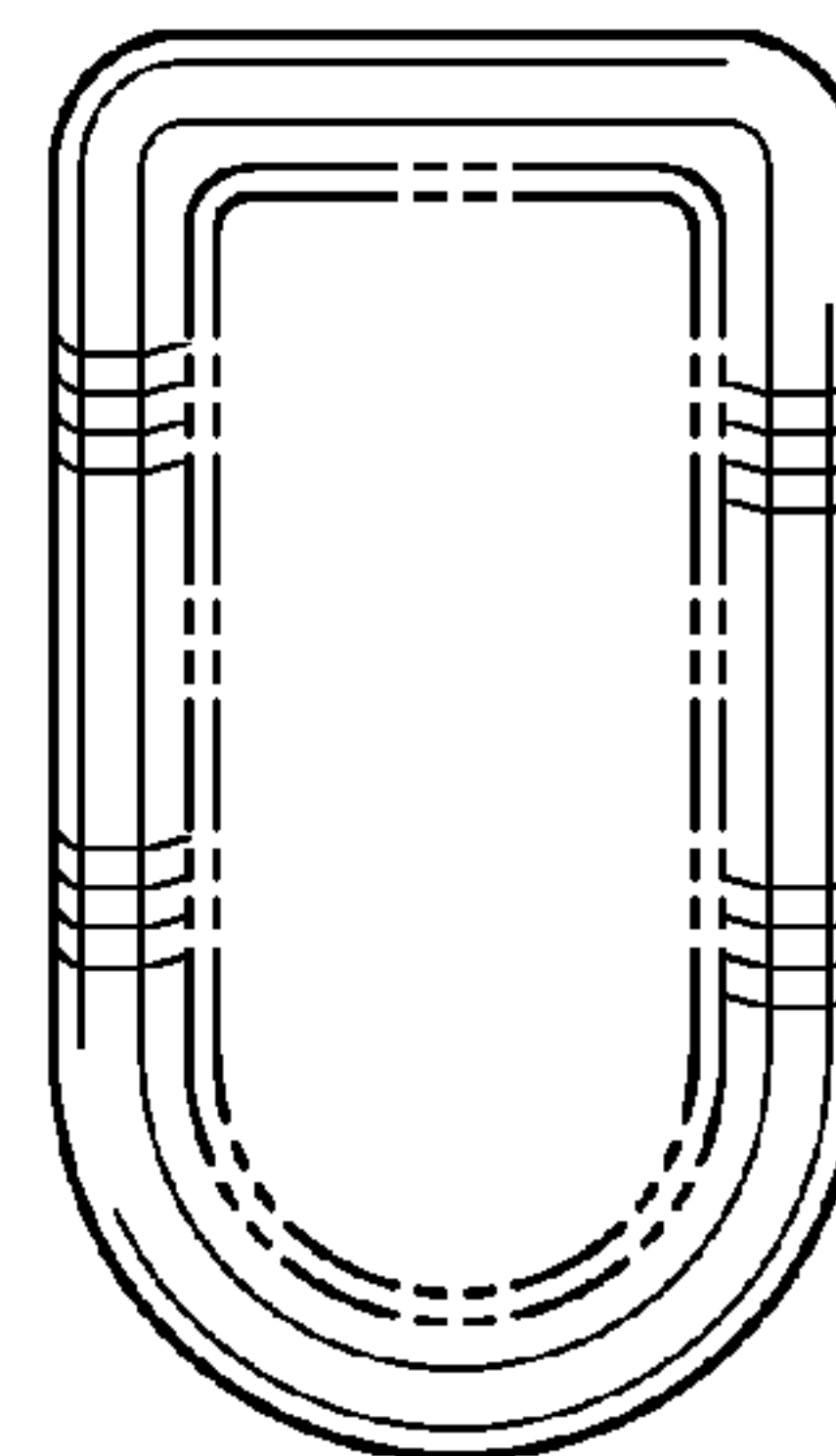
