FIG. 2 is a front view thereof;

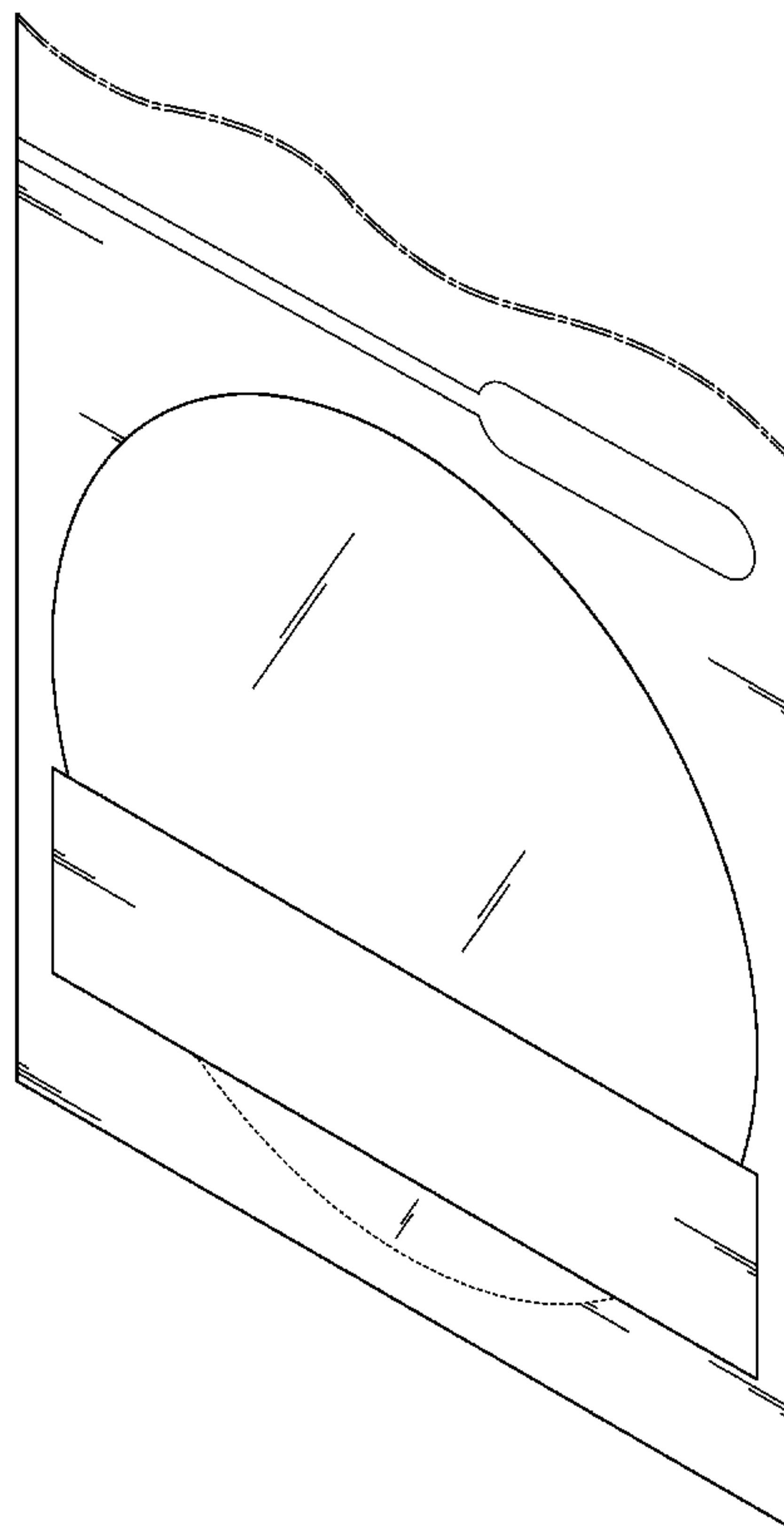
FIG. 3 is a top view, the bottom view being a mirror image

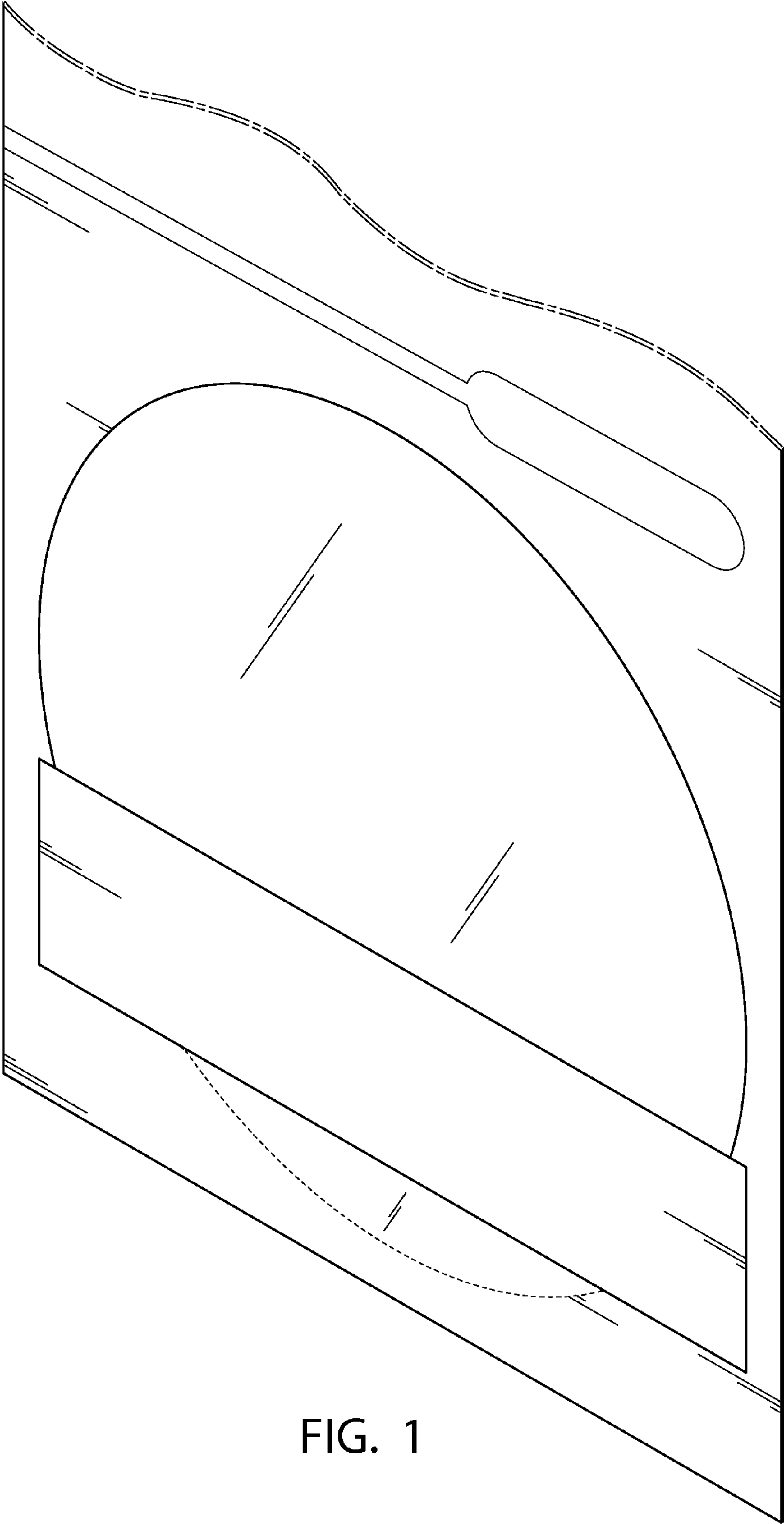

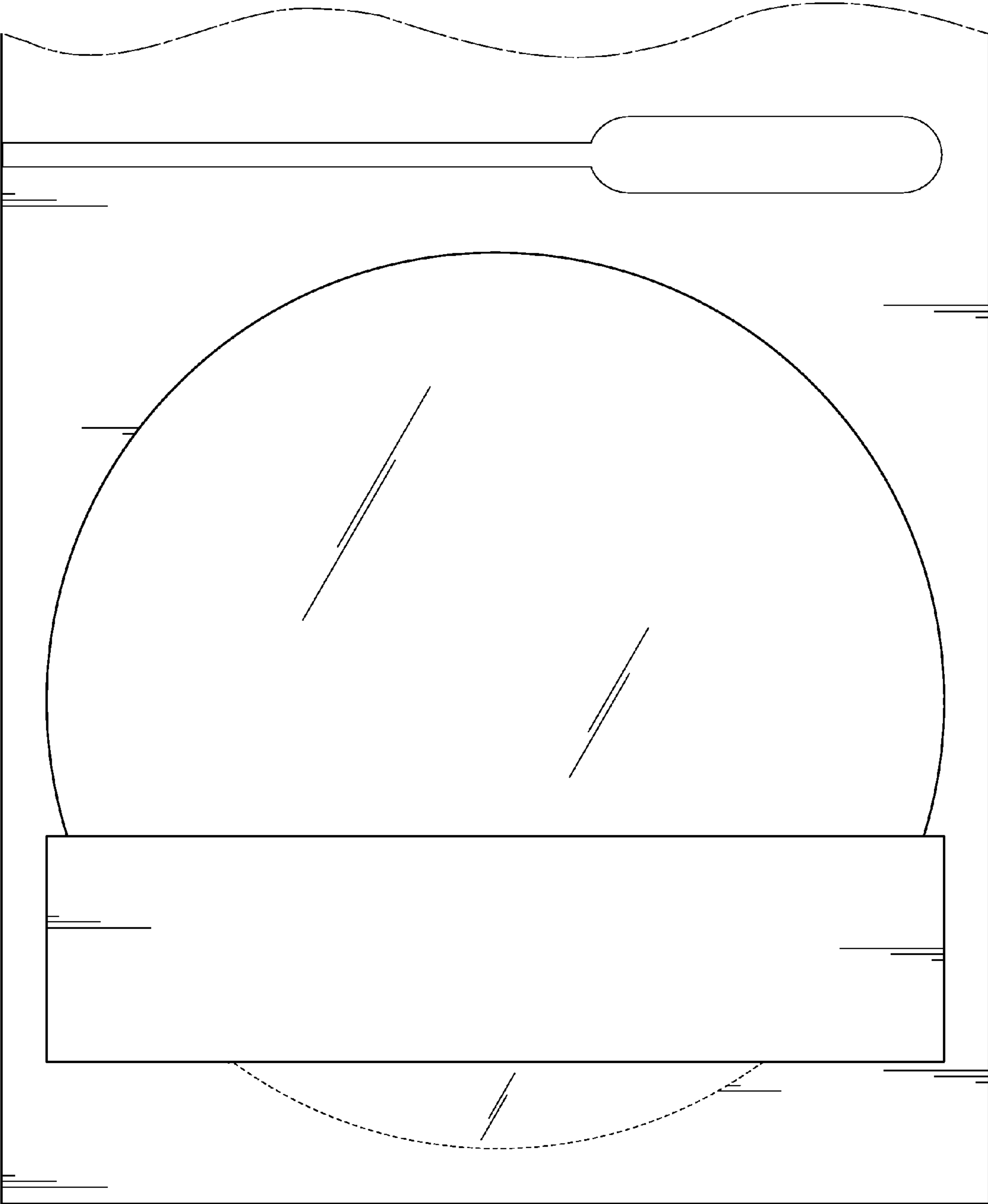

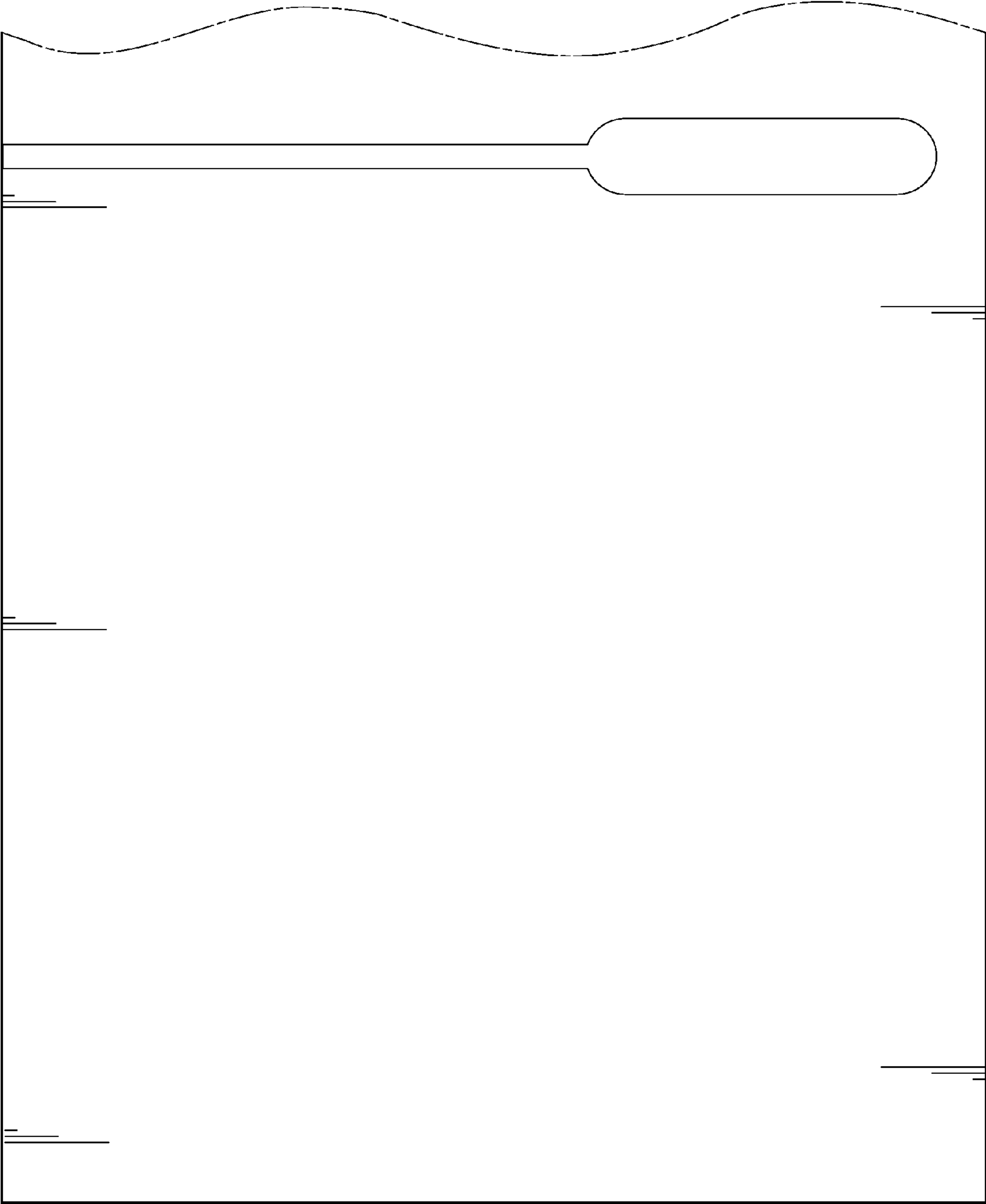
