(57) **CLAIM**

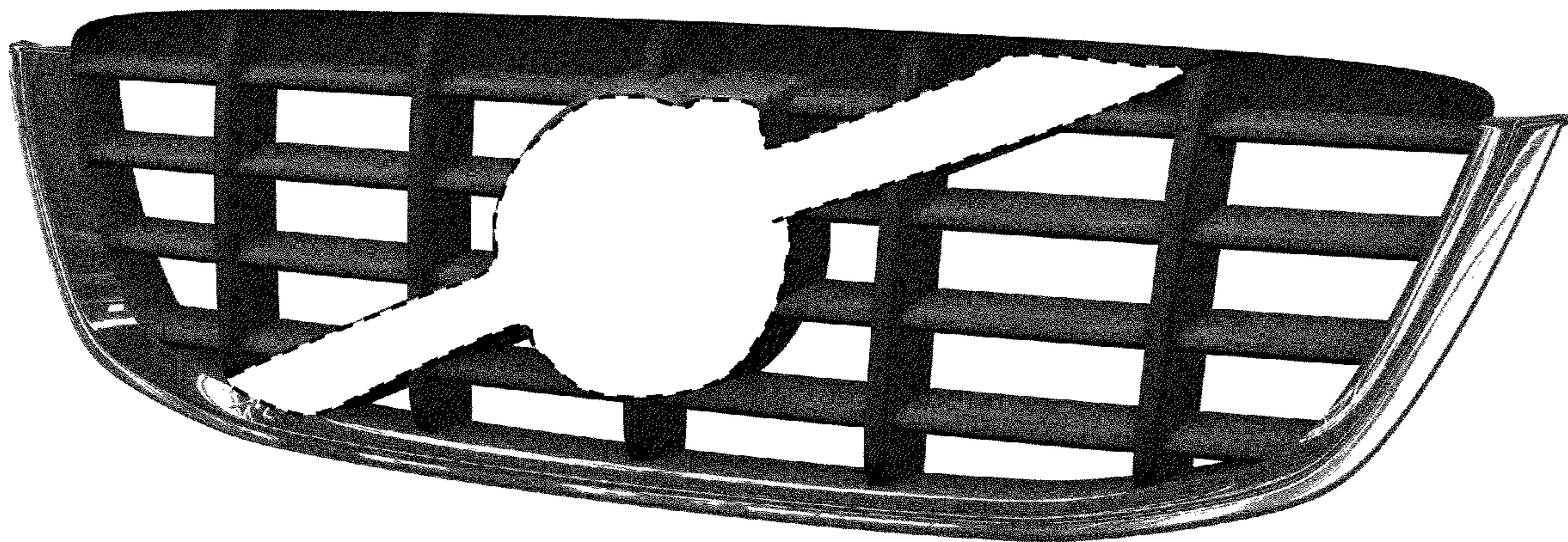
The ornamental design for a vehicle grille, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a vehicle grille;  
FIG. 2 is a bottom plan view of the vehicle grille;  
FIG. 3 is front elevational view of the vehicle grille;  
FIG. 4 is a left side elevational view of the vehicle grille; and,  
FIG. 5 is a perspective view of the vehicle grille.

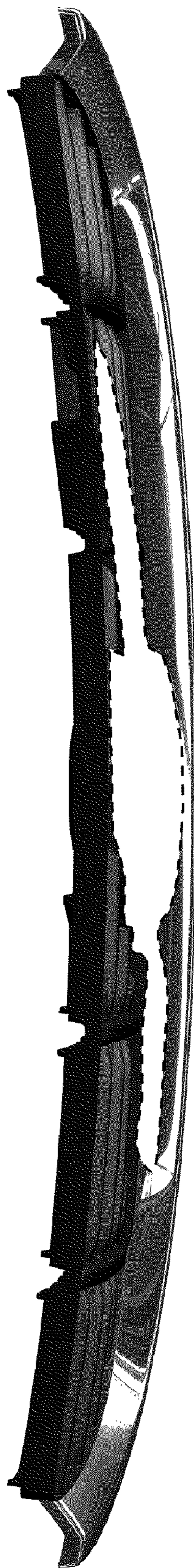

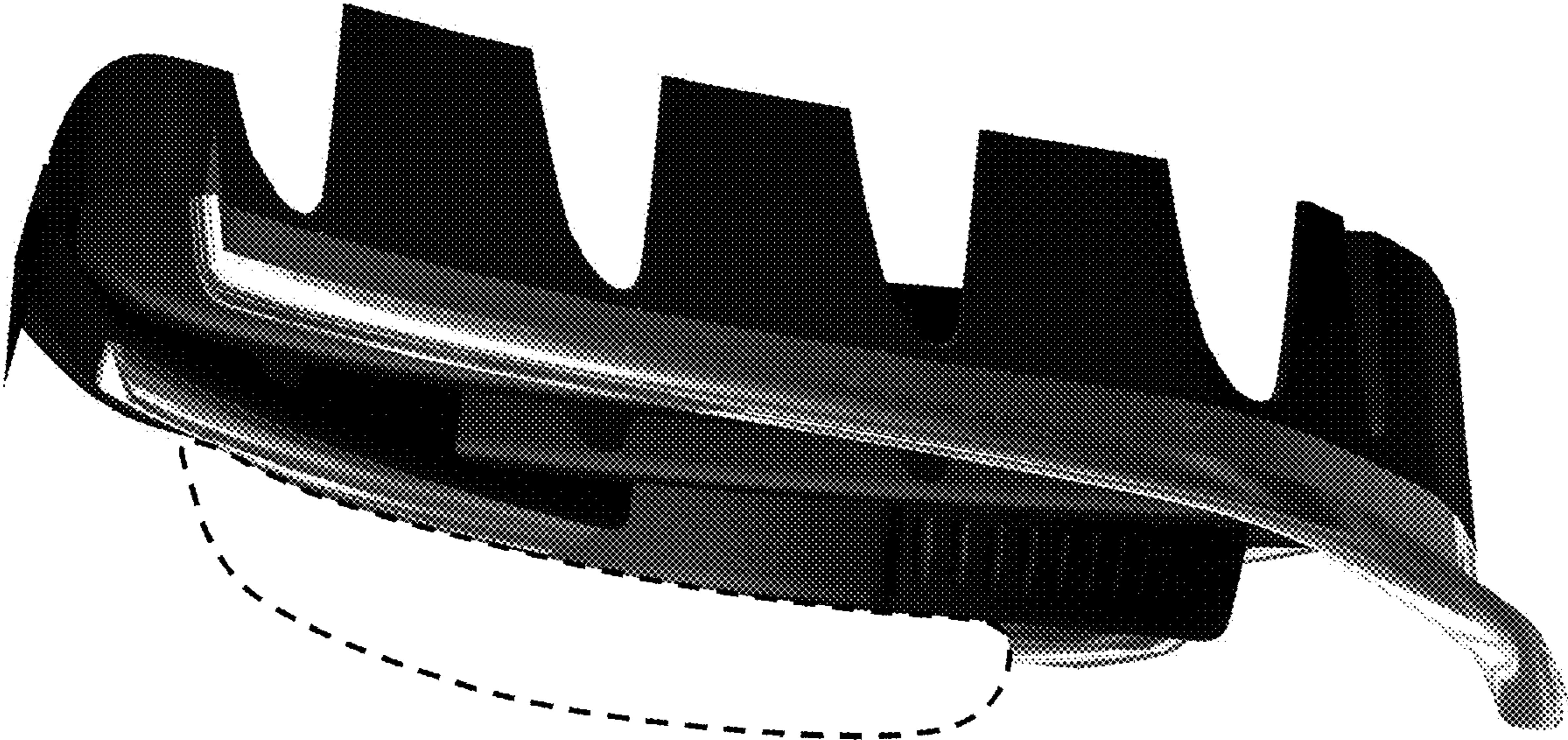
