The ornamental design for an optical disc player/recorder, as shown and described.

FIG. 9 is a left side elevation view thereof;

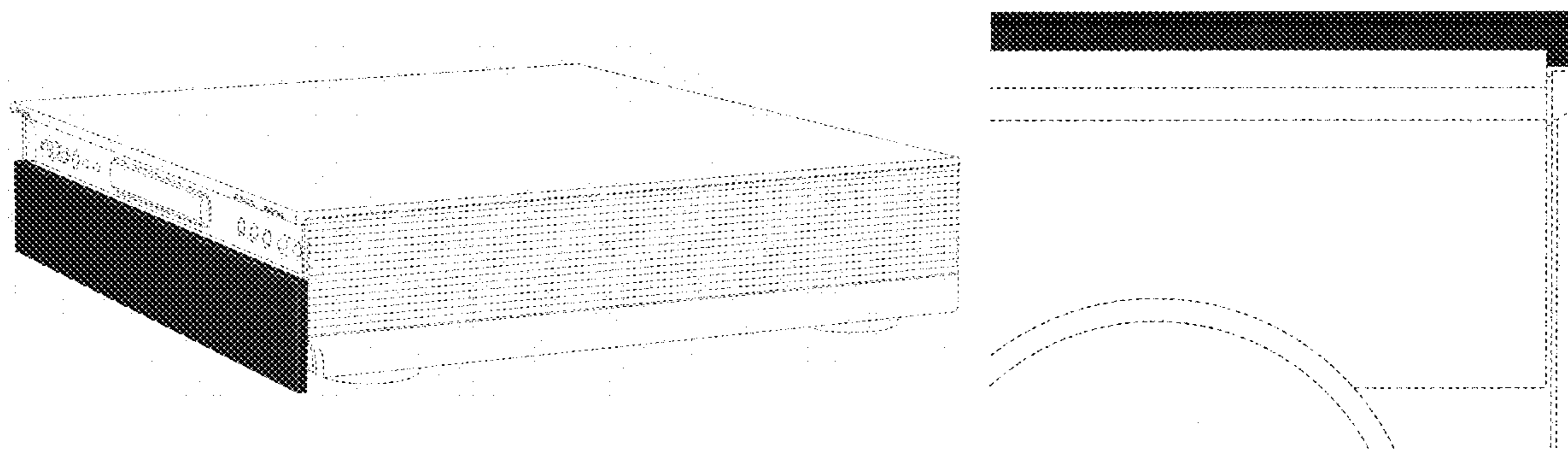


FIG. **10** is a top plan view thereof;

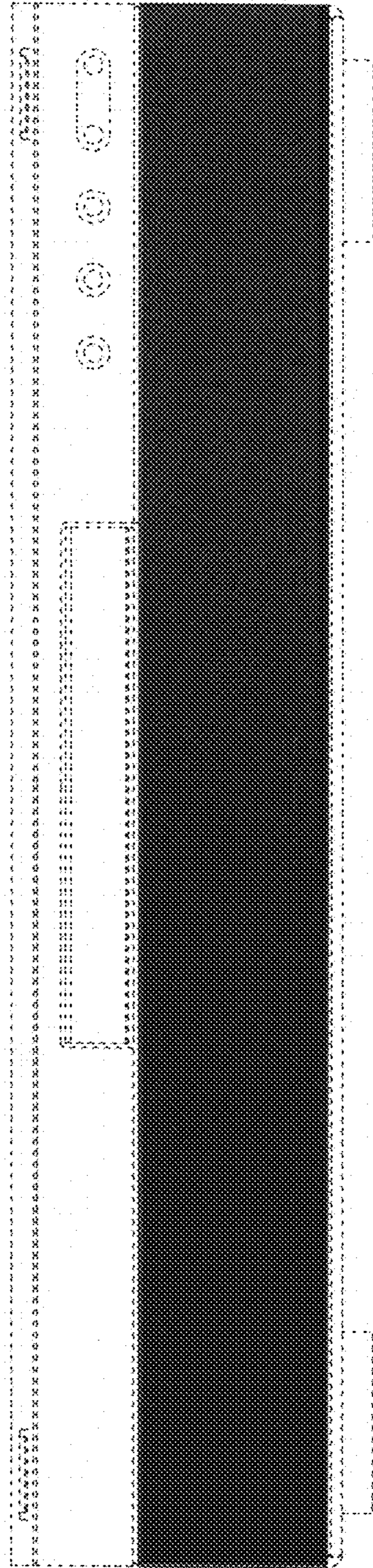

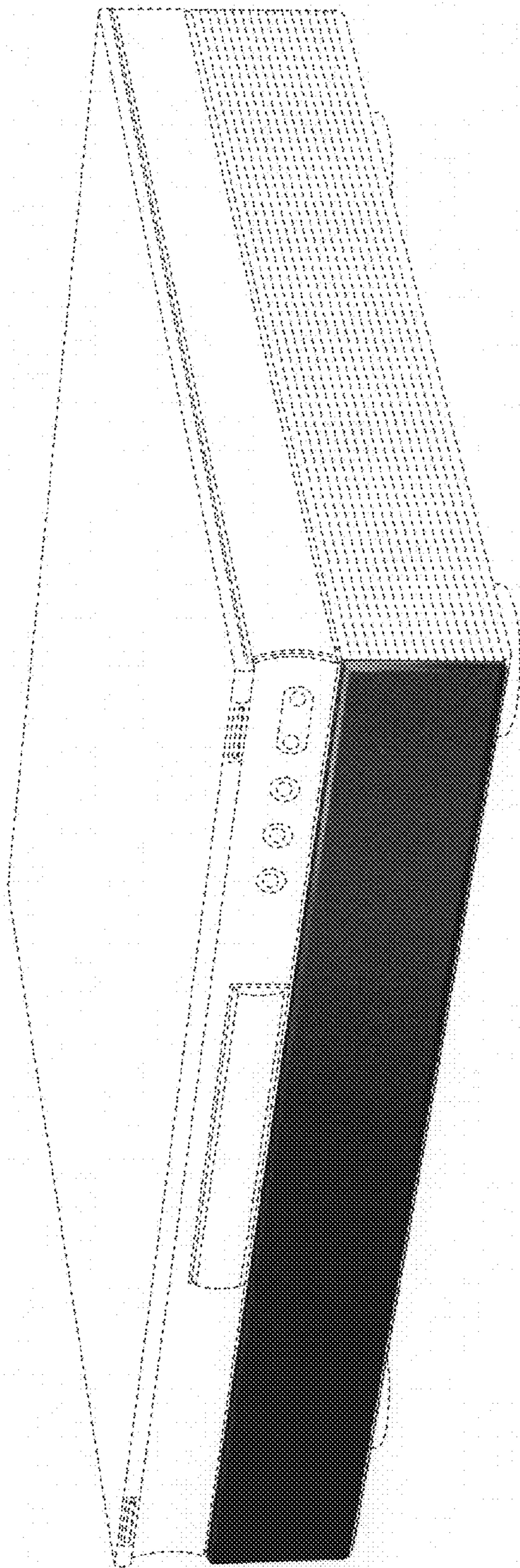

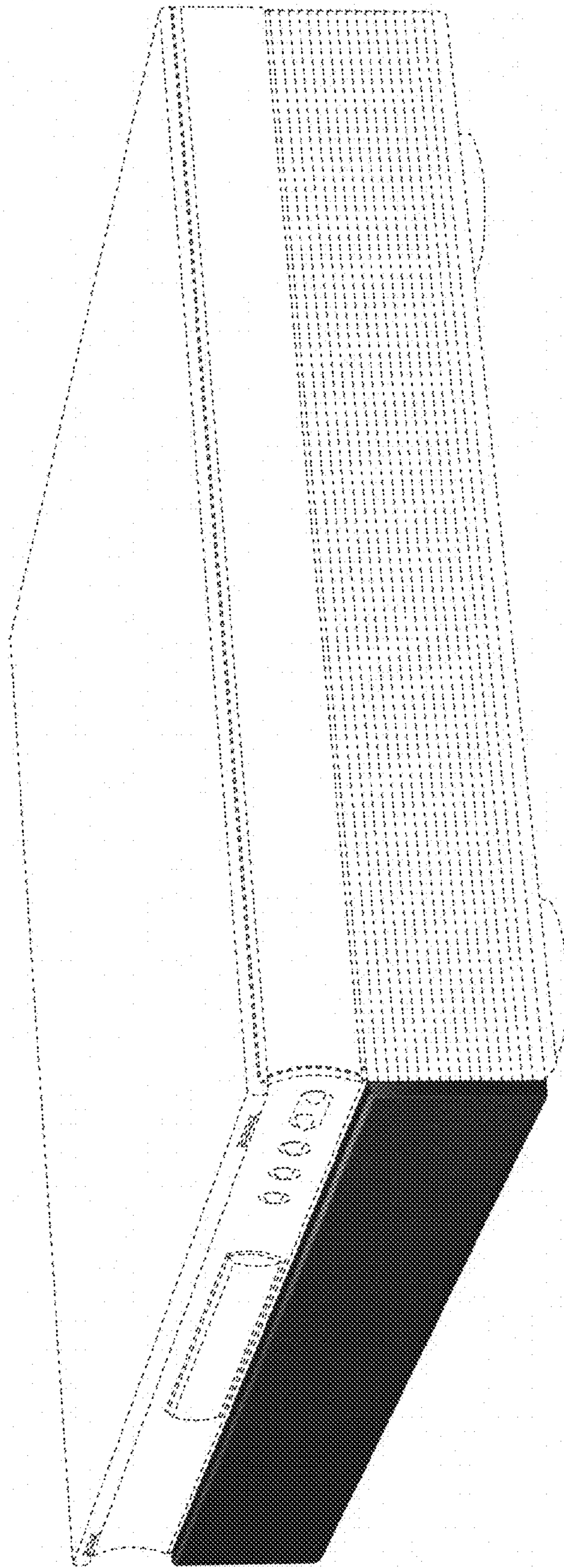

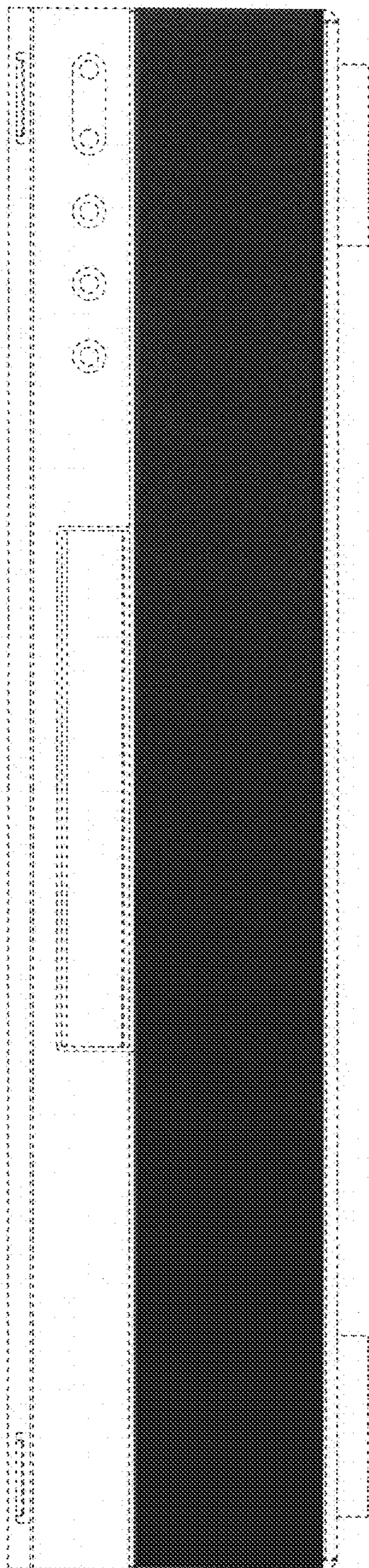

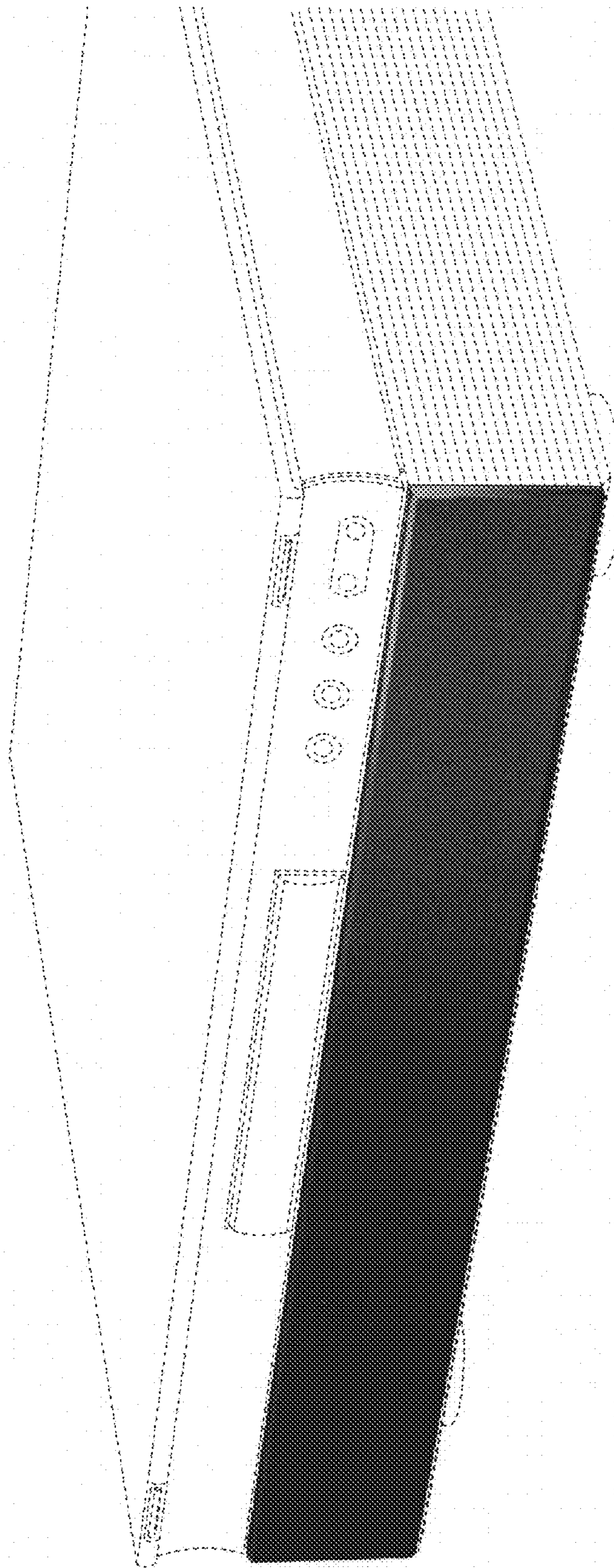
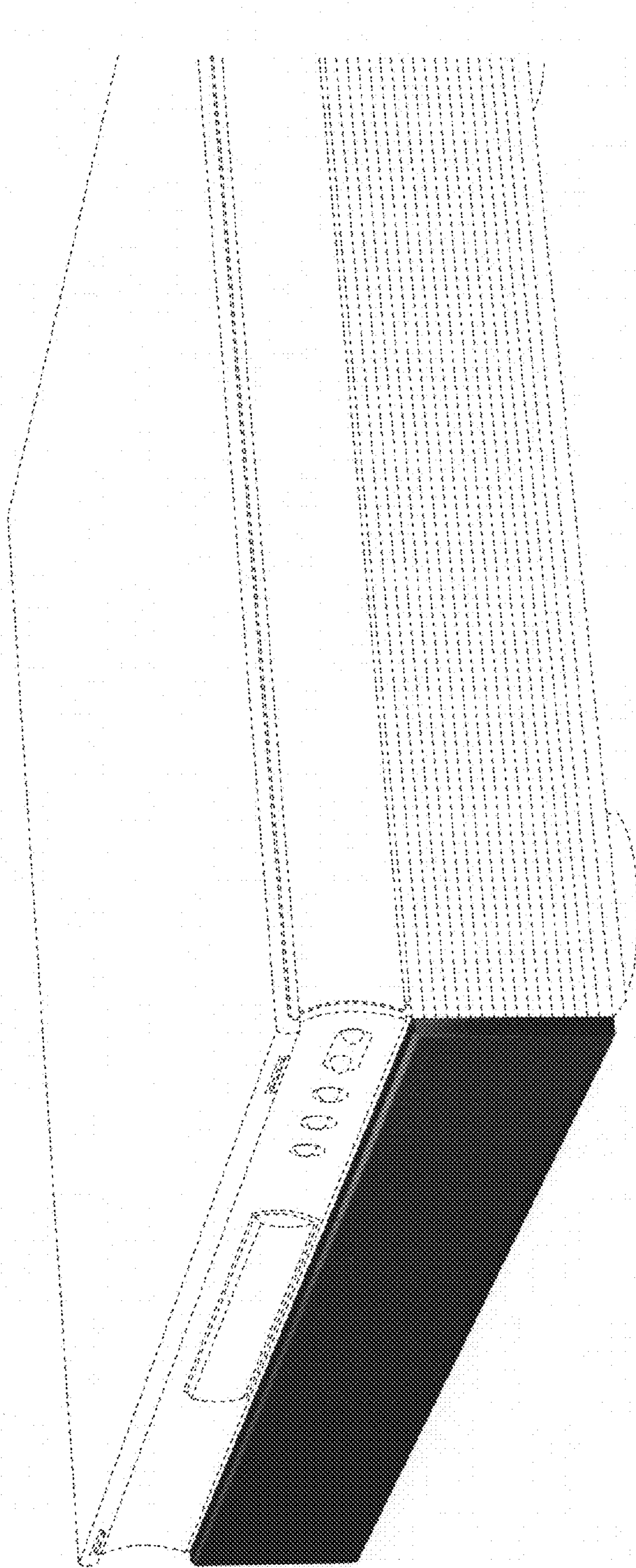

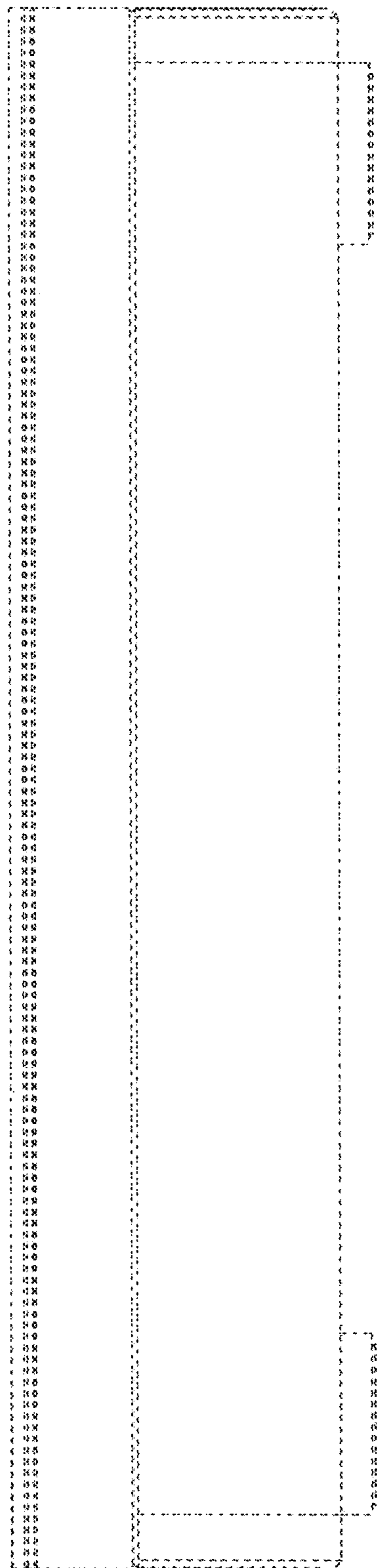

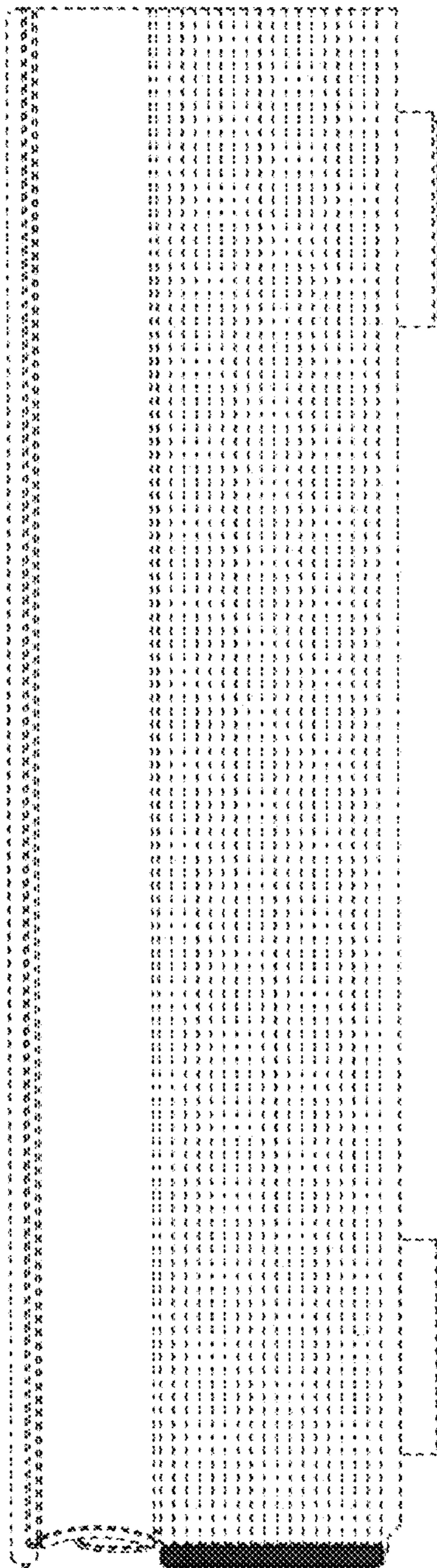

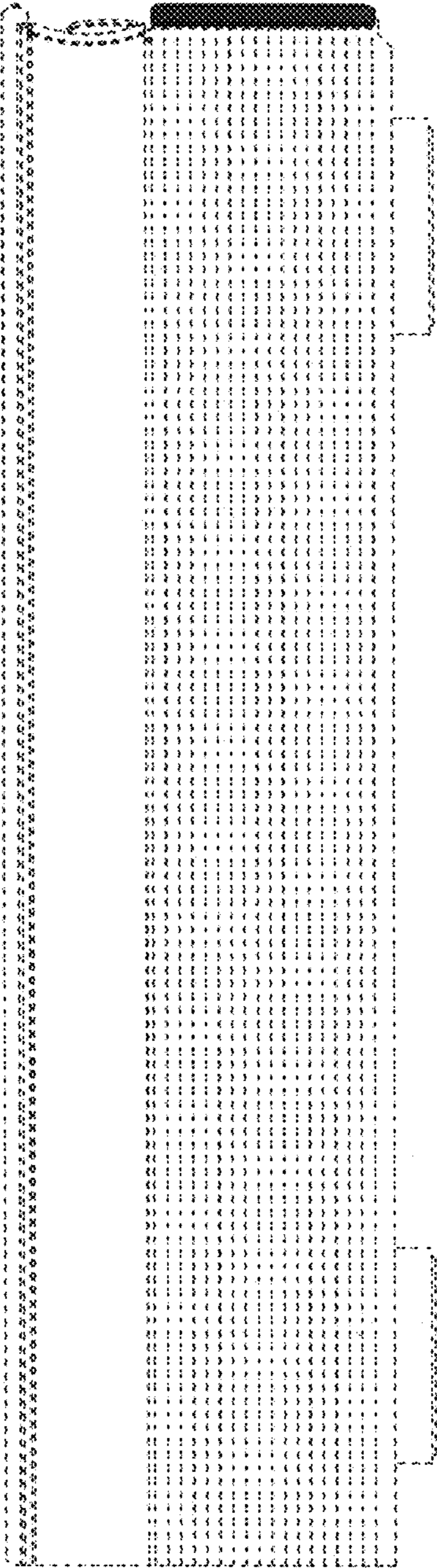

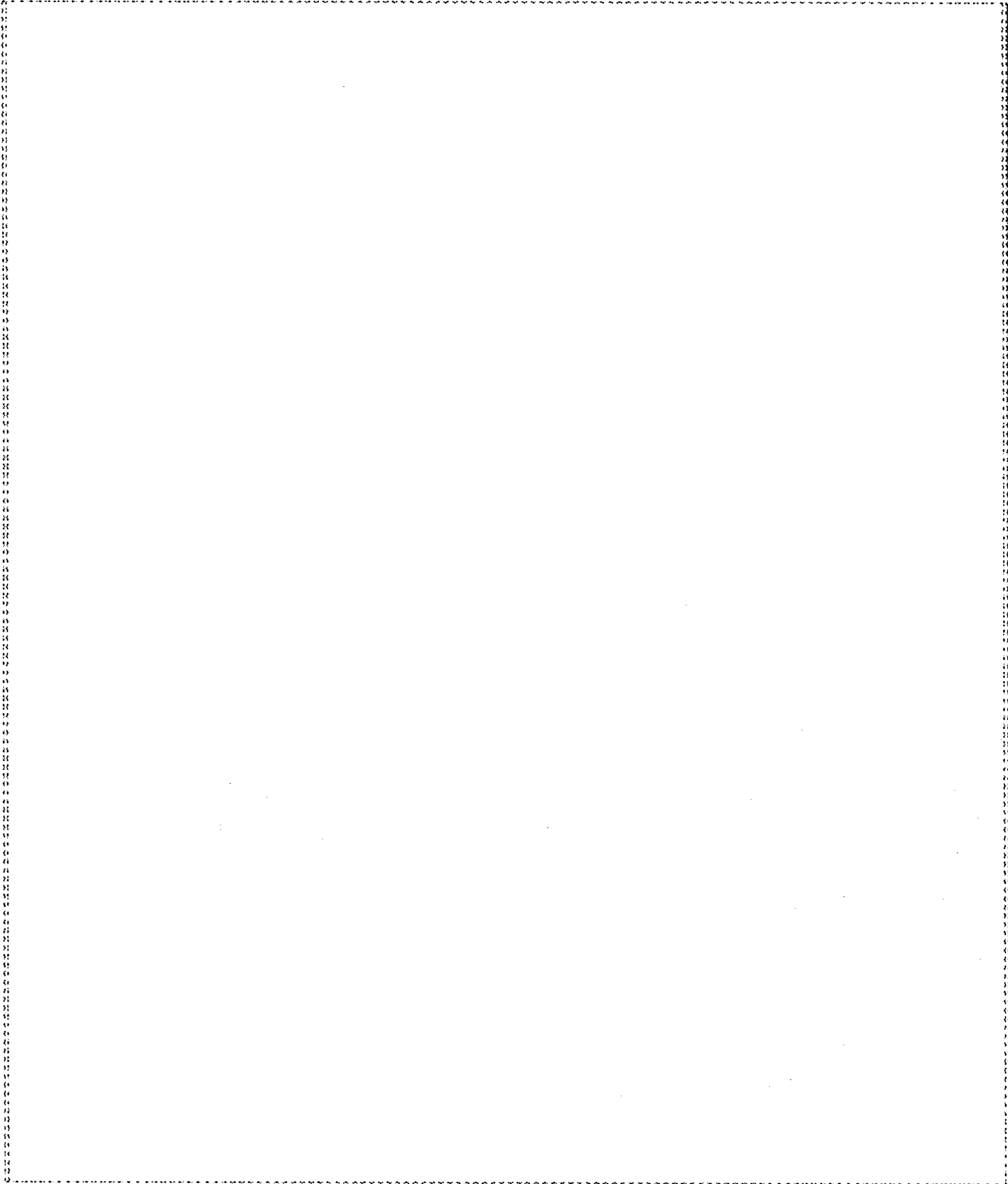

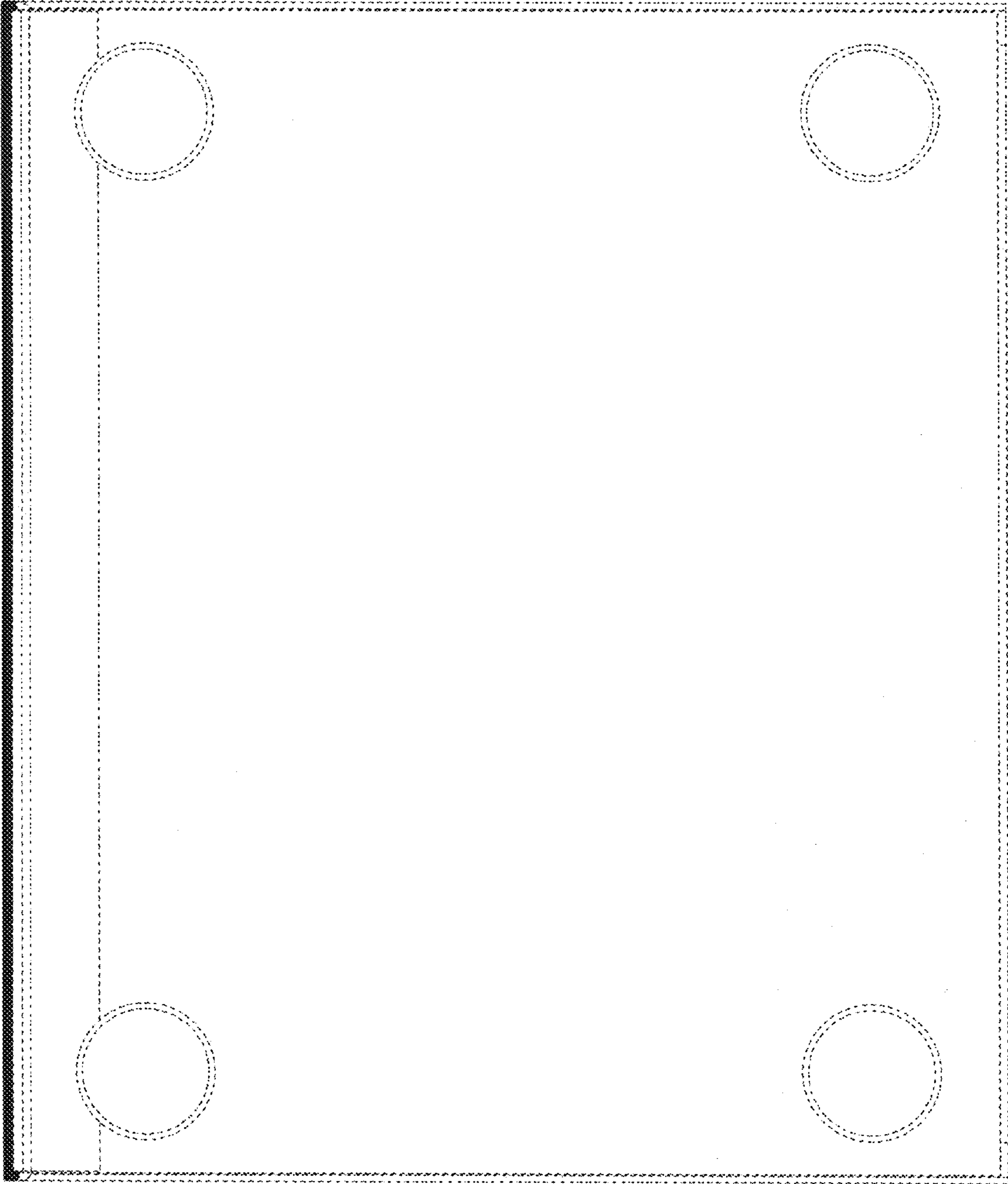

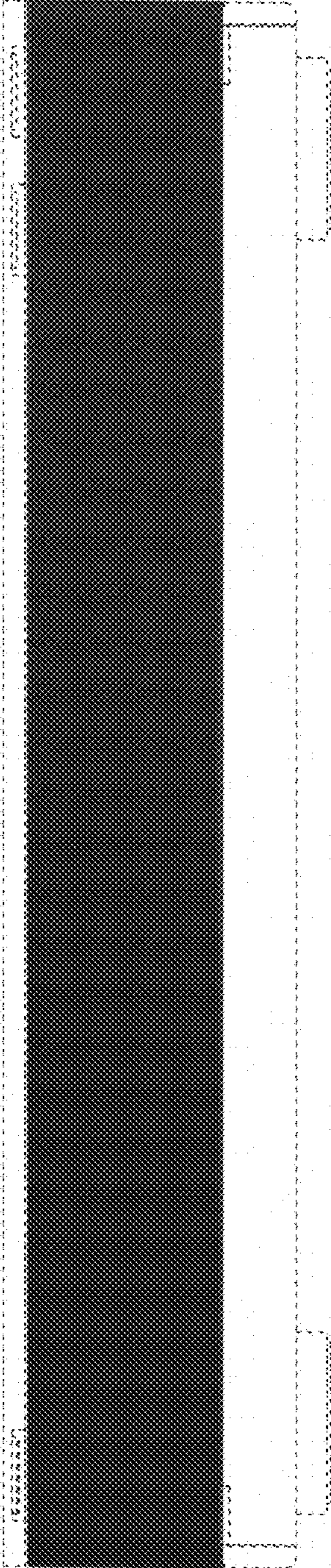

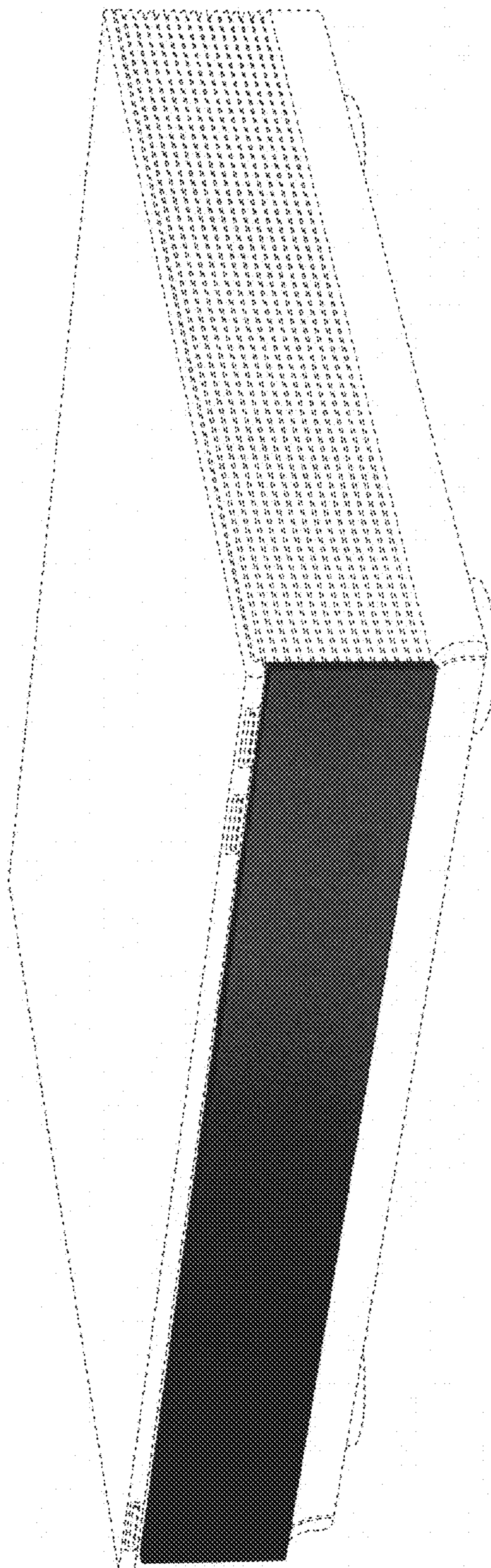

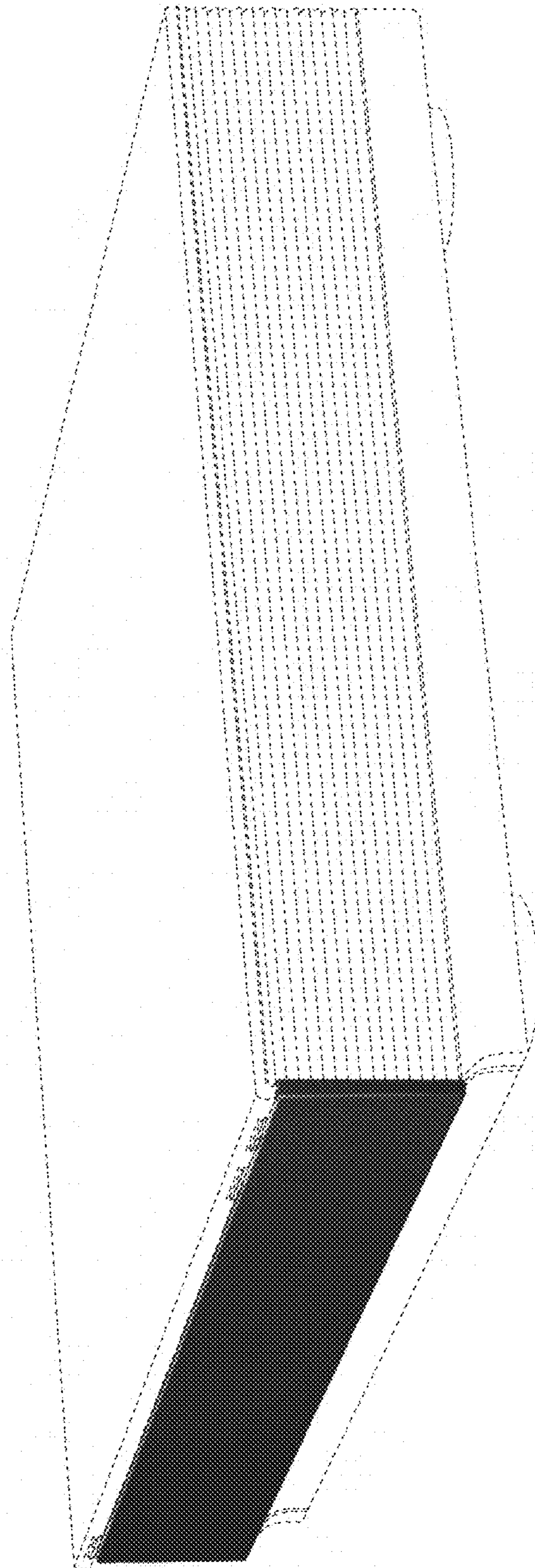

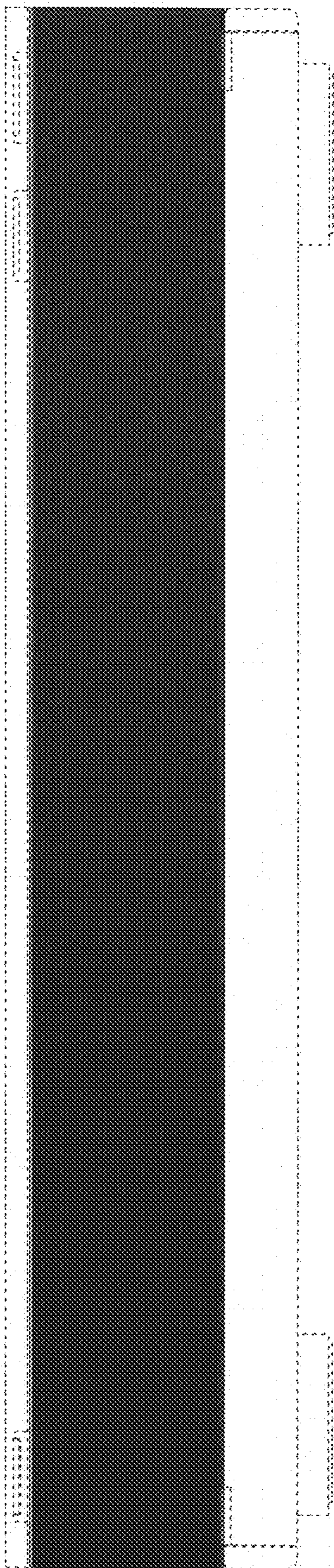

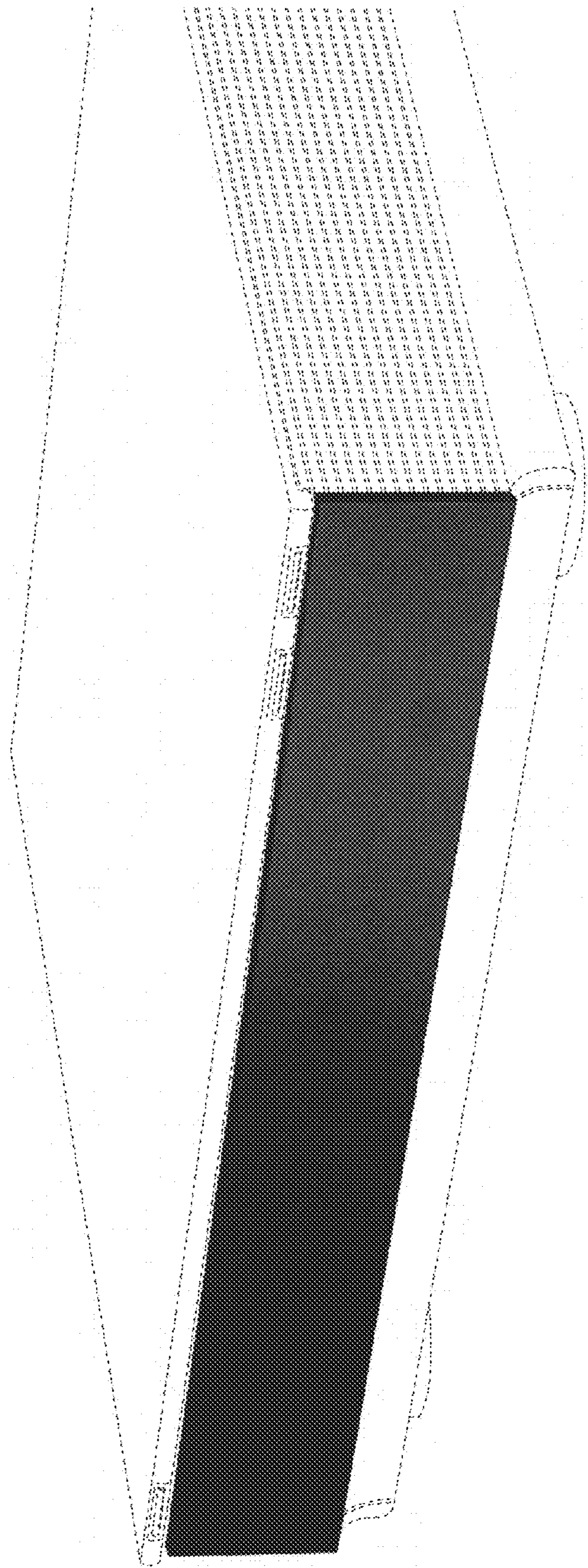

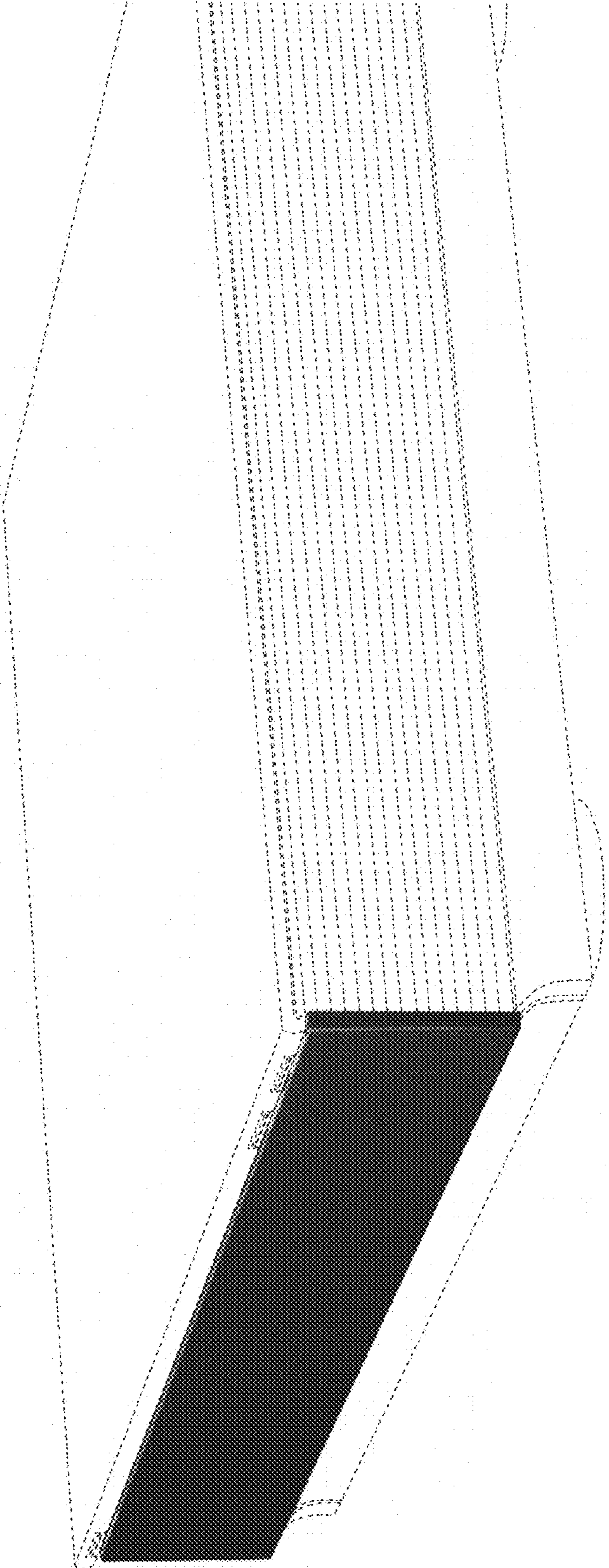

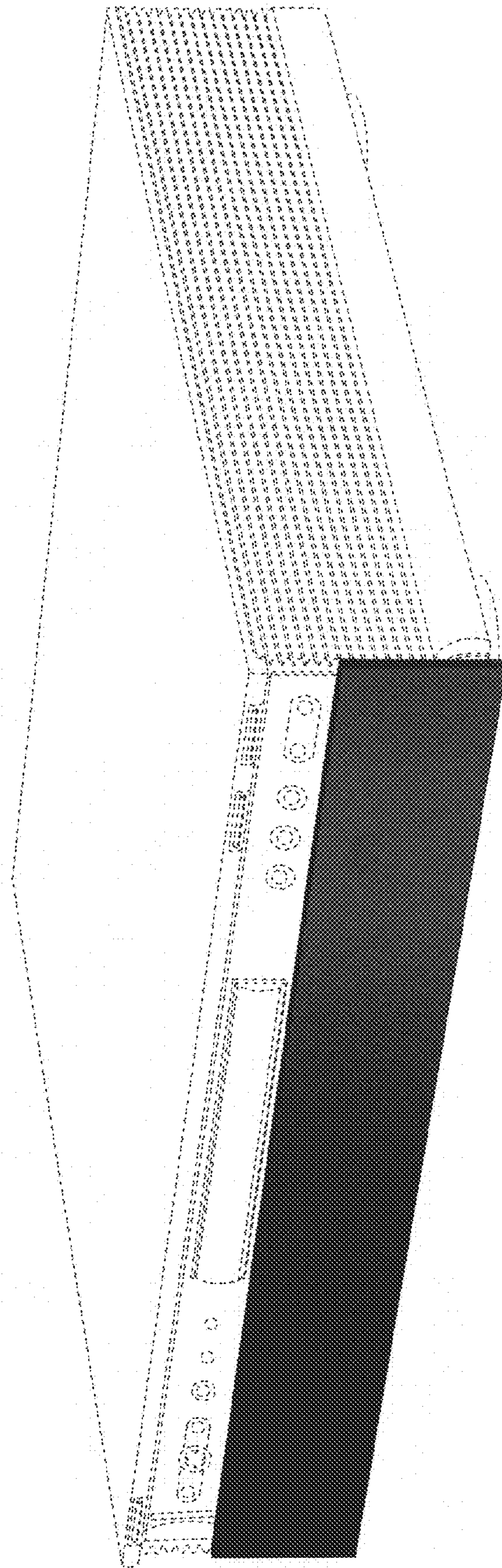
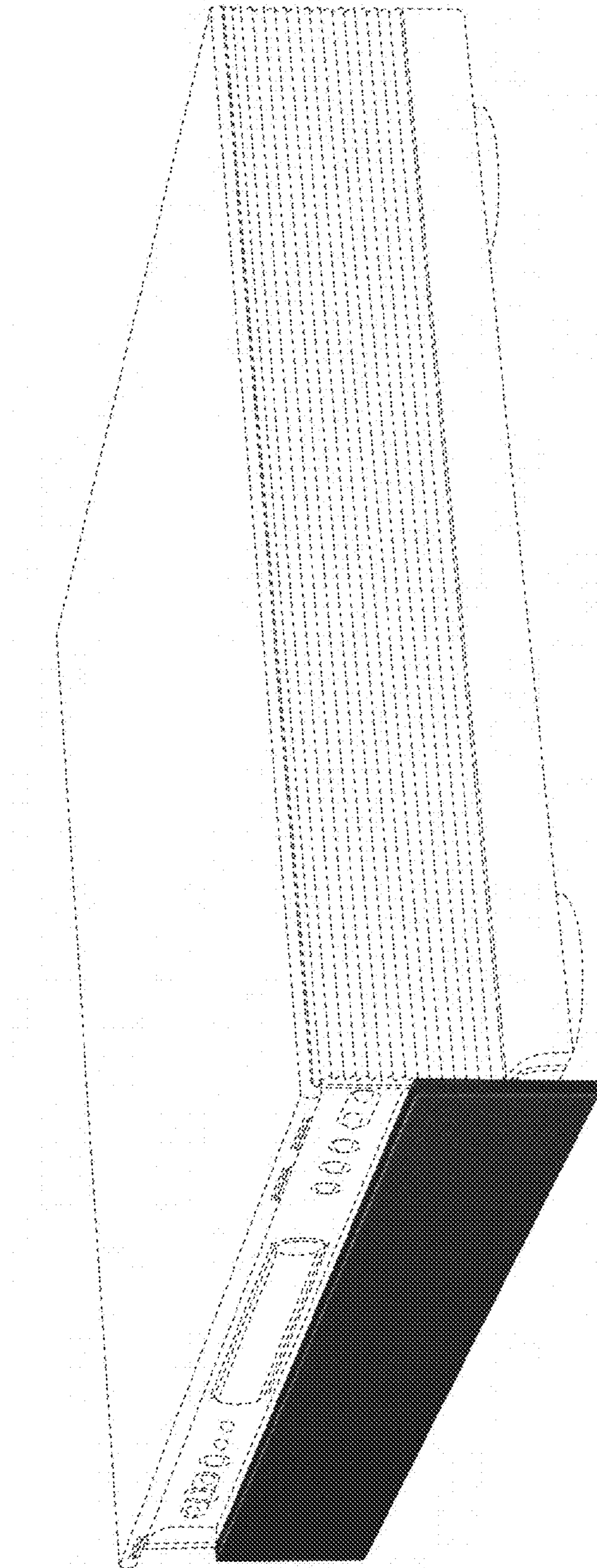

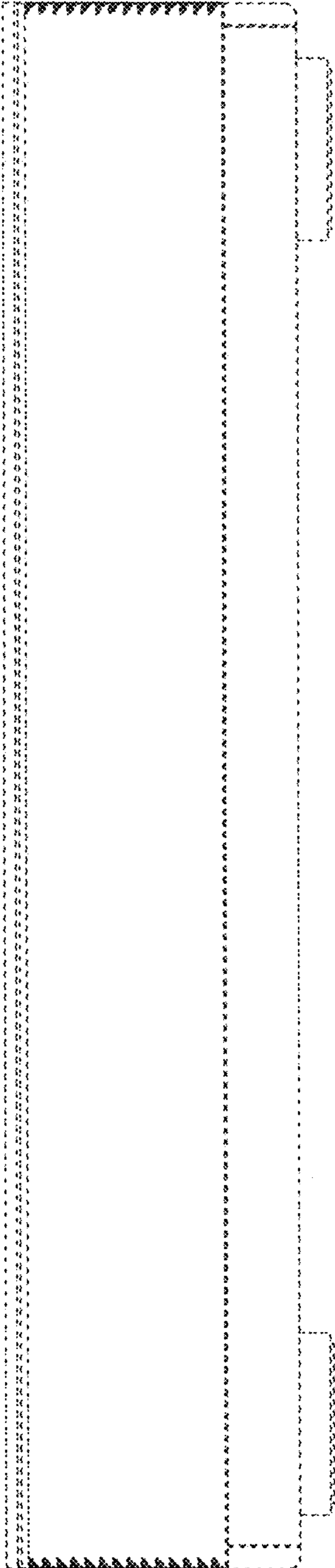

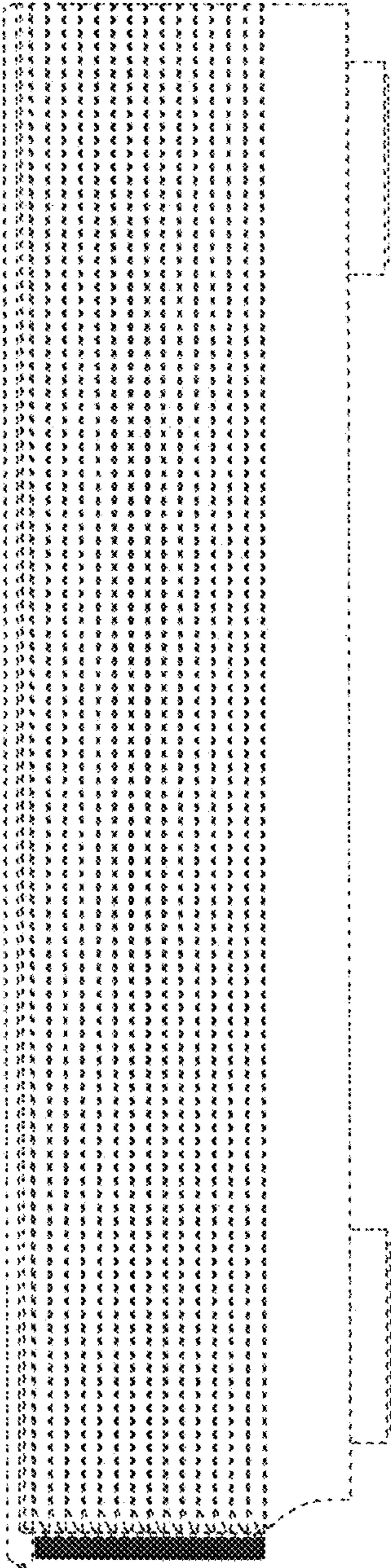

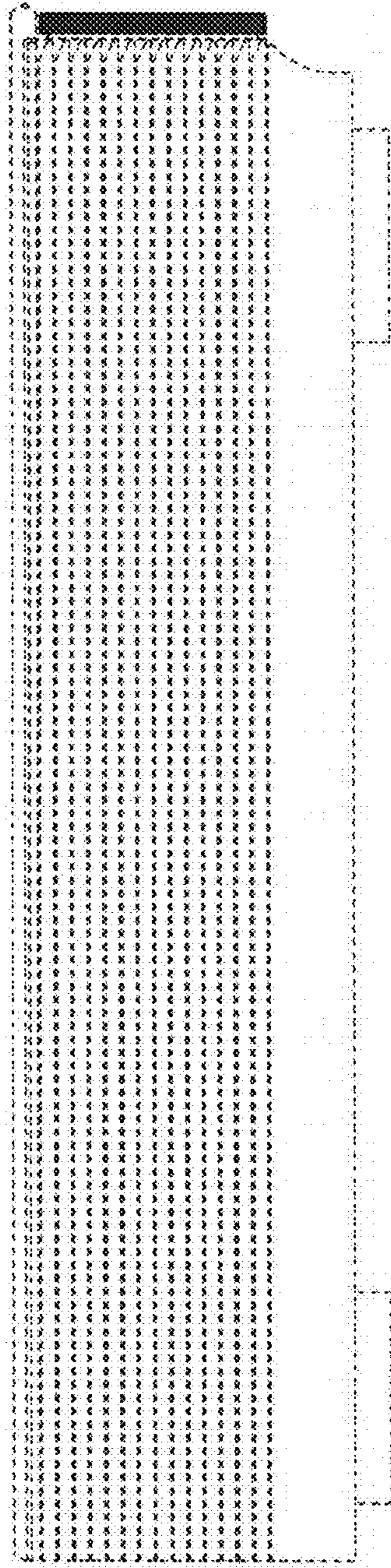

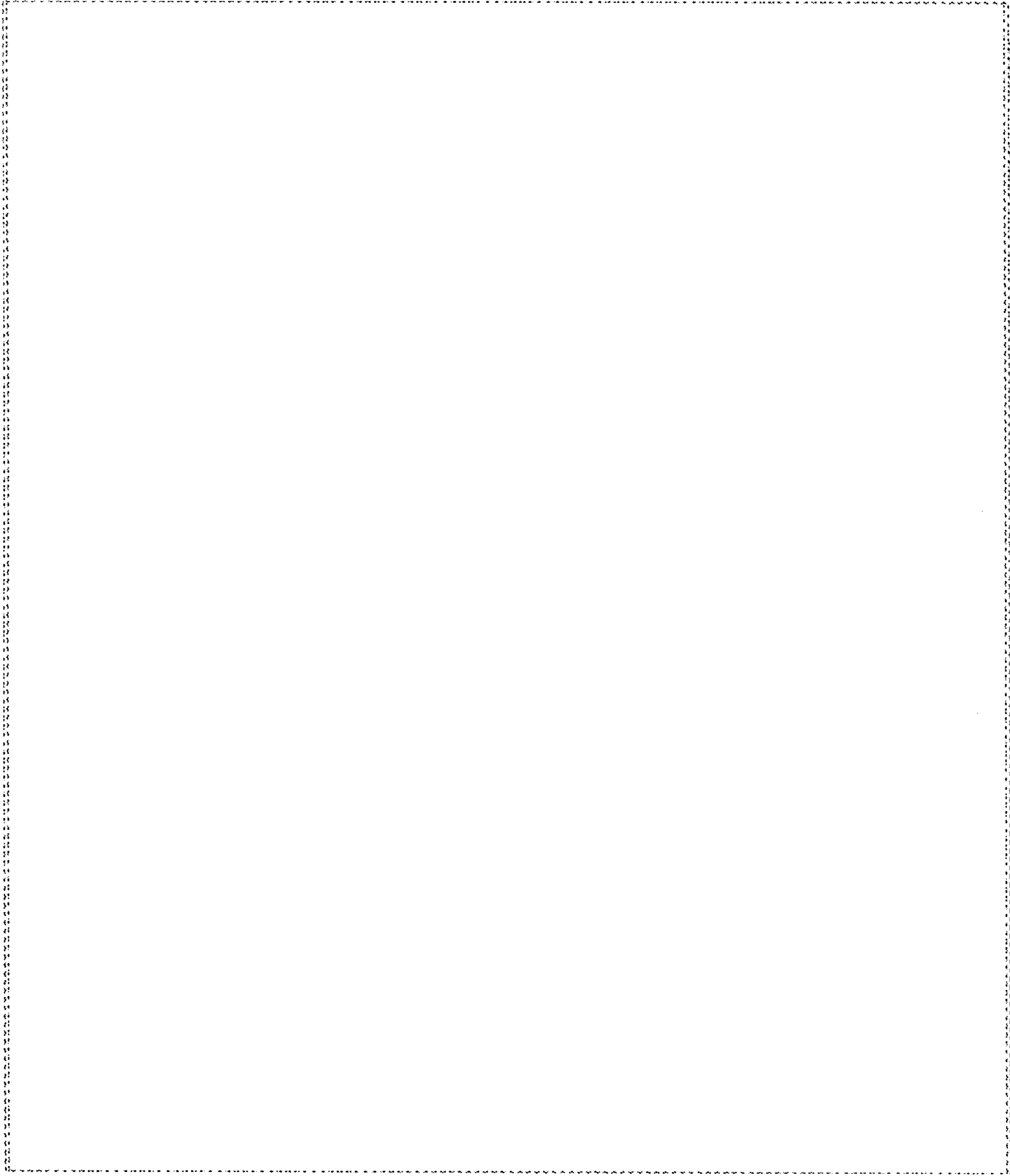

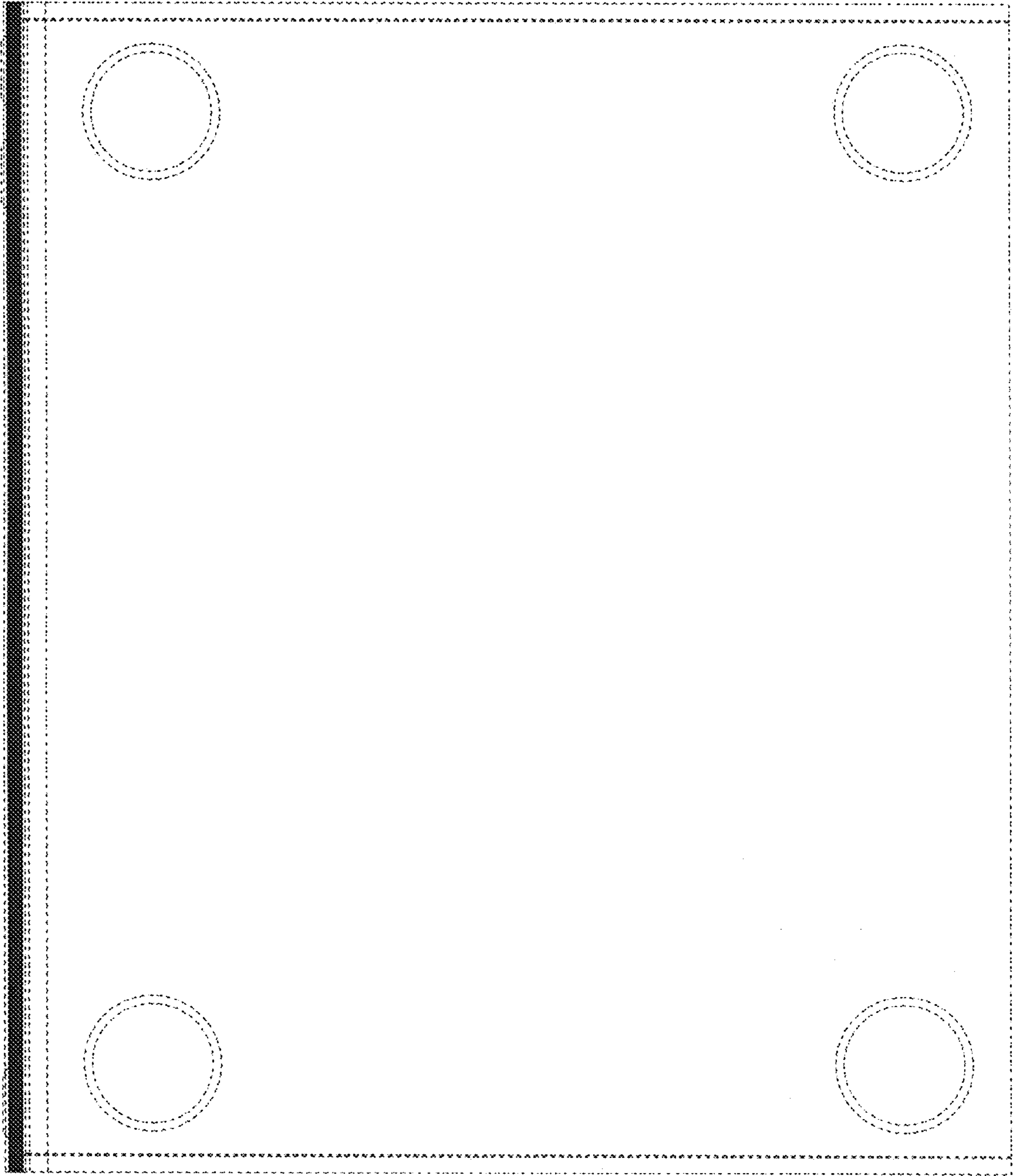
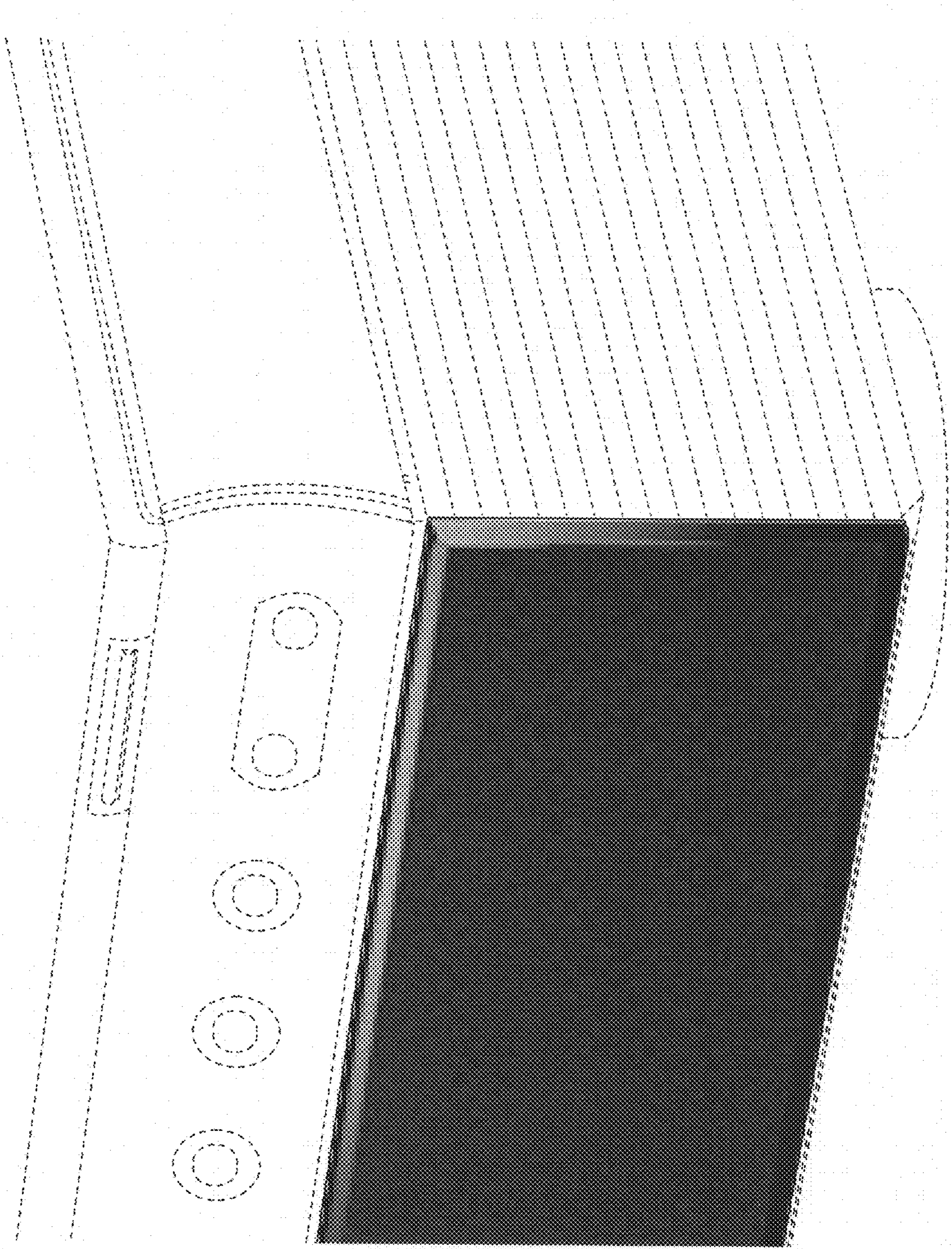

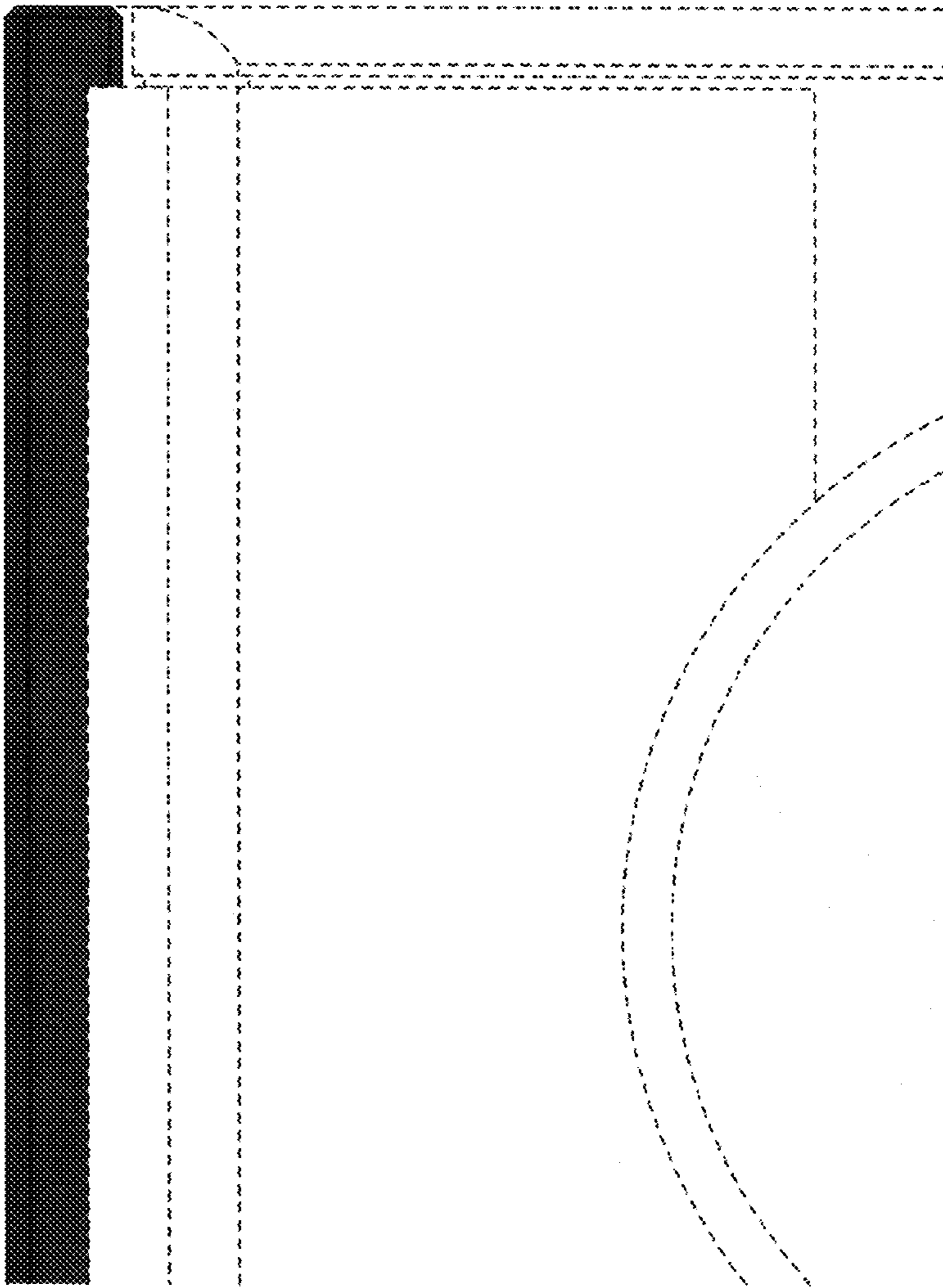
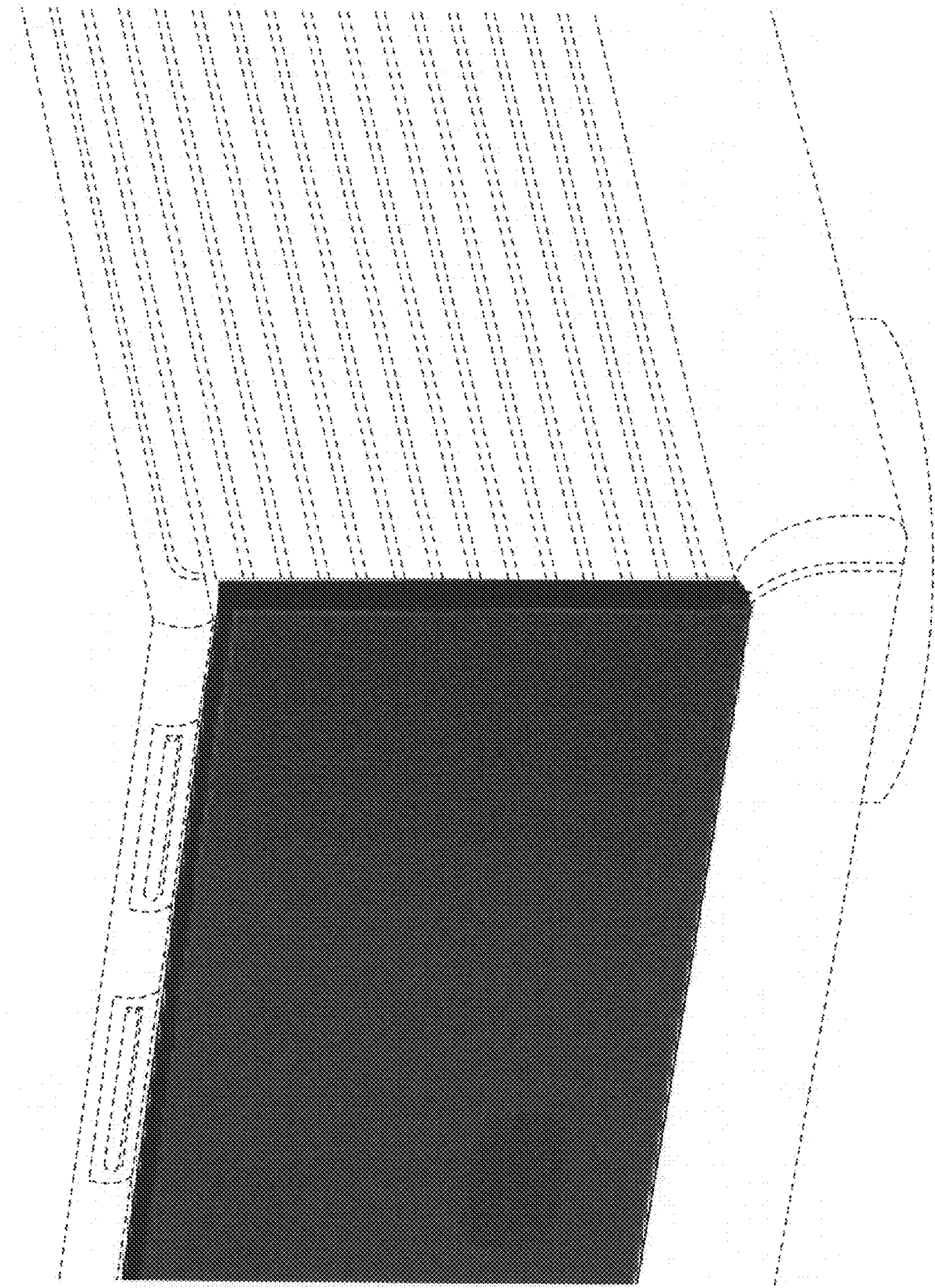

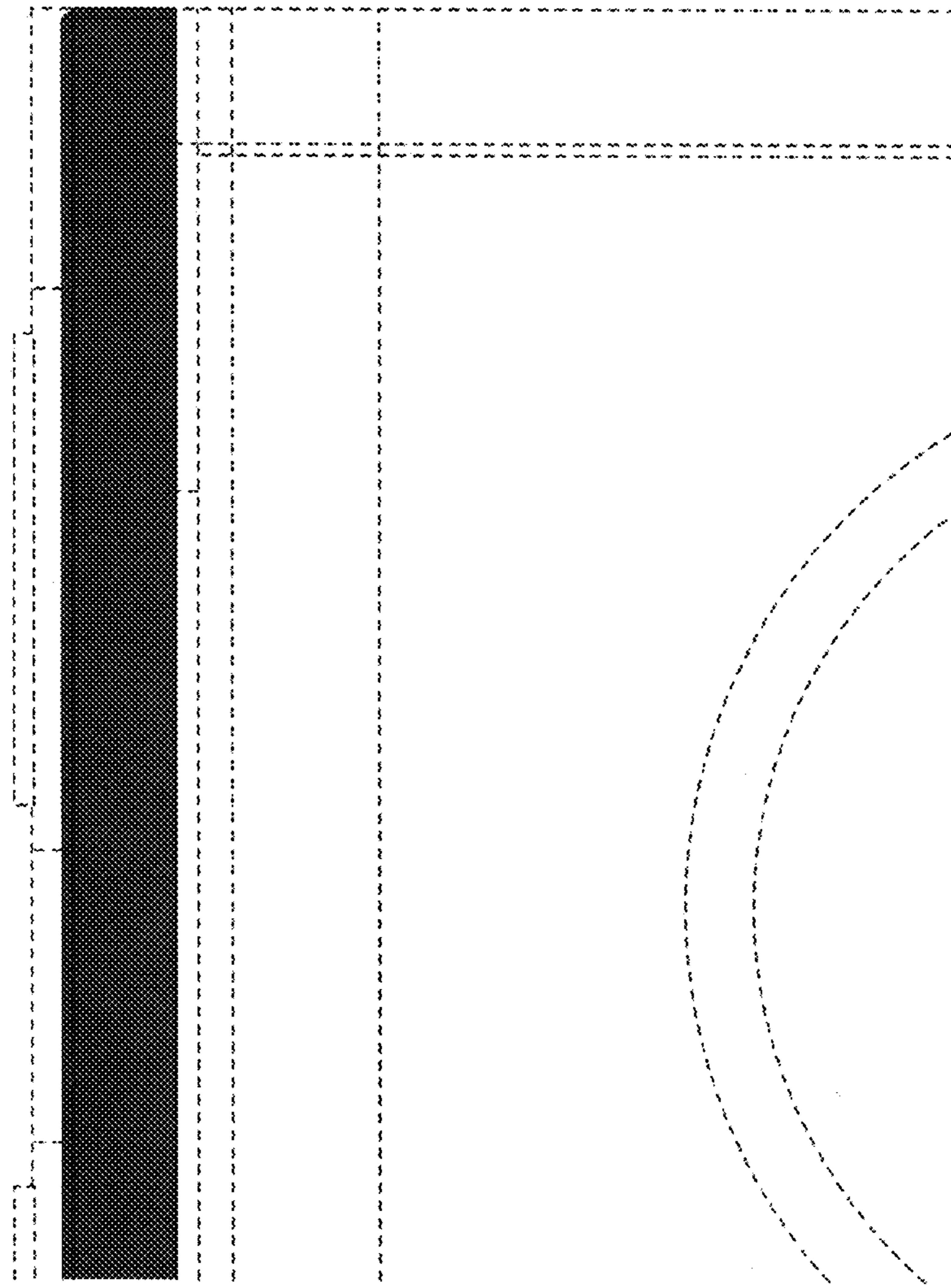
